CIAC heeds Duterte's call, defers rentals of locators

LARK FREEPORT – The Clark International Airport Corp. announced on Tuesday that it is deferring the collection of lease rentals of its locators in direct response to President Rodrigo Duterte's appeal during his recent State of the Nation Address for government agencies to assist the business sector adversely affected by the COVID-19 pandemic.

"We currently have about 45 locators and we told them that they don't have to right now pay their rentals for the months of April to June this year, and they also do not need to worry

about paying any interests or penalties on delayed payments," CIAC president Aaron Aquino said

According to Aquino, the ECQ and GCQ were imposed inside Clark Freeport Zone during the months of April to

"We hope this policy will serve as a spring-board for businesses here at the aviation complex to promptly recover from the sudden business disruption and income loss caused by the pandemic," Aquino added.

NLEX Philippine Arena Interchange reopens on August 1

THE NLEX Philippine Arena Interchange in Bocaue, Bulacan will reopen to the public on August 1, 2020 after being closed due to the coronavirus pandemic restrictions and for the exclusive use of "We Heal As One" quarantine facility.

To curb the spread of COVID-19, the interchange requires contactless transactions through RFID. As part of NLEX Corporation's effort to help motorists transition to cashless transactions, the tollway company will put up RFID installation sites at strategic areas of the Philippine Arena Interchange. Cash-paying motorists who will pass through the road will be required to sign up for an RFID account and have the RFID installed on their vehicles before entry/

'The interchange is surrounded by a mega quarantine facility, a prospective terminal for northern provincial buses---both are inside the Philippine

Arena complex, and a molecular testing laboratory located at the western portion. For everyone's safety, we are implementing the RFID-only policy at the interchange. This would ensure physical distancing through cashless payments," said NLEX Corporation President and General Manager J. Luigi L. Bautista.

In its previous statement, NLEX Corporation said the move to promote contactless payments is in line with the Department of Transportation (DÖTr) - Land Transportation Franchising and Regulatory Board's (LTFRB) directive on the mandatory use of RFID and the ongoing RFID interoperability project aimed at unifying the electronic toll collection systems of all expressways in the country.

'We are committed to provide our customers with safer and innovative payment solutions such as the RFID. We have several installation



sites within the expressway and even offer 24/7 RFID installation for those who are not available during specified business hours," Bautista add-

The reopening of Philip-

pine Arena Interchange complements the recent opening of Tambobong Interchange. Both are vital in the decongestion of Bocaue Interchange and in easing mounting traffic along Governor F. Halili Road in Bocaue-Sta.Maria corridor.

These alternative roads provide better access and convenience to motorists bound for Sta. Maria, Angat, Pandi, and other towns in eastern Bulacan. -Press release

DBP, Customs, BTr, and PayMaya sign accord on automated collection

STATE-OWNED Development Bank of the Philippines (DBP) has signed an agreement with the Bureau of Customs (BoC) to automate the collection and remittance of customs fees and charges that are generated through the 17 customs districts nationwide, a top official said.

DBP President and Chief Executive Officer Emmanuel G. Herbosa said the joint initiative with BoC, along with the Bureau of Treasury (BTr) and PayMaya Philippines, would utilize DBP's online banking system and ensure seamless transfer of funds to state cof-

"DBP takes pride in this endeavor which promotes the use of digital finance in ensuring transparency in customs collection," Herbosa said.

DBP is the eighth largest bank in the country in terms of assets and has a branch network of 129 offices and 11 branch-lite units nationwide. BoC is the second largest revenue earning agency in the National Government next to the Bureau of Internal Reve-

Under the agreement, all collections and payments made in and deposited to DBP will be remitted to a BTr-BoC-PayMaya clearing account. In addition, DBP would provide additional service through its Digital Banking Portal or DBP2 to enable BTr to conveniently monitor remittance of customs collec-

Herbosa said this joint undertaking is an essential element in the National Government's efforts to shift to digital platforms to increase efficiency and effectiveness in its revenue generation activities.

He said these types of partnerships that involve active private sector participation would be an ideal model for other state agencies seeking to bridge the gaps in their service delivery systems.

"The way forward for government is to transcend from the typical and ineffective manual processes and leverage on available information and technology resources to improve the level of a typical public service such as customs collections," Herbosa said. -PR

To the Point

Let us not succumb to fear or surrender to lies

NEVER SINCE the late unlamented Marcos dictatorship has a president ever deigned to shut down the independent media and stifle criticism and dissent.

Even before he officially assumed his post, on May 31, 2016, President Duterte already made clear his unbridled contempt for media, even hinting that killing journalists might be justified: "Just because you're a journalist you are not exempted from assassination, if you're a son of a bitch."

It has been downhill ever since as the president ramped up his offensive against the independent media, joined by his minions and fanatic followers, his messages of hate amplified by a machinery dedicated to the fabrication of half-truths and falsehoods. Indeed, entering the president's fifth year, we find the media, and the truth, increasingly under siege.

ABS-CBN has been shuttered, thousands of its employees about to join the country's millions of unemployed, and the congressional lapdogs who did their master's bidding salivating over the prospect of wresting away the network's physical assets in what we can only describe as perhaps the most shameless displays of the arrogance of power in our country's history.

Rappler and its CEO, Maria Ressa, continue to fend off an all-out legal assault.

State security forces continue to openly slander, without any evidence whatsoever, and endanger journalists and media organizations by labeling them rebels or terrorists for demanding that the government respect and protect freedom of the press and of expression.

And now we are entering the era of the Anti-Terrorism Act of 2020 that is likely to lay waste to all our constitutionally guaranteed rights and freedoms by making practically anything and everything we do or say open to being deemed committing or supporting terrorism on the say-so of an executive body.

In fact, just this weekend, we have seen previews of how this draconian law may be abused and applied against critics and dissenters.

In Cagayan de Oro, where a protest was held on Saturday to support calls for the return of ABS-CBN, three funeral wreaths were delivered to the Northern Mindanao studio of the network. Ribbons on the wreaths linked the campaign for the network to the communist insurgency and listed down organizations, including the NUJP, falsely linked to the rebels.

The next day, in Pandi, Bulacan, police seized thousands of copies of the alternative news magazine Pinoy Weekly from the offices of the urban poor group Kadamay, claiming, again falsely, that the publication, which focuses on the issues and problems facing marginalized sectors, taught people to fight the government.

But this is not the time to succumb to fear. This is not the time to surrender to the lies. This is the time to do what we in the profession of truth do best, be journalists.

Let us close ranks and resist repression. Let us unite with our audiences, the people we serve. We owe it to them to keep press freedom alive in the service of their right to know.

TODAY IN PHILIPPINE HISTORY

Pantaleon Lopez is born

leon Lopez, a Tagalog dramatist, a prolific playwright was born in Pandacan (which was then a separate town from Manila). He was the second of two children of Felix Lopez, whose work was ferrying people across the Pasig River, and Pia de los Santos, who sold candles to add to the family income. He was only 12 years old when his father passed away. It was Felipe G. Calderon, a regular passenger of his father, who became his benefactor and assumed responsibility for his education.

When he came of age, the trader and propagandist, Jose A. Ramos, employed him through his guardian's recommendation. Later, allured by the theater, he became a member of the Compania Fernandez Chorus. The choirmaster doubted his ability and had to be bribed to include Lopez in the group's performances until Lopez eventually proved his competence.

Lopez married Pricila Ignacio, a chorus member whom

he met on the stage in 1893. The couple engaged in buying and selling at the Quiapo market to eke out a living. Later, they established a successful transportation business, leasing carretelas, which enabled Lopez to perform with the Fernandez troupe. However, it was only in 1898 that he started thinking of writing plays himself.

His first play, "Masamang Kaugalian", a zarzuela in three acts, was staged in Teatro Filipino on January 31, 1901. This was followed by another threeact play, "Maling Pagsampalataya", which demonstrated the absurdity of believing in super-

On March 7, 1903, his three-act zarzuela, "Ang Infierno", whose score was written by Hipolito Rivera and Leon Ignacio, debuted in Teatro Libertad. This was his most successful play. Another successful play, "Rosa", was shown not only in Manila but also in Tarlac, Pampanga, and the Tagalog provinces.

Lopez wrote more than 20

plays before he died. His "Sintang Pinucao" was all but finished when acute tuberculosis caught up with him on September 22, 1912. The plays Nena Pantoches and "Ibong Manlulupig" were presented in Felicidad Theater, on Calle Principe, immediately prior to his demise. They were initially meant to generate funds for his medical expenses.

Besides acting, Lopez was an active singer in the San Ignacio Church choir in Intramuros for ten years. He was a tenor with a voice range comparable to that of Victorino Carreon and Nemesio Rata. He also played musical instruments such as the flute, the clarinet, and the violin.

By his wife Pricila, who often managed the business side of his presentations, he sired 10 children, among were Martin, who married Ciriaca del Prado; Pantaleon, a bass-baritone singer who married Asuncion Loanco, a mezzo-soprano singer; Maria; and Irinea, who married Vicente

President Duterte's another call to lawmakers to finalize the Bayanihan II Act, a recent measure to finance government-initiated programs to help businesses, employees and marginalized members of society to cope with the impact of the pandemic.

"It was no less than President Duterte who reminded bigger establishments—in our case, the CIAC as the government-owned corporation—to give assistance to stakeholders on rentals, or a form of an extension in the period of payments," he added.

In addition to the deferred collection of lease rentals during the quarperiod, Aquiantine no said CIAC locators are also given a 30-day grace period from the last due date of their rental payments or from the date of the lifting of the ECQ, MECQ and GCQ, "whichever is longer, without incurring in-

After the grace period, locators are then given the option of paying their unsettled accounts through a twelve-month installment scheme, he added.

"This means the amount of rentals accrued by locators during the ECQ, MECQ and GCQ can be equally amortized in twelve months following the end of the 30-day grace period, and again without interest or penalties," Aquino clarified.

For outstanding accounts as of March 15, 2020 or "old unpaid accounts prior to the imposition of the ECQ", Aguino noted CIAC shall grant a grace period for payment of 90 calendar days, adding that no interest or penalty shall be imposed from March 16 up to June 15.

The CIAC chief noted that these policies will be applied while awaiting an official guideline from the Department of Trade Industry on the request of both the Clark Development Corp. and the Bases Conversion Development Authority to allow the grant of full waiver on payment of lease rentals from April to June 2020.

The Clark Civil Aviation Complex managed by CIAC is home to the privately-run Clark International Airport, as

well as the mixed-use business district Clark Global City, and currently around 45 locators in cargo and aviation-related businesses.

gateway for OFWs is not an SBMA initiative, but a program managed by the National Task Force on Returning Overseas Filipinos (NTF-ROF) headed by the Department of Transportation, and reinforced by the Overseas Workers Welfare Administration, Philippine Ports Authority, Department of Tourism, Office of Civil Defense, and the Office of the President.

Eisma issued the clarification after a social media post on Sunday by former Olongapo City Mayor Rolen Paulino claimed the SBMA has kept the plan under wraps and that the mayors of communities around the Subic Freeport, as well as their representatives to the SBMA board of directors were kept in the dark about it.

"If former Olongapo Mayor Rolen Paulino is saying that we did not consult them about this plan, then he is promoting disinformation. He is also barking up the wrong tree, and prematurely at that," Eisma said.

"If ever, he should demand consultation from the DOTr and other agencies because this project is national government-driven, not SB-MA-driven. The SBMA is but a tiny cog in this big machine that is undertaking the program," she pointed out.

In his post addressed to residents of communities near the Subic Bay Freeport, Paulino stirred opposition to the OFW repatriation program by raising doubts on government transparency and rousing local fear of increased Covid-19 transmission.

"May mga lumalabas po na balita na ang SBMA (sic) ay gagawing Covid-19 testing center at launching area ng mga OFWs at sila ay dadaan sa rapid (sic) at swab test ng Red Cross bago pauuwiin," said Paulino, who now sits as consultant at the city hall. "Dapat naman tayo ay makunsulta or maipaalam man lang sa atin ang kanilang plano."

Eisma revealed, however, that as early as April this year, the OWWA and DOT have been talking about OFW repatriation with the tourism departments of both the SBMA and Olongapo City. Records of "group chats" involving the concerned parties would bear this out, she added.

"I will understand if Rolen Sr. did not know about this because he is not the mayor, but I assume that the head of Olongapo tourism reports to the mayor, because my own tourism head reports to me," the SBMA chief said.

Eisma said she has already advised con-cerned agencies about the demand for consultation from the for-mer mayor. "However, if they would grant consultation, my quess is it would not be the father, but the son, the sitting mayor, whom they would properly contact," Eisma added, referring to Olongapo City Mayor Rolen Paulino Jr.

Spillover

Eisma likewise pointed out that Subic is being considered only for any spillover of OFWs being repatriated through the Manila and Clark airports, as the Subic Bay International Airport still has no night-landing ca-

"We're still working on building that capability, so until then, OFW flights cannot land in Subic and we would only be available for the spillover. If the hotels in Manila, Clark, and Angeles City can no longer keep up with the number of returning OFWs, then that will only be the time that Subic would come in," she stressed.

At the local level, Eisma said the repatriation plan would still have to be approved by the SBMA board "once the

safety protocols are already firm." The elder Paulino's wife Cynthia sits in the board as city representative.

Eisma also revealed that OWWA and PPA officials had again called up the SBMA this week to revive the stalled talks, but she had insisted that "the final plans would have to be solid before we agreed."

She said the same agencies are also discussing the proposal with the Freeport Area of Bataan and the Clark Freeport, as well as the government of Zambales and Bataan, but the discussion "is taking so long precisely because solid safety protocols should be in place."

Whatever the outcome of the discussions, Eisma said the SBMA would not shirk its duty to help as necessary, citing Pres. Duterte's order in his recent State of the Nation Address for government agencies to help OFWs who have lost their jobs and returned home due to the Covid-19 pandemic.

"It has been a national pride to call the OFWs modern-day heroes because of their economic contribution to the country, and it would be a national shame if we should refuse them our help now that they needed it most," Eisma said.

no Hall. He was assisted by program chief implementer Angelina Blanco, PESO chief Luningning Vergara, and tourism officer Jay Luna.

In his statement, Pineda said the program is his "humble" offering to Kapampangan repatriates who were stranded overseas because of the

"Maliit lang pong bagay itong programa kumpara sa sakripisyong ginawa ng ating mga ka-

papayan sa ibang bansa. Masaya po ako na makita natin silang safe na nakauwi sa probinsya at makapiling ang kanilang pamilya pagkatapos ng mahabang panahon," he shared.

He assured the repatriates that the provincial government is ready to assist them in case something will happen to them during their remaining 11 days of home quarantine.

"In case may mangyari sa inyo or sa mga kapamilya ninyo, please coordinate with your barangay respective health workers. Hindi po napuputol dito ang commitment namin sa inyo. Hanggang nasa Pampanga kayo, kami po ang bahala sa inyo," he added.

According to Blanco, at least 161 Kapampangan ROFs have benefited from the program. Of this number, 132 were sent home while the remaining 29 are still under quarantine at NCC.

Meanwhile, the repatriates were overjoyed as they thanked the provincial government for the service extended to them.

"Gov siguro kulang po ang thank you para pasalamatan po namin kayo sa tulong na ibinigay niyo sa amin. Sabi nga ng mga kasama namin sa ibang bansa, sana-all may ganyang programa tulad ng pagkalinga ng pamahalaan ng Pampanga sa mga ROFs," said Virgillo Navarro, who came home from New Zealand.
