Santos denied any wrongdoing in securing a loan since "the local government unit of San Simon represented by the chief executive can secure loan" to implement various projects which will benefit the people of

# Nanay heads Covid-19 recovery, rehab team

CITY OF SAN FER-NANDO – Vice Gov. Lilia "Nanay" Pineda has been designated chair of the newly organized Pampanga Recovery and Rehabilitation Team (PRRT) principally tasked to map out strategies to jumpstart the local economy.

Executive Order No. 23, S-2020 signed by Gov. Dennis "Delta" Pineda on Sept. 8 created the PRRT to serve as the economic cluster within the existing local Covid-19 task force as "urged" by the Department of the Interior and Local Government "for the LGUs to start planning and budgeting for local recovery and rehabilitation now, even if the Covid-19 pandemic is

not yet over..."

Named members of the PRRT are the chairpersons of the sangguniang panlalawigan committees on health, appropriation, trade, infrastructure, education, agriculture and aquaculture.

Also designated members are the chiefs of the provincial offices on health, investment and promotion, public employment service, social welfare and development, tourism, agriculture, veterinary, engineering, manpower and training, disaster risk reduction and management, and the local finance committee.

The provincial planning and development office serves as the PRRT secretariat.

# PH surpasses 3 million Covid-19 tests

THE PHILIPPINES has conducted more than three million COVID-19 tests as of mid-September, as the government continues to implement an aggressive testing program to detect COVID-19 cases.

In a recent webinar with investors, National Action Plan Against COVID-19 Deputy Chief Implementer Secretary Vince Dizon also reported that testing per day has drastically increased to almost 42,000 per day, from just over 500 tests conducted per day in March.

Dizon said the government's continuous aggressive testing program is part of the National Action Plan Phase II anchored on the "Prevent, Detect, Isolate, Treat, and Reintegrate" (PDITR) strategy.

He also credited the Task Force Test, Trace, and Treat coalition with the private sector in the ramp-up of COVID-19 laboratories nationwide. The country

now has a total of 125 accredited labs nationwide from only one in February.

This is really a prime example of what we can achieve together if the national government, the local governments, and the private sector work on one unified purpose.

According to the testing czar, balancing the risk of infection and the need to reboot the economy posed a serious challenge to the country's ongoing pandemic response. He pointed out that the best option is to reopen the economy safely, as he called for the public's continued cooperation by following health protocols.

We cannot argue the fact that we need to open up the economy now, as safely as possible. That, I think, should be our objective. How do we do this? The experts have said that if we are able to have the capacity to test, isolate, and treat, and we make the general population follow the minimum health standards such as wearing of face mask and face shield, proper hand hygiene, and physical distancing, then we can open up the economy. And this is what we're seeing in other countries.'

Dizon said that the government is looking into more innovations to test more Filipinos and speed up the turnaround time on the release of test results. These include antigen tests and pooled testing

He added that under the PDITR strategy, COVID patients are quickly isolated from their communities to lessen the transmission of the virus, especially in densely populated cities. Dizon cited the experience of Navotas City which has successfully brought down its positivity rate last August, after reporting a record-high number of new COVID cases in July. -PR


AN ACT RENAMING THE NINOY AQUINO INTERNATIONAL AIRPORT AS

Be it enacted by the Senate and House of Representatives of the Philippines in Congress

SECTION 1. The name of the Ninoy Aquino International Airport, otherwise known as NAIA, is hereby changed to Paliparang Pandaigdig ng Pilipinas.

Incidentally, a petition before the Supreme Court toward the same end - of renaming the Ninoy Aquino International Airport – filed by the bobo-babbling Atty. Larry Gadon was junked for "lack of merit" only last week.

About the same time that came out in the internet a picture of the inauguration of the Benguet General Hospital's molecular biology laboratory at the prominently and proudly named "Eric Yap Building."



Insofar as the guidelines of the National Historical Commission of the Philippines, Yap is wrong in both antics.

Naming Manila's international airport after Aquino fully subscribes to: "No public place should be named or renamed after a person within ten (10) years of his death except for highly exceptional reasons (e.g. his death was due to assassination in the service of the country, he/she gave exceptional service to the nation, death while trying to save others, death was a result of his patriotism, and death while in performance of one's duty).

Not to mention Republic Act No. 6639: An Act Renaming the Manila International Airport as the Ninoy Aquino International Airport signed on Dec. 10, 1987.

On the other hand, the naming of a government building after Yap is a direct contravention of the NHCP guidelines,

"No local governments, institutions, places or buildings shall be named after a living person."

"In the naming of public places after people, the use of the word 'memorial' should be deleted as it is already understood that the person being honoured is already deceased."

No, we don't wish Yap to be instantly memorialized just to justify or legalize into existence the Eric Yap Building.

Yes, we wish Yap's bloated ego be cut to his diminutive

### The Grieving Mother

I SHARED these thoughts a few months ago to our family when I celebrated Mass for my sister-in-law's first death anniversary. I realized that the thoughts that I had shared then are also very appropriate for today's Memorial of Mary, Our Lady of Sorrows.

The image that we get of Mary in today's Gospel is that of a GRIEVING MOTHER, isang inang nagluluksa, which is how I propose to translate MATER DOLOROSA, the title by which we commemorate Mary today.

In Kapampangan we refer to the first death anniversary as "LUKAS PALDAS". Literally, it means removing one's grieving clothes (Hubad Luksa). In Tagalog, they call it "BABANG LUKSA" (Putting down the grief, allowing grief to descend). I asked a friend of mine from Bulacan why they use BABA instead of HUBAD. He said, grieving for them is not just something you wear and easily remove like clothes. When you lose someone you really love, grief is like something that envelopes and permeates your whole being. It takes a lot more to put it down

This makes me understand why we Filipinos have a different way of celebrating Easter. The Easter eggs and bunnies of Europeans and Americans do not mean much to us. So, we have reinvented our Easter and enculturated it as something like our "Babang Luksa," our Pinoy ritual of putting an end to the grieving process. We prefer to dramatize it through our traditional Salubong, the encounter between the Risen Jesus and the Sorrowful Mother, facilitated by the coming down of an angel. The angel's task is to remove the black veil that covers the face of Mary to allow her to share in the joy of her Risen Son.

Last Easter Vigil, because we were still under ECQ and were not yet allowed to hold public religious gatherings, I myself played the role of the angel that performed the ritual of removing the black veil of grief from the head of the Sorrowful Mother. When I did it, I imagined her to be our country or the whole world today, knowing how a veil of grief had descended upon us and covered or lives since the start of the pandemic crisis that had locked us all down in our homes.

Imagine how much more painful the grieving must have been for people who have lost their loved ones to the Covid-19 in the past few weeks? Imagine the thought of letting your loved one suffer and die alone in a hospital ICU? Imagine not being allowed to even kiss or touch them? Imagine saying goodbye to them through a cellular phone? Not being able to have a proper wake in order to mourn together as a family? Having to have your loved one cremated within 24 hours?

#### Pope Francis

I don't know why we often find ourselves apologizing when grief makes us break into tears. One of the scenes that we will never forget about that time when Pope Francis visited the Philippines took place at the parade grounds of UST. Remember that girl who broke

down before him after asking the question "why does God allow young people to suffer abuse?" The Pope himself cried and embraced the little girl. Later he said, "Sometimes God helps us to see more clearly with eyes washed by tears." Victor Hugo said something to that effect too in his novel Les Miserables, he said, "Those who do not weep do not see.'

In the introduction to his sermon on the mount, Jesus says, "Blessed are those who grieve, they shall find consolation." Imagine calling grief a blessing? But maybe that is the paradox of it. Only those who have loved can truly grieve. I don't know if I've ever mentioned to you that Italian writer, Carlo Rovelli in his book entitled, The Order of Time, who gives a positive meaning to grieving. He says, "It isn't absence that causes sorrow (or grieving). It is affection and love. Without affection, without love, such absences would cause us no pain. For this reason, even the pain caused by absence, is, in the end, something good and even beautiful, because it feeds on that which gives meaning to life."

Only those who love can truly grieve. Only those capable of compassion can be stricken with sorrow for the pain of another person. My honest feeling is that what the Blessed Mother grieves about in our day and age is when people cannot even grieve anymore; when people just don't care. When they remain unaffected by the suffering of others.

When the Papal Nuncio visited us in the Diocese of Kalookan, he retold to us the story of our beloved patron saint, San Roque-who lived in the time when Europe was stricken by a deadly plague. At some point in his homily, he shifted to our own times and said, modern people are confronted by an even more serious kind of plague: the plague of indifference.

He alluded to the story of Cain and Abel, where, he said, it is the Lord who grieves. What affects God more deeply is Cain's incapacity to grieve about the terrible thing that he had done to his brother. God is grieved by Cain's answer to his question, WHERE IS YOUR BROTHER? When Cain replied and said, AM I MY BROTHER'S KEEPER? What he was actually saying was, WHAT DO I CARE?

Indeed, It is indifference that kills our hopethe very incapacity itself to grieve. And so, you see, why we celebrate the image of Mary as a grieving mother. Mary's grief is the sorrow of love that brings hope with it. Remember what Jesus says in John 16:20-22: "Amen, amen, I say to you, you will weep and mourn, while the world rejoices; you will grieve, but your grief will

#### TODAY IN PHILIPPINE HISTORY

### Philippines-Mexico galleon trade ends

ON SEPTEMBER 14, 1815, the galleon trade between the Philippines and Mexico ended a few years before Mexico gained independence from Spain in 1821. The Spanish Crown took direct control of the country, and was governed directly from Madrid. The opening of the Suez Canal and the invention of steam ships, which reduced the travel time from Spain to the Philippines to 40 days, made this more manageable.

Galleon trade became the fundamental income-generating business for Spanish colonists living in the Philippine of Antipolo, chosen as the pa-Islands with a total of 110 Manila galleons set sail in the 250 years of the Manila-Acapulco galleon trade (1565 to 1815).

The Manila galleons or Manila-Acapulco galleons sailed the Pacific for nearly three centuries, bringing to Spain their cargoes of luxury goods, economic benefits and cultural exchange.

Positive results of the galleon trade were the intercultural exchanges between the Philippines and the Americans, symbolized by no less than the Mexican-made Virgin troness of the sailors, who protected them from the untold perils across the Pacific.

The mango de Manila, tamarind and rice, the carabao (known by 1737 in Mexico), cockfighting, Chinese tea and textiles, fireworks display, tuba (coconut wine) making came to Mexico through the trans-Pacific trade.

In exchange, the return voyage brought innumerable and valuable flora and fauna into the Philippines: avocado, guava, papaya, pineapple, horses and cattle.

# Niyama: How do you behave when you are the only witness?

MOST PEOPLE think that yoga is all about asanas (body poses), which discourages many from joining join for all they see are challenging yoga poses of women in revealing outfit, fit for the beach. Whatever happened to the beautiful and flowing traditional yoga clothes? Seeing yoga being advertised falsely and westernized, treated more as a business and for ego-based intention, rather than a School of Life, to live in a spiritual way, is disheartening.

Allow me to impart my humble knowing and understanding on the meaning of the system in depth, to guide and encourage aspiring students to learn the very purpose of the practice, as well as to give light to the curious.

In my previous article I discussed the first of the eight limbs (paths) of yoga, which is Yama. Let us take a look at the second limb, Niyama.

Niyama, governs the rules of personal behavior and conscious choices. How do you live when no one is looking? How do you behave when you are the only witness? What are your real intentions?

This second step of Yoga is much needed in our present critical situation to prevent the further spread of the coronavirus, by applying awareness in all our actions – a selfresponsibility, so we can regain our strength the soonest and build back what we have lost.

Niyama, has five sub-limbs: shaucha, santosha, tapas, svadhyaya and ishwara pranidhana.

**Shaucha** or purity, cleanliness. It relates to the cleansing of the outer body through a regular bathing and maintaining good hygiene, the purification of the inner body through consistent exercise, asanas (body postures), pranayama (breathing techniques) and kriyas (detoxification of internal organs). Purity in thoughts, speech, action, surroundings, intentions, nutrition, is part of shaucha.

Santosha or contentment. It is the absence of addiction to power, control and approval. Through this practice, the mental turbulence that disturbs your contentment vanishes. Keeping the mind focused on happiness, that no matter what circumstances you are in and what is happening around you, your state of calmness remains the same and your peace becomes independent from any given situation.

**Tapas** translated as austerity. It refers to the discipline of the external and internal body. People often associate discipline with deprivation. You may want to ask yourself your goals in life and start mapping the steps to attain it. These steps are what we are referring to as

discipline. They are well-thought-of actions, the vehicle to transport you to your dream destination.

The Sanskrit word tapas also mean "heat or internal fire." It evokes fiery passion, to burn away impurities in the body, choosing a healthy balanced diet, developing regulated food intake.

To follow nature's rhythm, like rising early when the sun rises in the morning and retiring as soon as the moon takes over, radiates peace in the mind and tranquility in the heart. With tapas involved, a yogi's life is certain to shine brightly, she becomes a beacon of light that brightens up the dark.

**Svadhyaya** refers to the dedication of study of Vedic spiritual literatures and prayers. The Gayatri mantra is the base of all Vedic verses, which has two categories, Vedic and Tantra. Mantras are words recited repeatedly to give siddhi (power), to those who chant them. A union with your desired deity or God.

Svadhyaya illuminates the difference between knowledge and knowingness. It teaches you, not to confuse information with wisdom. Performing holy actions and maintaining holy thoughts, to create selflessness, is svadhyaya. When svadhyaya lives in your awareness, dependence on superficial and outer accomplishments deceased and joy arises from within.

Ishvara Pranidhana means faith or to surrender to God. It is an action of completely surrendering to the unknown, believing in the wisdom of the higher self. Furthermore, it is a dedication to fulfill your sacred duties, trusting the process even in uncertainty, to mirror the God-like perfection to attain samadhi (enlightenment/bliss) and to be One with the Supreme Being, the essence of all existence.

As you embrace Niyama and your practice becomes a natural expression in your daily living, expect to receive a pure contented sense of well-being, a glowing body of health, a euphoric divine connection with your spirit and an eternal life filled with rhapsodies of ecstasy.

### **Execs: No maltreatment of workers...**

laws, especially giving salaries below the minimum wage, were just among the numerous complaints that the workers raised against RSC management.

The workers plight went viral in the internet after broadcast journalist Erwin Tulfo featured them in his program where he organized a rescue operation led by the Department of Labor and Employment regional office and the local police.

In Tulfo's program, the workers also alleged maltreatment such as making them "target practice," and forced to sniff shabu (methamphetamine) to keep them awake to last them longer hours for work.

But all their allegations were categorically denied by the RSC officers during the press conference.

#### Police certification

A certification from the San Simon PNP stated that the municipal health office has provided assistance during the conduct of mandatory and unannounced drug-testing for employees of RSC proving that no illegal drugs are permitted in the RSC compound.

The RSC compound

is also certified Covid-19-free which explains the strict security procedures being implemented because of the pandemic. Only 15 workers at a time are allowed out during their days off owing to the pandemic, said Salazar.

Meanwhile, a Youtube video of the Erwin Tulfo program "Tutok Tulfo" showed some of the reported more than 100 workers coming out of the gate of the RSC compound after one of the staff of Tulfo called the workers on their cellphones and asked them if they still needed to be rescued to which they replied, "yes."

A few hours earlier, the DOLE led by regional director Zenaida Angara-Campita entered the RSC compound with the police but came out without the workers prompting Tulfo's staff, who remained outside the compound, to call the workers.

Upon hearing the workers' distressed call over the phone, the DOLE and the police went back inside the compound and were later shown in the video coming out of the gate with the alleged detained workers.

But during Tuesday's press conference, Arellano noted that some of the workers who were

allegedly detained came out fresh from taking a shower and wore clean clothes.

"Malilinis po ang kanilang damit at kumpleto ang kanilang gamit mayroon pong representative ng DOLE na sumaksi," she said.

"Hindi namin alam na mayroon silang plano at sabay-sabay na aalis. Sa katunayan, kinabukasan may natangap kaming text messages at tawag humihingi sa amin ng pasensya," she narrated as she showed the text messages on her cellphone. "Gusto nila magbalik trabaho na."

"Natakot lang daw po sila may nagsabi sa kanila na isasara ang kumpanya at huhulihin ang kanilang boss," according to Arellano saying that only 42 of their 500 workers resigned. Salazar said all of the 42 workers are probationary meaning they were only hired last June and July.

#### No guns

"Wala pong maltreatment," she stressed.
"Wala pong baril ang mga Chinese," denying that they are being made target practice. She admitted that there are some 20 Chinese nationals working at RSC with complete documents and legitimate working permits.

RSC president Irwin Chua was not present during Tuesday's press conference but distributed a printed statement saying he is a Filipino citizen with Filipino parents who grew up in Tondo, Manila.

Chua said RSC workers come from all over the country and some of the issues being raised do not concern race. But just like Filipinos, some workers also have some misunderstandings which are quickly resolved by management because they do not tolerate abuse and harassment.

#### Harassment

Chua said based on his perspective, what is happening is harassment. He noted that many times they have been visited by DOLE, the Department of Trade and Industry, the police, Bureau of Fire Protection, and the municipal government with no issues raised.

It happened only now just because Tulfo was not allowed to enter the RSC compound.

Chua admitted that RSC is not perfect but assured the authorities that they are continually improving their system and procedures.

"Mahal ko po ang Pilipinas," he concluded his statement.

AN ORDINANCE DECLARING MORATORIUM ON AMUSEMENT TAX FOR THE MONTH OF AUGUST 2020 TO DECEMBER 2020 IN THE CITY OF SAN FERNANDO, **PAMPANGA** 

WHEREAS, President Rodrigo Roa Duterte declared, by virtue Proclamation No. 922, a State of Public Health Emergency throughout the Philippines to prevent rapid containment and prevention of the Corona Virus (COVID-19), in view of the pandemic and or international concern which threatens national security and in order to mobilize governmental and non-governmental agencies to respond to the threat;

WHEREAS, the COVID 19 pandemic has gravely affected the business community, the entertainment industry included, due to community quarantine measures implemented by the national government in response to COVID 19;

WHEREAS, the City of San Fernando, Pampanga has to adopt strategies to help the business sector cope and stabilize the economy under the "new normal" environment by easing stringent requirements and adopting measures granting reliefs as may be allowed by law;

WHEREAS, pursuant to Section 192 of RA 7160 otherwise known as the Local Government Code of 1991, "Local government units may, through Ordinances duly approved, grant tax exemptions, incentives or reliefs under such terms and conditions as they may deem necessary";

WHEREAS, pursuant to Section 455, Chapter 3 of RA 7160, par. b (1), the City Mayor as the Chief Executive of the City Government shall exercise such powers and perform such duties and functions xxx for efficient, effective, economical governance the purpose of which is the general welfare of the its inhabitants pursuant to Section 16 of this Code; the City Mayor shall exercise general supervision and control over all programs, projects, services and activities of the city government;

WHEREAS, the Honorable City Mayor Edwin D. Santiago has communicated a letter-request for the enactment of an Ordinance declaring Moratorium on Amusement Tax in the City of San Fernando, Pampanga for the month of August 2020 to December 2020;

WHEREAS, the Sangguniang Panlungsod deemed fit to assist the business sector, including those in the amusement business, in this time of COVID 19 pandemic, by declaring a Moratorium on Amusement Tax for the month of August 2020 to December 2020 in the City of San Fernando, Pampanga.

Santos also denied any anomaly in the town's acquisition of several parcels of lands surrounding the town hall which, he said, "will eventually benefit the people."

Santos even said their critics' allegations that the parcels of land are not contiguous and are under "lis pendens" or have pending legal actions is not true.

He said there is even a bonus since the acquired lots will reach up to the end of the lot of the National Grid Corp. of the Philippines (NGCP).

"Atin yang bonus, miras ya keng dulu ning NGCP," he said, claiming that this will mean free additional parking space.

#### Suspect

Santos said he suspects that Vice Mayor Wong is reacting negatively to the land purchase because her brother's PTT gas station will be set for demolition because it encroached on the road.

Santos said with the lot acquisition, they will now have a space for a training center, a multi-purpose gym, and other necessary offices.

He disclosed that the office of the mayor plans to entice the Regional Trial Court (RTC) in Macabebe town to relocate in San Simon

dens, he said: "The ti- by offering them a portion of the land. This will be convenient for the RTC since it easily gets flooded in Macabebe while the location in San Simon is flood-free and is very accessible, he explained.

"The mayor has a lot of plans around the municipal hall," he added. Santos said there is

now an ongoing construction, an expansion of the municipal hall to better serve and accommodate the people. The new building has a budget of P5 million from the Capitol and 4th District Rep. Rimpy Bondoc.

"Because the present municipal hall building is quite small, more space is needed to accommodate and better serve the people," he noted.

Santos said with the plans of the office of the mayor and the progress now taking place in San Simon, big businesses are taking a second look at the town.

"The office of the mayor has received a lot of inquiries from big businesses like SM, Puregold, and Vista Land, just to name a few," he disclosed.

Santos said the proximity of San Simon to Manila and its strategic location make it an ideal location for investment.



# (DC launches 'Clark Bike Days'

CLARK FREEPORT – Bikers and cycling enthusiasts will now have a chance to rediscover the scenic routes in this Freeport as Clark Development Corporation (CDC) launches "Clark Bike Days."

In a Facebook post by CDC-Tourism and Promotions Division (TPD), the stateowned firm shared that Saturdays and Sundays will be dedicated as 'bike days' in the Freeport to welcome bikers and cyclists who would like to traverse and experience pedaling to various sites here.

The Prince Balagtas Road, which is also one of the designated routes for 'bike days', will be closed to motor vehicles every Saturday and Sunday except for FA Korea CC players and employees.

The "Clark Bike Days" activity will have morning and afternoon schedules. The morning program will be from 5:00 AM to 10:00 AM while in the afternoon it will commence at 3:30 PM and will end at 6:00

To ensure the protection and well-being of bikers and cyclists during the activity, safety protocols, and guidelines were also put in place. These include the utilization of QR codes for contact tracing purposes and other stan-dard health measures such as wearing of face mask, maintaining a safe distance be-tween bikers, and observing traffic rules among others.

Aside from its mission to encourage a healthy lifestyle and promote an alternative way of transportation, the provision of the 'bike days' program in the Freeport also aims to stimulate local tourism and recuperate from the far-reaching effect of the pandemic.

During a recent radio interview in Clark in Action, Melvin Fausto, coach of the Philippine Triathlon team shared that they are coordinating with CDC - TPD and Bases Conversion and Development Authority (BCDA) to make biking a part of the Tourism Recovery Plan in the Freeport.

"We met with CDC and also with BCDA, to make this a part of the Tourism Recovery Plan. So, we are going to make an event for this and of course, we're practicing the protocols as well. We would like to show that biking is safe in Clark even during this time of pandemic," Fausto said.

This Freeport has been one of the preferred routes for cyclists due to its safe, convenient, and accessible bike

paths and lanes established along the main thoroughfares of Clark. The provision of additional traffic signage and lights also assures a safe ride for bikers navigating the area. With these features, Clark continuously poised itself as a bikeable, walkable, green, and specifically resilient destination in the country.

Before the pandemic, the state-owned firm has approved the construction of bike lanes inside the Freeport following the increase in numbers of bike enthusiast here, including workers using the bicycle as their form of transpor-

It can be recalled that the regional office of the Department of Tourism (DOT), with several non-government organizations and CDC, also launched a 'bike tour' to promote Clark as a tourism destination featuring various historical sites and new tourist attractions here.

CDC has constructed the initial bike lanes along major roads here such as in M.A. Roxas Highway and Abad Santos Avenue. The bike path in Gil Puyat Avenue leading to Mabalacat Gate has also been set for completion.

# SBMA resumes P122.7-M perimeter fencing, road rehab projects

SUBIC BAY FREEPORT - The Subic Bay Metropolitan Authority has resumed the implementation of perimeter fencing and perimeter road rehabilitation projects designed to improve the security in this premier free port zone following the easing of Covid-19 restrictions in construction works.

SBMA chair and administrator Wilma T. Eisma said the projects were disrupted by the onset of the Covid-19 pandemic last March, but "are now

back in full force.

Eisma said the P69.7-million perimeter fencing project will cover the entire stretch from the Kalaklan Gate up to the Kalayaan Gate of the Subic Bay Freeport Zone, while the P53-million perimeter road rehabilitation project will run from the 14th Street Gate to the Kalayaan Gate.

"The two projects are complementary," Eisma said. "The fencing project will improve the security at the Freeport perimeter, while the road rehabilitation project will improve management of access along the

perimeter areas."

According to the SBMA Engineering Department, the seven-kilometer long perimeter fence project, which started on January 2 of this year, is now 53 percent completed.

It was previously scheduled to be finished by October 28 this year, but the delay caused by the Covid-19 pandemic has moved project completion to April 2021.

The project involves the installation of special load-bearing concrete blocks with the strength of 2,500 psi, SBMA project engineers said. It also includes clearing and excavation works, column and tie beam installation, block laying, and plastering works.

Meanwhile, the perimeter road rehabilitation project is now 11 percent completed.

Project engineers said it will address the deteriorating condition of the old perimeter road that separates the Subic Bay Freeport Zone from communities in the adjacent City of Olongapo, and improve drainage along the perimeter road
