

## **Misidentified 'owner' of RSC** plant files cyber libel vs. Tulfo

CITY OF SAN FERNAN-DO -- A former town councilor misidentified as the "cruel owner of Real Steel Corp" in social media posts by popular TV news anchor Erwin

Tulfo filed seven counts of San Simon and the of cyber-libel against the latter late Tuesday afternoon.

(RSC) here have been conducted by the Department of Labor and Employment and the local police to ensure the safety and welfare of the workers. Only recently, the local police even issued to the company a certificate of its compliance with mandatory drug tests among its workers as mandated by law.

"No [RSC] employees have been found positive of illegal drugs during random and regular drug testings," said Major Freddie Herry who issued the certification even as he belied allegations that "some workers were forced to sniff illegal drugs" inside the

steel plant premises.

Herry has since been relieved of his post as San Simon police chief, claiming that his relief was due to false accusations against him in the social media.

## 2 foreigners, 4 Pinoys recover from Covid-19

BAY FREE-SUBIC PORT---Two foreigners and four Filipinos are the latest patients to have been declared recovered from the coronavirus disease here after finishing their 14-days quarantine. This according to an update issued by Subic Bay Metropolitan Authority chair and administrator Wilma Eisma on Monday.

The recovered foreigners were both male, aged 37 and 43. The Filipinos comprised two females, aged 25 and 49 and two males aged 34 and 40 male.

As of Sept. 21, there were recorded 23 confirmed cases of Covid-19 among freeport residents, of which four are active cases and 19 recoveries.

As to guests and transients, on record as 14 confirmed cases, with 2 active ones and 12 recoveries.

Among SBMA employees, there were 17 confirmed cases, of which 12 are active and five recoveries.

## AC gov't launches facemask livelihood program; calls out Kapampangan designers for help

ANGELES CITY - In an effort to protect the environment and help some of its residents recover financially, Mayor Carmelo "Pogi" Lazatin, Jr. recently launched a facemask livelihood program. Lazatin said this pro-

gram aims to promote reusable alternatives for facemasks and Personal Protective Equipment (PPEs), while providing sustainable livelihood for marginalized sectors including solo parents, persons with disability (PWDs), stay-at-home parents, and women's groups. "Ngayong panahon pandemya, marang mi sa mga kababayan natin ang naapektuhan ang mga kabuhayan. Kaya minabuti naming simulan itong livelihood program na ito, na pwedeng-pwede nilang gawin kahit sa kanilang mga tahanan," Lazatin

shared.

Under the said program, Executive Assistant IV Reina Manuel explained, the city government will hire homebased 'mananahi' to produce reusable facemasks and PPEs.

"Each 'mananahi' would also be required to have their own sewing machine at home," Manuel said.

Meanwhile, all materials, such as fabric, bands, and thread shall be provided to the 'mananahi' by the city government and will be distributed and collected house-to-house by members of the Public Employment Services Office (PESO), Manuel furthered.

According to Irish Bonus-Llego, Ängeles City Economic Development Investment and Promotions Office (ACEDIPO) Officer-in-Charge, each 'mananahi' is required to produce 250 facemasks per week, and 20 PPEs per month.

PESO Officer Maria Rosa Teodora Basilio also shared that they will be paid P4 per facemask and P300 per PPE.

## Mabalacat City College has new president

MABALACAT CITY — The Mabalacat City College now has a new president in the person of Dr. Michelle Aguilar-Ong, the former executive director of the Nayong Filipino in Clark. Ong, who has a Ph.D in Public Administra-

Ong, who has a Ph.D in Public Administration, bested two other candidates for the position after the city government here conducted an official search for president of the government-owned educational institution.

According to city administrator Atty. Emmanuel Ignacio, the search is the first of its kind in Central Luzon. The MCC, meanwhile, is the  $5^{th}$  city college in the country to conduct such a scout.

The search started mid-July of 2020, and all applicants underwent public forum and panel interviews, while abiding by proper health protocols and procedures.

The final deliberation, Ignacio said, was conducted last September 11, via video conference. Just like any other search, it had a committee composed of representatives from different sectors including education, business, the Association of Local Colleges and Universities, Commission on Higher Education, and Civil Service Commission. The committee for the search for MCC president was composed of Dr. Irineo "Bong" Alvaro Jr., chairman, representing the business sector; Dr. Dolores T. Quiambao, representing Don Honorio Ventura State University president Dr. Enrique G. Baking for Education; and Dr. Raymundo P. Arcega, Association of Local Colleges and Universities executive director.

Ignacio said the three applicants were all qualified for the position based on their professional merits and achievements. However, after thorough deliberation, the committee adjudged Ong as the most qualified to run the MCC.

Ong, who was also a television host at a public and media affairs program of GNN TV 44 and part-time faculty member of the Graduate School of DHVSU, officially took her oath as the new MCCpPresident before Mayor Crisostomo Garbo on Sept. 18.

For his part, Garbo congratulated Ong for her appointment, giving her his full trust and confidence for quality education at MCC.

### No mere construct is Marcos' martial law

"THE PRESENT generation that is loud in its condemnation of Marcos never experienced Marcos. So that rant is directed at their construct of Marcos. Shouldn't they be studying Derrida and Lyotard more?"

San Beda Law Graduate School Dean Ranhilio Aquino falls flat on his snooty nose at this vain attempt at intellectual snobbery timed for the dead dictator's birthdate.

No scale of Derrida's Deconstruction, no scope of Lyotard's "postmodern incredulity towards metanarratives" can disprove – as they can only hopelessly dispute - that Marcos, and all that evil that outlived him, happened. What with thousands upon thousands of Filipinos as living testimonials.

Ğenerations of disconnect to the actual events are easily bridged by generations of those who were there. So, what stirred Aquino's pa-intellectual idiocy?

Or did he just show what really lies beneath the veneer of his burnished law graduate school dean construct?

No mere construct though is my own story of martial law. Here reiterated for the nth time is its beginning:

A SATURDAY. Up early for a "DG" discussion group – at the Assumption College in San Fernando.

Something uncanny, there is nothing but pure static on the radio. The usual though – light banter, small-town gossip among passengers – at the jeepney from somnolent Poblacion, Sto. Tomas to the capital.

Somethinguncanny, there are nonewspapers at the news stands. Only *komiks* are being hawked by ambulant newsboys.

At the Assumption bus, some sense of gloom, a foreboding of doom, guarded whispers among us students of something terrifying.

On campus, a disturbing quietude. Still, some two-dozen hardcore KM-SDK activists go on with the DG originally to finalize the agenda of the demo at the gates of Camp Olivas planned for Tuesday.

Marcos has declared Martial Law. First heard from a kasama with a brother in the military. The PC - Philippine Constabulary has been rounding known activists since last night. Not even pipsqueak of Makibaka, Huwag Matakot! heard.

Just then, a platoon of uniformed constables enters the campus. Enough for all of us to find any and all means out of Assumption except the main gate where, we presumed more PCs are posted, maybe even with machineguns.

Downtown San Fernando, in front of the town hall are 6X6 PC trucks, military fatigues are everywhere. Long hair is sheared not by scissors but mostly by bayonets and hunting knives.

Jumped on a passing jeepney, just in time.

when the destiny of humanity is at stake?

All gone holocaust! in а An early morning date with the neighbourhood barber the next day. After a long while, the sun burns my ears and nape again.

Lie low, really low. Take refuge in the rice paddies. In morbid fear of what tomorrow may bring.

So, what hath Martial Law immediately wrought?

Resumption of classes. By the main gate of Assumption College, the dreaded Black List is posted - names of activists who will not be re-admitted unless with clearance from the PC commander.

A piece of advice from my political science professor: "Don't go to the PC alone, they will just arrest and detain you, as they did to a number of your comrades. Bring somebody influential with you."

Apu Ceto So, whom am I to seek but my spiritual director and rector at the Mother of Good Counsel Seminary – the Rev. Fr. Paciano B. Aniceto. (I was not even a year out "on

probation" from San Jose Seminary then.) At the Pampanga PC Command beside the Capitol, Apu Ceto vouched for me as a character witness before a panel of interrogators, and then took my case to the provincial commander himself – the dreaded Col. Isidoro de Guzman who would later earn infamy in the Escalante Massacre in Negros.

Alone at the interrogation room, I was subjected to romanza militar at my every answer the berdugos did not take to their liking.

- "KM o SDK?"
- Wala po A smack on the head. "Name? Alias?"

Caesar Lacson y Zapata. Nickname: Bong. No alias – A slap on the face.

*"Ikaw si* Carlos. *Di ba ikaw itong nasa mga letrato* (shoving to my face a number of photographs of marches, rallies and demos)"

Kamukha ko po - the table suddenly kisses my face.

Then off to the detention center at the side of the command. At each single cell, the sergeant -Pascua or Pascual? - shoves my face between the iron bars and asks the detainee: "Kasama mo ito?" and then turns to me: "Kilala mo yan?"

Of course, we knew one another but no one ratted out. Conscientization most manifest there.

Contusions and all, I managed to be remanded to the custody of Apu Ceto. I have written this and I write it again: The good father, in what could only be deemed as a leap of faith - in his God unquestionably, in me too, maybe - signed a document that said in part, "...in the event that subject activist-provocateur renew his connection with the Communist Party of the Philippines and its various fronts in the pursuit of rebellion; or undertake acts inimical to peace and order, or in gross violation of the provisions of Proclamation 1081 and other pertinent decrees, the signatory-custodian shall be held responsible and as liable ... " with a proviso that in my stead, he would be placed in the PC stockade. Did he tell me to change my ways? Did he impale in my conscience the gravity of my case, his implication in any instance of carelessness or recidivism on my part thereon? No. From the Constabulary command, his mere request was for me to please accompany him to church. Before the Blessed Sacrament, he knelt and silently prayed. He did not even ask me to pray with him. He just motioned me to sit near him. By the side of the good father, in that darkened corner of the Metropolitan Cathedral, I wept. Washed by a torrent of tears was my PAGE 5 PLEASE

My long tresses – down to my shoulders and back - saved for the day.

Proclamation 1081 – declaring Martial Law in the Philippines though dated September 21, 1972 came into the open in September 23.

Martial Law! The news is out - even in barriotic Sto. Tomas. Arriving home, in time to see my mom stoking the last flames flickering on a mound of ash that used to be my beloved Communist Manifesto, Das Kapital, Lenin's thoughts in volumes of pamphlets, Mao's The Five Golden Rays and the Little Red Book, Amado Guerrero's Lipunan *at Rebolusyong Pilipino,* posters of Che Guevarra, Marx, Lenin, and Mao.

In between tears, a jumble of Marx-Lenin-Mao thoughts – *The history of all* hitherto existing society is a history of class struggle ... Capital is dead labor, that vampirelike, only lives by sucking living labor, and lives the more, the more labor it sucks...The way to crush the bourgeoisie is to grind them between the millstones of taxation and inflation ... Trust the masses, rely on the masses, learn from the masses...The people, and the people alone, are the motive forces of history...

And Che's mind too: What do the danger and sacrifices of a man or a nation matter,







## Ninoy's yardstick

THE LATE Senator Ninoy Aquino had a simple yardstick of a true leader. He must not only be brilliant, he said, but he must also have a heart. Cabeza y corazon, his close ally in Zamboanga City, the late Mayor Cezar Climaco, would have put it in his native tongue.

That was his parting and final message to members of his Senate staff who saw him at his modest house in Times St. in Quezon City. It came shortly before he departed for the United States on self-exile.

He was allowed to leave the country at the behest of no less than then First Lady Imelda Marcos. She visited him at the Philippine Heart Center where he was confined due to a heart problem sometime in 1980. And he was nonplussed, charmed and openly grateful.

Undoubtedly, he had Ferdinand Marcos in mind when he said that. That Marcos was an exceptionally brilliant mind was not lost on his principal political nemesis at the time. He was, after all, a bar topnotcher who conducted his review of the law while incarcerated for a crime he was later acquitted of. The timely intervention of a Laurel patriarch saved the day, out of compassion that it would have been sheer waste to put behind bars such an intelligent young man.

Apparently, Ninoy felt, as did other Philippine leaders at the time, that something was missing in the brilliant president that yoked the nation under martial law. Under martial rule, the Philippines suffered widespread human rights violations, slid into economic chaos and ignited social unrests never seen before. Rapacity and plunder were common pejoratives that characterized the dictatorial regime.

For Ninoy, it was a heartless regime. Former Singapore Prime Minister Lee Kuan Yew remarked once that Marcos may have started as a hero but ended up exactly the opposite when he left power or when power deserted him.

The historical wrongs committed by Marcos are what's driving the frantic moves at historical revisionism by pro-Marcos and pro-Duterte cabals, which could also be one and the same thing. The agenda is clear as day: to resurrect Marcos as a hero that he was not. Apparently, the former dictator's burial at the Libingan ng Mga Bayani is consistent with this effort but not enough.

So, the next step toward the goal is to declare a local holiday for Marcos in his native province of llocos Norte. If, or when, this is achieved, a national day for him, on his birthday or on the anniversary of martial law should be part of the unfortunate logic. Who knows all this could happen under Duterte's watch.

Now comes former House Speaker Pantaleon Alvarez who has scored the Duterte Administration for its failure in addressing the

COVID 19 crisis in the country. Alvarez is a Duterte ally who has fallen out of the president's grace.

Pantaleon was politely oblique and less straightforward in pointing at the cause of the failure. The next president, he said, must have brains. You get the drift.

Between Marcos and Duterte, the choice is no brainer as who has more gray matter between the ears. One was a bar topnotcher, the other, well, was probably number 11 as all of those who didn't make it to the top 10 were.

But Marcos would not have slapped the virus even if that were possible, peed on Taal volcano or ate its ashfall, recommended the use of kerosene to disinfect face mask, suggested spraying the whole country or Metro Manila with pesticides to rid of the deadly bug, or bristled ridiculously at Leni Robredo's criticisms.

He would have been guilty of all other crimes, except the above. All this would have been beneath him. That was the brilliant part Ninoy, in all probability, had in mind. Alvares deductively referenced the alleged failure on the COVID crisis on the need for a brilliant mind in Malacañang, a reverse Descartes, in way.

If Marcos had brilliance except a heart, what's missing in Duterte apart from brilliance, as Alvarez had glossed over?

Both probably have a heart in the literal sense, but as the Scriptures has a caveat: it is the most deceitful of all things. The problem is not physiology but psychology.

Let's count one way. Juan Ponce Enrile, then Marcos' defense chief, assured Ninoy that he would not be arrested. He was, the day or night martial law was declared. Alan Peter Cayetano, Duterte's Speaker of the House, assured that ABS-CBN would not be shut down. The network is close, for all intents and purposes, forever and ever if his patron's wish is granted.

As of this writing, Duterte is set to speak before the General Assembly of the United Nations on a number of issues besetting the country, first, and the world, second. Expect hubris to influence content.

Much of the nation waits (perhaps not, on second thought) with bated breath what Duterte will say or not say. Or whether his speech will show a man of intelligence or without it, a man with a heart or someone who needs one badly.

If he were alive today, Ninoy would probably say a mouthful of nays. Certainly, not the "pambihira" comment he was wont to utter out of frustration.



into "administrative violations" that could have been committed by the RSC management, not-"minor offenses" ing during a recent inspection.

This, even as it clarified that 42 laborers earlier reported to have been rescued were in fact allowed to freely leave the steel plant after they filed their resignation.

"It was just a miscommunication and wrong angling of the story by a media entity from Manila," DOLE Region 3 director Maria Zenaida Angara-Campita was quoted as saying in media reports. "They were actually prevented to go out of the factory compound because of the quarantine protocols and lockdown and health concerns.

Campita noted that there are over 400 workers at the RSC manufacturing plant, but only 42 of them voluntarily resigned due to "homesickness" after a six-month lockdown imposed by the company to prevent its workers from contracting the coronavirus.

She cited the company paying more than the minimum daily wage,

with laborers receiving P750 to P850 per day.

#### Deceived

Stranded in Pampanga, the resigned workers are reported to be appealing to RSC management for reinstatement claiming that they were "deceived by a former employee who spread baseless and unfounded stories" about the com-

"Hindi po perpekto ang Real Steel pero sinisiguro po namin na tuloy tuloy and pag improve ng aming sistema at pamamalakad," Chua said in a statement read

to reporters by one of his staff.

RSC general manager Melodie Arellano reiterated her strong denial of allegations of maltreatment and illegal detention of their workers, clarifying that they were prohibited to go outside of the compound due to health concerns "and nothing else."

Chinese national in one of the social media posts with caption "Chinese national pinipilit ang mga empleyado magshabu, ginagawang target practice at binubugbog,"said Tayag in his complaint affidavit filed received by Atty. Chito Pantaleon, provincial associate prosecutor and investigating prosecutor.

- SATURDAY Tayag's complaint against Tulfo is only the first of what appears to be a series of legal actions against the media 2020 • MONDAY personality.

The management of Real Steel Corp. is reported to be preparing separate complaints of multiple counts of cyber-libel against Tulfo and a certain Joey Gumana, the alleged source of "malicious" information of the news anchor.

According to RSC legal counsel Jose Mari C. Lacas, pieces of evidence have been gathered against the duo alleged as "responsible behind the lies and baseless accusations posted on social media against the steel manufacturing industry."

"Tulfo's multiple posts including allegations of maltreatment and other accusations against the owner of RSC have been found to be baseless and false," said Lacas.

In his Sept 10 and 11 posts on Facebook, Tulfo said some of the employees at RSC are being maltreated and were made as target practice by the Chinese owner and forced to sniff shabu before reporting to work.

He also said that the RSC owner would be facing multiple criminal charges in court including human trafficking, violation of the immigration laws, and serious illegal detention as complained by the workers who, he noted, were prevented from going out of the steel factory for six months.

Earlier, the Central Luzon office of the Department of Labor and backed Employment, by the town police visited the RSC to check the condition of workers and at the same time conduct investigations on

the allegations made by Tulfo on his social media page

"The workers were not locked-up, they were not allowed to go out and accept visitors to protect them from the coronavirus," said DOLE-3 director Maria Zenaida Angara Campita in a phone interview, adding that RSC intention is good to prevent its employees from contracting the coronavirus disease.

Campita said the workers voluntarily resigned and were not rescued as earlier reported in other media outlet.

The local police also issued certification citing that RSC workers and their workplaces are drug-free.


