# In 126 days of quarantine: Capitol nets P290-M quarry revenues

CITY OF SAN FERNANDO – Not even in this community quarantine period amid the coronavirus disease pandemic could stop Pampanga from generating revenues out of Mount Pinatubo's "vomit" of sand and gravel.

This, despite the zero income during the suspension of quarry operations from March 20 to May 17 when the province was put under enhanced community quarantine, and later under modified ECQ.

From May 18 to Sept. 20, with the easing of quarantine protocols, a total of P289.6 million was added to the provincial coffers. This brought to P730 million the total quarry collections under the administration of Gov. Dennis "Delta" Pineda that started in July 2019, according to provincial administrator Atty. Charlie Chua.

The revenues consisted of quarry collections, weighing scale fees, fees on sand and gravel permit, accreditation of motor vehicles and heavy equipment, and fines and penalties.

September recorded the highest collection, totaling to P68.402 million, per the report of the Kapampangan a Lulugud at Matapat (KALAM), the provincial quarry regulatory unit headed by former Bacolor Mayor Buddy Dungca.

With the general community quarantine and subsequently moderate GCQ imposed in greater areas in Metro Manila as well as the rest of Luzon, the construction industry appeared to have rebounded, spiking the demand for sand and gravel.

"The quarry sector is contributing a big part to Capitol's local income. Governor Delta has thanked quarry operators and haulers for their support by paying tax and fees, which are being used in our Covid-19 responses and regular programs and projects," Atty. Chua said.

Per the Local Government Code of 1991, a part of the quarry revenue, in this case the P250-quarry tax per truck, is shared on a 40-30-30 percent allocation among the barangay, town or city, and the Capitol. **With Pampanga PIO** 

# **Pre-registration for nat'l ID system starts in CSFP**

CITY OF SAN FERNAN-DO – Pre-registration for the national ID system started here Monday with the Philippine Statistics Authority and the city civil registry office collecting names, ages, and other demographic information of residents.

This is pursuant to Republic Act 11055-- "An Act Establishing the Philippine Identification System" mandating a single official ID interconnected with all other IDs issued by the government be issued every Filipino.

The pre-registration however will cover only some five million heads of households all over the country identified in the "Listahanan" program of the Department of Social Welfare and Development, the PSA said.

The city has been designated as pilot area for the pre-registration along with other cities and towns in the initially targeted 32 provinces.

"Prayoridad na maparehistro ang mga low-income household heads upang mapadali ang pagbubukas nila ng bank accounts para sa pagtanggap ng tulong mula sa pamahalaan at upang maiwasan ang pandaraya," explained PSA in its official website.

It added that the national ID system is aimed at "facilitating the delivery of government services, strengthening social protection and financial inclusion, and advancing the Philippines' shift towards an inclusive digital economy."

For the city, targeted for pre-registration are 28,590 individuals.

"Dalawang indibidwal bawat isang pamilya ang ating target. Mayroon po tayong kabuuang 14,295 target families sa lahat ng barangay kaya umabot sa 28,590 ang kabuuang bilang ng indibidwal na maisasama sa ating pre-registration activity," explained city civil registrar Rimando Umali.

Barangay San Jose has the largest number of expected registrants with over 2,800 prioritized households, he said.

Pre-registration procedures comprise the submission by the surveyed individual of his/ her personal information, including full name, address, date and place of birth. A PSA-issued birth certificate or any proof of identity must also be presented.

"Ang pre-registration po, kung saan kinukuhanan natin ng impormasyon at binibigyan natin ng appointment ang mga indibidwal, ay susundan ng registration proper. Pagkatapos nito ay maghihintay ng isang linggo o higit pa ang isang indibidwal bago makuha ang ID, through pick-up o maaari ring i-deliver sa kanila," said PSA Pampanga Registration Officer II AJ Kevin Samson.

The pre-registration process will pave the way for actual registration starting Nov. 25, which will involve collection of biometric information, PSA Assistant Secretary Rosalinda Bautista said in a recent radio interview. –*CSFP-CIO*

Eisma said the agency has recently given its go-signal for Autokid Truck Solutions to create a line of public utility buses that will utilize an automated fare collection system (AFCS) and be compliant with social-distancing rules as well.

"This is an innovative concept that fulfils a felt need in this time of the pandemic, so we're going for it," Eisma said.

"With this, we can minimize the dangers of virus transmission, thus creating a better environment for workers, residents and visitors in the Subic Freeport," she added.

According to Autokid Subic Trading Corporation CEO Kevin passengers to use public services instead of private vehicles," Yao said.

"This preference reduces traffic, air and noise pollution, and accident rate in cities," he added.

Foremost among the features of the new system is the use of loadable payment cards that would preclude the need for passengers to carry cash for their bus fare.

Yao also stressed the added advantage of predictable travel time, as the firm would regularly deploy vehicles at a certain time period so that the public would know exactly when to expect the buses.

The company has proposed three bus routes in Subic's Central Business District. One will be from Kalaklan Terminal to Main Gate Terminal and vice versa, another from Main Gate Terminal to Royal Duty Free and vice versa, and the third from Main Gate Terminal to Kalaklan to Royal Duty Free to Main Gate.

The proposed fares will be P25 per person for the first two routes, and P30 per person for the third route, which is longer.

The SBMA and the company are already discussing a dry-run of the routes for which the buses will be fielded to see how the plans would actually work out.

Yao also pointed out that Autokid will field environment-friendly buses that are Euro IV-compliant, using Yuchai engines. He added that the units will be equipped with comfortable seats, air-conditioning, a global positioning system (GPS), and closed-circuit television camera (CCTV) to ensure the safety of the riding public.

Following the approval of Autokid's proposal last month, the SBMA had required the firm to register its fleet of motor vehicles and have its drivers accredited by the agency.

# Coca-Cola's Balik Pinas program helps OFWs to restart back home

"I WAS suddenly jobless, and during a global crisis. I worried about supporting my family," says Carlos Manzano, 43-year-old breadwinner for a family of two. "I really didn't have any plans for when I returned to the Philippines especially since I was an OFW for almost a decade."

Carlos had been working as a company messenger in Qatar for eight years—until the COVID-19 pandemic shook the trajectory of his career and, consequently, the well-being of his family. Carlos shares that he had just planned for a short visit to his loved ones back home in the Philippines when his company carried out company-wide layoffs. "I couldn't have known," Carlos shares, "that my short trip would be a permanent one."

Carlos and his brother Jazz, who shared the same fate as his, returned to the Philippines. Their livelihoods were casualties of the pandemic: their future, and that of their families, was marked by uncertainty. Their outlook mirrored those of the 180,000 overseas Filipino workers (OFWs) repatriated due to the pandemic and the numerous crises it gave rise to.

#### <u>A ROAD TO</u> <u>A NEW START</u>

With parts equal determination, resilience, and unflagging hope, Carlos, Jazz, and their father Lito-who himself had been an OFW for eighteen years-set up a beverage distribution business called Naga Jac Beverages Trading in their hometown of Naga. But, as with any new business venture, the family's optimism was tempered with anxiety over how it would all turn out-especially during such tenuous times.

their warehouse, however, a perfect opportunity to succeed presented itself in the form of the *"Balik Pinas Program* of Coca-Cola", which was offered to the Manzano family by Carlos Rivera, the Territory Sales Manager of Coca-Cola Beverages Philippines, Inc. (CCBPI) in Naga City.

was able to rise up from being a simple janitor to a sales manager in Brunei," says Billy. "I had the confidence and the experience; I told myself I didn't need to worry too much."

### Cayetano unclothed

"THE EMPEROR has no clothes. Even if he continues to act as Speaker, the body does not follow him [anymore]. Sir, hindi na po kayo ang Speaker."

So spake Seputy Speaker and Pampanga 4th District Rep. Juan Pablo "Rimpy" Bondoc Tuesday hours ahead of the House special session called by President Duterte with the embattled Taguig Rep. Alan Peter Cayetano still insisting he remained as Speaker.

"I have seen many speakership battles. The opposing camp that doesn't have the numbers have graciously accepted it and found a way to work with the majority. Let us put off the charade and work for the Filipino people," said the multiple termed congressman.

On Monday, Marinduque Rep. Lord Allan Velasco was elected as the new Speaker by a majority vote of 186 House members in an informal session at the Celebrity Sports Plaza in Quezon City.

Cayetano called Velasco's election "fake," saying the proceedings were conducted "illegally" outside the Batasang Pambansa.

His camp promptly came out with a "manifesto" of support for him purportedly signed by a total of 200 representatives. lawmakers—Maguindanao's Two Esmael Mangudadatu and Zamboanga Del Sur's Divina Grace Yu—whose signatures appeared on the manifesto as promptly denied having signed it.

"It was a bad breakup. Let us all be adults here," Bondoc said.

Of the disparity in numbers, Bondoc said: "There are 186, and 120 were physically present. There are many others who told me they would have voted to [for Velasco] if they had a chance. We will release [the list of those who voted for Velasco]."

Which has come now to be moot, with Cayetano tendering his "irrevocable resignation as the speaker of the House of the Republic of the Philippines" on Facebook Live Tuesday.

As much moot, alas, was Cayetano's resignation itself - coming as it is after being already veritably and ignominiously ousted from his seat.

In Cayetano, the emperor had no clothes, indeed. Shedding all of them in his naked attempt to hold on to power. Personal honor and public welfare be damned.

DEAR GRADUATES, I am sure there has never been a graduation like yours in the whole history of the Ateneo. This must be the first time in history that the university is holding a virtual graduation like this, by force of our present circumstances.

The Covid-19 pandemic has been a humiliating experience for all humankind. It has made us realize how vulnerable we really are, in spite of all the scientific and technological advances that we have achieved in the past century. We're not even talking about an asteroid colliding with the planet earth. We're just dealing with one microscopic viral mutation that is enough to put all of us in a defensive mode and force us to hide like rats in our homes.

We were aware of the concept of quarantine for the sick, but never in our wildest dreams did we think that there would ever be a time when whole populations would need to be quarantined, as a desperate measure to stem the tide of a pandemic.

Nations around the world, including global powers, have called for lockdowns, paralyzing transportation, commerce and trade, causing business bankruptcy, massive unemployment, and the consequent the collapse of global and national economies. Suddenly, we all find ourselves in a state of uncertainty about the future.

I never thought that the Biblical narrative of a tenth plaque, about hapless Hebrew slaves waiting for the passing angel of death would one day become real. And we're not just talking about one night of Passover; we're talking about practically more than a whole year of waiting, of desperately trying to protect the vulnerable ones among us, hoping against hope that we can finally find the cure and the vaccine that will protect us from this dreadful disease. As of this writing, more than 32 million people around the world have been infected, and around a million of them have died.

Will we ever be able to get back to normal, to the way we lived our lives before this pandemic? I do not mean to be pessimistic, but I dare say prophetically that humankind will look back to 2020 as the year when the world got infected by a literal virus, experienced a system breakdown, and had to be put on a reset mode.

Hey Jude There is a song that became popular in my younger years that suddenly makes sense to me now. It says, "Hey Jude, don't make it bad, take a sad song and make it better." It is what we are being called to do now-not to go back to our old ways, but to make things better. We can turn this crisis into an opportunity, only if we have the humility to admit our foolishness, to change our wasteful, abusive and egotistic ways of dealing with our environment and with one another. Unless we get to reconfigure our economic and political systems in ways that are more mindful of the common good and the good of the planet earth, we cannot turn this breakdown into a breakthrough. It is ok to let go of old habits. As the song also says, "Don't you know that it's a fool who plays it cool by making the world a little colder." No, we can make things better. Among the many great mentors that I had in the Ateneo, there is one who still stands out in my consciousness, 42 years later: Fr. Roque Ferriols. He was the one who taught me to keep asking the question, SINO AKO? ANO ANG LAYUNIN KO SA BUHAY? In my whole college life, I never listened to a lecture as intently as I listened to Fr. Ferriols. I remember how he opened his course in Pilosopiya ng Tao with the Filipino saying, "Madali ang maging tao, ngunit mahirap ang magpakatao." Then he asked, "Ano ang kahulugan ng MAGPAKATAO?" Si Fr. Ferriols and nagmulat sa akin tungkol sa tunay na hangarin ng edukasyon, ang MAGPAKATAO. Tandang-tanda ko pa nang tanungin niya kami, "E ano kung makapagtapos ka ng kolehiyo sa Ateneo? E ano kung sumikat ka, yumaman, o maging makapangyarihan sa lipunan? Ano ang kinalaman ng lahat ng ito sa tanong na SINO AKO? at ANO ANG LAYUNIN KO SĂ BUHAY?'

the objective is to develop our multiple human INTELLIGENCES and their application in the various careers and fields of human endeavor. As members of the human species we distinguish ourselves from the rest of our fellow creatures as intelligent beings, hence we refer to ourselves as "HOMO SAPIENS," TAONG NAG-IISIP.

We think of our capacity to develop our rational intelligence as our most significant advantage over all other species in the course of evolution, that it is what makes us superior to all other creatures, including the prehistoric dinosaurs that got wiped out by a climate change.

But have you ever thought of the possibility that the very thing we consider as our strength could also be our weakness? Is it not the same intelligence that enables us to monopolize, control, to manipulate, to dominate, to systematize cruelty, exploitation and to oppression, violence and murder? The Israeli historian and public intellectual, Yuval Harari, published a widely acclaimed book entitled Homo Sapiens. He calls Homo Sapiens the most dangerous and most destructive species that ever lived on planet earth.

#### Hubris and nemesis

The other teacher who also had a profound influence in my formative years in the Ateneo was the American Jesuit, Fr. Joseph Galdon, whom we called Fr. Bob Hope. Yes, he was a splitting mage of the famous comedian, Bob Hope. I remember learning two important Greek concepts from Fr. Galdon in my subject in Classical Greek Literature: HUBRIS and NEMESIS. Roughly, their equivalent terms in English would be ARROGANCE and DOWNFALL.

I also learned how these two terms were related to each other. In Greek mythology, hubris refers to the excessive pride that supposedly offends the gods and is the common cause for human downfall. Nemesis, on the other hand, stands for a mythological deity—the god of retribution, the one who is ready to strike down those who are afflicted with hubris.

In the Bible, we also hear about the interrelatedness of hubris and nemesis, such as in Proverbs 16:18 where we read, "Pride goes before destruction, and arrogance before a fall."

Hubris is the most common pitfall of human intelligence. It makes you understand why God had to warn Adam and Eve about the toxicity of the Tree of Knowledge of good and evil. It is not knowledge itself that is poisonous but the power that it brings. It is like the ring in Tolkien's Lord of the Rings; anyone who wears it becomes delusional. Ironically, it is when we become excessively proud that we actually turn stupid and find ourselves on the path of selfdestruction. Today I suggest that you take time to read Psalm 90 and take its reminder seriously. It says, "You turn us back to dust, and say, 'Return, o mortal!' A thousand years in your eyes are merely a day gone by, like a watch in the night. You sweep them away like a dream; in the morning they spring up like grass, but by evening they wither and fade... our life is over like a sigh. Seventy is the sum of our years, or eighty, if we are strong; Most of these are fruitless toil; they pass quickly, and we are gone... Teach us to number our days aright, so that we may gain wisdom of heart...' I think the Homo Sapiens survived and dominated the world after the dinosaurs, not because of our big brains but because of our big hearts, our capacity to express care, solidarity with and compassion for each other, our capacity to love, to build family, community and a humane society. 

Dawn also stressed about women being objectified.

"Men should stop objectifying women for their own sexual gratification. Just because a woman shows a little bit of skin or wears makeup, doesn't mean it is an invitation to be sexualized or have unwanted attention towards them

"There is a serious problem with our society if we accept that it is ok for men to objectify and exploit women, it says so much about our mental capacity and moral values. It is never ok to touch someone without their consent. Men are not entitled to women's bodies married or not."

Dawn is among the celebrities who are against the rape culture in the country. She also hates the idea that it's women's fault when they are harassed.

You should take responsibility [for] your actions. If you think I'm sexy, thank you very much. If you feel tempted because of what I wear, that's your problem and not mine. I can wear whatever I want to wear."

On the other hand, Dawn also supports the women empowerment and the right way to educate the youth of sex education.

Sex is part of life. Teach young children how to protect themselves instead of telling them NOT to have sex at all. Sex is not just having a sexual intercourse. It is also discussing about proper hygiene and a lot more. Children must be taught so they grow up informed." she explained.

### EdSa greens JASA with 23,000 plants

CITY OF SAN FERNANDO -- "Planting trees is a way of protecting the environment, and protecting the environment is a way of prolonging one's life." Talking green, Mayor Edwin "EdSa" Santiago has spurred the city government to intensify its urban greening program along the Jose Abad Santos Avenue here.

Starting Tuesday, the city environment and natural resources office has been planting 23,000 different species on the median strip of the busiest thoroughfare in Pampanga.



The San Fernando stretch of JASA is the city's business center, hosting major commercial establishments such as car dealerships, banks, a hospital, restaurants, bus terminals, gas stations, home improvement supply depots, even a school.

Santiago cites the need to balance economics with the ecology: "Ang pagtatanim kasi ay isang paraan upang ma-balanse natin ang kalagayan ng ating kalikasan. Habang nagtatayo tayo ng mga modernong imprastruktura, habang inaangat natin ang ating ekonomiya, at habang dumadami ang bilang ng mga sasakyan, kailangan hindi nakakalimutan ang kalikasan."

With the greening of JASA, air quality in the area is expected to be improved.

"Ang pinaka-goal ng ating aktibidad ay mabawasan yung epekto ng climate change sa siyudad at ma-improve yung air quality. Alam naman natin na yung papel ng mga halaman sa ating kapaligiran ay mag-absorb ng mga toxic gases," said city environmental management specialist Juliuzar Pasion.

Pasion said 1.5 kilometers of the median strip of JASA will be planted with shrubs and bushes, including hibiscus varigata, golden pandacaqui, green pandacaqui, golden miagos, pandanus, dwarf camoning, and lemon top.

City-based Wilson's Instant Tree Bank, a partner of the city government in its urban greening program for the past years, has been tapped anew for the JASA greening.

"One of our main objectives sa Wilson's is to provide support sa mga urban greening programs ng mga local government units, kabilang na ang San Fernando. We are glad na nakuha natin ang proyekto dahil magagawa nating matamasa yung ating misyon na maipalaganap ang environmental protection, tree planting, at greening efforts," said owner and manager Benson Aboujafari.

### Economy to open despite risk, Galvez says Covid can be KO'd

Gov. Albert Garcia and Mariveles Mayor Jocelyn Castaneda.

"We can beat Covid, we can knock out Covid for as long as we obey the minimum health standard. Kaya natin ito," he said.

He made himself as an example being exposed to the danger of contacting the dreaded disease but having his immune system strengthened. "I think we can beat this virus if we can protect ourselves," the secretary said.

He was all praises for the governor and the mayor in their fight against Covid-19. "Para maging successful ang isang local government unit, very prominent is leadership. Kaya makikita natin why in Bataan it is so low in active cases. This is because of the leadership of the governor," Galvez said.

He said that Castaneda almost shed tears because of the surge more than a month ago of the virus in Mariveles: "A municipality with 800 cases napakahirap but she was able to manage and bring it down to 120. Napakalaki ng nagagawa ng leadership.'

Bataan, he said, has brought Covid- 19 active cases down to almost 300, very low number compared to many places in the country.

He said that his team will study the "kindness station" of Castaneda and the "kusina sa barangay" as well as the free hospital billing of Garcia in helping constituents in the fight against Covid-19.

He said these are good innovative practices worth-copying.

Turning to the need to open the economy, the secretary said "may potential na malaki ang Bataan to contribute to our economy because it is an economic zone. Sa ating Phase 3, we need to open up despite the risk. We cannot lock down anymore because for every lockdown, malaki nawawala."

"We have to concentrate on prevention and detection. The 85 percent of our work should be dedicated to prevention. People have to protect themselves to protect their livelihood and the economy," he noted. "Beat the virus and

open the economy. If we will not open our economy, we will die from hunger. Mas marami namamatay sa ibang sakit kesa Covid. We cannot survive without our economy," Galvez added.

He urged local government units to identify and appoint their own prevention, detection, testing and isolation czars to efficiently delegate responsibilities.

He said that one of the best practices of Bataan was its aggressiveness in terms of testing and isolation. Galvez considered testing very important, the virus being an unseen enemy. He said that testing and contact tracing are good weapons in the fight against the virus.

The governor said that he met Galvez more than a month ago when Bataan was problematic about the surge in Covid-19 cases.

"Nag-alok noon ng tulong si Secretary Galvez tungkol sa biglang paglobo ng virus sa Bataan at sa Mariveles at nangakong dadalaw. Pero nagagalak akong sabihin sa inyo na malaki na ang ipinagbago since that time," Garcia said.

Per Monday night report of Dr. Rosanna Buccahan, chief of the provincial health office, Bataan has 2.552 confirmed Covid-19 cases with 329 active, 2,176 recoveries, and 47 deaths. There were seven new confirmed cases and 12 new recoveries.

of the Xevera township in Barangay Tabun here Saturday.

Delfin Lee, president of GARHC, was on hand to "monitor" the event which he said was part of his commitment to Xevera Mabalacat home buyers since its inception in 2009.

He attributed this to the affordability of the units which are all ready for occupancy inside the Clark special economic zone.

"Nagpapasalamat ako hindi sila nagpabuyo, ang iba kase nag-file ng kaso e wala naman kaso. Inabot tayo ng maligno," he said. Lee, now 64 years old, said he wants the Xevera townships community to get back to their former glory.
