New SFEX road opens to motorists from December 28 to January 15

STARTING December 28 and until January 15 next year, the new and expanded section of the 8.2-km Subic Freeport Expressway (SFEX) will be opened temporarily to serve motorists coming in and out of the Subic Bay Freeport Zone during the holiday season.

Department of Public Works and Highways (DPWH) Secretary Mark A. Villar along with Subic Bay Metropolitan Authority (SBMA) Chairman and Administrator Wilma B. Eisma and NLEX Corporation President and General Manager J. Luigi L. Bautista, led the drive-thru of the new expressway lanes built to improve traffic flow and road safety.

The new SFEX road, constructed beside the existing SFEX carriageway, will be available to motorists on December

28, 2020 until January 15, 2021 from 6:00 am to 6:00 pm. During this period, it will be closed from 6:01 pm to 5:59 am the next day for the continuing construction of remaining works.

4 LGUs in CL among most competitive in PH

CITY OF SAN FERNAN-DO -- Four local government units in Central Luzon made it to the top three spots in separate categories for the most competitive cities and municipalities nationwide.

Malolos City earned the top spot for the Most Improved Component Cities, while Baliwag town in Bulacan bested other 1st to 2nd class municipalities in the country in terms of infrastructure.

Baliwag also ranked 3rd in overall competitiveness, 4th in terms of government efficiency, and 6th in resilience and economic dynamism.

Baler in Aurora was ranked as the 3rd among all 3rd to 4th class municipalities in the country in terms of overall competitiveness. It also ranked 3rd in terms of infrastructure while it ranked 6th in terms of economic dynamism.

Sta. Maria town in Bulacan garnered the 3rd spot among 1st to 2nd class municipalities in the country in terms of economic dynamism. It also ranked 5th in overall competitiveness.


Department of Trade and Industry regional director Judith Angeles said the ranking is based on the results of the 2020 Cities and Municipalities Competitiveness Index (CMCI), which shows economic development and competitiveness indicators among local government units.

"All participating LGUs were assessed based on four pillars namely economic dynamism, government efficiency, infrastructure, and resiliency. CMCI is developed by the National Competitiveness Council through the regional competitiveness committees with the assistance of the United States Agency for International Development," she explained.

Aside from these LGUs, other Central Luzon towns and cities included in the top 10 in different CMCI categories were Bacolor, City of San Fernando, and Sta. Rita in Pampanga; Marilao, Baliwag, Sta. Maria, Angat, Bustos, Bocaue, Paombong, Malolos, and San Jose Del Monte City in Bulacan.

Also in the ranking were Talavera and Cabanatuan City in Nueva Ecija; Tarlac City; Subic and Olongapo City in Zambales. -- By Marie Joy S. Carbungco/PIA-3

Holiday sting in AC nets P5.4-M shabu, 3 suspects

ANGELES CITY – Police seized P5.4-million worth of shabu and arrested three suspected "notorious" drug peddlers in a buy-bust operation in Barangay Ninoy Aquino here Saturday evening.

Some 800 grams of shabu packed in 11 heat-sealed transparent plastic bags with an estimated Dangerous Drug Board value of P5,440,000 were confiscated from the suspects along with the P5,000 marked money, said city police chief Col. Rommel Batangan.

Batangan identified the suspects as Noraden Naser Ariray of Barangay Ninoy Aquino, whom he described as a "high-value target," drug watch-listed Roberto Angeles Carbungco of Barangay Lourdes Northwest, and Anthony Quitalig Bonifacio of Bamban, Tarlac, who had been jailed previously due to illegal drugs.

Appropriate charges for violation of Sections 5 and 11 of Republic Act 9165 (Comprehensive Dangerous Drug Act of 2002) are now being prepared for filing in court against the suspects, who are now all locked up in jail, according to Batangan.

"Through our revitalized anti-drug campaign in line with the directives of our chief PNP Gen. Debold Sinas, along with the support of the community even during this pandemic, we continue to yield positive results," Central Luzon police director Brig. Gen. Valeriano De Leon said in a statement on the successful police operations.

He asked the support of the public in their campaign against illegal drugs.

"As we keep on working double time to stop the proliferation of illegal drugs in the region, we also urge everyone to help us in our campaign against illegal drugs," De Leon said. –*With media reports*

DBP bags int'l award for first ASEAN bond issuance

STATE-OWNED Development Bank of the Philippines (DBP) was cited by a renowned international multi-media firm for its bond issuance last year, which was aimed at raising funds to bankroll projects on the environment and financial inclusion, a top official said.

DBP President and Chief Executive Officer Emmanuel G. Herbosa said the bank's maiden issuance of ASEAN Sustainability Bonds, amounting to P18.125-billion, won as Best Sustainability Bond – Financial Institution in The Asset Country Awards 2020 presented by Hong Kong-based financial publication The Asset.

"As a development financing institution, DBP has always been at the forefront of sustainable development and environment protection." BALANGA CITY -- The number of active cases of coronavirus disease in Bataan continued to drop, this time to 87 as per Monday report of Gov. Albert Garcia.

The governor said that the patients are all isolated at the Bataan General Hospital and Medical Center, exclusive hospital for Covid-19 in this city.

Per latest report of the provincial health office, there were two new infections and seven new recoveries recorded, increasing the number of confirmed cases to 3,651 and those who have recovered to 3,486.

The number of deaths remained at 78.

The new confirmed cases are both women, a 24-year-old from Mariveles and a 45-year-old from Hermosa.

"NO VACCINES, no VFA!"

Treating the Americans like a bunch of yokels might have sealed our fate to settle for China's Sinovac in lieu of the US-made Pfizer-BioNTech and Moderna vaccines.

IT IS a quiet Christmas.

"Among, nucarin cayu pu magsimbang bengi? (Father, where do you say the Misa de Aguinaldo?)," asked my good neighbor as he saw me watering my plants, a day before the start of the traditional Masses.

After I answered his question, with a bit of a sad note on his face, my neighbor continued: "E ya pu masaya ing pascu ngeni, tahimic ya pu at maracal ing mebauas a saya at sigla. (Christmas is not a cheerful one this time, it is so quiet and so much of the jovial preparations are gone)."

To which I quipped, wanting only to say something that will be equally pleasing to his statement, "Awa, jo, o inia pin umpisa na pa mu ning September, panayan cu neng magcanta i Jomari Chan, pero angga na ngeni ala pa! (Yeah, and I've been waiting for Jomari Chan to sing his famous Christmas medleys, but haven't heard him till now)."

Much as I was amused at our conversation, I am not surprised that I almost agree with him. I agree with him that this Christmas is indeed "tahimic" in the sense that many of the "fanfare" elements that have characterized the past Christmases have been reduced or almost done away with (at least for the time being, am sure)... no more Christmas parties, for one; traditional carolers from house to house are not allowed; family reunions or large neighborhood gatherings are practically banned; the hide and seek game between ninongs/ninangs and their inaanaks is not gonna happen it seems; the turnout of big number of Massgoers is controlled and restricted by health protocols. There are infractions of course, and knowing the "Pinoy spirit" there will be "clandestine" ones, but still and true enough these restrictions will still render our Christmas preparation and the celebration of the day itself, a silent one.

It is a quiet Christmas, and its silence is felt. But I do not lament it. On the contrary, I welcome this silence. Or, was it not silence that welcomed the little baby Jesus? When due to the "restrictions" they encountered, his parents had no choice but to be "cornered" in a stable, away from the noisy human activities in the inns and residences, since it was an unusual day of census, a crowded time, a noisy and busy time for people? So, the baby Jesus was born in the quiet and stillness of the stable. It is this fact that I am sure gives sense to the song, "Silent Night." But it is in that silence of the first Christmas that it all made sense. Jesus was ushered into this world, with Mary and Joseph, silently savoring that wonderful moment of the birth of the Savior. No noise, no hustle and bustle and no crowd that steal their attention from their lovely baby. In that still silence, they had all the time and the opportunity to be

with and for the baby, the baby had their full attention. The God-incarnate had their hearts unto Him alone, and their joy was so full, and they savored every moment and every thought so divine and good.

I take it that it is but time and fitting to celebrate this Christmas in its precious silence. We have been far too noisy in the past; noise that distracted us and took away our attention from the essence of the Child Jesus' coming among us. Noise that bothered us and made us lose our focus on the golden moment that God have wanted us to have... the silence to grow in spirit, in hope and faith, which Jesus, the Savior, came to give us.

This pandemic somehow has paved the way for this silence... it has kept us away from the usual things we loved to do but which in turn may have kept us away from the real sense of Christmas.

May we see and feel in this silence the growth of faith and trust in God, and realize how much many other good things in us which our "silenced moments" have elicited in us, and enabled us to do, things which we were not accustomed to; may we see how this silence have helped us see better the goodness, kindness and importance of our family members, and appreciate one another; the generosity and concern of our neighbors and friends which maybe in the past we have ignored or not even appreciated.

May we see in this silence the joy of simply being together, working and helping each other; see the beauty of being dependent on others and others dependent on you; that simple yet profound joy of knowing "we have each other" in our families.

Above all, may we also see the growth in our prayer life; appreciate the moments that we had to fall really on our knees and talk to God from our hearts; those golden and quality moments of opening ourselves to God in tears, in our helplessness, disappointments and perhaps, desolation; those moments when we have to really look up to God as the one and only source of our well-being. If Christmas this time is thus so silent and quiet, but becomes the golden moment for us to grow as faithful and believers indeed, then despite the absence of the usual noise and haste (and perhaps, also waste) of our past Christmas celebrations, it is still a joyful and very merry Christmas. A Silent, but truly Joyful and God-filled Christmas to one and all!

The Covid horizon 2021

THE WORLD will be a safer place against the COVID 19 IN 2021. It's a fearless bet, a friendly wager that is more than a fervent hope; it's an unshakeable optimism based both on science and faith, which can be both one and the same. Never mind the impostors called variants.

The silver bullet, or whatever color you may want to assign to it, is the discovery of more than one vaccine to counter the pandemic that has imbruted the entire world. When it rains, it pours. Miracles are ageless.

Many countries of the world have begun to roll out their mass vaccination programs as early as the week before Christmas Day. Some will start jabbing their most vulnerable sectors in a prioritized approach not later than January next year. The remaining few countries, for some reason – partly because of logistics, partly because of politics or both may have to wait a little longer before the vaccines arrive.

The possibility, in their case, is so real you can cut it with a knife, so goes a song. The victims and potential victims could freeze before the much-needed solution in freezers would reach their destination in the tropics. It's worrisome, if not frightening. Geography and geopolitics might dictate the tempo and speed of the worldwide vaccination drive in this age of acceleration.

Sadly, the Philippines may belong to those who, in the verses of Alexander Pope, are "the last to lay the old aside" and are not those "to whom the new are tried".

On second thought, President Duterte has announced that, in fact, his soldiers and, according, Secretary Ed Año, some Cabinet members have been inoculated with the vaccine by Sinopharm from China. A caveat: the Food and Drug Administration has clarified that it hasn't approved any vaccine yet.

Health Secretary Francisco Duque is clueless, or he makes it appear that way. Hath his eyes not seen nor his ears heard that a vaccination program in the country has been made already? What everybody heard from the President through a television performance is the same as what he did, he said. Honest-togoodness.

Duque, of course, has been raked over the coals by senators and others in the past for his patented cluelessness on critical issues affecting his department and the government, particularly on health concerns and charges of corruption at PHILHEALTH. They wanted him out of both agencies not one minute longer. But he's somebody special to the President and, fortunately or otherwise, he seems not feckless but flawless. So, he stays and let the rest of the country go hang.

In his latest, not last, public address, Duterte has threatened to abrogate the Visiting Forces Agreement with the United States unless the latter provides at least 20 million doses of the Pfizer vaccine to the Philippines, pronto. No Either the President is bluffing or is dead serious. Sen. Miguel Zubiri takes the President seriously and is presumably not happy with what he calls the politicization of the anti-COVID vaccine. Others think he's bluffing, or probably the precise word is joking, subject to interpretation by his jesters who have been chided for their alleged breaking of health protocol. It's on record: he called off his earlier plan to cross the South China Sea on a jet ski. No big deal.

It's a guessing game. Duterte is enamoured by things Chinese, like Sinovac vaccine. If the U.S. calls his bluff, he could always say "see, I gave them the chance to walk their talk but they proved the old saying that in politics, domestic or international, there are no friends, only permanent interest". If the US caves in, Duterte can always say, I would rather have the Chinese vaccine because it's consistent with my independent foreign policy. Besides, China doesn't need an advance payment for it.

By the way, China is so confident of the efficacy of its much-ballyhooed vaccine that it had ordered millions of doses of the Pfizer brand. Maybe it doesn't have enough supply to jab its Red Army with and the rest of the teeming billion Hans.

Obviously, unlike Duque and company, Xi Ping and his comrades did not drop the ball in their negotiation with Pfizer. Something must have been lost in translation between Pfizer executives and Philippine leaders. It goes to show that, indeed, the use of English in the Philippines is fast deteriorating. The last survey found that elementary English is what's spoken in Philippine colleges and universities. We've come a long way, baby.

People remember that someone has referred to the COVID 19 as veerus. I tell you, we're really in trouble in English alone.

It's a good thing that local government officials have declared their intention to purchase some, if not all, the vaccines they need and start the ball rolling as soon as possible, with or without the national government.



Thus, Gov. Dennis "Delta" Pineda on Sunday called on all sectors to marshal resources for the province to raise an initial P200 million to P300 million for the purchase of anti-Covid-19 vaccines and immunize priority sectors in the province.

Pineda said the vaccine should be administered before the second quarter of 2021 to medical frontliners in public and private hospitals handling Covid-19 patients as well as to workers in private companies

to strengthen the capacity of the health system while restarting the economy.

These groups would consist the first batch of recipients of vaccine allotments from the national and provincial government.

For the multi-sectoral fund drive, the governor urged local executives and legislative councils in 19 towns and three cities to appropriate funds for the vaccination program. He said Vice Gov. Lilia "Nanay" Pineda and the sangguniang panlalawigan are supportive of larger allocation pro-

posals from him.

"We will all have to sacrifice some projects in order to prioritize further the health needs of our constituents," the dovernor said.

Pineda said he is set to begin dialogues with the business sector, which is encouraged to put up counterpart funding and launch other means.

He said the brand of vaccine should be approved by appropriate health authorities and purchased in accordance with the government's procurement law. In a meeting last Dec.

18, former President Gloria Macapagal-Arroyo and provincial officials discussed ways to help the local economy recover from the pandemic. As consultant to the provincial government, Ms Arroyo recommended the clustering of barangays in enforcing health protocols, with councilors overseeing the clusters.

She said that in this way, Covid-19 incidence in Pampanga, which is much lower than those of other large provinces near Metro Manila, would flatten further.


