# Former police general is new CDC top honcho

CLARK FREEPORT President Rodrigo Duterte has appointed a retired police official to the top post of the Clark Development

The president appointed on Tuesday retired Brig. Gen. Manuel Gaerlan as president and CEO of the staterun firm CDC which administers, manages, and develops the Clark Freeport Zone.

The lands were Nature's before they were the people's, and then back. Vacant lands, mostly privately-owned according to Mayor Diman Datu, now look like mini-jungles of mixed tall grass and wild plants.

Some eight years after the Bacolor Rehabilitation Act or Republic Act 9506 was passed to resurrect the one-time capital of the Philippines back to its old glory, it doesn't seem that nothing really much has happened to achieve this.

Datu, in a brief interview, disabused this notion. "Bacolor is in a much better position now than before the Mt. Pinatubo eruption in 1991 in terms of opportunities for growth," he said with a veteran politician's usual air of optimism.

Optimism, of course, is the practical and classic disposition in the business (it used to be a vocation) of politics, a constant virtue, like the pi. Datu, experienced and energetic, has been in the demanding arena for easily a dozen years, perhaps more.

Datu blames the vast lands' unsightly idleness to lack of people. Only less than 50 percent of Bacolorenos have returned to their old residences while the rest are scattered in several Pampanga towns.

"We're like the Jews, dispersed and our culture diffused in those areas where we have relocated permanently," he says. He echoes the by former Congressman pride. Otherwise, the municipal development tics-challenging antidote name a building after please.

Statistics-wise, color is an anomaly. There are more than 39,000 people living in this third-class municipality, 30 percent of whom isn't native-- workers from other provinces and itinerant businessmen who chose it their permanent home after the lahar inundation subsided and life started to assume normalcv gradually. Local farmers have been a loval presence due principally to the attachment of their lifelines, both sentimental and survival, to the lands.

Otherwise, the originals have elected a dual citizenship of sorts: native of Bacolor and resident of their adopted town. As it happened, Bacolor has more registered voters, nearly 50,000, versus the actual population. "Most of our people enjoy the best of both worlds," he laughs it off. "With the social services and other benefits they get from their old town and the new one. They figuratively rise up in arms if they don't get any from their original town."

In the real Athens as in Bacolor, custom is king. (Bacolor rightfully earned the comparison because of its uniquely rich and distinctly Kapampangan literary heritage.) Bacolorenos have never lost their love for their time-tested tradition. They always come to celebrate our finew settlement provides as much, perhaps, even better, opportunities and hopes as the one they were forced to leave behind basically untended now for more than quarter of a century.

The Clark Freeport is a major incentive. Many of the new generation of Bacolorenos born before and after the Pinatubo tragedy have good paying jobs in the former American airbase. Many of them are much better off than their parents were before the volcanic cataclysm, Datu explains. "I, myself, go home to a house in a resettlement area every now and then to relax."

Pampanga 3<sup>rd</sup> District Rep. Aurelio "Dong" Gonzales, who authored and pushed the rehab measure under then President Gloria Macapagal-Arroyo, has said that almost all the infrastructure projects under the law have been completed-roads, bridges and a hall for each barangay. These also include renovations of the Don Honorio Ventura State University which gained its new status during Gonzales' watch.

A little caveat: Details of the rehab progress and accomplished projects, though, are difficult to secure from the solon or his office. Repeated requests have been effectively stymied by vague generalities or tepid, tentative response.

He mentioned at least two government agencies that have yet to fulfill their obligations under the rehab act: the Department of Environment and Natural Resources and the Department of Tourism. Villafana did not elaborate. The law, by the way, has expired, according to Gonzales.

Even a new executive building for the municipality remains on the drawing board, per Datu. He also scores the Department of Public Works and Highways for not downloading a single centavo to the municipal government for the intended infra projects to the locality. A little puzzled and quizzical, he did not explain or speculate.

As expected, out of sheer gratitude and political correctness, Datu acknowledges the huge contribution of Gonzales to the rehabilitation of Bacolor. "We owe him a lot," he says, appreciating who has, for the longest time, helped buttered Bacolor's bread.

To attract Bacolor people from resettlement areas to come back, Gonzales bares that he is asking the National Housing Authority and other government agencies to build housing projects to boost the manpower capability of the town. With the lack of details, so much of that remains a polpie-in-the-sky itician's chimera, considering the crushing pandemic and the all-too-importvaccine. The jabbing solution has exposed the country's deficits and disadvantages, from system to sense.

There is one criticism: by law, a council should have been convened and a reliable source from the Pampanga Chamber of Commerce and Industry, which was organized to prime countryside growth in the Pinatubo aftermath, complains they have never called one. The council has reportedly met a number of times, according to Villafana or Datu: in other words, probably sans PamCham or its representative. The council was deemed abolished once it had formulated the scope and specs of its ambitious plan, according to Villafana. Sorry.

The late Levy P. Laus, PamCham's founder and chairman emeritus, once expressed his commitment to marshalling the private sector as added impetus for Bacolor's economic and social recovery. He walked his talk. He worked hard to bring back Don Bosco Academy to Bacolor after it relocated to Mabalacat City after the lahar attack on Barangay Cabalantian. His work paid off and saw it fulfilled before he died. Following his tragic death in a helicopter crash, a building was named after him. a first for a secular person at Don Bosco.

A fellow alumnus of Laus at Don Bosco, a prominent surgeon, once recalled that some alumnus questioned the inLaus when he's not even a canonized saint. The surgeon had a no-brainer for an answer: follow Laus's example of providing generous financial contribution to the school.

Before his death, Laus also was able to establish a car dealership and a restaurant along GSO, putting his money where his mouth was. Whatever other Laus plans were in the pipeline before he died are now highly conjectural. One former Laus Group manager believes that is all for now for Bacolor, especially in view of the pandemic.

Datu is highly encouraged by the rising of commercial establishments, such as the Laus' auto dealerships and franchised restaurant, a batching plant, and subdivisions in his town counting three with his fingers. In due time, he expects to elevate the town to a first-class status from the current level with a sharp eye on the prize - a substantial increase of its share in the Internal Revenue Allotment that now stands at about P100 million. That is, if the ban on the classification of local government units is lifted, and the national government treats Bacolor a "special case," something that the national government has denied it for the last 30 years or so, Datu laments.

Overall, Bacolor's diminutive chief executive likes the way things are shaping up from his looking forward perspec-

# EdSa to form group for Covid vax purchase, prioritization

CITY OF SAN FERNANDO -- Mayor Edwin "EdSa" Santiago announced Tuesday the plan to create a technical working group that will focus on the city government's Covid-19 vaccination, including the procurement process and prioritization of target population.

The plan came up during Santiago's meeting with department heads of the local government unit right after a virtual special general assembly of the League of Cities of the Philippines which also tackled the roles of local authorities in the Covid-19 vaccination efforts.

Santiago tasked the city government's financial departments to modi-

fy the city's budget for the response to emerging and re-emerging infectious diseases, including the initial purchase of vaccine, which is expected to rise to P20 million to P25 million from the earlier targeted amount of P10 million.

The group will also be responsible in identifying the priority groups or clusters to be vaccinated first as the city is targeting to inoculate more than 260,000 Fernandinos.

Santiago said the group will also study which particular vaccine the city will tap and identify personnel and facilities that will administer the vaccines. -CSFP-CIO

The initiative will also fast track the coordination and facilitation of projects and programs for over two million IPs in Northern and Central Luzon. Burgos recognized the role of IPs in fostering peace and development in

"As advocates of peace and de-

velopment, Nolcom will continue to collaborate and partner with the different government agencies and other concerned stakeholders for the implementation of programs and projects that will capacitate and empower IPs and improve their living condition," Burgos said.

For his part, National Commission on Indigenous Peoples (NCIP) commissioner Roland Rivera commended Nolcom's initiative to establish an affairs desk aimed at protecting and promoting the rights of IPs as well as preserving the cultural heritage.

"NCIP will work closely with the AFP to advance the well-being of the IP, develop a culture of non-violence and support in developing a progressive indigenous cultural communities," Rivera said.

#### **AC** Puso Center completes 32 minor surgeries serbahan nila ang mga safety

ANGELES CITY - Amid the many challenges presented by the COVID-19 pandemic, Mayor Carmelo "Pogi" Lazatin, Jr. remains true to his promise of prioritizing the health of all Angeleños, as the Puso Center completes 32 minors surgeries on some of the city's financially-challenged

Established on February 27, 2020, the 3-in-1 clinic, composed of a minor surgery clinic, animal bite treatment center, and dental clinic aims to provide Angeleños with easy access to quality and free healthcare.

"Marami sa mga kababayan natin ang walang kakayanang magbayad sa doctor o magpunta sa ospital, kahit may sakit sila. Sa pamamagitan ng Puso Center, matutulungan natin silang mapangalagaan ang kalusugan nila, lalo na ngayong panahon ng pandemya," Lazatin said.

Executive Assistant IV Reina Manuel shared some of the minor surgeries performed by Puso Center's resident doctor Dr. Rey Hipolito include the removal of lipoma, abdominal mass, ear and skin tag, foot warts and the excision of cysts on the back, tendon, index and ring finger.

The clinic's newly-installed skin cauterizing machine, the Neo-Frecator, was also used on one patient to minimize tissue damage and further infection, Dr. Hipolito said.

To ensure that the machine will work properly, an initial inspection was also done by Executive Assistant IV Manuel and Dr. Hipolito. Manuel also personally oversaw the renovation and repair of the Puso Center, prior to its launching last February.

Meanwhile, according to Lazatin's Chief Adviser and Tactician Director IC

Calaguas, aside from the free medical procedure, patients of the Puso Center will also receive free medicines and a follow-up check-up to ensure that their wounds will heal safely and properly.

To ensure the safety of Angeleños being treated at the Puso Center, its medical staff makes it a point to implement the necessary COVID-19 protocols, Calaguas added.

"Para mas lalong mapangalagaan ang kalusugan at kapakanan ng mga kababayan natin na nagpupunta sa Puso Center, sineseguro ng medical staff dito na inoobat health protocols laban sa COVID-19," Calaguas said.

"Ini-ischedule ng maayos yung pagbibigay ng free anti-rabies, pati na rin yung mga minor surgeries na ginagawa dito, para ma-maintain pa rin ang proper social distancing," Manuel furthered.

Providing readily available medicine and quality medical services is also Mayor Lazatin's way of carrying out his father's legacy, former Angeles City Mayor and Pampanga First District Representative Carmelo "Tarzan" Lazatin.

# Choosy? Echos mo, Roque

TOTOO PO, meron tayong lahat na karapatan para sa mabuting kalusugan pero hindi naman po puwede na pihikan dahil napakaraming Pilipino na dapat turukan.

Thus, presidential spokesman Harry Roque saying Filipinos cannot be choosy with the brand of Covid-19 vaccine that they would get from the national government.

This, even as he pushed for the government-procured 25 million doses of vaccine from China's Sinovac Biotech, a part of which is expected to arrive by February.

Bad enough that the national government virtually controls which brand/s of vaccines to procure, retorted Sen. Ping Lacson. Pero por Diyos, por santo - that's us, and surely many others - "Pati ba naman ang pagpili kung ano'ng ituturok sa braso ng mga Pilipino, hindi pa rin pwede mamili ang Pilipino?" So, he rued.

Indeed, Ping: "Bakit ko naman pipiliin ang brand na 50 percent lang ang efficacy at wala man lang application for Emergency Use Authorization, against other brands with 79 percent and/or 95 percent efficacy and have pending EUA approval from the Food and Drug Administration?"

Bayan Muna Rep. Ferdinand Gaite lectured Duterte's official blabber: "Mr. Roque, if it is a matter of safety and effectivity, if it involves public money, then the people have the right to be 'choosy.' *Trabaho niyo at pananagutan niyo* sa publiko na siguruhin na ligtas at epektibo 'yang bakuna."

Adding: "Hindi naman kalabisang hingin na tiyakin ng pamahalaan na ligtas at epektibo ang gagamiting bakuna."

As straightforward is public health expert Dr. Tony Leachon, once adviser of the national coronavirus task force: "That's a very unfair statement coming from the spokesperson because to me it is enshrined in the Constitution that health is a basic right and it is about wellness."

"We deserve to be choosy because we need to find the right vaccine for us based on efficacy and safety," he said. "The government works for the people. I think the government should actually follow that particular aspect of looking for the right vaccine.'

Leachon upholding salus populi suprema lex esto, thus: "And if there's safety concern, you need to heed the call of the customer, as well as the people, that you need to provide the right [and] the efficacious vaccine."

Meanwhile, as of Monday, Jan. 11, all local governments that have signed advanced marketing commitments did so with only one vaccine maker – AstraZeneca. They are:

I WONDER what the other people in that synagogue in Capernaum did when the possessed man entered and made a scene. I suspect that they all ran away. And I think people got very impressed with Jesus precisely because he remained cool even when the possessed man spoke very aggressively and tried to intimidate

I used to be afraid of barking dogs until I became a dog lover myself. I realized that when dogs get aggressive with strangers, they are actually the ones that are feeling intimidated by the presence of those strangers. They are more afraid of you that you are of them. And they can sense fear also; the more you react to them with fear, the more they react to you with aggressiveness. And if you run away, they will run after you.

If you are a dog lover, you would know how to assure a dog that you mean no harm. You will just stay cool and let the dog bark on. Because you are not reacting with fear or running away, the moment the dog realizes that you are not attacking it, it will gradually come near you, continue barking as it smells you up close. Eventually, when it stops barking and wags its tail, that is its way of saying, "Oh, ok; I thought you wanted to hurt me." By then you can already pat it and it will lick your finger and you become its newfound friend.

(Pag pumatol ka nga naman sa may diperensya sa pag-iisip e baka may diperensya ka rin.) Instead, sasabihin mo, "Pagpasensiyahan natin siya, wala siya sa sarili niya." Just because people are capable of abusing us verbally or of inflicting physical harm on us does not mean they are evil themselves. We distinguish between the action and the person between the sin and the sinner.

This is what we call the perspective of mercy. It prevents us from hating anybody in this world and teaches us to treat even people who behave obnoxiously, with understanding, patience and even forgiveness. Isang importanteng doktrina para sa Kristiyano ang "Walang masamang tao dito sa mundo; kahit na totoong maraming taong nakakagawa ng masama." Lahat tayo'y likas ng mabuti; pero sa loob at labas natin laging may labanan ng dalawang puwersa: ang mabuti at masama. Good and evil spirits. Because we are also spiritual beings ourselves, we have to learn how to deal with good and evil spirits around us and within us.

Ang mga masamang espiritu ay parang virus din. Nandyan lang sa paligid, pwedeng dumapo sa iyo o pumasok sa katawan mo pero walang epekto pag malakas ang resistensya mo. In our covid vocabulary, you remain asymptomatic. (Yun nga lang pwede mong ipasa sa ibang tao at kung mahina ang resistensya nila, mas matindi ang epekto. Magkakasakit sila.

Kung merong physical viruses, meron ding spiritual viruses. Kung may physical immunity, meron din tayong spiritual immunity. If we need physical nourishment, rest and exercise in order to keep ourselves physically fit, we also

need spiritual nourishment, rest and exercise to keep ourselves spiritually fit, because we can also get sick, spiritually.

#### Possessed

Our Gospel describes spiritual illness as a situation of BEING POSSESSED OR BEING UNDER THE SPELL OF EVIL SPIRITS. Hindi naman lahat ng sakit na dumadapo sa tao ay sakit pang-katawan o physical. Nagkakasakit din ang diwa, isip at kaluluwa ng tao. Pwedeng malusog ang pangangatawan pero may diperensya ang kaluluwa. Minsan mukhang ayos sa panlabas ang tao pero WALA SA SARILI. Salamat na lang at naisabatas na dito sa Pilipinas ang MENTĂL HEALTH LAW. Kasi mababa daw ang mental health awareness ng maraming Pilipino. Baka mababa din ang awareness natin ng spiritual health.

Isa sa mga pinakamalaganap na sakit na dulot ng stress at mga trauma sa tao ay ang depression. May mga taong dahil sa depression, parang feeling nila walang halaga ang buhay nila. When the depression gets really serious, ang iba sa kanila ay nagdi-develop pa ng suicidal tendencies. Ang iba dahil sa tindi ng mga pinagdadaanan sa buhay ay nakakagamit ng iba't ibang paraan para matakasan ang katotohanan, may nalululong sa mga bisyoalak, sugal, pornography, droga, nagiging

Hindi sila masamang tao. They are just suffering from a disorder; nawawala lang sa sarili. We can only help them if we try first of all to understand where they are coming from or what they are going through, and how we can be there for them. How we can help free them from their mental or spiritual captivity. This, I repeat is the Christian perspective of mercy and compassion. When we learn to see other people, including those who hurt us or do us harm as fellow-sufferers, we learn to respond to them with Christian charity.

Mas madaling magmahal kapag ang minamahal mo ay normal, mabait, matino, maayos ang pag-iisip. Nasusubok ang pagmamahal natin sa mga taong wala sa katinuan. Kapag kaya pa rin natin silang pagmalasakitan, makabawi. Kapag kaya pa rin natin silang damayan, alalayan at paglingkuran upang sila'y gumaling at makabalik sa sarili.

ON JANUARY 11, 1897, the so-called "Thirteen Martyrs of Bagumbayan" were execut-ed following their arrests after the Cry of Pugadlawin on charges of treason and sedi-

Cry of Pugadlawin was an event where Andres Bonifacio, founder of the Katipunan, and its members assembled together then tore their cedulas which symbolize their determination to take arms against Spanish colonizers.

The 13 martyrs executed in Bagumbayan (Luneta) after the mock trial were: Numeriano Adriano (lawyer), Domingo Franco (businessman and propagandist), Moises Salvador (propagandist), Francisco L. Roxas (industrialist and civic leader), Jose Dizon (Katipunan member), Benedicto Nijaga (lieutenant in the Span-

ish Army and Katipunan member, a native of Calbayog, Samar), Geronimo Cristobal Medina (corporal in the Spanish army and Katipunan member), Antonio Salazar (businessman), Ramon A. Padilla (employee and propagandist), Faustino Villaruel (businessman and Mason), Braulio Rivera (Katipunan member), Luis Inciso Villaruel, and Estacio Manalac.

## Missing (and Messing) the Point

IN THE Senate Committee of the Whole hearing last Monday on the government's vaccination plan, the senators brought to fore what was mainly ailing the government of the current dispensation: it's missing the point, if not messing it.

The senators, for instance, noted that in 1995 or thereabout, about 96 percent of Filipinos thumbed up the government's vaccination program. This year, that percentage dropped to more than 60 percent.

Health Secretary Francisco Duque had no answer but offered a solution: a massive marketing campaign to reverse the trend.

Sen. Richard Gordon, who saw the huge discrepancy, pointed out that the high approval rating was recorded during the time of then Health Secretary Juan Flavier. The mention of Flavier was not conceivably an accident.

Duque missed Gordon's subtle but savvy insinuation: it's wasn't more and more creative information or marketing strategies that did it; it was TRUST. So much so that in the marketing slogan, Let's DOH it, the agency's acronym was front and center its brand message. The name was the slogan because it served as the emblem of trust. Now, that's smart marketing.

The people bought into the message, not because it was simple and dumbed down and beneficial, but because the people were ready to entrust in Flavier's their health, and ultimately, sent the barrio doctor by an overwhelming vote to the Senate where and when he endeared himself more to the people. He could have been another Magsaysay but for destiny.

Sen, Ping Lacson, who has no love lost for Duque -- and makes sure he stabs at it when chance presents itself -- could not also reconcile two recent poll results that seemed to cancel each other out. On the one hand, one survey says about 30 percent would not have themselves jabbed. On the other hand, more than 90 percent feared that they will contract the virus.

He may not have intended it, but Lacson doubled down on the issue of trust. People trusted more the virus, therefore feared it, more than the government ventriloquists. That's funny in the Senate bubble, but not in the real world outside where, as Lacson urgently pointed, COVID victims continue to fall by the wayside because of the deadly bug.

Lacson's later comments zeroed in what's the issue at hand and what has been long eating him up inside. He warned Secretary Carlito Galvez, the anti-COVID czar, that incompetence was as infectious as the invisible virus. So much about pet peeve.

Sen. Francis Pangilinan noticed inconsistencies in the vaccination plan of the

government. The Inter-Agency Task Force (IATF) headed by Galvez has a vaccination timeline from 2021 to 2022 for 50-70 million people with 148 million doses. The DOH, which is part of the IATF, narrowed it down within 2021

Galvez and company grappled with a sane, sensible answer.

Senators Frank Drilon and Ralph Recto alternately mauled the logic of the anti-COVID Cabinet in not allowing the private sector and the local government units purchase any of the vaccines given the Emergency Use Approval (EUA). Director General Eric Domingo, arguing more like a lawyer than a medicine man, replied that they are not allowed because only the national government can. It's not cast in stone, but that's the way it is.

The flummoxed senators, who nearly fell off their chairs, didn't say the policy was stupid but it sure didn't make sense. Why is it supposedly safe for the millions of Filipinos targeted by IATF and not be to the other millions in the private sector and the LGU constituents? Domingo: because the national government or somebody says so. It was ridiculous apart from having no rhyme. What is good for the goose isn't good for the gander.

Robert Reich, former Cabinet member of US President Bill Clinton wrote in his memoir "Locked in the Cabinet" that being in government is about holding a public trust and getting the job done. "To confuse the two," he said, could lead to big mistakes."

The good news is that, for all the apparent confusions and inconsistencies, Filipinos can look forward to being jabbed in February this year. Drilon is the implacable Doubting Thomas because of the supply issue (80 percent of available vaccines already cornered by rich countries) and funds for acquiring the vaccines are still in the air. The drift: manage your expectations.

For once, the Senate has proved itself still a trustworthy democratic institution, even if it tiptoed on the controversial vaccination of members of the Presidential Security Guard and looked the other way on other things in the past. It's better not to ignore the aging and cranky dragon on the doorway. The honorable elders in this realm can be as bad and blind only as they choose to be bad and be blinded.

That's a statement of hope or a naive hyperbole.

er services in his office and advised his staff to immediately undergo self-quarantine prior to assessment and swab testing.

"Sa mga taong nakasalamuha at nakausap ko ng matagal mula Jan. 4, 2021, kung maaari po sana ay ipagbigay alam lamang ito sa city health office o sa rural health unit upang maisailalim kayo sa contact tracing at iba pang assessment," Aquino furthered. completion in February. With this, we can continue providing faster and safer access to and from Subic especially for businesses and logistics companies operating in the area as well for tourists," said Public Works and Highways Secretary Mark A. Villar.

The P1.6-billion SFEX Capacity Expansion project aims to increase the road capacity of SFEX from one lane in each direction to two lanes in each direction with the construction of two additional lanes, bridges, and a new tunnel. It intends to improve traffic safety, provide additional road capacity, and reduce travel time to and from Subic Bay Freeport.

Expressway-standard LED lights are also being installed, while the elevation of Maritan Highway-Rizal Highway-Tipo Road junction was raised and the drainage system was enhanced to allow motorists to experience comfortable and easy journeys all year round.

According to GMA-7's press release, 24 Oras emerged as the Philippines' top news program for 2020. In terms of total broadcast hours, the Kapuso network and its news channel, GMA News TV, had devoted a combined average of 18 hours daily for the channels' various news and public affairs programs. This is for the period of January to December 2020.

GMA allotted almost 25 percent of its actual airtime to news and public affairs shows, which was equivalent

All these accounted for 75 percent of GMA News TV's programming or 13.5 hours daily on the average. GMA-7 also claimed the number one spot on Mega Manila's AM and FM lists.

Based on Nielsen's Radio Audience Measurement, GMA-7's Super Radyo DZBB recorded 41.9 percent audience share among AM stations. It also had a reach of 2.3 million listeners as of December 2020.

GMA-7's FM station Barangay LS 97.1 had 29.5 percent audience share among FM stations, and had a reach of 4.8 million listeners as of December 2020.

GMA-7's new product, GMA Affordabox, which was launched in mid-2020, had sold one million units within six months in 2020. At present, GMA-7 continues to offer a variety of content through its digital channels Heart of Asia and
