The collection of P1,036,607,994 COVered the period from July 2019 to February 2021, excluding March 20 to May 17 last year when the strictest form of quarantine against Covid-19 grounded the homegrown quarry industry, according to records of the provincial quarry monitoring unit Kalam.

of quarry receipts are inventoried and recorded.

On a per month basis, the highest collection was made last February,

at P72.8 million. "The amount we collected proved that the monitoring and collecting system we put in place is efficient. Taxing according to actual volume hauled is right. This also showed that quarry operators and haulers are cooperating with our policies," Governor Pineda said.

He thanked guarry associations that police their own ranks and the provincial treasurer's office that collects the taxes and fees at the Capitol and not in checkpoints.

He also commended Kalam personnel headed by former Bacolor Mayor Romeo "Buddy" Dungca for properly regulating the multi-million industry.

The governor Pineda said the high collections bring benefits to the communities. The Local Government Code of 1991 (RA 7160) distributes the sand tax at a 40-30-30 percent sharing to barangays, towns

Editorial

Women's lives upended, rights eroded amid Covid-19

THE COVID-19 pandemic has erased decades of progress towards gender equality. From high job losses to exploding burdens of unpaid care, from disrupted schooling to an escalating crisis of domestic violence and exploitation, women's lives have been upended and their rights eroded. Mothers — especially single mothers — have faced acute anxiety and adversity. The consequences will far outlast the pandemic.

But women have also been on the front lines of pandemic response. They are the essential workers keeping people alive and holding economies, communities and families together. They are among the leaders who have kept prevalence rates lower, and countries on track for recovery.

This year's International Women's Day highlights the transformative power of women's equal participation. We are seeing it ourselves at the United Nations, where I am proud that we have achieved gender parity in UN leadership posts for the first time in history.

The evidence is clear. When women lead in government, we see bigger investments in social protection and greater inroads against poverty. When women are in parliament, countries adopt more stringent climate change policies. When women are at the peace table, agreements are more enduring. And with women now serving in equal numbers at the top leadership posts at the United Nations, we are seeing even more concerted action to secure peace, sustainable development and human rights.

In a male-dominated world with a maledominated culture, gender equality is essentially a question of power. Males are an essential part of the solution. I call on countries, companies and institutions to adopt special measures and quotas to advance women's equal participation and achieve rapid change. As we recover from the pandemic, support and stimulus packages must target women and girls specifically, including through investments in women-owned businesses and the care economy.

Pandemic recovery is our chance to leave behind generations of exclusion and inequalities. Whether running a country, a business or a popular movement, women are making contributions that are delivering for all and driving progress towards the Sustainable Development Goals.

It is time to build an equal future. This is a job for everyone — and for the benefit of everyone.

Wishing upon a star

I WONDER if the mother of James and John was also among the women who accompanied Jesus up to Calvary in Jerusalem. If she was, I imagine her later standing with Mama Mary at the foot of the cross, and looking at the crucified Jesus with the two criminals positioned on his right and on his left. She would have recalled what she wished for just a few days back, as narrated in today's Gospel, when she said to Jesus, "Promise me that these two sons of mine will be positioned, one at your right and one at your left in your kingdom." Here now is the king with thorns for his crown and the cross for his throne. She probably said to herself, "Thank God, he did not grant my wish."

Don't we, like her, also wish a lot of things for ourselves and for our loved ones, and perhaps even resent it when our wishes are not granted? Have you ever thanked God for not granting your wish because you realized later on that what you asked for would have broken your heart? There is a saying that goes, "Be careful what you wish for because you might just get it."

In St. Mark's version of this passage, it is the two boys themselves who make the wish. By the time Matthew was writing his Gospel, they were already consciously projecting an ideal or exemplary image of the apostles. Matthew must have been embarrassed by the thought that these two young apostles were so humanly ambitious, so he rewrote the story and put the request for positions of power in the mouth of the mother instead. But you realize, as you read on, that the mother is just being used as a mouthpiece. Later in the conversation, Jesus asks not the mother but the two disciples themselves. If it was the mother who made the request, he should have asked, "Can your sons drink the cup that I am going to drink?" Instead, he addressed it on James and John themselves, "Can you drink the cup that I am going to drink?'

Jesus must have been aware of the proverbial "cup of suffering and death" that the Greek philosopher, Socrates, was made to drink. The great philosopher was accused of corrupting the minds of young men and sentenced to death by being made to drink a cup of hemlock. Jesus was alluding to the passion and death that he was about to face in Jerusalem when he asked if James and John were ready to drink the cup he was going to be made to drink. And they boldly replied, "Yes, we can!" Meaning, it was their own wish, after all.

There is a song that was composed in 1940 for Walt Disney's animated adaptation of Pinocchio entitled WHEN YOU WISH UPON A STAR. Unfortunately, most of us know only the first verse of the song which says,

"When you wish upon a star

Makes no difference who you are Anything your heart desires

Will come to you."

It's where the typical American dream of being whoever and whatever you want to be second verse of the song says,

"If your heart is in your dream No request is too extreme When you wish upon a star As dreamers do"

The prophet Jeremiah was just a young boy when he started his prophetic career. Like James and John, he was starry-eyed, ambitious, and self-willed, especially when he recalled that he had been chosen for the job already from his mother's womb. Later when he started to suffer the consequences of his bold prophetic words, he would lament to God. He would say in Jer. 20,7 "You seduced me, Lord, and I let myself be seduced; you were too strong for me, and you prevailed. All day long I am an object of laughter; everyone mocks me. Whenever I speak, I must cry out, violence and outrage I proclaim; The word of the LORD has brought me reproach and derision all day long. I say I will not mention him, I will no longer speak in his name. But then it is as if fire is burning in my heart, imprisoned in my bones; I cannot endure it."

I imagine the Lord answering Jeremiah's lament with a song, "I beg your pardon; I never promised you a rose garden." He would probably have said, "You wished for this, Jeremiah; have you forgotten your youthful dream?" And so, the song's second verse is important,

"If your heart is in your dream

- No request is too extreme
- When you wish upon a star
- As dreamers do...

True dreamers are willing to go through the most extreme trials and tests and not give up easily. They are wishing upon a star, and the star is Jesus. He tells the dreamers like James and John it's ok to aspire for greatness, but they had to understand that true greatness is not about lording it over. It is not about titles and privileges. And so, he says, "You want to lead? You have to be a servant. You want to be first? You have to be a slave. You want to work with the Son of God for the redemption of sinners? You have to be ready to join the son of Man who came to give his life as a ransom for the many."

And so, I repeat, BE CAREFUL WHAT YOU WISH FOR.

TODAY IN PHILIPPINE HISTORY

Some native Filipinos and mestizos present a petition demanding explusion of the friars

ON MARCH 1, 1888, some native Filipinos and mestizos marched in procession to the official residence of Jose Centeno and presented a petition demanding the immediate expulsion of the friars of the religious orders, and of the Archbishop, whom they declared unworthy to occupy the Primacy of the Islands.

Centeno, a mining engineer, was acting civil governor of Manila, and an anti-clerical, was said to have emboldened the demonstration.

The petition addessed to the Governor-General, further demanded the secularisation of the benefices and the confiscation of the estates of the Augustinians and the Dominicans. The demand, said to have been written by Doroteo Cortes, a mestizo lawyer, also accused the friars of compassing the death of Father Burgos, by subornation of justice. There were 810 signatures to the petition, but when the signatories were summoned and examined, most of them declared they did not know what they had signed, and denied that they wished the friars to be expelled.

The result of this appeal was that the principal persons who took part in it were banished, or sent to reside at undesirable places within the Archipelago.

Combinado: First shared kitchen facility launched in AC

ANGELES CITY — The shared kitchen commissary concept, something new to the local food business community here, found concrete expression with the launch Saturday of Combinado, the first cloud kitchen in north of Luzon.

pressured by what they see on social media especially since the Covid-19 pandemic boosted their time in using gadgets.

Other crucial factors attributed to the prevalence of teenage pregnancy include lack of information about reproductive health and sexuality, ineffective or lack of parental guidance, poverty, and early engage-

ment in risky behaviors.

"Since the first pregnancy until subsequent pregnancies, we found out that it is an interplay of factors. Adolescent pregnancy is not just about the adolescents, it's also about their parents, their friends, their partners, and even the community they belong to," Monterona said.

Among the 20,974 recorded pregnant adolescents in Central Luzon, 311 or 1.48 percent live births are from mothers in the young ages of 10-14.

In addition, Popcom said teenage pregnancy is a threat to the health not only of young mothers, but also of children.

We know that pregnancy has ill effects on the overall wellness of the mothers. We know that when a woman is pregnant, there are risks that we have to guard. The risks become doubled in terms of health concerns if the pregnant mother is an adolescent," Monterona explained.

Popcom said children born to very young mothers are at a higher risk of diseases and death.

Adolescent pregnancy is also a concern on the total development of the individual with implications on family, community, and socio-economic factors.

"The affected are not only the young mothers

Arte Tattoo: Going beyond aesthetics for the art of self love and healing

CITY OF SAN FERNANDO — Every tattoo and piercing goes beyond aesthetics from a journey that tells tales behind the markings, inks, studs, or rings.

"Tattoo is a form of healing," said Arte Tattoo owner and piercing specialist Patty Tiu-Thomson.

"I have been a tattoo enthusiast for a long time. I was one of Charles' loyal clients at first. I would refer to him from those in my network like my friends or those in the music industry until eventually we figured since I have been referring to him some clients, we can just partner and make it bigger and take it out from his home studio," she added.

Founded by Charles Arteta and Kel Laquin at a small house studio in 2012, Arte Tattoo now has three branches: Poblacion in Makati, Malingap in Quezon City, and Baliti here.

"The one in Malingap was already planned but then lockdown happened. So within three months time it was locked down, we didn't know if we would continue or not. So we've decided to push through and eventually we agreed to have a branch outside Manila so just in case lockdown happens again, we have already one that is here and operating," she said.

Arte Tattoo houses a total of 10 tattoo artists and two piercing specialists. They are known for their bespoke designs on fine lines and minimalism, japanese oriental tattoos, realism and illustrative tattoos, traditional and neo-traditional, as well as hand poked manifestation tattoos.

"Our artists draw their own designs. We conceptualize along with the client. If our clients find a design that they like online, they can show it to our tattoo artist and they can make something out of it but not completely copy what was shown," she said.

Defining self love through inks marked on the body, Arte Tattoo brings part of the healing process as they share some through their "Arte Stories" via social media.

"With everything that's going through right now, everyone has different ways of healing or coping so we use our tool which is tattooing to help cope with what they are going through," she shared.

"Tattoos are like windows to

your soul. You can be known just by looking at your tattoo. It's nice to know that you have one that is just yours, a design that is meant for you alone, something you won't see on other people," she furthered.

Known in Manila as one of the go-to places to get inked, Arte Tattoo ensures its standards on hygiene and sanitation as well as safety protocols against Covid-19 in all of its three branches.

"Now we have doubled our safety protocols. We have added PPEs, gloves, face shield, and face masks. We also have a contact tracing form. We have days when we accept walk-ins as well," she noted.

Arte Tattoo has its monthly "Arte Tattour" activity where tattoo artists from their Manila branches visit for a session for Kapampangans who want to experience their skill and creativity.

Located at the 2nd floor of Quez building along McArthur highway Baliti here, Arte Tattoo is open every Wednesdays to Sundays 11 a.m. to 7 p.m. while Mondays and Tuesdays are strictly for appointments only.

Arte Tattoo Valentine's Day promo is still ongoing. All self love tattoos from medium to large size are at 50 percent off while piercings are at buy one get one promo and an additional piercing if you bring a friend for a piercing/tattoo. Promo runs until March 14.
