# 141 AC health volunteers get P1-K pay hike

ANGELES CITY — Mayor Carmelo "Pogi" Lazatin, Jr. will be giving additional P1,000 honoraria to 141 city health volunteers assisting in the vaccination sites — 43 barangay health workers, 49 barangay nutrition scholars, and 49 barangay population officers — starting October 1.

In Memorandum Nos. 1318, 1319, 1320, Lazatin expressed his recognition to the 141 volunteers who have been dedicating their services in battling the Covid-19 pandemic.

The amount may be small compared to their efforts amid the pandemic, Lazatin said, but this will not falter the city government from showing gratitude for their endless service.

Currently, the said health volunteers have been receiving P4,000 monthly salary.

It can be recalled that amid the pandemic, Lazatin has raised the salary of 111 nurses to P12,000.

A total of 76 day care workers who assisted the city government during the food packages distribution also received a P1,000 honoraria.



# New Clark airport terminal includes all-gender restrooms, other inclusive features



The new CRK terminal features all-gender restrooms in an effort to create a more vibrant and inclusive community for everyone.

The new CRK terminal's prayer rooms include a footwashing station that Muslim passengers and visitors can use for ritual cleansing.



Clark International Airport's (CRK) new passenger terminal building, which will open its doors to passengers and visitors by the end of 2021, will feature inclusive amenities such as all-gender restrooms, nursing stations, and multifaith prayer rooms.

"Creating welcoming and inclusive spaces is at the heart of CRK. CRK will be a space where we embrace a positive atmosphere and treat everyone with utmost respect," BCDA President and Chief Executive Officer (CEO) Vince Dizon said. "At CRK, it is about accommodation and inclusion for all."

Restrooms at the new CRK terminal will provide all-gender accommodations for transgender, non-binary identifying individuals, and cis-gender people traveling with opposite-sex children or elderly companions. Other inclusive features include nursing stations and prayer rooms, each with a foot-washing area for Muslims.

Inclusivity and intuitiveness are among the key principles that Luzon International Premiere Airport Development Corporation (LIPAD) follows in terms of operating and managing the new CRK terminal.

With a vision to be the quietest gateway in the Philippines, LIPAD will operate a "silent airport policy" where passengers and visitors will rarely hear boarding calls and instead rely on posted announcements for quick reference.

Colors and signages will guide passengers and visitors at the new CRK terminal. Facing Manila Bay, the carpets and chairs at the domestic area are in blue; while green is the color for the international area as it faces Mount Arayat.

LIPAD, led by Filinvest Development Corporation, JG Summit Holdings Inc., Changi Airports Philippines Pte. Ltd. and Philippine Airport Ground Solutions Inc., won the 25-year concession for the operations and management of CRK in January 2019.

The CRK New Passenger Terminal Building Project is the first hybrid public-private partnership project that was planned, constructed and completed–from start to finish–under the Build Build Build program of the Duterte administration.

# To the Point

## **Curioser** and curioser

"ISN'T THAT double payment – you shelled out money to buy the items, then you buy those using your own money again?"

Asked Sen. Panfilo Lacson of Health Secretary Francisco Duque III at Tuesday's Senate blue ribbon committee hearing on the DOH transfer of P42 billion to the Procurement Service-Department of Budget and Management to purchase medical supplies on its behalf.

The PS-DBM bought1.3 million face shields at P120 apiece from the Philippine Blue Cross Biotech Corp. Since these items were part of PS-DBM's inventory, senators questions now whether these were bought using DOH funds or using PS-DBM funds.

"When you moved P42 billion to PS-DBM, did you move it so they can purchase medical supplies and equipment for you, which are now common-use supplies and equipment?" Sen. Franklin Drilon asked Duque. "Or did you transfer the P42 billion so PS-DBM can build an inventory from where public hospitals can get their supplies?"

"Ginamit ang pera ng DOH para bumili. Pinagtubuan pa – tubong lugaw," furthered said Drilon. "They made P4 profit then they got a [4%] commission using budget and funds allocated by Congress."

Even as Duque insisted that PS-DBM merely bought on their behalf, he admitted: "Mr. Chairman, I'm sorry, but I have no information...that we purchased this. What I understand is, the budget that was used to purchase these common supplies and equipment is separate from the money utilized to purchase the face shields."

Retorted Drilon: "What was the budget of PS-DBM in 2020? I assure you, they don't have that kind of money to be able to purchase P42 billion worth of common supplies and equipment which are medical equipment."

Asserting, in Filipino: "You cannot say that the budget used was from PS-DBM. The budget came from DOH."

Duque could only whimper: "I beg to disagree. But we will look into this. Give me a little more time to verify this."

Aye, it's getting curioser and curioser in Duterte wonderland. With Rappler.com reports

### Jethro's advice on leadership

LUKE SAYS Jesus spent a whole night of prayer before he chose twelve from among his disciples to become his apostles. I am inclined to believe that he got this strategy from Moses, as told in the book of Exodus. In modern principles of management, they would call this DELEGATING POWER.

Leaders cannot be effective if they monopolize authority. Good leaders know how to delegate responsibilities to fellow leaders who are reliable. They do not "micro-manage". They are not insecure. They do not mind delegating some roles to others who could do it well too, or sometimes even better than they could. Good leaders breed fellow leaders.

In the Book of Exodus chapter 18, 13-27, we are told that, at the start of Israel's journey to the promised land, Moses was performing all the leadership roles by himself and he was getting stressed out to the point of becoming inefficient and ineffective. Now they happened to pass through Midian, the place where Moses had stayed for some time and encountered God in a burning bush.

While they were there, apparently, he was being observed by his father-in-law, Jethro, the father of his wife Zipporah. Jethro had noticed that there were long lines of people who needed to consult Moses about everything, including managing petty disagreements and conflicts. At some point Moses became so tired to the point of being indisposed. And so Jethro gave him a wise advise. Remember, Jethro was a priest himself. He said to Moses,

"You will surely wear yourself out, both you and these people with you. The task is too heavy for you; you cannot do it alone. Now, listen to me, and I will give you some advice, and may God be with you... look from among all your people those who are God-fearing, trustworthy, honest, and capable, and delegate some of your responsibilities to them... You attend to the more important matters and let them decide on the other issues of importance... Lighten your burden by letting them bear it with you! If you do this, and God so commands you, you will be able to stand the strain, and all these people, too, will go home content."

Perhaps we should call this JETHRO'S PRINCIPLE OF WISE LEADERSHIP. In the Canon Law, we would refer to this as delegating authority to vicars. Some people ask me, how does a bishop practice leadership in such a huge diocese? I remember meeting in Rome some bishops whose dioceses have only around 50 to

100 thousand baptized members. That is only one parish in some dioceses here in the Philippines. Most bishops lead dioceses with anywhere between half a million to 2 million members. How do we do it?

Well, we have followed Jethro's principle since a long, long time ago. We delegate leadership roles, whether in the pastoral or administrative aspects of the life of the diocese. What is done by the bishop is also done by the vicars and by the parish priests and mission chaplains. Like I said, a good leader breeds fellow leaders. It is also the best way of assuring the sustainability of our institutions and preparing for leadership succession. Look the Church is still alive and thriving after 2,000 years. It will continue functioning long after we are gone.

This is also the reason why we avoid entrusting the ordained ministries of leadership to people with authority hangups and all sorts of issues that make them insecure about delegating leadership. Monopolistic leaders tend to be clericalistic. Instead of breeding fellow leaders, they will tend to lord it over and make the wells of charisms dry up.

Bad leaders are usually those who are full of themselves, who feel easily threatened, who don't appreciate feedbacks and suggestions. Good leaders identify with a common vision and mission. They can set aside the ego and don't make themselves indispensable.

But then of course, human as we all are, we have to learn to deal with idiosyncracies and imperfections. Look, even the Lord did not succeed with all twelve. One of them eventually went astray. No big deal, the vacancy was soon filled out by Matthias. This apostolic leadership has been handed down from generation to generation. It is not perfect; it has to continue renewing itself, becoming more inclusive, adaptable and capable of responding to the signs of the times.

Please pray that the Holy Spirit continue to keep breathing new dynamism and wisdom on our leaders both in Church and in society.

# How To Shoot A Distracted Duck, Lame or Not

Even the best intention can be a costly distraction.

"Martha, Martha', Our Lord tells Mary's sister, " you are distracted by many things". And yet, Martha's fault was simply asking Him to tell Mary, who was sitting by His feet, to help her prepare something for the visitors who came by their door unannounced.

Theologians and preachers have a lot to say about the biblical scene, and one of their best talking points is that our best effort fails when we fail to consider what's our real priority.

In our time, there's another Mary who knows too well the value of focus. Vice President Maria Leonor" Leni" Robredo is saying that we are the way we are in the crucible of the pandemic because the one on top of the job, President Duterte, is distracted by many things. And that, to her, gives the impression that he doesn't have a sense of urgency about the plague.

The latest distraction is the controversy on the purchase of the alleged overpricing of medical supplies from a small company, depriving the government, according to Sen. Minority Floor Leader Franklin Drilon, about P280 million. The ongoing Senate hearing has lifted the lid on the Pandora's box that shows one of the company owners has link to Malacanang.

The humungous anomaly has triggered a potential constitutional crisis as Duterte has threatened to not allow any member of his Cabinet to appear before the Senate investigation on account of alleged unfair treatment of Duterte's men.

The Senate has , so far, stood its ground. The public waits like prize-fight wagers to see who blinks first. Senators Richard Gordon, Panfilo Lacson and Drilon, are in no mood to cut the President a slack. In fact, they seem ready to engage him mano-a-mano. Duterte's threat remains in its sheath. Lacson, no doubt, is better motivated, if for political reason: he's aiming for Duterte's post when he leaves the Pasig Palace in June next year. That doesn't mean patriotism isn't part of the job. His political ad on line unmistakably carries the message: Heneral ng Bayan (The People's General).

The expose on the overpricing controversy came after the Commission on Audit flagged the Department of Health on its disbursement, even parking, of funds it was given to address the adverse effect of the pandemic, especially in light of the dominant Delta variant.

The COA findings have rattled Duterte's cage. As expected, insults and expletives have since flown fast and thick from Malacanang's end toward the Senate, especially to the 'fat' one and to the other who allegedly has changed the way he combed his hair lately.

Don't mind being 'fat', replied he who claimed to be a good looker than the Pasig tenant. My hair hasn't moved a bit since insanity has apparently set in one place office, the unfazed general threw back in a tit-for-tat.

Did Duterte mean well in his over-the-top tirades against members of an equal branch of government? Hardly, according to former Sen. Sergio Osmena, who remarked that Duterte was simply out of line in his response—unpresidential, so many put it—to the senators of the realm who were just doing their job. The COA didn't even say, he said, there was corruption, but simply called the attention of DOH and others like the Senate that something could be wrong and must be investigated. When there is smoke, there must fire.

There must be another thing that makes the President lose his concentration or focus on the job. His non-renewable lease in Malacanang, and all the powers that go with it, are nearing their end day by day. The sword of Damocles coming from the International Criminal Court is still hanging ominously as his term gets shorter. The possibility of him being asked to face the court and account for violation of human rights in his war against drugs isn't just imaginary.

In Duterte's mind, he has two options to prevent that from happening. One option is to anoint a candidate who will protect him from any suit against anything from anywhere. The other option is run for vice president and short-circuit the Constitutional provision on no- reelection for any president. One way to avail of the first option is to have his daughter mayor of Davao City to be his successor. It seems doable, but not a walk in the park, although earlier surveys show good signs. The idea to have Senator Bong Go run for the presidency has fizzled out. The second option is now being shot by the opposition as a violation of the Constitution. Everything appears fluid and tricky ,and Duterte maybe in a 'panic mode' as one senator saw it.

To many, Duterte's current distractions are bereft of any good intentions and are simply alibis and diversionary tactics to hamper any attempt to ferret out the truth in governance under his watch. The Delta variant is all over the archipelago and one medical expert is worried that government is just tinkering with all sorts of lockdowns,old and new, to beat it.

From Robredo's perspective, there is lack of leadership to direct the efforts of agencies and task forces mandated to stop the virus. Obviously, Robredo yearns to be at the top of the action. It is said the vice president is the best job in the world because all she has to do is wake up in the morning and ask "How's the President Doing?". You can't blame Robredo, especially when what she sees is what she gets.

Sometimes, she fessed up, she wished she were given the opportunity to be directing the national against the virus, seeing the gaps in the implementation and coordination as if it were a headless chicken. She must have realized she needed to be the President to do that. That means she must decide, sooner than later, to run for the office. Otherwise, she will remain the best well-meaning critic of Duterte.

AN ORDINANCE PENALIZING THE ACT OF PRANKING FOOD DELIVERIES ORDERED ONLINE AND ANY OTHER FORMS OF ELECTRONIC MESSAGING TO BE PAID ON 'CASH-ON-DELIVERY' BASIS, AS WELL AS REFUSING TO PAY FOR ONLINE ORDERS WITHOUT VALID JUSTIFICATION AND FOR OTHER PURPOSES.

Whereas, the Enhanced Community Quarantine (ECQ) that is currently in effect restricts the movement of people to buy their food and/or basic necessities;

Whereas, the restriction as a consequence forced individuals to rely on available online food supply and delivery service, advertisements on social media networking sites, mobile phone applications, and the like;

Whereas, with such convenience more importantly in these times of community quarantine because of the Covid-19 Pandemic, it is almost effortless for consumers to do their transactions for food purchases online yet there are instances where businesses as well as their delivery mechanisms are being victimized by pranksters;

Whereas, the City Council is mandated to formulate legislative measures to protect its citizenry in reference to numerous reports of pranksters and bogus buyers of online food delivery services in the City;

Whereas, pending the numerous bills filed before the congress for the amendment of the E-Commerce Act of 2000 and all other relevant laws of the land, this legislation aims to protect food delivery service businesses and their respective food transporters against pranksters and bogus buyers, especially those who cancels their order(s) without valid justification;

NOW THEREFORE, be it ordained by the Sangguniang Panlungsod of Angeles City, in session assembled that:

**SECTION 1. TITLE.** This Ordinance shall be called the "The Anti-Online Pranking Food Delivery Ordinance of 2020".

**SECTION 2. DEFINITION OF TERMS.-** For the purpose of this ordinance, the following terms shall be defined as follows:

- a. **Bogus buyer-** a scammer who enthusiastically shows interest on an item and orders for it over the internet, phone call, text messages and chat but will not actually buy it.
- b. Cash on delivery (COD)- is a type of transaction in which the recipient makes payment for a good at the time of delivery.

- c. Food delivery service- is a courier service in which a restaurant, store, or independent food delivery company delivers food to a customer where an order is typically made either through a restaurant or grocer's website or phone, or through a food ordering company.
- d. Online- connected to, served by, or available through a system and especially a computer or telecommunications system such as the Internet.
- behavior that involves playing tricks towards another that are designed or formulated to be funny or cause humor and whether or not it was intended to cause harm or damage.

SECTION 3. COVERAGE. All transactions made through online and/or over the internet- website, social media, delivery service applications, mobile and landline- either phone call or text in personal, residential, commercial and industrial establishments, including government offices located within the territorial jurisdiction of Angeles City are covered under this ordinance.

The franchise and/or acknowledged owner of the mobile phone number, landline number as well as of the social media account or e-mail address used in the act of pranking Food Delivery Service ordered be it online or through mobile/landline phone is Prima Facie considered the caller or customer who placed the order unless otherwise the user was made known or identified.

SECTION 4. PENAL PROVISION. - Any person violating or causing, inducing, or abetting the violation of any prohibitory provision of this Ordinance, upon final conviction by the court, be imprisoned for no less than one (1) month but not more than six (6) months and pay a fine of not less than one thousand pesos (P1,000.00) but not more than five thousand (P5,000.00). Such penalty for fine, or both, shall be imposed at the discretion of the Court.

SECTION 5. ADMINISTRATIVE AUTHORITY OF THE CITY MAYOR. - The City Mayor, upon consultation with the concerned departments and agencies in the City, is hereby authorized to issue rules and regulations for the effective implementation of this Ordinance.

SECTION 6. SEPARABILITY CLAUSE. - If for any reason any part of this Ordinance shall be declared to be unconstitutional or invalid, the other parts of provisions hereof which are not affected thereby shall continue to be in full force and effect.

SECTION 7. REPEALING CLAUSE - All local legislative measures, inconsistent herewith are hereby repealed or modified accordingly.

**SECTION 8. EFFECTIVITY CLAUSE** - This ordinance shall take effect immediately upon its approval.

# Subic-Clark Railway may become a white elephant

ANGELES CITY - The Bataan Nuclear Power Plant. The Expo Filipino in Clark. The Mabalacat-Clark-Angeles Road. All constructed at great expense, all falling into disuse.

The realigned Subic-Clark Railway Project (SCRP) could fall into the same state of being a white elephant warned the multi-sectoral advocacy group Pinoy Gumising Ka Movement. "And even worse, given its adverse socio-economic and environmental impact to developed and developing areas it would traverse in Bataan and Pampanga provinces," it added.

'We cannot afford to lose any more money especially at this time of the pandemic," PGKM chair Ruperto Cruz said on the projected cost of the SCRP and the capacity of the government to repay the loan for it.

Cruz renewed Monday his group's claims of a "seeming deception" on the part of the Department of Transportation


Communication in the realignment of the SCRP.

"Did (Transportation Secretary Arthur) Tugade come here to manipulate us," he asked. "Why did they realign it? Are there sacred cows that they want to avoid?'

"We have been asking for five good reasons why the DOTr is realigning [SCRP] because it will hit so many subdivisions, commercial areas and even farmlands. Subdivision owners don't like it. Farmers don't like it. Businessmen don't like it. Where will it pass through Clark? Will its crossover Friendship? Where will it end where will it start?" Cruz said. "Why has the DOTr failed to this day to address these issues we have raised?"

"I know that some members of the CILA (Clark Investors and Locators Association) don't like it too but they are not moving because they are beholden to the BCDA (Bases Conversion and Development Authority)," he said.

SCRP "may not be able to stand public scrutiny, hence the total lack of any public hearing attendant to its planning."

"All that was done was a table survey, not any study," Cruz added.

#### **VIRTUAL HEARING**

Over the weekend, a "notice of public hearing" on the environmental impact assessment of the project with the Environmental Management Bureau was published in the legal noticers section of Philippine Star.

"The public hearing will be conducted on a virtual format (video conference) because of the threat of the highly contagious Delta variant of Covid-19 in the region," the notice said.

"It was a shotgun notice, sans any official invitation to the stakeholders or anyone with grave concern over the project," Cruz said.

'Its being virtual already makes the hearing suspect as it would be easy to control and manipulate all discussions on the part of the administrator of the virtual conference," he noted. "If what is being said is not to their liking, they can easily cut off the speaker and blame technical glitch-

Cruz pointed out that the threat of the pandemic "is a lame excuse, given faceto-face meetings and even assemblies being conducted, especially political ones, in the region."

Participation zoom meetings video conferences also required not only "technical savvy" but possession of at least a laptop or a good mobile phone, he said: "I have a laptop but I don't know how to attend a Zoom meeting. What about the farmers? They don't even have a laptop to start with."

"If Tugade will insist on the realignment we will bring this before the Senate Blue Ribbon Committee and even to the Supreme Court," Cruz vowed. "And he may just kiss his Senate dreams goodbye."





# Republic of the Philippines City of Angeles 18th Sangguniang Panlungsod

ORDINANCE NO. 538, S-2020 (PO-134-06-20)

AN ORDINANCE AMMENDING ARTICLE III, SECTION 2- (r), SECTION 4 AND ARTICLE IV, SECTION 4 OF ORDINANCE NO. 113 SERIES OF 2000 ALSO KNOWN AS AN "ORDINANCE CREATING THE ANGELES CITY URBAN HOUSING BOARD AND THE LOCAL URBAN POOR AFFAIRS AND HOUSING OFFICE OF ANGELES CITY, SPECIFYING THEIR DUTIES, FUNCTIONS AND RESPONSIBILITIES" OTHERWISE KNOWN AS "THE ANGELES CITY HOUSING BOARD AND LOCAL URBAN POOR AFFAIRS AND HOUSING OFFICE OF ANGELES CITY."

Be it ordained by the Sangguniang Panlungsod of Angeles City in session assembled that:

**Section 1.** Article III, Section 2 (r), of Ordinance No. 113, Series of 2000 "An ordinance strengthening Republic Act 11469 otherwise known as "Ordinance creating the Angeles City Urban Housing Board and the Local Urban Poor Affairs and Housing Office of Angeles City, is hereby amended, to read as follows:

**SECTION 2. POWERS, DUTIES, FUNCTIONS AND RESPONSIBILITIES:** The Local Urban Poor Affairs and Housing Office shall exercise and perform the following powers, duties, functions and responsibilities and; to wit:

r. To provide technical and legal assistance to qualified urban poor beneficiaries and shall provide preventive or interim measures and legal assistance to qualified urban poor beneficiaries especially those have rights that had been violated or needing protection;

Mandated by law, the City government should and always continue to find ways to accommodate/entertain urban poor affairs such as land dispute complaints, ejectment cases, report of association anomalies and other queries and make necessary actions/advice regarding the matter. It is also tasked to conduct necessary ocular inspections and site investigations and hold community dialogues, consultations and other discussions.

The LUPAHO Office and any of its personnel and instrumentalities should not be involved or be in any part as a collecting agent of any private land owner contracting to sell for socialized low cost housing projects.

**Section 2.** Article III, Section 4, of Ordinance No. 113, Series of 2000, is likewise hereby amended, and to read as follows:

#### SECTION 4. DUTIES, FUNCTIONS AND RESPONSIBILITIES OF THE

**ADMINISTRATIVE AND PLANNING DIVISION:** The Administrative and Planning Division shall exercise and perform the following duties, functions and responsibilities; to wit:

- a. Shall prepare annual plans/programs to be implemented by the LUPAHO consistent with the policy of the Angeles City Development Council;
- b. To prepare the annual budget for the implementation of urban housing projects and urban poor alleviation projects to the City Budget Officer;
- c. To administer and monitor the proper implementation of each programs;
- d. Shall in coordination and consultations with the PRESIDENTIAL COMMISSION OF THE URBAN POOR (PCUP) formulate the operational guidelines of the Urban Poor Affairs Planning Process;
- e. Monitors and Oversees all programs and projects;
- f. Conduct Urban Planning and Analysis on the current housing situation of the City;
- g. Formulation of Program of Work/Program Design;
- h. Acts as representative of the Local Urban Poor Affairs on official meetings and/or discussions;
- i. Prepares and facilitates documents relative to the disbursement of office funds;
- j. Accounting and Liquidation of office funds;
- k. Prepares and submits accomplishment reports to the Chief Executive;
- 1. Provide assistance to the Legal, Engineering and Community Organizing Division on a continuous basis;
- m. The LUPAHO Office through this Division with the aid of the Community Organizing Division shall ensure that the President of the Urban Poor Association of a concerned barangay due for negotiation, MOA signing and/or awarding of lands for Socialized Housing beneficiaries shall be an official witness.
- n. Perform all other administrative affairs necessary, etc.

**Section 3.** Article IV, Section 4, of Ordinance No. 113, Series of 2000, is hereby amended, to read as follows:

#### ARTICLE IV PROHIBITED ACTS

**SECTION 4.** Any person who sell his right after being awarded a parcel of land by the government and identified by the Local Urban Poor Affairs and Housing Office as qualified beneficiary/ies within the meaning of R.A. 7279 shall be prohibited. Lands acquired by beneficiaries may not be sold transferred or conveyed except through hereditary succession, or to the government or to other qualified beneficiaries for a period of twenty five (25) years. Provided however, that the children or the spouse of the transferor shall have the right to repurchase from the City Government within a period of two (2) years. If in case found violating this provision, the lot awarded shall be canceled and the beneficiary will be blacklisted for further future socialized housing project of the City.

**Section 4.** Applicability Clause. All other provisions of Ordinance No. 113, Series of 2000 as amended, which are not hereby amended shall remain in full force and effect.

**Section 5.** Effectivity Clause. This ordinance shall take effect immediately after its approval.

#### Ordinance No. 06, S-2021

AN ORDINANCE PROMOTING A SMOKE-FREE ENVIRONMENT BY REGULATING THE USE OF TOBACCO CIGARETTES AND E-CIGARETTES IN PUBLIC AND ENCLOSED SPACES WITHIN THE TERRITORIAL JURISDICTION OF BACOLOR, PAMPANGA AND BANNING OF TOBACCO ADVERTISEMENT, RESTRICTING ACCESS TO TOBACCO PRODUCTS, IMPOSING PENALTIES FOR VIOLATIONS THEREOF AND FOR OTHER PURPOSES

WHEREAS, the 1987 Constitution of the Republic of the Philippines provides that the State shall protect and promote the right to health of the people and instill health consciousness among them;

WHEREAS, Republic Act No. 7160, otherwise known as the Local Government Code of the Philippines empowers Local Government Units (LGU) in upholding of the general welfare of their constituents to include, among others, the promotion of health and safety;

**WHEREAS**, Section 5 of Republic Act No. 9211, otherwise known as the Tobacco Regulation Act of 2003, prohibits smoking in certain public places, whether enclosed or outdoors; imposes bans on tobacco advertising and imposes restrictions by banning sales in places frequented by minors;

WHEREAS, Section 24 of Republic Act No. 8749, otherwise known as the Philippine Clean Air Act of 1999, prohibits smoking inside enclosed public places, including public utility vehicles;

WHEREAS, Land Transportation Franchising & Regulatory Board Memorandum Circular 036, s. 2009, clearly prohibits smoking in all public utility vehicles and public transport terminals, requiring public utility vehicle operators to prominently display "No Smoking" signages in their authorized units and premises;

**WHEREAS**, the Philippines was the 15th largest consumer of tobacco in the world in 2002, ranks second in number of smokers in the 10-member Association of Southeast Asian Nations (ASEAN) and currently has one of the highest smoking rates in Asia, as well as some of the lowest cigarette prices;

**WHEREAS**, President Rodrigo R. Duterte's Executive Order No. 26, issued on 16 May 2017, provides for the establishment of smoke-free environments in public and enclosed spaces found within the territorial jurisdiction of the Philippines.

**BE IT ENACTED**, by the Sangguniang Bayan of Bacolor, Pampanga, on its Regular Session held at Max's Restaurant, Macabacle, Bacolor, Pampanga;

Section 1. Short Title- This Ordinance shall be known as "THE COMPREHENSIVE SMOKE FREE ORDINANCE OF BACOLOR, PAMPANGA".

**Section 2. Purpose**-It is the purpose of this Ordinance to safeguard public health and ensure the well-being of all its constituents by protecting them from the harmful effects of smoking and tobacco consumption.

Section 3. Coverage-This Ordinance shall apply to all persons, whether natural or juridical, whether resident or not, and in all places, found within the territorial jurisdiction of Bacolor.

**Section 4. Definition of Terms**– The following terms shall have the meanings ascribed to them in this section. Any words or terms not defined shall be given their plain and customary meanings, unless the context requires otherwise, and shall be interpreted in a manner consistent with the purpose and spirit of this Ordinance.

- a) Cigarettes –refers to any roll or tubular construction, which, contains tobacco or its derivatives and is intended to be burned, heated, or smoked under ordinary conditions of use.
- b) Civil Society Organization (CSO) refers to a legally constituted voluntary civic and social organization or institution created with no participation of government, including but not limited to, charities, development non-governmental organizations (NGOs), community groups, women's organizations, faith-based organizations, professional associations, coalitions and advocacy groups. As used in this Ordinance, CSO do not include organizations or associations related to or connected with the tobacco industry in any way;
- c) Designated Smoking Area (DSA) refers to an outdoor area, where smoking is allowed without violating this Ordinance, provided that such area strictly meets the following minimum requirements:
  - 1. it shall be located in an open space with no permanent or temporary roof(s) or wall(s);
  - it shall not be located within ten (10) meters of entrances, exits, or any place where people usually congregate:
  - 3. It shall not have an area larger than ten (10) square meters;
  - 4. Only one (1) DSA per building is allowed;
  - 5. No food or drinks shall be served in the DSA;
  - 6. Minors or persons below the age of 18 shall not be allowed at (or within) DSA;
  - 7. Every DSA shall have highly visible and prominently displayed "Smoking Area" sign and a graphic depiction with a corresponding explanation of the ill effects of smoking on smokers' health, on passive smokers and on third-hand smokers.
- d) Enclosed or Partially Enclosed means being enclosed by one or more walls or sides, whether covered by a roof or not, or even if open on all sides but is covered by a roof, regardless of the type of material used for the roof, walls or sides, and regardless of whether the structure is permanent or temporary in nature.
- e) Electronic cigarette is an electronic device that simulates tobacco smoking. It consists of an atomizer, a power source such as a battery, and a container such as a cartridge or tank. Instead of smoke, the user inhales vapor. As such, using an e-cigarette is often called "vaping". E-cigarettes are activated by taking a puff or pressing a button. Some look like traditional cigarettes and most versions are reusable.
- f) Law Enforcement Team refers to the body created to spearhead the implementation and enforcement of various ordinances in the city.
- g) **Municipal Tobacco Council (MTC)** refers to the body created to have over-all supervision and control in the implementation of this Ordinance.

- h) Minor refers to any person below eighteen (18) years old;
- Outdoor Advertisement -refers to any sign, model, placard, poster, board, billboard, banner, bunting, light display, device, structure or representation employed outdoors wholly or partially advertise or promote a tobacco product to the public.
- Person in charge refers to any person who has control or responsibility over any place or means of public transport covered by this Ordinance, or any agent or designee of such person, including the proprietor, possessor, manager, or administrator;

In case of public places, public outdoor spaces, or other establishments, it refers to the director, trustee, president, manager, or other officer of a corporation, the manager or partner of a partnership, the owner, proprietor or operator of a sole/single proprietorship, or the administrator of a government property, office or building, as the case may be.

In case of a public transport, it refers to the owner, the driver, the conductor, or the captain of a public transport.

In case of workplaces, it refers to the employer, who may be an individual employer, or a sole proprietor, or if the employer is a corporation, the director, trustee, president, manager or other officer of the corporation.

- Point of sale refers to any location at which an individual can purchase or otherwise obtain tobacco products;
- I) Public Transport refers to any vehicles, whether mobile or stationary, used in the transport of passengers or available t the public as a mode of transport, such as, but not limited to, jeepneys, buses, taxicabs, trains, ships, airplanes, light rail transits, vans, tricycles, pedicabs, motorcycles, and other public utility vehicles, whether covered by a Certificate of Public Transport or not;
- m) Public places refers to all places that are accessible or open to the public, whether or not by invitation or by payment, or all places for collective use, regardless of ownership or right to access, including, but not limited to, establishments/stores that provide food, accommodation, drinks, professional services, merchandise, entertainment, or other services, as well as gasoline stations, banks, malls, shopping/business arcades, town squares, terminals, airports, seaports, schools, places of worship, churches, hospitals, cinema houses, gymnasiums, covered courts, funeral parlors, barber shops, cockpits, gaming areas, internet cafes, recreational facilities, pedestrian lanes, overpasses, underpasses, parking areas, waiting sheds, sidewalks, and other places where people usually congregate;
- n) Public Outdoor Spaces -refers to outdoor spaces that are open to the public, or places where facilities are available for the public, or where a crowd of people would gather, such as, but not limited to, playgrounds, sports grounds or centers, church grounds, health/hospital compounds, parks, gardens, resorts, markets, streets, sidewalks, walkways, entrance ways, waiting areas, and the like;
- Shisha –refers to device or instrument, which may have a single or multi-stemmed pipe for smoking, whether or not it delivers nicotine to the user. In which the smoke is passed through a water basin before inhalation. It is also known as waterpipe, sheesha, hoocha, nargeela, argeel, or nargile;
- p) Second-hand smoke refers to the smoke emitted from the burning end or heated tobacco products usually in combination with the smoke exhaled by the smoker.
- q) Smoking refers to being in possession or control of a lighted, emission-producing tobacco product, regardless of whether the smoke is being actively inhaled or exhaled.

- r) Tobacco Advertising and Promotion refers to any form of commercial communication, recommendation or action with the aim, effect or likely effect of promoting a tobacco product or tobacco use, either directly or indirectly, including but not limited to, any message or image promoting smoking, tobacco use, tobacco products, brand names, or tobacco company names or any promotional materials or structure that contains these, such as, but not limited to, posters, streamers, signages, standees, billboards, fliers, umbrellas, parasols, CDs, film, caps, t-shirts, sweatshirts, visors, backpacks, sunglasses, writing implements, towels, mugs, candies, stickers, and the like.
- s) Tobacco Industry refers to organizations, entities, associations, and individuals that work for or in behalf of the tobacco industry, such as, but not limited to, tobacco manufacturers, wholesale distributors, importers of tobacco products, tobacco retailers, front groups and any other Individuals or organizations, including, but not limited to, lawyers, scientists and lobbyists that work to further the interests of the tobacco industry.
- t) Tobacco Products products entirely or partly made of a tobacco leaf as raw material which is manufactured to be used for smoking, sucking, chewing or snuffing such as but not limited to cigars, cigarettes, and cigarillos.
- u) Tobacco Product Substitute —refers to any device or instrument that resembles the outward appearance of a traditional smoking/tobacco product or that is intended to be a substitute for traditional smoking/tobacco products, whether or not used to deliver nicotine to the user, including, but not limited to, electronic nicotine delivery systems, shisha, and other similar devices.
- v) Vape/vaping to inhale vapor through the mouth from a usually battery-operated electronic device (such as an electronic cigarette) that heats up and vaporizes a liquid or solid This electronic cigarette contains a small reservoir of liquid nicotine solution that is vaporized to form an aerosol mist. The user "vapes," or puffs on the vapor, to get a hit of the nicotine.
- Workplace –refers to any place where more than one person, regardless of employment status, performs work. Vehicles used in the course of work are considered workplaces.

Section 5. Prohibited Acts— The following acts shall be prohibited:

- Smoking, vaping or using any tobacco products, including e-cigarettes, in any part of any enclosed or partially enclosed public place, workplace, public transport, or public outdoor space, except in duly approved designated smoking area;
- Knowingly allowing, abetting, or tolerating smoking or vaping or the use of any tobacco products in any of the places enumerated in the immediately preceding paragraph, except when smoking is done within duly approved designated smoking areas;
- Selling, distributing, or advertising tobacco products in a school, public playground, or any other facility frequented by minors, or within one hundred (100) meters from any point of the perimeter of these places.

Purchasing or buying any tobacco products from a minor, or selling or distributing any tobacco

- product to a minor, or using, buying, selling any tobacco product by a minor;
- e) Placing cinema and outdoor advertisements of tobacco products;
- Placing, hanging, posting, distributing any type of tobacco advertisement, such as leaflets, posters and similar materials, outside the premises of point-of-sale establishments;

- g) Selling tobacco products without a permit or license;
- Smoking or vaping while driving whether public utility vehicle or private utility vehicle with open windows, motorcycle, tricycle, tri-sikad and pedicabs;
- Failure to comply with any of the duties and obligations set forth in Section 6 or in any other provision of this ordinance.

Section 6. Duties and Responsibilities of Persons in Charge— The person in charge of any enclosed or partially enclosed public place, workplace, public transport, or public outdoor space shall:

- a) Post and display prominently "NO SMOKING" signages in the most visible locations in the area where smoking is prohibited:
  - i. For public places, workplaces, and outdoor spaces, at the minimum, a "NO SMOKING" sign must be posted at the entrance of the area. The "NO SMOKING" signage shall be at least eight (8) inches x 11 inches in size and the international "No Smoking" symbol (consisting of a pictorial representation of a burning cigarette enclosed in a red circle with a red bar across it) shall occupy no less than seventy (70%) of the signage. The remaining lower 30% of the signage shall show the following information:



"STRICTLY NO SMOKING"
as per ORDINANCE NO. 00-00
Violators can be fined up to P2,500.00

- ii. For public transport, the "NO SMOKING" signage shall be in the form of a three and one-half (3.5) square inch-sized sticker to be placed on the windshield, in addition to a ten (10) square inch-sized "NO SMOKING" sign in the most conspicuous location within the vehicle facing the passengers:
- Remove all ashtrays or any receptacles for disposing of cigarette refuse from places where smoking is prohibited;
- c) For persons-in-charge of schools, public playgrounds or other facilities frequented by minors, post the following statement in a clear and conspicuous manner:

#### SELLING OF CIGARETTES OR OTHER TOBACCO PRODUCTS NOT ALLOWED WITHIN 100 METERS FROM [SCHOOL/ETC] PERIMETER

d) For person-in-charge of point-of-sale establishments, post the following statement in a clear and conspicuous manner:

#### SALE/DISTRIBUTION OF TOBACCO PRODUCTS TO MINORS IS UNLAWFUL

- Ensure that all the employees in the establishment are aware of this Ordinance and to provide a procedure to warn violators;
- f) Allow inspectors and representatives of the duly designated civil society organization (CSO) and deputized civilians, entry into the establishment on any regular business day and during regular business hours for the purpose of inspecting the premises compliance status;
- g) Undertake all reasonable steps to ensure strict implementation of this Ordinance, and to inform and refrain people from smoking or using any tobacco product in their establishments, except in duly approved designated smoking area. At the minimum, establishments shall ensure compliance with the following procedure:
  - Stop people from smoking/vaping or using any tobacco product by warning the violators and/or requesting them to leave the premises.
  - If the violator fails to comply by ceasing to smoke or by leaving the premises, the person in charge or his agent shall immediately report the incident to the proper authorities (e.g., the nearest peace officer or police officer).
- h) Remove all forms of tobacco advertisements other than those found inside the premises of a retail establishment that is authorized or permitted to sell tobacco products;
- Remove all tobacco products and related advertisements from establishments and properties located within the one hundred (100)-meter perimeter of a school, public playground or other facility frequented by minors;
- Indicate any intention to sell or advertise tobacco products in all its business permits and related applications (including in case of renewal) for permits and licenses;
- k) Secure a permit for the establishment of a designated smoking area in accordance with the specifications provided in Section 4.C and ensure that the designated smoking area remains compliant with such specifications; and
- Obtain clearance and secure approval for the sale and/or advertisement of tobacco products, and remove all tobacco products and related advertisements if the permit/license issued pursuant thereto does not allow it.

Section 7. Persons Liable— The following persons/individuals are liable under this Ordinance:

- a) Any person who commits the prohibited acts stated in Section 5 hereof;
- Persons-in-charge who knowingly allow, abet, or tolerate the prohibited acts enumerated in Section 5 and who otherwise fail to fulfill the duties and obligations as enumerated in Section 6 of this Ordinance;
- Any passenger, driver, conductor, or inspector of public transport, government-owned vehicles smoking as stated in Section 5;
- d) In addition to or regardless of the liability of the persons in charge, any corporation, partnership, entity or establishment that fails to comply with the requirements under Section 5 and Section 6 in relation to Section 11.

Section 8. Penalties— The following penalties shall be imposed on violators of this Ordinance:

#### A. VIOLATIONS

1. Violation of Section 5 (a) and Section 6

Third and Subsequent Offenses P2,500.00. or imprisonment for a period not exceeding 5 days or both at the discretion of the court.

2. Violation of Section 5, (b), (c), (d) and (e)

P1,500.00

P2,000.00

Third and Subsequent Offenses P2,500.00. or imprisonment for a period not exceeding 20 days or both at the discretion of the court. Suspension or revocation of business license or permit (in case of a business entity or establishment), if applicable.

3. Violation of Section 5 (f), (g) and (h)

First Offense P1,500.00

Second Offense P2,000.00

Third and Subsequent Offenses P2,500.00 or imprisonment for a period not exceeding 20 days or both at the discretion of the court. Suspension or revocation of business license or permit (in case of a business entity or establishment), if applicable.

In case of establishments which do not opt to declare their establishments as totally free from smoking but fail to provide the appropriate designated smoking areas as certified by the Municipal Health Office within the 60-day period, their business permits may be revoked.

In case where smoking is allowed, abetted or tolerated in an establishment in violation of this Ordinance, a penalty shall be imposed upon the President or Manager in case of corporations, partnerships or associations, or the owner, proprietor or operator in case of single proprietorship, whether tourism-accredited or not as follows:

Third Offense or succeeding P2,500.00 violations thereof shall be ground for Suspension or revocation of business license or permit or closure.

For drivers/passengers of Public Utility Vehicles (PUVs)

Fine of P 500.00

Fine of P1,000.0

Fine of P2,500.00 or 10 days imprisonment or both at the discretion of the court.

Drivers of public transport are also required to post the following sign inside their vehicle:

Penalty for violation thereof:

Fine of P500.00

Fine of P1, 500.00

Fine of P2,500.00 or imprisonment for 3 days but not more than 6 days at the discretion of the court. The penalty or fine, provided above may be imposed administratively through the Citation Ticket System established pursuant to this Ordinance.

- **B. SUSPENSION OF LICENSE/PERMIT**: In addition to the fine or imprisonment, the License or permit to operate any establishment shall be suspended upon:
  - 1. Failure to take corrective action despite notice within ten (10) calendar days from the receipt of notice of violation of this ordinance, which may be in the form of a citation ticket;
  - 2. Failure to pay the fine within ten (10) calendar days from receipt of notice of violation, which may be in the form of a citation ticket, regardless of whether or not such notice or citation ticket was accepted.
- **C. CANCELLATION OF LICENSE/PERMIT AND CLOSURE ORDER**: The license/permit of any business entity or establishment shall be subject to revocation or cancellation by the Mayor, upon the recommendation of the MTC, in the event that the business entity or establishment:
  - i. Continues operations despite the suspension of its license/permit;
  - Fails to take corrective action despite the receipt of two (2) consecutive notices of violation of the Ordinance, which may be in the form of citation ticket(s), within ten (10) calendar days from receipt of the second notice;
  - iii. Re-installs, re-posts, or distributes any removed or confiscated tobacco advertisements; or
  - iv. Is found to have committed three (3) or more violations of this Ordinance.
- D. CONFISCATION/REMOVAL OF TOBACCO ADVERTISING: In addition to other penalties imposed, any tobacco advertisement found in violation of this Ordinance shall be removed or confiscated and destroyed by the deputized authorities concerned after due notice.
- E. COMMUNITY SERVICE- If a violator is unable or unwilling to pay the fines imposed, he/she may choose to render community service (e.g. tree planting, clean-ups, receives smoke-free orientation/seminar from the MHO, assist in the implementation of smoke-free advocacy activities in the LGU). For every hour of community service rendered, the outstanding fine shall be reduced by an amount equivalent to triple the hourly minimum wage.

Section 9. LIFTING OF THE SUSPENSION/CLOSURE ORDER— An order for the suspension or cancellation of the business permit/license and closure of any business entity or establishment shall be lifted only upon compliance with the following requirements:

- a) Submission of a written request to the Municipal Health Office for re-inspection;
- b) Payment of re-inspection fee of Php 500.00
- Full compliance with the Ordinance upon re-inspection;
- Secure from the MTC an endorsement to lift the order of suspension or cancellation of business permit/license and closure.

Section 10. Compliance with the Ordinance as Additional Requirement of Sanitation Standards — Compliance to the Ordinance shall form part of the Sanitation Standards of the Municipal Health Office. The Municipal Health Office shall integrate the requirements of this Ordinance with its Sanitation Standards and its requirements for the issuance of a sanitary permit. No Sanitary Permit shall be issued, unless the Municipal Health Office has verified, upon inspection, compliance with the requirements of this Ordinance.

Section 11. Compliance with the Ordinance as Additional Requirements of Business Permits, License Applications and Renewals —Compliance with the Ordinance shall form part of the requirements for the issuance of business permits and licenses.

- a) No business permit or license to operate shall be issued, unless the applicant business entity or establishment is found to have complied with the requirements of this ordinance;
- Business entities or establishments within the one hundred (100) meters from any point of the perimeter of any school, playground or other facility frequented by minors shall not be allowed to sell or advertise tobacco products;
- c) All Business Permits and Licenses shall be stamped or marked with the following notations, where applicable:

#### STRICT PROHIBITIONS:

#### Smoking Selling of Tobacco Products to Minors •Tobacco Advertisements

•Selling or advertising of tobacco products within the 100-Meter Perimeter of any school, playground or facility frequented by minors (or where the establishment is identified to be within the restricted zone

Section 12. Fees— The following fees to defray the costs of inspections for purposes of monitoring compliance with this Ordinance and of the processing of applications for necessary permits and licenses:

Mayor's Permit Fee- CIGARETTE (Retailer)-P500.00 annum Designated Smoking Area Fee- 500.00 annum Re-inspection fee (For Violators) – P 500.00

Fees collected in accordance with this Ordinance shall be earmarked to supplement the operational funds of the MTC and the Smoking Cessation program to be established pursuant to this Ordinance. The fees shall be automatically deposited to a separate trust fund for this purpose.

#### MUNICIPAL TOBACCO COUNCIL (MTC)

Section 13. Municipal Tobacco Council-A Municipal Tobacco Council (MTC) is hereby created to implement and monitor this Ordinance as well as to conduct educational awareness campaign, information dissemination programs, and capability building programs, for the constituents and enforcers. The Municipal Tobacco Council shall be composed of the following:

School Superintendents, Department of Education (DepEd)

The Municipal Tobacco Council shall not include as a member any person or entity who works for or on behalf of the tobacco industry, or who works to further the interests of the tobacco industry. No member of the Council shall represent or receive any contribution or compensation, directly or indirectly, whether financial or otherwise,

from the tobacco industry. The Municipal Tobacco Council and its members shall not deal with the tobacco industry or individuals or entities that work to further the interests of the tobacco industry, except to the extent strictly necessary to effectively regulate, supervise, or control the tobacco industry and tobacco products. These measures are necessary to protect the primary health objectives of this Ordinance and avoid conflict of interest for its enforcers.

Section 14. Civil Society Participation—Within thirty (30) calendar days from the effectivity of this Ordinance, the Municipal Health Office shall designate, with the approval of the Office of the Mayor, a representative(s) of one or more CSOs, with no tobacco industry relationship, affiliation, or membership, to form part of the Municipal Tobacco Council and assist in the implementation of this Ordinance.

#### Section 15. Powers and Duties of the MTC—Other than

- 1) Receiving, reviewing and processing reports of the complaints for violations of this Ordinance and
- 2) Deputizing enforcers under sections 12 to 20 hereof, the Municipal Tobacco Council shall have the following respective duties and responsibilities:

#### a) The Mayor shall

- 1. Act as Chairman of the Local Tobacco Control Board
  - b) The Municipal Health Office and SB Committee Chairperson on Health & Sanitation shall:
- 1. Act as Vice Chairperson and Co- Vice Chairperson of the Municipal Tobacco Council
- 2. Act as Chairperson of the Local Enforcement Team (LET) and Over-all Coordinator in the implementation and enforcement of this Ordinance.
- 3. Coordinate with the PNP in assigning a hotline or any other number to which violations of this Ordinance maybe reported by telephone call or by SMS and a person to operate the line and record
- 4. Develop and conduct orientation seminars for enforcers.

#### c) The MPDC and the BPLO shall:

- Act as Over-all in-charge in the city-wide information and education campaign of this Ordinance and other activities such as:
  - preliminary inspections and in monitoring violations of this Ordinance 1a)
  - developing and promoting a smoking cessation program 1b)
  - promoting awareness of this Ordinance and in encouraging public support and 1c) participation in its implementation and enforcement
  - 1d) developing and conducting orientation, seminars and trainings for enforcers
  - evaluating the performance of the MTC and the effectiveness of the implementation 1e) and enforcement of this Ordinance.
    - The Municipal Administrator or Representative from the Mayor's Office shall:
- 1) Facilitate mobilization of resources, authorization and deputization process, inspection and monitoring initiatives and closure orders.

#### e) The Municipal Engineering Officer shall:

- Conduct, together with the Municipal Health Office or on its own, inspection activities as provided in this Ordinance.
- Determine whether or not enclosed or partially enclosed public places, workplaces or other 2) public places, and point-of-sale establishments, comply with the requirements of this Ordinance.

#### f) The CSO Representative shall:

- 1) Assist in preliminary inspections and in monitoring violations of this Ordinance

#### h) DepEd REPRESENTATIVES shall:

- 1) Assist in preliminary inspections and in monitoring violations of this Ordinance

#### **ENFORCEMENT**

Section 16. Enforcement on Individuals. — Members of the PNP and Deputized Officers shall apprehend and issue Citation Tickets against persons caught smoking in places where such is prohibited. They shall forward copies of the tickets they issued to violators to the Municipal Treasurer's Office regularly, at least thrice a week.

Section 17. Enforcement on Public Transport. — Members of the PNP, TMU and/or LET duly deputized by the MTC shall inspect public conveyances during their regular hours of operation and shall issue Citation Tickets upon discovery of any violation of this Ordinance. They shall forward copies of the tickets they issue to violators to the Municipal Treasurer's Office regularly, at least thrice a week.

Section 18. Enforcement on Establishments. — Sixty (60) calendar days after the effectivity of this Ordinance, an inspection team composed of representatives from the Law Enforcement Team, Municipal Health Office, SB Committee on Health & Sanitation, Municipal Engineer's Office and the Business Permits and Licensing Office, shall conduct inspections of establishments and buildings to determine their compliance with the provisions of this Ordinance and certify the appropriateness of the designated smoking areas, taking into consideration the purpose of this Ordinance which is to protect non-smokers from the pernicious effects of tobacco smoke. Payment of required fees shall also be inspected, monitored and reported.

Regular inspection shall thereafter be conducted at least once every month or simultaneously with other regular inspections, whichever is more frequent, during normal hours of operation of the establishment.

A period of thirty (30) days shall be given to the management of the establishment to comply with the requirements of this Ordinance. Non-compliance with the requirements set forth in this section shall be a ground for cancellation of the business permit by the Mayor's Office.

In the course of inspection, the inspection team may apprehend individual violators and request the assistance of the PNP in doing so.

The inspection team shall issue a Citation Ticket against the establishment upon finding of non-compliance with or of any violation of this Ordinance. A Citation Ticket may be issued for each day that the establishment is found to be non-compliant.

Re-inspection of the establishment shall be done on any day after the issuance of the Citation Ticket, but in no case, not less than ten (10) calendar days after such issuance. If the establishment fails to comply with the obligations stated in the Citation Ticket upon re-inspection, the inspection team shall recommend the suspension of the license to operate of the establishment, consistent with Section 11 hereof.

Section 19. Civilian Participation in Enforcement -Within thirty (30) calendar days from the effectivity of this Ordinance, the MTC shall designate a Civil Society Organization (CSO) to discharge the duties and responsibilities enumerated in Section 15 (f) thereof.

The MTC may deputized qualified civilians as enforcers for any violation of this Ordinance. Any person can file with the MTC a report of or complaint for any violation of this Ordinance.

#### Section 20. Functions of Deputized Enforcers.

- a) Monitor and inspect the public places covered by this Ordinance;
- b) Report violations, issue citation tickets, and submit reports of compliance to MTC;
- c) Act as a complainant or witness in a criminal or administrative proceeding against violators of this
- d) Conduct a citizen's arrest pursuant to Rule113; section 9 of the Rules of Criminal Procedure when an individual violator refuses to cease smoking in a prohibited area even after fair warning has been given; and seek assistance from the PNP's in conducting an arrest.

#### HOTLINE AND CITATION TICKET SYSTEM

Section 21. HOTLINE-There shall be established a local hotline to which violations of this Ordinance may be reported, either by phone call, short message service (SMS), email, or other forms of communication. A hotline coordinator will be designated to receive information reported in the hotline so that appropriate action may be

Section 22. Citation Ticket System-Any and all violators of this Ordinance shall be informed of their violation and the penalty corresponding thereto by means of a Citation Ticket System.

- a) A citation ticket shall be issued to persons liable for any violation under the Ordinance. It shall contain, among others, the name and address of the violator, date, time and place of violation, name of the deputized enforcer, specific violation committed, the corresponding administrative penalty, and the due date for compliance in accordance with the ordinance.
- b) When a citation ticket is issued to a violator, the violator shall report to the City Treasurer on or before the due date stated in the citation ticket, which shall in no case be more than five (5) business days from the date of apprehension and issuance, in order to pay the fine imposed.
- Members of the PNP and other enforcers duly commissioned or deputized by the MTC shall have the power to apprehend violators of the Ordinance and issue citation tickets.
- PNP and deputized enforcers shall submit duplicates of the citation tickets issued to the Municipal Treasurer within three (3) business days. The Municipal Treasurer shall keep duplicates of all citation tickets issued to violators, and other records of violations of the Ordinance reported through other means, such as the hotline.
- The citation ticket booklet shall be issued by the Municipal Treasurer and distributed to enforcers and all other persons in charge with the enforcement of the Ordinance.

WHEREAS, the 1987 Constitution of the Republic of the Philippines provides that the State shall protect and promote the right to health of the people and instill health consciousness among them;

WHEREAS, Republic Act No. 7160, otherwise known as the Local Government Code of the Philippines empowers Local Government Units (LGU) in upholding of the general welfare of their constituents to include, among others, the promotion of health and safety;

WHEREAS, Section 5 of Republic Act No. 9211, otherwise known as the Tobacco Regulation Act of 2003, prohibits smoking in certain public places, whether enclosed or outdoors; imposes bans on tobacco advertising and imposes restrictions by banning sales in places frequented by minors;

WHEREAS, Section 24 of Republic Act No. 8749, otherwise known as the Philippine Clean Air Act of 1999, prohibits smoking inside enclosed public places, including public utility vehicles;

WHEREAS, Land Transportation Franchising & Regulatory Board Memorandum Circular 036, s. 2009, clearly prohibits smoking in all public utility vehicles and public transport terminals, requiring public utility vehicle operators to prominently display "No Smoking" signages in their authorized units and premises;

WHEREAS, the Philippines was the 15th largest consumer of tobacco in the world in 2002, ranks second in number of smokers in the 10-member Association of Southeast Asian Nations (ASEAN) and currently has one of the highest smoking rates in Asia, as well as some of the lowest cigarette prices;

WHEREAS, President Rodrigo R. Duterte's Executive Order No. 26, issued on 16 May 2017, provides for the establishment of smoke-free environments in public and enclosed spaces found within the territorial jurisdiction of the Philippines.

Thus Gov. Dennis "Delta" Pineda entreated Archbishop Charles Brown, apostolic nuncio to the Philippines, during the civil reception for the papal envoy at the Capitol here Tuesday.

The papal nuncio is scheduled to celebrate the Holy Mass on Sept. 8 in San Vicente Ferrer Parish in Barangay Calulut to commemorate the canonical coronation of the Virgen de los Remedios in 1956 or 65 years ago. [To be livestreamed on Facebook page of the Roman Catholic Archdiocese of San Fernando.]

The then Diocese of San Fernando's first prelate, Bishop Cesar Ma. Guerrero, began the crusade of penance and charity in 1952 to end the social unrest in the province as a result of landlessness.

The Vatican, through Pope Pius XII, decreed the canonical coronation of the image in 1956, signaling the start of the sharing of lamac (offerings) that helped bridge the gap between the rich and poor in the province.

The Virgen de los Remedios has since been consecrated as the patroness of Pampanga.

To this day, the image of the Virgen and that of the Santo Cristo del Perdon (Lord of Pardon) travel from town to town, the crusade sustained by prayers and acts of generosity to poor families.

At the Capitol reception, an 18-inch image of the Virgen de los Remedios de Baliti (as the original pilgrim image was named) sculpted by Maestro Wilfredo Layug and a Capiz parol (lantern) handcrafted by Rolando Quiambao were gifted by Layug and Governor Pineda and Vice Governor Lilia Pineda to Archbishop Brown. He was shown an

exhibit of Marian images and was treated to songs by Arti Sta. Rita.

Vice Governor Pineda and the sangguniang panlalawigan presented Resolution No. 6926 expressing the province's deepest appreciation for the presence of the papal nuncio in the Sept. 8 event.

The papal envoy hailed the people of Pampanga for their "extraordinary way" of expressing the faith in their culture and heritage.

"There is a beautiful harmonization of Filipino values and Christianity in the Simbang Gabi, Giant Lantern Festival, songs and devotion to the Virgen de los Remedios," he said.

He also expressed admiration for Filipinos who spread the faith all over the world. Archbishop Brown further relayed the love of Pope Francis for Filipinos. The Pope celebrated the Mass at the St. Peter's Basilica in the Vatican City for the 500 years of Christianity in the Philippines.

On Wednesday, Archbishop Brown concelebrated with Archbishop Florentino Lavarias and Archbishop Emeritus Paciano B. Aniceto the Holy Mass celebrating the 65th anniversary of the canonical coronation of the Virgen de los Remedios.

Held in the early morning at the San Vicente Parish Church in Barangay Calulut here, the celebration was livestreamed on the Facebook page of the Roman Catholic Archdiocese of San Fernando. Health protocols limit-
