

EdSa gets CSC award

CITY OF SAN FERNANDO -- Mayor Edwin "EdSa" Santiago was bestowed anew the Presidential Lingkod Bayan Award, one of the most coveted titles given by the Civil Service Commission to outstanding government workers.

This is the third conferment of awards to Santiago by the CSC under its Honor Awards Program (HAP): the Presidential Lingkod Bayan Award in 2016, and the Top Partner Individual in 2018.

For the Central Luzon region, only three civil servants received the award for 2021 under the individual category, namely Santiago, Dr. Claro Mingala of the Nueva Ecija Philippine Carabao Center, and Mayor Mario Salvador of San Jose, City Nueva Ecija.



21-M Filipinos fully vaxxed

CLARK FREEPORT -- Some 21 million Filipinos have been fully vaccinated against the coronavirus disease, as the government recorded an average of 400,000 jabs administered daily in September.

At Monday's 'Sa Bakuna, Panalo Ka' event held at SM

City Clark, National Task Force Against Covid-19 chief implementer and vaccine czar Carlito Galvez Jr. said that from March 2021 to date, a total of 46,251,087 vaccine doses were administered.

"Of the said number, 28,108,548 Filipinos received their

first dose. We are expecting this to rise to 30 million this coming week. About 21,737,744 of these individuals were already fully-vaccinated, which is about 28 percent of our target population," he disclosed.

In terms of vaccine deliveries and

NLEX's sustainability efforts yield carbon footprint reduction

THE NLEX Corporation has reduced its carbon footprint through its solar photovoltaic power system installed in select toll plazas.

In its recent data, the total energy harvested for 2020 was 171 megawatt-hours which gained carbon emission savings of 134,232 kilograms or equivalent to 4,006 trees planted. Record shows that the Bocaue Barrier has generated the highest CO2 emission savings with 50,618 kgs or equivalent to 1,511 trees planted. The Balintawak Toll Plaza came in second as it yielded CO2 emission savings of 42,980 kgs or corresponding to 1,283 trees planted.

The tollway company first harnessed solar power in its Meycauayan southbound toll plaza in 2018 followed by the toll plazas in Balintawak, Bocaue, Mexico, Angeles, San Fernando southbound, and Harbor Link (Karuhatan) in 2019 to boost energy efficiency and contribute to the reduction of carbon emissions along the expressway network.

In the coming years, NLEX is looking into installing solar power panels in more NLEX and SCTEX toll plazas to further lessen the company's carbon footprint.

"The things we do are guided by our commitment to the greater good. We are seizing the opportunity to do more for our motorists and environment by improving our operational efficiency and promoting sustainability. This is deeply ingrained as one of our core values," said NLEX Corporation President and General Manager J. Luigi L. Bautista, highlighting that "ever since, we have been complying with our responsibilities for the environment as an ISO 14001:2015 (Environmental Management System) certified company.

Aside from using solar power, NLEX has been incorporating sustainable energy in its operations through its LED lighting or energy efficient roadway lighting systems, closed circuit television (CCTV) cameras, and variable mes-

sage signs.

Since 2006, NLEX has encouraged green practices by spearheading tree planting initiatives within the expressway. It has been implementing the "Greening the NLEX" program to mitigate the effects of global warming and environmental imbalance. The company has also been conducting monthly clean-up drive in the Tullahan River since 2010 together with volunteers from select host communities in Valenzuela City, Quezon City, and Caloocan City.

Using renewable energy in the company's operations is in line with the entire Metro Pacific group's commitment to help the Philippines meet the United Nations Sustainable Development Goals particularly UNSDG 7 (Affordable and Clean Energy) and UNSDG 13 (Climate Action).

NLEX Corporation is a subsidiary of the Metro Pacific Tollways Corporation (MPTC), the toll road arm of the Metro Pacific Investments Corporation (MPIC).

panga has as long, and lasting, political pedigree as the Lazatin, the patriarch starting in 1941.

Former President Gloria Macapagal-Arroyo, herself of presidential lineage from the venerable Apung Dadong, is a shoo-in anew for Pampanga's 2nd congressional district seat, with an eye for the speakership of the House again. Her son, incumbent Rep. Juan Miguel, Mikey to everyone, giving way.

In the 3rd District, even as he seeks his third and last term, Rep. Aurelio "Dong" Gonzales Jr. has fielded his daughter Alyssa Michaela for the district's slot in the provincial board and his son Aurelio Brenz for the San Fernando city council.

In the 4th District, term-ending Rep. Juan Pablo "Rimpy" Bondoc is practically returning a family heirloom to elder sister Anna York Bondoc-Sagum, the House seat alternating between the two siblings since the death of their father Don Egmidio in 1997 while in office. Anna York is married to incumbent San Luis Mayor Dr. Jayson Sagum who is also seeking reelection.

A new batch of second generation politicians takes to the provincial stage. Reelection Mabalacat City Mayor Crisostomo Garbo's three-term councilor daughter Win-Win aspiring for the provincial board.

Outgoing board member Ferdinand Labung ceding his 3rd District seat to his son Lucky who is incumbent councilor of Bacolor.

Guagua Vice Mayor Sajid Eusoof, son of former Mayor Israel "Baby, The Name You Can Trust" Eusoof, has also turned his sight on the provincial board.

In the City of San Fernando, incumbent councilor Ralph Deinn Henson will have his father, many-time board member Rosve for mayoralty standard bearer.

Of second generation politicians, the most candidates could be coming from the brood of once-forever Mabalacat City Mayor Marino "Boking" Morales with daughter ABC president Marjorie Morales-Sambo and son Ignacio Miguel running for the city council, and son incumbent councilor Dwight in the Patrol Partylist. Boking himself is reported to be filing his COC for mayor anew on Oct. 8.

A case of the wife over the husband obtained in Arayat town with the term-ending Mayor Emmanuel "Bon" Alejandrino stepping down to the vice mayoralty for his wife Madeth aka "Madir" to take a shot on the mayorship.

Politics goes conjugal too with Sta. Ana Vice Mayor Reinhart "Soy" Guevarra contesting the mayorship while his wife incumbent Mexico councilor Trina Dizon seeking reelection.

Family feud

A contradiction, indeed, an anomaly, to the state of moonlight-and-roses among political families here is the thistle-and-thorn situation of the Floreses of Macabebe town.

But for short two one-term interregnums, the Flores family reigned over the town since the days of their patriarch Domingo in the 1960s, the mayorship reduced to nothing more than a family rigodon.

Incumbent Mayor Leonardo "Bong" Flores will be challenged by his sister, incumbent Vice Mayor Mayor Annette Flores-Balgan, herself a three-term mayor who was his successor and then predecessor.

The vice mayoralty will be contested by Flores' son Vince against Balgan's daughter Mary Clare Therese aka Bembong who are both incumbent councilors.

The Pinedas

Of Pampanga's foremost family in politics as well as in philanthropy, only board member Mylyn Pineda-Cayabyab has filed her COC – for reelection – as of Oct. 5, ending speculations that she would rise to the vice governorship in place of her mother.

"May misyon pa po si Nanay sa pagbibigay ng higit pang kalinga sa ating mgas kababayan. Ay, mas malakas pa nga po siya sa akin," Cayabyab said erasing all doubts of Vice Gov. Lilia "Nanay" G. Pineda retiring from politics after a stellar performance as multi-term Lubao mayor, board member, three-term governor, and vice governor.

Which inadvertently raised speculations whether Gov. Dennis "Delta" Pineda would seek reelection or switch place with Nanay.

Though Lubao Mayor Esmie Pineda has not filed her COC as of this writing, she is expected to run for reelection.

Bataan

A modus vivendi is working perfectly for the powerful Garcia and Roman political clans in Bataan, notwithstanding different party affiliations.

Scions of the late Enrique "Tet" Garcia, congressman and governor, incumbent Gov. Albert "Abet" Garcia and 2nd District Rep. Jose Enrique "Joel" Garcia III, both on their last terms, are switching positions for the 2022 polls.

Another brother, Balanga City Mayor Francis Garcia who is in his third and last term, is seeking reelection. First cousin Vice-Gov. Cris Garcia is seeking reelection for her last term.

First District Rep. Geraldine Roman filed her COC for her last term while her brother, lawyer Tonyboy Roman, in his first run for public office, is eyeing one of the 10-member seats in the sangguniang panlalawigan.

All Garcia and Roman candidates have remained unopposed as of the fifth day of filing.

Nueva Ecija

Cracking is the once monolithic Joson political dynasty in Nueva Ecija that dates back to pre-Martial Law era with its founder Gov. Eduardo "Tatang" Joson.

Former Gov. Eduardo Nona to "EdNo" Joson who also served as representative to the Batasang Pambansa and the House of Representatives of Nueva Ecija's first congressional district, is set to slug it out with his younger brother incumbent Mariano Cristino "Boyot" Joson of Quezon town, deemed as the last stronghold of the clan.

EdNo is backing the candidacy for governor of Palayan City Mayor Adrienne Mae Cuevas, while Boyot is supporting incumbent Gov. Aurelio Umali.

Their nephew, former Vice Gov. Edward Thomas Joson who is the eldest son of their eldest brother, the late Gov. Thomas Joson III, is seeking the said post under Cuevas and against Umali's brother, reelectionist Vice Gov. Anthony Umali.

Former Gov. Czarina Umali, the incumbent governor's wife, is seeking a comeback as representative of Nueva Ecija's 3rd congressional district against incumbent Rep. Ria Vergara, who herself is part of the powerful political family that includes Cabanatuan City Mayor Myca Elizabeth Vergara and Vice Mayor Julius Cesar Vergara.

Popular Gapan City Mayor Emerson Pascual has filed his candidacy for the 4th congressional district of Nueva Ecija. His sister board member Joy Pascual aspires to take his place as mayor. With correspondents' reports

'We see traces of the dark days of Martial Law'

WE, THE undersigned convenors of pro-democracy coalition 1SAMBAYAN, strongly denounce the recent order of President Duterte barring his Cabinet and other executive officials from attending legislative investigations in the Senate on the anomalous transactions of Pharmally with the government, specifically with PS-DBM, involving overpriced medical supplies in 2020 and 2021 at the height of the pandemic.

We see traces of the dark days of Martial Law in the president's recent pronouncements: no respect for the rule of law, no separation of powers between branches of government, and no regard for due process, all done to protect the interest of a private company, his Chinese friends and their friends in government. It is the same heavy-handed, dictatorial and authoritarian despotic rule employed by the late President Ferdinand Marcos.

We appeal to the PNP and the AFP to remain loyal to the country and the people, and ignore this illegal and unconstitutional order, even if it came from their commander-in-chief, who is certainly not acting like the father of a nation. It is an abuse of his commander-in-chief powers, and it does not give him carte blanche to use it to prevent other agencies of government from performing their mandates.

We also appeal to the people to put an end to this regime, to always be vigilant and alert, and see the signs of a return of Marcosian authoritarian tactics: the closure of ABS-CBN, widespread graft and corruption, economic recession, and numerous tales of extrajudicial killings and violations of human rights.

We also encourage everyone, especially those who will cast their votes come May 2022, let us unite in choosing leaders who will put the people first above their own interests and those of their friends, who will restore democracy and strengthen our democratic institutions, and who will steer our country to recovery from this pandemic and economic decline.

Unburdening oneself

IT IS easy to guess why Martha is feeling burdened in our Gospel today. It's not really because she has a lot of things to do in the kitchen. In fact I think she's quite used to doing it all efficiently. I think she is burdened because she wants to do something else.

Her sister is in the living room, enjoying the company of Jesus, listening to his teachings. She wants to do that too. But she seems to have convinced herself that she had no choice but to do all the cooking in the kitchen instead. That is how she has defined her role. She is also burdened by the definition of a woman's role as presupposed in Jewish society: a woman belongs to the kitchen. That her role is to serve the men. She was quite used to playing this role before, until her sister started going against it. At that moment, Mary chose the role of a disciple seated at the Rabi's feet and learning from him, taking to heart the Word of God so she could serve it too.

Actually, there are two persons cooking up something in the Gospel. Martha cooking up literal food in the kitchen, and Jesus cooking up spiritual food in the living room, and teaching Mary how to do it. In case you did not know, preparing for a homily like this is a whole art and discipline in itself. It's very much like preparing a dish, making it palatable, and serving it well. And believe me, we do not always succeed in it.

Perhaps because I love to eat like a Kapampangan, I've always loved to learn how to prepare food myself. I used to enjoy watching my mother do it in the kitchen

when I was a little boy. There were times when I wanted to assist her so I also could learn to cook, but I was always called to do the men roles in the garden while my sisters did the women roles in the kitchen. There is really something oppressive about this type-casting of roles. I wonder how many wives feel so burdened when their husbands just cannot include among their men roles some share in babysitting, changing diapers or putting their babies to sleep, as if it was below their dignity to do so.

I think Jesus has some important tips in today's Gospel for burdened people like Martha on how to UNBURDEN THEMSELVES. First, don't do what you need to do with a heavy heart. Even the lightest task can become a heavy burden if you carry it out reluctantly, if you cannot give your whole heart to it. Like the reluctant prophet Jonah in our first reading. The story of Jonah will continue to be read tomorrow, so let me just reserve it for tomorrow.

The second tip is, to unburden oneself with the overload of stereotypes and pressures to live up to societal expectations. We only make ourselves miserable when we do things against our will, when we do things only to comply with an obligation or to meet up to

someone's expectations.

Obedience is not about surrendering to God's will like you have been defeated and had no other choice. Obedience is rather about embracing God's will as your own, about freely responding to his invitation.

In Matthew Chapter 11, Jesus gives his disciples a good summary of what it takes to unburden our lives and living what Milan Kundera calls "The Unbearable Lightness of Being". Jesus says, "Come to me all you who labor and are burdened and I will give you rest." He offers a secret to living the lightness of being, but his solution is paradoxical, "Take my yoke upon your shoulders and learn from me."

What he is trying to tell us is, "What often burdens us in this world is not really the weight of the loads that we carry but the manner in which we carry them." As they would say in Tagalog, "Wala iyan sa dinadala. Nasa nagdadala." I am sure the cross that he carried to Calvary was pretty heavy too. What lightened it was his will to embrace the Father's will. That was all that it took to make his yoke easy and his burden light. To carry it as an act of love, for the redemption of the world.

Digong's Riddle

There probably hasn't been a Philippine president as riddlesome as the one whose lease in Malacanang is going to expire in less than year. In fact, President Duterte started his journey to the presidency on a riddle; he's now embarking on a version of a sunset boulevard on another riddle.

Prior to launching his presidential bid in 2016, Duterte announced that he was actually retiring from politics. He had been there, done that, and apparently was already tired of being in the game for decades. As it turned out, it was a political ruse, ostensibly to keep the other presidentiables', notably from the Liberal Party, guard down.

Looking back, the element of surprise worked partly, perfectly to pave his way to the Palace by a plurality, not majority, mandate. If Sen. Grace Poe and then Secretary Mar Roxas only agreed to join forces, with either dropping to be the vice presidential bet, history would have been different. As always, the rear view mirror is perfect foresight.

Last week, he mouthed with the same passion and conviction the word 'retire' again, as he accompanied his most trusted aide, Sen. Bong Go who filed his certificate of candidacy for vice president. Obviously, there was already a done deal, a modus vivendi, a fait accompli. Duterte would drop his vice presidential plan in favor of Go. It's a matter of going through the motion.

There is just one business matter left to be settled: who will be Go's running mate? Almost at the same time, Sara Duterte Carpio filed her reelection bid as Davao City Mayor. This further wrapped the riddle in an enigma. A Sara-Bong tandem doesn't look like a bright political idea, going against the time-honored text that politics is supposed to be an addition, political stature and geography wise.

Duterte explained to the public why he was abandoning his earlier plan to go by the backdoor to the presidency, as Constitutionalists saw it and were ready to challenge his political audacity in court. He realized, he said, with a semblance of mental honesty, that most Filipinos – about 60 percent of them the survey said--- frown at his vice presidential target.

As a lawyer, Duterte was aware of the possible pushback. He was acting, of course, consistently with the trademark of an autocrat or authoritarian: opacity, if not duplicity. His giving way to Go could be part of a bigger riddle which is still being played out. Go, for all we know, may just be a consenting adult to the whole riddle. He's the go-to guy, with pun intended.

On Tuesday, the biggest part of the riddle may have been revealed with the Ferdinand "Bongbong" Marcos Jr. making his presidential bid official by filing his certificate of candidacy. Like Go, he has no running mate. It looks like a simple arithmetic: 1 plus 1 is equal to two. But it may not be as simple as that, as riddles go. Ultimately, go may be, well, gone.

The surveys could be at the heart of Digong's riddle. The son and daughter of two different strong men, dictators if you will, haven't moved from their ranks as the two top seeds in the run-up to the 2022 presidential race. Bongbong boasts of a Solid North while Sara has most of Mindanao in her pocket. Many Filipinos don't seem to mind their fathers' brand of leadership, something that continues to befuddle Vice President Leni Robredo, given how the country has suffered under authoritarian rule, with or without the pandemic. Robredo's apparent indeciveness to throw her hat into the presidential derby maybe a haunting offshoot of such perception of reality. Can you imagine she's still at the bottom in surveys despite beating Bongbong in the 2016 vice presidential race? Another riddle.

"With one look, they'll forgive the past, they'll rejoice I've returned at last," actress Glen Close, playing the role of silent movie star Norma Desmond, sang in the Broadway play 'Sunset Boulevard'. The thought chills the spine.

The full answer to Digong's riddle will be known soon, Presidential Harry Roque assured all and sundry. It will either be on October 8, the last day of filing, or November 15, the final day of substitution. The final revelation is part of the political drama, providing a temporary diversion to the ongoing Senate investigation into the Pharmally controversy, and the impending probe of the International Court of Justice, both of which could lead to Malacanang.

The riddle is inevitably a part of our national political narrative in our continuing struggles against widespread corruption in government, on the one hand, and trampling of human rights, on the other, even as we look up to the rubric of democratic institutions as our defensive tools.

If eventually, it will turn out to be a Bongbong-Sara tandem, and it looks like it will be as day follows night, wholly consistent with the logic of a Digong riddle. It's a riddle, alright, but not necessarily synonymous with principle.

"The beauty and riddle of studying the motives of any politician is trying to decide which is idealism or what is self interest, and often we are left to conclude that the answer is a mixture of both," Britain's Prime Minister Boris Johnson said.

Which one weighs heavily can be inferred from historical experience.

But, with two strongmen' children looming as the next two top leaders of the nation in the next six years, it's another riddle that many, if not most, have not learned the hard lessons. Emerson suggests that the key to a riddle is another riddle.

AN ORDINANCE GRANTING LOCAL FRANCHISE TO OPERATE A VILLA WITH SWIMMING POOL AND FUNCTION AREA RENTAL AT BLK. 3, LOT 12 & 14, SAMPAGUITA ST., MALINOVILLE SUBD., BARANGAY MALINO, CITY OF SAN FERNANDO, PAMPANGA AND FOR OTHER PURPOSES

EXPLANATORY NOTE

WHEREAS, the City Government of San Fernando, Pampanga has enacted Ordinance No. 2015-024, otherwise known as the Games and Amusement Code of the City of San Fernando, Pampanga, and later amended by virtue of SP Ordinance No. 2019-008, to regulate and protect people going and employed in amusement centers, carnivals, fairs, resorts, amusement parks, cockpit arenas, internet cafes, e-bingo, games and the traditional bingo parlors, karaoke bars, among others;

WHEREAS, a certain Roldan S. Bautista, registered co-owner of property located at Blk. 3, Lot 12 & 14, Sampaguita St., Malinville Subd., Barangay Malino, this city, submitted an application for a franchise to operate a Villa with swimming pool and function area rental in the property abovementioned, which was included in the Order of Business of the Sangguniang Panlungsod on September 27, 2021;

WHEREAS, the Sangguniang Barangay of Malino, this city, passed Barangay Resolution No. 012 s. 2021, "interposing no objection" to the operation of the Villa with swimming pool and function area rental in the property abovementioned;

WHEREAS, the application was referred to the Committee on Games and Amusements which subsequently conducted a series of committee hearings and studies to determine the merit and purpose of the application to operate the above-mentioned Villa with swimming pool and function area rental;

WHEREAS, the Sangguniang Panlungsod found the application meritorious and in order, thereby grants the applicant, Roldan S. Bautista, the authority to operate the said the Villa with swimming pool and function area rental; renewable every three (3) years pursuant to SP Ordinance No. 2019-008;

NOW THEREFORE, BE IT ORDAINED by the Sangguniang Panlungsod of City Government of San Fernando, Pampanga, in session assembled, adopts as it hereby adopts the following Ordinance:

ARTICLE I
Title

Section 1. Title- This Ordinance shall be known as:

“AN ORDINANCE GRANTING LOCAL FRANCHISE TO OPERATE A VILLA WITH SWIMMING POOL AND FUNCTION AREA RENTAL AT BLK. 3, LOT 12 & 14, SAMPAGUITA ST., MALINOVILLE SUBD., BARANGAY MALINO, CITY OF SAN FERNANDO, PAMPANGA AND FOR OTHER PURPOSES”

Section 2. Definition of Terms – As used in this Ordinance, the following terms shall mean:

2.1 Business – refers to the trade or commercial activity regularly engaged in as a means of livelihood or with a view of profit;

2.2 Charges – refers to a pecuniary liability, as rents or fees against persons or property;

2.3 Tax – refers to an enforced contribution usually monetary in form, levied by the law-making body on person and property subject to its jurisdiction for the precise purpose of supporting governmental duties;

2.4 Fee – means a charge fixed by law or ordinance for the regulation or inspection of a business or activity; it shall also include charges fixed by law or agency for the services of a public officer in the discharge of his official duties;

2.5 Franchise – is a right or privilege affected with public interest which is conferred upon private persons or corporations, under such terms and conditions as the government and political subdivisions may impose in the interests of the public welfare.

ARTICLE II
Authority to Operate

Section 1. Authority to Operate – There is hereby granted to a certain Mr. Roldan S. Bautista, the authority (local franchise) to operate the said Villa with swimming pool and function area rental located at Blk. 3, Lot 12 & 14, Sampaguita St., Malinville Subd., Barangay Malino, this city

Section 2. Duration of the Authority to Operate – The Authority to Operate herein granted to Mr. Bautista shall be for three (3) years only, retroactive from January 1, 2020 up to December 31, 2023, subject however to the option of Bautista to renew thereafter.

ARTICLE III
Payment of Business Taxes

Section 1. Payment of Business, Fees and Charges – Business Taxes, Fees and other charges shall be imposed and made payable yearly by Mr. Bautista to the City Treasurer’s Office during the lifetime of this Ordinance and its subsequent renewal.

ARTICLE IV
INFECTION CONTROL PROTOCOLS FOR AMUSEMENT/ LEISURE ESTABLISHMENTS

Section 1. The said Villa with swimming pool and function area rental shall at all times adhere to the following Health Protocols:

- 1.Face masks and face shields shall be worn at all times while inside the arcade;
- 2.Implementation of physical distancing of 1- meter apart within the store premises and at queuing areas;
- 3.Employees and customers are required to fill out an employee health declaration form or customer contact tracing form upon entry for contact tracing purposes;
- 4.Maximum number of customers shall be posted at the entrance and strict control of customer inflow shall be observed;
- 5.Separate entrance and exit points shall be implemented, and a queuing line outside the arcade with physical distancing markers shall be installed;
- 6.Indoor air ventilation systems should conform with applicable protocols and standards.
- 7.Sanitation areas shall be installed in accessible locations;
- 8.Signages reminding customers to observe minimum health standards, avoid risky behavior such as shouting and talking loudly shall be posted within the establishment;
- 9.Employees shall wear proper PPE, including both face mask and face shield, and shall practice proper handwashing during their duty;
- 10.Company shall delegate at least one (1) Safety Health Officer to:
 - a.Monitor all staff through temperature checking, monitoring of covid symptoms and assessing mental health status daily;
 - b.Report employee/s to City Epidemiology and Surveillance Unit (CESU) who develop covid symptoms or who tested covid positive;

- c. Report to TF WASH of LGU-CSFP for disinfection;
- d. Remind employees to practice minimum public health standards;
- e. Monitor regular cleaning of all contact surfaces such as doors, knobs, tables, windows, etc. at least every 2 hours; and

11. Regular daily sanitation/disinfection of the establishment should be done before and after the activity.

**ARTICLE V
Penalty Clause**

Section 1. Penalty – Failure on the part of Mr. Bautista to comply with any or all provisions of this Ordinance shall be meted the following fines and penalties, over and above the penalties imposed by the Office of the City Treasurer of the City of San Fernando, Pampanga, to wit:

a. For First Offense – Any person, natural or juridical, who violates this Ordinance for the first time shall be fined the amount of Three Thousand Pesos (PhP3,000.00) and a stern warning of revocation of the Business Permit to operate and or the imposition of the penalty of imprisonment for six (6) months;

b. For Second Offense - Any person, natural or juridical, who violates this Ordinance

For the first time shall be fined the amount of Five Thousand Pesos (PhP5,000.00) and the cancellation of the Business Permit to operate with the penalty of imprisonment of one (1) year; without prejudice to the filing of other criminal cases in violation of other existing national laws.

The officers of the juridical person such as the manager, operator/administrator or any person in-charge of the management of the said Villa with swimming pool and function area rental, shall be directly responsible for its operation and shall be fined and penalized as that of the natural person.

**ARTICLE VI
Miscellaneous Provisions**

Section 2. Repealing Clause – Local Ordinance, Resolutions, Orders, Rules and Regulations and other issuances of the City Government of San Fernando, Pampanga that are inconsistent with this Ordinance are hereby repealed,

amended and modified accordingly.

Section 3. Separability Provision – If for any reasons, any section of this Ordinance, or any portion hereof, or the application of such section or provision, or portion hereof to any person, group or circumstance is declared invalid or unconstitutional, the remaining provisions of this Ordinance shall be in full force and effect.

Section 4. Effectivity – This Ordinance shall take effect immediately after its approval, publication in a newspaper of general circulation in the Province of Pampanga and the posting of the same in the city’s Bulletin Board and conspicuous places.

procurement, Galvez reported that a total of 77.4 million vaccine doses were already delivered in the country from February 2021.

These include 48.7 million doses procured by the national government; 19.6 million doses donated through the Covax facility; 5.3 million procured by the local governments and private sector; and 3.6 million donated by other countries.

"We are expecting more deliveries this 4th quarter from different manufacturers. Based on our latest negotiations with vaccine makers, we are confident that at least we will be receiving 100 million vaccines by the end of October. With this, we have also recalibrated our vaccine supply allocation so that 89 percent are now distributed to the provinces in order to boost vaccination rate at the local government," he said.

For his part, NTFAC

deputy chief implementer Vince Dizon assured that despite criticisms, the national government will continue to work hard to achieve the 70 percent target of vaccinated Filipinos at the end of the year or early next year.

Meanwhile, Health Secretary Francisco Duque III called on the local governments and local chief executives to always keep their line list of vaccinated individuals updated because this is a very important aspect or part of the national vaccination operations.

He also cited the importance of strong public and private partnerships in boosting vaccination coverage in the country.

Aside from vaccination, Duque also reminded the public about the importance of effective information dissemination, as well as the observance of minimum public health standards in order to have full protection against Covid-19. — **Marie Joy S. Carbungco/PIA-3**


