

P92-M in ghost projects feared lost in 'Garbo-Boking collusion'



No pending case

CITY OF SAN FERNANDO -In what could be a response to the story of an alleged "Garbo-Boking collision" over the COA-flagged P92 million ghost projects during his term, former Mabalacat City Mayor Marino P. Morales posted on his FB page on Tuesday a clearance from the Ombudsman certifying that the graft office has no records of any pending criminal and administrative cases against him as of 18 December 2019.

ABALACAT CITY -- Veteran broadcaster and Mabalacat mayoral bet Diosdado "Deng" Pangilinan expressed fear of what he called "Garbo-Boking collusion" over the P92-million city funds flagged by the Commission on Audit as having been spent for "non-existent" projects.

Pangilinan was referencing incumbent Mabalacat City Mayor Crisostomo Garbo and his immediate predecessor Marino "Boking" Morales

In a notice of disallowance in August 2018, COA said the payments made by the Mabalacat local government to A.L. Dare Construction for slope protection works along Sapang Balen and Quitangil creeks in 2016, when Morales was mayor, violated procure-

Pampanga village chair shot dead

CITY OF SAN FERNAN-DO – A barangay chairman of Guagua, Pampanga was shot dead around 9:10 p.m. Monday in Barangay Sto. Cristo of the said town.

Police identified the fatality as Barangay Sto. Nino chairman Ranier Asban, 45.

According to witnesses, Asban was standing at an Echo gas station talking on his cellphone when a man casually walked towards him and repeatedly shot him before escaping on board a motorcycle heading towards Feeder Road in Sto. Cristo.

Two shots hit Asban on the face and one on his forearm.

Police have yet to determine the motive for the shooting and the identity of the suspect. A dragnet operation was immediately launched and flash alarm raised for the possible arrest of the suspect who was described as wearing a black T-shirt, short pants, and blue surgical facemask. *Punto News Team*

AC deploys 2 ronda buses for booster shots inoculation

ANGELES CITY — The city government here under the leadership of Mayor Carmelo "Pogi" Lazatin, Jr. has deployed two ronda buses in the 33 barangays starting on January 17, 2022 to give booster shots to Angeleños who have been fully vaccinated on or before October 31, 2021

Mayor Lazatin said this is to bring the vaccines closer to the people thru the Ronda Bakuna sa Barangay, ramping up the efforts to fasttrack the delivery of booster shots to avoid the newest Covid-19 Omicron variant.

The deployment of ronda buses will also be done via sched-

ule to ensure observance of safety health protocols, Lazatin explained.

According to Lazatin, the city has decided to deliver booster inoculation thru the Ronda Bakuna to ensure the safety, health, and welfare of his kababayans as well as the employees at the

356 AC govt't employees undergo antigen testing

ANGELES CITY — Some 356 city government employees here have underwent free antigen testing on January 17, 2022.

Mayor Carmelo 'Pogi' Lazatin Jr. said this is to ensure the safety of the employees by early detection of the virus.

"Sa kasalukuyan po, ang working arrangement pa rin natin sa city hall ay skeletal workforce, seven day work week schedule pa rin po. Ipinapatupad po natin ito bilang pag-iingat sa ating mga empleyado," Lazatin shared.

The free antigen testing conducted by the city government is in partnership with Monsour Del Rosario.

Lazatin said that employees who have been tested positive were assessed by health workers from Rafael Lazatin Memorial Medical Center led by Dr. Froilan Canlas, after the staff of the Ange-

les City Disaster Risk Reduction and Management Office led by Rodolfo Simeon transferred them to RLMMC.

According to City Health Officer Dr. Verona Guevarra, they will be allowed for self-isolation once assessed by the Barangay Health Emergency Response Teams, since the city government is now adopting the guidelines of the Department of Health for home isolation and quarantine of fully vaccinated individuals.

Dr. Guevarra also said that most patients who are allowed self-isolation are those who have mild symptoms.

Further, Lazatin's Chief Adviser IC Calaguas explained that if a patient has no capability for self-isolation, lacking adequate facilities, he or she will be taken to the designated quarantine centers of the

city government.

The city on January 4, 2022 has launched the city's telemedicine hotline that Angeleños can access for free 24/7 via phone calls and Messenger, intended for medical concerns of Covid-19 patients that are currently at home isolation or quarantine.

The hotline are as follows: 0915 927 0554; 0915 927 0549; 0915 927 0512; 0969 061 9531; 0969 061 9532; 0969 061 9578; and 0969 061 9535.

The prescribed medicines for them will be then delivered via house-to-house.

Lazatin extended his gratitude to Del Rosario for his initiative to assist the city government in this time of the pandemic.

He is also reminding Angeleños to be vigilant and to follow the minimum health protocols.



DILG urges barangays in CL to invest in nutrition

CITY OF SAN FER-NANDO, Pampanga (PIA) -- Department of the Interior and Local Government (DILG) called on barangay officials in Central Luzon to invest in nutrition, citing that a healthy barangay is needed to build a resilient community.

DILG Regional Director and Regional Nutrition Committee Vice Chair Karl Caesar Rimando said nutrition is one of the very important sectors that local governments should pay attention to, therefore it is important to include nutrition programs, projects, and activities in the development plans of local governments.

"We know that as barangay leaders, you know the basic needs of your community better. You fully understand the situation of your barangay. Hence, you are the ones who know very well what are the programs, projects, activities that the barangay should pay attention to. Hopefully we do not forget the programs for the nutrition of our youth," he said.

The director hoped that as the barangays prepared their devolution transition plan for the implementation of the Mandanas-Garcia

ruling, they considered the nutritional needs of their constituents and prepared their barangay nutrition programs in line with their barangay nutrition action plan and the Philippine Plan of Action for Nutrition.

Among the programs that local governments should prioritize, Rimando said, is the First 1,000 Days program as this plays an important role throughout the development of a child.

"It is very important that our youth get the necessary nutrition interventions so that they can grow to be productive members in the society. By investing and paying attention during this time, it will bring healthy youth and enthusiastic leaders of the country in the future," the DILG official noted.

Other programs that he mentioned are supplementary feeding program for underweight children, diet program for overweight, Operation Timbang Plus, and nutrition month celebration, among others.

In terms of funding, he said that barangays can ask the support of city, municipal, or provincial nutrition committees for nutrition programs that need to be addressed but cannot be funded by the barangay.

COA noted that the contractor under Morales claimed to have spent on four projects namely the first Phase Sapang Balen Creek project P22,443,500; costing the last phase of Sapang Balen Creek project P39,985,500; the first phase of the Quitangil Creek project costing P17,382,700; and the last phase of the Quitangil Creek project costing P18,885,000.

COA said the projects were "duplication of DPWH projects of Pampanga's 3rd Engineering District." It

also cited the "ineligibility of the lone bidder and eventual contract awardee for non-compliance with various government requirements, such as complete set of approved plans, technical specifications, bill of quantities by the bidder, and BAC resolution recommending the award." It noted "irregularities in the conduct of bidding and in the bidding documents."

"These are all mandatory requisites and requirements under Republic Act No. 9184 or the Government Procurement Reform Act," COA said.

COA then asked for the refund of the P92 million to the local government coffers, giving Morales, city hall employees involved and the private contractor six months within which to return the amount or file an appeal. The respondents reportedly opted to file an appeal even as the six-month period is about to expire.

Plunder

In January 2019, plunder charges were filed in the Ombudsman against Morales and other respondents by two officers of the Mabalacat City Traffic Enforcement Group (MCTEG) on the case of P92-million ghost projects.

Serving as the legal counsel for the complainants, city administrator Atty. Emmanuel Ignacio was cited in an interview with Punto as saying that the criminal case was based on findings of a probe he headed in 2018 indicating that "some P92 million worth of infrastructure projects reported by the Morales administration were actually projects funded and done by the DPWH."

Ignacio clarified that the COA case was civil in nature and aimed only at returning the P92 million to government cof-

in our hands as taxpayers and that is what we have filed before the Ombudsman," he added. "The criminal aspect of the case has been in our hands all along but we filed it only now."

It can be recalled that Ignacio came with Garbo when he assumed the city mayorship in June 2017 after Mortales was unseated by the Commission on Elections for overstaying in office beyond the three-term limit.

Failure to collect

In a press statement, Pangilinan said that "as local chief executive of Mabalacat City, Garbo has failed to compel Morales to return the P92 million spent on the non-existent projects at the Sapang Balen and Quitangil creeks.".

"Pinotrektahan ni Garbo si Boking sa P92 million ghost projects kaysa sa ipaglaban ang interes ng Mabalacat, dahil ang utos ng COA kay Garbo ay ibalik yong P92 milyong pondo na binulsa ni Boking sa dalawang pekeng proyekto," Pangilinan claimed.

"This apparent collusion between Garbo and Morales is detrimental to the Mabalacat City government and the people because millions of pesos are unaccounted for," he added.

[°]Kaya hindi gumalaw ang kaso ng plunder na isinampa laban kay Boking at hindi naibalik yong P92 milyon dahil sa sabwatan ni Garbo at Boking," said Pangilinan. "The GarBoking collusion over the COA findings is alarming."

According to the Pangilinan, "What former Mayor Boking and his cohorts did was direct stealing of public money and this is plunder and a non-bailable case and perpetual disqualification from holding public office."

Furthered the broadcast journalist: "Kung peke ang projects na sinasabi ng CÓA nasaan ang P92 milyon? Ibig sabihin ninakaw nila ang pera dahil wala naman palang nangyari proyekto sa ilalim ng kanyang (Boking) administrasyon. Maaring kasabwat din si Garbo dahil wala ginawa aksyon para habulin si Boking."

Apprised of the issue and asked for its response, the Mabalacat City Government through the city information office told Punto! over the phone that it opted not to comment at

Seeing with the heart

OUR ALLELUIA verse today is a quotation from Ephesians 1:17-18, where Paul prays the following blessing for the Ephesian community, "May the Father of our Lord Jesus Christ enlighten the eyes of our hearts, that we may know what is the hope that belongs to our call."

It is obviously an echo of that part of our first reading where the Lord rebukes the prophet for being unable to identify the one he was being asked to anoint as new leader for Israel, as replacement for Saul. There, the Lord says to Samuel, "God does not see as human beings do. You see the appearance, but the Lord looks into the heart."

The writer tells us the old prophet was grieving for Saul. Why was he grieving for a man who wasn't even dead yet? King Saul was obviously still alive, but he had become a different man. He had been corrupted by power. He was no longer the man the Lord had earlier asked Samuel to anoint for leadership in Israel.

The author tells us that Samuel had instructed Jesse and his sons to join him in offering a sacrifice, so as not to make it too obvious that he was already preparing for an election. Saul had become a dictator and dictators do not want to hear of an election, you know. And so Samuel had to be more discrete. In fact, the old prophet expresses his apprehension to God. He said, "If Saul hears about this

But unknown to him, his purpose was obvious to everyone in Bethlehem. The author says the elders of the city were trembling when they met him because they knew his purpose. And the sons of Jesse were excited because they knew anyone of them might be chosen by the

The visit of Samuel to Bethlehem reminds me of the fairy tale CINDERELLA, about the prince who goes out in search of the owner of the glass shoe Cinderella had left behind in the palace. All the other women in the kingdom were too eager to be tested, perchance the shoe might fit their foot and they would qualify to marry the prince and become a future queen.

In our first reading, the equivalent of Cinderella is David. While his brothers were all very enthusiastic about being sized up by Samuel, the young David was not. That is why he was not with them. He was more concerned about looking after ested in power. And I think, this is what 16, 1-13, Mk 2:23-28)

God saw in his heart, which Samuel did not see—the heart of a Good Shepherd. It is what the Lord was looking for in a prospective leader for Israel.

David here is like the hobbit Frodo in The Lord of the Ring, who was the only one who could not be corrupted by the enchanted ring because he had a pure

They say "power corrupts, and absolute power corrupts absolutely". That is why Satan has always dangled it as a delicious fruit to human beings since the beginning of creation. Remember how he persuaded Adam and Eve? "No, you shall not die if you eat of it. You will be like God... Don't you like that?"

Up to now, there are many people who feel and behave as if they were God the moment they are made to wear the ring of power; they begin to think they are the Lord and forget about the Lord of the ring.

Being one like us in humanity, Jesus knew he was also vulnerable to the lure of power. He counteracted it through KENOSIS, a total renunciation of power through self-emptying. That was how he kept his heart in the right place.

Saul could no longer carry out what God had anointed him for because his heart had become dull and hardened. He had been blinded by power.

Christianity's antidote to the delusion that power brings is the acclamation that we recite after that prayer of deliverance from evil that we recite at Mass after the OUR FATHER. When we are entrusted with power and Satan tries to massage our ego to make our heads grow big, it is then that we need to fix our eyes on God, the one true source of power and say, "For Thine is the kingdom and the power and glory, forever and ever."

Only in the self-deprecating attitude of a humble steward entrusted with power can the eyes of our hearts remain clear-sighted. Perhaps we should reformulate the Beatitude of Jesus and say instead, "Blessed are the pure of heart for they shall see as God sees."

Or, she's both, which she needs in the slime -and -grime of Philippine politics, especially presidential politics. Not that these will ensure certain victory, which is vastly uncertain at the moment. But she has a crucial point to prove, and that should not be taken away from her.

prepared for the mano-a-mano race with the (in)famous former son of a dictator, and raring with not-so -contagious passion to snatch victory from the brink of defeat. She's heard loud and clear what the latest survey announced: she's trailing Bongbong Marcos by the proverbial mile, nearly light years away behind, while time is becoming shorter like nanosecond to the finish line.

As the American writer Todd Gitlin wrote much earlier, the principle behind the passion had to be righteous. In this sense, Leni is an idealist, not a pragmatist. And idealism is all but dead in in the quagmire of Philippine politics. It is supposed to have engaged a wider, bigger public; it is supposed to be, as Gitlin asserted, unignorable.

But is it? The twenty percent she garnered from the latest poll, five months or so before D-Day, as opposed to BBM's 50 plus percent doesn't inspire confidence that it's on its way. Her passion and ideals should have ignited a bigger response from the populace, captured forcefully in their imagination and triggered an unprecedented people's movement.

Except in few people's - leaders, political and not, if you will-mind like the nearly forgotten Pampanga congressman and mayor Oscar Rodriguez, with his familiar, routine rhetoric. Call of duty, he was quoted as saying, when he filed his candidacy for mayor as soon as it was sure Leni would be in the hustings. Nobody should expect a proven and tested political warrior like him to just stand on the sideline while Leni's parade passes by. He must be in the parade as well.

So far, not so good. The political wand that he used to wield has lost its magic. The latest news is that in Angeles City, Leni is the chosen one. No similar good news from the other local fronts. Not surprising, in the land where pragmatism has pervasively reigned for the longest time and dirty money is considered political speech and platform much earlier than anywhere.

Asked on CNN Philippines if she was in favor of the disqualification move in the COMELEC (that was before the poll body ruled), Robredo replied she would rather beat BBM on election day than earned the victory via the several DQs filed against him. It's clear she doesn't only envision a political victory but a moral one.

She wanted the narrative, a false one, he proclaimed without batting an eyelash, endlessly repeated by the BBM camp, dumped in the dustbin once and for all: that he was cheated in the vice presidential race six years ago. The Presidential Electoral Tribune had thrown out the bunkum with concrete evidence at least twice, but the bird-brained assertion continues. She's optimistic that she would be vindicated once more by the electorate. Un-

Like a true champion and warrior, she's fortunately, the optics and numbers are not tangential to her thinking. snapshots, to be sure. But the gap between Point A, where she is is at the moment, and Point B where she aims to be, is still a dismal reality. The indicatives are not consistent with the moral imperatives that she seeks, not just for herself but for the nation.

> She has made her point, though. The nation lacks the moral quality, the moral excellence needed to rescue Philippine politics from the deep abyss into which it has fallen. A legal victory in the COMELEC or any court, whether supreme or inferior, can't make that happen. Only the voters can. That's the redemption. "If you want to reinvent your country, you have to have the audacity of hope", former President Barack Obama wrote in his book of the same title.

> In other words, what Robredo wants is a changed nation. That's her audacity because that's her hope. Apparently, the COMELEC listened, too. Two days ago, the poll body dumped one petition asking for the cancellation of BBM's candidacy on the ground that he broke the law on tax evasion. The ruling was simple and straightforward: the petitioners didn't do their homework. The law that BBM allegedly broke didn't yet exist when he committed the alleged crime involving moral turpitude. No law, no foul, period.

> BBM may have won the battle, not necessarily the war. Not yet, anyway. There are other DQ cases pending. Eventually, those who wanted BBM disqualified may have to go to the High Tribunal for the final say. It would be a big bet, anchored on the SC' s supposed independence. Independence means, according to a former justice, a final word based on the law and facts.

> In the final analysis, Leni's immovable position for moral excellence in a field of competition where vice pays tribute to virtue, it's pretty sobering to recall what Napoleon once said about victory, whether in war or politics. Morality, he said, lies on the heavy side of the artillery.

> The latest good news to Leni, on the heels of COMELEC's junking of an anti-BBM petition, is that 23 former members of the Cabinet of former President Fidel V. Ramos, have manifested their full support for the vice president to be the country's next president. That's lot of substance, but not enough.

> The Bongbong-Sara tandem , meantime, is a spreading a better political gospel. At least two former presidents (both criminally charged during their tenures) are on their side. The candidates themselves are flaunting their political pedigrees, not exactly exemplary. such formidable opponents, Robredo's sheer audacity rises even more. Democracy is supposed to be based on the conviction that extraordinary possibilities can happen. Cross your fingers.

Netizens have taken the CDC to task for imposing the inspection of vaccination cards and/or RT-PCR test results on every individual entering the freeport pursuant to its "no vax card/Covid test, no entry" policy.

Traffic jams at the gates to the freeport that would result to workers coming in late was the foremost issue raised over the policy.

Former Clark International Airport Corp. president-CEO Alexander Cauguiran's open letter to the CDC suggesting that the inspection be undertaken at the entrance to the individual workplaces was received with universal approval by the netizens.

"The measures that

CDC are implementing is a response to the sudden increase of cases in the CFZ in the past days. There was a sudden surge of cases in CFZ in the past week. Kailangan po nating masigurado na bakunado at hindi "carriers" ang mga pumapasok sa Clark.
