5 govs reelected, 2 switch with kin

ITY OF SAN FER-NANDO -- All five reelecting governors of Central Luzon won by big margins over all comers, new and old in the political game. This, per the unofficial count of Halalan 2022. At 98.51% of the count, Bulacan's Daniel Fernando has 973,749 votes to former governor and incumbent vice governor Willy Sy-Alvarado's 576,783.

In Nueva Ecija, Gov. Oyie Umali garnered 825,857 votes against rival incumbent Palayan City Mayor Rianne Cuevas' 367,307 with 99.87% of the votes in.

Pampanga Gov. Den-

nis "Delta" Pineda garnered 668,757 votes against former Candaba Mayor Danilo Baylon's 453,408 in the final count.

From 100% of the returns in Zambales, Gov. Jun Ebdane posted 199,874 votes against former 2nd District Rep. Cheryl Deloso-Montalla with 133,479.

Running unopposed, Tarlac Gov. Susan Yap still got 598,224 votes.

13 mayors reelected, 3 defeated, 6 newbies

CITY OF SAN FERNANDO – Thirteen incumbent mayors of Pampanga have been given a new mandate by the electorate on Monday. Three incumbent mayors lost. Six new ones are elected. This, per the unofficial count of Halalan 2022 of ABS-CBN. Unless indicated otherwise, the results are at 100%.

Incumbents who lost are in Magalang – Romy Pecson (29,742) to Malu Paras-Lacson (38,560); in Sta. Rita – Dagi Salalila (11,754) to brother Art Salalila (12,423); and in Sto. Tomas: Gloria "Ninang" Ronquillo (13,404) in a return bout with Johnny Sambo (15,126).

Newcomers made it in Arayat – Madeth Alejandrino (21,464) over

BALANGA CITY -- The municipal/city board of canvassers on Tuesday proclaimed the winning municipal candidates in their respective town in Bataan.

Proclaimed with the mayors were the vice-mayors and members of the sangguniang bayan/panglungsod.

In Samal town, newcomer

Alex Acuzar won over reelectionist Mayor Aida Macalinao.

In Dinalupihan, SB member Herman Santos was elected mayor of the town after beating two rivals for the post.

Pilot Jopet Inton was reelected mayor of Hermosa after winning over rival former mayor Danilo Malana.

Reelectionist Mayor Efren Pascual, Jr. remains as chief executive of Orani after opponent SP member Reynaldo lbe failed in his bid.

Vice Mayor Robin Tagle won the mayoral post of Abucay after defeating comebacking former mayor Ana Santiago who was undefeated for three terms.

Reelectionist Pilar Mayor Carlos Pizarro, Jr. successfully defended his post against Ed Santos, husband of a former mayor. Another reelectionist, Mayor Antonio Raymundo of Orion kept the position from rivals, former mayor Pepe Santos and businessman Ramon Hernandez.

Comebacking Mariveles mayor Atty. Ace Jelo Concepcion defeated reelectionist Mayor Jocelyn Castañeda, also a lawyer.

Bagac Mayor Ramil del Rosario was reelected after rivals failed to inch him out.

Reelectionist Balanga City Mayor Francis Garcia was unmoved in his post being unopposed.

Morong Mayor Cynthia Estanislao, a physician, was relected after defeating three opponents.

Incumbent Limay Mayor Nelson David also won a new mandate trouncing rival former mayor Ver Roque.






GMA, NANAY PROCLAIMED

Date with history

TAKE A bow, Carmelo "Pogi" Lazatin Jr.

In his very first re-election bid, Lazatin did the unprecedented in the annals of the city's electoral history - garnering over 112,947 votes -- the first ever hizzoner to attain aye, surpass – the 100,000-vote mark, the first ever to be voted by over 50% -- exactly 54.87% -- of the city's total voting population of 205,822.



A landslide, indeed, an avalanche by any measure, totally burying the pretender to the mayoralty's 47,300 votes to electoral nothingness, okay just to be kind - to utter insignificance.

With Lazatin's triumph comes now the greater challenge: his numbers manifesting the greatest affirmation by the city electorate of his sterling performance in his very first term as mayor now engendering among them higher hopes of even greater accomplishments in his second term.

Tall order? Worry not, Pogi always delivers.

Shine on, Crisostomo C. Garbo.

Indeed, a rarity elsewhere and never in the history of Mabalacat, from town to city, has a single slate - governor, vice governor, two board members, mayor, vice mayor, all of 10 councilors - been voted straight.

Yeah, if fading memory still serves right, not even during the dictator Marcos' KBL bloc-voting days when then popular Fred Halili handily won the mayoralty while his gubernatorial bet, the erudite Estelito Mendoza, lost miserably.

No mean feat, did Team MCG – standing as much for Mayor Cris Garbo as for Mabalacat City Government - achieve in the elections just past with its wholesale poll victory.

"The people of Mabalacat City have spoken once again..." So declared Garbo in his post-election statement.

How the people have, indeed, spoken! Garbo garnering 75,794 votes over 60% more than the combined votes of his rivals, former forever-mayor Boking Morales with 25,926 votes and broadcaster Deng Pangilinan with 3,659.

tian Halili's measly 25,440.

"Through the ballots, they have reaffirmed, in unison, their choice for a governance that firmly stands on integrity, honesty, credibility. and unwavering service," enthused Garbo.

Rising up to the new challenge, thus: "With the help of the Almighty God, we shall endeavor once again to deliver to expectations anchored in our 'Bayung Mabalacat' vision. We shall also continue to challenge ourselves to do even more in pushing our beloved city and its people to greater success."

Rise now, Vilma B. Caluag.

With 55,508 votes to her name, the first-ever lady mayor takes over the City of San Fernando. No spectacle in terms of numbers there, but the magnitude of her electoral ascendancy comes to brilliance with the very renown of the rivals she bested.

Unarguably, was the most inexperienced in the field of governance among the marquee names in the city's mayoralty contest: multi-term provincial board member Rosve Henson, longtime vice mayor Jimmy Lazatin, and certainly not the least, multi-term congressman, EDSA 2 hero, three-term city mayor, World City Mayor awardee Oca Rodriguez.

Daunting as the task ahead is for Caluag, the greatest challenge for her at the onset is to immediately prove she has something more substantive other than her prowess to parlay her Tik-Tok moves to electoral victory, sans daughter Nicole and husband Melchor.

Even as her triumph serves as an empowerment to all women, gender will be the least consideration in her performance



as city mayor, of the very capital of Pampanga at that!

Luck be a lady, so we can only wish her. For now.

Outsiders, insiders

WE CONTINUE to pray for our PPCRV volunteers, as well as other groups that are closely monitoring the reporting of partial unofficial counting of election returns. I suggest that we keep ourselves focused by being attentive to the Word of God.

In our first reading today, St. Luke narrates how the first missions in the earliest Christian communities of Jerusalem and Antioch began. Ironically, what precipitated or accelerated the missions was not exactly the explicit intention of evangelizing. It was rather PERSECUTION!

Many of the disciples were forced to leave Jerusalem after Stephen was stoned to death. Some of them went as far as Phoenicia, Cyprus and Antioch. At the start, they were sharing the good news of Jesus Christ only to their fellow Jews, and lived a community life bonded by love and mutual care.

Last Good Shepherd Sunday, I told you about the two kinds of audiences in the synagogues: the "insiders" and the "outsiders." The "insiders" were the ones who behaved like exclusive club members. They were the ones who counted themselves as "chosen people," Jews by birth and ethnicity.

The "outsiders", on the other hand, were Greeks or Gentiles who were attracted to Judaism but remained marginalized; they were never integrated to the mainstream. Parang mga sampid ang turing sa kanila. They could not join the insiders even if they had already been attending synagogue worship for many years. Why? Because there were Jewish regulations which they found difficult to follow, like circumcision, as well as the Sabbath and food regulations.

St. Luke tells us it was at Antioch where disciples from Cyprus and Cyrene first began to give attention also to the outsiders. There were too many of them and they were all interested to listen, so the Jerusalem community responded to the need and sent Barnabas to help out. And then Barnabas himself needed some help and he went to Tarsus in order to enlist Paul as a companion in mission work.

Actually, that tells us a lot about the daring character of Barnabas. He was aware that the other Christian communities avoided Paul because he used to be suspicious of his motives. It was Barnabas who removed that suspicion by taking Paul as a companion in mission. St. Luke tells us it was this initial mission that made

the community of Antioch grow bigger than the original community at Jerusalem.

In our Gospel today, Jesus, as it were, is saying, "It is easy for me to identify those whom the Father is asking me to shepherd. They are the ones who listen to me and follow me as their shepherd."

Jesus says the first sign that the Father is at work in people is when they open their hearts and minds to listen to God's word. It means they are being drawn by the Father to the Son and are being entrusted to his care. Jesus says he looks after them for his Father. In short, the real Shepherd is the Father who has entrusted the sheep to the Son's care. "The Father and I are one," Jesus says.

Perhaps this should teach us the proper approach to evangelization. We don't even have to try too hard. The most basic sign of a fertile ground is good will, a basic willingness to listen. Those called by the Father are merely following their instincts, as it were. They come on their own; and Jesus does not reject them.

The Psalm today is also saying the same thing, "I tell of Egypt, Babylon, among those who know the Lord, of Philistia, Tyre, and Ethiopia." This is like a fulfillment of Isaiah's beautiful oracle in Chapter 2:

"Many peoples shall come and say: 'Come, let us go up to the LORD's mountain, to the house of the God of Jacob, that he may instruct us in his ways, and we may walk in his paths.' For from Zion shall go forth instruction,

and the word of the LORD from Jerusalem."

Nowadays, we have modern lay missionaries who enter non-Christian countries, not to proselytize, but to simply work as migrant workers or professionals and live a community life among themselves. They do what Pope Francis says is the "right kind of evangelizing," which is by giving witness to life in Christ as a loving community, without even attempting to convert people to a religion. They evana persecutor of Christians, and they were gelize by attraction. And people who are drawn to them say, "See how they love one another."



NLEX authorized to implement new toll rates starting May 12

NLEX CORPORATION will implement new toll rates for NLEX starting May 12.

The Toll Regulatory Board gave NLEX the go signal to increase its toll by P2.00 in the open system and P0.34 per kilometer in the closed sys-

adjustments, The which followed regulatory procedures and underwent thorough review, were part of the approved periodic adjustments of NLEX due in 2016 and the completion of the new Subic Freeport Expressway (SFEX) in 2021.

Motorists have been enjoying safer and more comfortable journeys brought about by the new SFEX since it was partially opened in December 2020 and fully completed in February 2021. A total of 16.4 new lane kilometers, two new bridges in Jadjad and Argonaut, and a new tunnel were constructed for this infrastructure project.

Under the new toll fee matrix, motorists traveling anywhere within the open system will pay an additional ₱2.00 for Class 1 vehicles (regular cars and SUVs). ₱6.00 for Class 2 vehicles (buses and small trucks), and ₱8.00 for Class 3 vehicles.

The open system is from Balintawak, Caloocan City to Marilao, Bulacan while closed system covers the portion between Bocaue, Bulacan and Sta. Ines, Mabalacat City, Pampanga including Subic-Tipo.

Those traveling the NLEX end-to-end between Metro Manila and Mabalacat City will pay an additional ₱27.00 for Class 1, ₱69.00 for Class 2 and ₱82.00 for Class 3 vehicles.

To help cushion the impact of the toll increase, public utility jeepneys (PUJs) under the NLEX Passada and Tsuper Card discount and rebate program will continue to enjoy the old rates. Provincial buses will also be covered by a graduated rebate scheme for a period of three months.

The tollway company spent P6.9 billion to complete several major projects and enhancements at NLEX-SCTEX since 2015 that improved the region's landscape, increased accessibility, enhanced safety and provided travel convenience to motorists.

To name a few, these include the expansion of San Fernando Interchange; the new toll lanes in Marilao, Bocaue, Tipo, Balintawak, Meycauayan, and Mindanao; the pavement upgrade at NLEX; the new exits in Meycauayan and Valenzuela and entry in Balagtas; the rehabilitation of bridges in Bigaa, Bocaue, and Meycauayan; and the improvement of drainages in Balintawak. Valenzuela. and Meycauayan; retrofitting of San Simon and Sta. Rita bridges.

In spite of the challenges of the pandemic, the tollway company has not wavered on its commitment to provide quality service to its motorists and has continued to undertake high impact projects that will benefit the economy.


