

CRK-Busan flights to resume July 1

CLARK INTERNATION-AL AIRPORT – Flights between this international airport and Busan, South Korea are set to resume July 1.

The twice weekly – Monday and Friday – flights are via Jin Air LJ 031/032.

Busan hosts South Korea's largest seaport and is considered the country's second largest city with a population of 3.6 million.

It is known for its beaches, nature reserves, and temples, as well as its annual international film festival. The action-horror film "Train to Busan" impacted the city in the world movie map.

Aside from Busan, Jin Air has also started CRK flights to Incheon, South Korea every Wednesday and Saturday via LJ 023/024.

Another Korean airline, Jeju Air is also flying to Incheon every Thursday and Sunday via Flight 7C 4603/4604.

CIAC remits 176-M to national treasury

LARK FREEPORT — The government-run Clark International Airport Corp. reported on June 28 that it has remitted a total of P176,739,971 this year as dividends to the Bureau of Treasury that contributed to the national government's funding requirements for Covid-19 responses.

"Despite the overwhelming challenges at the Clark aviation complex brought about by the pandemic, CIAC's operational flexibility and fiscal discipline has generated an upward annual profit margin from 16 percent to 27 percent and thereafter to 46 percent from 2019 to 2021, and thus, our capacity to remit dividends," CIAC president Aaron Aguino said.

From the total amount of dividends

settled, P156.74 million was remitted on May 5, 2022 and P20 million last May 16, 2022, payments derived from revenues in managing the aviation complex.

Aquino added this year's remittance is 35

percent higher than the P130.5 million contribution of the agency to the national treasury at the height of the Covid-19 outbreak in 2020.

"In the coming years, we hope to sustain and even increase CI-

CSF gets ISO certification anew

CITY OF SAN FER-NANDO – The city government was granted an International Organization (ISO) Certification 9001:2015 anew for its quality management system (QMS).

This time, the certification was issued by SOCOTEC Certification International I, the Philippine arm of an assessment and accrediting firm, and was handed by its operations director Gilmore Rivera to Mayor Edwin "EdSa" Santiago on June 27 at Heroes Hall.

Based on their series of audits, SOCOTEC said it was proven that the services of the city to its customers are of "good quality, streamlined, and efficient" – the parameter to meet the international standards of QMS.

Currently, dozens of government services coming from over 20 offices adopt processes that are certified by an ISO through different firms including the SO-COTEC.

estate in Barangay Lamao where the GA is located and manufactures basic weapons and ammunition for the Armed Forces of the Philippines and Philippine National Police has an area of 370.371 hectares.

Unity and universality

IF YOU get a chance to visit the famous heritage Church of the Santiago Apostol Parish in my hometown in Betis, Guagua, Pampanga, I advise you to take a close look at our very well-preserved retablo. The image in the middle niche is that of the Risen Christ. But who do you think are positioned on his right and on his left? Not James and John: even if it was these two young and ambitious disciples who asked for those positions. (See Mark chapter 10.) So, who do you find on the right and the left of Jesus? Yes, Saints Peter and Paul, whose shared feast we are celebrating today.

Why did the Church choose to celebrate these two great apostles on the same day? Why not one day for Peter and another for Paul? I think, this feast day has a catechetical purpose. It is meant to remind us of the two directions of the Church's mission: unity & universality.

Before I explain, let me first point out that these two men were not chosen because they were perfect; they were both sinners. Peter denied the Lord; Paul persecuted the Church. What made them into pillars of the Church were not their natural qualities. I dare say what actually strengthened them was the Lord's faith in them, despite their weaknesses.

I hope you don't get scandalized by that. I know that when we speak of faith, we think only of our faith in God. But God having faith in us? Yes. Listen to the Gospel. It begins with Peter confessing his faith in Jesus. In reply to Jesus' question, "Who do you say that I am?" he says, "You are the Christ, the son of the living God." But it does not stop there. What follows is Jesus also declaring his faith in Peter: "You are Peter, and on this Rock I will build my

He was a sinner but he was chosen by God nevertheless. The present-day successor of Peter, Pope Francis, expresses the same idea in his motto as bishop: "Miserando atque eligendo." Wretched but

Remember that scene at the lake in Luke Chapter 5, when Jesus instructed Peter to cast his nets into the deep and suddenly they made such a huge catch that their boats were almost sinking? Remember how Peter fell on his knees before Jesus and said, "Leave me Lord, I am a sinner!"? And how Jesus said, "Be not afraid, from now on you will be a fisher of men."

St. Paul was like that too. Didn't you hear him say in our second reading from his 2nd Letter to Timothy, "The Lord stood by me and gave me strength."? He always had serious doubts about himself, because of his weakness, which he called a "thorn in the flesh." In 2 Cor. 12, he confesses that he begged the Lord three times to remove his weakness. But the Lord said to him, "My grace is enough for you; for in weakness power reaches perfection." And so, Paul declared, "It is when I am weak that I am strong." Meaning, it is when I accept my weakness in all humility that God's strength becomes truly manifest in me.

On this day, we are supposed to remind ourselves that the Church is kept steady by two massive pillars of faith, two of our greatest apostles: Peter, whom I call the apostle of unity," and Paul, whom I call the "apostle of universality." I propose that this must the reason why the Church has chosen to commemorate them, not apart from each other but together, on the same day.

They remind us that we all must participate in the mission of the Church, which has two directions: inward unity, and outward unity—towards universality. Inwardly, we must build communion and strengthen our unity with one another, with our fellow disciples, our fellow members in the community of the baptized, the Church, the body of Christ. Outwardly, we must learn to dialogue, that is, build communion and serve as instruments of unity in the world, even with non-Christians and non-believers, because they are also called to be children of God. We can always find other bases for unity aside from a common faith. Like unity around respect for life and human dignity, a common concern for the environment, for the earth as our common home, a shared compassion for the poor and the disadvantaged, a common aspiration for a more humane society, etc.

Jesus expresses these two directions of mission using two images familiar to fishermen: BINDING & LOOSING. They are what fishermen do to mend their nets: bind the torn parts of the net and loosen the tangles. In Tagalog we say "Pagtatali ng napatid, at pagkakalag ng nagkabuhol." I know we usually apply the binding and loosing to the principles of justice and mercy: binding as holding people accountable for their actions, and loosing as setting free from anger and resentment through forgiveness.

But the meaning can actually go beyond justice and mercy: binding can be applied to uniting, strengthening, making firm. Loosing, as opening up to the values of inclusivity and universality. They are the two important qualities of mission in the Church.

Pope Francis often reminds us that one always goes with the other. If we do binding and forget the loosing, we can become self-referential, narrow minded, parochialistic and Churchy in the negative sense, having no relevance, impact or transformative influence on the world.

But if we do loosing and forget the binding, we also can get lost in the world and lose our identity. Instead of bringing about God's kingdom in the world, we end up being seduced by worldly kingdoms. It is not one or the other; it has to be both.

If not for the pandemic I would probably be joining the concelebrated Mass today at the Manila Cathedral for our yearly celebration of the Pope's Day.

What I appreciate most in Pope Francis is the way he has combined both the Pauline and the Petrine aspects of his office as PONTIFEX MAXIMUS (Supreme Bridge-builder). I would suggest that we call him not just a "Successor of Peter", but as holder of the double offices of Peter and Paul. That is why we pray for him not just on this day, but at every Mass. He presides in charity over his brother bishops all over the world to make sure the Church is kept in the right course, in the two directions of mission—in unity and universality.

A simple advice

WHEN Ferdinand Marcos, Jr. takes his oath of office on his inauguration day as the next Philippine president, apart from remembering his inaugural address, he is expected to be mindful of what he is going to swear to do while in office-- at least in the next 6 years, barring Charter Change which has been tried in the past but failed.

er Senate newbies have their roles cut out for them, which former Sen. Franklin Drilon frankly tells them not to take lightly.

The Constitution is clear and unequivocal on what his position as the highest official of the land entails. There are four things:1) protect and defend the Constitution 2) execute the laws 3) do justice to everyone and 4) serve the nation.

The job has never been more daunting because ,unfortunately, 1) there is no school for presidents and 2), like a paratrooper, he has to learn the important lessons on the way down. Being the son of a former president dictator may help, if it will not hamper or hurt him.

It is axiomatic that presidents are elected to solve problems, apart from the undying (universal) optimism, or folly, if you will, of voters that they will keep their promises. BBM has a lot on his plates, problems and promises alike. There are also the needling, messy "leftovers" of his predecessor, which he can repudiate or, worse, repeat. Success or failure can come from succession.

In his book 'The Choice', American journalist Bob Woodward wrote, quoting another author: "There is a "field" that comes with being the president. The job brings a historical procession of previous presidents, of the greatness of the office, and the country and its struggle." From that, Woodward recalled the author saying the president could construct a vision of a better society or "the possible society".

What is BBM's vision using these parameters as a paradigm? How does he see himself and the future in light of the past and the present? He may consciously construct the Filipino society in the next six years or beyond in terms of his promise -- "the golden age"-and the huge, unprecedented challenges the country is facing at the moment. His familiar choices for his Cabinet is reflective of his campaign nostalgia for a socalled "golden age". Choosing the biodegradable Juan Ponce Enrile, who has defied time and legal trials, as his presidential legal counsel tells a lot about his nostalgia and his utopia as well.

With problems, there is the economy in shambles `. BBM's economist can pick their poison: beat the inflation or fight the rising prices. China is apparently in on wait-and see posture before its next move in the West Philippine Sea. The International Criminal Court is set to resume its investigation on the alleged "war against humanity" of soonto -be former President Duterte, his big-time benefactor. This will be a litmus test on the predecessor-successor's quid pro quo. The case against former Sen. Leila de Lima and other issues concerning the judiciary are'

Incoming Sen. Robin Padilla and oth- also pressing. Democracy is continually threatened while respect for human rights remain a major issue.

> With promises, BBM should remind himself of how he missed the so-called " golden age" in his father's time, impliedly looking forward to it during his administration. Part of the package, among other olden" campaign incentives, is bringing back the price of rice to P20 per kilo. The audacity of such a promise is astounding and mind-boggling.

> Matching the four to-do Constitutional agenda, BBM may translate them into four moral principles: righteousness, justice, kindness and peace. In a perfect world, these are axiomatic. In an imperfect world, and with China breathing down our neck, good luck. "Never fear to negotiate", John F. Kennedy said in his inaugural speech," but never negotiate out of fear".

> BBM's greatest enemy may be himself. His reputation, or what passes for it, precedes him. Political pundits may also view him a beneficiary of post modernism, where integrity is less important By this, it means he may be leading in a time of post moral, post truth, post decency political culture. In short, a lowering of expectations. His predecessor will likely make it in history as one who may have lowered the bar in terms of moral and democratic leadership.

> BBM tows a heavy baggage as it were, political and otherwise. First off, he is the son of a former dictator rudely thrown out power by his own people in a peaceful revolt. He may have been restored to his late father's former post, there are many questions that remain unsettled. Tax issues against him and his late father's estate continue to hound him and his family. He's not exactly enamored of press freedom. The laundry list is long and vertiginous.

> He may want to seriously pay attention to his incoming head of the Bureau of Internal Revenue, Lilia Guillermo. Her simple word of advice, which she told media she would tell the president face- to- face, is to be a model president. By that, she probably meant, first and foremost, BBM has to pay his taxes correctly and on time, including the P203 billion that ballooned from the original P23 billion that the Supreme Court had ordered him and the other co-administrator of the Marcos estate to settle a long, long time ago.

> "Public servants are teachers", former U.S. Sen. John Ashcroft once said. "The teaching example of our leaders is profoundly important".

> What should BBM teach us then? He knows the answer, but the answer remains to be seen although the BIR's chief simple advice of being a model public servant is sufficient and specific enough.
