BALANGA CITY -- Bataan is no longer suited for a nuclear power plant unlike more than 40 years ago when construction of the Bataan Nuclear Power Plant in Morong town started, Gov. Jose Enrique Garcia III said Monday.

Yes to CCSFP as state college, No to integration with DHVSU

CITY OF SAN FERNANDO - The city government is not opposed to the proposal to convert its City College of San Fernando into a state college but expressed vehemence against the school's integration with the Don Honorio Ventura State University.

This was the consensus arrived at during a consultative meeting among stakeholders called by Pampanga 3rd District Rep. Aurelio "Dong" Gonzales, Jr. at the DHVSU gymnasium in Bacolor town on Monday.

"The proposal to integrate CCSFP to DHVSU is a no-no

for us. But, the conversion of the college into a state college or state university, eventually, is another thing. It is something that we can agree upon. Besides, that was, to me, our ultimate dream, to have a state college for Fernandinos," said Mayor Vilma B. Caluag.

Stakeholders comprising the board of trustees, supreme student council, the faculty and employees' association, and the alumni association of the CCSFP earlier came out with position papers expressing their opposition to House Bill 4079 that seeks the PAGE 21 PLEASE

Taiwanese company expands operation in Bataan ecozone

HERMOSA, BATAAN --A Taiwanese company is expanding its operation at the Hermosa Ecozone Industrial Park here with its grand inauguration held Monday.

The YFC Boneagle Electronic Technology Philippines Corp. under the YFC Development Corp. is expanding its operation in the manufacture of power cords of 3C, copper LAN cables, patch cords and others used in e-commerce platforms and systems that have something to do with digital distribution channels. Hermosa Mayor Jo-

pet Inton said that 700 ic Technology na isa na new employment opportunities will be generated initially by the expansion program of the firm.

The mayor said this was part of the pledge of seven Taiwanese firms to expand operations in the country with investment worth P3.7 billion. He said that based on the report released by the Philippine Economic Zone Authority, there are other manufacturing firms interested to operate in Hermosa.

The Hermosa Ecozone is under PEZA.

DHVSU-Sto. Tomas campus expansion, new courses eyed

STO. TOMAS, PAM-PANGA - Expansion of facilities and new courses are mulled for the Don Honorio Ventura State University-Sto. Tomas (DSTC) campus in Barangay Moras Dela Paz here.

This was disclosed during the recent courtesy call of DHSVU president Enrique G. Baking to Mayor Johnny A. Sambo. Baking was accompanied by DSTC director Jovita G. Rivera and Jeffrey M. Gomez, DSTC faculty association president.

Baking said the DSTC "is very promising" since it is very near the City of San Fernando, and this required new venue or expansion of facilities to accommodate future courses such as in nursing, pharmacy, medical technology, physical therapy and medical allied courses to be offered at the DHVSU main campus in Bacolor, as well as DSTC.

Presently, DSTC has only existing 12 classrooms housing 2,200 students enrolled in four programs: BS Information Technology, Bachelor of Elementary Education, BS Business Administration, and BS Hotel Management. The campus is also seasonally inundated with floodwaters.

Baking said a two- or three-storey building can house the additional students. Sambo responded that construction of a three-storey building in the open space fronting the senior high school annex building of PAGE 6 PLEASE

To the Point

This is the way: to grow in love

ON THIS World Day of the Poor God's word is a forceful admonition to break through that inner deafness, which we all suffer from, and which prevents us from hearing the stifled cry of pain of the frailest. Nowadays we too live in troubled societies and are witnesses, as the Gospel told us, to scenes of violence – we only have to think about the cruelty that the people of Ukraine are experiencing - injustice and persecution; in addition, we must face the crisis generated by climate change and the pandemic, which has left in its wake not only physical, but also psychological, economic and social maladies. ... We see peoples rising up against peoples and we witness with trepidation the vast expansion of conflicts and the calamity of war, which causes the death of so many innocent people and multiplies the poison of hatred. Today also, much more than in the past, many of our brothers and sisters, sorely tested and disheartened, migrate in search of hope, and many people experience insecurity due to the lack of employment or unjust and undignified working conditions.

... The poor pay the heaviest price in any crisis. Yet if our heart is deadened and indifferent, we cannot hear their faint cry of pain, we cannot cry with them and for them, we cannot see how much loneliness and anguish also lie hidden in the forgotten corners of our cities...Let us take to heart the clear and unmistakable summons in the Gospel not to be led astray. Let us not listen to prophets of doom. Let us not be enchanted by the sirens of populism, which exploit people's real needs by facile and hasty solutions. Let us not follow the false "messiahs" who, in the name of profit, proclaim recipes useful only for increasing the wealth of a few, while condemning the poor to the margins of society. Instead, let us bear witness. Let us light candles of hope in the midst of darkness.

Amid dramatic situations, let us seize opportunities to bear witness to the Gospel of joy and to build a fraternal world, or at least a bit more fraternal. Let us commit ourselves courageously to justice, the rule of law and peace, and stand always at the side of the weakest. Let us not step back to protect ourselves from history, but strive to give this moment of history, which we are experiencing, a different face.

How do we find the strength for all this? In the Lord. By trusting in God our Father, who watches over us. If we open our hearts to him, he will strengthen within us the capacity to love. This is the way: to grow in love. Indeed, after describing scenarios of violence and terror, Jesus concludes by saying, "Not a hair of your head will perish." But what does this mean? It means that he is with us; he walks with us to guide us...We should always repeat this to ourselves, especially at times of greatest trouble: God is a Father, and he is at my side. He knows and loves me; he does not sleep, but watches over me and cares for me...

Since he loves us, let us resolve to love him in the most abandoned of his children. The Lord is there... *(From the homily of Pope Francis on World*)

I HAVE a feeling that this was not the first time Zaccheus was observing Jesus from a distance. I think he had been spying on him prior to that, probably listening to his teachings, but from afar, from a vantage point where he could see and hear him without being seen or heard himself.

Maybe he had heard Jesus' challenge being addressed to him during those times. You know how it is with the Word of God; it has the power to change people's lives. Remember that passage in Hebrews 4:12 that says, the Word of God is "living and effective, sharper than any two-edged sword, penetrating even between soul and spirit, joints and marrow, and able to discern reflections and thoughts of the heart."

I have heard many stories of people who were not serious about their faith until one day, the Word of God hit them even as they kept a safe distance. I know someone who said he just attended a funeral Mass and he stood at the back pretending not to listen, but the sound system was good and he felt himself drawn to listen to every word. In fact, he felt like the priest was addressing every word of his homily to him personally.

Our first reading today, for example contains words that are like the twoedged swords described by Hebrews: "You think you are alive, but in truth, you are dead... You think you are rich, but in truth you are so poor and wretched... You are neither hot nor cold... Buy from me the real gold that will make you rich, spiritually, the real clothes that will cover your nakedness, the real ointment that will open your eyes and make you see... Those whom I love, I discipline." These words of John in the Book of Revelations are timeless.

I imagine how Jesus said words like these, words which caught the attention of a tax collector like Zaccheus, from a distance. I imagine Zaccheus wanting to I imagine how Jesus said words like (Homily Week in Or Lk 19,1-10)

come close to Jesus but holding back, because he did not feel worthy. And so, he got the surprise of his life when one day, it was Jesus himself who took the initiative and drew near to him. He may have thought he would not be seen from up there where he had positioned himself. But Jesus, who was passing by, stopped right in front of the sycamore tree, looked up at him and even invited himself to have dinner with him at his house. It means Jesus had been aware of his presence from a distance all the time and Zaccheus did not know it. Actually, another way of putting, "Come down, Zaccheus" was "Come near, Zaccheus." You want to be my friend? I want it more than you do.

That was enough to change the life of Zaccheus. That was his chance to become truly alive, not dead, truly rich, not wretched. He did not think twice anymore when he heard Jesus as it were "knocking at the door." All that Jesus was asking of him was to open up. That was all that it took to change his life's direction and fulfill his heart's deepest desire. And he went for it.

I know that some of those whom Jesus wants to visit are keeping a safe distance. Some of them have not stopped watching online because Jesus' words have pierced their souls many, many times. Inevitably, the time comes when he draws near and comes knocking. When that time comes, please, don't hesitate. Open up. It might be the very first day of the rest of your life.

Ever wonder if there are gadgets especially designed for them? Were these gadgets more expensive than regular ones? I have the same queries back then. But after learning more about the world of people with visual impairment, I've learned a lot.

Back then, a person with visual impairment still needs to install a cellphone software called Talkback to use it. Thanks to modern technology because most cellular phones today, either Android phones or iPhones have a built-in Text to Speech accessibility. All you have to do is go to Settings and proceed to the Accessibility menu of your cellphones. Isn't that amazing? With this feature, it can be useful educationally because a learner with vilular phone in doing research, recording lessons, and using emails. More so for an adult with visual impairment who can do more than just a regular call and text messaging.

How about computers? Is there a special keyboard for them? How can they know the text shown on the computer screen? There is a screen reader called JAWS or Job Access with Speech that can be installed in computers and laptop. A free software with almost the same function called NVDA or NonVisual Desktop Access is commonly used in public schools. When installed, these screen readers will read all the text and icons shown on the computer screen. They will also read anything the mouse pointer **PAGE 6 PLEASE**

The mysterious death of a number inmates who had earlier testified against a former s enator over drug money surfaced anew. An unexplained big, big ` hole dug in the ground near the penitentiary is discovered. The plot thickens like an Agatha Christie whodunnit. Life imitating art.

So, what's up?

In a time of deceit, George Orwell, prophet of newspeak, said, telling the truth is a revolutionary act. The Edsa People Power in 1986 was described as revolutionary in that it was decisive and clear about the truth. To a man, the Filipinos ran the dictator out of power, and became the toast of the democratic world. "You can't handle the truth", Jack Nicholson screamed his head off against Tom Cruise in a movie. J.K. Rowling said truth is both a beautiful and terrible thing and suggested caution in exposing it.

Is Remulla up to it? He is hemmed in by a clashing personal and official dilemma: his son has been caught flagrante in receipt of imported marijuana while former senator Leila de Lima still languishes in jail on trumped up alleged drug crime which witnesses against her have already admitted the result of coercion. Of course, Remulla has vowed that he will not lift a finger to help his eldest child. In a perfect world, you can bet your life on it. Not in Pinoylandia. In a sense, the International Criminal Court (ICC) is determined to pursue the alleged crime against humanity In the war drug during the Duterte Administration because of a Nicholson-like argument. Numbers were conflicting: 30,000 perished, according, to human rights group. Not so, only 6,000, countered the law enforcement groups. The devil is in the detail. This is a job for a super body like ICC. No, we can handle it, Remulla and other members of the choir, sang.

is at work and can be deemed responsible for a weak, false or utter disregard for accountability, especially in the public sense. On the one hand is the Christian faith that encourages forgiveness. On the other, there is the Chinese influence on putting a premium on the importance of face, as in "hiya". In either, forgiveness or face, not both at the same time, has instilled a strong sense of accountability. You want the former, accept the stigma. You want the latter, give up something as precious as life.. You can't have your cake and eat it. too.

Accountability matters. In countries where it works, there is political stability, economic progress and global clout. You can cite the US and other western countries and East Asian nations like Japan and South Korea, as exemplars. We haven't made up our mind, it seems.

A couple of days back, former Senate Minority Leader Franklin Drilon served notice about the increasing lack of transparency in the use of public money in light of increasing intelligence funds for certain government agencies, some of which didn't have it the past. Hello, Orwell. Intelligence funds, as he pointed out, do not pass the usual government auditing. Franklin hit the nail on the head: diminishing accountability of government officials.

Accountability is at the heart of a well-established doctrine in public service. A public office is a public trust. There is no doubt that it is less than honored, at least in our time and setting. " A body of men who do not hold themselves accountable to anybody," Thomas Paine warned ," ought not to be trusted by anybody."

On second thought.....

After a generation as outliers in Philippine politics as result of EDSA, the Marcoses are back in business, or power more precisely. With a vengeance, of not only restoring the sullied name but rewriting history as well, or their happy version of why there was EDSA in the first place. There are still unresolved issues where TRUST or CASH is writ large, like the P23 or P203 billion estate tax due for decades ruled with finality by the Supreme Court. When the chief tax collector in the country appealed to her president that he should serve as model public servant, she presumably had the importance of accountability, first and foremost, in her mind. The debate still rages on, especially on social media, whether he's living up to her standard. Bantag, in his defiant and uncouth posturing against the two raps he's facing, may have an opinion vis-à-vis the new kid on the justice block. Is it a case of the pot calling the kettle black?

WHEREAS, NLEX Corp reported to the Office of the Mayor of Mabalacat, Pampanga that there have been increasing incidents of stoning in Mabalacat, at times committed by minors, that have been one of the leading causes of vehicle damages and accidents in the North Luzon Expressway (NLEX);

WHEREAS, stoning incidents committed by minors expose such minors to the traffic dangers on NLEX and SCTEX;

WHEREAS, responding to the report, Mayor Crisostomo Garbo of Mabalacat recognized the adverse effect and gravity of these stoning incidents which needs a more compelling local legislation to prevent minors from endangering themselves as well as the SCTEX motorists;

WHEREAS, stoning is a public nuisance that must be abated;

WHEREAS, stoning is only considered malicious mischief under the Revised Penal Code with a light penalty that is not commensurate with the risk and damage that it poses to the public as well as to minors who commit them;

WHEREAS, there is a need to impose stiffer penalties to persons who throw stones at vehicles in NLEX and in any public road within Mabalacat, Pampanga;

WHEREAS, if committed by minors, there is a need to strengthen and support barangay and parental control on these minor children who throw stones at vehicles traversing the NLEX, consistent with Republic Act No. 9344 as amended by Republic Act No. 10630 otherwise known as "An Act Establishing a Comprehensive Juvenile Justice and Welfare Council under the Department of Social Welfare and Development, Appropriating Funds Therefore, and for Other Purposes";

SECTION 1. TITLE- This Ordinance shall be known as the "Anti-Stoning Ordinance".

SECTION 2. DECLARATION OF POLICY. It is hereby declared that the act of throwing stones or any other objects in NLEX, SCTEX and any other public road in Mabalacat, Pampanga, whether directed at passing vehicles or not, shall be penalized.

SECTION 3. PROHIBITED ACTS. The following acts are hereby prohibited:

a. Meandering near, and climbing, the NLEX and SCTEX fence without any legitimate purpose.

- b. Throwing stones or any other object at vehicles traversing the NLEX and SCTEX within the territorial jurisdiction of Mabalacat, Pampanga
- c. Throwing stones or any other object inside the NLEX and SCTEX

SECTION 4. WHEN A MINOR OR A MEMBER OF AN IP COMMITS THE STONING. The provisions of Republic Act No. 9344 as amended by Republic Act No. 10630 shall be observed by the law enforcement officers in handling minors who commit stoning.

Consistent with Rule 6 Part 1 of the IRR, ICCs/IPs, in dealing with minors involved in stoning, have the right to use their own commonly-accepted justice systems, and other customary laws and practices within their respective communities as may be compatible with the national legal system and with internationally- recognized human rights.

CIVIL LIABILITY **GUARDIAN/S** SECTION PARENT/S OF 5. OF OR **APPREHENDED MINORS-** The parents or guardians who are in actual custody or living together with the minor are under obligation to pay for any damage caused by the minor on any vehicle or property inside NLEX and SCTEX.

For this purpose, parents shall mean any of the following: biological parents, adoptive parents or individuals who have custody of the child. Guardians shall refer to (a) person who under court order is the guardian of the person of a minor, (b) a public or private agency with whom the minor has been placed for custody by a court, (c) a person in charge of the custody or who is taking care of a minor whether relative or not, (d) a person at least 18 years of age and authorized by a parent or guardian to have the care and custody over him or her.

SECTION 6. POWERS, DUTIES AND FUNCTIONS OF THE BARANGAYS-

- a. Strengthen the implementation of its security system in preventing stoning activities in the expressways;
- b. Lead in educating communities particularly the minors on the dangers of engaging in unnecessary activities within a certain distance from the expressway;
- c. Coordinate the operation and programs with the Philippine National Police (PNP);

- ii. for the second offense, a penalty of Php 3,000.00 or community service for three (3) days.
- iii. for the third offense, a penalty of Php 5,000.00 or community service for seven (7) days.

If committed by a minor, the barangay shall require the minor, together with the parents or guardians, to undergo community-based intervention, such as community service, counselling, anger management training, psycho-social intervention, to name a few. Community service shall be used as intervention and not as a penalty.

SECTION 8. NON-RESIDENT OFFENDER. If the child is a non-resident of the barangay, the law enforcement officer or the barangay shall follow the Integrated Care Management Protocol in Handling Care and CICL and the Barangay Protocol in Handling CAR and CICL issued by the DSWD and JJWC.



Welfare Code for Children in the City of Mabalacat, Pampanga" is hereby amended to read as follows:

SECTION 17. Strict Implementation of the Existing National and Local Laws and the mandatory formulation and approval of Child Protection Policies of Public and Private Agencies, Establishments and Organizations catering to Children. The City Government of Mabalacat, through the CCWC shall ensure that provisions found in existing laws and issuances to protect children are STRICTLY ENFORCED and that FULL IMPOSITION OF PENALTIES are executed pursuant to the powers granted by the Local Government Code of the Philippines to the Local Government Units (LGUs).

In addition, agencies, establishments, sectors and organizations, public and private catering to children, bound by their duties and obligations, shall formulate and approve their own Child Protection Policies and shall be held accountable to implement the policies and services stipulated under such legal instrument.

SECTION 3. SEPARABILITY CLAUSE. All pertinent provisions of City Ordinance No. 26, Series of 2020 which were not amended shall remain valid and in full effect.

SECTION 4. REPEALING CLAUSE. All previous issuances, ordinances, rules and regulations or parts thereof which are inconsistent or in conflict with the provisions of this Ordinance are hereby repealed or modified accordingly.

SECTION 5. EFFECTIVITY CLAUSE. This ordinance shall take effect upon approval by the Sangguniang Panlungsod and after its publication to any newspaper of local and/or national circulation.



conversion of the CCSFP into a state college and its integration as a campus of DHVSU.

The position papers were transmitted to Baguio Rep. Mark Go, chair of the House committee on higher and technical education on Sept. 27.

Variably calling the proposed legislation as "absurd, insulting, and unacceptable" the stakeholders cited that "the CCS-FP's identity must remain as it always has been committed to the Fernandino's best interest - accessible to those who deserve it...its quality education top-notch, as evidenced by its LET and civil service passing rates."

The faculty and employees' association pointedly declared that "Integration to another institution is similar to eradicating CCS-FP's history, brand, culture and achievements.'

The board of trustees noted that HB4079 "will not only divest the city a platform to offer free quality education (which seeks to alleviate the poor condition of Fernandinos through formal education) but will also veer away from the spirit of devolution which empowers local governments and ensures that decisions are made closer to the constituents, thereby improving the delivery of services. stakeholders

The

lamented that "no public consultations, or at the very least, consultations with the stakeholders (i.e. students, faculty, alumni, etc.) were held."

While HB4079 was filed in August 2022, Gonzales filed a second bill on Sept. 19 - HB4985 seeking the conversion of the CCSFP into a state college to be known as the State College of the City of San Fernando. The school's integration with DHVSU dropped altogether.

On Nov. 11, Gonzales invited city officials led by Mayor Caluag and CCSFP president Gloria Bañas to a meeting to discuss both bills in the wake of their opposition to HB4079.

congressman The also requested the House committee on higher and technical education to defer committee-level schedules for the proposed bills pending the meeting with the concerned LGU.

Short of addressing all the concerns raised by the stakeholders on HB4079 in the Nov. 11 meeting, Monday's meeting was scheduled.

The stakeholders expressed "surprise and cluelessness" over HB 4985

Mayor Caluag said that they were not made aware that there was another proposal that did not require the CCSFP to be under the administrative umbrella of DHVSU.

It was here that she clarified that "we can agree upon" the conversion of the CCSFP into a state college.

Caluag, though, asked Gonzales for more time as she vowed to immediately call a meeting with the schools' trustees to further discuss the proposal.

The mayor said that a final decision will be made after her meeting with the trustees and vowed that her administration will continue programs to improve the quality of education being offered by the CCSFP.

In just the third month of her administration, Caluag increased the number of the college's enrollees from 700 to 1,500 students. CCSFP is also batting to add more courses to offer next school year.

Gonzales said that while Congress has the power to initiate the conversion of CCSFP to a state college with or without the approval of the LGU, he will accord respect to city officials by waiting for their decisions before making any further legislative actions.

"At the end of the day, this [bill] will not be about me or the mayor but the Fernandinos who will benefit from the funding and other national government Gonzales assistance," said. Punto News Team/ PR
