


NLEX Corp. to build 3rd Candaba viaduct

106 applicants hired on-the-spot at Clark job fair

TAU gets automated drip system from Israel

CAMILING, TARLAC -- Israel turned over an automated drip system to the Sustainable Mechanized Agriculture for Research and Technology (SMART) Agriculture Center of Tarlac Agricultural University (TAU).

P670,000-The worth project was funded by MASHAV, Israel's official international development cooperation program.

"MANATILING GISING. Hindi ninyo alam ang araw ng pagdating ng Panginoon." Ang Gospel reading ngayon ay tungkol sa mga bagay na hindi natin alam, kung ano ang darating, kung ano ang mangyayari bukas. Ang alam lang natin ay ang mga bagay sa nakaraan, mga biglaang pangyayari na marahil ay hindi natin napaghandaan – mga biglaang kalamidad, katulad ng lindol, pagputok ng bulkan, biglaang pagbaha, o mga sunog na hindi inaasahan. At kung gaanong perwisyo ang pwedeng idulot ng mga ganitong pangyayari, pati na ang pagkawala ng kabuhayan, biglaang pagkamatay ng mga mahal sa buhay, pagkasira at pagkawasak ng lahat ng naipundar.

Maraming tumulong sa mga nasunugan sa Navotas, pero isa sa mga tulong na iminungkahi ko sa parish priest ay post-trauma counselling. Pwede kasing mangyari na napakatindi ng traumang naranasan ng mga biktima, mananatili ang kanilang pagkabiktima, mahihirapang makabawi. Sabi ng matatanda, "Masira na ang lahat sa buhay mo, huwag lang ang loob mo." Kapag nasiraan nga naman ng loob ang tao, parang hanggang doon na lang siya, parang wala nang bukas.

Nakakatulong ang pagbabalik-tanaw at ang mga aral na pwedeng matutunan sa mga nangyari na sa nakaraan. Natutulungan tayo sa kasalukuyan na maging handa para sa mga bagay na hindi natin alam na puwedeng mangyari sa hinaharap. Kaya nga mayroong mga disaster-preparedness drills – hindi naman para takutin tayo kundi para alam na natin kung sakaling mangyaring muli kung ano ang gagawin, dahil hindi naman talaga tayo sigurado sa mga bagay na pwedeng mangyari sa hinaharap.

Pagdating" ang literal na kahulugan ng salitang ADBIYENTO, mula sa Latin AD-VENTUS. Ito ang apat na Linggo ng ispiritwal na preparasyon ng mga Kristiyano para sa pagdating ng Kapaskuhan. Kulay ube ang Adbiyento, ang kulay ng penitensya sa ating mga Kristiyano. Kakulay ito ng Kuwaresma na paghahanda naman para sa Pagkabuhay. Paalala ng simbahan na kung ibig natin maranasan ang ligaya ng pagkabuhay, dapat tayong dumaan sa penitensya ng Kuwaresma. Gayundin, kung ibig nating maranasan ang ligaya ng Pasko, dapat tayong dumaan sa penitensya ng Adbiyento.

Kaya nanghihinayang ako, dahil ito ang panahon na halos hindi maramdaman dito sa atin sa Pilipinas. Bakit? Dahil masyado nating minamadali ang Pasko. Hindi pa nga nag-uundas, Pasko na sa mga malls. At nalulungkot ako kapag pati mga taong sanay naman sa pagsisimba ay nagpapadala na rin sa komersyalismo, para daw sulit ang gastos ng Pasko. Nawawalan tuloy ng kahulugan. Nakakaligtaan na natin na ang pinaghahandaan natin ang pagdating ng Diyos sa ating piling, ang Diyos na pumasok sa kasaysayan natin bilang isang taong katulad natin, Diyos na nailakbay sa atin.

Nakakalimutan natin na ang pagdating na pinaghahandaan natin sa adbiyento ay may tatlong panahon: kahapon, ngayon at bukas, o nakaraan, kasalukuyan, hinaharap. Dumating si Kristo nang isilang siya sa Bethlehem. Ang nakaraan kapag binabalik-tanaw sa alaala ay maaaring sariwaing muli sa ngayon.

Pero sa Adbiyento ipinahahayag din natin na darating siyang muli sa hinaharap, sa wakas ng panahon, hindi natin alam kung kailan. Sinasabi natin sa Kredo, "Siya ay muling paririto at huhukom sa nabubuhay at nangamatay na tao." Hindi lang pagdating kundi PAGPARITO.

Ang pangatlong panahon na pinaghahandaan natin sa Adbiyento ay ang pinakamahalaga: hindi kahapon, hindi bukas, kundi ang NGAYON. Ito ang narinig nating sinabi ni San Pablo sa ating ikalawang pagbasa. "Ngayon na ang panahon upang bumangon sa pagtulog. Nalalapit na ngayon ang ating kaligtasan..."

Kapag bata pa tayo, ang lakas ng tukso na ipagwalang-bahala ang kasalukuyan dahil akala mo marami ka pa namang panahon. Kapag talagang inisip natin na malayo pa ang katapusan o ang pagdating ng hinihintay na deadline, malakas ang tendency natin na ipagpaliban para bukas ang mga bagay na puwede na sanang gawin ngayon. Saka lang tayo nagpa-panic kapag tumanda na tayo at biglang napaisip, kaunti na lang pala ang natitira nating panahon. Para tayong mga istudyanteng tutulog-tulog sa exam at biglang magugulantang sa titser na nagsasabing, "Oras na. Tapos o hindi tapos, ipasa ang papel."

Kung medyo kaedad ko kayo, palagay ko matatandaan ninyo ang isang Kodak commercial na sumikat dahil sa maramdaming kanta na kasabay nito: "Good morning yesterday, you wake up and time has slipped away..." Ang magandang umaga'y nagiging kahapon. Paggising mo lumipas na pala ang panahon.

Ang kasabay na video ay isang nakatatanda na nagbabalik-tanaw sa nakaraan sa pamamagitan ng mga lumang litrato. Binabalikan sa alaala pati ang maraming mga posibilidad na puwede pa noon pero lumipas na ngayon. Sabi nga ni Noel Cabangon, "Pana-panahon ang pagkakataon, maibabalik ba ang kahapon?" At ang punto niya ay simple lang. Isang paalala na "Lumilipas ang panahon."

Ang sikreto ng hinaharap ay ang pagkamulat na napakabilis lumundag ng bukas sa kahapon, lalo na kung hindi natin isinasabuhay at pinagyayaman ang ngayon. Kaya nagpapaalala si San Pablo sa ating ikalawang pagbasa na huwag maging kampante, huwag sayangin ang panahon, huwag magsawalang bahala na para bang laging nandiyan ang pagkakataon. Mabilis mawala.

Ito ang dahilan para sa Adbiyento. Ito ang panahon na dapat itanong sa sarili, "Kung alam mo lang na iyon na pala ang huli ninyong pagkikita ng kaibigan mo, o ng mga magulang mo, o ng mahal mo sa buhay ano kaya ang ginawa mo? Kung alam mong may taning na ang buhay mo, paano mo gagamitin ang natitira mong panahon? Kung alam mong magugunaw na ang mundo o magwawakas na ang daigdig sa loob ng isang linggo, paano mo gugugulin ang pitong huling araw na natitira sa buhay mo?

Ang pinakamahalagang pagdating na dapat paghandaan sa adbiyento ay hindi kahapon o bukas kundi ngayon.

Di ba sabi ng kinakanta natin sa simbahan, "Minsan lamang ako daraan sa daigdig na ito. Kaya anumang ang mabuting maaaring gawin ko ngayon o anumang kagandahang-loob ang maari kong ipadama, nawa'y huwag kong ipagpaliban, (sana ay

Traffic and politics

A generation or so ago, and it always seems it was yesterday, traffic was not a local governance reality like politics was, is or has been and always will be. Politics, after all. Is a continuum. It may sound hopeless, so there is the challenge or the curse, as the case maybe, if you will.

Pat Guevarra, the peaceable former mayor of San Fernando, then still the capital of Pampanga, saw only half of the equation. "it's a sign of progress", he told a group of his media friends whom he favored every now and then with "good only for five" notes to a local gas station, meaning five liters of gasoline. It was enough to do the regular news hunting. It also shows how traffic wasn't yet a problem at the time;

In the time of the late Gov. Bren Guiao, when governance was fun and a slap in the back impressed or interpreted, rightly and wrongly, as a sure endorsement, traffic was never on the agenda during the morning meeting at the Capitol. Growth was, or its bragging right. Beating Cebu became a political mantra.

The subsequent eruption of Mt. Pinatubo only delayed the inevitable, perhaps made more dramatic the unprecedented growth in the province and in the future city of San Fernando, transforming the local landscape in more ways than one. Growth in traffic made it more obvious.

Last week, Acting Gov. Lilia Pineda saw the flip- side to Guevarra's equation:it's a problem that worsens every day it stops or delays you on your track. It appears that traffic has already arrived in Guagua, near her hometown, from Guevarra's erstwhile kingdom. If only she could stop the wave, like King Canute of the legend. While scientists assure us that the universal continues to expand, traffic continues to get worse before they get better, and the challenge or curse inevitably ends up on the local official's, mayor or governor, plate.

One local official was once asked about the predictable problem in his area, and he was quick to draw a simple solution: traffic aides. The problem continues to be predictable as ever to this day. The traffic jams that are a daily occurrences where traffic aides were as seen part of the problem remain. So do the traffic aides.

Albert Einstein had earlier warned that you cannot solve a problem on the same mindset or thinking it was created.

Traffic aides may seem remotely inspired by Einstein's suggestion. They are humans,too and no match for the harsh and hard realities in their territory: rain, heat and wayward motorists. Whether they are vulnerable to persuasive factors, it's part of the landscape. There are traffic signs, some dumb down for effect, but still are largely considered as optional, mere suggestions and not applicable, thank you.

Traffic is costly. A Japanese study estimated that about P6 billion a day is lost in the traffic gridlock in Metro Manila. It's a warning to other regions beyond the Imperial Capital. There was once a resounding call to decongest it as a sure-fire solution. When it looked like traffic was beginning to clog up city streets in Pampanga as well, the strident call suddenly ceased. One

businessman asked another businessman if he still believed in the idea of decongestion. Progress had overtaken the summon.

The recent appointment of the son of former Clark top man Arthur Tugade to a transport agency brings hope that the traffic problem in the country would be eased. If the father's genes are dominant, he should have an eye for the obvious and doable. When he came to Clark, the older Tugade saw something unusual in the corporate practices. He found out, for instance, that government mone y was placed in the checking accounts, where it didn't earn interest, instead of into saving, were it should have earned. For some reason, it also decided to do away with some incentives, triggering the exits of some executives. Tugade didn't mind.

Tugade, the Younger, may following his father's footstep as the new kid on the LTO block: see the obvious, do the doable. He can start with the licensing process where a big, critical part of imposing discipline among drivers can start. Start with the fixers which the agency says on its posters are illegal, but lurk around the environment, in and out.

Implement the laws or the ones taken for granted. For instance, there used to be a law that banned tricycles on highways. Pity the poor, one former LTO executive explained why the law was mothballed in his time. The executive was a former mayor, a politician, to be exact, in a position where political will is needed.

The younger Tugade can start with something that be felt and seen. The others, he can learn like a parachutist: on the way down.

Like politics, traffic is too important to be left alone to politicians. He may also consider having a hand in choosing and training traffic aides to do their job more effectively and with authority. The other night, one self-appointed parking valet stopped a bike-riding traffic aide while guiding a "client" to a slot as if he had the authority to do so

The police should rediscover their old role in helping manage the burgeoning traffic problem in our society. They seem to be not really keen on resurrecting an old task with the same passion and conviction. It's consistent with the serve and protect mandate. The acting governor suggested that in calling the police to help in managing the rising traffic menace. Again, Tugade can harness the cooperation of the local officials, the police, and the private sector, especially the business sector in collectively addressing the traffic pains.

"Have you ever noticed that the one driving slower than you is an idiot and any driving fast is a maniac?", George Carlin said.

The younger Tugade can break the mindset. It will be a good start.

aba Viaduct.

"The new road and the improvement of the present expressway will ensure the continued interconnectivity of Metro Manila and areas south of Luzon, on one hand, and central and northern Luzon, on the other," Gonzales said.

He noted that aside from thousands of motorists and commuters, billions of pesos worth of goods are transported between the National Capital Region and central and Northern Luzon

through NLEX.

"So, safety issues arising from the two viaducts' age and their constant use and heavy load are a real concern. I am glad that NLEX Corp. is addressing these," he enthused.

A civil engineer by profession. Gonzales said he had foreseen such issues in 2016, when he proposed in a meeting with the Pampanga Chamber of Commerce and Industry that a new viaduct needed to be constructed.

Lawyer Romulo Qui-

mbo, chief communications officer of Metro Pacific Tollways Corp. of which NLEX Corp. is a subsidiary, was reported to have told the meeting that the third highway would be built between the two existing northbound and southbound viaducts.

To comprise lines, the third highway is planned to start construction in the first quarter of 2023 and targeted to be completed toward the end of 2024. A traffic scheme will be set in place during construction to avoid inconvenience and disruptions on the part of motorists and commuters.

Quimbo said the third highway is planned to be used by cargo trucks and other heavy vehicles, while the existing spans would be limited to cars and lighter vehicles. He noted that the two viaducts are being repaired, improved and retrofitted so they would become "like new roadways."

The new viaduct will reportedly cost NLEX Corp. some P8 billion.

The Department of Public Works and Highways, Department of Transportation, National Economic and Development Authority, and the Toll Regulatory Board have reportedly expressed support for the planned new viaduct.

TRB officials however warned that its construction and completion would require increase in toll fees.

As this developed, Gonzales also appealed to NLEX Corp. to assist the DPWH in the rehabilitation of at least five bridges crossing the expressway, from Bulacan to Pampanga.

"These were built by the national government or local governments. They are not part of NLEX but they make access to the expressway easier and faster," he said. Among these is one that will replace the two existing flyovers in the City of San Fernando which Gonzales had also discussed some seven years ago with members of the local business chamber. phoons," he stressed. Solidum disclosed that the agency has developed a plant growth promoter increasing rice yield from 20 to 30 percent, and fattens rice stalks to not be easily destroyed by strong winds.

Meanwhile, DOST Undersecretary for Research and Development Leah Buendia shared that they are continuously funding research development programs for climate

adaptation, disaster management, and disaster risk reduction.

"We have many programs in the aspect of agriculture, health, and industrv... Among those that we have now are food packages that we hand over to those affected by disasters," she said.

The agency also conducting information, education, and communication campaigns to elicit climate change among awareness communities.

For her part, DOST Undersecretary for Scientific and Technical Services Maridon Sahagun emphasized that they are also developing scientists and researchers by providing scholarship programs for undergraduate and graduate degrees with specialization in science and technology.

"If we do not have the expertise here, we will look for countries that can provide us with training for our scientists, researchers, and engineers to do adaptation and all the preparations that we need to address climate change," she said.

DOST is also building up and improving the facilities and infrastructures of Philippine Atmospheric, Geophysical and Astronomical Services Administration, and Philippine Institute of Volcanoloav and Seismoloav to strengthen their forecasting and monitoring capabilities.


