

Smoke smothers San Simon town

Environmental, health crises loom



SAN SIMON, Pampanga — Alarms were raised over an impending large-scale environmental and health crisis posed on the residents here as harmful emissions from steel manufacturing facilities here remain unabated.

In a press briefing, San Simon Association of Barangay Captains president and ex-officio councilor Randie Flores alleged a high mortal-

ity rate and the emergence of pulmonary and related diseases obtained among residents, triggered largely by daily emissions of highly toxic air pollution and contaminants from several steel plants along Quezon Road.

"Almost 30% of our barangay's total popula-

tion has health issues due to the heavy pollutions brought about by mostly Chinese-owned steel smelting



2 steel plants to undergo EMB air, water sampling

CITY OF SAN FER-NANDO — The regional director of the **Environmental Man**agement Bureau of the Department of Environment and Natural Resources in Central Luzon has ordered EMB personnel to conduct air and wastewater sampling tests at Wan Chiong Steel Corp. and Melters Steel Corp. in San Simon town on Jan.

In a mission order signed by EMB Region 3 director Wilson Trajeco, a team from the EMB and one representative from the Provincial Environment and Natural Resources Office are assigned to conduct the site investigation.

This, according to Trajeco, is "in the interest of the service and in view of the strict implementation of RA 8749 otherwise known as the Philippine Clean Air Act of 1999."

Under the order, the team shall validate the veracity of information stated in the incident report of Wan Chiong Steel Corp. dated

Agila to help nat'l govt on agri issues

BALANGA CITY – A non-government organization in Central Luzon called the Agricultural Growth through Inclusivity and Leadership by the Private Sector for Acceleration of Modernization and Industrialization (Agila) has expressed its intention to come to the aid of the national government on the issues surrounding the agri-

culture industry of the Philippines.

In an official statement, Agila identified the current problems of the agricultural industry including the drawback in logistics considering the country is composed of more than 7,000 islands, the continuous increase in population, and the effects of climate change.

According to Agila president Jerry Pelayo, former mayor of Candaba, Pampanga, agricultural importation in the country must all be on a government-to-government basis, and all transactions must be published for transparency.

His group also noted the need to create a monitoring board in order to efficiently keep an eye on the imports and avoid hoarding of goods.

Pelayo also cited the necessity of the Department of Agriculture "to have police power in order to put teeth in the law."

The former Pampanga Mayors' League president turned full-time farmer also

Ebdane bares priorities in SOPA

IBA, ZAMBALES – More development projects to improve public service delivery, create more economic opportunities, and further push for development sustainability in the province were cited by Gov. Hermogenes Ebdane in his 2023 State of the Province Address (SOPA), on Jan. 23.

Speaking before the Zambales provincial board and other local government the governor said his administration will continue to build facilities to address infrastructure gaps and improve the delivery of social services and public health, as well as meet requirements for business and ancillary services.

Among the proposed infrastructures are a state-of-the-art annex facility for the President Ramon Magsaysay Memorial Hospital and a new Capitol building, Ebdane said.

The development program, he added, will be funded under the LGU-Omnibus Term Loan Facility Program of the Land Bank of the Philippines.

"It is high time that we must implement identified priority development projects as embodied in our comprehensive development plan," Ebdane enthused.

Aside from implementing infrastructure projects to sustain development, the provincial government has also identified four other priority areas that it will focus on under his direction.

These include improving health and social services by establishing a state-of-the-art hospital with more doctors, nurses, and other medical professionals; strengthening education and youth development to bolster youth participation in community-building; capacitating human resources and upgrading technological resources to promote excellence among government workers; and providing livelihood and support to social enterprises to create opportunities for sustainable income-generating activities for various sectors.

Ebdane is confident of success in these endeavors following an increase in local income from dredging activities in three river systems in the province. The dredged materials are used mainly for ongoing reclamation projects in Manila Bay.

"The key to achieving these goals is intensified revenue generation program, including efficient tax collection," he said. "We expect more revenue to be generated through proper management of dredging, which have become a viable source of income for the province."

"We must be bolder in our ambitions for the province... We must not only win in our fight against poverty; instead, we must end it! We must not only lay down the foundation of good governance; rather, exemplify and demonstrate it in our decisions and actions. We must not only fulfill our duties as public servants, but engage our people in building a community and inspire actions of change for sustainable development," Ebdane added.

The theme of this year's International Day of Education reminds us that "to invest in people, prioritize education." Investment is critical to achieving Sustainable Development Goal 4.

Last year's Transforming Education Summit gathered the world together to reimagine education systems so every learner accesses the knowledge and skills required to succeed. Over 130 countries made commitments to ensure that universal quality education becomes a central pillar of public policies and investments.

A Call to Action on Educational Investment and the establishment of the International Financing Facility for Education created a fresh push on domestic and international financing.

And the Summit launched a range of global initiatives to mobilize support for education in crises settings, girls' education, foundational learning, transforming teaching, digital tools, and green education systems.

Now is the time for all countries to translate their Summit commitments into concrete actions that create supportive and inclusive learning environments for all students.

Let's deliver education systems that can support equal societies, dynamic economies and the limitless dreams of every learner in the world.

The Davos lamentation

Instead of skiing, apart from speaking, our President needed to let it out before a world audience. In Davos, Switzerland where global leaders met recently to discuss the state of the world's economy, President Bongbong Marcos found the perfect opportunity to tell the world why—not how—he became a politician, ultimately as the highest official of his country.

He never intended to be in politics, he said, but his father's rude expulsion from Philippine politics in 1986 via the EDSA People's Revolution, his family's eventual six-year exile, their difficult survival, and concerned about his father's legacy, compelled him to jump into politics. His father went through tough times in politics made the sacrifices, probably not all, to serve the country.

And what did he and his family get in return? It was the darkest day in their lives, he said, even for the country, the day they left Malacanang for Hawaii instead of Paoay. His return to the Philippines and becoming a politician was premised on the perceived unfair treatment the family received from their countrymen.

Those who disagree with his pathetic lamentation can match every word or sentence with pictures, videos and testimonies that will separate facts from fiction, the chaff from the grain.. The jury is still out whether PBBM has made converts after the conference. Those who heard him, or cared to listen to what he had to say, had the resources available to find out, if they didn't know beforehand, that the message was true or not. Trolls and social media have made the search for truth difficult, if not impossible.

He brought along a big delegation speciously to answer any and all questions about the country's need at present, including investments and loans to shore up a country that is more heavily indebted than ever, partly thanks or not thanks to his predecessor. The delegation is there for another purpose: to serve as living witnesses to confirm his unpleasant memories from his own people. One of them is a former president whose late father was a former president who sought asylum at the US embassy in Manila for fear of his safety.

So far, the former dictator has been successfully buried, after an eternity of a wake in his hometown, in a hallowed ground meant only for heroes and patriots. The medium is the mes-

sage. What other things will be made or invented in his honor, there is at least about five years for the only son to do or bid. Once upon a time, soa it was said, a brave soldier led a guerrilla group known as Maharlika in defeating Japanese enemies during World War II somewhere in the Cordillera mountains.

Historians had debunked the dubious claim, along with the heroic medals that were supposed to have been given for the improbable war feat. The emperor was naked in the face of such make-belistory. A new Maharlika has recently emerged, this time it's about fighting a different enemy to deal with the economic difficulty the nation is facing. It's supposed to be a huge fund drawn from private sources, later on amended because of massive opposition, amended further to access funds from other sources until, as one expert commented that it no longer looks the same as it was meant to be.

You'll never know, in fairness. The Davos sales pitch may just work. The melo-dramatic confession might just do the trick. The outsized delegation of experts and politicians might just convince some people to try the offer, who knows. On the biblical principle that the borrower is slave to the lender, it might be worth the try.

In his Davos message, was PBBM like Shylock asking for for a pound of flesh from Antonio who owed him? "A pound of flesh is mine because I paid for it", he told Portia, the judge. Fair enough, she agreed but told Shylock he should not, in the process, shed a drop of blood from Antonio. To be fair, PBBM made no such explicit demand in his message.

'The Marcoses are back, they and their President and ours ,too (he is the President, too, of those who were responsible for their exile) still feel bad about their past, and no doubt have an ax to grind against their own people. Suffice and easy to say that their pent -up feelings and grievances, rightly and wrongly, will impact politics and governance in this country, as they have evidently done already, in the next five years or so, even beyond.

One harbinger of such impact would be if PBBM will signal, one way or the other, a Charter Change which former Supreme Court Chief Justice Artemio Panganiban recently opined that this is the i wrong time to do it. The other is how PBBM treats the opposition. There are no encouraging signs on the horizon so far. Former senator Leila de Lima is still in jail after six years while the former chief of staff of his presidential legal advisor has been released after a much shorter term in detention.

The 'pound of flesh' and the 'drop of blood' might as well be understood better not literally but metaphorically. Healing ,of course, of anything is said to be not only a matter of time but a matter of opportunity. Our leaders need to have such wisdom. It takes two to tango as to unify.

Work Values of School Heads

The school head is essentially a leader of the staff and the pupils/students of a school. Being a leader, it is only but proper and necessary that she must possess some qualities and values that are considered good, important, and desirable in bringing about a favorable climate and condition conducive to teaching and learning. Aside from this, the school head serves as the school's agent or conveyor of values and ideas. She is look up to as a teachers' leader model.

Each worker brings to his jobs certain likes, dislikes, and personality traits that make up her" value sets". When this value sets conflict with those in her job, the job suffers. This conflict results in poor work attitudes, like absenteeism, tardiness, low productivity and general discontentment for the workers as well those around her.

The school head and the teachers have important roles of modeling learners and desirable values within the school system to bring out appropriate personnel development and good relationship with other teachers.

In decision making, the values of the school head serve a perceptual screen. Work values condition the screening of possible alternatives and serve as the criteria against which higher goals are assessed and projected. The nature and extent of differences in work values between and among members of the group will have systematic effects on their working relationship. With this performance, she is going to be able to strive for higher rank within the profession and to relate herself successfully to others.

THE FÓLLOWING ARE WORK VALUES OF A SCHOOL

- 1. Aesthetics is component of work that is inherent in the work. This permits the person to make beautiful things and to contribute beauty to the world and the formation of a healthy attitude toward work.
- 2. Achievement is the feeling in accomplishment of doing a job well. In short, the worker feels accomplished or fully satisfied after she determines the worth of her finished work.
- 3. Altruism is a work value that enables a person to contribute to the welfare of others. This component assess social services values and interest in the job.
- 4. Creativity is another component of work values which reveals one's capability to invent new things, design new products, or develop new ideas.
- 5. Surroundings as a work value component means the degree of pleasantness of the working conditions while carrying out the job. Physical and psychological environment appear to have bearing on the work value orientation of the workers.

Leading and managing the school requires over exertions and time. A good school head or principal therefore also must have the subsequent leadership qualities and mindset:

- 1. Visionary. A visionary principal doesn't accept the establishment. He/she strives to satisfy the required outcomes. He/she finds ways to deal with future challenges.
- 2. Visible. A principal who is commonly seen within the school premises promotes stability, calmness and sustainability. A visible school head may do the following:
- Take the primary two hours within the morning to roam around and remember of what's happening within the school;
- b. Inspect common toilets, facility, electric lamps, presence of intruders, etc;
- c. Communicate with parents and a few learners and monitor if there are learners staying outside during class hours.
- 3. Transparent. To be transparent means to be honest the least bit times, particularly all told financial transactions involving human and technological resources. Transparency in financial management may make or break a faculty head. Stakeholders must be told on how the money is spent and liquidated supported the upkeep and Other Operating Expenses (MOOE), canteen proceeds, income from IGP, donations, contributions, etc. The more transparent the varsity head is, the higher for the college. If transparency is obvious within the school, people are going to be enticed to support school-based endeavors. Keeping them informed of the E-SIP/AIP and also the School report is a plus. Pertinent information is posted in an updated Transparency Board along with the Citizen's Charter.
- 4. Provides Technical Assistance. A school head must provide Technical Assistance (TA) to people who need it. In fact, TA is one in every of his/her Key Result Areas (KRAs). It's going to be within the variety of mentoring, coaching, conducting training and workshop, answering some inquiries, leading a team, sharing opinions, correcting and editing proposals and correspondences, etc.
- 5. Empowers people. To empower means to provide others the total trust to try and do something for the betterment of the school. School heads who are afraid to delegate their responsibility don't seem to be real leaders and managers.


the state agricultural universities and colleges in our country to help address the anticipated agricultural setback in the future," he added.

and manufacturing plants," Flores revealed.

He identified five suspected major emitters of harmful particles and air contaminants particularly in Barangay San Isidro as WanChiong Steel Corp., Real Steel Corp., Altima Empire Steel Corp., SKK Steel Corp, and Melters Steel Corp.

He said that even before he assumed the chairmanship of Barangay San Isidro, these steel corporations have been the subjects of complaints of residents.

Flores narrated that in 2020, he filed a complaint against Melters Steel Corp for non-compliance of their pollution control devices (PCD). He later filed an affidavit of desistance after the corporation complied with the proper use of their PDC.

"But for the past weeks now, Melters Steel factory has been spewing thick smoke and harmful air pollutants and we are now preparing necessary legal measures to abate this irresponsible business operations of the steel company," Flores stressed.

Another steel factory in the area, Wanchiong Steel Corp., has been "blatantly spewing even larger air pollutants on a daily basis."

"These must all be stopped at the soonest possible time." Flores said.

Flores said factors that contribute to the harmful emissions might be negligence on the part of the steel corporation's outmoded and improper use of their PCDs as they had already found out long before.

Flores claimed some factories have lessened their smoke emission by

using an electric arc furnace, a non-emitting pollution device but a number of them are still using in their factories induction technology, an old model, which causes the smoke.

"The emission is not totally cut, but with the use of the electric arc furnace it helps a lot to control pollution being spread in the community," Flores added.

Flores recently sponsored in the sangguniang bayan Ordinance No.'23-003 - "An Ordinance Abandoning the Traditional Technology on Smelting Steel Scrap and Modernizing the Production of Steel Billets Attuned to the Environment-Protective Latest Technology within San Simon, Pampanga" which has already passed second reading.

He said during the time of the late Mayor Leonora Wong, she convened a regular tripartite team inspection quarterly. The members or the team consisted of the DENR, LGU, and barangay officials.

Flores, however, said the present administration of Mayor Abundio Punsalan Jr., has not convened the tripartite team for the welfare of constituents here, particularly in the worst affected barangays of San Isidro, Sta. Monica, San Pablo Proper, San Pablo Libutad, and Dela Paz.

Flores also appealed to Punsalan to support and approve the ordinance to combat hazardous pollutants that are painting the San Simon skies black.

"This occasion brings back happy memories of the time when I was still your parish priest at the Pisamban Maragul... and we worked together more than a decade ago now, through the "Sagip Sapang Balen" environmental advocacy project.
