Opens March 29, toll-free for now

MANILA -- After its inauguration with President Marcos, the 5-km Caloocan-España Section of the NLEX Connector will be open to the motoring public starting 12:01a.m., March 29, and toll will not yet be collected for a limited time.

"We are offering free access for a limited period, so motorists can experience for themselves the convenience of using the NLEX Connector," said NLEX Corp. president J. Luigi L. Bautista.

NLEX will issue another announcement to advise motorists when it will start collecting toll for this new expressway built to improve mobility and deliver economic development opportunities in north and south Luzon.

With the opening of the first section of the elevated expressway, motorists may now enjoy the comfort of traveling between Caloocan and Manila in just five minutes instead of 30 minutes or more when using local roads. This is very timely as NLEX anticipates the influx

CEB generates P56.8-B revenues for 2022

MANILA -- Cebu Pacific (PSE: CEB), the Philippines' leading carrier, recorded a 261% increase in revenues to P56.8 billion in 2022 from the previous year.

Passenger business led the steep recovery with growth of 459% year-on-year to P35.1 billion, on the back of higher travel demand, both domestically and internationally, coupled with the easing of various travel regulations.

While 2022 brought optimism on the demand front, CEB's profitability remained challenged by the economic environment, as jet fuel prices spiked and the peso depreciated versus the dollar.

Amidst these headwinds, CEB's EBITDA returned to positive territory at P664 million from 2021's negative P8.8 billion. Net loss narrowed to P14 billion in 2022 from P24.9 billion the previous year, and operating loss reduced to P11.4 billion, about half of previous

year.

The airline's recovery accelerated during the fourth quarter of 2022. Total revenues up 192% year-on-year to P19.2 billion. Net loss reduced from P2.9 billion in the fourth quarter of 2021 to P1.9 billion in the fourth quarter of 2022. Operating loss decreased significantly, from P4.3 billion in the fourth quarter of 2021 to P232 million in 2022.

Despite facing unprecedented headwinds, CEB is confident in its ability to overcome them while remaining true to its commitment to enable everyone to fly. "CEB is ready to move forward with optimism and confidence as we transition from recovery to growth mode. 

Instead of spilling your blood on the streets, why not walk into a Red Cross office and donate blood? Choose to share life. Share your blood.

Do we need to walk barefoot till our soles get blisters as a form of penance for our sins? Why don't you buy a pair of slippers and give it to a child who goes to school dragging his torn footwear?

Do we need to sing the "Pasyong Mahal" as an act of devotion to the story of Christ's sufferings and death? Why don't you buy a Bible instead and read one chapter a day with your family for the rest of the year?

Do you need to get the flowers from the Holy Week carrosas to bring home and adorn your family altar? Why don't you bring flowers instead to a home for abandoned seniors and brighten the faces of lonely grandparents with the love you bring?

Wretched food

TODAY'S FIRST reading makes me think of that passage in the sermon on the mount in Mt 7 where Jesus asks in v.10, "Which father among you would give his son a snake when he asks for a fish?" I wonder how Jesus would have reacted if one of the disciples played the wise guy and quoted Number 21 and said, "How come when the Israelites asked for food God gave them snakes causing many of them to die?" My answer to that is, "They were not asking for food. God had already given them food but they were still complaining about it."

Listen to what they said to Moses in Num 21:5, "Why have you brought us up from Egypt to die in the wilderness, where there is no food or water? We are disgusted with this wretched food!" It was not true that they had no food. They did not like the food God was giving them. Siguro hindi masarap. What they longed for was the kind of food that they ate when they were still in Egypt. In short, they were practically expressing regret that they even escaped from slavery at all. It's like saying, "We would rather remain as slaves and have good food, than be free and be hungry." Imagine, they called the food that God was giving them "WRETCHED FOOD!" How painful that must have been for God!

Sometime children behave like that towards their parents. They don't realize the kind of poison that comes from their mouth when they behave like spoiled brats. I remember a father, a jeepney driver, telling me how hurt he was to hear his son whom he was sending to college saying he was ashamed to show his classmates his "miserable Nokia phone" while everyone else had an iPhone.

What would you feel if you were a mother who had to wash a mountain of clothes just to earn some money and buy some food to serve at table for your children, and then the children say, "we are sick of this wretched food?" (Sawa na kami sa walang kuwentang pagkain na ito!) I find it more sensible not to treat the sto-

The Israelites, as it were, had been bitten by the poisonous snakes among their own companions, whose mouths were spitting venoms of uncharity and utter insensitivity to the very one who cared for them. Children can be like that when they are young and unaware of what their parents have to put up with to be able to feed them. It takes time before they realize that what was served to them was not just rice and fish but blood, sweat and tears. The strange part of the story is when Mo-

ses is told to mount a serpent on a pole to save those who had been bitten from perishing by getting them to behold that which had poisoned them. It becomes even more strange when the Gospel applies it to the "lifting up of the son of man" so that those who behold him whom they have pierced will be brought to a realization and saved.

The symbolism is basically making a paradoxical statement—until we realize the deadly poison that has bitten us, until we get to recognize the pain that our own uncharity and insensitivity have caused on the very people who care or us, we will not be healed.

An ode to my *Tatang* on his 99th birthday

I WAS on my third year as a school administrator of the St. Nicholas Academy: CCEI in Macabebe when one parent approached me after the general orientation and told me she was my late father's teacher in his last post as a public school principal.

She went on to tell me that the way I talked and argued over some school issues reminded her so much of my father. I could have just simply thanked her for her kindest of words. Don't get me wrong. My *tatang* was not one highly-celebrated or multi-awarded figure who landed on the front page of leading newspapers for some outstanding achievements. Far from that! He was one simple, ordinary individual who touched the lives of others in an extraordinary way. It was his unassuming and unpretentious ways that endeared him to the people he met.

To this day, my siblings and I get to meet some of his former students and teachers who have nothing but praises for him. As a school principal, he brought out the best in his teachers. His personal joy was to see his teachers become better year after year, rise from the ranks, and get promoted as school administrators as well.

During the bygone era of issue-based election campaigns, local politicians would come to our house to seek his "little endorsement" and bring him to their sorties and caucuses. Barrio folks loved seeing and listening to my *tatang* as he was someone they believed in and can relate to. Despite the friendships he had forged with and his loyalty to our town's political leaders, he shied away from politics and never asked for any favor. I think this is the reason why the second-generation political leaders he supported continue to treat us not as supporters but as family.

Of the many hats he wore, I think he was in his best elements when he was just "Emo" to the love of his life, "Curing," our mother and "Tang" to his nine children. Growing up, we did not live a comfortable life. But despite this, we always felt complete as individuals because my parents' great love for each other and for us **PAGE 11 PLEASE**



Our brain and our bragging right

By their IQs - intelligence quotients, that is - you shall know them.

So every so often, the IQs of nations of the world are measured. Per the latest, ours is not really that bad – needing more improvement, no doubt—but not among the best, let alone the best, in the world, or in Asia for that matter.

The latest IQ report shows the Philippine average at 81, which is 111th out of 199 countries. Our average IQ was found lower than that of North Korea (91), Myanmar (90), Irag (89) and Afghanistan (82). Not surprisingly, Japan (106), Taiwan (106) Singapore (105) are among the world's highest. China and South Korea are also included. The five countries have one thing in common, if it is factored at all: Confucian ethic.

The pandemic also brought down our IQ five points lower from the pre-pandemic average of 86. It was also dead last in the ASEAN region led by Singapore with 108. Vietnam had 94, Malaysia had 92, Thailand had 91, Brunei 91, Cambodia 91, Laos 89 and Indonesia 87.

What gives? IQ is the standard measure of smartness. But there other contributing factors such as poverty, quality of education and other socio-economic circumstances. The Filipinos, apparently, didn't do well during a twin fate of authoritarian regime and a calamity as can be gleaned from the data of the world population review . Our IQ world standing is a wake up call – again – to our national leaders.

Meantime, the debate on whether IQ is a function of genes or environment continues. The two school of thoughts have been simplified to nature (genes) and nurture (environment). It is said that the secretary to Albert Einstein once commented that if Einstein grew up with polar bears, he would still be Einstein. The late Singapore Prime Minister Lee Kuan Yew believed in the role of genetics as well. He openly encouraged intermarriage among his people with high IQ. His country's consistent standing in the upper echelon of the best and the brightest seems to validate this, apart from its highly reputable educational system.

Filipinos are very good musician,though, Lee Kuan Yew said in an inter view for his biography. "Yes the boys (his) – they're bright, they read the notes and produce the sounds but in a mechanical way." Whereas you get a natural musician,a Filipino, he listens to it, he can without looking at the notes, reproduce for you the sound. He's got the mental and musical capabilities."

Sir Francis Galton, a 19th century scientist and polymath, believed in pedigrees or genetics. He thought geniuses, or people with high IQs owed their success to genetics or "natural abilities" passed on by their ancestors. It also explained why societies with many immigrants and refugees were often successful. We call it brain drain, to explain the diasporic movement our bright people to temporarily or permanently seek green pastures in foreign countries. In his book "Geography of Genius", Eric Weiner noted that foreign immigrants make up only about 13 percent of the United States population but they have most, if not all, patents and inventions in their names and have won most of the Noble Prize awards. Inversely, he also explained the decline of the Greek civilization because of the intermarriage of the Greeks to "lesser" peoples .

Jack Ma,the most famous Chinese businessmen, explained at least two factors leading to his rise as one of the smartest businessmen in the world through Alibaba. In an interview for the Weiner's book, Ma cited the strict educational system in China and the influence of religion. Education, Taoism, and in a way, the coercive impact of the communist government influenced his success. In the end, however, Ma's high profile success also became his undoing. He's no longer as publicly visible as he used to be, apparently due to the coercive environment he lives in.

In his book, Weiner concludes that genius is not in a single individual but in a cluster, as in a certain geographical site, like Greece which produced most of the world's philosophers like Socrates and Aristotle. Only Renaissance Florence (of Italy) came close, Weiner wrote. Machiavelli and the Medecis were her most famous citizens.

Notwithstanding the persuasive notes from history, Weiner thinks high IQ, or genius If you like, is not "out there" or "in here" but in spaces in between. He specifically says genius begins at home, like charity. And home means family, and what is a nation but groups of families that live, enrich and promote a culture of excellence, like world-class IQ.

Which means we have a lot of work to do, given where we are in the latest IQ world ranking. Quoting the ancient Greek poet Hesiod ,as Weiner did, "before the gates of excellence, the gods have placed much sweat. The road is long,rough and steep. The sweat of labor often mingled with the sweat of pain." Where do we begin?

There are at least two elephants in the room: poverty and corruption, More people fell deeper into poverty in 2022, especially outside Metro Manila ,according to the Social Weather Station,while income inequality continues to beset the country. Inequality of opportunity and low mobility, said the World Bank, waste human potential. The Philippines also ranks 116th among 180 countries in the Transparency International Corruption Perception Index in 2022, moving up to 33rd place from 38th last year , and cited among the decliners in the Asia Pacific region.

With its huge debt, soaring inflation, rising criminal activities, political cross purposes hedging reforms and a perceived weak judiciary, the national leadership can be lost in the weeds, so to speak. A charter change, more borrowings through a dubious plan, increase intelligence funds and reviving the ROTC may not be the priorities needed to boost our IQ ranking in the world. We have to define and determined where our genius loci should be. And it's not in the mythical golden age of the past. Payment of the P203 billion estate tax ordered by the Supreme Court to the Marcoses will be a good way to start, thank you.

AN ORDINANCE *INSTITUTIONALIZING THE FERNANDINO DIALYSIS CENTER* IN THE CITY OF SAN FERNANDO, PAMPANGA AND FOR OTHER PURPOSES

EXPLANATORY NOTE

WHEREAS, Section 15, Article II of the 1987 Constitution of The Republic of the Philippines states that the State shall protect and promote the right to health of the people and instill health consciousness among them;

WHEREAS, Section 2 of the Local Government Code of the Philippines states that the territorial and political subdivisions of the State shall enjoy genuine and meaningful local autonomy to enable them to attain their fullest development as self-reliant communities and make them more effective partners in the attainment of national goal;

WHEREAS, according to a study from the University of the Philippines, one (1) Filipino dies from kidney failure every hour, and there are close to 35,000 Filipinos who are undergoing dialysis and treatment for kidney disease in the country and over the past decade the number of new cases has increased by about 15% every year and with uncontrolled diabetes and hypertension as risk factors for kidney disease that could end up requiring a kidney transplant, dialysis is a temporary measure;

WHEREAS, in the Philippine context, 2% of Filipinos have chronic kidney disease and to date, there are 414 indigent dialysis patients in the City of San Fernando, Pampanga;

WHEREAS, as stipulated on Philhealth Circular No. 022-2015: New PhilHealth Dialysis Package, a dialysis patient who is a principal member with no dependent/s shall be granted an automatic additional 45 sessions. In case wherein the principal member and one of the dependents are both undergoing dialysis, they shall both share a maximum of 90 sessions only. Thus, this health problem levies a massive economic burden resulting in out-of-pocket expenses to patients;

WHEREAS, the City Government of San Fernando, Pampanga, endeavors to support and provide assistance to the Fernandinos who are currently afflicted from renal and kidney diseases by offering a complimentary hemodialysis service;

NOW THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG PANLUNGSOD OF THE CITY OF SAN FERNANDO, PAMPANGA, in Regular Session assembled that:

SECTION 1. TITLE - This Ordinance shall be known and cited as, "FERNANDINO DIALYSIS ORDINANCE OF THE CITY OF SAN FERNANDO, PAMPANGA"

SECTION 2. DECLARATION OF POLICY - It shall be the policy of the City Government of San Fernando, Pampanga to promote and safeguard the health and welfare of its citizens by institutionalizing sustained access to health programs and services for kidney health.

SECTION 3. SCOPE - This Ordinance shall cover all qualified beneficiaries certified by the City Health Office (CHO) and City Social Welfare and Development Office (CSWDO).

SECTION 4. DEFINITION OF TERMS - When used in this Code, the terms shall mean:

- 4.1. Dialysis Center refers to the site of the Fernandino Dialysis Center of the City of San of Fernando, Pampanga
- 4.2. Dialysis is the medical term for removing the waste and extra fluid from the blood that the kidneys can no longer remove themselves.
- 4.3. Professional Fee is an amount due to a medical specialist (nephrologist) contracted by the City Government of San Fernando, Pampanga to render medical
- services to dialysis patients. The amount is fixed and agreed upon by the contracting parties
- 4.4. New Dialyzer refers to the first use of a dialyzer in a hemodialysis process that is exclusively belonging to a patient;
- 4.5. Re-use Dialyzer refers to the repeated use of dialyzer (maximum of 9 uses) in a hemodialysis process by the patient owner.
- **4.6.** AICS a term which means Assistance to Individuals in Crisis Situation, a social safety net or a stop-gap mechanism to support the recovery of individuals and families from unexpected crisis such as illness or death of a family member, and other crisis situations.

SECTION 5. ESTABLISHMENT OF THE FERNANDINO DIALYSIS CENTER – The present administration under the leadership of its new Local Chief Executive Hon. Vilma B. Caluag has entered into a Memorandum of Agreement (MOA) with the Luzon Medical System (2nd Party Facility Provider) by virtue of Sangguniang Panlungsod Resolution No. 2022-018 dated August 1, 2022 for the establishment of the 25- Dialysis Machine Center. The Fernandino Dialysis Center is situated at the Civic Center, Barangay San Isidro, City of San Fernando, Pampanga. The partnership shall be eventually operated and managed under the PPP (Private – Public Partnership).

SECTION 6. SCREENING OF APPLICANTS - Dialysis patients in the City shall undergo the process of profiling, enlistment, assessment and enrolment to the program through the joint efforts of the City Mayor's Office- Community Affairs Division (CAD), City Health Office, (CHO) and City Social and Welfare Development Office (CSWDO). The dialysis session will be awarded to the qualified beneficiary once certified by the City Health Office and City Social Welfare and Development Office.

SECTION 7. RATES AND CHARGES - The rates and charges to be imposed in the operation of the Fernandino Dialysis Center are as follows:

C. PhilHealth dialysis package covers a total of PhP 4,000.00 per session. Any excess thereof shall be shouldered by the city.

D. Dialysis patients without PhilHealth shall be assisted by the City Health Office- PhilHealth Section to avail of the PhilHealth Point of Care (POC) Service.

E. In any case, bonafide Fernandinos who have already exhausted the limit of PhilHealth coverage equivalent to 90 sessions per year, may apply to avail of the 3,000 free sessions per year on top of the PhilHealth allowable coverage provided by the partner 2nd party provider or thru the Fernandino Dialysis Center-AICS unit shall assist patients in seeking medical and financial assistance and referral to partner hospital or other charitable institutions.

SECTION 8. UTILITIES - Building, water, and electricity will be provided and shouldered by the Local Government Unit of the City of San Fernando, while building maintenance, supplies, and other needed logistics will be provided by the 2nd party facility provider.

SECTION 9. REVENUES - All receipts and proceeds derived from the collection of Fees and other charges authorized in the preceding sections for the operation of the Fernandino Dialysis Center shall accrue to the General Fund of the City of San Fernando, Pampanga for which, such amount or amounts shall be used and appropriated exclusively for the purposes of the said Fernandino Dialysis Center.

SECTION 10. FUTURE EXPANSION PLANS - The City Government of San Fernando, Pampanga recognizes the need for the Fernandino Dialysis Center to grow and expand in order to provide improved and expanded services to its constituents. The City Government of San Fernando, Pampanga hereby authorizes the private-public partnership agreement to include provisions for future expansion of the Fernandino Dialysis Center. The 2nd Party Facility Provider shall submit a proposed plan for the expansion of the Fernandino Dialysis Center to the LGU for approval.

The City Government of San Fernando, Pampanga reserves the right to approve or reject the proposed plan for the expansion of the Fernandino Dialysis Center. In case of rejection, the 2nd Party Facility Provider shall submit an amended plan for approval. Once the plan for the expansion of the Fernandino Dialysis Center has been approved, the private-public partnership agreement shall be amended to include the provisions for the expansion.

The City Government of San Fernando, Pampanga shall provide the necessary funds to support the expansion of the Fernandino Dialysis Center. The 2nd Party Facility Provider shall also contribute resources, expertise, and services to deliver the expanded services or infrastructure. The City Government of San Fernando, Pampanga shall establish an oversight committee to monitor the implementation of the expansion plan. The committee shall be composed of representatives from the public and private sector partners.

SECTION 11. SEPARABILITY CLAUSE - If for any reason any part of provisions of this Ordinance shall be held unconstitutional or invalid, other parts or provisions thereof which are not affected thereby shall continue to be in full force and effect.

SECTION 12. REPEALING CLAUSE - All previous issuances, Ordinances, rules, and regulations or parts thereof which are inconsistent or in conflict with the provisions of this Ordinance are hereby repealed or modified accordingly.

SECTION 13. EFFECTIVITY CLAUSE – This Ordinance shall be effective upon the approval of the Sangguniang Panlungsod and shall take effect immediately upon satisfactory compliance of publication in a newspaper of general circulation in the Province of Pampanga and posting of the same in the City's conspicuous places, including the City's 35 barangays.
