## The farce is played out

"IT'S THE prerogative of the House."

Terse was the initial statement of former president and current Pampanga 2nd District Rep. Gloria Macapagal-Arroyo on her demotion from senior deputy speaker to simply deputy speaker last week.

Only to be followed by a longer statement that, among others, said:

"In the Philippines, the House leadership has traditionally been closely associated with the sitting President, and this relationship of deep trust between Speaker and President has been beneficial in smoothly enacting the legislative agenda of the President. I think this is acceptable, because in the Philippines, the check and balance needed in any democracy has traditionally been well-provided by the Senate.

"When President Marcos won, I wanted to aspire for the Speakership of the House. But it soon became apparent that he was most comfortable with then Congressman Martin as Speaker. I quickly realized the wisdom embedded in that sentiment.

"By this disavowal, I hope that we can preempt any needless politicking so that the House and our President can focus on the job at hand with minimum distraction."

Politicking. Distraction. The operative words unlost to House Speaker Martin G. Romualdez who, after days silence, issued his own statement, thus:

"There is still much work to do, so occasional moves to destabilize the House should be nipped in the bud.

"The House cannot be distracted from finding legislative solutions to issues that affect the lives of ordinary Filipinos. Rather than engaging in politicking, I would rather that we, in the House of Representatives, remain focused on more urgent matters.

"The House of the People is in order. This same level of order is what allowed us to approve on third and final reading at least 29 of the 42 bills that comprise the legislative agenda of President Ferdinand Marcos Jr.

"[The House] should prioritize the real problems of the ordinary people, the only thing that deserves attention. Let's set aside premature politicking."

Vice President Sara – without the H – Duterte took politicking to down the basest plane altogether in her resignation from the Lakas-CMD immediately after GMA's demotion: "I am here today because of the trust of the Filipino people in me to lead and serve them and the country, and this cannot be poisoned by political toxicity or undermined by execrable political powerplay."

Execrable toxicity. The plot thickens? More pop-

## Living La US Visa Loca

LAST WEEK I was with a friend whose application for a US tourist via was denied for the nth time. She was actually more surprised than saddened by this result in her latest attempt to fly to the fabled land of milk and honey.

Even prior to the pandemic, she was all over Asia and visited her relatives in Canada two times and even attended her niece's wedding in Australia. On top of these frequent foreign trips, her business has remained lucrative over the years, even surviving the pandemic. In a nutshell, she is the type of person who can really afford to travel the world. But for one reason or another her childhood dream to see the United States of America has remained elusive.

Whether it is a simple case of the stars not aligning in her favor, or the consular officer not fully convinced of her reasons for applying a US visa, I could only guess about my good friend's fate. Most of the time, the unexpected becomes the expected and the expected becomes the unexpected. People whom we consider to be shoo-ins for a US visa because of their wealth, education, and travel history are usually among the first to be denied of having one.

This leads me to share the story of another friend's mother who was in her late 50's when her daughter, who was about to give birth to her eldest child, asked her to apply for a US tourist visa. Her only reason for flying to the US was to look after her daughter and her first grandchild during that particular period in the first-time mother's life.

She went through the usual process, presented her documents and told the consular officer her reason in applying for a tourist visa. At one point during the interview, she was asked what her source of income was. To this, she proudly replied in her broken English, "Oh, my business? Me and my family, we are selling God!"

This must have floored the consular officer prompting him to ask a follow-up question: "So, you must be rich. What kind of god do you sell?"

Sensing that my town mate has cornered the consular officer in her field of expertise, she calmly said, "We are rich, but not very very. We sell many kinds of gods. We sell Sto. Nino god, Apung Nazareno god, Cristong Ari god, Apung Manaoag and all kinds of Mama Mary, we sell them all. We also sell angels in many size, color and style!"

The consular officer knew, based on the documents presented, that my town mate was referring to the family's chain of stores selling religious images and other items. He knew that the person in front of him was telling the truth and had no other reasons for going to the US than to be with her daughter and her grandchild. But he must have enjoyed the tête-à-tête fully that he opted to ask a final question: "What else do you sell aside from these many gods?"

To this, my town mate simply replied, "We also sell the body and blood of Christ!"

In case you missed what she meant by those, she was actually referring to the Mass wine and the pack of unconsecrated hosts which are staple offertory items during the Mass.

But you guess it right! The consular officer must have enjoyed his encounter with this street-smart lady from Macabebe so much so that he gave her a ten-year multiple US visa.

As for the many whose application is denied for a variety of reasons known only to the consular officers manning those dreaded windows at the US embassy, rejection is not a closure but most likely, a redirection. The USA is not the beall and end-all of your dreams. Similar or even better opportunities await you in other countries, or even right here in the Philippines. There are no dream jobs or dream lives waiting for all of us somewhere. We live our own dream jobs, we craft our own dream lives. It is high time we realize that there are things that are not simply meant to be. The United States is just one of the many countries in the world to visit and enjoy. If it is not ready to welcome and appreciate you, better set your sight on another destination.

## **Surgical politics**

In a brightly lit room, a future Cabinet member of a future president of the Philippines once likened a body politic to a human body. His analogy was his diagnosis of Philippine politics at the time. "You think our problem is politics?" he prodded a small group of opposition leaders facing an unprecedented, improbable opportunity: a snap presidential election in the time of a dictator.

"Our problem actually is renal," the future Cabinet member, a doctor, flatly declared, explaining how the grave illness was not only hurting the well-known patient but the country. Subsequent findings following the sudden flight of the dictator from power seemed to validate the doctor's observation. Renal problem was poisoning, one way or another, the political events in the country.

In much later times, the use of a drug for mental illness was often talked about as part of the medical menu of a top official, even as an insane war on drug that was estimated to have victimized, dead or alive, officially more than 6,000 individuals to as high as 30,000 people unofficially.

Who's behind the insanity? The question is at the heart of a pending investigation by the International Criminal Court (ICC). The ICC wants to look into it because the Philippine government is seen as unable and unwilling to do the tough task. Two top officials, President Bongbong Marcos and former President and now Congresswoman Gloria Macapagal Arroyo lead those who oppose the probe.

In recent days, the two figured in a new controversy involving surgical politics of some kind. Arroyo was suddenly removed as senior deputy speaker to deputy speaker. This unexpected transition was viewed as a clear demotion and a dimunition of power of the next-in -line to the speakership held by Congressman Martin Romualdez. Arroyo theorized that she was misconstrued of planning a coup to take away the speakership from Romualdez. She had met some congressmen in South Korea prior to her demotion. A rai in the group is suspected to have blown the convenient cover.

Whatever the reason was for her "demotion", Arroyo was ,no doubt, seen as a political threat to Speaker Romualdez. She could not be treated lightly. Sun Tzu's advice makes sense: know your enemy. Draw lesson from a cautionary tale: Pantaleon Alvarez versus Gloria Macapagal Arroyo. Besides, there will be a presidential race in 2028, and the first

cousin will not be qualified to run. Do the math, and surgical politics was necessary.

In medical parlance, surgery is a procedure to repair or remove a part of the body, sometimes a "growth', which usually involves cutting the body. It is a form of treatment. It entails some bleeding. It also involves pain.

PBMM has a more professional view of things, not of the scheme, which appears political as some saw it. Arroyo's case was not a demotion, or surgery, if you will, but the result of a regular process in any organization. It's a normal movement in any organization like the House of Representatives. Par for the course, they say in golf.

The Peter Principle of lateral arabesque is close to PBBM's takeaway. Politicians, like employees, rise to the level of incompetence or undesirability and have to be moved to positions where they are useful or, better, can do no harm. Sometimes, the issue really is super-competence or super-incompetence. It's takes no rocket science to correctly guess of which one Arroyo is guilty.

Whatever the semantics used in Arroyo's case, it must have been a big blow to her stature and ego. Once upon a time, when she ruled in Malacanang, she was told of a young, cavalier Pampanga businessman commenting unfavorably on an appointee. "Who is he to question my decision?", she was heard reacting

Only few a days before, PBBM had called her his "secret weapon" in his curated trips abroad, especially in his recent image-boosting state visit to the United States. She's was instrumental in making Sara Duterte run as his vice president, probably ensuring his overwhelming victory in the presidential race. "What is this dagger I see before me?", Macbeth asked. The vice president's subsequent break up from Arroyo's Lakas was predictable. There is more honor, it seemed, among thieves than among the so-called honorables.

In reality, there's such a thing as surgical politics, and

it works in a more favorable light. In Britain or Ireland, for instance, members of Parliament, have a series or one-onone meetings with their constituents to know what their needs or problems are. It's similar to a doctor having a confidential discussion with his patient about his medical problem and what needs to be done about. The political surgery makes them accountable, responsible and vulnerable.

In the Philippines, more surgical meetings are held by their lawmakers in their sweet time. This can be gleaned from their record attendance during sessions, not just the roll call. It also serves as the secretary' handy excuse whenever a constituent calls or pay visit to the lawmaker's office. It's either the boss has a meeting with his constituents in the province or is attending a session. It's been proven effective and cheaper.

As the House adjourned sine die, it was deemed both fitting and proper by everyone to see to it that the political hatchet is buried. Romualdez Arroyo's new replacement, Pampanga Congressman Aurelio Gonzales, Jr., staged a kiss-and-make up by both kissing Arroyo's hands in full view of their comrades and of the general public. Someone whose name meant praise, it was written, kissed his Master before he gave Him away for 30 pieces of silver.

All is fair, not necessarily forgotten or forgiven, in love, war and politics. At a glance, all is well that ends, announced a TV newscaster after seeing the de rigueur. Will Shylock demand for his pound of flesh?

It's too early to tell. There will be elections in 2025 and 2028. Political pundits say the spade work for both seasons has already started. The new senior deputy speaker may find his new title longer and more arduous, consistent with the Peter Principle. Looking forward, he may do a lot more spade work and deeper thinking. A big misstep made not too long ago may haunt him later. Hell hath no fury like a woman scorned. Or two. Power is the ultimate aphrodisiac, the now centenarian Henry Kissinger, once said.

AN ORDINANCE GRANTING A LOCAL FRANCHISE TO OPERATE *PAPUBBIT,* LOCATED AT ROBINSONS STARMILLS PAMPANGA, BARANGAY SAN JOSE, CITY OF SAN FERNANDO, PAMPANGA

#### **EXPLANATORY NOTE**

**WHEREAS**, the City Government of San Fernando, Pampanga has enacted Ordinance No. 2015-024, otherwise known as the Games and Amusement Code of the City of San Fernando, Pampanga subsequently amended by SP Ordinance No. 2019-008, to regulate and protect people going and employed in amusement centers, carnivals, fairs, resorts, amusement parks, cockpit arenas, internet cafes, e-bingo, games and the traditional bingo parlors, karaoke bars, among others;

**WHEREAS**, the PAPUPANDA Philippines Int'l Corporation whose trade name is PAPUBBIT is a business entity duly organized and existing under and by virtue of Philippine laws and one among the many business establishments covered by this aforementioned Ordinance;

**WHEREAS**, a certain Mr. David Lavarias Tan, president of PAPUPANDA Philippines Int'l Corporation, has submitted an application for the renewal of Local Franchise to operate and submitted a Lease Contract Agreement with the Robinsons Land Corporation, which was included in the Order of Business of the Sangguniang Panlungsod;

WHEREAS, the Sangguniang Barangay of San Jose, this city, passed Barangay Resolution No. 05, series of 2023 "interposing no objection to the operation of PAPUPANDA Philippines Int'l Corporation";

**WHEREAS**, the application was referred to the Committee on Entertainment, Games and Amusement which subsequently conducted a series of committee hearings and studies to determine the merit and purpose of the application to operate the above-named PAPUBBIT;

**WHEREAS**, the Sangguniang Panlungsod found the application meritorious and in order, thereby granting the applicant, Mr. David Lavarias Tan, the renewal of franchise to operate the said **PAPUBBIT**, renewable every three (3) years pursuant to SP Ordinance No. 2019-008;

**NOW THEREFORE, BE IT ORDAINED** by the Sangguniang Panlungsod of City Government of San Fernando, Pampanga, in session assembled, adopts as it hereby adopts the following Ordinance:

ARTICLE I

#### "AN ORDINANCE GRANTING A LOCAL FRANCHISE TO OPERATE PAPUBBIT, LOCATED AT ROBINSONS STARMILLS PAMPANGA, BARANGAY SAN JOSE, CITY OF SAN FERNANDO, PAMPANGA"

**Section 2. Definition of Terms –** As used in this Ordinance, the following terms shall mean:

- 2.1 Business refers to the trade or commercial activity regularly engaged in as a means of livelihood or with a view of profit;
- **2.2 Charges –** refers to a pecuniary liability, as rents or fees against persons or property;
- **2.3 Tax –** refers to an enforced contribution usually monetary in form, levied by the law-making body on person and property subject to its jurisdiction for the precise purpose of supporting governmental duties;
- **2.4 Fee –** means a charge fixed by law or ordinance for the regulation or inspection of a business or activity; it shall also include charges fixed by law or agency for the services of a public officer in the discharge of his official duties;
- **2.5 Franchise** is a right or privilege affected with public interest which is conferred upon private persons or corporations, under such terms and conditions as the government and political subdivisions may impose in the interests of the public welfare;

#### **ARTICLE II Authority to Operate**

**Section 1. Authority to Operate –** There is hereby granted to a certain Mr. David Lavarias Tan, the franchise to operate the said **PAPUBBIT**, located at Robinsons Starmills Pampanga, Barangay San Jose, this city;

**Section 2. Duration of the Authority to Operate –** The request for a local franchise to operate the said **PAPUBBIT**, herein granted to Mr. Tan shall be for three (3) years only, from the date of enactment up to December 2026, subject however to the option of Mr. Tan to renew thereafter.

#### **ARTICLE III Payment of Business Taxes**

**Section 1. Payment of Business, Fees and Charges –** Business Taxes, Fees and other charges shall be imposed and made payable yearly by Mr. Tan to the City Treasurer's Office during the lifetime of this Ordinance and its subsequent renewal.

#### **ARTICLE IV** INFECTION CONTROL PROTOCOLS FOR LEISURE ESTABLISHMENTS

**Section 1.** The said **PAPUBBIT** shall at all times adhere to the following Health Protocols:

- 1. Voluntary wearing of face masks in open spaces and non-crowded outdoor areas however, face masks shall continue to be worn in indoor private and public establishments;
- 2. Encourage physical distancing of 1- meter apart within the premises and at queuing areas;
- 3. Employees and customers are required to fill out an employee health declaration form or customer contact tracing form upon entry for contact tracing purposes;
- 4.Maximum number of customers shall be posted at the entrance and strict control of customer inflow shall be observed;
- 5. Separate entrance and exit points shall be implemented, and a queuing line outside the facility with physical distancing markers shall be installed;
- 6.Indoor air ventilation systems should conform with applicable protocols and standards.
- 7. Sanitation areas shall be installed in accessible locations;
- 8. Signages reminding customers to observe minimum health standards, and avoid risky behavior such as shouting and talking loudly shall be posted within the establishment;
- 9. Employees shall wear facemasks, and shall practice proper handwashing during their duty;
- 10.Company shall delegate at least 1 Safety Health Officer to:
- a.Monitor all staff through temperature checking, monitoring of covid symptoms and assessing mental health status daily;

- b.Report employee/s to City Epidemiology and Surveillance Unit (CESU) who develop covid symptoms or who tested covid positive.
- c.Report to TF WASH of LGU-CSFP for disinfection
- d.Remind employees to practice minimum public health standards
- e.Monitor regular cleaning of all contact surfaces such as doors, knobs, tables, windows, etc. at least every 2 hours; and
- 11. Regular daily sanitation/disinfection of the establishment should be done before and after the activity.

#### **ARTICLE V Penalty Clause**

- **Section 1. Penalty –** Failure on the part of Mr. Tan to comply with any or all provisions of this Ordinance shall be meted the following fines and penalties, over and above the penalties imposed by the Office of the City Treasurer of the City of San Fernando, Pampanga, to wit:
- **a.For First Offense –** Any person, natural or juridical, who violates this Ordinance for the first time shall be fined the amount of Three Thousand (=P=3,000.00) Pesos and a stern warning of revocation of the Business Permit to operate and or the imposition of the penalty of imprisonment for six (6) months;
- **b.For Second Offense -** Any person, natural or juridical, who violates this Ordinance for the second time shall be fined the amount of Five Thousand (=P=5,000.00) Pesos and the cancellation of the Business Permit to operate with the penalty of imprisonment of one (1) year; without prejudice to the filing of other criminal cases in violation of other existing national laws.

The officers of the juridical person such as the manager, operator/administrator or any person-in-charge of the management of the said PAPUBBIT located at Robinsons Starmills at Barangay San Jose, City of San Fernando, Pampanga, shall be directly responsible for its operation and shall be fined and penalized as that of the natural person.

#### **ARTICLE VI Miscellaneous Provisions**

- **Section 2. Repealing Clause –** Local Ordinance, Resolutions, Orders, Rules and Regulations and other issuances of the City Government of San Fernando, Pampanga that are inconsistent with this Ordinance are hereby repealed, amended and modified accordingly.
- **Section 3. Separability Clause –** If for any reasons, any section of this Ordinance, or any portion hereof, or the application of such section or provision, or portion hereof to any person, group or circumstance is declared invalid or unconstitutional, the remaining provisions of this Ordinance shall take its full force and effect.
- **Section 4. Effectivity –** This Ordinance shall take effect immediately after its approval, publication in a newspaper of general circulation in the Province of Pampanga and the posting of the same in the city's Bulletin Board and conspicuous places.
