NLEX PUTS UP MORE WEIGNDRIAGE STATIONS

MANILA – To help truckers comply with the anti-overloading policy of the government aimed at promoting motorist safety and prevent early deterioration of road caused by overloading, NLEX Corp. has put up more weighbridge stations for truckers entering NLEX, SC-TEX and NLEX Connector.

The tollway company is strictly enforcing the anti-overloading provisions of RA 8794 (An Act Imposing a Motor Vehicle Users Charge on Owners of all Types of Motor Vehicle and for Other Purposes). It is also implementing the 33-ton weight limit on the Candaba Viaduct southbound, as affirmed by the Department of Public Works and Highways and the Department of Transportation.

Modern commercial complex to rise in Hermosa

HERMOSA, BATAAN -- A modern commercial complex with three buildings will soon rise in 3,500 square meters of flat lands adjacent to the MacArthur Highway and Roman Superhighway in Barangay Culis here.

Mayor Antonio Joseph "Jopet" Inton and local investor/developer former Bataan Vice Gov. Ben Alonzo led the ground breaking Tuesday to signal the start of construction with target date of completion in one and a half years.

The architect and consultant to the project under the Alonzo family's 925 Plaza Development Corp. is Fedore Yap.

The structure will have at the center a 5-floor edifice sandwiched by two 2-storey buildings.

Inton explained that connectivity is the root of progress, connectivity through roads, through the business sector and officials of government. "Noong una pa lang, nag-drawing na ako noong bago ako tumak-

bo dinrawing ko na kung ano ang magiging itsura ng bayan natin. Dati hindi pa masigla ang komersyo dito wala pa yung Jollibee at ibang fastfoods.'

Now not only Jollibee but McDonalds, Chowking and 7-Eleven are doing business in the area.

'So, 'yun ang isang area of growth natin itong kasama ang Hermosa ecozone at palalakasin natin itong Culis - Palihan highway na ito isa yan. Ang isa pa ang upland area, magkakaroon tayo ng isa pang economic zone kaya number two engine of growth," the mayor said.

"Nandiyan na din ang first part Hermosa, yong second engine of growth bale dito sa Hermosa Central, hinati natin Hermosa upland then Hermosa Central. So dito sa Hermosa Central may dalawang engine of growth, ito ngang lugar ninyo at yong first part Hermosa na ginagawa na din ngayon," he continued.

"Siyempre hindi natin mabubuo ang plano ng Hermosa kung hindi natin maisasama ang upland, kaya sa tulong ng ating mga kaibigan, ginagawa na ngayon ang Hermosa Ecozone - Mabiga to Subic road para mai-connect na natin ang upland. Marami pang mangyayari sa upland na iyan dahil mayroon diyang dalawang Freeport Area of Bataan-approved location. Isa sa National Bookstore which is 300 hectares, and 1st Hermosa 100 hectares na third engine of growth ng bayan natin," Inton said.

The mayor expressed pride that a family from Hermosa, the Alonzo clan, invests in the town. With the example shown by the Alonzos, the more those from the outside will not be afraid of investing in Hermosa, he said.

Alonzo said they believed in the theme for progress of the Hermosa government of "Lipad Hermosa".

Nagkaroon ng SC-TEX, saan ka lalabas eh di sa bayan pa rin ng Hermosa." he noted.

"I was really impressed by the action of the mayor and I was gratified for it. Alam niyo, minsan isinama niya ko doon sa upland areas natin, ipinakita niya sakin kung ano ang economic development na nangyayari doon sa upper barangay natin at nakita ko kung ano ang sinasabi nating connectivity at naroroon ang connectivity na sinasabi na para doon sa patuloy na pag-unlad ng ating lalawigan, ng bayan ng Hermosa una sa lahat," Alonzo said.

The former vice governor said he foresaw the entry of more local investors in Hermosa.

Botolan LGU bares P55.36-M development projects

BOTOLAN, Zambales — A total of P55.36-milion worth of development projects are set for implementation this year under the 20% Development Fund from the Annual Internal Revenue Allotment (IRA) and the Local Disaster Risk Reduction and Management Fund (LDRRMF).

Mayor Jun Omar C. Ebdane said the projects include building various public facilities, road construction and repair, procurement of equipment and vehicles, flood-control and slope-protection, and purchase of emergency equipment and supplies.

"This year, we are going to continue with projects that will fasttrack development in the community and hasten improvement of the quality of life of our people," Ebdane said.

"In the last six months, we finished road construction at Barangay Paco, repair of the Korokoy Road from Barangay San Miguel to Barangay Danacbunga, and repair and improvement of classroom building at the Polytechnic College of Botolan. We will have more of these kinds this year," he added. Ebdane said his office, in consultation with other departments of the Botolan local government, has identified eight projects to be funded under the LDRRMF, with a total cost of P21.53 million. On the other hand, 19 projects will be implemented with funding from the 20% Development Fund for a total cost of P33.83 million.

set under the LDRRMF are the construction of an operations center for the municipal disaster risk reduction and management office at P3 million; Phase 1 construction of drainage canal and flood control/ slope protection works at Barangay Paco, P3 million; shore protection and rehabilitation along Barangays Bangan to Danacbunga, P2.5 million; and purchase of welfare goods, food supplies, and other necessities for disaster response at P6.46 million.

Under the 20% Development Fund, the biggest projects are the purchase of tractor for tourism operations at P3.5 million; mini-dump truck, P3 million; construction of parking area and landscaping at the Botolan People's Market, P3 million; construction of welcome/thank you arches at barangays Panan and Bancal, P4 million; and construction of additional facilities at Dr. Florentino Doble Memorial Hospital, P2.5 million. Ebdane said he expects the implementation of more development projects in the coming months with continued windfall from dredging operations at the mouth of the Bucao River here, which yields lahar sand sold mostly for reclamation projects in Manila Bay. "Last year, we received P30 million as municipal share from the dredging operations, and this helped us address our budget deficit. This year, we will get more shares from dredging and I hope that a good portion of this would be able to fund more development projects," Ebdane added.

'No-kill' animal shelter gets BAI accreditation

ANGELES CITY -- The Angeles City Dog Pound and Animal Shelter has been accredited by the **Bureau of Animal Industry** - a first in the city's history.

Mayor Carmelo "Pogi" Lazatin Jr. said the BAI certification will boost the city government's programs and services of putting premium on the lives and welfare of animals.

"With this, we will now be in charge of the strict monitoring of backyard pet breeders and their accreditation, the assurance of adequate care and shelter for the animals, and the avoidance of abuse, maltreatment, cruelty and exploitation of animals by humans," the mayor noted.

For her part, Lazatin's chief adviser IC Calaguas, an advocate of animal rights and welfare, said that with the certification all animals will receive appropriate standards of accommodation, feeding and general care, the prevention and treatment of disease and the assurance of freedom from fear, distress, harassment, and unnecessary discomfort and pain, and allowing animals to express normal behavior, which is what the law requires and what the city ensures.

"We value animals a lot, especially the stray pets that we rescue, take care of, and help find fur-ever homes." she said.

Alongside this development, the city government is encouraging Angeleños to adopt instead of shopping for pets, and give rescued animals their fur-ever family.

City veterinary OIC Dr. Christian Xyric Arcilla as-

sured the public that their office will conduct continuous monitoring activities to ensure that all animals are properly handled and cared for.

He also announced that the city will partner with different agencies in the conduct of animal welfare trainings to the city's 33 barangays.

Aside from the establishment of an animal pound, Angeles City is also offering free spaying and neutering to cats and dogs, giving free checkups and medicines, and conducting house-tohouse anti-rabies vaccination.

The Angeles City Dog Pound and Animal Shelter is the only "no-kill" animal pound in Pampanga and the second in Central Luzon which is operating with certification by the BAI. Angeles CIO

FOR THE RECORD, this is not an attempt to invalidate or downplay the mental health issues that confront today's youth. As a private school administrator for the past 21 years, I have been a witness to the varied struggles of our learners, including those that affect the state of their mental health. In fact, the numbers are definitely concerning.

According to the World Health Organization, 10-15% of Filipino children age 5 to 15 face mental health problems; while 16.8% of Filipino students age 13 to 17 have attempted to end their lives for at least once within the year before the conduct of the Global School-based Student Health Survey in 2015. On the other hand, the National Statistics Office says that mental health illnesses rank as the third most common form of morbidity among Filipinos.

But when I look back at my student days in the not-so-distant past, I couldn't help but wonder if our generation was simply made of harder stuff that although mental health issues were probably around during that time, we had a distinct way to face and overcome them. Either that, or we had a strong support system around us which prepared us to face a gamut of challenges that came our way.

In the absence of many gadgets to tinker with, we were out in the streets playing, or in the rice fields running and climbing trees. We walked our way to school under the heat of the sun, bathed under the rains, or jumped and swam in the rivers on our way home. The playmates we fought with over a game of marbles in the afternoon, are the same playmates we tag along and partner with the next day in a game of patintero or moro-moro against a group of boys from across the street, or our school mates from another grade level.

We run after each other in the school ground or right there in the middle of the streets; we stumble, we fall, we rise again and then run as fast as we can, unmindful of the scratch on our knees or on our elbows. No one goes to the class adviser or to a parent to complain about being "pushed" during horseplay. Everyone joins the fun and is ready to get hurt, all in the spirit of enjoying the games we have all been accustomed to.

We may not be equals in terms of our family's economic status, or our own intellectual capacities but outside of our own homes and the classrooms, we were simply a bunch of children and teenagers enjoying each other's company, exploring the world as we knew it, and leaning on each other for some form of support.

School work did not stress us at all; we had fun learning the basics and embraced the stern discipline we received from our teachers. We always looked forward to the afternoons tending the garden assigned to our class. The weekends served as a breather to be with our friends to play basketball in a makeshift court in someone's backyard, watch a rerun of some FPJ or Dolphy movies in a neighbor's TV set, or read the latest issues of Aliwan, Hiwaga and Love Story komiks being rented out by another neighbor.

We had our own share of failures, rejections, and family problems. Quite surprisingly, we never made a big deal out of all these. Whether we had a unique way of coping, or we were simply oblivious to all of these because we were enjoying our youth, I really do not know and I better leave it to the experts. But I just wish today's youth can learn a lesson or two from the generations that came before them especially the Batang '80s and '90s. I would like to believe that we were able to draw our strength from both the physical and social activities we enjoyed doing without any fear of judgment or rejection.

Undoubtedly, the Covid-19 pandemic has even worsened the already-problematic state of mental well-being of many Filipino youth. We are comforted by the thought that over the years, there has been an increasing awareness for mental health. Mental health issues are real; to deny their existence will be a great disservice to many who continue to suffer in silence.

AN ORDINANCE GRANTING A LOCAL FRANCHISE TO OPERATE ARSENIA'S PRIVATE RESORT, LOCATED AT BARANGAY SAN NICOLAS, CITY OF SAN FERNANDO, PAMPANGA

EXPLANATORY NOTE

WHEREAS, the City Government of San Fernando, Pampanga has enacted Ordinance No. 2015-024, otherwise known as the Games and Amusement Code of the City of San Fernando, Pampanga, and later amended by virtue of SP Ordinance No. 2019-008, to regulate and protect people going and employed in amusement centers, carnivals, fairs, resorts, amusement parks, cockpit arenas, internet cafes, e-bingo, games and the traditional bingo parlors, karaoke bars, among others;

WHEREAS, the **ARSENIA'S PRIVATE RESORT** is a business entity duly organized and existing under and by virtue of Philippine laws, and one among the many business establishments covered by this aforementioned Ordinance;

WHEREAS, a certain Ms. Jennifer A. Miranda, the attorney-in-fact of Ms. Janice N. Alcantara, the owner of Arsenia's Private Resort, has submitted an application for the Local Franchise to operate which was included in the Order of Business of the Sangguniang Panlungsod;

WHEREAS, the Sangguniang Barangay of San Nicolas, this city, passed Barangay Resolution No. 06-2023, "interposing no objection to the operation of Arsenia's Private Resort";

WHEREAS, the application was referred to the Committee on Entertainment, Games and Amusement which subsequently conducted a series of committee hearings and studies to determine the merit and purpose of the application to operate the above-named ARSENIA'S PRIVATE RESORT;

WHEREAS, the Sangguniang Panlungsod found the application meritorious and in order, thereby grants the applicant, Ms. Janice N. Alcantara, the renewal of franchise to operate the said ARSENIA'S PRIVATE RESORT, renewable every three (3) years pursuant to SP Ordinance No. 2019-008;

NOW THEREFORE, BE IT ORDAINED by the Sangguniang Panlungsod of City Government of San Fernando, Pampanga, in session assembled, adopts as it hereby adopts the following Ordinance:

ARTICLE I Title

Section 1. Title- This Ordinance shall be known as:

"AN ORDINANCE GRANTING A LOCAL FRANCHISE TO OPERATE ARSENIA'S PRIVATE RESORT, LOCATED AT BARANGAY SAN NICOLAS, CITY OF SAN FERNANDO, PAMPANGA". Section 2. Definition of Terms – As used in this Ordinance, the following terms shall mean:

2.1 Business – refers to the trade or commercial activity regularly engaged in as a means of livelihood or with a view of profit;

2.2 Charges – refers to a pecuniary liability, as rents or fees against persons or property;

2.3 Tax – refers to an enforced contribution usually monetary in form, levied by the law-making body on person and property subject to its jurisdiction for the precise purpose of supporting governmental duties;

2.4 Fee – means a charge fixed by law or ordinance for the regulation or inspection of a business or activity; it shall also include charges fixed by law or agency for the services of a public officer in the discharge of his official duties;

2.5 Franchise – is a right or privilege affected with public interest which is conferred upon private persons or corporations, under such terms and conditions as the government and political subdivisions may impose in the interests of the public welfare;

ARTICLE II Authority to Operate

Section 1. Authority to Operate – There is hereby granted to a certain Ms. Janice N. Alcantara, the franchise to operate the said **ARSENIA'S PRIVATE RESORT**, located at Barangay San Nicolas, this city;

Section 2. Duration of the Authority to Operate – The request for a local franchise to operate the said ARSENIA'S PRIVATE RESORT, herein granted to Ms. Alcantara shall be for three (3) years only, from the date of enactment up to December 2026, subject however to the option of Ms. Alcantara to renew thereafter.

ARTICLE III Payment of Business Taxes

Section 1. Payment of Business, Fees and Charges – Business Taxes, Fees and other charges shall be imposed and made payable yearly by Ms. Alcantara to the City Treasurer's Office during the lifetime of this Ordinance and its subsequent renewal.

ARTICLE IV INFECTION CONTROL PROTOCOLS FOR LEISURE ESTABLISHMENTS

Section 1. The said ARSENIA'S PRIVATE RESORT shall at all times adhere to the following Health Protocols:

1.Voluntary wearing of face masks in open spaces and non-crowded outdoor areas however, face masks shall continue to be worn in indoor private and public establishments;

2. Encourage physical distancing of 1- meter apart within the premises and at queuing areas;

3.Employees and customers are required to fill out an employee health declaration form or customer contact tracing form upon entry for contact tracing purposes;

4.Maximum number of customers shall be posted at the entrance and strict control of customer inflow shall be observed;

5.Separate entrance and exit points shall be implemented, and a queuing line outside the facility with physical distancing markers shall be installed;

6.Indoor air ventilation systems should conform with applicable protocols and standards.

7.Sanitation areas shall be installed in accessible locations;

8. Signages reminding customers to observe minimum health standards, and avoid risky behavior such as shouting and talking loudly shall be posted within the establishment;

9.Employees shall wear facemasks, and shall practice proper handwashing during their duty;

10.Company shall delegate at least 1 Safety Health Officer to:

a.Monitor all staff through temperature checking, monitoring of covid symptoms and assessing mental health status daily;

b.Report employee/s to City Epidemiology and Surveillance Unit (CESU) who develop covid symptoms or who tested covid positive.

c.Report to TF WASH of LGU-CSFP for disinfection

d.Remind employees to practice minimum public health standards

e.Monitor regular cleaning of all contact surfaces such as doors, knobs, tables, windows, etc. at least every 2 hours; and

11.Regular daily sanitation/disinfection of the establishment should be done before and after the activity.

ARTICLE V Penalty Clause

Section 1. Penalty – Failure on the part of Ms. Alcantara to comply with any or all provisions of this Ordinance shall be meted the following fines and penalties, over and above the penalties imposed by the Office of the City Treasurer of the City of San Fernando, Pampanga, to wit:

a.For First Offense – Any person, natural or juridical, who violates this Ordinance for the first time shall be fined the amount of Three Thousand (=P=3,000.00) Pesos and a stern warning of revocation of the Business Permit to operate and or the imposition of the penalty of imprisonment for six (6) months;

b.For Second Offense - Any person, natural or juridical, who violates this Ordinance for the second time shall be fined the amount of Five Thousand (=P=5,000.00) Pesos and the cancellation of the Business Permit to operate with the penalty of imprisonment of one (1) year; without prejudice to the filing of other criminal cases in violation of other existing national laws.

The officers of the juridical person such as the manager, operator/administrator or any person-in-charge of the management of the said ARSENIA'S PRIVATE RESORT located at Barangay San Nicolas, City of San Fernando, Pampanga, shall be directly responsible for its operation and shall be fined and penalized as that of the natural person.

ARTICLE VI Miscellaneous Provisions

Section 2. Repealing Clause – Local Ordinance, Resolutions, Orders, Rules and Regulations and other issuances of the City Government of San Fernando, Pampanga that are inconsistent with this Ordinance are hereby repealed, amended and modified accordingly.

Section 3. Separability Clause - If for any reasons, any section of this Ordinance, or any portion hereof, or the application of such section or provision, or portion hereof to any person, group or circumstance is declared invalid or unconstitutional, the remaining provisions of this Ordinance shall take its full force and effect.

Section 4. Effectivity Clause – This Ordinance shall take effect immediately after its approval, publication in a newspaper of general circulation in the Province of Pampanga and the posting of the same in the city's Bulletin Board and conspicuous places.

AN ORDINANCE GRANTING A ONE-TIME CASH INCENTIVE AMOUNTING TO TWENTY-FIVE THOUSAND PE-SOS (PHP 25,000.00) TO REGISTERED FERNANDINO SENIOR CITIZENS RESIDING IN THE CITY OF SAN FER-NANDO, PAMPANGA WHO ARE EIGHTY- FIVE (85) YEARS OLD AND WHO WILL REACH EIGHTY-FIVE (85) YEARS OLD, THEREAFTER ON THE EFFECTIVITY OF THIS ORDINANCE, PROVIDING FUNDS FOR ITS IMPLE-MENTATION AND FOR OTHER PURPOSES

EXPLANATORY NOTE

WHEREAS, Article XV, Section 4 of the 1987 Philippine Constitution states that, "The family has the duty to care for its *elderly* members but the State may also do so through just programs of social security";

WHEREAS, Article XIII, Section 11 of the same constitution states that, "The State shall adopt an integrated and comprehensive approach to health development which shall endeavor to make essential goods, health, and other social services available to all the people at affordable cost. There shall be a priority for the needs of the underprivileged, sick, elderly, disabled, women, and children. The State shall endeavor to provide free medical care to paupers.";
WHEREAS, pursuant to the objectives of Republic Act No. 9994, otherwise known as the Expanded Senior Citizens Act of 2010, the City of San Fernando, Pampanga, recognizes the invaluable contributions of its Senior Citizens to nation and community building, thereby, prioritizes the grant of benefits, privileges, and incentives to them;
WHEREAS, pursuant to the pertinent provisions of the Republic Act No. 7160 otherwise known as the Local Government and appropriate and appropriate. WHEREAS, Article XIII, Section 11 of the same constitution states that, "The State shall adopt an integrated and com-

ment Code of 1991, Local Government Units (LGUs) shall enact Ordinances, approve Resolutions, and appropriate funds for the general welfare of its inhabitants which shall ensure the delivery of basic services and facilities, senior citizens included;

WHEREAS, this Ordinance aims to honor the Senior Citizens of the City of San Fernando, Pampanga, recognizing their vital roles and contributions in nation-building, development, and progress of the City of San Fernando, Pampanga, through the grant of additional benefits as our way of reciprocating their contributions and reaffirming the long-time honored tradition of caring for our elderly, especially those reaching the age of 85 years old;

WHEREAS this particular age group of senior citizens no longer work because of their fragile state of health due to poor cognitive functions, visual and all hearing problems, and heart diseases, among other health issues prominent in their age group, thus, the grant of cash incentive is appropriate, in addition to their monthly pension which is insufficient for their rapidly increasing medical needs;

WHEREAS, as a tribute to the invaluable contribution to the City, the City of San Fernando champions the rights of the Fernandino elderlies as manifested in the various Ordinances and Resolutions enacted and passed affording them benefits and privileges;

NOW THEREFORE, BE IT ORDAINED by the Sangguniang Panlungsod of City Government of San Fernando, Pam-

panga, in session assembled, adopts as it hereby adopts the following Ordinance:

ARTICLE I General Provisions

Section 1. Title - This Ordinance shall be known and cited as the "CARE AND LOVE FOR FERNANDINO SENIOR CITIZENS ORDINANCE."

Section 2. Scope - This Ordinance shall find application to all senior citizens registered and residing in the City of San Fernando, Pampanga whose age is 85 years old who will reach 85 years old thereafter upon the approval of this Ordinance.

Section 3. Declaration of Policy - It is hereby the declared policy of the City of San Fernando, Pampanga to prioritize the inclusion of its senior citizens in the mainstream of the city considering their contributions to the community and development of the city, being the bedrock of humanity and civilization; pamper them, when possible, grant them financial assistance, provide for their medical needs when warranted by circumstances, and treasure them as family members. Ensure that this Ordinance is properly, effectively, and efficiently implemented to ensure that their well-being is prioritized by the City Government.

Section 4. Definition of Terms - As used in the Ordinance, the following terms shall mean:

4.1. Cash Incentive – refers to the amount to be awarded by the city to the senior citizen registered and residing in the City of San Fernando, Pampanga whose age is 85 years old.

4.2. Grant - refers to tax-free financial assistance given to qualified Senior Citizens by the Local Government Unit of the City of San Fernando, Pampanga who reached the age of 85 years old.

4.3. OSCA - refers to the Office of the Senior Citizens of the City of San Fernando, Pampanga.

4.4. OSCA ID - refers to the identification card issued for free by the City Government of San Fernando, Pampanga to its Senior Citizens.

4.5. Senior Citizen - refers to any resident/citizen of the City of San Fernando, Pampanga who is at least sixty (60) years old.

4.6. Registered/Qualified Fernandino Senior Citizen - refers to a senior citizen who has completed the process of registration with the City Government of San Fernando and presently residing in the city for 10 years.

4.7. Bonafide Senior Citizen - refers to a senior citizen who was born in the City of San Fernando, Pampanga, and presently residing in the city for at least five (5) years.

ARTICLE II The Cash Incentive and Requisites for Availment

Section 5. Cash Incentive - A one-time Cash incentive of P25,00.00 shall be granted to senior citizens who are 85 years of age upon the effectivity of this Ordinance and those who will reach 85 years old thereafter after conforming to Section 6 of this Ordinance.

Section 6. Requisites For Availment of the Grant/Incentive - A senior citizen who is a registered resident of the City of San Fernando, Pampanga whose age is 85 years old, (presently residing in the city for at least.

The grantee or his/her authorized representative shall provide the following documents within thirty (30) days from the 85th Birthday of the beneficiary:

- JUNE 03.

1.Certificate of Birth duly certified by the Local Civil Registry where the awardee was born and/or by the Philippine Statistics Authority (PSA);

2.Government-issued ID (preferably Senior Citizen's ID).

3.Barangay Resolution from the concerned Barangay that the grantee is presently residing in the city:

For Certified/Qualified Senior Citizen- at least ten (10) years.

For Bonafide Senior Citizen - at least five (5) years.

ARTICLE III Implementing Office

Section 7. Implementing Office - The Office of the City Mayor shall assign the Community Affairs Division (CAD) in coordination with the City Social Welfare and Development Office (CSWDO) to implement this Ordinance.

Section 8. Award Committee - There shall be an award Committee initially created and tasked by the Office of the

City Mayor to evaluate and validate proofs to determine the awardee's true and actual age and qualification. The award committee shall be composed of the following:

Chairman:

- City Mayor
- SP Member /Chairman of the Committee on Senior Citizens Affairs

Members:

- City Local Civil Registrar
- City Budget Officer
- City Treasurer
- CSWD Officer
- Community Affairs Division Chief
- Liga ng mga Barangay President

ARTICLE IV

Mode of Payment

Section 9. Mode of Payment – Upon the approval of this Ordinance, the cash incentive shall be given to qualified beneficiaries upon submission and satisfaction of the necessary requirements.

ARTICLE V Manner of Awarding

Section 10. Manner of Awarding of the Cash Incentive – The Office of the City Mayor through the Community Affairs Division Office (CAD) in coordination with the City Social Welfare and Development Office (CSWDO) shall assign a date for the awarding of the said incentive to all qualified and eligible beneficiaries.

In case of the absence of the beneficiaries during the awarding ceremonies, the nearest kin of the family are authorized to claim the incentive on behalf of the beneficiary.

ARTICLE VI Appropriations

Section 11. Appropriations - The funding required to effectively implement this Care and Love for Fernandino Senior Citizens Ordinance shall be appropriated annually in the General Fund of the City Government of the City of San Fernando, Pampanga.

ARTICLE VII Final Provisions

Section 12. Repealing Clause - All Executive Orders, Issuances, Rules and Regulations, or any part thereof, contrary to or inconsistent with this Ordinance are hereby repealed or modified accordingly.

Section 13. Separability Clause - If for any reason, any part or provision of this Ordinance shall be held unconstitutional or invalid by a court of competent jurisdiction, other parts or provisions hereof which are not affected thereby shall continue to in full force and effect.

Section 14. Effectivity Clause - This Ordinance shall take effect fifteen (15) days after its publication in a newspaper of general circulation in the Province of Pampanga, and posting of the same in conspicuous places of the City Hall of the City of San Fernando, Pampanga.

AN ORDINANCE ENACTING THE 2023 LOCAL INVESTMENT INCENTIVES CODE OF THE CITY OF SAN FER-NANDO, PAMPANGA

EXPLANATORY NOTE

WHEREAS, the Local Government Unit (LGU) of then Municipality of San Fernando, Pampanga through its Sangguniang Bayan has enacted its first Investment Code by virtue of SB Ordinance No. 199-010 on August 18, 1999 which was subsequently amended by SP Ordinance No. 2003-006 on April 9, 2003, specifically to promote a business friendly newly converted component city;

WHEREAS, the City Government of San Fernando, Pampanga, is the crossroads of economic development in the region and is gifted with a competent labor force and a bustling multifarious business with a deeply involved private sector partner in local governance is aptly capable of tapping and mobilizing more resources to improve its capability of rendering better socio-economic services to its constituents;

WHEREAS, a synergized executive-legislative branches of governance have committed to implement the long-ranged blueprint of development programs in the City Government of San Fernando, Pampanga vis-à-vis the generation and promotion of the business climate by granting investors better incentives when doing business in the city;

WHEREAS, by virtue of Executive Order No. 14, s. of 2009, the Honorable City Mayor of San Fernando, Pampanga has created a Technical Working Group composed of the City Officials and representatives from national agencies i.e., BOI, NEDA, DTI etc. and the business sector headed by the Pampanga Chamber of Commerce and the Multi-Sectoral Governance Council among others, to formulate the City's 2023 Investment Incentives Code;

WHEREAS, after the conduct of in-depth studies, research and series of brainstorming activities, a landmark legisla-

tion --- the 2023 Investment Incentives Code of the City of San Fernando, Pampanga was completed and presented to the Sangguniang Panlungsod for deliberation and appropriate action;

NOW THEREFORE, the Sangguniang Panlungsod of the City of San Fernando, Pampanga is session assembled,

ADOPTS as it hereby adopts the following Ordinance:

"AN ORDINANCE ENACTING THE 2023 LOCAL INVESTMENT INCENTIVES CODE OF THE CITY OF SAN FER-NANDO, PAMPANGA".

CHAPTER I TITLE, SCOPE & POLICY

Section I. Title - This Ordinance shall be known as the "The 2023 Investment Incentives Code of the City of San Fernando, Pampanga".

Section II. Scope - This Ordinance covers all kinds of investment categories existing and potential, within the territorial jurisdiction of the City of San Fernando, Pampanga.

Section III. Declaration Policy - It is the policy of the City Government of San Fernando, Pampanga to attract new investments, both local and foreign, keep and retain existing investments and to encourage their expansion by creating a business-friendly environment. It shall promote economic development and generate income for the people of the City of San Fernando, Pampanga. Along this line, the following are the City's investments objectives:

a. Encourage investments that optimize local human and physical and natural resources in the city within the context of sustainable and equitable development;

b. Ensure investment-friendly and responsive local governance that fosters free enterprise and private initiatives;

c. Provide a package of fiscal and non-fiscal incentives for investors in preferred investment areas;

d. Assist in the marketing of quality and affordable Fernandino products and services;

e. Promote the active participation of non-government organizations and the private sector as partners of the city government in achieving its development goals and objectives;

f. Spread the benefits of economic development to all the City's thirty-five (35) barangays, particularly in the growth and zonal areas as specified in the Comprehensive Land Use Plan of the City;

Section IV. Definition of Terms - As used in this Ordinance, the following terms shall mean: a. **Board –** the City of San Fernando Investment Incentives Board as enacted under this Ordinance;

b. **Business Tax –** refers to the tax on income computed from the capital investment for a new enterprise and amount of gross sales for existing enterprise;

c. **Office –** shall refer to the City Investment Promotion Division under the City Tourism and Investment Promotion Office (CTIPO-IPD), which is the office that serves as the technical secretariat of the board in all its Investment activities especially in formulation of policies;

d. **New Projects –** refers to a project/activity listed in the Investment Priority Areas that has not started commercial operations undertaken by: (i) a newly organized/formed enterprise; (ii) an existing enterprise that shall engage in an entirely distinct and different activity from its existing business operations; or (iii) an existing enterprise that shall engage on the same activity provided that it shall establish a new facility in an area not contiguous to the premises of its existing project and with new investments.

e. **Expansion Projects** – shall mean the installation of additional facilities and equipment that will result in increase in production capacity of the same product line within the same existing plant/facilities of the enterprise;

f. **Modernization Projects –** in general, modernization must result in any of the following (i) at least twenty five percent (25%) substantial reduction of production cost/cost of provision of the service; or (ii) upgrading of product or service quality or classification of the facility (e.g., hospitals, hotels, resorts) to a higher class or category;

g. **Capitalization –** the total project cost which includes buildings, machineries, equipment and working capital as per line of business; the cost of land is only included if it was acquired not more than two (2) years prior to the application;

h. **Registered Enterprise** – any individual, partnership, cooperative, corporation or other entity incorporated or organized and existing under Philippine laws, and registered with the Board in accordance with this code, provided however, that the term registered enterprise shall not include commercial banks, savings and mortgage banks, rural banks, savings and loan associations, building and loan associations, development banks, trust companies, investment banks, finance companies, brokers and dealers in securities, consumers' cooperatives and credit unions, and other business organizations whose principal purpose or principal source of income is to receive deposits, lend or borrow money, buy and sell or otherwise deal, trade or invest in common or preferred stocks, debentures, bonds or other marketable instruments generally recognized as securities, or discharge other similar intermediary, trust or fiduciary functions;

i. **Existing Enterprise** – an enterprise already operating in the City of San Fernando, Pampanga which has plans to diversify to other business ventures falling with the Investment Priority Areas as defined by the Board;

j. **Fiscal Incentives** – refer to discounts from payment of local business taxes;

k. **Non-fiscal Incentives** – refer to the services and assistance provided to investors by the Investment Board and other City government departments to facilitate a registered enterprise' operationalization and entry in the market;

I. **Labor Intensive Industry** – refers to the industry which requires at least 200 or more of human labor to produce the products; the proportion in which labor is used for the production is much higher compared to the proportion of capital;

m. **Comprehensive Land Use Plan (CLUP) –** which shall be the primary and dominant bases for the future use of land resources by the City;

n. Investment Priority Areas (IPAs) – the economic activities that the Board shall have declared as such;

o. **Expansion shall include Modernization and Rehabilitation –** increase of existing volume or value of production of upgrading the quality of the registered product or utilization of inefficient or idle equipment under such guidelines as the Board may adopt;

p. **Investment Priority Plan (IPP) –** the overall plan prepared by the Secretariat and approved by the Board, which includes and contains:

1. The specific activities and generic categories of economic activity wherein investments are to be encouraged and the corresponding products and commodities to be grown, processed or manufactured pursuant thereto for the domestic export market;

2. Specific public utilities can qualify for incentives under this Code and which shall be supported by studies of existing and prospective regional demands for the services of such public utilities in the light of the level and structure of income, production, trade, prices and relevant economic and technical factors of the regions as well as the existing facilities to produce such services;

3. Specific activities where the potential for utilization of indigenous non-petroleum-based fuels or sources of energy can be best promoted; and

4. Such other information, analyses, data, guidelines or criteria as the Board may deem appropriate.

q. Information and Communications Technology or (ICT) — the totality of electronic means to access, create, collect, store, process, receive, transmit, present and disseminate information;

r. **ICT Sector** — those engaged in providing goods and services primarily intended to fulfill or enable the function of information processing and communication by electronic means. The ICT sector includes telecommunications and broadcast information operators, ICT equipment manufacturers, multimedia content developers and providers, ICT solution providers, internet service providers, ICT training institutions, software developers and ICT-ES providers;

s. **ICT-Enabled Services "(ICT-ES)" Sector** — those engaged in providing services that require the intrinsic use of Id's including engineering or architectural design, informatics service providers, offshoring and outsourcing service providers such as call centers, back-office processing, software development, medical or legal transcription, animation, game development, and other services that require the intrinsic use of a networked information infrastructure.

CHAPTER II THE INVESTMENT INCENTIVES BOARD

Section 1. Investment Incentives Board – To ensure effective and efficient implementation of this Code, the Investment Incentives Board of the City of San Fernando, Pampanga shall continue to perform the duties, functions and responsibilities under this code.

Section 2. Composition of the Board – The Investment Incentives Board shall be composed of the following:

Member

Any head of office of the City Government of San Fernando may be called as a resource person of the board, especially in cases in which the specific investment pertains directly to the industry or sector within the jurisdiction of that office.

Section 3. Appointment of Alternate Representative – Members of the Board may recommend the appointment of alternate representative/s by submitting to the Chairperson the name and qualifications of the recommended alternate. The authorized Alternate Representative is entitled to all rights and privileges due to a member of the Board.

Section 4. Meetings and Quorum of the Board – The Board shall meet regularly at least on a quarterly basis to plan, assess and evaluate its programs, projects and activities. The Chairperson may call a special meeting of the board when he/she deems it necessary. The presence of at least a majority (50%+1) of its members constitutes a quorum.

Section 5. Manner of Voting – In all meetings, regular members of the Board or, in their absence, their alternates are

eligible to vote.

Section 6. Duties and Responsibilities of the Board – The Board shall be responsible for the regulation and promotion of investments in the City. It shall exercise its powers and perform its duties as follows:

- a. Formulate and approve policies governing the promotion of investments in the City;
- b. Formulate Investment Priority Areas (IPAs);
- c. Prescribe the rules governing the rules and restrictions of incentives;
- d. Approve or deny applications for registration with the Board, prescribing such terms and conditions as it may deem necessary to promote the objectives of this Code;
- e. After due hearing, decide controversies concerning the implementation of this Code within thirty (30) days after the same has been submitted for decision;
- f. Monitor and ensure compliance by the registered enterprise with the terms and conditions set forth in letter d and with the provisions of this Code;
- g. Ensure compliance by the registered enterprises to the provisions of this Code;
- h. After due notice and hearing by the Investment Board, cancel the registration or suspend the enjoyment of incentives of any registered enterprise and or require refund of incentives enjoyed by such enterprise including interests and fines under this Code; for (i) failure to maintain the qualifications required by this Code (ii) for violation of any provisions of this Code, including the terms and conditions of registration; Provided that the registration of an enterprise whose project timetable, as set by the Board is delayed by one (1) year, shall be considered automatically canceled unless otherwise reinstated as a registered enterprise by the Board;
- i. Formulate and implement rationalization programs for certain industries whose operation may result in dislocation, overcrowding or inefficient use of resources, thus, impeding economic growth. For this purpose, the Board may formulate appropriate guidelines in consultation with the relevant government agencies and the private sector, to implement the programs;
- j. Enter into agreements with other agencies of government for the simplification and facilitation of systems and procedures involved in the promotion of investments, monitoring of compliance of registered enterprises with terms and conditions set forth and with the provisions of this Code and other activities necessary for the effective implementation of this Code;
- k. To request necessary funding from the Sangguniang Panlungsod to support the operations of the Implementation of this Code;
- I. Promulgate such rules and regulations as may be necessary to implement the provisions of this Code;

Section 7. Powers and Functions of the Chairperson – The Chairperson of the Board shall have the following powers and functions:

- a. Accept the designated members (permanent and alternate) of the Investment Incentives Board;
- b. Preside over the regular and special meetings of the Board;
- c. Tender annual reports to the Board and such special reports as requested;
- d. Recommend to the Board such policies and support measures that may deemed necessary to carry out the objectives of this Ordinance; and
- e. Exercise such other powers and perform such other duties as may be authorized by the Board;

Section 8. Powers and Functions of the Vice-Chairperson – The Vice-Chairperson of the Board shall have the following powers and functions:

- a. To preside over the regular and special meetings of the Board in the absence of the Chairperson; and
- b. To perform such duties of the Chairperson in the absence of the latter, and such other duties as may be assigned to him/her by the Board.

Section 9. The City Tourism and Investment Promotion Office - Investment Promotion Division (CTIPO-IPD) – The Investment Promotion Division under the City Tourism and Investment Promotion Office shall act as the Technical Secretariat of the Board, and shall perform the following duties and responsibilities:

a. Accept, process, and evaluate, and act on the recommendations of the Board on all applications for registration on the grant of incentives under this Code;

b. Provide the necessary support services to investors as specified under the Code;

c. Establish and maintain networking relations with other offices and agencies whenever appropriate and necessary;

d. Collate, analyze and compile pertinent data and information, and conduct studies and stakeholder consultations concerning areas that have been or may be declared as IPAs by the Board;

e. Recommend to the Board any modifications or amendments to existing legislation and procedures on local investments;

f. Prepare agenda for meetings of the Board, and submit for the latter's consideration and approval of the policies and measures which are deemed necessary to carry out the provisions of this Code;

g. Render and submit annual/special reports to the Board or to the City Government of San Fernando, Pampanga relative to its activities relative to its activities and implementation of the Code within sixty (60) days after the close of each calendar year, or as may be requested;

h. Review and recommend the inclusion and removal of a certain IPAs that can directly affect the City's Local Econom-

ic Development or may result in favorable business climate, subject to the approval of the Board and the Sangguniang Panlungsod;

i. Report to the Board or to the City Mayor and to the Sangguniang Panlungsod matters affecting plans, programs and performance of the Office; and

j. Perform such other functions that are necessary and incidental for the effective implementation of this code.

Section 10. Honoraria - Honoraria shall be given to the members of Local Investment Incentive Board and Staff for their participation in the Local Investment Incentives Board Meeting. The following are the guidelines in the distribution of the Honoraria:

a. Board Members and Staff in attendance will receive an Honoraria amounting to PhP2,000.00 and PhP 1,000.00 respectively per meeting;

b. Alternate Representatives are entitled to the Honoraria of the member he or she represents.

Section 11. Funding – The amount necessary for the implementation of this Code shall be sourced from the concerned department of the City of San Fernando, Pampanga, and included in its Annual Investment Plan and Annual Appropriations.

CHAPTER III INVESTMENT PRIORITIES PLAN

Section 1. Investment Priorities Plan – The Board, after consultation with appropriate government agencies and the private sector, shall formulate and submit to the Sangguniang Panlungsod its Annual Investment Priorities Plan (AIPP) for approval.

Section 2. Criteria in determining the IPP – Economic activities that shall be included in the IPP must be environmentally, socio-economically, technically and financially sound after thorough evaluation and analysis by the Board. The determination of IPAs to be listed in the IPP shall be based mainly on the CLUP of the City, specifically on the following criteria:

- a. Long term comparative advantage;
- b. Economic soundness;
- c. Extent of contribution of the activity to the specific development goal; and
- d. Value of social objectives;

CHAPTER IV INVESTMENT PRIORITY AREAS

Section 1. Investment Priority Areas – Incentives, upon the approval of the application by the Board, shall be provided to new, expansion, diversification, and modernization projects of registered enterprises in the following areas:

A. Manufacturing and Industrial Estates

- Electronic Precision Assembly
- Food Processing (excluding beverages soft and hard drinks)
- Wearables and Homestyle including lantern making.
- Agriculture and Aquaculture Machineries and Implements
- Pharmaceuticals
- Ice Plants
- Information Technology Park Development

B. Services

- Health and Wellness
- Retirement Village
- Medical Tourism Services and Facilities
- - Sports complexes and centers
 - Cold Storage

C. Information and Communications Technology

• Companies and enterprises under the ICT Sector, which includes, but not limited to: telecommunications and broadcast information operators, ICT equipment manufacturers, multimedia content developers and providers, ICT solution providers, internet service providers, ICT training institutions, and software developers;

• Companies and enterprises providing ICT-Enable Services, such as, but not limited to: call centers, back-office processing, software development, medical or legal transcription, animation, game development, and other services that require the intrinsic use of a networked information infrastructure;

• Other ICT related businesses which are covered by the definition of ICT under this Code.

D. Creative Industries as defined in Republic Act No. 11904, otherwise known as the *"Philippine Creative Industries Development Act"*.

E. Agri-Business

- Post-harvest facilities
- Trading and Marketing Facilities
- High value crop production
- Organic Fertilizer Production
- Organic Agriculture Production
- Farm Tourism Sites and Attractions

F. Tourism and recreational facilities, such as, but not limited to:

- Resorts
- Theme parks
- Hotels and Accommodation Establishments
- Meetings, Incentives, Conventions and Exhibition facilities
- Novel and innovative facilities
- Ecotourism Sites and Attractions
- Adaptive re-use of Cultural heritage projects including local historical sites and properties, cultural properties and cultural treasures

G. Environment Management Facilities

- Material Recovery and Recycling Facilities
- Biodegradable Waste Processing Facilities
- Waste Water Treatment Facilities
- Waste to Energy Facilities

H. Transportation

- Mass Transport Facilities (such as Light Railway Transit, Bus Rapid Transit)
- Passenger Terminals
- Taxi Services

I. Any Business Enterprise that produces and develops renewable and sustainable energy; engages in the production, manufacturing and/or marketing or sale of equipment and hardware; and construction of facilities, buildings, commercial establishments and residences that will promote the use of sustainable energy.

J. New and Expanding Labor Intensive Business Enterprise, included as Investment Priority Areas (IPAs) under this code, with the capitalization of less than Thirty Million Pesos (PhP 30,000,000.00), and employing at least two hundred (200) employees of which 40% are Fernandinos; and

K. Green buildings, as certified by reputable third-party accreditation systems such as Philippine Green Building Initiatives, Leadership in Energy and Environmental Design (LEED), and the like, pending the City Government's initiatives on Green Building Accreditation.

Section 2. Determination of Additional Investment Priority Areas – In consultation with the national government agencies and the private sector, the Board may identify additional investment areas, for inclusion in the list of priority investment areas; and upon deliberation and approval, shall then be adopted for implementation under the City of San Fernando Investment Program, upon concurrence of the Sangguniang Panlungsod.

The following shall be the basis for the inclusion of the proposed investment areas:

- a. It must generate high level of employment;
- b. It must create linkages with local industries; and
- c. It must not have deleterious effect on the environment.

CHAPTER V APPROPRIATE INCENTIVES AND SUPPORT MEASURES

Section 1. Appropriate Incentives and Support Measures – The Board shall identify and recommend to the Sangguniang Panlungsod appropriate Fiscal and Non-fiscal Incentives and support measures which the City shall be willing to extend, in order to promote priority investment areas and activities to targeted investors.

Section 2. Removal or Deletion of Investment Priority Areas – With the concurrence of the Sangguniang Panlungsod, the Board may remove an area or activity from the list of Investment Priority Areas. Grounds for the removal of Investment Priority Area shall be as follows:

a. Sufficient investments in the area or activity have been attained;

b. The continued extension of incentives or support measure for the specific investment area is no longer to the interest of the city;

c. The investment area and activity cannot attract investors within reasonable time and cost or may result in unfavorable business climate.

CHAPTER VI INCENTIVES TO REGISTERED ENTERPRISES

Section 1. Fiscal Incentives Guaranteed by the City Government of San Fernando, Pampanga among registered enterprises – Under this Ordinance, all registered enterprises with the following capitalization shall be granted fiscal incentives in terms of business taxes, to wit:

Section 2. Commencement of Granting of Incentive – The computation of the period for the commencement of the approval of the incentives shall be reckoned from the first day of January of the year following the approval of the application; provided that the enterprise shall only be entitled with the incentives commensurate to the actual capitalization as cited in Section 1 of this Chapter.

Section 3. Non-Fiscal Incentives – In case the business falls within the category of the IPAs, the following non-fiscal incentives shall be added, such as:

- a. Site selection & regulation assistance;
- b. Assistance in the documentation procedure of exports;
- c. Labor Recruitment and Arbitration assistance;
- d. Coordination assistance with the concerned offices of the City Government;
- e. Other non-fiscal Incentives as may be determined by the Board.

CHAPTER VII REGISTRATION OF ENTERPRISES

Section 1. Qualifications of a New Enterprise – a new enterprise which intends to avail of the incentives provided for in this Code must satisfy the following qualifications, to wit:

a. The new business enterprise must be qualified to do business and must have complied with all the requirements mandated under existing local and national laws and the Constitution and through presentation of certificates of registration issued by the Securities and Exchange Commission (SEC), Department of Trade and Industry (DTI) or Cooperative Development Authority (CDA) and other national government regulating agencies, as the case may be;

b. The investment must be among the approved "Investment Priority Areas (IPAs)";

c. The investment must provide employment among bonafide residents of the City of San Fernando;

d. The new enterprise must have a capitalization of:

1.At least Thirty Million and One Pesos (PhP30,000,001.00) but not more than fifty Million Pesos (PhP50,000,000.00), in case of Small-Scale enterprises;

2.OverFiftyMillionandOnePesos(PhP50,000,001.00)butnotmorethanOneHundredMillionPesos(PhP100,000,000.00), in case of Medium-Scale enterprises;

3.More than One Hundred Million and One Pesos (PhP100,000,001.00), in case of Large-Scale enterprises; and

e. The new enterprise must provide direct employment in accordance with the requirements of Section 1(J) of Chapter IV of this Code.

For any enterprise which opened and operated a business and qualified for incentives under this code, and thereafter closes for any reason, and thereafter re-opened, the Board shall exercise utmost prudence in determining the motive or intent of its re-opening before it could be considered as a new enterprise.

Section 2. Qualifications of an Existing Enterprise – The following shall be the qualifications of an existing enterprise: a. It must have complied with all the requirements mandated by existing local and national laws;

b. The business falls under any of the activities under the investment priority areas;

c. It expands its existing facilities such as construction of new buildings, installation of new machineries and equipment or improvements thereof which will result in the increase in production;

d. It must have an additional investment of not less than Thirty Million Pesos and One Pesos (P30,000,001.00), per line of business which shall be the basis of the grant of incentives

Section 3. Application, Approval and Registration Procedure – All applications under this Code shall be filed with the Office, recorded in a registration book, and the date appearing therein and stamped on the application shall be considered the date of official acceptance. Applications shall be required to pay a one-time, non-refundable filing fee of;

Upon acceptance and approval, applicant shall also be required to acquire order of payment to the City Investment Promotion Office and pay to the City Treasurer's Office the non-refundable registration fee of 1/20 of 1% of the amount of investment.

Section 4. Certificate of Registration – The Office shall issue a Certificate of Registration duly approved by the Board and duly signed by the Chairman to the business concerned as registered enterprise duly stating the incentives and privileges granted under the provisions of this Code.

Section 5. Duties and Responsibilities of Registered Enterprises - Registered enterprises shall have duties and responsibilities such as but not limited to,

a. Corporate Social Responsibility (CSR) – Registered enterprises with projects under the pioneer status are encouraged to undertake CSR, to the extent possible, in accordance with the development plan of the community where the registered project is located. The CSR project within the city must be done during the availment period, on any of but not limited to Livelihood Development Projects, Environmental Protection and other Green Projects, Apprenticeship and Leadership Program, Health and Education Program, Social Infrastructure and basic services, and other programs in line with the development agenda of the city.

CHAPTER VIII FORFEITURE AND OTHER SANCTIONS

Section 1. Forfeiture and other Sanctions - After due notice and hearing, the Board may cancel the registration or suspend the enjoyment of incentives of any registered enterprise under this Code on the basis of the following:

a.Failure to maintain the qualifications required by this Code; or

b.Violation of any provisions of this Code, of the terms and conditions of registration;

of San Fernando, Pampanga during its 38th Regular Session held on April 24, 2023.

Provided, however, that if the registration of an enterprise whose project timetable, as set by the Board, is delayed by one (1) year, the grant of the benefits under this Code shall be considered automatically canceled, unless otherwise reinstated as a registered enterprise by the Board.

CHAPTER IX FINAL PROVISIONS

Section 1. Repealing Clause – All Local Ordinances, Resolutions, Orders, Rules and Regulations and other issuances of the City Government of San Fernando, Pampanga that are inconsistent with this Ordinance are hereby repealed, amended and modified accordingly.

Section 2. Separability Provision – If for any reasons, any section of this Ordinance, or any portion hereof, or the application of such section or provision, or portion thereof to any person, group or circumstance is declared invalid or unconstitutional, the remainder shall be in full force and effect.

Section 3. Effectivity Clause – This Ordinance shall take effect sixty (60) days after its approval and satisfaction of its required publication of three (3) consecutive issues in the newspaper of general circulation in the province of Pampanga and the posting of the same in the City's thirty-five (35) barangays and other conspicuous places in the City.

He highlighted the significance of establishing sufficient and reliable infrastructure to support key agricultural processes and empower marginalized farmers to optimize their harvests.

Pineda co-signed the MOA with DA-Region 3 director Crispulo Bautista. and PhilMech director Dionisio Alvindia. Standing as witness to the signing was board member Ananias Canlas, Jr. who is the chairman of the SP committee on agriculture.

The provincial government has allocated P238 million to cover site development, the construction of two warehouses, drainage systems, a 3-phase electrical system, office supplies, and various machines and equipment required for the complex.
