

SFELAPCO: Sept. power rate still at P10.50/kWh

CITY OF SAN FERNANDO – A welcome relief for the residents of the City of San Fernando and Floridablanca town in Pampanga: the power rates for September remains as those in August – at P10.50 per kilowatt-hour (kWh).

This, despite a slight uptick in power consumption following days of warmer weather, the San Fernando Electric Light and Power Company said.

Unlike in August, when the province experienced almost-daily rains, September brought fairly sunny weather to Pampanga and most of Central Luzon which led to increased electric consumption due to longer operations of air-conditioning units and additional human activities.

While increased consumption normally results to higher power rates, the prevailing prices somehow managed to absorb the additional electricity usage, resulting in the power rates remaining unchanged, said SFELAPCO, noting that at P10.50/kWh, its rate is among the lowest in Luzon.

The power distributor expressed its appreciation for this development, particularly considering the continuing increase in the prices of basic commodities.

Notwithstanding their business revolving around electricity, SFELAPCO emphasized that it does not mean they benefit from higher power rates. A significant portion of power rates are passon charges paid to power generators and transmission line operators. These are among the factors that hugely dictate power rate hikes.

Thus, even when distribution fees— which go to SFELAPCO remain the same, overall power rates may still go up.

SFELAPCO also emphasized that since the firm is temporarily buying from the Wholesale Electricity Spot Market, it is not safe from the volatility of market prices, that are driven by both local PAGE 7 PLEASE

AC's POC 100% functional

Thus, the Department of the Interior and Local Government graded the peace and order council (POC) of the city government here under the leadership of Mayor Carmelo "Pogi" Lazatin, Jr.

The DILG recently released the list of local government units in Central Luzon with functional POCs for 2022.

"We, in Angeles City, will continue to adhere to laws and policies undertaking peace and order," Lazatin said in response to the DILG rating, vowing to that his administration will continuously deliver programs to ensure the protection, safety, and welfare of his constituents.

In the DILG's 2022 POC performance audit, Angeles City garnered the following percentage points per pillar — Organization (10%); Meetings (20%); Policies, Plan, and Budget (25%); Reports (24.37%); General Supervision (20%); and two bonus points for Innovation. The Angeles City Police Office, upon the express order of the mayor, maintains 24/7 police visibility with the city government allotting a budget for the weekly gas allowance intended that purpose.

During Lazatin's inaugural speech, he vowed to maintain peace and order in the city by implementing the 24/7 911 hotline linked to the Angeles City Emergency Disaster Command Center to further minimize emergency response time.

The city has maintained

a low crime rate for the past four years of Lazatin's term, saying he wants to keep it that way.

DILG's assessment is annually conducted to evaluate the functionality of regional, provincial, city, and municipal peace and order councils.

The POC performance audit is "to acknowledge the innovations done by the councils and their secretariats, enhance their strategies and interventions and build an avenue to showcase their best practices." **Angeles CIO**

The floaters of September

They were eyeball to eyeball, historians recalled, and the other side blinked. It was October 1962 and the world stood on the brink of a possible war, even a nuclear conflict. The United States and the former Soviet Union were engaged in a test of will or nerve. The latter installed nuclear-armed missiles in Cuba, a 90-mile neighbor of the former.

US President John f. Kennedy would not be intimidated. He threatened to use military force,a naval blockade of Russians ships, to remove the ominous threat. Soviet Union President Nikita Kruschev balked but eventually agreed to remove the missiles after a long standoff. If the Americans would pledge not to invade Cuba in the future, the missiles will go. The US agreed and, in addition, also secretly removed its military base in Turkey.

The crisis was defused and the world was safe again.

Fast forward 61 years later in Asia. This September, in a mini version of the missile crisis, China installed a 300-meter rope of floaters or buoys in the West Philippine Sea to block Filipino fishermen from entering the Scarborough shoal, a traditional rich fishing ground. The shoal is part of 90 percent of the WPS or South China Sea which China claims to own under its fictional nine – dash line version, and lately a ten -dash line.

In 2016, the Arbitral Tribunal declared China's claim baseless and illegal. Instead, it awarded the Philippines' claim over it. China has since ignored the court's ruling, defied it, in fact by reclaiming parts of it and building military bases on them. It also continued an unbridledexpansive activities in the WPS. The placing of the string of floaters is the most recent, and a political dunk.

President Bongbong has vowed that not inch will be given away under his watch.He sounded loud and clear, despite China's aggressive tactics in the WPS. The water cannon firing at

US President John f. Kennedy would not be imidated. He threatened to use military force,a val blockade of Russians ships, to remove the ninous threat. Soviet Union President Niki-Kruschev balked but eventually agreed to motorized boats deputized by the Philippine government to continually resupply its Marine troops at an abandoned ship at Ayungin Shoal, another territory claimed by China, is part of the bullying in the sea.

China got what is was asking for.

All it took was a little bit more of courage than his predecessor, former President Duterte showed, or the lack of it, for President Bongbong to prove before the whole world that he meant business when he vowed the Philippine territory or its valid claim in the West Philippine Sea remain intact.

The President gave a more muscular and decisive order that a rope of floaters installed by China in the WPS be dismantled. The order was immediately executed without hassle by the Philippine Coast Guard. Chinese authorities have, in response warned the Philippines that it causing problems in the WPS by removing the barriers " without permission", from China..

The scuttling of the Chinese floaters also, once and for all, demolished the naïve argument by no less than Sen. Robin Padilla that China is not responsible for the escalation of conflict in the WPS. The neophyte senator has not responded to some calls that he resigns his post on account of his favorable comment on China's aggressive moves in the WPS. The latest word is that the actor-turned senator has issued a copout: everyone should shut up on the WPS dispute, except PBBM.

The effect of the two pandemic school years on the social and mental well-being of students cannot be underscored. It is something that will not simply go away just because we are now back to in-person learning modality.

For the past so many years, modern technology has prevented learners from engaging in physical activities that allow them to engage with real playmates in actual games and competitions. Gone are the days when the streets and vacant lots were teeming with students after class or during the weekends. Today, they are either in the computer shops for virtual online games, or busy with their own phones playing Mobile Legends while their playmates are located somewhere else. So now we have students who cringe at the slightest physical activity, citing exhaustion even after only a few minutes of actual work. They find themselves in a very unfamiliar territory when they face opponents in a real game or contest, not knowing how to handle and process defeat as part of any competition and as a learning process as well.

Students nowadays access information with a single click on the keyboard, prompting some experts to note that this might lead to the eventual demise of physical libraries. During our time we had to go to a library, scout all possible sources of information and if personal weekly allowance permits, have the materials photocopied. If not, note-taking is the key!

So, the question is, do we simply raise both hands as a sign of surrender and give up on our students? The answer of course, is a resounding PAGE 9 PLEASE Kundi ng totoo na mga pahayag ng mga 'columnist,' at mamamahayag upang itong 'readers' malaman ang dapat paniwalaan at mga tamang ulat.





FROM PAGE 1 The cases for violations of Section 3 (e and h) of RA 3019 (the Anti-Graft and Corrupt Practices Act), and the "Possession of Prohibited Interest by a Public Officer" from Article 216 of the Revised Penal Code were filed on Sept. 7 against Gonzales by Terrence Napao, barangay chairman of Santo Cristo and president of the Association of Barangay Chairmen of Mexico, Pampanga.

Charged along with Gonzales were members of his family: City of San Fernando councilor Aurelio Brenz, 3rd District board member Alyssa Michaela, Aurelio III, and Aurelio Michaline – all officers of the A.D. Gonzales Jr. Construction & Trading Co., Inc -- along with company director Zenaida Quiambao.

Also included in the charge sheet were Department of Public Works and Highways-Region 3 director Roseller Tolentino, chairman of the bids and awards committee (BAC) Ignacio Evangelista, BAC vice chairman Arthur Santos, and Anna Marie Tayag, BAC secretariat.

In his complaint, Napao alleged that Gonzales and the DPWH officials "conspired to corner" P611,577,718.40 worth of flood mitigating projects which were awarded to the construction company bearing the congressman's name and with business address adjacent to the residence of the deputy speaker in the capital city.

"These projects are glaring examples of 'conflict of interest in public service', and obviously manipulated to favor the family-owned business of Congressman Gonzales, a known super-rich contractor in the province and a powerful 'trapo' (traditional politician)," Napao said.

Copies of the complaint-affidavit distributed to media indicated that at least three civil works projects for the flood management program in Pampanga obtained from the congressional funds of Gonzales were awarded to the family-owned construction business.

Napao cited a general information sheet from the Securities and Exchange Commission allegedly naming Gonzales' immediate family members as either corporate shareholders, officers or directors of A.D. Gonzales Jr. Construction & Trading Co., Inc.

At its registration at the SEC in 1993, the congressman was listed as one of the company's incorporators owning 77% of the shares. Up until 2015, Gonzales sat as the company's president who held 25% shares, it was alleged.

"Any right-minded citizen would easily figure out why and how a senior deputy speaker, a city councilor and a bokal (provincial board member) owning a construction company and with DPWH officials under their beck and call were favored with hundreds of millions worth of government contracts." Napao alleged, adding "With huge projects such as these, it would be the height of naiveté not to sense a collusion between the congressman's company and the DPWH."

The infrastructure projects included the construction of drainage systems and flood mitigation structures and facilities within major river basins and principal rivers in the town of Mexico and at the City of San Fernando and Bacolor town sections of the province.

The complaint narrated that in awarding the projects, the DPWH regional office "evidently favored" the lawmaker's construction company "knowing fully well from the start of the bidding process that the corporation is owned by individuals holding public offices in a province where these projects will be implemented through countryside development funds sourced from taxpayers' money."

NLEX gives back...

Corrupt practices

Under Section 3 of RA 3019, "corrupt practices of public officers constitute (e) causing any undue injury to any party, including the Government, or giving any private party any unwarranted benefits, advantage or preference in the discharge of his official administrative or judicial functions through manifest partiality, evident bad faith or gross inexcusable negligence."

The same section provides that "corrupt practices of public officers constitute (h) directly or indirectly having financing or pecuniary interest in any business, contract or transaction in connection with which he intervenes or takes part in his official capacity, or in which he is prohibited by the Constitution or by any law from having interest."

Article 216 of the Revised Penal Code or the crime of Possession of Prohibited Interest by a Public Officer referred to a "public officer who directly or indirectly shall become interested in any contract or business in which it is his official duty to intervene."

There is no doubt, the policy under PBBM is no longer as sanguine, thankfully, as it used to be under the previous administration. Even giants understand the value of caution, like the US and Russia did during the Cuban missile crisis. China's next moves will be probably- hopefully= be done in the same manner. Raising the ante in the WPS or SCS can only lead to something more serious.

To be sure, China has not given up its long-time position that Taiwan is part of the mainland. Under President Xi Jinping, China's plan is to invade the tiny island in 1927 or thereabout. Taiwan, with the aid of the US, has taken notice. To be forwarned. is to be forearmed.

There are other things to consider. The US has increased the number of its bases in the Philippines. More are reportedly in the drawing board. Whether it's about Taiwan or about the WPS or SCS, China knows the implication of more US bases nearby. It's not just for deterrence; it's a threat as uncomfortable as the missiles in Cuba.

China's economy is in trouble a. And this, according to analysts, may impact its plan, present and future, in the region. The US has also expanded its alliance with oth-

These are the same realities that become the bedrock of the many education reforms we need to institute in our schools that include teaching strategies, intervention and remedial programs, relevant co-curricular activities that promote holistic formation and a dynamic er countries like Japan and Australia as countermeasure to China's hegemonic moves. On the other hand, some analysts, believe that China may not alter its plan under Xi, notwithstanding its economic problem or the growing US alliance.

Is China big enough and strong enough to start a war now against the West and win it? The Ukraine war is instructive. Russia, which is six times bigger, was expected to defeat its neighbor quickly when it invaded the neighbor last year. More than a year after it invaded Ukraine, Russia finds itself being at the receiving end of a counteroffensive that is closer to Kremlin than it has ever been. Ukraine is in it to win it. Thanks to the logistics and moral support of Ukraine's allies, the US and NATO countries, principally. For China, Ukraine should be a cautionary tale.

The David versus Goliath conflict is making smaller countries realistic now when faced with the existential challenge from bullies using mightis-right as a policy. Size is now relative. PBBM must have been emboldened by this new concept. His expanding alliance for a joint patrol arrangement in the WPS with the US, Japan and Australia makes practical sense.

In other words, it's a braver position to counter any Chinese aggressive move more effectively in the WPS.

the provincial government for the project. He stressed that the facility would not only serve as a disaster response hub but also as a venue for their youth programs.

"Malaking tulong itong ibinigay ni governor sa atin. Kumbaga nagpre-prepare tayo in case of disaster. So, dahil multipurpose siya nagagamit din natin siya sa ibang activities like mga programs natin sa kabataan – volleyball and basketball tournaments," he said.

The inauguration ceremony coincided with the opening of the women's inter-barangay volleyball competition which was also attended by the governor. To foster sports camaraderie among the youth, the governor personally provided financial assistance to all participating teams in the tournament. **Pampanga PIO** partnership between the school and the parents.

Perhaps one of the biggest challenges of Generation X and Y teachers in handling today's GenZ, iGen or Centennial learners is how to "speak their language" and "dance to their music." This is not merely knowing their lingo or appreciating their song choices. It is about putting themselves in their students' situation, listening attentively without any preconceived notion or biases and yes, without an iota of judging. From there, teachers might just be able to really know what the learners want and need from them, and even from their families.
