# CIAC eyes Clark as SEA's logistics hub

CLARK FREEPORT – "Our goal for Clark is to make it a logistics hub in Southeast Asia."

Thus, said Clark International Airport Corp. president-CEO Arrey A. Perez, citing seven flagship projects eyed to further develop Clark as the premiere global civil aviation logistics hub in Southeast Asia.

At the Balitaan at Talakayan forum of the Central Luzon Media Association-Pampanga Chapter held Monday at the CIAC corporate offices here, Perez named the seven projects as: New CRK Direct Access Link, National Food Terminal, Urban Renew-

al and Heritage Conservation Program, Entertainment and Events Hub, Expansion and Upgrading of Road Networks and Utilities, Detailed Site Development Plan of 2nd Runway, and New CIAC Headquarters.

"These seven will further bring on the A-Game for the development of the Clark Civil Aviation Complex," said Perez, noting that the complex encompassing 2,347 hectares is the biggest aviation-related development in the Philippines.

He clarified that of the seven flagship projects, top priority has been focused on three.

National Food Terminal.

To be sited in some 64 hectares of farm land near the Clark International Airport, the NFT is designed "to emerge as the Philippines' premium wholesale market and distribution hub for high-value and top-quality food products."

The "cutting-edge facility" shall provide a range of services from research and quality control, warehousing, and food processing to marketing and trading for both domestic and international markets.

At a projected cost of \$152 million, the NFT construction has a 2024-2026 timeline. The mode of implementation is joint venture private partnership.

# **Gawad Makabata conferred to Lazatin**

ANGELES CITY — The Regional Sub-Committee for the Welfare of Children (RSCWC)-Central Luzon conferred the Gawad Makabata (Local Chief Executive Category) to Mayor Carmelo "Pogi" Lazatin, Jr. during the 31st National Children's Month Regional Culminating Ceremony held on Nov. 22.

This is the second year in a row that the city government under Lazatin received the award for "substantial contributions in ensuring the children's right to survival, development, protection, and participation."

Since taking office in 2019, Lazatin has made the welfare of children as a priority program of the city government.

With his call that "No

Angeleño youth will be left behind in terms of education," the city government provided free school supplies and gear to all public school students and daycare learners in the city.

Lazatin also established the Kanlungan ng Kabataan Reformation Center, a P50-million project that aims to provide shelter and rehabilitation for homeless individuals and support youth in need of care and guidance. The center is a multifaceted facility encompassing the Bahay Pag-Asa, Sagip Batang Solvent Reformation Center, Home for the Girls, and temporary shelters for homeless families and mentally-challenged individuals.

The center will collaborate with the De-

partment of Education to provide an alternative learning system and enlist the assistance of TESDA for training programs.

In the 2022 Child-Friendly Local Governance Audit of the Department of the Interior and Local Government, the city also received the Seal of Child-Friendly Local Governance with a 92.46 rating.

# PN gets 2 more gunboats from Israel

CAVITE CITY – Two more fast attack interdiction craft (FAIC) platforms, also known as the Acero-class gunboats from Israel were received by the Philippine Navy at the Commodore East Posadas Wharf here on Nov. 18.

The platforms will begin the mandatory enhancement, maintenance, and training prior to commissioning them as PG906 and PG907 under the Acero-class patrol vessels of the Fleet's Littoral Combat Force and will begin.

The delivery is part of the FAIC Acquisition Project of the Revised AFP Modernization Program Horizon 2 contracted with Israel Shipyards which include a total of nine platforms, and the

transfer of technology to bolster the PN's shipbuilding capability.

"It marks another milestone in the Fleet's resolve of reinforcing the country's littoral/coastal defense with modern fast patrol combat vessels that have proven to be highly reliable in addressing current and emerging threats, and transnational crimes," the PN said in a statement.



# Biz leader appeals for safety, access in CSF road rehab

CITY OF SAN FERNAN-DO – Business leader Renato G. Romero recently appealed to the Department of Public Works and Highways to implement public safety measures and provide access to businesses affected by the P225-million road rehabilitation work along the Dolores section of the MacArthur Highway here.

While thankful to the DPWH and the City Government of San Fernando for the project that would replace asphalt finish of the road with cement block underneath, Romero nonetheless requested the government to consider the urgent concerns of the motorists and affected establishments.

"I remember that our request was for the improvement and rehabilitation from Juliana to JBL Hospital and all the way to the intersection near St. Jude Village. I am happy that it has been granted," he said.

However, he urged the DPWH to strictly monitor contractors of road projects and at the same time consider businesses that are affected by civil works. For the Dolores project, the winning bidder is Royal Crown Monarch Construction and Supplies Corp.

"Nothing could be more important than the safety of motorists and pedestrians. This is why there is this 'Safety First' mantra in any other construction project," he said.

The DPWH, he said, must strictly impose construction safety measures. He proposes to adopt international standards like use of orange barriers, rope lights, and lighted directional and warning signs.

"Aside from conforming to international standards, warning signs, barriers and lights during the night must be adequate," he said, noting that in some construction projects, contractors place only plastic straw, yellow "do not cross" tapes that are inadequate to ward off pedestrians and vehicles.

He also pointed out that proper advisory must be made by the DPWH and the contractors, mounting the so-called Project Information Boards (PIB) that are mandated by law.

The boards contain details like project duration, winning contractor, amount of project and time table.

"The PIBs are important for transparency and accountability. And there is a mandated size for these. The Dolores section project has no billboard. That should have been put up prior to the actual construction works," Romero said.

A pillar of the Pampanga Chamber of Commerce and Industry, Romero also appealed to DPWH and host LGUs to always consider business and local traders so as not to affect their operations.

"Road construction in some areas takes about 20 days at the very least for excavation, cement laying and curing. These periods can lead to loss of revenues. Let us remember that the businesses pay taxes that we use for government projects and infrastructure. Thus, the government must be more considerate and draw an implementation plan that would have minimal impact on the business operations," he said.

# Japanese industrial park to double dividends for SBMA

SUBIC BAY FREEPORT – Japanese developer partners at the Subic Techno Park (STEP) have agreed to double the dividend payments for the Subic Bay Metropolitan Authority which will amount to almost \$1 million.

SBMA chairman and aministrator Jonathan D. Tan said the consen-

sus came about during a STEP board meeting held in Tokyo, Japan on Nov. 17. STEP is a joint venture agreement between the SBMA, Japan International Development Organization (JAIDO) and Toyo Construction Co. Ltd. (TOYO) that was executed in April 1996. The JVA was executed for the planning, development, construction, operation and

maintenance of STEP's 74-hectare industrial estate inside the Subic Bay Freeport Zone.

As agreed in the JVA, SBMA will maintain the 49.97% share equity and Japanese developers led by STEP president Ichiro Tsuji and his associates will have 50.03% equity.





# 'My congressman, my mayor'

2O25 DAWNED early on Nov. 16 in Angeles City and the rest of the 1st District of Pampanga.

At the mass oath-taking ceremony for the city's elected barangay and SK officials held in Royce Hotel and Casino, Clark Freeport, the perfunctory swearing into office evolved into a virtual proclamation rally with inducting officer Pampanga Vice Gov. Lilia "Nanay" Pineda declaring the adoption, indeed possession as her very own, of Mayor Carmelo "Pogi" Lazatin Jr. and Congressman Carmelo "Jon" Lazatin II.

"My congressman," Nanay addressed Pogi. "My mayor," she called Jon. The stress on the first person singular possessive pronoun for unmistakable emphasis.

Long out in the open in the city and the district is that the Lazatin siblings will switch elective positions in 2025, with Jon already into his third and last term at the House.

"Magaling ya pu y Mayor Pogi. Magaling yang magaling, pero atin pa mu rin metung a the best at kailangan mu namang maging mayor na ning Angeles - my mayor, Jonjon Lazatin," enthused Nanay, with a beaming, applauding, approving Gov. Dennis "Delta" Pineda standing by her side.

Indeed, no opening salvo in any local political campaign in recent memory could measure up to the tumultuous applause that greeted the vice governor's declaration.

"Kailangan ku pa pung mangampanya king Angeles?" The din of the cheering rendered Nanay's query into a rhetorical question.

The high-profile presence at the event of Magalang Mayor Malou Lacson and Mabalacat City Mayor Cris Garbo, the other two LGUs that comprise Pampanga's first congressional district, made a strong affirmation of Nanay's declaration.

Taking the cue from the vice governor on the need of Angeles City for a more equitable take of the gross income earned (GIE) shared among LGUs contiguous to the Clark Freeport currently enjoyed most by Mabalacat City, Garbo proffered a service vehicle for each of the 33 barangays.

The thunderous huzzahs that met Garbo's announcement reverberated across the whole expanse of Royce Hotel and Casino.

### The Parable of the Trustees

MULA NANG naging bishop ako, I have been invited to become a BOT (board of trustees) member of so many corporations and foundations. These entities have a legal personality to own resources, both solid and liquid assets according to Philippine laws. Most of them are nonstock, nonprofit. Ibig sabihin, if they generate any income, it is not meant to benefit any of the board members. Hindi kami stockholders who will enjoy shares of dividends from the corporation's net income, which are called "profits." Bakit? Kasi hindi naman kami owners or shareholders. We are TRUSTEES. The assets may have been transferred to the corporation by individuals or families who established the foundation and intended it as a lasting legacy—to continue its vision and mission through its programs and projects.

Sa Tagalog, the best equivalent word is KA-TIWALA, from the root word TIWALA, meaning trust. It is a relational word. Ganyan sa Tagalog basta nilagyan ng KA (kapatid, kaibigan, katrabaho, kakilala, kabaro, kalaro, etc.) relational iyan. Sa KATIWALA, may nagtitiwala at may pinagtitiwalaan. The tiwala (trust) is what matters. The resources entrusted are really just a token of that trust; the more important thing is the relationship.

Our Gospel today is often entitled "The Parable of the Talents." Hindi ko type, kasi masyadong focused sa assets na para bang walang pinagkaiba sa pinahiram ng pera na sinisingil pagkatapos na may interest. No. I'd rather entitle it "The Parable of the Trustees." They were chosen by the master because they enjoyed his trust. Probably because he had worked for some time with them and known them enough to entrust his assets to them. Why do we say so? Because the writer says the master entrusted different amounts to them: five to the first, two to the second and one to the third, and adds "TO EACH ACCORDING TO HIS ABILITY."

When he comes back, he evaluates their performance, and the ones who prove trustworthy are entrusted with GREATER RESPONSIBILI-TIES. (They are not rewarded with money but with greater trust.). They are actually three but we group them only into two: the ones who proved themselves to be truly trustworthy, and the one who broke his trust.

Like I said earlier, trust is a relational word; it is founded on a relationship. Therefore, it works both ways. It's not just the master who's investing his trust on his stewards, the stewards were also being invited to trust their master—his wisdom and intentions. Before the master's trust was broken by the third steward, that steward's trust had been broken first. What broke that steward's trust? I propose two things: one, what he heard people say about his master—which poisoned his attitude and made him say to himself, "What's the point in working for this master? He will only use me to enrich himself."

Secondly, his trust is also destroyed by his own envy and insecurity. He probably said to himself, "Why only one for me? Why does he trust me less than the other two?" He did not trust the master's reason. He just made up his mind that the master was unfair. This applies very well to people in this world who already have enough resources but are still not happy because they compare themselves with those who seem to have more and end up feeling sorry for themselves and asking: "Why do others have more and I have less?" And yet, I have also met a lot people who are poor, or who have much less in life but grateful for what they have and are able to maximize whatever little they have. (I count the David family that grew up in the Bale Pinaud among them.)

In the Gospel, the amounts of money entrusted don't really matter much to the master whether 5, 2, or 1. What matters most is that all three are trusted. In the end, however, only the first two proved themselves trustworthy. They both made the most if what had been entrusted to them. They both became the best version of

(I hope you see why this makes me think of us 13 children of our parents who all grew up with very meager resources. How different each one of us was as a person—in terms of gifts, looks, intelligence, personality, but how we were guided by our parents to consider ourselves blessed, never to envy others or try too hard to prove ourselves to be better than anyone but to aspire only to be the best version of ourselves. I hope you take time to read our stories in the book which we are launching later today, the "Bale Pinaud".)

The Church has given a name to this important principle of Christian discipleship: stewardship. They have been laid out beautifully in that pastoral letter written by the US Conference of Catholic Bishops in 2003, "Stewardship: A Disciple's Response." That letter could be summarized into one sentence: "As Christian stewards, we receive God's gifts gratefully, cultivate them responsibly, share them lovingly in justice with others, and return them with increase to the Lord."

They are the four very basic principles of stewardship, which you can take home with you: 1) to develop a sense if grace or to receive God's gifts with gratitude, 2) to cultivate them responsibly, 3) to develop a sense of justice by sharing them generously with others (especially those who have less), 4) to return them to the giver with increase.

# **Game-changer**

The tantalizing notion that a free Leila de Lima will turbocharge the political opposition may be too much . Although it's still on the realm of possibility , she's nonetheless shaping reality or perception. People may start liking the chances that the future will be better than good. After all, her freedom, although not yet full, already rises to the level not just of individual but collective thanksgiving. The former senator is free and it is a shared one.

Truth, indeed, can set people free or run away with wild imagination. The more truth is told or shared, the more it changes people's lives. Community is best defined in that sense. Or nationhood. Seven more prisoners are telling the nation and the whole world they told lies about the senator because they were told so under duress. It will encourage others to tell the truth about other things. Who knows how much, indeed, we don't know?

Leila de Lima, former senator and former secretary of justice, thrown behind bars for nearly seven years on the strength of lies has already made a huge difference in people's lives, not just some prisoners's, and she's just starting. She's got a long way to go.

"In a time of deceit," George Orwell wrote, 'telling the truth can be a revolutionary act.

But first things first. De Lima has to seek justice first, a time of reckoning for those who started those lies that built that prison. There is a former president and a former justice secretary who should be made accountable. There is a bigger truth out there that need to be told. It concerns the lives of more than 30,000 or affects more 100 million. There is a crime against humanity crying out to be exposed. She has said she will help in ferreting out the truth.

And people are becoming braver. There's a changing tune. Some lawmakers want a resolution passed allowing the International Criminal Court to pursue an investigation of a former president who was also behind the lies that then

imprisoned a former senator. There are hints the ICC may, after all, be allowed to do its job. The former senator may be able to make the difference. The government categorically said so.

There was a time when a former president led her fellow politicians in calling to ban the ICC. Power can be tricky and illusory. The former president has no longer the former power and influence she used to yield over other power-seekers. The order has been changed, albeit even reversed. The call of the times may no longer be the same. The call for truth rather than lies is more resonant than before.

De Lima feels it. On social media, she's egged on to pursue the enablers of lies in the corridors of power. There's an election coming in 2025. It's an opportunity for truth to be told, not just for personal but collective reason. The nation needs to know and make up its mind about a certain future built around the truth. It's not just about politics but about justice and the truth that can set people free.

"When I despair,' said Mahatma Gandhi," I remember that all through history the way of truth and love had always won. There have been tyrant and murderers and for a time they can be invincible but in the end they always fall." "They always will", he said

But first thing first. De Lima must be reminded, constantly, of the half-naked fakir who understood the truth and lived it. Justice must come first. Right now, there are distractions on the hori-

# The kind-hearted but forever clueless Bida

MY PREVIOUS article on the "primera contravida" prompted many of my friends to request a piece on the "bidas." According to them, the leading antagonists took the limelight last time, so it is but proper for their counterparts to take center stage as well.

What is highly noticeable among the protagonists in many Filipino movies and telenovelas is that they are always initially depicted as a bunch of weak individuals who are either uneducated or misinformed about the laws that protect them, or are simply afraid to stand up for their rights. As if their current misfortunes were not enough for their already miserable life, they are always at the receiving end of the contravida's evil schemes.

It is only after experiencing unimaginable misfortunes that they begin to chart their own future and craft a winner-takes-all revenge plan. Along the way, they get to meet a Good Samaritan or two. Like our protagonists, these angels went through the same oppression and are therefore more than willing to join in the fray, no matter the danger and the costs are, for as long they witness the ultimate downfall of the "primera contravida."
