Kapampangan chefs and even Aeta cooks whipped out popular Kapampangan and native dishes and followed authentic culinary procedures without embellishing them. The famous "sisig" presented in its purest form, said 2nd District board member Mylyn Pineda-Cayabyab, festival chair.

She urged Kapampangans and non-Kapampangans to visit the festival booths at SM City Pampanga featuring "all Kapampangan delectable delights" until Dec. 6. On Dec. 6, also at the Capitol grounds, the second cook-off will be held, this time for the "Best Kapampangan Heirloom/ Iconic Dishes."

Through the same eucharist which we celebrated with them on this Day of

We hope that the statement issued by the Mindanao State University can still touch the consciences of the perpetrators. It says, "Violence has no place in a civilized society, and it is particularly abhorrent in an institution of higher learning like MSU, a bulwark of peace, harmony, solidarity, reverence for life and humanity. This attack is an assault on our core values and our commitment to creating a safe and inclusive community for all." We could not agree more. With them we reaffirm our unrelenting commitment to peace and our repudiation of violence.

We pray for the eternal repose of those who have died, and for the healing of those who have been injured. We unite ourselves spiritually with their families and draw strength and consolation from our faith in Christ who will "restore all things to himself, making peace by the blood of his cross..." # Of break-ups and goodbyes

TO SAY that the Kath-Niel breakup took the Philippines by storm would probably be an understatement. The story took center stage in the country's leading newspapers, became the number one trending topic in all social media platforms and merited more-than-the-usual coverage on primitive television news.

The bitter ending in the eleven-year romance even eclipsed news stories of national interest and global impact. For days, many Filipinos found themselves glued to the juicy details behind the highly-publicized love story. Knowing our penchant for such drama, this would probably continue for the months or even years to come.

More than knowing the real reason behind the break-up, what I find really interesting is the way people have been reacting to the story. The manner by which people are taking their sides, putting the blame on some assumed third-party and even investing so much of themselves into this showbiz saga is, to my honest belief, a reflection of their own personal values and priorities.

Let us take the case of the solidly loyal and highly-affected Kath-Niel fans who immediately turned their collective rage on the two girls who are supposedly the reason for the break-up. Without even an ounce of veracity on their side, they were quick to blame and bash these girls. Who knows, the two were probably made to believe, convinced or even sweet-talked by Daniel that the relationship has already ended and that he was already free to move on with his life.

Second, those who were loyal to Daniel including some of his family members, defended him by claiming Kathryn was too-focused on her career, choosing to accept more projects than to spend quality time with her boyfriend. Why even the so-called "Pinoy machos" joined in the discussion saying such indiscretion was "normal" for men and that these two-timing men would still come home to their "originals" anyway, so why make a big fuzz over a onenight stand?

In the midst of all these speculations, only a handful questioned Daniel's loyalty. Some resorted to slut-shaming the two girls who are supposedly the cause of the breakup, while others criticized Kathryn for being too-career oriented. Call me an honorary feminist but I think this archetypal viewpoint of justifying male chauvinism puts us several steps back to the Dark Ages. If it takes two to tango; then there is no reason to exonerate one and convict the other.

A good friend of mine who has been based in the US for the longest time commented in our group chat that in the Philippine showbiz industry, it is highly common to "build" a love team to be able to sustain the fans' interest and loyalty. This is a tried-and-tested formula from Gloria-Juancho, and Nestor-Nida in the 60s; Guy-Pip and Vilma-Bobot in the 70s; Sharon-Gabby, Maricel-William, Snooky-Albert and Pops-Martin in the 80s; and today's power love teams as "created" by leading television studios and film companies. The more successful the love teams become in terms of box-office hits and multiple endorsements, the more difficult it is for any of the duo to break away from this team and build a name and a career as a solo artist. While there have been many artists who were successful in moving out of the shadow of their onscreen partners, many lost their careers when their love teams ended.

Of all the memes that followed after both Kathryn and Daniel confirmed the breakup, one stood out - "Mabuti pa ang KathNiel umabot ng 11 years pero ang P125M, 11 days lang." Don't you just love how Filipinos can be creative to find humor in almost anything in life? This one hits the spot if only for its powerful message to remind us that there are more pressing concerns in our society than the Kath-Niel break-up.

Can you just imagine how things would turn out differently in our country if the millions of Kath-Niel fans and followers would be as engrossed and invested as they have been for eleven years in demanding for accountability and transparency from our elected government officials? Eleven years of following every movie, TV show, guesting, mall tour, concert and even news article of their beloved showbiz couple - translate this into keeping an eagle eye on every directive, order, law, pronouncement and budget spending of our honorable officials even for just one full term of office. How do you think this new-found vigilance would impact our unending quest for a significant and lasting change in our country? Well, your guess is as good as mine.

FROM PAGE 1 "Our goal at SBMA is in line with HCPTI's goal of creating more employment opportunities, generate new income, boost the tourism, attract more foreign and local investments, and expand the trading business in Subic," enthused SBMA chairman and administrator Jonathan D. Tan during the inauguration of the Subic Port at the former Naval Supply Depot (NSD) here on Tuesday, Dec, 5.

Tan said the 10-year Subic Port joint venture will revitalize the ports, yards, and cargo han-

dling inside this freeport. The joint venture also includes the development, operation and management of several ports inside the former US naval base.

He added that the upgrade of the port facilities is expected to improve cargo processing efficiency, reduce ship turnaround times, and increase the volume of bulk and break bulk cargo handled.

For his part, HCP-TI chairman Dr. Reghis M. Romero II said: "We have to make Subic contribute significantly to total national employment, productivity, trade volume, capital inflows and gross international reserves. This pursuit entails modernization of infrastructure and complete digitalization of all segments of operations."

He added that with the inauguration of the Subic Port operation, the Philippines will now be able to provide enough buffer from global inflation and regional conflicts, citing that the unrest in Ukraine and Israel has put a damper on the global economy.

"Sustainability in business may face threats due to some uncertainties, especially from external forces like the unrest in Ukraine and Israel. But I remain confident, considering that our economy can withstand external shocks which has been proven many times over - from the 1997 Asian financial crisis to the 2008 global economic meltdown and all the way to the recent covid-induced market slump and worldwide inflation," Romero said.

"Thanks to the fact that our economy is driven by consumption such that the nation can consume what it can produce. To a large extent, it makes our economy virtually self-sustaining. But to ensure economic expansion amid the growing domestic requirements, we have to trade beyond our borders and attract foreign capital and technologies," he furthered.

Romero underscored Subic's geographical advantage as the "closest international port to Taiwan, South Korea, and Japan, while also being at the strategic center of the 10-nation Southeast Asia."

"Subic therefore, is at the fulcrum of our country's territorial and economic security, where

the development and protection of critical infrastructure are, not just required, but imperative at extreme urgency," he said. "No wonder the Subic Port, at this very day, has become a monumental example of public-private partnership geared at achieving sustainability through unity."

Romero said Subic contributes to the GDP growth but said "our economy must expand by 7.4 percent in the last quarter of 2023 to achieve the government's full-year GDP growth target of at least six percent."
