CLARK FREEPORT – The imminent closure of the largest waste disposal facilities in Central and Northern Luzon before the end of this year has caused serious and widespread concerns as millions of its populace face grim prospects of a massive garbage crisis.



The Bases Conversion **Development Agency** and its subsidiary, Clark Development Corp., principal proponents of the 25-year contract with Metro Clark Waste Management Corp. (MCWMC), the engineered sanitary landfill builder and operator, have reportedly ruled out any extension or renewal of that contract expiring this October, hence MCWMC should immediately cease its operations of its facilities in Kalangitan, Capas, Tarlac.

# BCDA welcomes Senate bill on charter amendment

CLARK FREEPORT -- The Bases Conversion and Development Authority welcomes the filing of Senate Bill No. 2647, a measure seen to give workers access to affordable housing, accelerate infrastructure development, further drive investments in the country, and support the pension fund of the Armed Forces of the Philippines.

Seeking to amend RA 7227 (Bases Conversion Act of 1992) the bill was filed on April 30 by Sen. Alan Peter S. Cayetano, chairperson of the Senate committee on government corporations and public enterprises, together with the Senate committee on national defense and security, peace, unification and reconciliation, chaired by Sen. Jose "Jinggoy" P. Estrada and vice-chaired by Sen. Francis N. Tolentino.

# Lapid breaks ground for 94-bed medical facility in Capas

CAPAS, TARLAC - Pursuant to the government objective to bring health services in every locality through its hospital expansion and equipping program, groundbreaking rites were held on April 30 for a 94-bed medical facility here.

Leading the ceremony held at the proposed site adjacent to the town hall was Sen. Lito Lapid, along with Mayor Roseller "Boots" Rodriguez, Vice Mayor Alexander Espinosa, sangguniang bayan members, TIEZA general manager Mark Lapid, and contractor Tony De Jesus of Arrowhead Construction.

Lapid said the P54-million medical facility will be constructed on an 800-square-meter in the existing Ospital Ning Capas chargeable to the funding grant from the Senate, with the initial P30 million already been downloaded by his office through the Department of Public Works and Highways.

"The people of Capas express their deep gratitude to Senator Lapid for selecting our town to benefit from his improved healthcare program, which directly benefits our constituents. Hopefully we can have this done by the end

Lapid noted that the hospital expansion is another priority project through legislative funding. "What we really need is services for healthcare... Nobody wants to get sick."

He stressed that poor residents of Capas are the priority for the health care services to be provided in the new hospital that will be managed by the local

He explained the healthcare program in Capas and Tarlac provprovision that mandates local government units to provide various services for the general welfare of their constituents.

The current Ospital Ning Capas has a capacity of 60 beds and operates at a tertiary level, featuring an LGU-run Lingap care center.

With an annual budget of P90 million, it allocates only 10% of its capacity to private patients, reserving 90% for indigent ones. The hospital is staffed by 180 medical frontliners.

Upon completion, new

will be introduced to cater to the 20 barangays of Capas. The hospital will operate at limited capacity once the construction is in full swing.

Lapid is among the seven senators up for re-election in the 2025 mid-term polls. He landed No. 1 in the 2019 senatorial elections in Tarlac.

Meanwhile, Barangay O'Donnel also received a multi-purpose truck from Lapid. The groundbreaking ceremony was also attended by congressional, provincial and barangay

# Pathetic desperation

#### "THIS CHARADE must stop."

Thus, declared Defense Secretary Gilberto Teodoro in response to an unnamed spokesperson for the Chinese Embassy in Manila recently claiming that Beijing and Manila, through the AFP Western Command, allegedly agreed on a supposed "new model" early this year to diffuse tensions in Ayungin Shoal "approved by all key officials in the Philippine chain of command, including the Secretary of National Defense and the National Security Advisor."

A "devious machination of China," Teodoro called the alleged "new model."

"I reiterate that I have disallowed any contact between the DND and the Chinese Embassy since the courtesy call of Ambassador Huang Xilian, a few days after I assumed office in July of last year," Teodoro said.

"During the said courtesy call, there was no discussion or briefing on any 'gentleman's agreement' or 'new model,' which is contrary to the Chinese Embassy's pronouncements," he added.

"I am issuing this statement to generate awareness on this clear attempt by China to advance another falsehood in order to divide our people and distract us from their unlawful presence and actions in our EEZ (exclusive economic zone)," Teodoro said.

"We advise our citizens, the media, and the international community to beware of China's methods of manipulation, interference, and malign influence in furthering its own interests," he said.

"Absolutely absurd, ludicrous, and preposterous," National Security Adviser Eduardo M. Año called the Chinese Embassy's claims.

"No one in the Philippine government is, nor have been, empowered nor authorized to enter into or commit to any sort of agreement, understanding, or arrangement - more so informal ones, by our President," Año said in a statement.

"The Chinese Embassy needs to be reminded that you can never deceive the Filipino people with your fabricated stories, bluffs, and fake exchanges of communication just to support your illegal claim of Philippine territory as well as to justify your illegal, coercive, aggressive and deceptive actions particularly the use of military-grade lasers, water cannons, dangerous blocking maneuvers, and ramming of our vessels which has caused wounded casualties on our side," he added.

Año also questioned the timing of China's statement, which came after it was revealed that the cays of the Pag-asa Island in the West Philippine Sea are now in "degraded states" due to apparent island-building activities.

"This is the bigger story that they want to dislodge from the headlines and deflect attention from. It has truly reached a new low of pathetic desperation," said Año. *With media reports*

# A biblical paradigm

When President Bongbong Marcos proposed recently a new paradigm to address the continued belligerence of China in the West Philippine Sea, many were left guessing?

political, military, diplomatic? It is something out of the blue or box?

In the wake of the latest water-cannon incident on two Philippine ships that shocked the Filipinos anew, no less than Filipino senators called for a tit-for-tat response. If Chinese vessels can fire at us at will with water cannon, so can we, or should be as a proper response.

But nobody can predict exactly how the Chinese will respond in return. It could get worse. Not a few fear this could happen.

PBBB has come out with a better answer. Why not apply a blblical principle most every Christian Filipino knows by heart, if seldom practiced? Do not use? something wrong against a tactic that is inherently wrong and objectionable like an unjurious water cannon against an enemy. Just don't, period. The wisdom in the answer is obvious. You don't answer evil for evil.

It may work. In her book the "Good earth" about China by Pearl Buck a Chinese businessman ran away from poster being given away by Christian missionaries. The poster had the picture of a man crucified on the cross and it horrified him after knowing what it was all about. Has China been running awayfrom cross ever since and buck has making her point subtle and nuanced? Buck knew whereof she wrote: she was a missionary's daughter raised in the Ancient Kingdom

Does the way of peace had the same effect on belligerent mind?

In a way, it was part obviously of the strategy of PBBS's predecessor, Made sense. There is no use fighting a war you cannot win,. Only it it was too subservient a tactic it was perceived as

What would the novel idea be? Would it be a virtual surrender, encouraging more aggressiveness and belligerence,

In his book, 1984. George Orwell predicted the use of lies by authoritarian governments to impose their will in what was called "newspeak" where the meaning of the a word is exactly its opposite.

All this ongoing belligerence by China in the WPS revolves around this fictional theme. Her nine-dash-line theory for instance, has been found to be without basis. Other previous statements since then by Chinese authorities have been disproven by Philippine authorities a merely lying on their teeth. The latest is the so-called 'secret" arrangement with the Philippine government every one denies. Duterte, of course, in a fairness to the Chinese, has been mum about it. Could it be a fool's errand?

The Chinese have announced publicly they are the Filipinos kind friends iin this part of the world. They have sent help in the part, especicaly during the pandemic with Chinese vaccines that saved many fron COVID. But it apparently, such a friendly gesture had a cost: sovereignty,

And PBBB has made it clear that it will not surrender an inch of the country's territory for the sake of friendship. No way he will.

by the most critical decision to make. Aside from the availability of the invited sagalas especially the Reyna Elena, the hermana had to hire the best mosikus in town and reserve the arku from a handful of owners whose rental business thrived only in May. On top of all these concerns, the hermana along with the other organizing committee members had to consider the proverbial rains of May.

After the date had been set, each household in the barangay would then decide whether to participate by fielding a sagala or to donate a pre-determined amount to help defray the total expenses. The days that ensued were the busiest, and everyone was tight-lipped trying not to reveal the names of their respective sagalas. This added to the mystery and anticipation, with the grand reveal happening right before the very eyes of excited neighbors and onlookers on the actual night. This also meant scouting for new beautiful faces from other barangays or even nearby towns so that the people watching the Santacruzan would not see the same old faces everv vear.

For the town's young ladies and their parents,

Choosing the date of the Santacruzan was far it was a source of pride to be invited as a sagala. Some parents would never turn down any invitation as it meant refusing to be part of a festival in honor of the Virgin Mary. Never mind the costs for gown rental or hair and make-up, the family's pride and honor were on the line.

When the invited sagala stepped out of the house to the pompous music of the mosikus and the sparkling lights of the hand-held lucis, one could hear the collective oohs and aahs from the very eager crowd, as if showing their stamp of approval and admiration for the invited sagala.

The sagalas wore gowns that were most appropriate for the occasion. They looked very regal and queenly in either the traditional Filipiniana gowns, or princess-cut gowns. There were no revealing, see-through or nude gowns, and neither were there high-slits. Neither were there voluminous skirts and long trains that occupied not just the whole four-leg arc but the entire barangay road.

The wooden white arcs were simply adorned with hand-made flowers from crepe paper, nothing really fancy. Looking back, I think it was this planeness of the wooden arcs that highlighted the real





raised during a meeting of the National Solid Waste Commission when the Environmental Management Bureau-Region 3 reported that it had been notified by CDC officials about the "planned immediate closure" of the Kalangitan waste disposal facilities as soon as the government's contract with MCWMC expires this coming October.

Fearing a widespread environmental and health crisis as a result of the imminent closure of the largest waste disposal facility in Central and Northern Luzon regions, front line officials of the environment offices of various concerned local government units in Central and Northern Luzon, and the Cordillera Administrative Region were prompted to write a petition letter to Environment Secretary Ma.Antonia Yulo-Loyzaga including the regional officers of the National Solid Waste Management Commission.

The petition cited the Kalangitan facility as "an integral part to our regional waste management system handling more than 4,000 tons of wastes daily and being the only sanitary

landfill of its size in the region that fully complies with the environmental standards mandated by Republic Act 9003."

"The closure of this facility threatens to precipitate literally overnight, a severe waste management crisis throughout 3 Regions in Luzon directly affecting millions of its populace," the petition warned.

Expressing similar sentiments over the closure of the Kalangitan facilities, no less than 20 companies engaged in waste management and disposal also wrote petitions to the **DENR** secretary arguing against the BCDA and CDC action, and warned of the "imminent garbage crisis" facing the people of Central Luzon.

#### No alternative

The environmental officers of local government units in the three regions at the same time expressed their concerns over the "absence of comparable alternatives, as other facilities are either not fully capacitated, non- compliant with RA9003, too small or financially unfeasible or not affordable for their respective local governments."

Plans of the BCDA and

CDC to convert the existing sanitary land fill into other use such as tourism-oriented development is generally considered as "irresponsible, disruptive and counter-productive."

To LGUs contiguous to the Clark Freeport, closing Kalangitan without any alternative plan to deal with the massive waste that needs to be disposed daily "is irresponsible of BCDA and CDC" and a "betrayal of their mandate under RA 7227 (Bases Conversion and Development Act) to institute economic progress and development within and around the former US military installations."

Currently, some 120 cities and municipalities in Central Luzon and a few key cities and provinces in Northern Luzon use the engineered sanitary landfill in Kalangitan.

Waste disposals of nearly all households, business establishments including malls, hospitals, industries operating in cities and provinces in Central Luzon are being serviced by the Kalangitan landfill.

The Clark and Subic freeports are also dependent on the presence of an efficient waste disposal facility for their large quantity of households and industrial wastes.

#### Another landfill

According to a MCWMC official, the current 4,000-5,000 daily household, industrial and institutional wastes being hauled and disposed in the world-class Kalangitan sanitary landfill can easily be accommodated at a lesser cost to local governments and "far more efficient than the more expensive and less efficient landfill site" located in Floridablanca, Pampanga.

The official alleged that the supposed alternative land fill has yet to secure the necessary permits required by government regulatory agencies, and claimed "its capacity and operational capability remains doubtful as it can only accommodate far less than the Kalangitan landfill facilities.

#### Right of reply

mation, we urgently need to overcome legislative challenges that may hinder the optimum potential of these economic zones. More importantly, we seek to empower the workforce that drives the success of these business hubs by allocating a portion of our land for residential purposes," said BCDA president and CEO Joshua M. Bingcang.

We are extremely grateful to Senator Cayetano, Senator Estrada, and Senator Tolentino for filing Senate Bill 2647, which will help us achieve these goals," he added.

In a statement, Senator Cayetano said his proposed amendments are "crucial to maintaining investor confidence and facilitating the implementation of long-term infrastructure projects within BCDA economic zones."

Under Senate Bill No. 2647, a certain percentage

be declared as alienable and disposable, authorizing its sale for residential use, mixed use, industrial, and institutional purposes.

If passed, this measure is seen to mobilize residential and affordable housing development in BCDA ecozones, which is currently prevented by the leasehold status of the properties. This would benefit workers who usually need to live and commute outside the BCDA ecozones, providing them convenience and affording them the opportunity to own a property that they can pass down to their children or family members.

A portion of the net proceeds from the sale of the land shall be earmarked and remitted to beef up the pension fund of the AFP, according to the Senate bill. A chunk of the generated funds would also be allocated for the infrastructure

The bill also seeks to extend the BCDA's corporate term by another 50 years from its current remaining corporate life of 18 years.
