# If it's boring, it must be a SONA

There are two ways to objectively critique the President's SONA: 1) politics is more about the future than the past, or should be and 2) the country is much better than when the President first came to office

In sum, the SONA is the good news. Guess who's the savior?

It's no wonder it took President Bongbong Marcos a longer time to wrap up his narrative compared to the previous ones. There's joy in politics. Considering the cult-like response from the members of the choir in audience, the SONA is a time for celebration, indeed.

First off, rice should no longer be problem. More lands are being developed to plant more rice. Forget about the climate change. Government Is prepared to cope with it. As for the price, which early on was hoped to be pegged at P20 per kilo, based on a nostalgic view of the past, mostly in the time of a dictator, don't worry ,there will be more Kadiwa stores to cater to the poor.

The economy Is doing well, if only the Middle East didn't control petroleum and Russia stopped its murderous rampage in Ukraine, inflation would be more manageable. But wait, the Philippines is primed to be one of Asia's, economic standout, notwithstanding.

There's never been a rosier picture of the employment area. The latest is a 95 percent achievement. Only the employment rate during Moses time in Egypt was higher. Of course, Egypt had a full employment report then . Meaning, all the slaves had work to do, including the building of the pyramids. Unfortunately, Moses led the slaves in an exodus and Egypt was never the same again.

There's good news for the equivalent of slaves: teachers. No one, according to PBBM, should retire as Teacher 1. Whose idea it was , nobody knows because the Vice President had quit as the education chief. Will teachers now stop selling tocinos while their students are in recess? That's one big step toward improving the performance of Pinoy students in world contests for math excellence and creative thinking.

It's good to know that current administration has changed the previous strategy in fighting the drug menace. It will no longer be extermination, as in exterminating rats. In the meantime, PBBM was quiet about prosecuting those behind the death of 6,000 people, by official count, or 30,000 by unofficial tally. It must be the result of political leverage. PBMM doesn't say so.

The prospect of three Dutertes, the former president ,and the two sons joining the Senate fray in 2025 may not be scary but it's worth the worry. The sister-vice preside nt who made herself scarce during the third SONA is food for thought for a politi cian worth his salt. Guess who's afraid of the ICC.

Pragmatically, they are potential problem on the radar. The popular, if not notorious preacher APOLLO Quiboloy has been a real challenge against the police efficiency, if not loyalty, notwithstanding the huge intelligence budget. Guess who's believed to be hiding the preacher in plain sight. come home.

There's never been time when government has shown to be weak against those who defy the law, especially those summoned by the Senate in hearings in aid of legislation. Maybe because China is just a stone's throw away as its ships continue to sail nearer the Philippine shore even in broad day light, as if testing PBBM's resolve that not an inch will be taken away from the Philippine territory while he is the preside nt.

PBMM is a congenital optimist, his SONA says so. He still believes in the power of diplomacy in dealing with tension in the West Philippine Sea, even in the face obvious bad faith many times over from the other side. A new bilateral mechanism Has been forged by China and the Philippines in this direction. Justice Antonio Carpio doesn't buy it. Or tell it to the Marines.

PBMM's optimist doesn't exist in a vacuum. His SONA didn't touch the source of his confidence. The United States has repeatedly stressed it will watch his back if push comes to shove where the mutual defense treaty is invoked. So there. In the meantime, the president's sister-senator Imee Marcos has unwittingly revealed his brother's secret. China is wary of the US' bigger presence in the country she feared Chinese missiles are aimed at different sites of the archipelago. Even a paranoid, they say, has a real or imagined enemy.

One man's confidence is another woman's insecurity.

After all has been said during the SONA, vision and vulnerabilities and all, PBBM should now consider how his next SONA will be more interesting. Details, or much of them, must be trimmed. This should help reduce the length of the piece. A good speaker knows when to stop. He, the president, not the speechwriter(s) should be decisive.

Henceforth, no part of the speech should be boring. The SONA should inspire, not urge members of the audience to look for the next exit instead of remembering what the SONA said. The SONA should not end like a cult-worship but a real motivation for greater service to the

Quotations are a good way to end up a lofty speech like SONA. Only, be careful who to quote from given that politics is inescapably given to cynicism.. For instance, PBMM quoted from the British philosopher John Stuart Mills who in a book warned against the reality of electing representatives with low intelligence. In asking the youth to emulate Apolinario Mabini, PBBM should also have remembered that the sublime paralytic once wrote that Emilio Aguinaldo could only redeem himself from the treacherous death of Andres Bonifacio by dying in a battle.

As for POGOs, the last has not been seen or said about them. Maybe next time. Maybe never. Let's wait and see till Alice Guo and the cows

# First day jitters

CLASSES IN most private schools in the country have already started as early as July 15, at least two weeks earlier than the official start of the school year set by the Department of Education on July 29, 2024.

After two pandemic school years, and after witnessing the many effects of the heat index on the well-being of students and teachers last April and May, we are slowly reverting to the June opening and March closing of the school year.

I remember how during my first few years as a school head, the first day of classes was always like an obstacle my team and I wanted to hurdle swiftly in just one move. I always looked forward to the days ahead when things have "normalized" and I can then focus on accomplishing the tasks I have set for the school year.

Back in the days, the preschool and grade one rooms were the busiest areas with all our hands on deck as we navigate through a series of challenges – learners crying on top of their voices looking for the parents, guardians insisting on staying inside the room to look after their wards, among others.

It really takes tons and tons of patience, genuine love and if may just add, creativity for preschool and primary teachers to survive even for just the opening day. Thanks to their experience, they always find a way to pacify their young learners and assure them that things would be okay if they just stop crying and start participating in the activities, along with their new-found friends.

In the mid-2000's, we introduced our own version of two-week pre-opening enrichment classes for incoming preschool and grade one students, complete with simple recognition rites at the end of the session. While others viewed it simply as a marketing ploy, we considered it as a way to prepare our young learners to be ready for school even prior to the official start of classes. The two-week period enabled these young learners to have a real feel of the classroom setting without parents by their side, interact with kids their age who would later on be their classmates, and familiarize themselves with the classroom routine.

This pre-opening activity proved to be effective because one, the first week of classes for the preschool and grade one learners became pretty manageable and less stressful over the years. Second, enrolment in these departments has increased, thanks to the summer enrolees who opted to continue their academic journey in our school.

It's an entirely different story in the high school department, where parents reacted vehemently when they find the name of their children not belonging to what they consider the first section, the crème de la crème in the batch. But can we actually blame them if this was the era of homogenous sectioning when the theory of multiple intelligences was not even considered in grouping the students?

I remember how year after year, this was always a source of unnecessary stress and bickering, with some parents even threatening to pull out their children if they were not placed in the section they felt they "deserved." The irony of it was that while there were some who insisted to be placed in the "star section," there were a number who requested to be transferred to other sections so they can simply be "normal." Their reason? Simply put, they want to be out of the highly competitive section where everyone was running for honors and enjoy their high school life like many of their happy-go-lucky batch mates.

With the issuance of DepEd Order No. 36, s. 2016 containing the Policy Guidelines on Awards and Recognition for the K-12 Basic Education Program, we implemented the heterogeneous grouping from grade four to ten. Students are simply arranged alphabetically, and then divided equally among the sections to make sure there is an ideal number of male and female students per section. Since then, things have changed dramatically. Parents have learned to embrace these changes, knowing that it is what is best for their children.

The opening of the school year in the country will always have its share of issues, challenges and problems. Let us hope that as both public and private school administrators resolve the usual problems they encounter at their level, the national government address the more pressing issues that have been plaguing the education sector for years.

"Effective today, all POGOs are banned. The grave abuse and disrespect to our system and laws must stop," declared the president.

As early as last year, the CDC had acted promptly on the POGO issue, following the Sun Valley Clark incident. Under the leadership of president and CEO Atty.

Agnes VST Devanadera, the CDC supported the national government in curbing the growth of illegal POGO and related criminal activities.

Aside from terminating the sub-lease agreements related to the Sun Valley incident, the CDC Board on June 8, 2023, unanimously approved Resolution No. OSM-06-04, Series of 2023

suspending the processing and acceptance of applications from POGO and their business process outsourcing (BPO) service providers wanting to do business in this freeport.

"We stand with President Marcos in his commitment to eradicate illegal POGO operations. Our early actions reflect our dedication to safeguarding Clark's integrity

and ensuring community safety," Devanadera said.

On June 5, 2024, the Metro Clark Advisory Council (MCAC), the official coordinating body for CDC and local governments established under RA 7227 and RA 9400, passed Resolution No. 03, Series of 2024, following the rescue of nearly 900 victims from a human trafficking case in

Bamban, Tarlac, on March 13, 2024. This resolution endorsed the deferral of POGO applications by the CDC and Mabalacat City, strengthening efforts to combat POGO-related crimes.

With the Philippine Amusement and Gaming Corp. overseeing the cessation of POGO operations by the end of the year, CDC said it will continue to work closely with national and local authorities to enforce the ban effectively.

Noting that for over three decades, Clark has thrived as a tourism and investment hub, the CDC reaffirmed its commitment to maintaining this freeport as a secure and preferred destination for business and leisure.
