Straight men in drag in street revelry

MINALIN, PAMPANGA – As they have done for nearly a century now, straight men in drag took to the streets in this fishing town in a unique - arguably, the only one of its kind in the Philippines – and cherished tradition celebrated every January 1.

Pampanga's first festival of the year, Aguman Sanduk - the Fellowship of the Ladle - started in 1932, reputedly as a tribute to the contributions of womenfolk in sustaining the vitality of the community amid a severe drought.

Hence, menfolk garbed in

women's attire - from the most elaborate gowns to the most utilitarian "duster" - faces heavily made up, swayed, sashayed, swirled as they made their way to the Poblacion area to the utter delight of the townspeople.

This year, two dynamic clusters comprising 15 barangays, brought together the entire community for a day of revelry, laughter, and cultural pride.

Preparations for the festival began right after Christmas Day, as men from the barangays crafted dazzling floats and

Holidays generally peaceful in NE

CABANATUAN CITY – The Christmas and New Year celebrations in Nueva Ecija have both been generally peaceful and safe following initiatives to tame down use of illegal firecrackers and guns in revelries, police said Wednesday.

Nueva Ecija police director Col. Ferdinand Germino attributed the peaceful celebrations to the police's close collaboration with various stakeholders such as government agencies, non-government organizations, local government units and the community.

Among the interventions initiated by the police, Germino said, were strategic redeployment of personnel, surprise inspections on establishments and firecrackers selling areas, as well as regular visitation to cities and municipalities to provide guidelines to local police efforts.

Germino said they also stepped up conduct of search against illegal firearms, inspired the surrender of loose firearms through the implementation of Oplan Katok, among others.

"The unwavering support and collaboration of all sectors were instrumental in achieving a peaceful and orderly holiday season. NEPPO extends its gratitude to everyone who contributed to this success and reaffirms its commitment to ensuring the safety and security of Nueva Ecija," Germino said.

Health services to level up in CSF

CITY OF SAN FERNANDO – Mayoralty aspirant Mylyn Pineda-Cayabyab struck a chord among residents of Barangay San Agustin here with her avowed mission to level up the delivery of health services in the city, should she win in the elections in May next year.

No mere political stunt, Pineda-Cayabyab presented a tangible framework of her health agenda during a caucus in one of the city's most vote-rich barangays.

The former Lubao town mayor and two-term provincial board member started off with the city's annual budget of over P2-billion that can well accommodate improved health programs, "given thorough planning and proper implementation."

She said the city's rural health

units (RHUs) need to be increased and appropriately stocked with medicines to provide 24/7 medical services to residents. This is to allow for quick medical responses especially in areas that are far from hospitals.

Essential maintenance medicine for hypertension, diabetes, and uncontrolled cholesterol and triglycerides levels should also be made available in the RHUs to arrest the increase of more serious illnesses like heart failures, kidney or liver diseases.

She noted how the provincial government continues to receive requests for assistance from thousands of patients with renal problems which are preventable with early management. "Among them are close to 400 individuals from San Fernando seeking assistance for their dialysis treatment."

Pineda-Cayabyab said this number would have been arrested had early detection and management been employed through free regular laboratory tests and maintenance medicine.

"We will make this all available in the city. Starting with regular medical missions with free laboratory tests and available medicines, even just the generic yet efficacious varieties," she vowed.

"The people of San Fernando need not go to the provincial government for assistance because the city can satisfy all their medical requirement if funds are used judiciously," she added. **Punto News Team/PR**

BALANGA CITY -- The Philippine National Police conducted a surprise drug test on 60 personnel from the Bataan PNP Drug Enforcement Unit and intelligence unit province-wide at Camp Cirilo Tolentino here Thursday.

Bataan police director Col. Palmer Tria ordered the random drug test that was facilitated by the Bataan Provincial Forensic Unit led by Lt. Col. Amilyn Maclid.

Ambo and Bobet

LAST OCTOBER 6, a Sunday, Pope Francis named Kalookan Bishop Pablo Virgilio S. David as the 10th Filipino cardinal. Then, just this Sunday past, Dec. 29, the Holy Father appointed San Jose (Nueva Ecija) Bishop Roberto C. Mallari to the Diocese of Tarlac.

A short look back 18 years ago readily shows this current of events as some back-to-the-future scenario for the two prelates.

On Jan. 14, 2006, Pope Benedict XVI appointed Mallari titular bishop of Erdonia and auxiliary bishop of the Archdiocese of San Fernando. Four months later, on May 26, 2006, he named David titular bishop of Guardialfiera and also auxiliary bishop of San Fernando.

Aye, some feeling of déjà vu, okay, of divine design, obtaining in their priestly lives intertwining, originating in the Mother of Good Counsel Seminary.

Of their becoming bishops, I wrote in the long defunct Pampanga News issue of June 1-7. 2006:

MAKES ME feel really old. Two of my juniors at the Mother of Good Counsel Seminary, circa 1970s, are – within the span of three short months - princes of Mother Church. God be praised!

More than the element of time, what makes this event truly astounding is that Auxiliary Bishop Roberto Mallari and Auxiliary Bishop-Elect Pablo David were classmates. I don't know how many in their batch survived the five years from Infima to Rhetorics at MGCS, but I do know that theirs was one class that produced five priests – Ambo and Bobet, Ted Valencia, Eric de Guzman, and Wilfredo Manrique.

My batch – the "souls" that entered the gates in 1967 - set the record of entrants that has to this day remained unbroken - 72. Only 14 finished high school, four of whom did not belong to the originals. And only one made it all the way to ordination - Fr. Lorenzo Sarmiento, current pastor of St. Peter's Parish in Apalit. With Among Larry, we were luckier than some other batches that produced none.

Lucky with one priest out of a batch of 72! What with five in one batch that is not even half of ours? And two bishops to boot! God's hand shows in this one. Only atheists will be blind to that. As they are to just about anything else.

Ambo and Bobet make a study in divergence as I know them, er, as I perceive them to be. The public intellectual, Ambo makes a Thomas Aquinas to Bobet's John Mary Vianney, the private, quiet worker in the Lord's vineyard.

Ambo is into evangelization – as deputy head of the appropriately named AMANU (Capampangan for word) that is the Archdiocesan Media Apostolate Networks Unlimited, and co-host of Fr. Raul de los Santos and Fr. Deo Galang in the popular cable TV program Men of Light which takes the liturgy of the Word down to the daily grind of life.

Bobet is into pastoral ministry - as archdiocesan chaplain of the marriage encounter program that include, among a host of others, the Couples for Christ and its offsprings, the Singles for Christ, Handmaids of the Lord, and the Youth for Christ.

Both are much requested retreat and recollection masters and speakers. Where Ambo scorches the intellect, Bobet inflames the heart. Listening to them, one cannot help but be touched, be moved, be closer - even be converted, if ye be a man of little or no faith - to Christ.

Ambo and Bobet. Mind and heart. A Godsent combination that will most surely produce a most bountiful harvest for the Church.

St. Paul's Letter to the Ephesians read last Sunday – May 28, the day Ambo's episcopal appointment was published - proved truly providential: "...And he gave some as apostles, others as prophets, others as evangelists, others as pastors and teachers, to equip the holy ones for the work of ministry, for building up the body of Christ, until we all attain to the unity of faith and knowledge of the Son of God, to mature manhood, to the extent of the full stature of Christ."

Three years back, Archbishop Paciano B. Aniceto was agonizing over the crisis that swept the Pampanga clergy, spawned by all those scandalous allegations of infidelity to their vows. We were in San Francisco, California in his biennial pastoral visit that time.

Just think Among how much more trouble the Church would have been in had I become a priest," I told him, only-half joking.

The Good Apu Ceto's face so brightened that I thought he had an epiphany.

Ambo and Bobet. With them as auxiliaries, Apu Ceto would have no cause for agony. God is good!

INDEED, Ambo and Bobet, how they have worked in the vineyard of the Lord; how they live the very definition of the priesthood - impacted in my young mind when I entered the seminary - "God's greatest gift to His people, His people's greatest gift to Him."

In a word, she hasn't burned the bridge yet.

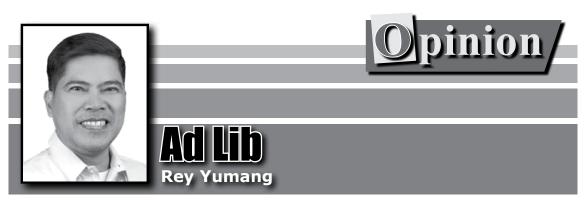
The president had earlier admonished her indirectly via the media to remember James Bond: never say never.

Section 4. Use of Savings and Augmentation – Pursuant to Section 336 of Republic Act No. 7160, also known as the Local Government Code of 1991, the Local Chief Executive and the Presiding Officer of the Sangguniang Panlungsod are authorized to augment any item in the approved annual budget for their respective offices using savings from other items within the same expenditure class. However, the executive shall provide a copy to the Sangguniang Panlungsod of the items that have been augmented, ensuring transparency and keeping the legislative body informed, as the Sangguniang Panlungsod is the approving authority of the budget.

For this purpose, "savings" refer to portions or balances of any programmed appropriation free from any obligation or encumbrance, still available after the satisfactory completion or the unavoidable discontinuance or abandonment of the work, activity of purpose for which the appropriation is authorized, or arising from unpaid compensation and related costs pertaining to vacant positions and leaves of absences without pay.

"Augmentation" – implies the existence in the budget of an item, project, activity or

purpose with an appropriation which, upon implementation or subsequent evaluation of needed resources, is determined to be deficient.

Section 5. Uniform or Clothing Allowance. The appropriation for each department may be used for uniform or clothing allowance of employees at not more than Seven Thousand Pesos (P7,000.00) each per annum, subject to the rules and regulations issued by the DBM. In case of deficiency, or in the absence of appropriation for the purpose, the requirements shall be charged against available savings of the agency.

Section 6. Priority in the Use of Personal Services Savings. In the use of savings, priority shall be given to the augmentation of the amounts set aside for compensation, Year-End Bonus and Cash Gift, retirement gratuity, terminal leave benefits, and other personnel benefits authorized by law.

Section 7. Separability Clause. If, for any reason, any section or provision of this Appropriation Ordinance is disallowed in the Budget Review or declared invalid by proper authorities, other sections or provisions hereof that are not affected thereby shall continue to be in full force and effect.

Section 8. The provisions of this Appropriation Ordinance shall take effect on January 1, 2025.

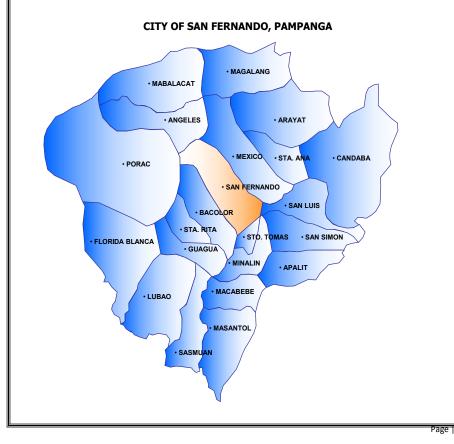

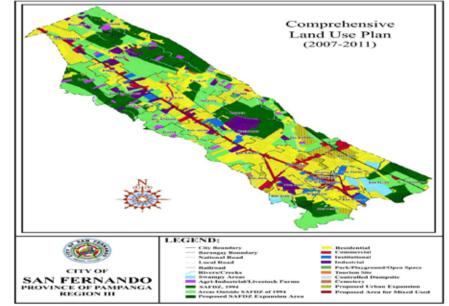

The City of San Fernando in Pampanga province forms part, and lies at the core of the Central Luzon great plain. It is bounded in the east by the towns of Mexico and north by Angeles City, in the west by Bacolor and in the south by Sto. Tomas. It is approximately 67 kilometers north of Metro Manila.

Looking at the regional perspective, the more important crossroads these road networks form i.e. those located at the center or core of Region III, are hosted by City of San Fernando. Because of this, City of San Fernando's geographic location has its very strategic advantage. This may have been the reason why San Fernando was designated as the Capital town of Pampanga as early as 1904 replacing Bacolor. In addition, it also acts as the regional administrative capital of Central Luzon, Region (Region III).

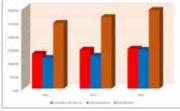


of San Fernando has thirty-five (35) Barangays with 354,666 registered total populations for the year 2020. GENERAL INTRODUCTION

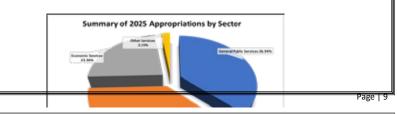
The total estimated receipts for the budget year (2025) amounts to P 2,936,395,113.00 which is 9.86% higher than the current year (2024) of P 2,672,817,979.00 and 19.82% higher than the past year (2023) of P 2,450,668,995.33. These amounts include the collection on Special Education Tax of P 230,000,000.00 for the year 2025 and 2024, P 236,978,412.03 for 2023. With these in light, the total available resources for appropriation for 2025 amount to P 2,706,395,113.00. The rate of local source to total receipts is lowest in 2025 which is 50.74% compared with 54.29% estimated receipts for 2024 and 53.06% actual receipts for 2023. Hence, National Tax Allotment (NTA) dependency is 46.94%, 45.71% and 49.26% for the year 2023, 2024 and 2025 respectively. The graph shows the comparative receipts for the period 2023 to 2025.



Out of the total available resources for appropriation for the budget year (2025) of P 2,706,395,113.00, almost 100% or P 2,706,355,715.36 will be appropriated leaving an unappropriated balance of P 39,397.64. The level of expenditure is higher than the current year (2024) which is P 2,442,206,903.88 out of the total available resources amounting to P 2,442,210,229.00 leaving an unappropriated balance of only P 3,325.12 which is also almost 100%.

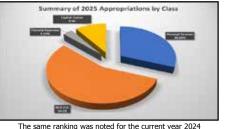

On the other hand, MOOE tops the expenditures by classification for the budget year 2024 with 50.61% or P 1,235,968,833.45 followed by Personal Services with 32.84% or P 802,083,024.63, then by Capital Outlay with 13.47% or P 329,007,045.80, and lastly by Financial Expenses with 3.08% or P 75,148,000.00. The same ranking was noted for the current year 2024 The Personal Services Limitation Rate increases at 37.43% because the total actual income from regular sources in the past year (2023) is P 2,212,763,583.30 while the total Personal Services is P 828,240,613.74. - Enforce the provisions of the National Building Code and implement the rules and regulations issued therefore of the LGU concerned
 - Process all building permit application on the basis of land-use and architectural, structural and geodetic, sanitary and plumbing, electrical, mechanical electronics and fire as well as other standards requirements, rules and regulations promulgated in accordance with the National Building Code
 - Inspect all buildings or its premises at all reasonable times and determine compliance with the requirements of the National Building Code, and the terms and conditions provided for in the building permit as issued;
 - Review and evaluate the design, plans and programs with the corresponding specifications estimates and other necessary building documents of all building projects under his charge;
 - Inspect the construction, repair, addition, renovation and/or demolition of all buildings in accordance with the National Building Code and prescribed the terms and/or conditions when the work will be allowed to resume;
 - Order discontinuance of the occupancy or use of any building or structure or portion thereof found to be occupied or used contrary to the provisions of the National Building Code;
 - Keep a permanent record and accurate account of all fees and other charges fixed and authorized by the Secretary of Public Works and Highways

Vision: By 2025, OCBO will be the premiere implementer of the National Building Code, improving the life of every Fernandinos towards a smart and sustainable city.

PART III: GENERAL PROVISIONS

1. Sale of Non-Serviceable, Obsolete or Unnecessary Equipment. The City Government is hereby authorized to sell non-serviceable, obsolete, or unnecessary equipment, including cars, vans and the like pursuant to Section 79 of P.D. No. 1445. The proceeds from the sale of such equipment shall be deemed automatically appropriated for the purchase of new ones, and for the repair or rehabilitation of existing vital equipment.

2. Mandatory Expenditures. The amounts programmed, particularly for, but not limited to, petroleum, oil and lubricants as well as for water, illumination and power services, telephone and other communication services, rent, retirement gratuity and terminal leave requirements shall be disbursed solely for such items of expenditures: PROVIDED, That any savings generated from these items after taking into consideration the City Government's full year requirements may be realigned only in the last quarter.

3. Travelling Expenses. Officials and employees of the City Government may be allowed payment of claims for reimbursement of travelling and related expenses incurred in the course of official travel, certified by the department head concerned as absolutely necessary in the performance of an assignment, and supported by receipts, chargeable to available allotment for travelling expenses.

4. Human Resources Development and Training Programs. The City Human Resources and Management Office shall review and formulate the human resource development and training programs to make the same responsive to the organizational needs and manpower requirements of the LGU and the need to train personnel in appropriate skills and attitudes. It shall likewise include in the human resource development and training programs measures to promote morale, efficiency, integrity, responsiveness, progressiveness, courtesy as well as nationalism and patriotism in the civil service. Such training programs shall be consistent with the rules and regulations issued by the CSC for the purpose.

5. Authorized Deductions. Deductions from salaries, emoluments or other benefits accruing to any city government employee chargeable against the appropriations for Personal Services may be allowed for the payment of individual employee's contributions or obligations due the following:

(a) The BIR, GSIS, HDMF and PHILHEALTH;

II. EXPENDITURE PROGRAM

Mandate:	 Responsible for the administration and supervision of all Market Operation including the duties, functions and assignments of all Market Personnel; Responsible for the implementation and administration of market rules and regulations; Responsible for the supervision and monitoring of market daily collections both in the Old and New Public Market (market fees, entrance fees, parking fees ambulant fees, and rental of stalls); Responsible for monitoring orderliness and cleanliness in the market premises in the Old and New Public
	Market.
Vision:	To make public market a dynamic viable enterprise and important integral part of the city government.
Mission:	 Develop, regulate public market operation and to professionalize market service; Make market more responsive and effective instrument of public service; make market operation contribute significantly to the financial capabilities of the city government.

(b) Associations/cooperatives/provident funds organized and managed by government employees for their benefit and Ifare.

6. Uniform or Clothing Allowance. The appropriations provided for each department may be used for Uniform or Clothing Allowance of employees at not more than Seven Thousand Pesos (P 7,000) each per annum, subject to the rules and regulations issued by the DBM. In case of deficiency, or in the absence of appropriation for the purpose, the requirements shall be charged against available savings of the agency.

7. Availability of Appropriations. Appropriations for CO under this Ordinance shall be available for release and obligation for the purpose specified for a period extending to one fiscal year after the end of the year in which such items were appropriated.

8. Limitation on Cash Advance. Notwithstanding any provision of law to the contrary, cash advances shall not be granted until such time that the earlier cash advances availed of by the officials or employees concerned shall have been liquidated pursuant to pertinent accounting and auditing rules and regulations.

9. Meaning of Savings. Savings refer to portions or balances of any released appropriations in this Ordinance which have not been obligated as a result of the following:

a. Final discontinuance or abandonment of an on-going program, activity or project by the head of the agency concerned due to causes not attributable to the fault or negligence of the agency which would not render it possible for the agency implement the said P/A/P during the validity of the appropriation.

b. Non-commencement of the P/A/P for which the appropriation is released. For this purpose, non-commencement shall refer to the inability of the agency or its duly authorized procurement agent to obligate the released allotment and implement the P/A/P due to natural or manmade calamities or other causes not attributable to the fault or negligence of the agency concerned during the validity of the appropriations.

c. Decreased cost resulting from improved efficiency during the implementation or until the completion by agencies of their of P/A/Ps: Provided, that the agencies will still be able to deliver the targets and services as approved in this Ordinance.

d. Difference between the approved budget for the contract and the contract award price.

e. Unused personal services costs pertaining to a) unfilled, vacant or abolished positions; b) non-entitlement to allowance and benefits; c) leaves of absence without pay; and d) unutilized pensions and retirement benefits arising from death of pensioners, decrease in the number of retirees, or other related causes.

10. Priority in the Use of Savings. In the use of savings, priority shall be given to the augmentation of the amounts set aside for compensation, Year-End Bonus and Cash Gift, retirement gratuity, terminal leave benefits, and other personnel benefits authorized by law.

11. Use of Savings and Augmentation. In accordance with Section 336 of Republic Act No. 7160, the Local Government Code of 1991, the City Mayor and the Presiding Officer of the Sanggunian are authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations.

For this purpose, "savings" refer to portions or balances of any programmed appropriation free from any obligation or encumbrance, still available after the satisfactory completion or the unavoidable discontinuance or abandonment of the work, activity of purpose for which the appropriation is authorized, or arising from unpaid compensation and related costs pertaining to vacant positions and leaves of absences without pay.

"Augmentation" – implies the existence in the budget of an item, project, activity or purposed with an appropriation which, upon implementation or subsequent evaluation of needed resources, is determined to be deficient.

12. Service Contracts. Service contracts may be entered into by the city government for professional consultancy services, which may include contracts with individual consultants. For this purpose, an individual professional consultant is an expert in a field of special knowledge or training who is contracted to render particular outputs or services primarily advisory in nature requiring highly specialized or technical expertise which cannot be provided by the regular staff of the agency. Such hiring creates no employer-employee relationship between the individual professional consultant and the agency.

Likewise, service contracts may be entered into by the city government for janitorial, security and other related services, whenever practicable and cost-effective for the government.

The foregoing service contracts shall be entered into by the agency through public bidding or other alternative methods of procurement in accordance with R.A. No. 9184 and its Revised Implementing Rules and Regulations, subject to pertinent budgeting, accounting and auditing rules and regulations.

13. The LCE can enter into procurement contracts without Sanggunian Authority. R.A. 9184 gives the LCE the power to enter into procurement contracts even without Sangguniang Panlungsod authority. This power of the LCE is pursuant to law which is sanctioned by the Local Government Code. (Section 22 (c) in relation to Sections 444 b. vi.; 455 b.vi.; 465 b.vi. of RA 7160)

Accordingly, once a budget for a particular procurement contract is already authorized by the Sanggunian via an annual or supplemental appropriation ordinance, the LCE no longer needs to secure any further authorization from the Sangguniang Panlungsod to enter into contract. (DILG Opinion No. 9, Series of 2006)

GSIS sets aside P8.6-Bemergency Ioan For 364K members, pensioners in Luzon

MANILA -- The Government Service Insurance System has set aside nearly P8.6 billion in emergency loans for 363,547 active members and old-age and disability pensioners affected by various typhoons.

In the province of Isabela, the deadline for application is on 4 January. Deadline for application in the provinces of Ifugao and Nueva Vizcaya, and the towns of Burgos and Bautista in Pangasinan province is on 5 January.

The emergency loan window is also open in

the provinces of Cagayan until 16 January; Albay on 23 January; Batangas, Camarines Norte, and Catanduanes, until 28 January.

Qualified borrowers in the provinces of Quezon (excluding Lucena City), Camarines Sur, and Laguna; city of Naga; municipalities of Juban, Bulan, Irosin, Barcelona, Donsol, Matnog, and Castilla in Sorsogon; and municipality of San Fernando in Masbate have until 30 January.

Application for the following areas in Sorsogon has been extended until 5 February: Sorsogon City, Bacon, Casiguran, Bulusan, Magallanes, Santa Magdalena, Gubat, Prieto Diaz, and Pilar.

In the municipalities of Pio V. Corpuz and Uson in Masbate province, deadlines for application are on 12 and 21 February, respectively.

Eligible to apply are active members who are working or residing in the calamity declared areas, have no due and demandable loan, not on unpaid leave, have paid premiums in the last six months prior to application, have no pending administrative or criminal case, and with a net monthly take-home pay of at least P5,000 after deductions.

Under the emergency loan facility, qualified members who have existing emergency loan may borrow up to P40,000 to pay off their previous emergency loan balance and enable them to receive a maximum net amount of P20,000. Those without existing emergency loan may apply for P20,000.

Old-age and disability pensioners may also apply for a P20,000 emergency loan, provided they are residing in the calamity areas and their net basic monthly pension is at least 25% after loan deductions.

Members and pensioners may apply for the loan through the GSIS Touch mobile application, which may be downloaded from the Google Play and Apple App stores.

The loan proceeds are electronically credited to the borrowers' eCard or UMID card.

The loan comes with a 6% interest rate, no service fee, and payment period of three years. It includes

a redemption insurance, which ensures that the balance will be deemed fully paid in the event of the borrower's death, as long as payments are up-to-date.

PhilHealth benefit for heart disease up by over 15-fold

MANILA -- As Filipinos celebrate the holiday season, the Department of Health recently called on people to prioritize their well-being by practicing moderation in their food intake and maintaining an active lifestyle. This is particularly important given that cardio-vascular diseases, specifically ischemic heart disease (IHD), remain the leading cause of death in the Philippines.

To provide expanded financial coverage associated with heart disease treatment, the Philippine Health Insurance Corp. significantly increased its benefits coverage for Ischemic Heart Disease-Acute Myocardial Infarction (IHD-AMI) or "heart attack" for all inpatient admissions effective Dec. 21, 2024.

PhilHealth Circular No. 2024-0032 published on the same date provides coverage for (1) Percutaneous Coronary Intervention (PCI) at P524,000 from P30,300, an increase of 1,629 percent; (2) Fibrinolysis at P133,500 from P30,290 or a 900% increase; (3) Emergency Medical Services with Coordinated Referral and Interfacility Transfer at P21,900; and (4) Cardiac Rehabilitation after PCI at P66,140. The expanded PhilHealth benefits packages for heart attack ensure that patients receive timely medical treatment by including emergency medical transport services to a capable health facility and all the medical interventions needed to ensure survival and good patient outcomes.

"We understand the significant financial burden that heart disease can place on families," said PhilHealth president and CEO Emmanuel R. Ledesma, Jr. "We have listened to the patients and their families, and with the cooperation of our partner health facilities, we have been able to determine the prevailing costs that led us to adjust and substantially increase our financial support in these life-saving treatments."

The enhanced heart packages support a comprehensive range of services that include emergency medical services, medicines, laboratory and diagnostic tests, medical supplies, use of equipment, and pertinent administrative fees. In the case of percutaneous coronary intervention, the procedure can be availed of at any of the 70 accredited Cath Labs nationwide.

The PhilHealth chief reminded the members that there should be no co-payment for inpatient admissions in basic or ward accommodations in both public and private health facilities nationwide.

"But we should not forget, heart ailments can be prevented. To support our members in their journey towards better health especially in the coming new year, we encourage everyone to avail of our primary care benefits under Konsulta," urged Ledesma, specifying consultations with primary care physician, laboratory tests for early detection as well as medicines to support those that already have heart conditions, all for free.

"Through the Konsulta, we can identify potential health risks early on, including family history of heart disease, allowing for timely interventions such as medication for cholesterol management and lifestyle advice, to prevent or mitigate the development of heart disease,". He asked Filipinos to register to their Konsulta provider of choice at any of the local health insurance offices nationwide or through their own account in the Phil-Health Member Portal.

By embracing a healthy lifestyle and by utilizing the Konsulta, Filipinos can better protect themselves from heart diseases for a healthier and productive future, he added.

Petitioner Mia Caballa Jung filed an amended petition for the recognition of foreign judgment pursuant to paragraph 2, Article 26 of the Family Code to capacitate her to use her maiden name as well as to remarry should she choose to do so in the future.

Petitioner alleged, in sum, that she and respondent Jin Young Jung married on 18 October 2008 and lived together for eight (8) years. No child was born into their marriage. Their relationship turned sour which led to the filing of cases for Violation of Republic Act No. 9262 or the Anti-Violence Against Women and their Children Act of 2004 and issuance of a temporary protection order.

She later learned that respondent Jung filed a Petition for Divorce in Seoul, South Korea. Upon receipt of Divorce Judgment in May 2019, she flew to South Korea and secured an original certified true copy of Divorce Judgment and its English translation as well as a notarial certificate containing the Korean text of the Korean Divorce Judgment and its English translation, duly notarized and apostilled.

Thereafter, she filed a Petition for Recognition of Foreign Judgment in Pasay City Regional Trial Court (RTC) docketed as Spec. Proc. No. R-PSY-19-04279 raffled to RTC Pasay City, Branch 112. Said petition was, however, later withdrawn. On 6 March 2024, she refiled the same petition in City of San Fernando (CSFP) Regional Trial Court but was dismissed by RTC Branch 44, CSFP for insufficiency in form and substance particularly, petitioner's non-compliance with the Judicial Affidavit Rule. Petitioner once again refiled a similar petition before the RTC CSFP on 1 July 2024 but was again dismissed by RTC Branch 43, CSFP for insufficiency in form and substance particularly petitioner's failure to attach a copy of the Korea Law on Divorce officially translated in English language.

Petitioner's counsel then flew to South Korea and obtained a duly notarized Declaration dated 4 September 2023 from Baik Young Bong certifying that the "Divorce laws of the Civil Code of the Republic of Korea as attached are true and correct and are true translations for the texts originally written in the Korean language.

With the addition of aforesaid Declaration, petitioner now re-filed the same petition pursuant to paragraph 2, Article 26 of the Family Code.

MAJIGANGGA FESTIVAL



STA. ANA, PAMPANGA – A Christmas tradition different from the usual lantern fests elsewhere and lost irretrievably in other Pampanga towns is fully alive here with giant papier-mâché puppets as the center of attraction.

This is the Majigangga Festival from Mexico's mojigangas, which in turn came from the boxigangas of medieval Spain according to the culturatus Ropbby Tantingco – where the puppets originally "wiggling and prancing like mean marionettes, they tail end the nightly lantern procession from Dec. 16 until Dec. 24."

For this year's edition, a total of 65 Pimpeño youth from 14 barangays proudly showcased their craftsmanship and creativity in keeping alive a much-cherished tradition.

"I started joining the festivities at age 13, and now, I get to craft my own majigangga," shared KJ Larway, one of this year's standout majigangga makers. Using bamboo sticks, PET bottles,

papier-mâché, foam strips, and even electric wiring for mobility, Larway

brought his Dancing Giant Puppet to life. "This is my way of preserving our treasured tradition," he added, reflect-ing the passion and pride of Sta. Ana's youth.

The Majigangga Festival in Sta. Ana began in 1970 as the brainchild of Jacinto Quiambao, who envisioned a celebration of the town's creativity and culture.

"The MICE industry in Central Luzon's Clark Freeport and Special Economic Zone continues to flourish, as the SM group's presence in Clark creates a seamless experience for MICE participants," the SM Group said.

In an earlier statement, SM Investments announced plans to further leverage the rapid growth of Clark by building its own multimodal transport terminal that will boost access to the area.

"Synergy plays a significant role in supporting this growth, with Park Inn by Radisson Clark offering over 200 rooms and plans for expansion already in progress," the SM Group noted.

It added that in anticipation of this potential growth, the hotel taps into local talent as it seeks individuals with understanding of the community as evidenced by the 80% in Park Inn's staff locally hired from Pampanga.

The SM Group highlighted that SM Clark was the venue for the prestigious MICECon 2024 last July which brought together leaders, stakeholders and experts to discuss the future of the MICE industry in the Philippines.

"This journey isn't just about infrastructure," Morato said. "It is also about building a thriving community where business, tourism and local talent come together to provide world-class facilities and services that meet the evolving needs of our clients and partners."

Currently, SMX Convention Center operates eight branches nationwide: SMX Manila, Megatrade Hall, SMX Aura, SMX Clark, SMX Olongapo, SMX Bacolod, Sky Hall Seaside Cebu, and SMX Davao.

SMX is also set to open the SMX Convention Center Cebu in South Road Properties, Cebu City, by the fourth quarter of 2026. *Punto News Team/PR*

VATICAN CITY -- As Pope Francis opened the Holy Door of Saint Peter's Basilica on Christmas Eve, he ushered in the widely-anticipated 2025 Jubilee Year of Hope.

The Holy Door is deemed 'Holy' since it calls all those who enter through it to walk in holiness of life. In the footsteps of the Pope, during the singing of the Jubilee hymn, representatives of the entire People of God crossed its threshold, as a prelude to the countless pilgrims of hope from every country and language who will visit St. Peter's Basilica and celebrate the mysteries of salvation during the Holy Year.

"During the Holy Year," the Pope has prayed, "may the light of Christian hope illumine every man and woman, as a message of God's love addressed to all! And may the Church bear faithful witness to this message in every part of the world!"

The Holy Father invited us to pray, to prepare ourselves throughout this year, so that this Jubilee may "strengthen us in our faith, helping us to recognize the Risen Christ in the midst of our lives, transforming us into pilgrims of Christian hope."

The Pope picked up the Jubilee theme of hope in his homily. He began recalling the Gospel passage according to St. Luke which recounts when the angel of the Lord, bathed in light, illumines the night and brings glad tidings to the shepherds: "I bring you good news of great joy that will be for all the people. For unto you is born this day in the city of David a Saviour, who is Christ the Lord." (Lk 2:10-11).

At that moment, the Holy Father reflected on how Heaven breaks forth upon earth amid the wonder of the poor and the singing of angels. "God," he highlighted, "has become one of us to make us like Himself; He has come down to us to lift us up and restore us to the embrace of the Father."

In Emmanuel, "God with us," the Pope reiterated, we find our hope. "The infinitely great made Himself tiny and the glory of heaven appeared on earth as a little child."

"If God can visit us, even when our hearts seem like a lowly manger," the Pope continued, "we can truly say: Hope is not dead; hope is alive and it embraces our lives forever!"

"Tonight, the door of hope has opened wide to the world" and "God speaks to each of us and says: 'there is hope also for you!'" he said.

"With haste," therefore, he said, "let us set out to behold the Lord who is born for us, our hearts joyful and attentive, ready to meet him and then to bring hope to the way we live our daily lives. For Christian hope is not a 'happy ending' which we passively await, but rather, a promise, the Lord's promise, to be welcomed here and now in our world of suffering and sighs."

As disciples of the Lord, the Holy Father encouraged, "we are called to find our greater hope in Him, and then, without delay, carry that hope with us, as pilgrims of light amid the darkness of this world."

"Brothers and sisters," the Pope reminded, "this is the Jubilee."

This is the season of hope in which we are invited to rediscover the joy of meeting the Lord," he stressed, adding how the Jubilee "calls us to spiritual renewal and commits us to the transformation of our world, so that this year may truly become a time of jubilation."

Concluding, thus: "Dear sister, dear brother, on this night the 'holy door' of God's heart lies open before you. Jesus, God-with-us, is born for you, for us, for every man and woman. With him, joy flourishes; with Him, life changes; with Him, hope does not disappoint." **Deborah Castellano Lubov/Vatican News**
