CLARK FREEPORT – The Bases Conversion and Development Authority distributed 36 transfer certificates of titles (TCTs) to landowners affected by the project in Pampanga pursuant to right-of-way (ROW) acquisition for the Subic-Clark-Manila-Batangas (SCMB) Railway Project.

BCDA vice president and Subic-Clark Railway project director Jocelyn L. Caniones led the turnover of TCTs to 17 lot owners from Porac and Floridablanca with Pampanga 2nd District board member Fritzie David-Dizon and provincial assessor of Pampanga Manuel N. Mendoza Jr., who represented Gov. Dennis "Delta" Pineda and Vice Gov. Lilia "Nanay" Pineda.

Citing their contribution to the smooth implementation of the SCMB Railway Project, Caniones lauded the landowners for their cooperation, citing the importance of the project in the development of Central Luzon and the country.

DOTr chief seeks AC help in ROW clearing

ANGELES CITY - New Department of Transportation Secretary Vince Dizon made a call at city hall on March 7 to seek assistance from the local government in expediting the resolution of right-of-way (ROW) concerns affecting the Clark-Angeles-Calumpit phase of the North-South Commuter Railway project.

Dizon immediately received the assurance of Mayor Carmelo "Pogi" Lazatin Jr. of the city's support in addressing ROW issues within his area of jurisdiction to prevent delays in the rail development, which is expected to enhance connectivity, ease traffic congestion, and boost economic growth in the region.

Lazatin also urged the DOTr to involve the affected barangays in the process.

"We fully support this project as it will provide a more efficient and accessible transportation system for our people. However, we need to ensure that all concerns are addressed promptly and fairly," Mayor Lazatin said.

During the meeting, Dizon emphasized the DOTr's commitment to working closely with the Angeles City government and other stakeholders to expedite the right-of-way acquisition process.

Lazatin and Dizon were joined by Lazatin's most recent chief adviser and now DOTr assistant secretary IC Calaguas, city councilor Atty. Arvin Suller, Executive Assistant IV Reina Manuel, and DOTr PMC Engr. Shi Yamamoto during the meeting also attended by city engineer's office OIC Helen Ayro, general services officer Evangeline Malonzo, business permit and licensing division chief Enrico Romero, city environment and natural resources officer Jenifer Castro, city assessor Michael Calaguas, and Angeles City Human Settlements and Urban Development Office deputy Rowel Nava.

The North-South Commuter Railway Clark Extension Project is expected to accommodate 342,000 passengers daily.

8 LGUs get P143-M Subic revenue share

SUBIC BAY FREEPORT - Local government units contiguous to this freeport have received their revenue share of ₱143 million from the Subic Bay Metropolitan

SBMA chairman and administrator Eduardo Jose L. Aliño explained that the revenue shares accorded

to neighboring LGUs are given to seven municipalities and a city surrounding Subic Bay Freeport to supplement their development funds in communities as well as enhance LGU projects in tourism, infrastructure, education, peace and order, health, and livelihood generation.

Aliño also shared that the amount is

determined according to 50% population, 25% land

area, and 25% equal sharing.

Olongapo City received the biggest chunk with ₱33.48 million as the most populated LGU, followed by Subic, Zambales at ₱21.48 million; Dinalupihan, Bataan at ₱17.83 million; and San Marcelino, Zambales at ₱17.19 million.

Hermosa, Bataan received ₱15.33 million; Castillejos, Zambales at ₱13.02 million; Morong, Bataan at ₱12.66 million; and San Antonio, Zambales at

According to the SBMA accounting department, the amount released accounted for two percent out of the five percent tax on gross income paid for by freeport locators from July to December 2024. The other three percent of the taxes paid are remitted directly to the national government.


Clark Development Corp. President and CEO Atty. Agnes VST Devanadera discussed the Clark Loop, a public utility bus transportation system operated by CDC under a special permit. This system provides safe, reliable, and convenient interconnectivity of transport systems to meet the growing passenger demand within the Clark Freeport Zone.

She emphasized integrating modern transport systems into urban planning to enhance connectivity for people, fostering growth, and improving the overall quality of life.

Devanadera also invited attendees to visit Clark, highlighting the area's ongoing developments and tourist attractions.

Comelec marks 14 poll hotspots in CL

CITY OF SAN FERNANDO — Fourteen areas in Central Luzon have been placed by the Commission on Elections under heightened monitoring as election areas of concern ahead of the 2025 national and local elections.

These areas include eight in Nueva Ecija, two each in Pampanga and Bulacan, and one each in Aurora and Bataan.

The classification is based on factors such as intense political rivalry and the presence of private armed groups that could potentially disrupt the electoral process.

This, even as Comelec 3 assistant regional elections director Elmo Duque assured the public that all necessary measures are in place to ensure smooth and secure elec-

Preparations include extensive training for election personnel, deployment of security forces, and setting up technical support teams to handle election-related concerns.

In line with these, the Police Regional Office 3 has ramped up its checkpoint operations to curb illegal firearms and prevent election-related violence.

PRO-3 public information office chief Major Aileen Rose Stanger has called for public cooperation in its checkpoint operations, stressing that checkpoints are essential in monitoring potential threats, intercepting illegal firearms, and deterring criminal activities that could disrupt the elections.

"With that, we ask the public, especially our motorists, to be patient and cooperative. These checkpoints are in place to ensure the safety of our communities and prevent any election-related violence," she said.

From January 12 to March 4, 2025, police operations in Central Luzon resulted in the confiscation of 205 firearms, four explosives, and 718 ammunition.

Among the seized firearms were 107 units of .38 revolvers, 22 units of .45 pistols, 22 units of 9mm guns, two rifles, one shotgun, one .40 gun, and 50 other types of firearms.

Authorities also apprehended one uniformed personnel, seven security guards, and 202 civilians who failed to present the necessary licenses at checkpoints.

In addition, authorities assure the public that strict security protocols, including monitoring of election hotspots, will be continuously enforced to maintain peace and order throughout the election period. Marie Joy S. Carbungco/

On Duterte's arrest

"TRUE JUSTICE... is about accountability, transparency, and the protection of human dignity." said Bagaforo, who is also president of Caritas Philippines.

So declared Caritas Philippines Bishop Jose Colin Bagaforo of Kidapawan on the arrest of former President Rodrigo Duterte on March 11.

"For years, former president Duterte has claimed that he is ready to face the consequences of his actions. Now is the time for him to prove it," he added.

"Walang katumbas ang saya'ng nararamdaman nila ngayon dahil magkakaroon na ng pagkakataon na marinig 'yung side nila at side niya sa isang maayos at patas na paraan," said International Criminal Court assistant to counsel Kristina Conti, who lawyers for some drug war casualties.

"Welcome! 'Yan ang mga katagang binibigkas ng mga pamilyang biktima ng papamaslang sa panahon ni Duterte. Lubos ang aming pag-asa na makamtan ang minimithing hustisya ng lahat ng mga biktima! Panagutin si Duterte!" said Llore Pasco, mother of two drug war victims.

Bishop Gerardo Alminaza of San Carlos noted the need for justice, that the victims and their families deserve truth and reparations. "These killings were not random; they were part of a policy that violated the fundamental right to life. The families of the victims deserve truth, reparations, and justice. As a nation, we must ensure that such crimes never happen again."

For Bagong Alyansang Makabayan president Renato Reyes, Duterte's arrest is a "historic step" to justice and "a blow to the regime of impunity that has been prevalent in the Philippines."

"Impunity cannot be forever, and we see that while the struggle may be long and difficult, the people will always prevail," he said. "Let this event serve as a warning to those who think that abuse of power will remain unpunished."

Human rights lawyer Chel Diokno said the Marcos administration must ensure that "he has nowhere to hide" and sought "no more safe spaces for tyrants."

"For decades, Duterte thought himself untouchable—above the law, beyond accountability. But history catches up with even the most ruthless despots. His reign of terror must meet its inevitable end: his conviction," he said.

Diokno warned that while Duterte's allies could "shield, manipulate, and derail" the process following his arrest, the government "must guarantee full protection" for the witnesses and victims' families, who he said are now at risk of retaliation.

The International Coalition for Human Rights in the Philippines and human rights group Karapatan meanwhile said that there should be no special treatment for Duterte and stressed that the law must be applied equally.

ICHRP noted that there has been a norm for "elite" officials in the Philippines who have "evaded justice through fabricated medical excuses and political maneuvering." With media reports

Living the Word

TO GOD be the glory. On Sunday, March 9, the venerable Apu Ceto turned 88. Reprinting here a piece I wrote on the occasion of his birthday 11 years ago.

AT 77 last Sunday, March 9, the Most Rev. Paciano B. Aniceto is two years past the age of retirement for Church prelates.

That he remains the shepherd of the Kapampangan faithful can only be divinely

Apu Ceto makes that classic definition of the priest that impacted me on my very first day at the Mater Boni Consilii Seminary eons ago - "the best gift of God to men, the best gift of men to God."

He simply lives the Word. So that hearing him is ever a renewal in faith. Like that time in 2003 when I accompanied him in his pastoral visit to California.

"The two priceless treasures of our people, coveted by other peoples... undiminished in value even through our worst economic dislocation," Apu Ceto says of faith and family as the defining character of the Filipino.

Live the faith. Love the family. That was the message he brought to the hundreds of Filipinos who came to his Masses. A message that reached out to, and touched Americans and Latinos too.

'Modernism and materialism, especially in wealthy America, besiege increasingly the very foundation of the Filipino-American family. Against this onslaught, we need to return to our core values and be steadfast in our Christian faith to prevail."

Apu Ceto refreshed the congregations with the Filipino core values grounded on Christian virtues - of respect for human life, love for the elders, the bayanihan culture of sharing and malasakit, and family prayer, especially to those already born in America.

And anathematized abortion and euthanasia as "pillars of the culture of death...high crimes against the family and against God."

"The baby and the elderly are integral elements in the nucleus of the Filipino family. Take them out, fission ensues, and the nucleus suffers a total breakdown."

In a clear jab at the pro-choice lobby in the US: "The baby in the womb is not a simple choice. It is a human being created in God's own image and likeness and therefore should come into the world to fulfil God's plan for him. Man has no business playing God, usurping His power over life and death."

Of love and respect of the elderly: "Filipino culture puts premium in the wisdom of age. Thus, we take good care of our elders, never treating them like overused rags fit only to be shut in some retirement home, left to die alone, and as fast forgotten."

And recalled the attendant promise of a blessed long life for those who subscribe to the Fourth Commandment – "Honor thy father and thy mother" - "so that all may go well with you, and you may live a long time in the land." So, the Apostle Paul wrote to the Ephesians. So, it was written in Exodus 20:12. So it has become Apu Ceto's apostolate too.

And then there was his birthday celebration six years ago - also a Sunday - distinguished - graced, I cannot force myself to write - by the presence of Her Excellency, President Gloria Macapagal-Arroyo, the Reverend Governor Eddie T. Panlilio, Congressman Dong Gonzales, City of San Fernando Mayor Oscar Rodriguez, and a host of other politicians and local leaders.

"If we really pray together, (we would discern that) one cannot monopolize truth. Truth begins in the heart, the sanctuary of our conscience." Apu Ceto's sermon searing the very soul of the congregation.

We need to purify and change. If we follow that process, we will have a peaceful and just society with integrity. You should watch and pray that you don't fall into temptation."

He did not have to say it. Apu Ceto could only mean the temptation of corruptive power for those in government, that which denies the people of their right to live with human dignity.

Warning: "Our country is at a crossroad. We are a divided people, eternally quarreling, bickering. Some media contribute to this. We are falling into the pit." Ouch!

And pointing the way: "We are asking the Lord to permeate every stratum of society. Families and leaders should work so there is a holistic approach in the search for a real, authentic, common good, for the progress and development of our people."

Ora et labora. Pray and work. Christian life at its most essential.

"Let us pray together, discern together so that we could know the will of God for the Filipino people."


He lives the Word. He is a sermon we see, we feel, and - prayerfully - we live. Apu Ceto blessed are we.

Siguro, ang tao parang rosas din-hindi sapat ang maganda at mabango lang siya. Kailangan matinik din. Panlaban daw ng rosas ang mga tinik niya, sa mga ibig sumira sa kanyang bango at ganda. Ganyan din sa tao. Dahil may kalaban tayo na ang laging hangad ay sirain ang likas na ganda at bango ng ating pagkatao, kailangan din natin ng tinik, ng talinong panlaban.

Ito ang nakikita ko bilang napaka-importanteng papel ng Espiritu Santo sa buhay natin sa mundo. Mas gusto ko ang salitang ginagamit ni San Lukas tungkol sa papel ng Espiritu Santo: pinatnubayan daw si Hesus sa pagharap niya sa mga tukso ng Diyablo.

Ang larawan na pumapasok sa isip ko ay isang sundalo na kailangang tumawid sa isang bukirin na puno ng "land mines" na hindi niya nakikita dahil nakabaon sa lupa. Pero may kasama siya na nakapuwesto sa di-kalayuan, nakasilip sa binoculars na nakaka-detect sa mga puwesto ng mga nakabaon na bomba. Ginagabayan niya ang sundalo sa pamamagitan ng walkietalkie para makaiwas ito sa mga land mines na kapag natapakan niya ay siguradong sasabog at patay siya. Ang kasama niya ang nagbibigay ng direksyon sa kanya para makatawid siya nang ligtas.

Naalala ko na si Pope Francis minsan ay

nag-react sa Italian translation ng Our Father, lalo na doon sa parteng nagsasabing "And lead us not into temptation" na sa Italiano ay "e non ci indurre in tentazione" (huwag mo kaming dalhin sa tukso). Parang hindi siya komportable dito kasi sabi niya, hindi naman ang Diyos mismo ang nagdadala o nagtutulak sa atin sa tukso. Mas pinaboran niya ang "e non abandonarci nella tentazione"—na sa tingin ko ay mas malapit sa Tagalog na "at huwag mo kaming ipahintulot sa tukso." Lalong maganda sa Kapampangan ("Emu ke ipaisaul king tuksu." Huwag mong hayaan na kami'y matalo ng tukso.) Wala nga namang ama na kusang magtutulak sa anak niya patungo sa panganib para lang matuto itong magpakatatag o magpakalalaki. Paggabay o pag-alalay ang ibinibigay ng ama sa anak, sa pagharap nito sa mga pagsubok sa buhay.

Ibig sabihin, kung paanong hindi nag-iisa si Hesus sa pagharap sa tukso, gayundin ang pangako niya sa atin na mga alagad niya. Tayo rin ay aalalayan ng Espiritu Santo sa pagharap natin sa mga tukso ng diyablo. Tagisan kasi ito ng talino kaya gumagamit din ng talino ang dimonyo. Women who lead us forward

THE OBSERVANCE of Women's Month is particularly significant in the Philippines where the legacy of patriarchy remains prevalent in this modern day and age. While it is but proper to acknowledge and celebrate the progress that many Filipinas have made as they tirelessly break barriers in fields that remain to be highly dominated by men, it is also imperative to recognize and reflect on the ongoing struggles they face in achieving equality and representation.

According to the World Bank collection of development indicators, women make up 41.48% of the country's total labor force in 2023, one of the lowest in the East Asia-Pacific region. The underrepresentation of women in leadership roles remains a challenge with only 25% of the country's national government positions being held by women according to the Philippine Commission on Women.

Filipino women face deeplyrooted issues of issues of misogyny, harassment, and gender-based violence. These barriers remain prevalent in various fields and industries. and even family structures, where women are often expected to fulfil traditional roles as caregivers while facing discrimination in their pursuit of careers or leadership roles.

However, there are promising developments; and the list continues to rise albeit silently and slowly but steadily. There have been many firsts, but definitely not the last.

Despite receiving much less funding and media attention than their male counterparts, Filipina athletes have shattered expectations and made history. The Philippines saw its first Olympic gold medal won by weightlifter Hidilyn Diaz in 2021. Then we also have basketball star Jack Animam, footballer and national team player Camille Rodriguez, tennis sensation Alex Eala to name a few. These athletes have paved the way for future generations, challenging the norm in a traditionally maledominated field.

One of the most notable achievements in the corporate world is that of Ruth C. Yu-Owen, the first Filipina to head an international advertising firm in the Philippines, Ogilvy & Mather. Her success is a reflection of how women are increasingly taking on pivotal roles in the corporate sector, although many still face gendered challenges in climbing the corporate ladder.

In the global business world, Filipina-American fashion designer Josie Natori achieved global recognition with her highend lingerie brand, The Natori Company. She is a trailblazer in the fashion industry, one of the few Filipinas to create an internationally recognized brand. Similarly, there's Loida Nicolas-Lewis, a Filipina-American businesswoman and philanthropist who became the first woman of color to run a U.S.-based company. Her advocacy for Filipina women's empowerment has inspired

countless women to lead in various industries worldwide.

Two male-dominated institutions, the military and judiciary, have seen the rise of Brigadier General Maria Teresa G. Timbol, the first woman to head the Philippine Army's Civil Relations Service. Former Chief Justice Maria Lourdes Sereno and Justice Teresita Leonardo-de Castro, indeed, Justice Cecilia Munoz Palma, the first woman appointed to the Supreme Court, have broken significant glass ceilings, though female judges still account for only 30% of the country's judiciary.

Nobel Peace Prize awardee Maria Ressa, co-founder of Rappler, has become a global symbol for press freedom, enduring multiple legal charges for her critical reporting against the Duterte administration.



Retrofitting works on 42 bridges along the expressway were completed in 2024, while repairs to the Marilao River Bridge expansion joints will be completed by March 2025.

The city government allotted P55 million for the construction of additional nine primary care facilities in the city.

Inside the newly-opened primary care facilities are dental rooms with dental chair and equipment, consultation rooms, laboratory rooms, physician's rooms,

pantries, storage rooms, and pharmacies with readily available medicines.

Lazatin is also set to inaugurate two more primary health care units in Barangays Tabun and Cutud on March 12.

The 36 TCTs comprised the second batch turned over by the BCDA for the SCMB Railway Project following the initial distribution of 68 certificates in November last year.

Under RA 10752 (Right-of-Way Act), owner of properties affected by a project and the implementing agency shall execute a deed of absolute sale, with the implementing agency facilitating the annotation of the deed of absolute

sale on the TCTs that are legal documents that serve as evidence of ownership of registered land.

The SCMB has a railway alignment of 26.9 kilometers in Porac and Floridablanca, affecting 519 lots in these municipalities. The BCDA has successfully completed the negotiations with 212 lot owners, 163 of which have already received either partial or full compensation.
