Notes from campaigns past

THE CIRCUS, er, official campaign period, has come to town. Incumbents, wannabes, has-beens, and never-bes are just about everywhere and anywhere inflicting themselves upon the hapless electorate.

Time anew to take out of the old baul this piece of 2006 vintage with some updated refurbishing.

You have no money? Dream on running, even winning. It won't cost you a thing. But never wake from that dream and live the nightmare of political realities here.

Even as a candidate, you have already been claimed by the voters to be their personal one-way ATM: no deposit required but ready to dispense cash anytime of the day or night for their power and water bills, cost of hospitalization, expenses for weddings, baptisms and funerals, birthday parties and fiestas, tuition for their kids, even milk for their infants. And yes, loads for their mobiles.

I remember the dearly lamented undefeated mayor of Apalit Tirso Lacanilao who, in one campaign sortie, was asked by a constituent for money to pay for the hospital bills of his wife.

Tirso was already fishing out P500 bills from his wallet when he happened to ask what caused the wife's hospitalization.

"Menganac ya pu," came the reply.
"Putanaydamo," raged Tirso. "Anyang magpacanyaman cang gagawan me ing anac mu e mu na cu man cayabe. Oba't ngeni cacu mu papabayad ing cayang pamanganac?" Classic Tirso.

You have money? Use it wisely.

Find some free lessons in this costly experience of a board member who ambitioned for a House seat in the 2004 polls.

Well beyond a year to the elections, BM was already crowing that P30,000 was doled out daily to his needy constituents even before the cock crowed in the morning. Into the campaign period, BM upped the ante to P50,000 per day. Still, he ended up in the kangkungan against one whose win earned him the title "Con-doctor."

His 2004 experience unlearned, BM did the same route in 2007, upping his daily doles to P70,000,

only to be picked out of the pansitan against one "Cong-tractor."

A dilemma: Identified as a generous giver in elections past, BM stands to lose a lot of the ground he covered in 2004 and 2007 if he tightens even just a bit his publicly-perceived-as-enormous campaign chest. Dati kang nagbibigay ng tig-500, bigla kang magbibigay ng tig-100, magiging masama ka pa sa iyong binigyan.

The flash of wealth is more a liability than an asset. Still remember Don Pepito Mercado? Throwing money like there's no tomorrow, the Don soared in the people's imagination as a mighty, invincible eagle in 1994 only to be reduced to a pitiful pipit in the 1995 gubernatorial polls. Principally because he just stopped being outlandishly generous at the time it counted most - in the middle of the campaign period.

Being official candidate of a party, even of the party in power is no sure-fire guarantee to victory.

In 1992, Marino "Boking" Morales did the unprecedented: He was the official candidate of the two dominant parties at war for the presidency. President Cory Aquino and candidate Fidel V. Ramos of Lakas-NUCD graced Boking's proclamation rally. At Boking's miting de avance, it was candidate Ramon V. Mitra that anointed him as the main man in Mabalacat

Dr. Catalino Domingo of the NPC drubbed Boking mightily. Thereafter, Boking though has done more unprecedented things. Like sitting as mayor beyond double the term limit, ultimately unseated only in 2017 ruling all of 22 years. His attempt for a comeback in 2019, albeit for the vice-mayoralty, ended in a drubbing by his own kin.

In some twist of irony, Boking's favorite whipping boy Anthony Dee's no-retreat-no-surrender mantra may have rubbed off on him as Boking tried a

Women on the Frontlines: Defenders of the Air Defense Command

IN CONTEMPORARY times, all professions aim to uphold gender equality, and the military is no different. Contrary to the age-old perception that air defense is a male-dominated field, the women of the Philippine Air Force's Air Defense Command (ADC) are steadily rewriting history. As part of the 2025 National Women's Month Celebration, we honor the resilience, dedication, and unrelenting commitment of these women who stand on the frontlines, upholding the security of our skies and the sovereignty of our country.

In line with the sub-theme "Babae sa Lahat ng Sektor, Aangat ang Bukas sa Bagong Pilipinas," we pay tribute to the special contributions of female soldiers in air defense operations. Their deployment to command and control centers, radar sites, and intercept units underscores that defenders are not measured by physical strength alone but by discipline and adaptability to evolving technology. The primary challenge of air defense is the real-time assessment of threats, requiring concentrated attentiveness and technical ability. These considerations have not deterred our female soldiers; they have demonstrated exceptional competence and have been active contributors to national defense. Their remarkable ability to think critically and remain composed in high-pressure situations significantly strengthens the PAF's role in safeguarding our skies.

Vigilance and prompt decision-making are paramount in air defense. Female soldiers within the Air Defense Command fill crucial positions as fighter pilots, air battle managers, air weapons controllers, missile system officers, radar operators, intelligence analysts, and aircraft maintenance technicians. They defend our skies, interpret threats, and maintain seamless coordination of aerial operations. Their strength and expertise continue to elevate the standards of air defense, proving that courage and skill

know no gender.

Notably, the PAF has made significant strides in integrating women into various roles traditionally dominated by men. In March 2022, 1LT JUL LAIZA MAE CAMPOSANO-BERAN PAF, now serving as captain, was introduced as the PAF's first-ever female jet fighter pilot. She is recognized as a combat mission-ready pilot and wingman on the SIAI-Marchetti AS-211 jet and serves with the 5th Fighter Wing at Basa Air Base in Floridablanca, Pampanga.

CAPT. PREXYLEE P DOMIN-ONG JAGS made history as the first PAF Judge Advocate General (JAG) officer to qualify as an air weapons controller for Air Defense Operations. This milestone underscores the vital role of legal officers within the battle staff of the Air Force's Air Defense and Air Operations Centers. By undergoing specialized training in air battle management, JAG officers gain invaluable insight into the complexities of the PAF's Air Defense mission, particularly in operations within the electromagnetic spectrum. This integration enhances their ability to provide legal guidance in high-stakes, real-time operational environments.

During the 77th PAF anniversary celebration at Basa Air Base on July 2, 2024 the female soldiers of the 960th Air and Missile Defense Group took center stage, serving as missile

Are vloggers journalists?

DURING THE March 21 House tri-committee hearing on the spread of fake news and disinformation, three prominent social media personalities and vloggers underwent intense grilling from lawmakers and were forced to apologize for making "sensationalized, baseless claims."

Manila Bulletin Lifestyle section editor Krizette Laureta Chu, vloggers MJ Quiambao Reyes, and Mark Lopez were among the 11 people invited by the House tri-comm which is composed of the committees on public order and safety, information and communications technology, and public information. Those invited as resource persons initially snubbed the first hearing and went to the Supreme Court with a petition to stop the probe.

By definition, vloggers are individuals who create and share videos that often feature their personal opinions, reviews, or even experiences. At a glance, they appear to deliver news-like content. However, a closer scrutiny will make one realize that the difference is simply glaring when it comes to accountability.

Journalists are bound by established ethical standards, professional codes of conduct. and the editorial oversight of news organizations. They are expected to verify information, provide balanced reporting, and distinguish between fact and opinion. When a journalist commits even an iota of mistake, there are consequencesretractions, corrections, and sometimes even legal actions can follow. All these are aimed at maintaining public trust and credibility.

On the other hand, vloggers often operate in a more informal, unregulated space. While some may adhere to personal codes of conduct, many work independently without any external editorial control. This lack of oversight simply means they are not held to the same standards of accuracy and accountability.

When they spread false information, there are few, if any, direct consequences, leaving their audiences vulnerable to manipulation.

The stark difference becomes clear when examining how these vloggers have used their platforms to spread fake news and misinformation, potentially manipulating their vast audiences. This results to their ability to wield significant power over public opinion because they are able to shape narratives without any form of accountability.

In the midst of the learning gaps and difficulties that educators all over the country have seen, experienced and proven to be a pressing concern among Filipino learners, the spread of false news and fake information is not just irresponsible; it is immoral. It

preys on the vulnerability of individuals who may lack the resources to critically evaluate such claims.

Without a doubt, the digital era has changed how we consume news. When digital platforms are increasingly relied upon for news, the consequences can be severe. In a study conducted by Rappler in 2019, data showed that nearly 70% of Filipinos rely on social media as their primary news source. If that content is filled with falsehoods, it can mis-educate and mislead communities or even an entire nation. As a result, a false information conveniently protected by the word "daw" can sow division, and even spark violence.

The ongoing House tricomm on the spread of fake news is a reminder that no one is above scrutiny and the proliferation of false information in any platform must be addressed. At the same time, the government must be cautious not to cross the line into stifling freedom of expression. Striking this balance will require establishing clear boundaries where vloggers are held responsible for their actions, but without infringing on their right to speak freely.

Make no mistake, vloggers are not journalists. They do not operate under the same ethical obligations. While holding them accountable is vital for the integrity of public discourse, it must be done in a way that respects democratic freedoms.

I hope for that day when Filipinos are able to choose, acknowledge, embrace, champion and protect responsible journalism over reckless content creation.

Linemen and telco crews worked together to systematically remove non-operational bundled wires that posed safety hazards and placed unnecessary strain on electric posts.

CDC maintains Clark Freeport as major national economic catalyst

Gov. Ebdane eyes 'future-proof' Zambales

BOTOLAN, ZAMBALES — Leaping over limitations in the past and seizing opportunities in the present, Zambales is now poised to become a "future-proof" province, said Gov. Hermogenes Ebdane Jr. in his State of the Province Address (SOPA) at the People's Plaza here on March 27.

The governor said his administration has revitalized income generation and boosted economic recovery in the past three years, thus enabling stronger public services, building more social infrastructure, and promoting sustainability for Zambaleños.

He added that despite past challenges, Zambales recorded more than P1.2 billion in local income in 2024 alone, mobilized P2.6 billion for infrastructure development, and distributed more than P341.8 million in social services, mostly for poor families and

Before this, Zambales faced limited revenue stream, scant opportunities for economic growth, political indifference, and very little grassroots participation, Ebdane pointed out.

"We inherited a Zambales filled with promise, but burdened by setbacks and limitations," Ebdane recalled. "The turning point came when we stopped waiting for



change and started becoming the change."

Ebdane said the provincial government took bold measures to revive revenue generation. These included a strategic river rehabilitation and restoration program that also earned income from collected Pinatubo debris that choked river channels, improving the quarrying network, and ensuring proper revenue collection.

Thus, with local revenue climbing from 2020 to 2024, Zambales earned its classification as a firstclass province in 2023, Ebdane said.

At the same time, the provincial government built

engines of economic growth: the Zambales Mango Industry Council that launched the P50-million Zambales Mango Green Valley Project to boost local mango production, and the Zambales Maritime Development Council that helped organize the Zambales Provincial Fisherfolks Association to promote modern fishing practices and ensure sustainable growth.

'We did not wait for investments; instead, we created it," Ebdane pointed out. He said the agriculture and fishery groups created will serve as economic

The cumulative total is broken down to: P1.3 billion in 2019, P99 million in 2020, P864 million in 2021, P163 million in 2022, P1.1 billion in 2023, and P1.3 billion in 2024.

Among the major infrastructure projects are the rehabilitation of the Pampang Public Market; the construction of the Rafael Lazatin Memorial Medical Center Annex Building (Phases 1 and 2); the construction of the material recovery facility; the construction of the Kanlungan ng Kabataan; the construction of a waste water treatment facility; the construction of the Bale Pusu Home for Abandoned

Elderly: and the rehabilitation and improvement of rural health units.

Other infrastructure works undertaken by the Lazatin administration include the construction of additional niches at and rehabilitation of the Angeles City Public Cemetery; the rehabilitation of the city pound and animal shelter; the improvement of facilities and construction of an additional floor at the City College of Angeles; the rehabilitation, improvement, and construction of additional classrooms, facilities, and buildings in various public schools; the improvement of alternate evacuations centers and construction of slope protection along Abacan

comeback anew - for the mayorship in 2022. This time facing a more formidable opponent other than his nemesis, incumbent Mayor Cris Garbo, in his own former factotum Deng Pangilinan. Boking lost.

Barangay chairmen are prized - and highly-priced acquisitions in elections. But like the party, they are no foolproof certainty to winning.

In 2004, Andrea Dizon-Domingo thrice paraded before the members of media 28 of the 33 barangay chairmen of the City of San Fernando as her committed campaigners.

She ended third placer to eventual winner Oscar S. Rodriguez who had no barangay chairman other than Do Santos of San Agustin in his corner.

Channeling Madame Didi, Dolores village chief Vilma Caluag was accompanied by a number of the 24 barangay chairmen purportedly already in her deep pockets when she filed her COC for San Fernando

mayor in 2019. Lightning struck twice with women contesting the mayorship of the capital city.

At her filing for the city mayorship anew last October, Madame Vi was accompanied only by her family.

From organization, let's shift to tactics.

The early bird does not always get the worm. Sometimes, because of his over-eagerness read: gagad - he gets to be shot first.

Think Pampanga First District in 1998 here. The first pretender to the throne being vacated by Cong Tarzan Lazatin was businessman Beko Panlilio. Ah, how the barangay captains swarmed around him from late 1996, only to lose them to "Cong Rey" Guiao, whose own campaign sputtered when Atty. Ed Pamintuan left the Angeles City Hall for the district. Of course, it was EdPam's vice, Blueboy Nepomuceno who went on to win.

The early bird gets to be fed first to the hungry mob. Heed the Kapampangan

adage here: Tauling kabit, manu. Last comes first.

Opinion polls are another matter to take real care of. Believe in published surveys at your own peril. There I go again.

In 2007, an alleged survey allegedly commissioned by the provincial government alleged that then-3rd District Rep. Rey Aquino in his comeback bid for the San Fernando mayorship led the incumbent Mayor Oscar Rodriguez 60-40.

So, what's new here? Oca never won in any published survey since he entered politics at that point. Conversely, he had won all but one – 1992 – electoral contests he joined: 1987, 1995, 1998, 2001 congressional races, and the 2004 mayorship.

And in 2007, Oca drubbed Rey to the tune of over 16,000-vote margin. Same margin of error placed in that alleged survey most certainly.

It was only in 2016 that the surveys proved correct the incumbent Cong Oca losing to the man he beat in the same contest in 2013, his inaanak Dong Gonzales.

Like Oca, another one who never won in any survey but won all elections he entered is Cris Garbo of Mabalacat - as councilor twice, board member three times and vice mayor once. And board member again in 2007, 2010 and 2013.

So, Garbo lost – to Boking Morales as projected by the surveys in 2016. So, who's been the mayor of Mabalacat since 2017 to date?

Surveys are meant to serve as campaign guideposts. Their efficacy for propaganda purposes to gain some bandwagon effect - have long been lost because of surfeit and the incredibility of results.

Have you read of any published local survey citing its margin of error? If you have, did they tell you how they arrived at it?

End of lesson for now. Keep on running, dream on winning.

anchors and engines to propel development in communities.

Under social services, Ebdane said the provincial government upgraded facilities in the four government hospitals in the province; broadened educational assistance to encompass elementary, high school, and graduate students; and provided livelihood support like agricultural grants, farming implements, fishing equipment, and skills training, especially to those adversely affected by the Covid-19 pandemic.
