ITY OF SAN FERNANDO – Notwithstanding the stunning loss in this capital city, Pampanga firmly remains a Pineda stronghold.

With 99.72% of the election returns transmitted as of 5:45 a.m. on May 14, the already proclaimed governor-elect VG Lilia "Nanay" Pineda garnered 707,782 votes against rival Danilo Baylon's 475,200. Of Pampanga's two component cities and 19 municipalities, Baylon won only in his Candaba hometown, beating Pineda by 8,053 votes.

In the vice gubernatorial race, incumbent Gov. Dennis "Delta" Pineda swept all towns and cities with 748,782 votes against former Gov. Ed Panlilio's 385,926.

Under the Pineda banner, mayors in the towns of Apalit, Bacolor, Macabebe, Minalin, and San Luis ran - and naturally won - unopposed, further solidifying their political dominance over the province.

Comelec: Elections in CL 'very orderly, very peaceful'

CITY OF SAN FERNANDO -- The Commission on Elections has declared the 2025 national and local elections in Central Luzon as "very orderly and very peaceful," noting the absence of major incidents and only minor technical glitches.

"We are pleased to report that the conduct of elections in Central Luzon has been very peaceful and very orderly. We thank all the voters for their patience and discipline, and most importantly, for coming out to vote and exercise their right to suffrage," Comelec assistant regional election director Elmo Duque said.

He reported that electoral boards and Department of Education supervising officials remained in polling centers after the voting hours to finalize tasks, including printing and posting of election returns (ERs), generating audit logs, saving backups, and reviewing ballots before machines were shut down.

Comelec also addressed concerns about defective machines, noting that only 49 out of 9,584 automated counting machines (ACMs) were reported damaged, which is just 0.445 percent.

These include 18 from Pampanga; Bulacan – 13; Tarlac – 12; Zambales – three; Bataan—two; and Aurora – one.

Duque assured that contingency machines were deployed swiftly to affected areas, minimizing delays.

"In Kaingin, Mey-



cauayan [Bulacan], we had to place ballots in a secured container while waiting for a replacement machine, but the voting resumed shortly after," Duque explained.

He also emphasized that no major disruption occurred during the elections. "There was a reported commotion in a barangay in Magalang, Pampanga, but it happened outside the polling place and did not affect the conduct of the elections in any manner," he clarified.

Duque said the

improved logistics of ACMs and the faster printing of ERs allowed some proclamations as early as 10 p.m.

Duque likewise appealed to the public to respect the election results and work towards unity.

"Thank you to our candidates for making this election peaceful and credible. We hope that everyone accepts the will of the people. Whoever wins, let us support one another for the good of our nation and our local government units. From this day forward, let us begin rebuilding together," he said. *Marie Joy S. Carbungco/PIA-3*

Move forward together for the nation's good

IN A bold gesture of peace, President Ferdinand R. Marcos Jr. has called on all newly elected officials to unify and "move forward together" for the nation's good.

"Governance is a shared responsibility, a mission that requires unity and burden sharing for the common good," Marcos Jr. said in a statement.

"To the newly elected, regardless of party or coalition, I extend my hand. Let us move forward together-with open minds and a common purpose," he added.

A day after the May 12 midterm elections, the chief executive said newly elected officials were put into office by the electorate to face the task head-on and listen to and act on the people's daily burdens, including inflation, jobs, and corruption.

"Public service goes beyond elections. The work of nation-building needs all who are ready to serve," he noted.

Quoting the rallying cry for unity by his late father and namesake, Marcos Jr. said, "If we are to prevail, we must prevail as Filipinos-for it is the only way to endure. If we are to attain our goals, we must march forward, not to the past but to the future."

"And we must do this as one family, a nation united," the president echoed his father's words.

At the same time, the president thanked all Filipino people who braved long lines, high temperatures, and intense heat to cast their votes in the midterm elections, which he described as a renewal of democracy.

"Maraming salamat sa bawat Pilipinong bumoto. Once again, our democracy has renewed itself—peacefully, orderly and with dignity," the president said.

The May 12 elections were "both a celebration of continuity and a call to act on the real challenges our people face," noted Marcos Jr.

He also thanked those who supported the administration's "Alyansa Para sa Bagong Pilipinas" candidates.

"We may not have won every seat, but our work and mission continue," the president said. "The work of nation-building needs all who are ready to serve."

On the eve of the May 12 elections, the president urged Filipinos to exercise their right to vote responsibly and protect the integrity of

After the losing

WE WUZ robbed. True or not, losers still lost.

As there's nothing you can do to undo what's done, may as well accept it, with all graciousness, with all humility. And go into some introspection, into reflection over the might-have-beens - no, not to sulk and wallow in blaming and self-pity, but to find the resolve to do much better for the next run. It's only three years away, you very well know.

To that end, what I have long proffered as post-election prescription for the solace of the hurting also-ran is this rumination of Pulitzer Prizewinning The New York Times columnist William Safire in his The First Dissident subtitled The Book of Job in Today's Politics, thus:

IS SUFFERING a defeat good for a political person? The run for office is a short run, and the loser is not likely to find comfort in talk about the long run. But can rejection at the polls be fairly presented as what condolencebearers sardonically call 'a character-building experience'?

Yes, and yes. And the dearly lamented Carmelo F. Lazatin, better known as the Tarzan, exemplified it.

Tarzan lost in his very first try for an elective post - mayor of Angeles City in 1980.

Losing an election early in a political career is deemed constructive. As Safire says, "a therapeutic trouncing introduces a little real humility into candidates who must at least profess humility."

Though not exactly a long shot in the 1st District congressional contest in 1987 - he was the beatific Cory's choice, after all – Tarzan managed to squeak through victory – by a plurality of less than a hundred votes against his closest rival, if now-selective memory still serves right.

Tarzan rolled through victory after victory thereafter - three terms in the Lower House, notwithstanding his being derided as the chair of the comite de silencio at the camara de representante; first ever city mayor to serve three terms; back to Congress in 2010.

He lost in his comeback bid for the mayorship in 2013 and was readily consigned to the dustbin of the political has-beens. Only to resurrect - by proxy - in 2016 with the masterful crafting of the twin victories of his namesakes - Carmelo Jr. aka Pogi, and Carmelo II aka Jon - at the city council, and in the first congressional district, respectively.

Contrary to all expectations, aye, in direct defiance of age and health, Tarzan won the chairmanship of the city's premier barangay of Balibago in 2018.

It was to be Tarzan's final yell, succumbing to cardiac arrest over the ravages of age seven months later.

But not his last hurrah – if only from the grave - with the definitive victory of Pogi as hizzoner of Angeles City, and the impressive re-election of Jon as Pampanga 1st District representative in 2019. Even more definitive victories for both in 2022: Pogi as first ever city mayor to garner over 100,000 votes, Jon unopposed.

Going on to their successful switch in 2025: Pogi running unopposed for the 1st District; Jon trouncing a former police general for the city mayorship.

The sons handling contemporaneously the positions held by the father one after the other. What greater political legacy than this?

Tarzan could not have known it but what Safire called the "law of political return" impacted upon him, ingraining him with the "comeback quality."

Qualified, thus: "Defeat, if it does not destroy them, tempers leaders. After reaching deep within for internal resources, they can rightly claim to have grown as a result of what the voters have taught them. In the art of comeback, one lesson is not to insist that voters admit they were wrong last time, even if their choice of candidates turned out to be inept or corrupt in office. On the contrary, the putative comebacker should compliment the electorate on having been right in spotting his own shortcomings in policy or personality or presentation, which have been corrected - with no compromise of principle, of course. Last time losers should assert with pride that they have learned enough to become next time's winners." Else, they stop running altogether. And stop



Mother of Good Counsel

WE'RE USED to giving each other little souvenirs, especially those who become our friends in the College of Cardinals. Like, there was this Cardinal from Latin America who gave away *stampitas* of St Oscar Romero. I asked for an extra copy if he had more to spare because the martyred archbishop Romero is my favorite saint.

There was one little gift that stood out for me, however. The giver did not even bother to identify himself. It was a stampita of the icon of the Mother of Good Counsel. I treasured it because I happen to be an alumnus of Mother of Good Counsel Seminary. I even took a photo of it and shared it immediately with my former classmates at Mother of Good Counsel Seminary in San Fernando Pampanga. Then I kept the photo in the pocket of the red cassock which I wore inside the Sistine Chapel.

During the silent casting of votes-which took at least an hour and a half at each time because we had to individually make an oath in Latin before putting the ballot on a silver plate and sliding it into a basin that looked like a flying saucersuddenly, I had the urge to sneeze so I quickly slid my right hand into my cassock's pocket only to realize that my handkerchief was not there; what my hand felt instead was the stampita. I took it out of my pocket and lost the urge to sneeze. I flipped the icon and found written on its back the prayer of St. John Paul II to the Mother of Good Counsel and prayed it in Italian.

At the bottom of the prayer,

I found some information about the origin of the stampita. It had come from the Santuario della Madonna del Buon Consiglio in Rome. I even said to myself how very nice of the Cardinal who gave us this little gift to remind us to commend our solemn act of choosing the next pope to the intercession of Mama Mary.

After Cardinal Prevost got elected as Pope, the news came out that the first Church he visited in Rome was the Sanctuary of Mother of Good Counsel! And lo and behold, who would meet him at the door-the rector of the shrine who was his brother in the Augustinian Order, whose superior general he was for two terms. When we lined up to greet him immediately after the conclave, I said to him in English, "Holy Father, I hope and pray that you get to visit us in the Philippines. 
When the trivia about the new Pope's background began to circulate in the social media, I learned that he became the provincial superior of an Augustinian province that was

What if the qualifications for public office were more stringent?

Currently, many candidates ascend to power with minimal experience or questionable backgrounds. Proposals to ban political dynasties have been repeatedly side-lined by the same lawmakers who would be the first casualties of an anti-dynasty law. Just imagine this: 80% of governors, 67% of House representatives, and 53% of mayors came from political dynasties. This is based on a study conducted by the Ateneo de manila University back in 2019. Without a doubt, this has not changed at all this year and probably has gone even worse.

If those running for public offices were required to pass the country's Career Service Examinations, hold at least a bachelor's degree, have at least three years of relevant work experience in government, have negative police or NBI record, we might just be able to limit the wannabe *honorables* from the barangay level all the way to Malacañang.

What if voters, young and old, made informed choices?

Voter education remains a pressing need, as many still elect candidates based on popularity or superficial appeal rather than competence and integrity. We have seen the results of mock elections in colleges and universities all over the country. None of the senatorial candidates from Team Kadiliman and Team Kasamaan made it to the winning circle and candidates from the local political dynasties were rejected outright. Sadly, this is not replicated in the national level. It appears that the supposed informed voters are outnumbered by the masa voters who are easily swayed by a one-time *ayuda* than an agenda anchored on long-term reforms and good governance.

What if campaign spending were limited?

The 2025 elections saw candidates like Camille Villar and Imee Marcos spending exorbitant amounts on advertisements, overshadowing grassroots contenders. I actively campaigned for the likes of labor leaders Atty. Luke, Ka Leody and Sonny Matula, for grassroots and environmental advocates Ballon and Ramos, and for sectorial representatives Castro, Brosas, Maza and Casiño. Almost always, the response I get is "Ninu ren? Ali ku la man balu." That is the moment when I sit down and introduce these candidates who have long been at the forefront of working tirelessly for genuine reforms in the country.

To ensure transparency and accountability, there have been calls to make the Campaign Finance Office a permanent entity and to review campaign finance laws. But over the years, no winning or losing candidate has ever been charged with any offense on early campaigning or over spending.

What if vote-buying were eradicated?

Despite being illegal, votebuying persists, with reports of candidates offering substantial amounts to secure votes. Despite the efforts of the COMELEC's Committee on Kontra Bigay to monitor and prosecute such offenses, erring candidates are able to circumvent the law and wiggle their way out of the cases filed against them.

What if the youth became catalysts for change?

With millions of young voters entering the electorate, their active participation and demand for accountability could drive significant reforms. I saw a video where a young student sent a Villar campaign shirt that was thrown at her during a motorcade back to the man on top of a pick-up. I could only guess that this was one voter who was tired of political dynasties or one of those affected by the inefficiency of PrimeWater. In any case, she made a strong statement.

The possibilities are vast. But for these "what ifs" to materialize, it requires a collective effort from both the electorate and policymakers. Only then can we hope for a political landscape that truly serves the people.

FROM PAGE 1 first ran and won as governor in 2010 and was re-elected three years later.

Meanwhile, incumbent Vice Gov. Jacqueline Khonghun (Lakas), garnered 279,807 votes. Khonghun, who was Ebdane's running-mate in the last two elections, ran unopposed this year.

Khonghun's brother, incumbent Zambales 1st District Rep. Jay Khonghun (Lakas), was also unopposed and re-elected with 160,887 votes.

In the 2nd District, another Ebdane ally, incumbent Rep. Doris "Bing" Maniquiz (Lakas), won another term with 173,0743 votes (68.41%), beating the 79,928 votes (31.59%) for former 2nd District Rep. Cheryl Deloso-Montalla who ran under the Nationalist People's Coalition (NPC).

Candidates from the SZP also dominated the polls in the 1st District, easily taking

over the three seats for the provincial board without any opposition. They are Cecil Felarca-Rafanan, with 68,244 votes; Ike Delgado, with 64,243; and Elmer Tumaca, 57,734 votes.

In the 2nd District, the SZP also lorded it over by gaining six seats out of seven. The winning aspirants are: Rundy Ebdane, with 158,804 votes; Reena Mae Collado, 137,615; Samantha Ablola, 123,806; Jim Abasta, 110,623; Eric Matibag, 100,127; and Reynaldo Tarongoy, 86,847 votes.

The only non-SZP winner for the provincial board in the 2nd District is Jury Deloso (NPC), who ranked fourth with 112,502 votes.

Interestingly, Jury Deloso, a nephew of former Gov. Amor Deloso and erstwhile Ebdane rival, ran under the SZP banner in the 2016 elections and won the top board member slot for the 2nd District.

Gov. Jose Enrique Garcia III, brother Rep. Albert Garcia of the 2nd District who ran unopposed, and sister Rep. Maria Angela Garcia of the 3rd District, led the proclaimed winners.

The incumbent governor was reelected with 388,011 votes, defeating his opponent Estrella Santos who garnered 49,237.

In the 1st District congressional race, unopposed Atty. Antonino Roman III was proclaimed the winner with 114,677 votes. He is the brother of incumbent Rep. Geraldine Roman, who was in her third and last term.

In the 1st District, all the Pineda allies registered triumphs.

Unopposed for the congressional post, Angeles City Mayor Carmelo "Pogi" Lazatin still managed to get 262,517 votes.

In Mabalacat City, the Atty. Geld Aquino-Marcos "Jun" Castro team-up upended the popular tandem of incumbent Mayor Cris Garbo and his daughter Win-win. Aquino had 69,244 votes against Garbo's 50,822.

Magalang Mayor Malou Paras-Lacson with 37,406 votes won anew against former Mayor Romy Pecson with 28,634.

Second District

In the 2nd District, the Pineda hometown of Lubao remains in the family's keeping: daughter Esmie Pineda reelected with 58,657 votes against contender Salvador Dimson Jr's 15,208.

Guagua Mayor Tonton Torres was reelected with 38,819 votes drubbing former Mayor Dante Torres' 13,681.

Reelected too was Sasmuan's Lina Bagasina Cabrera with 12.677 votes against Charito Montemayor's 7,781.

The district produced two new mayors:

Floridablanca's Michael Galang winning with 26,713 votes against

Sta. Rita's Reynan Calo with 14,256 votes beating incumbent Art Salalila with 10,543.

In Porac, POGO-infected incumbent Mayor Jing Capil won with 39,939 votes against Mike Tapang's 23,063. Even as Tapang was backed by the Pineda patriarch, Capil did not decamp to their rivals.

Third District

The City of San Fernando made a defiant stand against the Pinedas with Mayor Vilma Balle-Caluag entering into an axis with Baylon and Panlilio.

Caluag's Team Laban San Fernando's 12-0 rout of Mylyn Pineda-Cayabyab's ticket, punctuated by the incumbent's 127,124 votes against the challenger's 49,061, did indeed impact heavily on the perceived political invincibility of the Pinedas in Pampanga.

However, the blow mattered little, if any, to the race for the Capitol. Nanay still managing to get 86,348 as against Baylon's 84,229, and Delta snagging an even higher 89,349 vis-à-vis Panlilio's 77,384. This despite the programmed demonization of the Pinedas in the capital city from Day One of voter's registration.

In Bacolor, unopposed Mayor Diman Datu and

responsible for leading a company, making major decisions, and overseeing its overall operations.

Qualification (Education, Experience, Professional License, Skills Certification, Specialized Training):

Vice Mayor Ron Dungca are dyed-in-the-wool Pineda men.

In Mexico, incumbent Mayor Ruding Gonzales (46,487 votes) and opponent Arch. Alex Tumang (37,168 votes) were Pineda supporters both.

The same held in Sta. Ana, the Pineda patriarch's open support to eventual mayoralty winner Dinan Labung (17,314 votes) did not push also-ran Banung Barro (11,757 votes) out of the Pineda orbit.

In Arayat too, triumphant Jeffrey Luriz (38,765 votes) keeping the Pineda mother-son tandem in all his campaign collaterals, even with Delta joining losing incumbent Mayor Madir Alejandrino (7,098 votes) in her campaign sorties.

Fourth District

Unopposed Mayors Jun Tetangco of Apalit, Philip Naguit of Minalin, and Jay Sagum of San Luis even before the campaign period already joined Delta in his various service deliveries in the province.

Even as Nanay lost by 8,053 votes to Baylon in his Candaba hometown (her 31,171 against his 39,222), incumbent Mayor Rene Maglanque trounced Baylon's wife Aniway anew, 40,267 to 26,438. Her votes even 630 lower than those she got in their first contest in 2022. Maglanque's on

the other hand increasing by 1,073.

Unopposed Macabebe Mayor Leonardo "Bobong" Flores has long proven himself to be a die-hard Pineda ally, dating to the early days of Nanay as Lubao mayor.

By design, perhaps, of the rivals themselves, the political heat that obtained in San Simon did not reach the provincial level. While the eventually reelected Mayor JP Punsalan (18,114 votes) was all over the Pineda campaign, also-rans Dading Santos (17,581) and Rommel Bondoc (2,281) did not display any sympathy for the Baylon-Panlilio tandem.

In Masantol, openly Pineda-backed Dan Guintu successfully made a comeback to the mayorship he held for three terms, his 19,673 votes beating incumbent Mayor Ton Ton Bustos's 16,193.

In Sto. Tomas, all three contenders carried the Pinedas in their campaign materials. Of utmost significance is the support for the Nanay-Delta tandem of incumbent Mayor Johnny Sambo, famously loyal acolyte of Panlilio since his time as the town's parish priest. Sambo's 11,892 votes ensured his reelection bid against Raymond Ronquillo's 9,593 votes, and Matias "Bong" Pineda's 7,869 votes.

Only Vilma

In a headcount of the chief executives of Pampanga's 19 municipalities and two cities, only the capital city's Mayor Vilma Balle-Caluag stands outside the Pineda line.

Quo vadis, Baylon? Et tu, Panlilio?

Where go Baylon and Panlilio now? Each has twice been beaten for the governorship of Pampanga.

Panlilio who has kept the reverential "Among" despite the suspension of his priestly faculties was avalanched with votes in contests with Nanay in 2010 and 2013. His being declared winner by the Comelec in 2007 even negated by the proclamation of Nanay as "true winner" via electoral protest shortly before the 2010 elections. The one who once went by the moniker "Anak ng Ama" (Barabbas in Aramaic) losing to Delta in 2022 and to Nanay in the election just past. In each instance getting no higher than 41% of the vote. For the hopelessly hopeful, 2028 is already on the horizon and, as it's cliched, third time's the charm. Maybe, just maybe, all Baylon has to do is consult his wife Aniway for omens. Wasn't she bruited about as being possessed -- sinasapian, sinasaniban? - by the Virgin during her preachings? Who knows, Baylon may just do a Vilma in Pampanga.
