Engineered to convert wastewater into clean, reusable water, the facility is expected to significantly reduce water pollution from the public market. Treated water

ANGELES CITY — With just two weeks to go before leaving the city mayoralty to assume the Pampanga 1st District congressional post, Mayor Carmelo "Pogi" Lazatin Jr. continues to fulfill his dedication to public health by opening the city's 8th Puso Center Primary Care Facility in Barangay Capaya on June 17.

"Even as my term ends, my commitment to Angeleños' health remains. Delivering essential services to our communities is a responsibility I've upheld to the very last day," Lazatin said.

This latest facility marks the eighth of nine primary care centers promised by Lazatin during his 2024 State of the City Address. Additional centers have already been completed and inaugurated in Barangays Pulungbulu, Tabun, Pulung Maragul, Cutud, Malabanias, Anunas, and Amsic.

DOH raises awareness amid rising HIV cases in CL

CITY OF SAN FERNANDO -- The Department of Health Central Luzon Center for Health Development (CLCHD) is ramping up its call for awareness, early testing, and prevention as the number of human immunodeficiency virus (HIV) cases continue to rise in the region and nationwide.

DOH CLCHD Infectious Diseases Cluster OIC Angelica Joy Diaz reported that the number of new HIV diagnoses in the Philippines has significantly increased from just one case per day in 2008 to 57 new cases per day in 2025.

"Region 3 ranks third in the country with the highest number of HIV cases from January to March 2025," Diaz said, emphasizing

that HIV remains a growing public health concern affecting many communities.

Nationwide, the total number of people living with HIV (PLHIV) is projected to reach 252,800 by the end of 2025.

Despite ongoing public health interventions, Diaz said significant gaps remain in achieving the Joint United Nations Programme on HIV/AIDS 95-95-95 goals.

Only 55% of PLHIVs are aware of their status. Among them, 66% are receiving antiretroviral treatment, and only 40% of those on treatment have achieved viral suppression.

These numbers highlight the urgent need for early diagnosis, continuous treatment, and public education to stop the spread of

of those affected," she said.

The data also reveals that nearly half or 47% of new HIV cases come from individuals aged 25 to 34, while 33% are between 15 to 24 years old.

Alarmingly, there is a two to four year gap between the onset of sexual activity and protective measures such as condom use and HIV testing among men who have sex with men and transgender women.

With this, the DOH CLCHD continues to call on communities to remember those lost due to AIDS, support PLHIVs, and take the lead in fighting stigma, discrimination, and misinformation.

As part of ongoing efforts, the health depart-

HIV and improve the lives ment is also reinforcing its prevention messaging which include abstinence, being mutually faithful with an uninfected partner, using condoms consistently and correctly, avoiding sharing needles or syringes, and getting tested early and regularly.

"Knowledge is the first step against HIV. By knowing your status and accessing treatment. people living with HIV can stay healthy and prevent transmission because 'U equals U' or undetectable means untransmittable," Diaz stressed.

'On probation'

THE ENTIRE government bureaucracy is "on probation" and that it should not be "business as usual."

Thus, President Ferdinand R. Marcos Jr. reiterated his earlier pronouncement in the first part of the BBM Podcast Episode 2 which aired on June 16, stressing that anyone who fails to perform well will be required to leave the service.

"Sa military kapag sinasabi, ito yung gagawin mo. Pag hindi mo (nagawa), o anong nangyari? Hindi ko nagawa kasi ganyan. Out. You're relieved. Next. And that's what we should do," the president declared.

"We have to be very, very strict. Kahit kaibigan kita, mahal kita at lahat, pero hindi mo nagagawa yung trabaho. Hindi naman ito tungkol sa pagkakaibigan o pagmamahal natin sa isa't isa kung hindi para sa serbisyo para sa tao," noted Marcos Jr.

Even his friends who refuse to perform their duties will have to leave, he said, emphasizing that government service is not about personal friendships.

The president earlier ordered a "continuing performance review" of all government officials, stressing he does not want complacency in the face of the country's urgent concerns.

"Ayoko talaga 'yung business as usual kasi ang dami nating problema. Naging problema 'yan kasi business as usual tayo nang katagal-tagal. Ilang dekada tayong business as usual. Eh ano ang nangyari sa atin?" lamented the president.

He said he will be "very, very, very conscientious of hitting our targets on time. And that's the important thing."

"If you're not helping, get out of the way. Okay? Kung hindi mo kami tutulungan, basta umalis ka na lang dito. Gawin mo 'yung gusto mong gawin, pero pabayaan mo kaming magtrabaho. That's my attitude all the time," Marcos Jr. said.

'Hanap ng mas magaling'

THE PRESIDENT disclosed that he has been checking the situation on the ground as part of the ongoing performance review of his government officials.

"Makatanggap ka ng report na sasabihin, natapos namin 'yung project, ganito 'yung ginastos namin, may picture na maganda. Pero 'pag pinuntahan mo, iba," the Marcos Jr. said. "Eh totoo pala 'yung report, maganda 'yung report. Alam mo na 'yung taong 'yun hindi nagsisinungaling sa 'yo. The other side is, binola ako nitong mga lokong ito. Alam mo na, itong mga ito hindi reliable 'yan. Maghanap tayo ng iba."

President Marcos indicated he has counterchecked official reports. "Kaya pupuntahan mo nga. Kung hindi ka nakakasiguro, halimbawa, may report, napakaganda ng lahat. Pero may kaibigan ka na taga-doon, sasabihin, 'Boss, hindi totoo 'yan. Hindi nila natapos.' 'Talaga?' 'Oo.' 'Halika puntahan natin.' 'Yun, pag-explainin mo 'yung tao. Siyempre kung anu-ano 'yung mga paliwanag niyan. Hindi mo pala kaya, sige, palitan kita. Hanap





JUNE 15, 1991 Pinatubo: The end of days

ONCE WAKEN, Mount Pinatubo gave vent to centuries of pent-up fury with a series of powerful eruptions, the biggest of which spewed a deadly cloud of ash and gases 25 kilometers into the sky on June 13.

"That is already the big bang. I can't see any other eruption that will exceed this. What we are seeing now are phenomenal eruptions," Director Raymundo S. Punongbayan of the Philippine Institute of Volcanology and Seismology reported.

He cautioned though that: "The story of Mount Pinatubo is not quite over yet." Mount Pinatubo proved Punongbayan wrong - on the first assertion. and right - on the caution.

June 14 saw the dark clouds like the wings of a monstrous bird casting trembling shadows across Angeles City during the day and a strange gloomy spell that dimmed the lights of the city's tourist district in Balibago.

Residents, confused as to the real danger became expectant of a distant calamity. Frightened by the frequency of mild quakes and the smell of sulfur in the air, they braced themselves for the inevitable.

The people with foresight started to leave; the fearful began long prayers at home and inside churches; the ignorant, as usual the powerless, waited in trepidation, ready to accept anything, even danger and destruction in sordid acceptance.

That was how the Mount Pinatubo eruption of June 15, 1991 came to Pampanga: with deathly fear, unfathomable anxiety, and widespread confusion that only plagues, war and the other scourges of the Four Horsemen of the Apocalypse could have wreaked anywhere.

Like an epic, graphic accounts of the Great Eruption varied in their dramatic and incredible description. Real life narrations and first-hand experiences of those who remembered the event are reinvented in every retelling.

Newspapers of the day were unanimous on the congruent conclusion that the volcano had awakened from a 600-year slumber, with accurate forecast of vast devastation, widespread socio-economic dislocation, and a heavy toll from the volcanic

volcanic ash around Central Luzon. It spread and swirled the debris up to Metro Manila, and as far away as several countries that affected air travel for some time.

The midday darkness, the rumblings of the volcano, frightening quakes and aftershocks, lightning and thunder, howling winds and a torrential rain of pumice stones as big as golf balls, mud and ash did indeed presage an apocalyptic end of days.

Panic

Panic broke out in all the districts of Angeles City, its 180,000-populace caught in pandemonium.

Thousands of vehicles scampered out of the city carrying frightened families to San Fernando and nearby towns. The most opulent residents opted to seek safety in Metro Manila.

The families that stayed behind had no alternative places to make their sanctuary.

Those who panicked walked on foot or used every available transport to vacate their abodes in the city. Workers left their posts from factories, markets, shops, clinics, offices, and private occupations, to reach home as fast as they could to prepare for an evacuation. Even policemen on duty rushed home to secure their households.

Crying infants, mothers shouting instructions to members of the family, neighbors hollering for their straying children drowned out church bells that rang incessantly in warning and as notice to leave areas within the 30-kilometer radius from the spewing monster...

Phivolcs officials had earlier warned residents living within the danger zone to immediately abandon their places.

When the 1,500 US Air Force security unit who earlier declared they would abandon Clark "only when we see lava at our doorsteps" raced out of the abandoned base, Angeles residents knew it was time to do likewise.

said Quezon City Mayor Brigido Simeon Jr., a Kapampangan native. He brought some buses to help in the evacuation right at the Angeles City exit ramp of the expressway. The Amoranto Stadium and public and private school houses in Quezon City were designated evacuation centers.

Faces

Public places looked like an open sanitarium with people's faces covered by surgical masks against ash inhalation. Acquaintances barely heard each other, their speech muffled by heavy gauze masks. But what need was there of distinct language when common fear and the reality of danger made for easy communications among the distraught victims?

In the Metro Clark areas, pumice stone pelted rooftops. A mud rain, then a mighty shower of ash fall covered the premier community as it did towns all over the province.

All through the day and night, sulfuric fumes engulfed Pampanga as pebbles kept falling in malevolent fury. Leaden ash and sand caused building to collapse, first the rooftops buckling down, then the whole structure keeling over like a boxer pummeled by knockout punches.

Two were killed and dozens of commuters were injured when the roof of the Philippine Rabbit Bus terminal in Angeles City collapsed due to heavy ashfall...

Mute agony

Thus, the day of terror began. The nighty ashfall turned day into night while earthquakes shook the region...Mute agony, unimaginable horror, and certain pain, had been written. And equally visible on both the faces of the rich and the poor.

As if to add force to nature's punitive and merciless wrath, a powerful tropical storm appeared across Central Luzon. Its winds and rains unleashed millions of tons of pyroclastic materials from the slopes of the volcano. sending torrents of smoldering mudflows to Pampanga and Zambales lowlands, burying houses, scouring riverbanks, collapsing bridges, destroying roads, and causing massive destruction in infrastructure and private property unmatched even by the scourge of World War II. Seven bridges in Pampanga, including the three main spans in Angeles City - Abacan, Friendship, and Pandan Bridges - were destroyed by rampaging mudflows. Churches, markets, schools, public buildings, hospitals including the Ospital ning Angeles collapsed. The Biggest Bang that was the June 15 eruption would segue to the succeeding blasts with more devastation to follow. At the Zambales side was a group of media workers who quoted witnesses who said the skies darkened momentarily after the volcano erupted in the early morning of 15 June.

Newsmen reporting from Clark said Mount Pinatubo vomited scorching volcanic material in a violent outburst, then acrid ashes and gases oozed out of the volcano's active vents. Like the explosion of the first atom bomb in Hiroshima which was timed officially by the US military, the Phivolcs placed the Great Eruption at 8:15 in the morning of 15 June 1991. And thereafter, day turned into the blackest of night.

A tropical storm spotted a distance away from Central Luzon as early as 10 June moved in for the "kill" after the major explosion and developed into a full-blown typhoon.

Thus, Typhoon Diding blew

Exodus

Thus, started the biggest exodus of evacuees and refugees that only a war could generate. All main thoroughfares leading out of Angeles, even those of San Fernando, were jammed with motorists.

Heavy pedestrian traffic clogged narrow roads with frightful people carrying and bundles of clothing. Infants nearly choked in the miasma of sulfuric fumes and steady ash. Every frightened Pampango thought it was the coming of doomsday.

At the North Luzon Expressway, traffic grounded to a standstill as thousands of men and women occupied all lanes in their rush to get out of Pinatubo's way to wherever. "Kung saan kami maihahatid ng aming mga paa," the refugees would say.

"We met wave upon wave of panic-stricken people. Kung saan sila pupunta, hindi nila alam,"

or video blog can make or break reputations—sometimes unfairly so.

Two recent incidents in the Philippines highlight both the power and danger of this influence. One case involved a supposed loyal Starbucks customer identified as JP Abecilla, who experienced having his name misspelled by baristas. He felt disrespected, left his order and walked out and then used his platform to dramatize and express his disappointment over the incident what many saw as an honest mistake.

Another involved TikTok influencer Euleen Castro, more popularly known as the "Pambansang Yobab," who faced online backlash after her harsh comment on the food she ordered at Coffeebreak, a café in lloilo. In her food review video, Castro described the food as "tab-ang" (bland). She went on, pointed to the dishes and said, "Out of all of you, walang masarap." She ended the review by gesturing toward the dishes again and remarked, "Ang dami niyo diyan, walang masarap sa inyo, ni isa. P*ta!"

These two incidents raise important questions: At what point does feedback cross the line from honest critique into damaging disparagement? Are influencers truly experts—or are they merely loud voices seeking clout?

Let's face it. While it is true that social media has democratized content creation, it has also blurred the lines between opinion and expertise. Influencers, in their pursuit of views and viral fame, often resort to sensationalism. The result? They forget the realworld consequences of their posts. A negative review made with tact and clarity is one thing; public shaming, exaggerated reactions, sarcastic ridicule and review laced with expletives are another.

Businesses, especially small local ones, invest time, money, and passion into what they do. A single tactless review—often made without full context or professional training—can lead to lost income, employee layoffs, and long-term damage to brand reputation.

In response, a Starbucks spokesperson stated that they do not direct their partners to misspell names and emphasized their commitment to customer satisfaction. Many Starbucks customers shared their own experiences and never made a mountain out of a molehill of a misspelled name. Many at hindi ang paglikuran lamang ang IILANG TAO

found humour in it and shared the countess times they were christened with new names and even contemplated on taking a new alias.

On the other hand, Coffeebreak stated on their official Instagram that it will remain "committed to providing a warm, satisfying experience to every guest and to continuously grow from feedback shared with sincerity and respect."

It's crucial to differentiate between constructive criticism and outright bashing, or even an exaggerated and emotionally charged opinion that lacks nuance. Honest feedback should be rooted in fairness, with the intention to inform and help, not to shame or destroy. Don't get me wrong. I am all for allowing consumers to exercise their right to speak up, but influencers must also carry the responsibility of wielding their platforms with integrity. Just because they have a large following doesn't mean they are qualified to be a food critic or industry expert.

We must all call for a culture of responsible reviewing one that respects the people behind businesses. Thoughtful, balanced feedback can spark improvement. But reckless posts driven by entitlement and the hunger for internet fame can irreparably harm lives and livelihoods.

In this digital age, there is a pressing need for responsible criticism. The message is plain and simple: Speak up, but do so with care. Influence should never be used as a weapon to destroy but an instrument to build.



Lubao LGU extends free health services to 1,452 teachers


LUBAO, PAMPANGA — As students return to the classroom this week, the local government unit here led by Mayor Esmie Pineda leaves no stone unturned to assure that schools are not only physically prepared, but that the town's educators are healthy

blood sugar and cholesterol testing, and eye examinations.

Initial results revealed that many educators had elevated blood pressure, cholesterol, and blood sugar levels common conditions often neglected due to the pressures of balancing responsibilities at environments for students.

Many teachers expressed appreciation for the support, saying their health is often overlooked due to financial constraints and the demands of daily life.

From freshly painted classrooms to newly repaired chairs and blackboards, the municipal government ensured that learning spaces are safe and conducive to learning. Beyond infrastructure, the LGU placed a strong emphasis on the health and wellness of Lubao's 1,452 public school teachers.

Just days before the official school opening, Mayor Pineda and councilor-elect Jayson Pineda Victorino led a medical mission that offered free health services to teachers covering comprehensive screenings such as blood pressure checks, work and at home.

To address these health concerns, the LGU provided two to three months' worth of maintenance medication, vitamins, and reading glasses for free.

Flood prevention technology was another area of interest as AFAB met with Vision Tech, developer of an internationally recognized flood containment system. The firm expressed intent to set up a manufacturing hub in the Freeport.



AFAB seized the opportunity to position the FAB as a top investment hub at the top investment hub at the 2025 Global Business Club – Philippine Business Forum, held at the Korea Chamber of Commerce and Industry (KCCI) Grand Hall. Organized by the Philippine BOI and PTIC Seoul, the forum highlighted emerging opportunities in sectors such as electronics, semiconductors, clean energy, EV and critical tech agriculture, nıgi and logistics.



On the sidelines, AFAB conducted B2B meetings with Korean companies, promoting FAB's strategic incentives, support, infrastructure and proximity to regional megaprojects like the Bataan-Cavite Interlink Bridge and the Subic-Clark-Batangas Backed by enabling Railway. laws, competitive incentives, and a skilled workforce, AFAB is positioned to capitalize on



Among the most significant developments was a meeting with Ms. Anita Kim, representative of a proponent behind a proposed \$700 million 250MW Combined Cell Power Plant in the FAB, utilizing liquefied natural gas (LNG) as its main fuel. The project, which includes a \$200 million LNG storage facility, the marked beginning exploratory cooperation with AFAB supporting feasibility with assessments and inviting proponents for site visits.



environmental technology, AFAB explored an innovative air management system developed by Shin Taeyang Construction and Vision Power, which filters and conditions air without traditional HVAC systems. The proponents see FAB as a strategic entry point into the Philippine market.

Further highlighting sustainable technology, SAVUS Company presented its energy-efficient power-saving system that can reduce energy consumption by up to 30%. Discussions centered on the potential for SAVUS to establish operations within the FAB.



AFAB delegation also visited Pyeongtaek Port and Korea Superfreeze, gaining insights into cold chain logistics operations using LNG-powered facilities that models future logistics capabilities in the Philippines.



AFAB also met with C US Korea, Korea's leading EV charger manufacturer, which expressed strong interest in setting up a manufacturing facility within the FAB. The move aligns with the Philippines' growing push for sustainable transportation infrastructure.

Explorations in digital innovation saw AFAB engage with Chunho Information Technology and the Korea Data Agency for potential integration of advanced regulatory systems, particularly in Anti-Money Laundering (AML). AFAB also held talks with tech firms Mocoplex and Giftybiz, both expressing interest in locating their regional operations within the Freeport. Mocoplex presented "QRO," Korea's first integrated offline marketing platform, while Giftybiz showcased its kiosk systems and B2B mobile gifting . solutions.
