#### Fiction: Key component of language and culture

Fictional stories and myths were more than just a pastime and a hobby. In many civilizations, these stories that were passed down were made to make sense of a world that people had yet to comprehend. With a lack of scientific knowledge and development, phenomena such as eclipses, thunderstorms, and even the concept of an afterlife were explained through myths. The unknown and misunderstood by the human mind, are explained and comprehended through the human spirit and creativity, and even the most fantastical stories can offer an anchor into reality through its morals and lessons.

One of the most famous branches of mythology is Greek Mythology. The Greeks had gods to explain unnamed concepts pertaining to nature, life, and the mysterious cosmos. These gods became the building blocks for stories and epics, such as the Iliad and Odyssey by Homer, and the Argonautica by Apollonius. Traditional Grecian storytelling was done through word of mouth, sung and performed to an audience. They were not documented and written down

unlike fiction of today.

Ingrid Holmberg on The Creation of the Ancient Greek Epic Cycle states that "Oral composition is characterized by its fluidity, its lack of boundaries and closure, and its inherent capacity for shortening and lengthening in every compositional production". When there is a lack of a physical copy of a story, chances are that the storytellers will change some aspects of it. Possibly to fit their view or personal take

of the story, to censor or edit parts out, or even because of a misremembered line, but exercises the creative liberty and fluidity of storytelling despite.

A common version of the Iliad from many iterations portrays Patroclus and Achilles as friends or cousins, and shows a more filial relationship. Emily Wilson however translates a line from one of the oldest handwritten copies of the Iliad showing Patroclus and Achilles'

#### Infinite Gratitude to our Source of Hope

Dear Brother Alumni in Christ,

Peace and hope in the Lord Jesus!

As we mark the 75th founding anniversary of our beloved alma mater, the Mother of Good Counsel Seminary in this Jubilee Year of Hope, I join you in raising hearts full of infinite gratitude to the Source of all hope, who called us, formed us, and continues to send us out as His witnesses in a world ever in need of wise counsel.

Looking back to our days as young seminarians—my own journey beginning with Batch 1974—I can only marvel at how the seed of vocation planted in the soil of Mater Boni Consilii in San Fernando has borne fruit in so many varied paths of service, inside and outside the priesthood. The years may have scattered us across many fields, but our roots remain deeply entwined in that same soil of formation, where we first learned to listen to the voice of the Good Shepherd and the gentle wisdom of His Mother, our Lady of Good Counsel.

Not long ago, during the Conclave that elected Pope Leo XIV, we cardinals received from then-Cardinal Robert Prevost a small gift: a simple stampita of the icon of our Patroness. (I did not know until then that the devotion to the icon of the Madonna and Child known as "Madre del Buon Consiglio" in Italian was promoted by the Augustinian Order, which Prevost belonged to. Yes, the same Order of Missionaries that brought the Christian faith to us in Pampanga.) It was as though he were inviting us to entrust our deliberations to her maternal wisdom. And she did not fail us. Through her counsel, we elected the very man who reminded us—through that silent gesture—that the Church must continually look to Mary's humble discernment in moments of great decision.

As the world now teeters on the edge of new uncertaintiesglobal conflict, climate collapse, and the ethical frontiers of Al and digital power—how timely it is that we recall her title: Mother of Good Counsel. Her wisdom is not loud, but it is clear. Not forceful, but steadfast. She remains the Church's enduring bridge between divine grace and human history. In a world in desperate need of bridgebuilders, we who have been formed under her name are summoned anew to become what she is: vessels of hope, agents of unity, counselors of peace.

In my Corpus Christi reflection this year, I shared that the word "Communion"—in Tagalog,

Pakikinabang—reminds us that we do not receive the Eucharist merely for private devotion, but for mission. The bread we receive is not just blessed; it is broken and shared. In the same way, a life of gratitude that is not given away becomes empty. But a life that is taken, blessed, broken, and given becomes fruitfultransformed into hope.

May our 75th Jubilee rekindle in us that Eucharistic spirituality of participation. May we live not for ourselves, but as living vessels of gratitude and hope for a weary world. Let us be reminded, always, that our story began not with ambition, but with a call—and it continues not by our strength, but by God's grace.

To the Mother of Good Counsel, we entrust our seminary, our vocations, and our future. May she continue to teach us how to listen, discern, and build.

#### Time to protect teachers

CHILD PROTECTION is, without an iota of doubt, undeniably crucial inside the classroom. Over the years, the landscape of classroom discipline in the country has shifted dramatically. Judging on the collective experiences of teachers, I would like to think that the pendulum may


The excessive implementation of laws such as the Child Protection Policy (DepEd Order No. 40, s. 2012), the Anti-Bullying Act of 2013 (RA 10627), and the Special Protection of Children Against Abuse, Exploitation and Discrimination Act (RA 7610, amended in 2017) has created a school setting where teachers, supposedly the students' second parents, now walk on eggshells. Many fear that even the mildest form of correction could be misconstrued as abuse, and could lead to administrative sanctions or even legal consequences.

The Child Protection Policy explicitly prohibits corporal punishment, including shouting or the use of words that "humiliate or threaten." While this was intended to

prevent abuse, it has also discouraged firm verbal correction. Similarly, the Anti-Bullying Act rightfully protects children from peer and authority figure abuse, but its vague definitions can be exploited by students who resist any form of disciplinary action. RA 7610 further complicates matters by classifying emotional and verbal reprimands as potential forms of psychological abuse.

The result? A growing number of students who are, quite frankly, entitled for all the wrong reasons and to use the words from a public school teacher's viral social media post, "allergic to discipline." To think that these students will soon be part of the country's work force and who will move on with their lives as members of a larger community and the society.

Compare this to the 70s, 80s, and even the 90s—an era when many Filipinos remember being disciplined with tough love right inside the classrooms. Back then, our teachers were strict but fair. Whether it was a slap on the wrist, a stern and stronglyworded lecture, or being made to stand in the corner, the core values of respect and accountability were instilled in our minds and hearts. Not a single parent raised an eyebrow or filed a complaint. As for our generation, there were no cases of depression, anxiety or mental health breakdown. In fact, we grew up resilient, focused, and grateful for that kind of discipline we received from our teachers. We learned that discipline wasn't cruelty—it

Powerlessness pervades every classroom today. Many teachers I know are unable to correct bad behavior for fear of being labelled abusive. What makes the situation and every incident even worse is the long line of parents who seem to find it convenient to point all ten fingers at the school but not a single one at home, where discipline, like charity, always begins and grows.

For the nth time, I couldn't help but emphasize that teachers are not in any way enemies. They are second parents. Similarly, the school is not a battlefield but a second home. But like any home, rules and discipline are essential in creating a nurturing and productive environment. When the law strips educators of the ability to guide with firmness, we do more harm than good. We risk raising a generation of entitled students—ones who expect and clamor for praise but reject correction.

It's time to re-examine our policies—not to weaken child protection, but to strike a balance. Because in protecting the child, we must also protect the teacher. After all, the classrooms need and deserve teachers who can guide with tough love, discipline with dignity, and help shape resilient citizens who are ready to face the back-breaking challenges in the real world outside of their classrooms. Let's empower, not muzzle, every Filipino educator.

Marcos Jr. launched the Rice Processing System (RPS) II during a visit on June 30 to this city in Nueva Ecija, one of the country's top rice-producing prov-

Developed by the Philippine Center for Postharvest Development and Mechanization (PHilMech) under the Rice Competitiveness Enhancement Fund Mechanization Program, the RPS II, which consists of a stateof-the-art multi-stage rice mill valued at P55.35 million and two recirculating dryers worth P8.66 million, will significantly reduce post-harvest losses.

Some 6,000 farmers from Muñoz, who collectively manage a total of 9,200 hectares of rice fields, will directly benefit from the

president's latest initiative to improve the agricultural sector.

PHilMech director Joel Dator said RPS is expected to reduce the production cost of farmers by P2 to P3 per kilo through the use of mechanized production technologies.

The facility will also reduce post-production losses of farmers by 3 to 5 percent.

The RPS rice mill has a capacity of 2 to 3 tons per hour, featuring a precleaner, de-stoner, huller, mist polisher, length grader. color sorter, and blending

The system also features an automatic packing machine for milled rice, a rice hull bin, a dust collection system, and an air-conditioned control room.

Meanwhile, each of the two recirculating dryers has a 12-ton per batch drying capacity. They are made of stainless steel and equipped with two heating systems, a generator set, tools, and other accessories.

In addition to the facility, Marcos Jr. also distributed farm machinery worth over P31 million to 17 farmers' cooperatives and associations. These included one 4-wheel tractor with complete implements, 16 rice combine harvesters, and one handy cultivator.

One of the beneficiaries, the Usbong ng Halaman Av Yaman (UHAY) Agricultural Cooperative, expressed gratitude for the aid received.

**UHAY** chair Brando Sanchez said the combine harvester given to them will

significantly ease their farming operations, benefiting not only their 62 members but also farmers in nearby communities. He added that what used to take two to three days to harvest can now be completed in just a few hours, especially crucial ahead of an incoming typhoon.

light. She writes in her translation published in 2023: "My friend Patroclus, whom I loved, is dead. I loved him more than any other comrade. I loved him like my head, my life, myself." (Wilson, 2023.) This shows the deep love and care the two shared, this message seemingly lost in translation in other versions. These different translations stem from the same storyline, and the same place, and yet hold different messages for its audience. The

come from a time where a relationship such as Achilles and Patroclus' was frowned upon, and only explored again later on in time by translators such as Wilson, showing how stories are impacted by and impact the world.

While the risk of misinterpretation comes from the translations and inheritance of many stories over time, examining these differences gives readers of today an idea of the ideologies and ways of thinking at the time different works were written, published, or translations. Aspects of the stories we know may get rewritten or cut out, but the core messages of these stories stick for a lifetime. The Iliad remains a precautionary tale of the dangers of war, rage, revenge, and glory no matter the translation. And stories such as these help its audience digest emotions and events in the real world, no matter how fantastical a tale may be. Fiction and storytelling will forever remain a key component of language and culture, as it helps people connect

# On his first day as solon, Cong Pogi delivers school supplies to daycare centers

MAGALANG, PAMPANGA

On his very first day as representative of the 1st District,
Congressman Carmelo "Pogi"
Lazatin, Jr. hit the ground running as he personally distributed school supplies to daycare students in this town on July 1.

A total of 1,665 daycare students in Magalang will receive school supplies, including crayons, notebooks, pencil, eraser, sharpener, and writing pad, personally donated by Lazatin out of his own pocket.

Donned in his trademark red polo shirt, Lazatin was enthusiastically welcomed by daycare students in the 10 barangays he visited, namely Camias, San Francisco, San Jose, San Nicolas I and II, San Pablo, San Pedro I and II, Sta. Cruz, and San Vicente.

Just last month, Lazatin also participated in the Brigada Eskwela 2025 where he personally donated 580 sacks of cement, 116 liters of paint, and 232 paint brushes each to 58 public schools in Mabalacat City and 58 public schools in Magalang Town.

Participating in the annual Brigada Eskwela has been a tradition of Lazatin since he first became a councilor in Angeles City in 2013.

Lazatin has always advocated for education. As Angeles City Mayor, he spearheaded the repair of daycare centers in Angeles City, amounting to P5 million; the construction of additional classrooms, offices, laboratories, and canteen at the City College of Angeles (CCA), amounting to

P259 million; and the construction of the P50 million new annex building of the CCA, funded by the Philippine Amusement and Gaming Corp.

Under the Lazatin administration, 58,000 tablets were

distributed to public students in Angeles City from Grades 4 to 12; 3,200 tablets were distributed to public school teachers; and 3,200 tablets were distributed to students of CCA.

Now that he is in the House of

Representatives, Lazatin vows to further his efforts in championing quality education for all.

Part of Lazatin's legislative agenda is to propose measures to increase funds for the construction and maintenance

of more classrooms in public schools, to increase the salary of public school teachers by P20,000 across the boards, and to provide comprehensive training programs for public school teachers. **Press release**
