2,100 ARBs in CL awarded certificates of condonation, land titles from DAR

CITY OF SAN FERNANDO — Agrarian reform beneficiaries (ARBs) across Central Luzon received on July 4 close to 2,600 land titles and certificates of condonation in the continuing effort of the Department of Agrarian Reform to speedily implement RA 11953

(Condonation Law) by President Ferdinand R. Marcos Jr.

The certificates of condonation and land titles were awarded to some 2,100 ARBs involving over 2,600 hectares of lands covered by the agrarian reform program of the government.

In his speech at the awarding

ceremonies, DAR Central Luzon OIC regional director Atty. Eric Francis Luna disclosed that over P63 million have now been written off covering principal debts, interests and surcharges.

Luna also urged ARB-recipients to maximize the condoned amount in ensuring productivity of the awarded lands.

The distribution of certificates of land ownership award, electronic land titles under Project SPLIT (Support to Parcelization of Lands for Individual Titling), and certificates of condonation is a continuing program of the department




CL cops get 4G LTE radios to enhance connectivity

Zambales pushes fishing industry modernization

IBA, ZAMBALES — The provincial government here will start the modernization program of the local fishing industry here by procuring an automated harvester vessel with ancillary boats and training the fisherfolks in the use of this modern technology.

Gov. Hermogenes Ebdane Jr. said the provincial government aims to kickstart the modernization of the local fishing industry with the 96-feet long, steel-hulled harvester boat paired with two reinforced fiberglass lightboats and one service boat under an assistance program initiated by the Zambales Maritime Development Council (ZMDC).

The vessels will be built by Stoneworks Specialist International Corp. in General Trias, Cavite, the biggest fiberglass boat maker in the country, which also builds tugboats, barges, and other customized vessels. They will be operated by members of

the Zambales Provincial Fishery Association, a federation of fisherfolk groups across the province.


Ebdane said the procurement of a modern harvester boat and ancillary vessels "is the logical next step in pursuit of a long-term solution to the [West Philippine Sea] problem by giving local fishers a significant fighting chance."

While awaiting the delivery of the new vessels this year, local fishermen will undergo training on modern vessel operations under the Philippine Merchant Marine Academy (PMMA) in San Narciso town.

Ebdane stressed that the training component of the fisherfolk assistance program is as important as procuring the new vessels. "Learning new technology and developing new skills is necessary for our fishermen to be competitive. They need to adapt in order to survive and thrive," he added.

At least two fishermen's clus-

MONDAY, July 7. In the course of my call at the Capitol, Nanay Gov adumbrated the priorities of her second coming at the governorship. Of the myriad programs that span the whole socioeconomic-infrastructure spectrum of development, it was her upland agroforestry program that struck a lilting chord in me, especially hearing that bamboo is at its very core.

It was something like going full circle, fading memory still distinctly remembering something with bamboos in then-Nanay Baby's very first term.

Wisdom from the bamboo

PLANT BAMBOOS by the riverbanks to prevent erosion.

So, the Pampanga Bamboo and Rattan Center enjoined local government units along the coastal towns. Even as it boasts of having planted no less than 22,000 bamboo propagules all over the province, the council targets 5,000 more in August in celebration of the Bamboo Day Celebration which has been appropriated some P1 million by the provincial government.

Bamboo propagation has received a big boost with the Pampanga Agricultural College chosen as a pilot area for a 10-year research project supported by the United Nations Development Program. (Quick online check shows a Pampanga Bambusetum at the now-PSAU being a pilgrimage for benchmarking by educational institutions and LGUs.)

Rivalling, if not surpassing, the coconut as a "tree of life" for its myriad use, it gives us much pleasure now that the bamboo is getting the attention and importance it deserves.

Why, I would even go for the bamboo as national plant, not simply for its being the main component of the national house.

But for its thatched roof of nipa fronds, everything else in the *bahay kubo* is made of bamboo - from rafters to posts, from ceilings to walls - of sawali, down to the slatted floor.

Which manifests the wisdom of the early Filipino home builders, cool bamboo as building material being most appropriate for the hot tropics; the *bahay kubo* on bamboo stilts best to survive the periodic inundations from the swollen rivers in the rainy season.

Bamboo went beyond building material in Filipino life, at least the life we – the 50s plus-plus

generations - knew and lived.

The bamboo took a central role in our community life

The defining spirit of Filipino communal unity and cooperation the bayanihan – is bamboo-based. Here, the whole community helped a family relocate by carrying their whole house, with bamboo poles placed length-wise and cross-wise under the house floor, borne on the shoulders of men, the women following with pots of cool water and ladles for drinking.

The bamboo is celebrated in Filipino folk dances, from tinikling to singkil. And in song, the most famous

We urge the faithful to pray, fast, and offer sacrifices for peace in Gaza and throughout the world. War spares no one and there is no victory in war. The innocent suffer the most. We condemn the weaponization of starvation. Let food and badly needed humanitarian aid benefit all. We appeal for immediate ceasefire so that serious negotiations can take place for a long lasting solution to the problems of Palestine. We advocate for a sustained culture of peace rooted in justice, mercy and our shared humanity, transcending race, religion and politics.

We call our faithful to combat moral indifference, listen to all sides with openness, and foster a culture of engaged citizenship rooted in our Christian faith.

A Call to Action

We invite all clergy, laity, workers and political leaders to join hands in building a just and peaceful society as we do justice, love goodness and walk humbly with our God. In this Jubilee Year, let us enkindle our hope, strengthen our solidarity and remain vigilant in our stewardship of truth, justice, and the dignity of every human person. May Our Lady of Peace intercede and pray for us, to be instruments of God's justice and love.

The nation's menu

What's on the a la carte nowadays is not inviting. In fact, you may say items on the menu are kosher. The cuisine has never been so gross. What's scribbled like strange grafitti on the table top comes straight from Paul's letter to a young pastor Timothy. It warned all and sundry that the love of money, not money per se, is the root of all evil.

There had been a corporate killing of some 100 sabungeros, More is not mere potential. A whistle blower's story says the cadavers were dropped like trash in the murky waters of a volcanic lake where a popular native fish is raised. Sale of the popular tawilis has dropped since.

Where not yet on the slipper slope though, according to a Kapampangan social expert and renowned national columnist. In fact, were not yet sliding, as it were. But he sees the precipice from where he stands or sits.

The noisiest critic of the government, who once declared herself as the surviving second highest official of the land, is thankful, sort of, were not there yet. The president, she has been telling the whole world, is not fit for the job. So the country is not moving forward, maybe wayward.

Ironically, it's also a fitting description, thankfully, too, of her impeachment case. A former Supreme Court justice has calmed nervous souls that the trial has been delayed but not stopped entirely. The trial issue is still fraught. Danger is lurking somewhere in the so=called impeachment court and is coming from some senator-judges.

The unconstitutional mood has been that way from the get go, confirming what the British philosopher John Stuart Mills wrote that democracy breeds dumbs, Modern thinkers says it's even worse today than in the days of the kings.

In our neck of the woods, the

64 dollar question is: are we being run by politicians or by gambling lords? This question is raised after a notorious gambling lord, who once accused another gambling lord of having a dwarf as a fairy, has been tagged as a suspect in the serial killings.

Money, or the love it, is all behind this, according to the secretary of justice. He says more money is coming from all directions to influence the media, the judiciary and just about everybody that makes their bets on cockpit gambling that used to rake in billions for the government.

A well-known politician from the Solid North has recently said the same exact thing. The justice secretary is right on the money why so much is flowing crazy in many places to "kill" the missing sabungero issue.

The late <u>president John F.</u> Kennedy once said that that the Bill of of Rights is not an ala carte menu. Unfortunately, that's what's happening in the US right now and

'Macababad' town awakes

FOR AS long as I can remember, we Macabebe folks have been used to leaning on humor to cope with the annual flooding. To a fault, we have romanticized resiliency in facing relentless flooding in the town.

Proof? We have even started to name our beloved town as "Macababad" and tried to outdo each other by coming up with the wittiest memes – "Gumato ka, Macabebe!" "Albug ka mu, taga Macabebe kami!" "Ali ka taga Macabebe nung ala aka pang kaliskis at hasang ngeni!" - just to name a few that trended on social media.

But things are changing slowly though steadily. Last June, floods from high tide affected seven barangays, displaced thousands and disrupted livelihoods. To think this was not even the results of a typhoon. This situation must have awakened a long-dormant sentiment in the hearts of my town mates that instead of taking everything in stride, the usual barrage of jest was replaced by a collective demand for accountability.

Once again, the townsfolk reminded the local and national government leaders that road elevations and makeshift embankments have offered temporary relief only, allowing flooded sections to swap places each year. In fact, the long stretch of the main road in San Gabriel has been flooded in less than two years since it was elevated again.


Residents now openly urge local and national authorities to stop delivering mere BandAid fixes. Their message has never been crystal-clear - "We want concrete actions, transparent budgets, longterm plans."

The urgency is clear. Pampanga River Basin—of which Macabebe is a low-lying part—sees at least one major flood annually. Back in 2009,

2012, 2019, 2023, and 2025 the town was inundated for weeks. In September 2019 alone, nearly all 25 barangays suffered, affecting 30,000 people and requiring P433 million for infrastructure repair (pna.gov.ph).

But let us give credit to where it is due. The government authorities have responded by initiating the Integrated Disaster Risk Reduction and Climate Change Adaptation (IDRRCCA) Project Stage 1 in August 2024. This was financed by a ₱7.6-billion loan from South Korea's ExIm-EDCF. This effort aimed to reduce flood durations from 66 days per year to just 17 days in Macabebe and neighboring towns.

Punto ČL also reported that San Miguel's "Better Rivers PH" dredged 26 km of the lower Pampanga River last year,



removing nearly 700,000 tons of

based on best practices and climate models.

On top is a comprehensive watershed management. The dredging must be extended to upper tributaries. In 2024, SMC cleared 4.3 million MT of silt across 74.5 km, yet only 26 km was in Pampanga. Expanding clean-up upstream would reduce silt loads downstream.

Second, we need to invest on smart infrastructure investment. We can prioritize hydraulic modelling to identify pinchpoints. We can build redundant flood ways, reservoirs, and pump systems in critical barangays like San Gabriel.

Trite as it may sound, the third is to implement naturebased solutions consistently and rigorously. We must continue to reforest upland areas to improve infiltration. We must restore wetlands and mangrove buffers along the delta to absorb tidal surges before reaching inland.

Since we are talking about long-term government projects, we should foster a culture of transparency, accountability and active planning. Flood control efforts must be accompanied by publicly accessible budgets, regular progress reports, and thirdparty audits – if only to remind us of the horror stories of collapsed or underbuilt embankments in nearby towns.

The Macabebe town folks no longer want to be mere spectators but active and empowered partners in community resilience. They are now rising as advocates demanding that concerned government agencies deliver enduring safety, and not just seasonal relief. They have realized that resilient humor will never be a substitute for responsible and responsive governance. It's time for long term policies and investments to match their communal spirit and courage.
