

P11.43-B Hann Holding's IPO gets SEC green light

LARK FREEPORT - A P11.43-billion stock market debut of Hann Holdings Inc. has been approved by the Securities and Exchange Commission.

The SEC on Friday, July 18, said its commission en banc approved the registration statement of the firm which covers up to 2.5 billion common shares.

Hann Holdings will offer 500 million primary shares at P23.60 each, including an overallotment option of up to

50 million shares to be offered by its selling shareholder, Hann Group Holdings W.L.L., at the same price.

The IPO is expected to raise P11.43 billion, which will fund expansion plans and general corporate expenses of its wholly-owned subsidiary, Hann Philippines Inc.

Hann Philippines owns Hann Casino Resort, an integrated resort in Clark Freeport hosting Swissotel Clark, Clark Marriott, and Widus Hotel Clark.

The company is also developing Hann Reserve, 450-hectare eco-luxury sanc-

Celebrating Cong Tarzan's Legacy: Dugare of Mahalacat Citubood

MABALACAT CITY -Thirteen years ago, on July 21, 2012, the people of Mabalacat voted on what would be the culmination of a year-long battle for cityhood – a battle initiated by then Pampanga 1st

District Rep. Carmelo "Tarzan" Lazatin on May 25, 2011, when he filed House Bill No. 04736, "An Act Converting the Municipality of Mabalacat in the Province of Pampanga into a Component City to be known

as Mabalacat City."

After its filing, Cong Tarzan hurdled a yearlong scrutiny of the bill by his peers in the 15th Congress.

The bill was approved on Second

LGUs get 29 mini dump trucks from Capitol



CITY OF SAN FERNANDO - The Provincial Government of Pampanga handed over 29 mini dump trucks to various local government units at the Capitol Grounds here on July 21.

This initiative aims to improve the collection and transport of solid waste, especially in remote or underserved barangays across the province.

The project is aligned with the goals of RA 9003 (Ecological Solid Waste Management Act of 2000), as well as the 2022-2031 Provincial Solid Waste Management Plan of Pampanga. These vehicles are expected to boost the operational capacity of LGUs in implementing regular and segregated waste collection.

"The Capitol is funding these vehicles for our barangays, and they're meant for you. Please take care of the dump trucks assigned to markets and barangays for waste collection." Gov. Lilia "Nanay" Pineda told the recipient LGUs, including Mayors Leonardo "Bobong" Flores of Macabebe, Michael Galang of Floridablanca and Jeffrey Luriz of Arayat, along with Vice Mayor Jun Lim of Guagua.

Also present were punong barangays from Lubao, Floridablanca, Guagua, Magalang, Sta.


Ana, Masantol, Minalin, Macabebe, Apalit, Arayat, and Candaba.



Ombudsman suspends 13 Tarlac City officials over 'anomalous' transactions

The complaint arose from alleged massive irregularities uncovered by the Commission on Audit in the procurement of drugs and medicines by the City Government of Tarlac during calendar years 2017 and 2018, under the administration of then Mayor Cristy Angeles who is now Tarlac 2nd District repre-

Among the findings of the COA special audit team were:

1) ₱7.09 million in overpricing across three procurement transactions in 2017 alone;

2) ₱843,900 worth of medicines purchased outside the Philippine National

DPWH allots P100-M to finish new facility at AC hospital

ANGELES CITY - A total of P100 million pesos has been allocated for the completion of a multipurpose building at the **New Rafael Lazatin Memorial** Medical Center (RLMMC), also known as Ospital Ning Angeles (ONA), funded by the Department of Public Works and Highways upon the request of Pampanga 1st District Rep. Carmelo "Cong Pogi" Lazatin, Jr.

The allotment shall augment the completion fund of the Angeles City government for the New RLMMC.

"Ito po ang maganda kapag magkakampi lalo na magkapatid ang mayor at ang congressman, mas madali at mas mabilis po ang pag-request na magbaba ng pondo mula sa national government para sa LGU," Cong Pogi said.

In a letter addressed to Angeles City Mayor Carmelo "Mayor Jon" Lazatin II, Cong Pogi noted that the DPWH Pampanga 3rd District Engineering Office shall coordinate the project with the Angeles City LGU.

Cong Pogi, who served as Angeles City mayor for six years, had also allotted P200 million for the equipment of the New RLMMC during his term.

Mayor Jon, on the other hand, is now busy preparing for the operational requirements of the new hospital, including accreditation from the Department of Health, hiring of additional staff, and additional operational

Cong Pogi and Mayor Jon hope to complete the New RLMMC this year to better serve the people of Angeles city and the 1st District of Pampanga.

As city mayor, Cong Pogi spearheaded various infrastructure projects in the city amounting to P4.8 billion, broken down as: P1.3 billion in 2019, P99 million in 2020, P864 million in 2021, P163 million in 2022, P1.1 billion in 2023, and P1.3 billion

Among the major infrastructure projects are the rehabilitation of the Pampang Public Market; the construction of the Rafael Lazatin Memorial Medical Center Annex Building (Phase 1 and 2); the construction of the material recovery facility; the construction of the Kanlungan ng Kabataan; the construction of a waste water treatment facility; the construction of the Bale Pusu Home for Abandoned Elderly; and the rehabilitation and improvement of rural health units.

Other infrastructure works undertaken by the Lazatin administration include the construction of additional niches at and rehabilitation of the Angeles City Public Cemetery; the

Hope for justice, love for others

I DON'T cry every minute, but it's not easy to be the mother of a desaparecido (a disappeared person).

You don't know what will happen: Will you see him or not? Is this a truth or a falsehood? Because many falsehoods are presented to us. Will you pray not only for the disappeared but also for the perpetrators? So, there's conflict. It's very difficult.

(This inner conflict becomes more apparent, whenever she sees a tortured body that she initially suspects to be Jonas, only for it to be another person.)

When you see the body, you cannot even rejoice that 'it's not my child.' Why? Because the body is concrete proof of the cruelty of other human beings. You'll see it no longer has fingernails, the teeth are gone, the eyes are bulging out, and all that. And you say: 'Lord, why are people this cruel, that they can do this to their neighbor?

But you cannot even condemn the perpetrators because you know they are also children of God. So that's the conflict that's difficult to face.

We are sent to these circumstances because there is something good that you can do, to find something good in what is happening.

It is not easy to speak to victims of enforced disappearances, but because I was sent there, maybe the Lord thinks that there is something that I can do for them.

Before, when I said 'I seek justice,' I thought I should take revenge: 'Whoever took my son should pay for it in iail.' Before, that was my thinking,

But now, it's a different perspective. Justice is not about revenge. It's about making sure that nobody else suffers the suffering you go through. It's hard. And if that's what you're thinking about justice — to ensure that nobody else suffers — then you're motivated by love while seeking justice.

Cong Tarzan's MC paternity cancelled

"WE GIVE credit to whom credit is due. His leadership laid the groundwork for the opportunities Mabalacat enjoys today."

Thus, at the 13th cityhood anniversary, Mayor Atty. Gerald Guttrie Aquino honored mayor-forthe-longest-time Marino "Boking" Morales as the "Father of Mabalacat Cityhood" for his key role in the passage of RA 10164 converting the municipality of Mabalacat into a component city of the Province of Pampanga in 2012.

No, I have no beef on the recognition of Boking's paternity of the city.

Yes, I demur on the utter neglect if not outright denial of the indispensable part - indeed, without which there would have been no city – of Pampanga 1st District Rep. Carmelo "Tarzan" Lazatin.

Cong Tarzan has been so cancelled out at every Mabalacat cityhood anniversary celebration that it makes one think if the city government has made this as a deliberate, if official, act of historical revisionism.

In celebrations past, we have already raised this issue – Zona Libre,

So declared the city council of once forever Mayor Marino "Boking" Morales in Resolution No. 392 it approved last Monday.

Even as it hailed – rightfully – his "many years of dedicated public service as local chief executive," the resolution topped Mayor Boking's celebratory cake thus: "Foremost among his outstanding achievements is the passage into law of Republic 10164 in July 2012 which declared Mabalacat as

component city of Pampanga."
So – rightfully – earning the honor of being father of the city. The highly prolific Mayor Boking thereby adding yet another child, so to speak, in his multitude of 21, as of last count.

don't know if it was in the resolution's whereases but the news story on this city fatherhood cited as backgrounder that:

On May 18, 2012, then President Benigno Aquino III approved House Bill 4736, an "Act Converting the Municipality of Mabalacat in the province of Pampanga into a Component City to be Known as Mabalacat City.

House Bill 4736 which became Republic Act 10164 was sponsored by Senator Ferdinand "Bongbong" Marcos Jr., chairman of the Senate Committee on Local Government...

No fake news, but there obtained one major lapse in the cityhood narrative. (Come to think of it: Whenever the Marcos name crops up, some historical rewriting pops out. Even if so unwittingly.)

No denying that Marcos Junior did indeed a yeoman's job at the Senate for the passage of RA 10164. But what good was that, what cityhood would even befit Mabalacat, without the spadework that was House Bill 2509 sponsored by then Pampanga

1st District Rep. Carmelo "Tarzan" Lazatin? As we wrote here in July 2011 – a full year before the plebiscite that officially birthed Mabalacat City ---

..And then there is consolidated House Bill 2509/4736 mandating cityhood for Mabalacat already nearing approval, so Senator Ferdinand Marcos Jr., committee on local governments chair, himself is said to have declared.

Cong Tarzan, but of course, stands as the legitimate father of a Mabalacat City, having sown the very seed, incubated and nurtured the embryo which is soon a-borning.

Yes, Tarzan...

No, I don't mean to question, much less disparage, Mayor Boking's fatherhood of Mabalacat City, officialized as it is by city council Resolution No. 392.

It is just that Cong Tarzan deserves his own rightful place in the cityhood history.

Indeed, in the euphoria that followed the plebiscite, Mayor Boking himself was profuse in his acclamation of Cong Tarzan as "father of Mabalacat City.'

"By the grace of God and the sovereign will of the people, we are now a city" proclaimed tarpaulins all around Mabalacat at that time. Modesty be damned, I minted that phrase over café americano at Starbucks SM Clark with Mayor Boking and his most loyal lieutenant, double visionary Deng Pangilinan.

Delighted as he was with it, I remember the mayor asking how Cong Tarzan's name be incorporated in the tarps. Not wanting to disrupt the cadence in the phraseology, I suggested separate streamers thanking the Cong for his paternity of the city. Which, to my knowledge, were also posted.

As much a victory for the townspeople and Mayor Boking as a triumph for Cong Tarzan – given his being denigrated as chair of the *comite de silencio* at the House – was the cityhood of Mabalacat.

Ain't it long been clichéd that "Victory has many fathers..."?

So, why now make fatherhood of Mabalacat

City exclusive to Mayor Boking?

It smacks of historical revisionism pursuant to vested interests towards a second coming. Political, what else.

I am with you

A FATHER once shared a story with me just a few days after burying his 20-year-old son. One day, while scrolling through social media, he came across a video of a young boy asking his father how much he earned in a day. After hearing the amount, the boy opened his piggy bank and said:

"Dad, I want to give you everything I've saved up—just so you don't have to go to work for a day, so we can play basketball like we used to."

The father said he broke into tears after watching that video—because it brought back a memory. One night, his own son had knocked on his door:

'Dad, can I talk to you for a while?' But because he was swamped with work, he had replied:

"I'm busy, son. I have to finish this."

He had no idea that it was actually a silent cry for help. A breath of despair from a child who was carrying something heavy. It was a final plea for companionship—one he had missed. He would later learn that his son had been suffering from depression, which eventually led to suicide.

In today's Gospel, we hear Jesus say something

very similar to Martha:

"Martha, Martha, you are anxious and troubled about many things. But only one thing is necessary... And what was her sister Mary doing? She sat

down. She listened. She offered her presence.

The story of Martha balances out the earlier parable of the Good Samaritan. There, compassion was expressed through action: cleaning wounds, lifting the injured man, paying for his shelter. But in Mary's case, welcome was not shown by cooking or preparing food, but by stopping, listening, and being fully present.

We see the same kind of welcome in today's first reading. Abraham, in the heat of the day, stopped what he was doing. He noticed three visitors approaching and without hesitation, he and Sarah offered them their time, their food, and their presence. They had no idea that they were entertaining messengers

Thanks to the heads-up

He's no hypocrite, Sen. Ronald"Bato" dela Rosa, who could be the last man standing when the going gets really rough for his principals-- not the "we the people" preambled in the Philippine Constitution-- but the father and daughter tag team of the fighting, feisty Duterte clan.

Ergo, he will not attend the forthcoming 4th state-of-the-nation- address (SONA) of , who else, but the number one nemesis or spoiler, if you will, of his now-and-forever benefactors, the one standing between now and 2028. He probably knows the message, been there, heard that. So what else would be new, except that , according to the British journalist Malcolm Muggeridge, the latest news will be like the last or old one.

He wouldn't show up at the SONA and force a tongue-in-cheek grin with the VIP invites while it's all sour mood from the inside. Neither does he think it prim and proper at an honorable state affair for him to look like a grumpier grandpa. No way. He wants his grandchildren to remember him well, which is why talks about his impending warrant of arrest from the International Criminal Court get on his nerves.

Besides, he has a good example to follow and it's even legal: the Vice President of the Philippines, Sara Duterte, in case you forget. The first time, she didn't show up at the last SONA because she thought she deserved to be a designated survivor if something happened to the Palace super lucky teammate.

Ironically, it's another head-up that has caused, partly the current impeachment hullabaloo against the second highest official in the land. The VPs earlier verbal statement that she had hired a killer to do in the President, the First Lady and the Speaker of the House is a prima facie virtual Mt. Everest for her battery of 16 top notch lawyers.

The late Pampanga governor Bren Z. Guiao used to drill it on his allies and contractors cabesa, including the latest father of political dynasty in Pampanga, whose apotheosis far exceeded that of his mentor and benefactor, that loyalty is a two- way traffic. (By the way,the father of the new dynasty has unraveled the secret that you need a dynasty to fight a dynasty).

When the late governor lost to an action star, he deeply bewailed that many of his allies became scarce or invisible . He would recall that, in his golden days when everybody desired gold, many

would call him day or night to ask for favor: a post or a contract. The woman president at that time, for whom he showed what real loyalty meant, was only a phone call away. In fact, he didn't have to; dropping the magic name, would suffice, which he did some of the time.

The late business tycoon Levy Laus recall vividly that when the governor-friend died, he was alone in following the ambulance carrying the politician's body on the way to the governor's hometown. "Now, only the two of us are left," the business tycoon reverently spoke under his breath to his dead friend.

In the governor's time, the business tycoon led a group of concerned citizens ,mostly traders, in demanding that the governor put his money where his mouth was. A volcano had erupted, dislocating thousands, burying some places under lahar and a slogan reverberated through out the Pinatubo—landia: don't mourn, Pampanga will bounce back.

To his credit, his networking with a former woman president and her successor who defied political convention and a well-known sabungero to be her successor, paid off with a multi-million dike that ended the existential worries at the time.

"He was a tool of the boss, without brain or backbone", Franz Kafka described his character Gregor Samsa in "Metamorphosis". Obviously, Bato has enough backbone in accusing the present administration of kidnapping a former ex=president to surrender him to the ICC custody at the Hague. He also repeatedly proposed that the impeachment trial against the vice president be dismissed for legal infirmities. Whatever mental capacity the senator may need to comprehend the Constitution, which many says has been flagrantly violated by those who knew better, he has more than made up to meet Guiao's paradigm of a two-way traffic.

"Loyalty is the virtue of faithfulness", American author Edwin Louis Cole said. There is no iota of doubt that the hulk of a senator perfectly fits the adage to a T. He will always insist that the vice president is innocent of the charges against

Safety first

LEARNING MUST never stop.

So says the Department of Education. This was the battle cry that reverberated during the Covid-19 pandemic and extended to this day whenever classes are suspended due to natural calamities such as typhoon and flooding.

Ensuring that learning continues through alternative delivery modalities seems logical at first glance. Although this is a well-intentioned slogan, it actually fails to capture the disturbing reality of students and their families that are battling both natural calamities and the pressure of synchronous, asynchronous or modular learning sessions.

Over the weekend, the combined effects of Severe Tropical Storm Crising and the southwest monsoon have already affected at least 800,864 people across the country's 16 regions, according to the National Disaster Risk Reduction and Management Council (NDRRMC).

uncil (NDRRMC). In Pampanga, more than 50 barangays are flooded with the towns of Macabebe, Masantol, and Minalin as among the worst hit. A number of roads are submerged that even light vehicles are unable to pass.

As a result, local government units were quick to respond to the advisory of the NDRRMC, prompting them to suspend classes in all levels of public and private schools. This is a welcome move as we continue to prioritize the safety of the learners, teachers, and other school personnel.

I have to admit I am not big fan of online classes and modular learning and will choose in-person classes at any given time and day. For the past five years, I have observed that online classes during floods have become an added layer of stress among students and their parents rather than a refuge for the continuity of learning. True, we have all made significant and admirable efforts to shift to alternative learning delivery modalities. But the more pressing questions is: at what cost to students?

According to a 2022 World Bank report, only 20% of Filipino students in rural areas have stable internet access. In my beloved Macababad town, access to devices and connectivity remains an elusive privilege, not a given. Let us be honest here. When floodwaters rise, so do anxieties — not about quizzes, performance tasks or

deadlines, but about whether the house will hold, whether food is enough, and whether loved ones are safe.

Ideally speaking, learning should continue during these times. But insisting that it remains uninterrupted is, quite frankly, an oversight that already borders on impracticality and insensitivity. Teachers and school administrators, themselves victims of the same floods, are often obligated to deliver lessons despite facing similar challenges at home. But students, especially the most vulnerable, are expected to perform academically while living in evacuation centers or homes with ankle-deep water.

In 2023, a UNICEF Philippines study found that 76%

of students reported increased anxiety and fatigue during remote learning in disaster-stricken areas. The pressure to keep up academically amid chaos does not lead to learning, but to burnout. This proves that the physical toll of online classes is matched by a mental one.

I remain firm in my belief that

I remain firm in my belief that we can still bridge learning gaps without forcing education during crisis moments. During these times I don't see anything wrong if we pause learning temporarily. The safety and mental well-being of students should come before academics. True, education is important but so is empathy. In my hometown Macababad today, survival is the priority. Learning can wait.

ical supplies amounting to ₱24.6 million.

These transactions have been labeled by COA as "irregular" and fraudulent, violating multiple laws, including RA 9184 (Government Procurement Reform Act), RA 3019 (Anti-Graft and Corrupt Practices Act), and RA 7080 (Anti-Plunder Law).

The Office of the Ombudsman found sufficient grounds to grant the complainants' prayer for preventive suspension of the involved officials "considering that there is strong evidence showing their guilt" and the charges against them "may warrant their removal from office."

The Ombudsman further stressed that allowing the respondents to remain in their posts would com-

Reading on May 31, 2011, and later approved on Third Reading on June 6, 2011, with 241 "Yes" votes from the members of the House of Representatives.

On June 13, 2011, the bill was transmitted to the Senate and passed on Feb. 7, 2012. The Conference Committee report was ratified on March 6, 2012 by the House, and approved by the Senate on March 7, 2012.

On April 25, 2012, it was transmitted to then-President Benigno S. Aquino III. Finally, on May 15, 2012 – a full year after it was filed by Cong Tarzan - Republic Act 10164 was enacted into law.

A month later, on July 21, 2012, the people of Mabalacat were called on to decide on their fate via plebiscite. Out of 19,542 residents who voted, 14,078 (72%) voted for cityhood.

On July 23, 2012, the results of the plebiscite were published in the Official Gazette Vol. 108, No. 30, Pg. 3633 – Mabalacat is a City, Cong Tarzan's hard work had come to fruition.

Today, exactly 13 years later, Cong Tarzan's namesake and son, Carmelo 'Pogi" Lazatin, Jr. – now serving as the incumbent Pampanga 1st District Representative – looks back on his father's legacy for the city of Mabalacat.

"The cityhood of Mabalacat is one of the greatest legacies he could have left for the First District of Pampanga. It opened the doors for development in Mabalacat, and with that comes a ripple-effect for its nearby areas," Cong

Pogi said.

Now that he has assumed his father's mantle, Cong Pogi vows to make strides in working towards further development, not only in Mabalacat City, but for the whole First District of Pampanga. '

"I stand on the shoulders of a giant," said Cong Pogi, "My father has laid the groundwork, and I am determined to continue his work and serve the First District of Pampanga to the best of my ability."
