

# Collapsed in 2024, Arayat flood control project in danger again

#### **By Punto News Team**

ARAYAT, PAMPANGA – Repair and rehabilitation of the slope protection in Barangay Candating here that collapsed in August 2024 are yet to be completed and already it is in danger of a complete collapse with the onslaught rampaging waters of the Pampanga River wrought by the southwest monsoon and the recent series of weather disturbances.

On July 29, Gov. Lilia "Nanay" Pineda personally went on-site inspection and delivered relief packs to the 387 affected

ANGELES CITY -- Pampanga 1st District Rep. Carmelo "Pogi" Lazatin, Jr. is seeking the support of the Provincial Government of Pampanga and the Local Government Units of Angeles, Mabalacat, and Magalang for two House measures on the Sapangbato Watershed here.

On July 29, Lazatin simultaneously filed House Bill No. 2423, "An Act Declaring Sapangbato as a Protected Area in the Province of Pampanga, Providing For Its Management And For Other Purposes," and House Resolution No. 77. "Renaming the Reforested Portion of Barangay Sapangbato in Angeles City Intended For Watershed To Renato 'Abong' Tayag Watershed In Honor Of His Exemplary Service And Contribution To The Preservation Of The Watershed."

In separate letters dated July 31, addressed to Gov. Lilia "Nanay" Pineda, Ange-

# Nanay Gov: Purpose-driven, people-centric leadership in local governance



CITY OF SAN FER-NANDO – "Leadership is not just a position, but a responsibility. Let this program be a reminder to lead with purpose and for the people, and to always serve with compassion, not for personal gain."

Thus, Gov. Lilia "Nanay" Pineda urged local officials to embrace a style of leadership anchored in purpose, unity, and public service in her speech at the Leadership, Ethics, Accountability, and Development (L.E.A.D.) Program held at the Kingborough International Convention Center here on Aug. 5.

Spearheaded by the Provincial Government of Pampanga, in coordination with the Department of the Interior and Local Government, the L.E.A.D. Program seeks to enhance the leadership capacity of local officials by strengthening their understanding of ethical governance, accountability, legislative functions, and development-oriented leadership.

Also present during the program were Vice Gov. Dennis "Delta" Pineda, sangguniang panlalawigan members, mayors and vice mayors from various cities and municipalities, as well as members of the sangguniang bayan and sangguniang panlungsod across the province.

In her message,

the governor also reiterated her call for unity among public servants regardless of political affiliations.

DILG Undersecretary Marlo Iringan, who also graced the event, lauded Governor Nanay. "That's the mindset of a true leader," he said, commending her efforts to promote unity among local leaders.

Iringan also reminded the participants that public officials are not above the people, but rather among them, and that they are entrusted with the duty to remain present, available, and responsive to the needs of their constituents.

Discussed during the program were

various topics crucial to local governance, including ethical leadership in public service as presented by the Civil Service Commission; the role of local government units in the anti-illegal drugs campaign by the Philippine Drug Enforcement Agency; environmental responsibility in local legislation by the Department of Environment and Natural Resources; Sangguniang Panlalawigan Ordinance No. 878 by the Provincial Legal Office; and local legislation and the functions of standing committees discussed by the DILG. # Quezon's life inspires Aurora youth to lead with purpose

# Thousands get aid as SM ramps up relief efforts in CL

CITY OF SAN FERNANDO
-- As torrential rains brought
by Typhoons Crising, Dante,
Emong, and the southwest
monsoon inundated large
parts of Luzon, SM Foundation Inc., in partnership
with SM Supermalls and SM
Markets, swiftly mobilized its
Operations Tulong Express
to provide immediate relief
to thousands of families
displaced by the widespread
flooding in Central Luzon.

With several provinces placed under a state of calamity, SM Foundation distributed a total of 3,019 Kalinga Packs, each containing food and basic essentials, prioritizing the

hardest-hit barangays and vulnerable sectors across Bulacan, Pampanga, Tarlac, Olongapo, and Bataan.

In Bulacan, SM City Marilao led large-scale relief operations, reaching 1,500 flood-affected families in the town's most disaster-prone barangays. With Marilao placed under a state of calamity following extensive damage to homes, infrastructure, and farmlands, the mall mobilized support to reach the severely affected barangays and deliver aid. Simultaneous relief efforts were also conducted by SM City Baliwag and SM Center

Pulilan, where volunteer teams braved flooded areas to deliver Kalinga Packs to 400 households in barangays Tibag and Poblacion in Baliwag, and Tabon in Pulilan.

Targeting vulnerable sectors such as farmers and marginalized communities, SM malls across Pampanga provided aid for displaced families. SM City Clark delivered relief to 130 farmers in Barangays Dampe and Maligaya in Floridablanca, while an additional 100 kalinga packs reached evacuees in Mabalacat City.

#### **GSIS REPURPOSED Gambling Service Investment Scheme**

"WHY DID the Government Service Insurance System invest in online gambling?"

Asked Senate Deputy Minority Leader Risa Hontiveros in her privileged speech on Aug. 5, as she criticized the GSIS for allegedly investing over P1 billion of its funds in the online gambling platform DigiPlus.

"GSIS got into this when Digiplus shares were being offered at a peak of P65.30. Those shares have since dropped to a low of P13.68. That's a loss! In the first place, what was GSIS thinking, investing funds in online gambling?" she said.

Hontiveros went on to question why the GSIS is using public funds, particularly those of government employees, as capital for gambling. "Eh, tayo nga po, mga kasamang nagtatrabaho sa gobyerno, ni hindi pwedeng tumungtong sa casino lalo na hindi pwedeng magsugal doon. Kaya bakit ang GSIS, todo taya, at ginawang puhunan ang pera ng public employees sa sugalan."

And at a time when the nation has come practically as one in standing against online gambling!

"As of now, we in the Senate, along with the House of Representatives and even Malacañang, are all taking strong initiatives and firm stands against online gambling because of its harmful social costs," Hontiveros noted.

"So why is GSIS doing the opposite? Why is GSIS investing the retirement money of public servants to seemingly expand the e-gaming industry? We need explanations," she added.

Why, oh why, indeed?

Maybe, just maybe, quietly GSIS has repurposed itself to a new meaning – Gambling Service Investment Scheme.

GSIS into online gambling is but the latest manifestation of the "reckless and questionable investment decisions" under the current GSIS leadership.

"The guardrails we have put in place to guide and protect GSIS investments are seemingly being breached," Hontiveros said.

Aside from its questionable investment in online gambling, GSIS also maintains a 0.82% stake in Del Monte Pacific, a company "teetering under \$2.3 billion in debt" and facing massive write-offs.

"This investment has already incurred an estimated paper loss of P19.1 million for GSIS, representing a 32.5 percent decline in its stake," noted Hontiveros, calling on the Senate to act swiftly and review the policies, procedures, and guidelines governing GSIS's investment decisions.

"We should strengthen GSIS's investment policy compliance and oversight. We should increase transparency and accountability in their investments. And we should plug policy gaps and clarify ambiguities,"

# Ang Kabalintunaan ng Kawalang-Hustisya

# Baha, sugal, at ang kamatayan ng isang kabataan

ISA IYON sa mga gabing ang mga kalsada ng Malabon at Navotas ay tila naging isa na sa mga ilog at dagat. Bumalik na naman ang malalakas na ulang dala ng habagat, at kasama nito ang pamilyar na takot na unti-unting pumapasok sa mga tahanan ang baha. Pero sa gabing iyon, hindi lang baha ang nawala—kundi isang ama.

Noong Martes, July 22, hindi nakauwi ang ama ng anim na anak. Sanay na ang mga bata sa baha pero hindi sa ganitong misteryosong pagkawala ng kanilang tatay. Nagsimulang mag-alala ang buong pamilya. Ang panganay, si Dion Angelo—kilala sa bahay bilang Gelo at sa mga kapwa sakristan sa Señor de Longos Mission Station bilang Dion—ay lumibot sa mga kalsada kasama ang kanyang nanay na si Jennylyn na may kapansanan (bulag ang isang mata). Nagtanong-tanong sila, lumusong sa maruming tubig-baha na abot-baywang sa ilang lugar, puno ng takot at pag-aalala.

Hindi nila alam na na-aresto pala nang walang warrant ang hinahanap na tatay ni Gelo at nakakulong dahil diumano sa paglabag sa PD 1602—pagkakasangkot daw sa illegal gambling. Naaktuhan daw siya na nakikipaglaro ng kara y krus. Ang batas na ito laban sa illegal gambling, na ipinasa noong panahon ng yumaong ama ng kasalukuyang presidente ng Pilipinas, noong 1978, ay sinasabing proteksyon daw para sa mahihirap laban sa bisyo ng sugal. Pero makalipas ang ilang dekada, walang naaresto ni isa sa mga malalaking gambling lord. Ang mahihirap lang ang biktima ng batas na ito—katulad noong panahon ng Tokhang, kung saan quota sa mga drug suspect ang naging tiket para sa promosyon.

Ito ang matinding kabalintunaan: habang kinakasuhan ang mga dukhang nagsusugal ng kara y krus, wala tayong magawa sa pinakamalaking operator ngayon ng negosyo ng sugal sa pamamagitan ng online gambling: ang gubyerno sa pamamagitan ng PAGCOR. Dati, napaka-istrikto ng gubyerno sa public accessibility ng pasugalan. Ayon sa batas, hindi pwede ang slot machines sa mga supermarket at mataong lugar. At kailangan pa ng bouncer sa mga casino para sitahin ang mga menor-de edad at mga walang katibayan na kumikita sila ng higit sa 50k kada buwan. Ngayon, may access na ang pasugalan sa bawat cellphone, pwede nang magsugal sa silid, sa jeep, sa kama, ang kahit na sino, 24/7. Pwede pa ngang umutang sa Gcash ng pansugal.

Bakit pa pag-aaksayahan ng panahon ng kapulisan na arestuhin ang naglalaro ng kara y krus kung kahit mga bata ay pwede nang mag-sugal sa cellphone bago pa man sila matutong mag-multiply? Kung addictive ang sugal, ang pinakamalaking pusher ng adiksyon sa sugal sa kasalukuyan ay walang iba kundi sariling gubyerno natin sa pamamagitan ng PAGCOR—para daw kumita ang gubyerno ng pandagdag gastusing pampubliko.

Katatapos lang naming maglabas sa CBCP ng isang sulat pastoral laban sa online gambling na may pamagat na "Isang Pahayag Ukol sa Moral at Panlipunang Krisis Dahil sa Online Gambling. Pagkaraan ng ilang araw, naglabas naman ako ng isa pang sulat pastoral para sa Diocese of Kalookan tungkol sa pagbaha at korapsyon sa public works na pinamagatang "Kapag Tumataas ang Tubig at Nalulunod ang Katotohanan." Hindi ko alam na sa trahedyang sasapitin ng pamilya ni Gelo ay pagtatagpuin ng kapalaran ang magkatambal na problema ng korapsyon ng baha at sugal.

Si Gelo, 20 years old, isang third-year college student, ay siya sanang pag-asa ng pamilya. Tahimik, maaasahan sa pamilya, at tapat na sakristan sa simbahan. Panganay sa anim na magkakapatid, determinado sanang makatapos ng kursong HRS Human Resources Services sa Malabon City College para matulungan ang pamilya na makaahon sa kahirapan.

Pagkalipas ng 24 oras na walang balita tungkol sa kanyang ama, hinikayat ni Gelo ang kanyang ina na ipagpatuloy ang paghahanap kahit baha. Nilibot nila ang lahat ng police stations sa Caloocan, Malabon, at Navotas pero walang makapagbigay ng sagot.

Kinabukasan, naghiwalay pa sila ng kanyang ina para mas marami daw silang mapuntahan at mapagtanungan. Sinamahan si Gelo ng kanyang lola sa paghahanap, at doon nga nila natagpuan ang kanyang ama sa isang Police Station sa Caloocan. Parang nadurog ang kanyang puso sa nakita: sa isang munting silid sa likod ng police station kabitkabit ang mga posas sa tatay niya at lima pang

mga arestado rin. July 22 nang mawala, ipinablotter sa lahat ng police stations (na sanay namang magpalitan ng information sa isa't isa.) Pero July 25 na nang aminin ng kapulisan na nasa custody nila ang pinaghahanap na ama, at nasampahan na daw ng kaso noong araw mismong iyon. Unang araw pa lang nakiusap ang ama na ipaalam ng pulis sa pamilya ang pagkakaaresto sa kanya pero hindi siya pinagbigyan. ₱30,000 daw ang bail—isang imposibleng halaga para sa pamilyang halos hindi na makasapat sa pang-araw-araw na gastusin at bayarin sa eskwela. Pati nga bayad sa bawat dalaw sa presinto mabigat sa bulsa nila.

Kaya binalik-balikan ni Gelo ang ama para dalhan ng pagkain at lakarin ang kaso. Inaraw-araw ang paglusong sa maitim na tubig-baha hanggang magsimulang lagnatin nang Sabado ng gabi. Humingi pa ng paumanhin sa ina nang umaga na ng Linggo na hindi siya masamahan nito sa presinto dahil masakit ang katawan. At ibig pang magpasabi na hindi rin muna siya makakapag-serve sa Misang Linggo sa bagong simbahan ng Longos Mission Station.

Sinabihan siya ng nanay niya na uminom ng paracetamol at magpahinga muna. Nang gabing iyon bukod sa nilalagnat, nanginginig na rin siya. Pero ang ipinag-aalala pa rin niya ay ang kanyang ama, at kung paano makahabap ng pambayad sa piyansa. Na-trauma pa ang tatlong taong gulang na bunsong kapatid niya dahil siya ang unang nakatuklas kalaunan na wala na palang buhay ang kanyang Kuya Gelo. Linggo ng gabi, July 27 nang pumanaw ang binatang naging haligi ng pag-asa ng pamilya. Ang dahilan: leptospirosis, isang sakit na dala ng ihi ng daga sa maruming baha na nilusong niya sa paghahanap sa kanyang ama na inaresto diumano dahil sa kara y krus.

#### ISANG SIGAW NA UMAABOT SA LANGIT

Abot-abot ang paghihinagpis ng ama nang mabalitaan mula sa presinto ang pagkamatay ni Gelo. Kahit anong pag-alalay ng misis, sarili pa rin ang sinisisi. Pakiwari ba niya, pinabayaan na sila ng Diyos. Ni hindi alam kung ano ang gagawin para makapagbayad ng piyansa para makauwi, para maipagluksa at maipalibing ang panganay

Samantala, ang asawa niyang may kapansanan (bulag ang isang mata)—at ang lima pang nakababatang anak ang nagbantay sa burol na literal na nasa kalsada, dahil wala silang pambayad sa komersyal na memorial chapels para sa burol kay Gelo.

Paano ito nangyari? Paano mawawala ang buhay ng isang kabataan dahil sa sunod-sunod na dagok ng kapalaran? At ano bang magagawa nila kundi ang patuloy na lumusong sa baha kung sira pa rin ang flood control gate sa kabila ng bagong buhos na namang 281 milyong piso para ma-repair ito?

Sa kabilang banda, patuloy na kumokota ang kapulisan sa pag-aresto sa bisa ng lumang batas laban sa sugal na ginagamit ngayon na pam-bully sa mahihirap habang tahimik na winawasak naman ng talamak na online gambling ang mga pamilya. Paano tayo nasanay sa ganitong kultura ng pang-aabuso ng kapangyarihan ng ilang mga alagad ng batas na halos ginawa nang normal na kalakaran ang pagaresto nang walang warrant, pati ang panghihikayat na aminin na lang sa korte ang paratang para daw ma-abswelto at isanlibong piso lang daw naman ang penalty. Kaysa nga naman manatili sa kulungan at magpabalik-kalik sa husgado at magbayad pa ng abugado. Naisip ko: ilang libo katao ang umaamin sa hindi nagawang kasalanan dahil walang kalabanlaban sa batas? Ano na ang nangyari sa prinsipyong pinasikat ng yumaong Presidente Magsaysay "Those who have less in life should have more in law."?

Ang walang katuturang kamatayan ni Gelo ay isang talinghaga ng ating panahon. Ang kanyang kwento ay sumisigaw sa langit—at sa ating lahat. Isinisigaw ang tanong: ilang Gelo pa ba ang kailangang mamatay bago natin harapin ang mga sistemikong kawalang-hustisya na hindi lang kumikitil ng kabuhayan kundi ng mismong buhay ng ating mga kababayan?

#### What Now?

AS FLOODWATERS in my beloved hometown Macababad continue to subside and people's lives slowly begin to acquire a state of normalcy, my town mates' frustration, anger, angst and collective gnashing of the teeth that were overwhelmingly prevalent just a week ago are also starting to lose steam, with the flames that burned brightly at the height of the devastating floods now being extinguished again by their apathy and indifference.

Antini tana mu ba talaga? Alang pamiyaliwa keng ningas cogon?

It is ironic how when a disaster or a calamity strike us, we become emboldened to question a broken system and demand accountability from our leaders. But the moment we start to receive relief goods, cash assistance, *libreng sakay* and various forms of *ayuda* complete with tarp and photo-ops, we revert to being complicit and willing accomplices to that same broken system.

Our local government must act now. The Philippine News Agency has reported that in August 2024, President Bongbong Marcos inaugurated the ₱7.57 billion Integrated Disaster Risk Reduction and Climate Change Adaptation (IDRR CCA) Project Stage 1. This project aimed to dredge and widen key tributaries—the Third River, Caduang Tete, Eastern Branch, and Sapang Maragul.

So now, the Macababad townsfolk must actively and consistently petition the national government to fast-track the proposed Phase II of the IDRR CCA and the Central Luzon–Pampanga Floodway and San Antonio Swamp Ring Dike Project, an equally-important project designed to channel excess flow from Upper Pampanga River directly to Manila Bay via a 60 km, 400 m wide floodway.

As for another immediate step? Enforce the regular desilting at Pampanga Bay's mouth and maintain channel gates and dikes all throughout the year - not only during the typhoon season.

In a news report by Punto CL, Governor Lilia Pineda has urged DPWH to prioritize clearing operations downstream to prevent backflow of floodwaters into Macabebe and Masantol.

Nanay Gov. explained that although the provincial government is doing its part, solving the problem requires inter-agency coordination and a serious investment from the national

government. She added that the desilting must cover the 34-kilometer stretch of the Pampanga River, which covers the towns of Arayat, Candaba, Macabebe, Masantol, Lubao, and Sasmuan.

At the municipal level, local investments should include pump systems in low barangays, elevated roads in flood prone corridors, and rehabilitation of drainage canals. Did you know that as of today, our town does not even have a working pumping station in place? Sad but true. In the many instances that millions were spent on elevating roads, the same cannot be said for pumping stations in key areas, and a regular desilting of river channels in Purmerung Tete, Caduang Tete, Mataguiti, and Candelaria.

Lest we forget, we need to integrate nature based solutions: reforest upland watersheds, restore mangrove buffers along delta zones, and rehabilitate wetlands. These are strategies that are tested and proven to absorb tidal surges and reduce sediment load.

The time has come for us to end an era defined by passive spectators who turn devastating and painful flood season into humorous memes.

We should demand public disclosure on the funding and timeline of the IDRR CCA Stage II project, require third-party audits of flood control contracts, insist on quarterly updates on river dredging progress and sluice gate repairs, and involve local groups and various sectors to monitor the maintenance of canals and waterways.

The next chapter for our town is rehabilitation—with long term infrastructure, resilient environmental strategies, and bold citizen oversight. Only then can our community transform from "Macababad" into a model of climate litigation resilience - and ensure that seasonal floods become a thing of the past.

The court notes and admits into the records the Amended Petition dated July 4, 2025, filed on July 7, 2025, pursuant to the Order dated June

In her verified Amended Petition for correction of entries in certificate of live birth and cancellation of second certificate of live birth, petitioner Kristal Maye Briones Bonus (Kristal Maye) prays that after due notice and hearing, judgment be rendered:

During registration, petitioner was told that she could not use her father Country registration, petitorier was told that she could not use ner latiner (Edwin)'s surname, Mallari, because her parents were not married. Thus, she dropped the "Mallari" and officially started using "Kristal Maye Briones" - under which her Certificate of Live Birth (San Fernando Birth Certificate) was registered and issued by the Philippine Statistics Authority (PSA).

On December 18, 2021, the Petitioner, using the name Kristal Maye Briones, got married to Prince Jessie A. Bonus. Consequently, Petitioner's name became "Kristal Maye Briones Bonus".

Sometime in 2024, Petitioner's twin sister informed her that, in the Office of the Civil Registrar of Angeles City, there were Certificates of Live Birth that were first registered under the names "Angelika Briones Amat" and "Angela Briones Amat" - apparently pertaining to the Petitioner and her

The Petitioner was shocked to discover the existence of the Angeles Birth Certificate, as she knows her name to be "Kristal Maye Briones" and not "Angelika Briones Amat". Even more shocking was the revelation that the father indicated on said Angeles Birth Certificate was someone named "Emiteryo U. Amat" (Emiteryo) - who was certainly not the father (Edwin) she knew and grew up with and was a stranger to her.

Later, Petitioner found out that Emiteryo was her mother's legal husband and the biological father of her half-blood older siblings, Jolly Briones Amat (Jolly), Jenalyn Briones Amat, and Analiza Briones Amat.

The Petitioner has never seen or met Emiteryo in her entire life until recently, on February 6, 2025. As aforementioned, Petitioner has always known Edwin to be her biological father since birth.

After discovering the Angeles Birth Certificate, Petitioner asked her father, Edwin, about the discrepancies in her two birth certificates since she could no longer ask her mother, Shirley, who passed away on January

Edwin was also shocked to learn about the existence of a Certificate of Live Birth under the name "Angelika Briones Amat", yet he readily affirmed and assured Petitioner and her twin sister that "siguradu ku, anak da kayu" (I am sure you are my children).

To provide relief and peace of mind to the Petitioner, she and Edwin underwent DNA testing at the EasyDNA, a DNA Diagnostics Center, in Angeles City, where the results yielded a 99.998% probability of paternity.

Assured by the results, Petitioner sought legal help to start the process of cancelling her San Fernando Birth Certificate and to correct her Angeles Birth Certificate as advised by the PSA upon discovery of the existence of the latter birth certificate.

As such, the Petitioner and her twin sister called their eldest half-blood sibling, Jolly, to inform her about the existence and contents of the Angeles Birth Certificate and to enlist her help in contacting Emiteryo.

Shocked by the revelation, Jolly readily called her biological father, Emiteryo, and Informed him about Petitioner's Angeles Birth Certificate. She then helped and accompanied Petitioner and her twin sister to personally meet Emiteryo (later found to be "Emeterio") on February 6, 2025.

Emeterio was also shocked to learn about the existence of the Angeles Birth Certificate and affirmed that he was not the biological father of Petitioner and her twin sister.

The existence of the Angeles Birth Certificate at the records of respondents affects the Petitioner's identity given the fact that her name ever since she was a child is "Kristal Maye Briones Mallari" and her biological father is, in fact, Mr. Edwin L. Mallari and not Mr. Emeterio U.

Based on the foregoing, it is evident that although the San Fernando Birth Certificate of the Petitioner reflects her correct name (using her mother's surname) and filiation, it is void there being a previously registered birth certificate, and that it was erroneously filed in a place other than the Petitioner's actual place of birth. On the other hand, the Angeles Birth Certificate was filed in the correct place of birth but erroneously reflects, her name and her true filiation;

Petitioner now seeks not only to correct the name of her biological father (Edwin L. Mallari), but also to correct her name and use Edwin's surname, and be henceforth legally known as "Kristal Maye Briones Mallari (as her maiden name) and "Kristal Maye Mallari Bonus (as her married name).

Petitioner declares that the instant petition is not in any way filed to mislead the public or for any other fraudulent purposes and does not in any way prejudice public interest.

Finding the Petition to be sufficient in form and substance, the court hereby SETS the case for initial hearing on October 15, 2025 at 1:30 in

3. Directing the concerned civil registrars and the Philippine Statistics Authority (PSA) to carry out the necessary changes in their records accordingly

#### The material allegations of the Amended Petition states:

Petitioner Kristal Maye was born on April 11, 2000 in Angeles City, Pampanga to parents, Shirley C. Briones (Shirley) and Edwin L. Mallari ("Edwin"). She was named and thus had been using the name "Kristal Maye" from birth.

On May 26, 2000, Petitioner was baptized under the name "Kristal Maye Briones'

When Petitioner started schooling, she used the name "Kristal Maye Briones Mallari" until she graduated in high school.

The Petitioner has been using the name "Kristal Maye Briones Mallari" in both public and private transactions. She is known by her siblings, respondents Sherwin, Sherwina, and Cheenie, and their community by

Likewise, the Petitioner's father, Edwin, has been known as her biological father since her birth. This fact is also known by her siblings and their community.

Sometime in November 2019, Petitioner, along with her twin sister, Kricel Anne, went to SM Downtown (Customer Service) in the City of San Fernando, Pampanga to obtain their respective Certificates of Live Birth, as Petitioner and her twin were planning to get married with their respective partners soon. However, the twins were informed that they had no Certificates of Live Birth recorded therein.

Thus, the twins went to the Office of the Civil Registrar of the City of San Fernando, Pampanga, to late-register their birth, so that their respective Certificates of Live Birth would be issued.

More, the court directs the petitioner to serve copies of the Petition and its annexes upon the Office of the Solicitor General, the Philippine Statistics Authority, and the Office of the Local Civil Registrars of Angeles City and City of San Fernando, Pampanga and to each of the private respondents, within five (5) calendar days from receipt of this Order, and submit proof of their compliance within three (3) calendar days from completion of service.

In turn, the court directs the Office of the Solicitor General to enter its appearance in this case for the State within seventy-two (72) hours from receipt of the Petition and its annexes.

Finally, the court notes the Compliance with Manifestation of Petitioner stating, through their Joint Affidavit of No Relation, that they are not related to the branch clerk of court.






# Arrested in entrapment, San Simon mayor is no stranger to tangling with the Anti-Graft Law

SAN SIMON, PAMPANGA – Today, Aug. 6, Mayor Abun-dio "JP" Punsalan Jr., is set to undergo inquest proceed-ings for graft and corruption in the wake of his arrest in an entrapment operation at a restaurant in Clark Freeport

Zone yesterday, Aug. 5.

A post-operation report showed that the entrapment was conducted by the National Bureau of Investigation-Intelligence Service led by assistant director Noel C. Bocaling, with the assistance of the technical intelligence division, counter-terrorism division, criminal intelligence division, counter-intelligence division, intelligence research and analysis division, and the Pampanga District Office of





The operation reportedly stemmed from a complaint of Real Steel Corp., an investor in San Simon, alleging Punsalan was asking for P80 million – an initial P30 million, and the remaining P50 million in installment – in exchange for a local government resolution favorable to the company

Punsalan and his alleged cohort, identified as a certain Dr. Ed Ryan Dimla alias Doctor Yang, were arrested in the act of receiving the initial P30 million payment.

Also taken into custody by the NBI was a security personnel of the mayor after he yielded firearms and live ammunitions which will be

subjected to verification. The NBI said Punsalan and Dimla will face charges

for violation of RA 3019 (Anti-**Graft and Corrupt Practices** Act), among other violations of the Revised Penal Code.

#### SUSPENSION **VETERAN**

The entrapment is only the latest in Punsalan's brushes with RA 3019. On June 24, 2024, the

mayor was served with a 60-day preventive suspension order by the provincial government.

Signed by then-Gov. Dennis "Delta" Pineda, the order was based on Sang-guniang Panlalawigan Resolution 8538 dated April 29, 2024 recommending suspension on the grounds of Administrative Case No. 01-2024 against Punsalan for alleged "gross neglect of

duty, grave abuse of authority, gross misconduct in the performance of duty, and violation of the Anti-Graft and Corrupt Practices Act

The suspension was intended to ensure that the ongoing case against Punsalan "will remain unbiased and uninfluenced."

In June 2023, Punsalan, along with Vice Mayor Roma-noel "Dading" Santos and five members of the sanggu-niang bayan were suspended by the Office of the Ombudsman for "simple neglect of duty and simple misconduct" in the reclassification of a parcel of land in 2020.

On July 9, 2021, the Department of the Interior and Local Government served Punsalan a six-month

suspension order after the Sangguniang Panlalawigan of Pampanga found him and five other councilors guilty of "dishonesty, grave misconduct in office, gross negligence, gross dereliction of duty, and grave abuse of authority" over the purchase of that parcel of land near the municipal hall in 2020.

On Nov. 6, 2020, Governor Pineda ordered the two-month preventive suspension of Punsalan Jr. and councilors Romanoel Santos, Mark Macapagal, Irene Dagdag, Randell Bondoc, Archiebald Basilio, and Alekseyevich Vergara on the strength of SP Resolution No. 5529 arising from the same administrative case over the land purchase.

# Cong Pogi wants expanded mental health coverage from PhilHealth

ANGELES CITY -- Pampanga 1st District Rep. Carmelo "Pogi" Lazatin, Jr. is seeking mental health emergency, psychiatric, and neurological services to be included in the PhilHealth Mental Health Benefit Package for Out-Patient, through House Bill No. 2933, "Expanding The Primary Care Package Under Phil-Health To Include Benefit Package For Mental Health And For Other Purposes,"

which he filed on Aug. 4.
"There is a dearth of mental health services including hospitals and facilities in the country for individuals facing mental health challenges," said Lazatin in the bill's explanatory note.

The current benefit packages for outpatient offered by PhilHealth amounts to P9,000 for General Health Services and P16,000 for Specialty Health Services annually.

Lazatin notes that due to the expensive treatment for mental health disorders, the current benefit package is not enough; hence, the need to expand its coverage

# Crypto scam hub busted in Clark, 27 Chinese nationals arrested

CITY OF SAN FER-NANDO - Police uncovered a suspected cryptocurrency scam and illegal offshore gaming operation at the Clark Freeport with the arrest on Aug. 5 of 27 Chinese nationals and the discovery of eight Filipina women allegedly working in online scam activities.

Acting on Mission Order No. 2025-195 dated July 25, 2025 issued by the Fugitive Search Unit-Bureau of Immigration, Police Regional Office 3, together with the BI and military intelligence units conducted a predawn raid on a resort compound along Jose Abad Santos Avenue in the freeport.

Twenty-four Chinese nationals, 22 males and two females were caught in the act of operating a cryptocurrency investment scam hub, and eight Filipina women were also discovered on site, police said.

An hour later, a follow-up operation under Mission Order No.

2025-219 dated August 4, 2025 also issued by the FSU-BID was conducted at Unit 31, Clark Hills Village D, Sacobia Street, resulting in the arrest of three more Chinese nationals engaged in phishing and other scam-related activities. Dozens of computer workstations and electronic devices were seized and are now undergoing forensic examination, police said. In a statement, PRO3

This, President Ferdinand R. Marcos Jr. vowed in the latest episode of "BBM Podcast" aired over GMA on Aug. 4 night, hinting that he was aware which officials benefited from these failed or nonexistent projects.

The president said he already had "some names" of the private contractors involved in these anomalous projects but did not identify

them, only saying that "they know who they are."

"They are very notorious. They have been doing this for a long time," Marcos Jr. said. "I'm sorry, but they will have to account for their actions, and they will have to account for the expenditures that they have made that we did not see the results."

He emphasized that he is focused on solving the problem, not merely assigning blame. "You cannot fix the problem without knowing who to blame. So, one thing follows another."

"For us to fix the problem, we have to know what happened, where it went wrong, and who should be held accountable," furthered the president. "Someone must be held accountable because of the hardships our fellow Filipinos are going through. They deserve to know who is responsible,

and someone has to answer for their suffering."

Asked if there were allies among these corrupt officials, Marcos said: "Sorry, but I can no longer consider you an ally if that's what you're doing. I don't want to be allied with you anymore."

In his 4th State of the Nation Address on July 28, Marcos Jr. directed the DPWH to submit a list of all flood control projects

under his administration to determine which ones were failures, unfinished, "ghost" projects.

Said the president: "So, the people will find out. Those from Barangays 1, 2, 3 will say, 'That's supposed to be in our area, but we never saw anything like that." Then they should report it."

"We already have some names that are coming up. First of all, corporations that, mga contractor na talagang kitang-kita na hindi maganda ang trabaho nila. We will put them on a blacklist. Hindi na sila puwedeng magkontrata sa gobyerno, he added.

families.

Even as the governor lamented the delay in the project completion causing further anxiety and suffering to the residents on the riverbanks, she called on the Department of Public Works and Highways not only to facilitate "with utmost urgency" the repair of the slope but also to review similar infrastructures on implementation to check on their structural integrity.

The collapsed slope protection was under the 23CG0041 Flood Management Program— Construction/Rehabilitation of Flood Mitigation Facilities within Major River Basins and Principal Rivers funded with P91,485,522.95 by the General Appropriations Act. Construction started on March 4, 2024, with completion date set on Nov. 4, 2024.

Pineda has also renewed her call for the dredging of the Pampanga River as a flood-mitigation measure.

#### **DBM to DPWH:**

Visiting the Candating on Aug. 4, Budget Secretary Amenah Pangandaman

urged the DPWH to check on the design of various projects. "Kailangan baguhin na natin mga design ng flood control project."

Even as the Candating flood control project is still under warranty, thereby repairs are at no cost to the government, Pangandaman enjoined contractors to ensure that all projects must be of high quality.

She seeks to make flood control projects transparent to the public. "Gagamit po kami ng mga satelite at drones to check... Para makita kung tama ang pagpapagawa ng mga proyekto."

This, even as she called on the public to take photos of flood control and other road projects to monitor the developments and ensure there is no delay and corruption.
