# Pampanga rivers flooded with funds

# Top 10 contractors get P6.02-B

►ITY OF SAN FERNANDO – Major river channels in Pampanga are as much inundated with floodwaters at every downpour as with government funds in the never-ending engineering interventions for the protection of their slopes and embankments.

So, shows a cursory look at the list of flood control projects in the sumbongsapangulo.ph website. At that, focusing only on the Top 10 contractors who got most of the projects reported to have been completed from 2022 to 2024.

Abacan River - P666.946-M

At the Angeles City side alone, three construction companies reportedly completed mainly slope protection projects, to wit:

1)Three-In-One Construction with four projects amounting to P178.621 million;

2) Tonka Construction with two projects at P91.992 million; and

3) Radians Builders & Supply Corp., also with two projects at P29.643 million.

The three companies getting a total funding of P300.256 million.

Downstream Abacan River in Mexico was A. D. Gonzales Trading Co. Inc. with two diking and slope

# Capitol rushes to Sta. Ana to help in clearing waterways

CITY OF SAN FERNANDO
-- The Pampanga provincial
government rushed assistance
on Sept. 2 to Sta. Ana officials in
opening floodgates and clearing
clogged creeks to restore water
flow after flooding affected
several barangays.

The flooding was triggered by a massive buildup of garbage along Matubig Creek in Barangay San Agustin and the failure to open a floodgate under the responsibility of the National Irrigation Administration.

According to reports from the municipal and local disaster risk reduction and management offices, some 30 truckloads of waste—much of it carried downstream from other areas—blocked the waterway, causing floodwaters to inundate nearby homes and farmland.

Floodwaters affected homes and farmland in nearby areas.

Vice Gov. Dennis "Delta" Pineda personally coordinated with Mayor Dinan Labung in deploying heavy equipment, including backhoes, to remove debris and desilt the creek.

The vice governor said gate operation responsibilities need clearer definition.

earer definition. "Responsibilities over check gates are often passed around. If these gates had been raised on time, residents would not have suffered such damage," he said.

Pineda plans to meet with NIA officials and other mayors to clarify the management of floodgates.

Labung lauded the provincial government for its prompt response.

"If not for the immediate action of the governor and vice governor, the damage could have been much worse," the mayor said.

# CSFP to put up 'Rainbow House for Golden Gays'

CITY OF SAN FERNANDO --The city government here has stepped up its advocacy on social protection and inclusivity by establishing a "Rainbow House for the Golden Gays".

"I want them [LGBTQIA+] to not worry about their old age if they are not taken care of. We, your elected officials, will build a Rainbow House for the Golden Gays," said Mayor Vilma Balle-Caluag explaining the facility aims to provide shelter, care, and support for elderly members of the lesbian, gay, bisexual, transgender, queer, questioning, intersex, asexual, plus community.

The proposed site of the project—a former family learning resource center in Northville, Calulut—will be redeveloped in two phases.

The first phase will convert the building into an activity hub equipped with a conference room and reception area to host labor seminars, skills training, and

livelihood programs specifically tailored for the LGBTQIA+ sector and senior citizens.

The second phase will fully transform the facility into a

residential home that will offer compassionate care, safe housing, and a supportive environment for neglected and homeless LGBTQIA+ elders.

# Iwas-Putol: Health workers learn proper steps in caring for diabetic foot

CITY OF SAN FERNANDO --"Timely knowledge and action can save lives and limbs."

Thus noted Gov. Lilia "Nanay" Pineda as she expressed her strong support for a community lecture on diabetic foot care led by the Jose R. Reyes Memorial Medical Center (JRRMMC), in partnership with the Department of Health and the Provincial Government of Pampanga on Aug. 29.

The governor emphasized that strengthening community awareness and preventive practices is crucial to ensure early detection and management of diabetic foot ulcers—one of the most serious complications of diabetes that can lead to amputation if untreated. She underscored the need to equip frontliners and communities with the right information to avoid escalation of cases that require tertiary-level care.

The lecture was held as part of a continuing effort to raise awareness and build local capacity in preventing complications associated with diabetes, which remains one of the top 10 deadliest diseases in the Philippines.

The program brought together doctors, nurses, barangay health workers,

community volunteers, and local government unit representatives who play a key role in early intervention and patient education.

The event featured lectures from medical experts including DOH-3 director Dr. Corazon I. Flores who opened the program, Dr. Emiliano B. Tablante on diabetic foot infection, Dr. John Antolin TS Go on foot assessment, and Dr. Paolo M. Ramirez on treatment interventions.

Dr. Moonyen Almira Panganiban emphasized preventive strategies, Dr. Adrian Joseph Tablante outlined diabetic foot care guidelines, and Dr. Zakhira Mar R. Zipagan discussed basic wound care principles.

Dr. Ryan Jasper Ngo and Dr. Daveric De Jesus demonstrated wound care techniques, while Dr. Lorenz Rael D. Cruz explained appropriate dressing materials for various wound types.



Ending with a call to arms: "Together, let us reaffirm our pledge to serve with honor, to lead with integrity, and to build a Pampanga where governance is defined by trust, not tainted by

So, it cannot be helped to feel some bitter sense of irony as much in the statement of the is not even enough to just walk the talk. Live the mayors' league as in the very locus of its issuance. vow is what matters most.

It was but 22 days back, Aug. 5, at that same room of the same Kingsborough Convention Center that these same mayors took their "Panunumpa ng Lingkod-Bayań," vowing:

... ako'y maglilingkod nang buong katapatan, malasakit, at kahusayan, na walang kinikilingan.

Isusulong ko ang katarungan, katotohanan, at kapayapaan; ilalaban ko ang tama, lalabanan ang mali, at isasantabi ang pansariling interes alang-alang sa kapakanan ng bayan.

Paninindigan ko ang prinsipyo ng mabuting pamamahala: ang pagiging bukas, tapat, makatao, at makabayan.

Ipagkakaloob ko ang aking panahon, talino, at lakas sa matapat at makabuluhang paglilingkod sa mamamayan, anuman ang katayuan, paniniwala, o pinanggalingan nila.

Ako ay mananatiling tapat sa aking sinumpaang tungkulin sa buong panahon ng aking panunungkulan.

Hindi ko pababayaan ang tiwalang ipinagkaloob sa akin ng taumbayan.

Ako ay lingkod ng bayan. Taumbayan ang aking paglilingkuran.'

That pledge, serving as the leitmotif of the LEAD (Leadership, Ethics, Accountability, and Development in Local Governance) Program conducted by the Department of the Interior and Local Government and the Pampanga Provincial Government.

Ethics there fleeing with San Simon Mayor Abundio "JP" Punsalan's date with destiny over P30 million at Café Mesa in Clark Freeport Zone in the afternoon of that same day.



"Pasumpa-sumpa ka pa, 'tangna ka," that old ditty about broken vows went viral with photos of Punsalan pledging to ethical public service juxtaposed with video clips of his arrest by the NBI. Those bundles of crisp P500 bills, just too damning.

Out of 21, only one. Punsalan can be readily dismissed as an isolated case among the mayors of Pampanga. Fair enough.

What cannot be helped, if only in this instance, is the diminishing credibility of pledges verily taken on one's honor. Gone the way of political promises, pledges are routinely broken, peeled of all virtue, clothed in shame.

Pledges can only be redeemed in deeds. It

#### HABEAS PETITION GRANTED, RTC ORDERS RELEASE OF SAN SIMON MAYOR FROM DETENTION

MANILA -- Presiding Judge Desiree Gertrude Orquila-Mordez of the Regional Trial Court (RTC) Branch 206 in Muntinlupa City has ordered the release of San Simon Mayor Abundio "JP" Punsalan from detention.
In her decision dated September 2, the

honorable judge granted the petition for habeas corpus filed by Atty. Raymond Fluellin Viray on behalf of Punsalan in connection with SP Case No. 25-163.

Punsalan has been detained in the wake of the entrapment operation of the National Bureau of Investigation relative of an alleged P30-million extortion on RealSteel Corp, a business company operating in San Simon.

Also directed to be released were six others arrested along Punsalan.

# Beyond survival: Rising above the floods of corruption

AN INVESTIGATION is underway in the Senate on corruption in flood-control projects. But let's be honest: can politicians credibly investigate the very system many of them also benefit from? Who inserted these projects into the national budget as pork in the first place, often at the expense of education, health, and social programs?

For years, the "anatomy of corruption" in DPWH projects has been public knowledge. Senator Ping Lacson laid it bare in his privilege speech. Mayors like Benjamin Magalong of Baguio and Vico Sotto of Pasig have confirmed how a multi-layered system of grease money "commissions" leave just about forty percent or less for the budget. With so little left for the project, is it any surprise at all that they end up substandard and have to be refunded for repairs over and over again?

Yet, consistent with the SONA sound bite, in the latest hearings, the sharp rebuke "Mahiya naman kayo!" was directed only at contractors. Shouldn't the shame be more "inclusive"? Aren't there also congressmen, senators, district engineers, government auditors, and political patrons who share in the plunder?

The irony is that the loudest calls for shame often come from those who shamelessly applauded, even orchestrated, this racket. So we must ask: are these hearings really about accountability, or are they just coded threats to rivals—"Jump ship if you know what's good for you"?

The brazenness of it all should enrage us. And yet, many ordinary Filipinos feel trapped. As Kia Abrera said in her now-viral video, this is not just about spoiled elites showing off; it is about a system we all helped build. Survival politics taught voters to reward whoever eases the pain today—a sack of rice, a prescription, a handshake—because long-term promises feel

like luxuries the poor cannot afford. That is not ignorance, but conditioning. Patronage weaponized utang na loob and pakikisama. Dynasties and disinformation made corruption normal.

The real reset begins not with blaming the poor, but with demanding visible accountability at the top. Quick audits, real penalties, transparency people can actually see. But also, change begins with us. Every time we excuse cutting corners, bending rules, or abusing padrino connections, we reinforce the same mental model that allows billion-peso theft to masquerade as politics.

Social proof works both ways. If we start saying hindi pwede kahit maliit at the smallest levels, we create a culture where large-scale corruption becomes unforgivable. That is why the outrage we feel today must not fade into cynicism. It must translate into a culture of accountability that feels real, immediate, and non-negotiable.

To young Filipinos especially: you hold the keys. You live in the digital space where truth and lies battle daily. Use your platforms not just for outrage but for vigilance. Expose injustice, share facts, demand reforms. Make corruption

If floodwaters rise because public funds are stolen, the greater flood is the corruption that drowns our future. We cannot build a nation on foundations of systemic corruption. We can only rebuild it on social justice and the resolve to work together for the common good.

THAT IS exactly how I felt when I bumped into a social media post of yet another "nepo-baby" who was shamelessly basking in designer outfits, flaunting luxury bags, and seeing the world on board a private jet. Such ostentatious display of probably ill-gotten wealth has gone way beyond insensitivity; no wonder every hardworking Filipino taxpayer found the need to call it outright as systemic corruption.

And the sugar plumbing of project! these privileged and entitled princesses? Their parents who, by sheer of politically-orchestrated luck, have cornered multibillion-peso flood-control projects while thousands of families in remote towns and coastal barangays remain submerged in flood waters.

pines Under Water" probe reported that from July 2022 to May 2025, flood control spending hit an unprecedented ₱545 billion, with only 15 contractors snatching a staggering 20 percent of the pie, or roughly ₱109 billion. These 15 contractors represent less than one percent of the 2,409 contractors accredited by the Department of Public Works and Highways for the flood control projects for the same period.

So, pray tell, are Filipinos rightly enraged by all these? Should this new breed of "nepo babies" be spared from the taxpayers' wrath?

#### MATERIAL AND AFFIRMATIVE ALLEGATIONS IN SUPPORT OF THE HEREIN PETITION

9. Petitioner, John Co Tan filed a Complaint against the respondent Sps. Romel & Percy Due for Collection of Sum of Money before Metropolitan Trial Court (Branch 57) of San Juan Manila City, and same was dockeled as Civil Case No. 0278-SC. In the course of the proceedings, the parties entered in a Compromise Agreement agreeing among others of the terms and conditions set forth therein:

The Defendants in buying peace shall pay the above-mentioned plaintiff the amount of One Hundred Thirty-Two Thousand Pesos (Php132,000.00) representing their total obligation with the latter.

The defendants shall pay the said amount in installments at Php2,000,00 every 30th day of the month starting January 31, 2014 to December 30, 2014, and Php3,000.00 on January 31, 2015 to December 30, 2015, and Php4,000.00 on January 31, 2016 to July 31, 2017

3. The said amount shall be deposited at Account No. 1570094630 Banco de Oro, San

4. Should the defendants default in any foregoing installment payment, their entire liability shall immediately become due and demandable and the plaintiff shall be entitled to Court relief, i.e. for issuance of Writ of Execution.

 $5. \ That full compliance of with the terms and conditions of this Agreement shall constitute the final settlement of this case.\\$

"Accordingly, let Judgment be rendered in this case based on the said Compromise Agreement which shall be deemed final and binding between the contracting parties and immediately executory upon breach of the terms and conditions thereof".

12. On January 20, 2015 the MeTC Br. 57 of City of San Juan issued a Writ of Execution to enforce the said judgment against the respondents in a manner provided by law. Copy of the Writ Of Execution dated January 20, 2015 is hereto attached as ANNEX "F" and

13. On November 16, 2015, Sheriff III, Johni Glenn D. Runes of MeTC-Branch 57 of San Juan City issued a Sheriff's Notice of Sale on Upon Real Property giving notice to all the parties and the public in general that on December 16, 2015 at 10:00 in the morning or soon thereafter infront of the Office of the Clerk of Court 2nd Floor, PNP Bidg..., Santolan Road San Juan City that the TCT No. 561094-R will be sold at public auction to the highest bidder. Copy of the aforesaid Sheriffs Notice of Sale Upon Real Property dated November 16. 2015 is hereto attached as ANNEX "G" and made integral part hereof.

14. The aforementioned Sheriffs Notice of Sale Upon Real Property was published in Midday Monitor a newspaper of general circulation, on December 2 and 9, 2015. Copy of the Affiday't of Publication or Elvira P. Tagapuen dated December 9, 2015 is hereto attached as ANNEX "H" and made integral part hereof.

15. The Public auction proceeded on December 16, 2015 at MeTC Branch 57, San Juan City, where the subject property was sold to the petitioner JOHN CO TAN, being the highest bidder for the sum of One Hundred Fifty Thousand Pesos (Phpt50,000.00), Copy of the Certified True/Kerox Copy of Certification (Certification Certification Certifica

16. The Certification/Certificate of Sale was duly annotated/registered on TCT No. 561094. Ron the 5th page of the subject land title on May 27, 2016 as Entry No. 2016007762 as well as the Notice of Levy Execution on November 6, 2015 under Entry No. 2015015125. Copy of the said Annotation/Registration in the 5th page of the subject land title is hereto attached and marked as ANNEX "J". 17. Sheriff III, Johni Glenn Runes issued a Sheriffs Final Deed of Sale with dispositive portion of which read as follows;

WHEREAS, the period to redeem the said property given by law was already expired and that the above-mentioned detendant failed to/has not been able to redeem the above-mentioned property despite the laps of more than one (1) user.

IN VIEW WHEREOF, a FINAL DEED OF SALE is hereby issued in favor of the plaintiff Mr. John Tan, under the guarantees as prescribed by law, The Registry of Deeds of San Fernando, Pampanga is hereby order to null and void owners copy of Transfer Certificate of Title No. 56194-R and TCT No. 678366-R and issued a new title in favor of Plaintiff JOHN TAN.

Copy of the said Sheriffs Final Deed of Sale is hereto attached as ANNEX "K".

18. Petitioner paid the corresponding administrative fees and dues with the Registry of Deeds of San Fernando City, Pampanga, for total sum of PHP 1,983.28. Copy of the Official Receipt dated May 27, 2016 is hereto attached as ANNEX "L", and made an integral part hereof.

Petitioner has made his best efforts to contact the respondents Sps. Romel B. Due and Percy B. Due in order for the latter to surrender the owner's duplicate copy of TCT No. 561094-R to the petitioner but to no avail.

20. As such, petitioner has to exercise his legal options defined under P.D. 1528 otherwise known as Property Registration Decree, which particularly states that; Sec. 107. Surrender of withheld duplicate certificates. — Where it is necessary to issue a new certificate of title pursuant to any involuntary instrument which divests the title of the registered owner against his consent or where a voluntary instrument cannot be registered by reason of the refusal or failure of the holder to surrender the owner's duplicate certificate of title, the party in interest may file a petition in court to compel surrender of the same to the Register of Deeds. The court, after hearing, may order the registered owner or any person withholding the duplicate certificate to surrender the same, and direct the entry of a new certificate or memorandum upon such surrender. If the person withholding the duplicate certificate is not amenable to the process of the court, or if for any reason the outstanding owner's duplicate certificate cannot be delivered, the court may order the annulment of the same as well as the issuance of a new certificate of title in lieu thereof. Such new certificate and all duplicates thereof shall contain a memorandum of the annulment of the outstanding duplicate. Sec. 107. 21. As per Sheriff Final Deed of Sale (see: Annex K) issued to petitioner John Co Tan, it has been declared that the subject real property covered by TCT No. 561094-R is SOLD, has been declared that the subject real property covered by TCT TRANSFERRED AND CONVEYED to petitioner **JOHN CO TAN**.

22. Respondent, Sps. Romel B. Due and Percy D. Due has until May 27, 2017 to redeem the said real property (TCT No. 561094-R) but failed to redeem after a year from date of entry or registration (May 27, 2016) of the Certificate of Sale. Up to the filing of herein Petition, respondents Sps. Due failed to redeem the property one (1) year from the time the Certificate of Sale was entered, annotated and registered (Entry No. 2016007762) in the TCT No. 561094-R of the said real property. As such, respondent Sps. Due have deemed waived and lost whatever residual rights accorded to them by law -the right of redemption within a year from the date of the registration of the certificate of sale. By vitue of the expiration of the redemption period, the title or right of the respondents Lim on the subject property (TCT No. 561094-R) have been legally divested.

23. Moreover, on March 1, 2024, the petitioner sent a formal Demand Letter dated March 1, 2024 to the respondent spouses via LBC demanding them to surrender the subject title. Copy of the Demand Letter dated March 1, 2024 and copy of the LBC Receipt are hereto attached and marked as ANNEXES "M and N", respectively.

24. But despite the receipt of the said formal demand letter on March 2, 2024, the respondent spouses still failed to surrender the said title and just the same. Copy of the LBC Tracking Status is hereto attached and as ANNEX "0";

25. Being so, Petitioner had the right to the issuance of a new certificate of title and if the same cannot be registered by reason of the refusal or failure of the holder to surrender the owner's duplicate of title, the petitioner, being a party in interest, may file a petition in court to compel the surrender of the same to the Register of Deeds. In the event of failure to surrender the same or if for any reason the outstanding owner's duplicate certificate cannot be delivered, the Honorable Court may order the annulment of the same as well as the issuance of a new certificate of title in lieu thereof. Such new certificate and all duplicates thereof shall contain a memorandum of the annulment of the outstanding duplicate.

#### DECISION

In a petition, dated 7 February 2022, filed by the petitioner, through Atty. Francisco L. Macalino III, she prayed that, after due notice, publication, and hearing, the public respondent be ordered to cancel and/or correct in their records, the Certificate of Live Birth of Stephanie Bonifacio Nunez under Registry No. 2008-639: (a) the entire entries or statement under Entry No. 18 be corrected from "October 5, 2006, Manila City Hall, Manila, Arroceros" to "NOT MARRIED"; (b) the subject child's name be corrected from "STEPHANIE BONIFACIO NUNEZ" to "STEPHANIE LACAP BONIFACIO"; and (3) the name of the subject child' mother as informant thereof, under Entry No, 20 be corrected from "MARICEL B. NUNEZ" to "MARICEL L. BONIFACIO".

#### Factual Antecedence

On 10 March 2022, the petitioner, assisted by her counsel, filed the instant petition, and alleged

Petitioner is the biological mother of the minor, Stephanie Bonifacio Nunez (subject child), as evidenced by the latter's Certificate of Live Birth under Registry No. 2008-639, issued by the Philippine Statistics Authority. In the said document, the "date and place of marriage of parents" Under Entry No. 18 was entered as "October 5, 2006, Manila City Hall Manila Arroceros. In truth and in fact that the petitioner and the child's father John Robert B. Nunez, Jr., were never married on October 5, 2006 at the Manila City Hall. As proof thereof, she presented a certificate issued by the Philippine Statistics Authority. Thus, the entries therein should be corrected to "not married."

As a consequence thereof, the subject child is considered an illegitimate child, and shall follow the surname of her mother. Thus, her name under Entry No. 1 in her said certificate of live birth should be corrected from "STEPHANIE BONIFACIO NUNEZ" to "STEPHANIE LACAP BONIFACIO", pursuant to Article 176 of the Family Code.

Also, the name of the subject child's mother as informant in her said Certificate of Live Birth under Entry No. 20 was erroneously registered and reflected as "MARICEL B. NUNEZ", instead of her true and correct name thereof as "MARICEL L. BONIFACIO", which should be corrected and

The petitioner filed this case for cancellation and/or correction of the said false and/or erroneous entries in the subject child's Certificate of Live Birth, in order to conform and reflect her true records and circumstances of her birth, as supported by authentic documents. She also stated that this action is not intended to misrepresent the identity of the petitioner, the subject child, or for any other illegal purpose. In fact the petitioner and her child have no derogatory records, and criminal or civil suit filed

Finding the petition to be sufficient in form and substance, the court issued an Order dated 16 May 2022, setting the initial hearing on 7 September 2022 at 8:30 in the morning, wherein all persons interested in the petition were directed to appear at the aforesaid hearing and show cause, if any, why this petition should not be granted. Said Order was likewise ordered to be published in a newspaper of general circulation in the province of Pampanga once a week for three (3) consecutive weeks at the expense of the petitioner.

The Office of the Solicitor General (OSG), the Local Civil Registrar (LCR) of the Macabebe, Pampanga, and the Civil Registrar General, Philippines Statistics Authority (PSA), Quezon City, were notified of the said hearing

On 18 July 2022, the Office of the Solicitor General filed its Notice of Appearance, dated 5 July 2022, as well as the Letter of Deputation addressed to the Office of the Provincial Prosecutor of Pampanga, authorizing the latter to appear on its behalf.

During the hearing for the presentation of jurisdictional requirements, the petitioner marked and offered the following documentary exhibits:

Thereafter, the court admitted all the foregoing exhibits offered by the petitioner in its Order dated 7 September 2022.

On 17 Noven1.ber 2022, the court received the Judicial Affidavit of petitioner's witness, Corazon Lacap Bonifacio. A Special Power of Attorney was attached therein, which authorized the latter to action behalf of Petitioner Maricel L. Bonifacio-Davis in this action. The court subsequently noted the

On 25 April 2022, Maricel L. Bonifacio-Davis filed her Panghukumang Sinumpaang Salaysay dated 20 April 2022 and alleged that:

She confirmed that she was the one who filed the instant petition for her daughter, Stephanie Bonifacio Nuñez. As proof of their relationship, the former presented the Certificate of Live Birth of the latter with registry number of 2008-639 (Exhibit "A" and sub-markings). Based on the same document, the petitioner and certain John Robert Baltazar Nunez Jr.., were married on 5 October 2006 in Manila City Hall, Arroceros, which is incorrect. Although the latter was the father of the subject child, they were not married. This fact is supported by a certification issued by the Philippines Statistics Authority (Exhibit "B" and sub-markings")

By virtue of this action, the petitioner prayed that (a) the date and place of then alleged marriage entered in Entry No. 18 should be cancelled and corrected as "NOT MARRIED"; (b) the name of her child be corrected accordingly into "STEPHANIE LACAP BONIFACIO" and (c) to correct the her name in Entry No. 20 to "MARICEL L. BONIFACIO".

Corazon Lacap Bonifacio also executed her Panghukumang Sinumpaang Salaysay on 15

She knows the petitioner (Maricel L. Bonifacio-Davis) because she is her daughter. As proof thereof, she presented the latter's birth certificate, which is marked as Exhibit "J". By the same reason, the petitioner appoited the witness as her Attorney-in-fact to process the correction of the certificate of live birth of her granddaughter, Stephanie Bonifacio Nunez, which is marked herein as Exhibit "K". To prove the relationship of the petitioner and Stephanie Bonifacio Nunez, she presented the certificate of live birth of the latter which is marked as Exhibit "A". Thereafter, the entries in the birth certificate were individually marked as: Entry No. 1 which consist of the name of her granddaughter was marked as Exhibit "A-1"; Entry No.3 or the date of her birth was marked as Exhibit "A-2": Entry No.6 or the name of her mother was marked as Exhibit "A-3". Entry No.13 or the name of her father, John Robert Jr. Baltazar Nunez, was marked as Exhibit "A-4"; Entry No. 18 or her parent's date and place of marriage, which is 5 October 2006, Manila City Hall, Arroceros, was marked as Exhibit "A-5"; Entry No. 20 or informant of the said certificate of live birth marked as Exhibit "A-6".

Based on the subject certificate of live birth, the marriage of the petitioner with John Robert Baltazar Nunez, Jr. was held on 5 October 2006 in Manila City Hall, Manila, Arroceros. The witness contested the said entry because it is incorrect. As proof thereof, she presented the certificate issued by the Philippine Statistics Authority, which is marked as Exhibit "B". Pursuant to this document, the witness prayed that: the information entered the in Entry No. 18 be corrected and change into "NOT MARRIED"; the Entry No. 1 stating the name of her grandchild as "STEPHANIE BONIFACIO NUNEZ" to "STEPHANIE LACAP BONIFACIO"; and the Entry No.20 showing the name of her daughter as "MARICE B. NUNEZ" to "MARICEL L. BONIFACIO".

To prove her good reputation, the witness presented her Police Clearance dated 4 November 2022 (Exhibit \*L"), Barangay Certificate dated 4 November 2023 (Exhibit \*L-1"), Certification from the Office of Clerk of Court of RTC Guagua, Pampanga (Exhibit \*L-2") Certification from the Office of the Provincial Prosecutor (Exhibit \*L-3") and NBI Clearance (Exhibit "L-4").

On 7 December 2022, Ms. Corazon L. Bonifacio appeared for her direct examination and identified her Panghukumang Sinumpang Salaysay as well as her signature affixed thereon. She affirmed and confirmed the truthfulness of the same which she adopts as her direct testimony and the same was terminated

During the cross-examination by Public Prosecutor Alexander C. Lopez, Ms. Corazon Bonifacio confirmed that: she is the grandmother of the Stephanie Bonifacio Nuñez and Mother of Maricel L. Bonifacio; the father of granddaughter died two (2) years ago; the parents of the minor child Stephanie Bonifacio Nuñez were live-in partners and was never married; the Maricel L. Bonifacio is currently residing in Abu Dhabi; the purpose of this action is to allow the child to follow the surname of Maricel L. Bonifacio so that "she could be petitioned by her mother"; and she is aware that there will be changes in child' status from legitimate to illegitimate.

On 27 February 2023, the petitioner formally offered the following documentary exhibits:

On 7 June 2023, the court admitted Exhibits "A" to "L" with sub- markings for the purposes for which they are offered subject to the appreciation of the evidentiary value. As the petitioner rested his case, the instant action was considered submitted for decision.

#### Issue:

#### Whether or not the instant petition should be granted

#### Court's Ruling:

Under the Civil Code, the date of birth must be recorded in the civil register and the books comprising the records of birth are public documents, which are considered as prima facie evidence of such facts. Consequently, the law requires that, no substantial change therein shall be made without a judicial order. Hence, any person who desires to correct any entry must comply with the provisions of Rule 108 of the Rules of Court. Section 2 of the said rule explicitly requires that an entry of the fact of birth, marriage, and acknowledgements of natural children may be corrected upon showing good and valid grounds for causing it. At the same time, the petitioner must comply with the procedural requirements of impleading the proper parties and cause the publication of the order of the court.

Upon considering the evidence on records, the court is of the considered opinion that the correction of the Certificate of Live Birth of Stephanie Bonifacio Nuñez.

First, the petitioner has complied with the procedural requirements under Rule 108 of the Rules of Court. When a petition for cancellation or correction of an entry in the civil register involves substancial controversial alterations, including those on citizenship, legitimacy of paternity, or filiation, legitimacy of marriage, strict compliance with the procedural requirements is mandated. Here, the Order dated 16 May 2022, setting the initial hearing of this case was published once a week for three (3) consecutive weeks in Punto! Central Luzon particularly on June 13-18, 2022 (Exhibit "G" with sub-markings), June 20-25, 2022 (Exhibit "H" with sub-markings), and June 25 to July 2, 2022 (Exhibit "I" with sub-markings), Likewise, the said Order together with the petition was served to all the public respondents including the Office of the Solicitor General, as well as the private respondents John Robert Nuñez and Spouses Huberto Nuñez and Grace Nuñez.

When the instant case was announced to the public on 7 September 2022, there was no opposition raised by the public defendant and any person having or claiming interest from the correction of petitioner's Certificate of Live Birth. Hence, all the jurisdictional requirements and orders of the court to ensure that the correction thereof will not prejudice the rights and interests of any person without due process of law, were satisfied.

Second, just causes for the alteration of entries in Stephanie Bonifacio Nuñez's Certificate of Live Birth were present. The Petitioner Maricel L. Bonifacio-Davis was able to establish that she and the father of her child, John Robert Baltazar- Nuñez were never married during the lifetime of the latter. She even presented certifications issued by the Philippine Statistics Authority stating that there is as no record of marriage between her and John Robert Baltazar-Nunez in their office and shows that petitioner was In fact married to a man named as Samuel Michael Davis on 28 December 2015 (Exhibit "B"), as proof thereof. Thus, the correction of the entire entry in No. 18 stating "October 5, 2006, Manila City Hall, Manila, Arroceros" to "Not Married" as well as the alteration in Entry No. 20 from "Marice B. Nunez" to "Maricel L. Bonifacio" are reasonable.

However, the court cannot agree with the prayer of the petitioner to correct the entry in no. 1 from "STEPHANIE BONIFACIO NUNEZ" to "STEPHANIE LACAP BONIFACIO" because it is contrary to the decision of the Supreme Court that an illegitimate child whose filiation . is not recognized by the father bears only a given name and his mother's surname and does not have a middle name. The name of the unrecognized illegitimate child therefore identifies him as such. It is only when the illegitimate child is legitimated by the subsequent marriage of his parents or acknowledged by the father in a public document or private handwritten instrument that he bears both his mother's surname as his middle name and his father's surname as his surname, reflecting his status as a legitimated child or an acknowledged illegitimate child. Thus, the middle name of the child herein must be left blank as she does not have a surname for being an illegitimate child. does not have a surname for being an illegitimate child.

Lastly, the petition for correction of entries, as a special proceeding, seeks the establishment of a particular fact and shows the same in the books-comprising the records of birth. Regardless of the petitioner's mistake, the court is inclined to grant the correction of entries in the subject child's certificate of live birth in order for the actual facts to reflect in public records:

WHEREFORE, after the premises considered, the Court hereby orders, the following:

a) PARTIALLY GRANTS the Petition for Cancellation/Correction of Entry in the Certificate of Live Birth of the minor, Stephanie Bonifacio Nuñez, under Registry No. 2008-639, represented by her mother Maricel I Bonifacio-Davis:

b) Directs the public respondent, Local Civil Registrar of Macabebe, Pampanga and Civil Registrar General of the Philippines, to effect the following correction of entries in the subject birth certificate:

#### DECISION

This is a Complaint1 lodged by the plaintiffs represented by Marciano V. Mendoza as their attorney-in-fact against defendants Lolita Mallari, and the Registry of Deeds Pampanga as nominal party docketed as Civil Case No. R-ANG-19-03180-CV. The Court issued Summons2 with a copy of the Complaint together with its annexes to Lolita Mallari and the Register of Deeds Pampanga. The Sheriffs Returns3 states that for defendant Lolita Mallari, the attempt to serve summons to her failed because the said defendant is already in Australia. The service for defendant Registry of Deeds Pampanga was duly served. Upon motion of the plaintiffs, the Court allowed service of summons by publication upon defendant Lolita Mallari.4

In an Order dated January 11, 2021, the Court ordered the dismissal of the ease for lack of interests.5 Upon motion of the plaintiffs, the Court reconsidered the order of dismissal and reinstated the case.6

When this case was called for pre-trial on May 4, 2021, no counsel appeared for and in behalf of the defendants and no responsive pleading was filed for the defendants despite service of summons by publication. In view of the same, plaintiff's counsel filed a motion7 to declare defendants in default which the Court granted8 thus, defendant Lolita Mallari was declared in default

In a Special Appearance with Motion to Serve Summons filed by Rita De Leon Vinculado and Ronnie De Leon through counsel, they pray that summons be issued and served on them in order that the Court may acquire jurisdiction upon them. The Court did not act on the said motion since plaintiffs' counsel categorically declared9 that the plaintiffs have no legal claims against Rita De Leon Vinculado and Ronnie De Leon. In view of the said declaration, the Court no longer resolved the motion for being moot.

#### Plaintiffs Evidence

The plaintiff presented its witness Marciano V. Mendoza and his testimony established

Witness Marciano V. Mendoza is of legal age, a Filipino citizen, and residing at Lot 21, Block 4, Phase 1, St. Jude Village, City of San Fernando, Pampanga. He knows the plaintiff Ildefonso Dizon, Jr. because the latter appointed10 him as his attorney-in-fact and consultant Witness testified that plaintiff Ildefonso Dizon, Jr. owns a land located in Mabalacat City, having inherited the same from his deceased11 father, Ildefonso Dizon, Sr. The said property is covered by TCT No. 60136-R12 with a total area of One Hundred Two Thousand, Two Hundred Twenty-Two (102,222) square meters registered under the name of Ildefortso Dizon, Sr. To bolster the witness' assertion that Ildefonso Dizon, Sr. is the owner of the land covered by TCT No. 60136, witness presented and identified an approved subdivision plan with number Psd-03-013452(OLT)13.

After the death of Ildefonso Dizon, Sr. the witness, as administrator of the subject property, came to know that portions of the property of Ildefonso Dizon, Sr. in Mabalacat City were titled in the names of Ronnie de Leon14 and Rita De Leon15 and later on transferred to defendant Lolita Mallan16. The plaintiff Ildefonso Dizon, Jr. then filed a petition with the DAR Regional Office III for Erroneous Identification of farmerbeneficiary, Erroneous Issuance of Emancipation Patents and Unlawful Transfer in relation to Lot 4, Psd-03- 013452 (OLT), Brgy. Dapdap, Mabalacat, Pampanga. The DAR Regional Office III resolved the petition in favor of the plaintiff in an Order17 of the said office that was never appealed thus, it became final and executory18, With regard to the lands titled in the names of Ronnie de Leon and Rita V. de Leon, they were later on transferred to defendant Lolita Mallari19. During his testimony, witness Mendoza identified and affirmed his Judicial Affidavit as well as the documents attached to it.20

#### **COURT'S RULING**

After considering the uncontroverted evidence of the plaintiffs against defendant Lolita Mallari, the Court holds that plaintiffs have sufficiently proven their cause of action against the said defendant by preponderance of evidence

The uncontroverted evidence is that Ildefonso Dizon, Sr. is the registered owner of a parcel of land covered by TCT No. 60136-R It has been held that when property is registered under the Torrens system, the registered owner's title to the property is presumed legal.21 In view of the same, the title of Ildefonso Dizon, Sr. must be respected and any transfer must be due to the latter's exercise of his right of ownership. The evidence before the Court does not show that the late Ildefonso Dizon. Sr. executed any valid deed of conveyance in order to transfer the same to the defendant Lolita Mallari On the other hand, the uncontroverted evidence is that the DAR Regional Office III Order dated September 11, 2018 declared Ronnie De Leon as having been erroneously identified as tenant beneficiary of Lots 4 and 5 and that EP titles (TCT No. 4737 and 4738) were erroneously issued to him. The said DAR Order became final and executory. In view of the same, the title issued in favor of Ronnie De Leon has no legal basis since he did not acquire Lots 4 and 5 through any legal means of acquiring ownership. It has been held that mere issuance of an emancipation patent (EP) does not put the ownership of the agrarian reform beneficiary beyond attack and scrutiny.  $\!22$ It appears therefore that Ronni De Leon has no legal title over Lots 4 and 5 and thus, cannot legally transfer the same based on the EP titles issued to him. Inasmuch as the derivative title on which the defendant traces her title was declared erroneously issued. any transfer is illegal since any transfer did not originate from the legal owner Ildefonso Dizon, Sr. Although the defendant paid the realty taxes, the court holds that the same cannot prevail over the title of the late Ildefonso Dizon. Sr. In the case of the Heirs of Malabanan vs Republic,23 it was held that tax declarations and realty tax payments are merely indicia of a claim of ownership and are not evidence of ownership in fee simple. Likewise, in the case of Cureg v. Intermediate Appellate Court,24 the Honorable Supreme Court held that as against an array of proofs consisting of tax declarations and/or tax receipts which are not conclusive evidence of ownership nor proof of the area covered therein, an original certificate of title indicates true and legal ownership by the registered owners over the disputed premises. Hewing to jurisprudence, the title of the late Ildefonso Dizon, Sr. should be accorded greater weight as against the tax declarations of the defendant Mallari

Anent the prayer of the plaintiffs for the defendant to pay the attorney's fees and cost of suit, the Court awards the same pursuant to Article 2208, paragraph 2 of the New Civil Code since the plaintiffs were compelled to litigate in order to protect and assert

WHEREFORE, in view of the above disquisition, judgment is hereby rendered in favor of the plaintiffs and the Court hereby declares Transfer Certificate Nos. 588625 and 588626 registered in the name of the defendant Lolita Mallari null and void. Defendant is likewise ordered to pay the amount of P50,000.00 as attorney's fees and cost of

#### ORDINANCE NO. 731, S-2025 (PO-316-07-22)

AN ORDINANCE ADOPTING REPUBLIC ACT NO. 11511, OTHERWISE KNOWN AS "AN ACT PROVIDING FOR THE DEVELOPMENT AND PROMOTION OF ORGANIC AGRICULTURE IN THE PHILIPPINES AND FOR OTHER PURPOSES", AND INSTITUTIONALIZING, PROMOTING, AND DEVELOPING ORGANIC AGRICULTURE IN THE CITY OF ANGELES, PROVIDING FUNDS THEREFOR AND FOR OTHER PURPOSES.

**WHEREAS**, it is the policy of the State to increase agricultural productivity, enrich the fertility of the soil, reduce pollution and avert the destruction of the environment, prevent depletion of natural resources, protect the health of the general public, and save on imported farm inputs;

**WHEREAS**, Republic Act No. 11511, otherwise known as "An Act Providing for the Development and Promotion of Organic Agriculture in the Philippines and for Other Purposes", aims to promote, propagate, develop further, and implement the practice of organic agriculture in the Philippines;

**WHEREAS,** Section 14 of RA 11511 recognizes the pivotal role of the Local Government Units (LGUs) as front liners in the implementation and enumerates the role and responsibilities, such as, but not limited to the creation of local technical committees, and issuance of ordinances and/or resolutions approving and adopting organic agriculture in their locality.

WHEREAS, the Department of Agriculture (DA) – Department of Interior and Local Government (DILG) Joint Memorandum Circular (JMC) No. 02, Series of 2013 was issued stipulating the roles and responsibilities of the LGUs in the Implementation of the National Organic Agriculture Program;

**NOW THEREFORE**, on motion of Councilor Crisanto G. Cortez, duly seconded by Councilor Alexander P. Indiongco, be it ordained by the City Council of Angeles, in a session duly assembled that:

**SECTION 1. <u>TITLE.</u>** – This Ordinance shall be known as the "Organic Agriculture Ordinance of City of Angeles 2024".

**SECTION 2. DECLARATION OF POLICY.** – It is the duty of the local government to protect life and advance the rights of all citizens to food sufficiency, sovereignty and safety, sustainable livelihood and social equity in accord with the rhythm and harmony of nature. Toward this end, the local government with mainstream organic agriculture as a main agriculture practice in the City of Angeles;

**SECTION 3.** <u>**DECLARATION OF PRINCIPLES.**</u> – The practice of organic agriculture shall adhere to the following principles to guide the implementation of this Ordinance:

- The promotion and enhancement of the conservation and sustainable use of agricultural biodiversity shall prevail over any other activity in the agriculture sector;
- The empowerment of all small and marginalized farmers in the agricultural areas of the City is a priority which will include the value chain for organic agricultural products;
- The implementation of a strategy for mitigation and adaption to climate change is an urgent policy matter that needs to be integrated into all policies in all sectors;
- While unifying the initiatives and efforts of all government agencies and instrumentalities in the agricultural sector, the enhancement of the City's poverty reduction strategy should not be lost in sight;
- Organic agriculture is a contributor to the City's economy and the attainment of food security ecological sustainability and the well-being of the people of Angeles;
- Organic agriculture cannot co-exist with genetically-modified crops chemically produced crops and related organisms both living and non-living;
- Organic agriculture is multi-functional and in this sense, all existing policies of the government on agriculture should take this into account; and
- The integrity of organic products through the approved organic certification process and organic production handling and processing standards should be ensured.

**SECTION 4. DEFINITION OF TERMS.** – As used in this Ordinance, the following terms shall mean:

- Biopesticides are naturally occurring substances and microorganisms that control pests;
- Buffer Zones are defined areas on the boundary of an organic farm that have land use controls and allow only activities compatible with the protection of the organic farm. It serves as a barrier that surrounds or separates an organic farm from other traditional or conventional farms where plants are not designated as organic. The area of the buffer zones shall be determined in the Implementing Rules and Regulations depending on the total situation on the ground;
- Consumer Groups are organized consumer groups patronizing and advocating organic products;
- Conversion is the process of transforming a traditional or conventional farm into an organic farm for a period of three (3) to five (5) years;
- Food Security is the ability of the individual, household, and community to produce and/or access/ acquire appropriate, abundant, nutritious, and safe food on a regular basis using socially acceptable means:
- Organic Agriculture is a production system that sustains the health of soils, ecosystems, and people. It relies on ecological processes, biodiversity, and cycles adapted to local conditions, rather than using inputs with adverse effects. Organic agriculture combines tradition, innovation, and science to benefit the shared environment and promote fair relationships and good quality of life for all involved (IFOAM);
- Organic Center is a center with the following goals:
- i. Establish a strategic venue for consumer education, information, and communication for a sustainable healthy lifestyle;
- ii. Design as a showcase for organic products and farm technologies; iii. Develop holistic and sustainable technology training programs;
- iv. Formulate farm-based farmer-coordinated applied research program; and
- v. Promote environmental economic values in enterprise development.
- Small farmers are marginal and sub-marginal farm households and/or cultivating not more than one (1) hectare;

#### CHAPTER 2 - STRATEGIES

**SECTION 5. ORGANIC AGRICULTURAL ZONES.** – For the effective implementation of this Code, there are hereby set aside agriculture zones that will be protected from encroachment and contamination of using chemical-based farm inputs, mining, including contamination of genetically-engineered crops and other similar activities. These zones shall be organized according to ecological districts based on existing categories of land tenure instruments and arrangements such as the ancestral domain, the protected area and the agrarian reform communities.

These zones shall be set up according to the following minimum criteria:

- Presence of actual organic agriculture practitioners;
- Presence of natural or man-made water formations, including areas covered by irrigation and similar facilities;
- Identified buffer zone to shield organic agriculture from other land uses that impact in the integrity of the practice of organic agriculture;
- Areas suited for agricultural production as defined in the City of Angeles Land Use Plan to be submitted to the Sanggunian for approval in an Ordinance.

**SECTION 6.** <u>ORGANIC CENTERS.</u> – The City Government of Angeles, through the City Agriculture's Office, shall establish, recognize and/support Organic Centers including those initiated by the private sector that will promote, market, and develop organic agriculture;

The City Agriculture's Office may also recognize or support market centers that are established for the purpose of marketing organic products;

**SECTION 7.** <u>CONSERVATION OF INDIGENOUS FARM PRACTICES.</u> – Measures shall be established, by the farming communities, including indigenous people's communities, to conserve and protect indigenous knowledge relating to organic agriculture, including those that relate to seed conserva-

tion and propagation and the various ways in which on-farm and ex-situ mechanisms are established and sustained.

**SECTION 8.** <u>ORGANIC GENE/SEED BANK.</u> – The City Government of Angeles, through the City Agriculture's Office, in coordination with Non- Government Organizations (NGOs), international organizations and other appropriate agencies shall establish an Organic Seed/Gene Bank that will produce and supply organic, endemic or Indigenous seeds to farmers;

**SECTION 9. SUPPORT SERVICE TO ORGANIC FARMERS.** – The City Government of Angeles shall ensure support to organic farmers who wish to engage in organic agriculture, such as training, production, marketing and branding, including financial management and accounting, among other necessary skills to develop an organic agriculture product that will secure a market niche, including the practice of fair trade.

Support services shall also be primarily extended to small and marginalized farmers and women's groups including the promotion, enhancement and fulfillment of their rights as defined in national laws;

**SECTION 10.** <u>ACCESS TO CREDIT FOR SMALL AND ORGANIC FARMERS.</u> – Small and organic farmers, through the assistance of the City Agriculture's Office, shall have access to credit facilities and financial services through organized groups of small farmers preferably those cooperatives registered with the City Cooperative Development Office;

**SECTION 11. BIOLOGICAL AND BOTANICAL CONTROL.** – Organic Farmers shall practice and utilize biological and botanical methods, that rely on predation, parasitism, herbivory or other natural mechanisms in the control of pests and diseases in their organic farm;

The City Government of Angeles shall provide support to the Research Section of the City Agriculture's Office for the research and development of biological and botanical control.

#### **CHAPTER 3 – IMPLEMENTATION MECHANISMS**

**SECTION 12.** <u>IMPLEMENTATION MECHANISMS.</u> – The City Government of Angeles, through the City Agriculture's Office, shall ensure the implementation of this ordinance guided by the principles of the organic value chain. It shall ensure the marketing of organic products by providing centers for selling, transport and other necessary services. It shall also ensure that organic products have certified organic branding in accordance with the Philippine National Standards;

**SECTION 13.** ORGANIC AGRICULTURE MANAGEMENT COUNCIL. – The City Government may institute the formation of an Organic Agriculture Management Council, headed by the City Agriculture's Office that will assist in the implementation of the Ordinance and the formulation of an Organic Agriculture Plan for the City of Angeles. The Council, to be composed of appropriate national government agencies, non-government organizations (NGOs), People's

Organizations (POs), academe and such other appropriate offices engaged in or advocating organic agriculture, shall have the following functions:

- Identify and recommend organic agriculture zones as established in Section 5 of this Ordinance;
- Adopt the existing national standards for the accreditation of organic agriculture practitioners which
  may take into account second-party certification systems and farmers' guarantee systems;
- Develop incentive mechanisms for the organic agriculture sector, in collaboration with local government agencies under the City Budget Office which may include, but not limited to, subsidies especially with farming areas that do not exceed one (1) hectare limit, and the necessary crop insurance and other support system of agriculture sector; and
- Perform such other functions as may be necessary for the realization of the policies as well as the principles enunciated under this Ordinance.

In the absence of the establishment of the said Council, the City Agriculture's Office shall perform the above-mentioned functions in collaboration with other government agencies, NGOs, POs, academe and other appropriate offices.

**SECTION 14.** <u>APPROPRIATION.</u> – The City Government of Angeles shall appropriate a substantial budget to ensure the implementation of this Ordinance and to support the organic agriculture activities of the City:

**SECTION 15.** <u>INCENTIVES TO FARMERS, SCHOOLS AND BARANGAYS.</u> – The Local Government of Angeles shall give incentives, awards and financial support to farmers, schools and barangay local government units that pursue, promote and practice organic farming. The City Agriculture's Office shall formulate guidelines for developing incentive programs, award systems and/or financial support.

**SECTION 16. <u>STANDARD-SETTING.</u>** The City Mayor, through the City Agriculture's Office or the Organic Agriculture Management Council, in case it is established, shall formulate an organic agriculture standard appropriate for the Small Farmers of the City of Angeles;

The standard to be formulated by the City shall be anchored on the utilization of biodegradable waste as a resource for the organic agriculture system;

**SECTION 17.** <u>CAPACITY-BUILDING.</u> – To sustain and broaden the base for the implementation of this Ordinance, there is hereby adopted a continuous effort, funded by the budget set aside for organic agriculture as identified in Section 14 of this Ordinance, for capacity-building and training, including the accreditation of institutions for standard-testing and verification. Measures shall also be adopted to encourage the integration of organic agriculture in the primary, secondary and tertiary school curricula;

**SECTION 18.** RESEARCH AND DEVELOPMENT. – A Master Plan for Research and Development on Organic Agriculture shall be created by the City Agriculture's Office in coordination with the Department of Agriculture – Regional Field Unit III that will be funded by the City from the budget set aside for organic agriculture as identified in Section 14 in this Ordinance. The Master Plan shall be regularly updated in consultation with different sectors. The participation of farmers and other stakeholders such as, but not limited to, private entities, NGOs and LGUs in the research, development and implementation of the master plan is preferred;

**SECTION 19. <u>IMPLEMENTING RULES AND REGULATIONS.</u> – The City Mayor is hereby authorized to create a joint executive-legislative committee to formulate the Implementing Rules and Regulations of this Ordinance upon its effectivity:** 

**SECTION 20. SEPARABILITY CLAUSE.** – If any part of this Ordinance is declared unconstitutional, the remaining parts unaffected thereby shall continue to remain valid and in effect;

**SECTION 21.** REPEALING CLAUSE. – All ordinances, executive orders, rules and regulations of parts thereof inconsistent with this Ordinance are hereby repealed or modified accordingly;


SECTION 22. EFFECTIVE CLAUSE. – This Ordinance shall take effect upon approval.

#### **ORDINANCE NO. 732, S-2025** (PO-441-02-25)

#### AN ORDINANCE INSTITUTIONALIZING THE KATUWANG SA DIWA AT GAWA PARA SA MASAGANANG ANI AT MATAAS NA KITA (KADIWA) NG PANGULO IN THE CITY OF ANGELES.

WHEREAS, food security plays a crucial role in bolstering economic stability, driving agricultural productivity, enhancing public health, and fostering social harmony;

WHEREAS, economic growth is driven by an increase in investments, productivity, and consumer spending;

WHEREAS, LGUs have a direct impact on the local economy by encouraging business location and incubation, supporting enterprise development, linking local produce to markets, and facilitating job creation and livelihood development leading to sustainable local economic activities;

WHEREAS, the Department of the Interior and Local Government (DILG)Memorandum Circular No. 2024-003 enjoins all LGUs to set-up the KADIWA ng Pangulo (KNP) in their respective localities in partnership with the Department of Agriculture (DA), Department of Trade and Industry (DTI), Department of Labor and Employment (DOLE), and the Department of the Interior and Local Government;

WHEREAS, the KNP is part of the government's efforts in ensuring stable food supply and affordable products by enabling farmers to sell directly to consumers by eliminating market layers;

WHEREAS, the KNP also ensures value chain development by connecting farmers to markets and ensuring that the value generated by agricultural products is retained within the local economy;

WHEREAS, the advancement of the One Town, One Product (OTOP) initiative boosts growth for local Micro-, Small- and Medium-scale Enterprises (MSMEs);

WHEREAS, DILG MC No. 2024-003 enjoins LGUs to institutionalize the KNP by enacting an ordinance to that effect;

NOW, THEREFORE, BE IT ORDAINED by the Sangguniang Panlungsod ng Angeles in a session duly assembled that:

SECTION 1. TITLE. This Ordinance shall be known as the "KADIWA Ordinance" of the City of Angeles.

SECTION 2. KADIWA DAY IMPLEMENTATION. The KNP shall be conducted at least twice a month by the City, preferably every third Wednesday and Thursday of every month in an area to be designated by the Local Chief Executive.

If the third Wednesday and Thursday fall on a holiday, the KNP shall be conducted on the fourth Wednesday and Thursday of the month.

SECTION 3. MARKET AREAS OR PRODUCT CLUSTERS. The KNP shall have 3 market areas or product clusters, as follows:

- a. Agricultural produce such as rice, vegetables, fruits, grown by farmers from the various barangays in the city;
- b. Processed goods, both food and non-food, the Micro, Small, and Medium Enterprises (MSME); and
- c. Mercato stalls (ready-to-eat) food for micro-enterprises.

SECTION 4. RESPONSIBILITIES OF THE LOCAL GOVERNMENT UNIT (LGU). The LGU., through the Angeles City Economic Development and Investment Promotions Office (ACEDIPO) shall have the following responsibilities in the operation of the KNP:

- a. Lead in the overall management and operation of the KADIWA;
- b. Facilitate the invitation and mobilization of local micro-entrepreneurs, cooperatives and MSMEs to sell local produce products in the **KADIWA**; c. Identify and secure a suitable venue for the **KADIWA**;
- d. Assign stalls and provide any logistical support to participating sellers;
- e. Promote the KADIWA to the community/buyers thru an information campaign;
- f. Invite the community/buyers to participate during the **KADIWA Day** through information campaign (i.e. posting of tarpaulins or streamers, utilizing the social media, etc.); g. Coordinate with the City Agriculture Office (CAO) and other concerned offices and/or agencies for guidance in handling, operating, and managing the **KADIWA**, food and market supply, prospective sellers, and other arrangements needed and for the maintenance of sanitation, peace, order, and public safety every KNP Day.

SECTION 5. RESPONSIBILITY OF THE BARANGAYS. All barangays are encouraged to provide the necessary support in the transport of products and goods of their residents participating in the KNP.

The Punong Barangays are enjoined to promote participation in the KNP among farmers and MSMEs in their respective barangays.

SECTION 6. DESIGNATION OF FOCAL PERSON. The City Mayor shall designate a KNP Focal Person who shall come from the ACEDIPO and perform the following functions:

- a. Take charge in the overall implementation of the KNP;
- b. Keep record of data such as the number of participants and the amount of revenue generated during KNP Day, among others, and submit the same to the DA and DTI copies furnished the DILG; and
- c. Perform such other duties and functions as may be assigned by the City Mayor.

SECTION 7. FUNDING. The funds needed to fully implement this Ordinance shall be allocated in the annual budget of ACEDIPO.

SECTION 8. SEPARABILITY CLAUSE. If any provision of this Ordinance is held invalid, the other provisions not so declared shall not be affected and shall continue to be effective.

**SECTION 9. EFFECTIVITY.** This Ordinance shall take effect in accordance with the law.

competitiveness in shipbuilding, which was once a significant economic and industrial driver.

The president recalled that from 2014 to 2018, the Philippines had been producing up to 2 million gross tons of ships annually, before the industry's momentum slowed in 2019.

"Today, we raise the sails once more," he declared.

With Hyundai Heavy Industries' investment, Marcos Jr. noted that the Subic shipyard's capacity will expand from 1.3 million to 2.5 million deadweight tons, enabling it to build up to eight massive oil tankers yearly.

"Today, we will begin reclaiming our rightful place among the world's great shipbuilding nations," reiterated the president.

Marcos Jr. said the renewed push is anchored in government programs that align skills training with international standards

across 16 technical disciplines, from marine electricity to gas and arc welding.

He acknowledged that the shipyard's relaunch reflects a long-term vision not only to revive but to sustain the industry for future generations, symbolizing the nation's resilience and readiness to compete globally.

"Together, let us show the world that Filipinos have the skills, the vision to navigate the uncertain waters of an ever-changing world," President Marcos said.

For his part, Korean Ambassador to the Philippines Lee Sang-hwa said the project reflects the strengthening economic ties between the two countries.

"Today's event is, above all, a victory for the Philippines. It is a tangible result of President Marcos' tireless efforts to attract foreign investment through the CREATE More [Corporate Recovery and Tax Incentives for Enterprises

to Maximize Opportunities for Reinvigorating the Economy] Act," Lee said.

He added that Hyundai is projected to employ 7,000 to 8,000 workers in the coming years, calling the initiative a "powerful tripartite partnership" wherein Korea contributes shipbuilding technology, the United States provides financial support, and the Philippines offers skilled manpower and a strategic location.

HD Hyundai's restart of large-scale shipbuilding in the Philippines leases 200 hectares from Agila Subic, a Cerberus portfolio company, for operations beginning January 2026.

The 10-year lease covers shipyard operations designed to support both offshore wind platform construction and vessel production. The facility is set to begin full operations in January 2026, including both shipbuilding and offshore wind platform construction. *PCO/PIA-3*

protection projects, one at P270.194 million and a "Phase 1" with P96.496 million. For a total amount of P366.690 million.

#### Sapang Balen - P676.036-M

Slope protection works at the creek that meanders through the cities of Angeles and Mabalacat to Magalang town were also awarded to three companies, to wit:

- 1) Three-In-One Construction with the sole project in Angeles City costing P48.992 million; two in Mabalacat City at P145.411 million; and four in Magalang at P325.177 million - for a total of P519.580 million;
- 2) MCJ-Valenzuela Construction Enterprises with one project in Mabalacat City at P48.993 million and three projects in Magalang at P58.492 million – for a total of P107.485 million; and
- 3) Tonka Construction with one project in Magalang at P48.971 million.

In terms of sites. Angeles City had the least funding at P48.992 million while Magalang had the biggest at P432.640 million. Mabalacat City got P194.404 million.

#### **Quitangil Creek -**P492.852-M

Another waterway shared by Mabalacat City and Magalang with the engineering interventions undertaken by three by-nowfamiliar contractors, to wit:

- 1) Three-In-One Construction with two projects in Magalang at P119.932 million and one in Mabalacat City at P96.464 million for a total of P216.396 million.
- 2) MCJ-Valenzuela Construction Enterprises with one project in Magalang at P19.762 million and five in Mabalacat City at P108.145 million for a total of P228.077 million; and
- 3) Radians Builders & Supply Corp. with one project in Magalang at P48.379 million.

Prominently figured in all three major undertakings, Three-In-One Construction got the biggest share at P914.597 million.

#### Guagua River - P554.805-M

Along with its tributaries of Sapang Maragul, Betis River, and Upper Dalan Bapor,

Guagua River rehabilitation works comprised of five projects uniformly costing P96.49 million and one at P72.358 million, all undertaken by Ferdstar Builders Contractors.

#### Guagua-Pasak River -P338.331-M

The separate entry of Guagua-Pasak still showed Ferdstar Builders with a P96.489 million project it undertook with Cedar Construction.

Also undertaking one project each were 11-16 Construction at a cost of P48.842 million, and Northern Builders with P193 million.

#### Gumain River - P127.668-M

Tonka Construction undertook projects totaling to P127.668 million all sited in Cabangcalan, Floridablanca.

#### Caulaman River - P94.032-M

Still in Floridablanca. In Barangay Sto. Rosario, Radians **Builders & Supply Company** reportedly completed a slope protection project in three phases at P28.704 million, P28.704 million, and P36.624 million.

#### Porac River - P290.094-M

Sto. Cristo Construction & Trading had here what could be its minutest project in terms of cost at P48.844 million.

Northern Builders got the single biggest block of P241.250 million.

#### Pasig-Potrero River -P241.243-M

Ferdstar Builders with one project costing P144.750 million. A smaller P96.493 million awarded to 11-16 Construction.

#### Maasim River - P341.679-M

Sto. Cristo Construction monopolized the projects at this river in Candaba, to wit:

- 1) damaged dike rehab Vizal San Pablo Phase 1, P68.321 million: 2) damaged dike rehab Vizal
- San Pablo Phase 2, P68.394 million; 3) slope protection Phase 2
- Pulong Gubat, P68.321 million; 4) slope protection Phase 1 Bahay Pare, P68.321 million;
- 5) slope protection Phase 2 Bahay Pare, P68.321 million.

Total cost: P341.679 million Pampanga River - P1.044-B

Focused on the recurrent saga of failure that is the Candating, Arayat flood control project by Eddmari Construction at a cost of P274.596 million in one year alone (Oct 2023-Nov. 2024), the other flood control interventions along the stretch of the Pampanga River and its tributaries make a staggering discovery as well.

Other Pampanga Riverrelated projects of Eddmari Construction included:

- 1) slope protection in Cupang and Guemasan, Arayat costing P91.578 million;
- 2) revetment wall in Capalangan, Apalit at P74.883 million:
- 3) eroded riverbank in San Luis at P83.810 million; and
- 4) slope protection of Dalaquitan Bridge in Sto, Tomas, at P91.674 million.

A grand total of P616.541 in projects went to Eddmari Construction.

Not totally left out is Sto. Cristo Construction with a riverbank revetment project in San Mateo, Arayat at a cost of P91.095 million; and slope protection along Sapang Are in Apalit at P74.883 million. For a total of P165.978 million.

Also, in the Pampanga River projects board was 11-16 Construction with a slope protection in San Luis at P93.604 million; road dike in Sucad, Apalit with similar P93.604 million costing; and rehab of eroded bank in Cansinala, Apalit at P74.883 million. Total: P262.091 million.

#### Malasik River - P1.157-B

Grand as the cost of flood control project befitting the Rio Grande de Pampanga,

no other such engineering intervention in recent memory could, arguably, compare in scope to that at the Malasik River in Candaba town: four major sections at P144.750 million each (Total: P579 million); five other sections and six phases at P578 million.

All these, by a single contractor -- Sto. Cristo Construction & Trading, meriting Top 1 among flood control project constructors in Pampanga in the sumbongsapangulo list.

HB No. 4174 seeks to amend RA 11310 (Pantawid Pamilyang Pilipino Program (4Ps) Act), to include an additional "First 1,000 Days" (F1KD) Cash Grant per child aged zero to two years old at an amount no lower than P300 per month, for a maximum of three children for each qualified household beneficiary.

Under the current 4Ps Act. conditional transfer beneficiaries receive the following: at least P300 per month for per child enrolled in day care and elementary programs for a maximum of 10 months per year; at least P700 per month per child

enrolled in senior high school for a maximum of 10 months per year; and health and nutrition grant at least P750 per month for a maximum of 12 months per year – for a total of at least P1.750 per month, With HB No. 4174, this will increase to at least P2,050 per month. Through the additional grant,

Lazatin aims to address the issue of malnutrition among families with young children.

An article published by the United Nations Children's Fund states that an estimated 672,000 children suffer from wasting, with about 50% under the age of two years.

"It is very important that a child receives proper nutrition during the first 1,000 days of their life, and we aim to assist their families ensure this through the additional grant," Lazatin said.

On August 4, 2025, Lazatin also filed HB No. 2933, which seeks to include mental health emergency, psychiatric, and neurological services in the PhilHealth Mental Health Benefit Package for Out-Patient.

During his time as Angeles City mayor, Lazatin implemented the provision of P1,000 yearly cash assistance for registered senior citizens in the city.
