Sandigan junks 71 graft charges against Tumang


CITY OF SAN FERNANDO – Ousted from office by the Ombudsman in 2023, former Mexico, Pampanga Mayor Teddy Tumang, along with seven co-defendants, has been acquitted by the Sandiganbayan of 64 counts of violating the RA 3019 (Anti-Graft and Corrupt Practices Act) and seven charges of malversation of public funds.

The 32-page per curiam decision

(unanimous agreement) promulgated on Sept. 2, 2025 was signed by Presiding Justice Geraldine Faith Econg and Associate Justices Edgardo Caldona and Arthur Malabaquio.

The anti-graft court's Second Division granted the defendants' demurrer to evidence challenging the sufficiency of documents and

EO: Unclaimed impounded vehicles in AC sold after 90 days

ANGELES CITY - Wanting more space in its impounding areas already overcrowded with unclaimed vehicles, some over a decade there, the city government has come out with a measure for the proper disposal

Mayor Jon Lazatin on Sept. 3 issued Executive Order 14 Series of 2025 - Promulgating Implementing Rules and Regulations for Impounded Vehicles in Angeles City - to "provide clear guidelines to the management, disposition and auctioning of impounded vehicles in compliance with national regulations."

Cited as basis for the IRR was Section 72 of Ordinance No. 609-S-2021 to address the disposal of unclaimed impounded vehicles.

Under the EO, impounded vehicles unclaimed after 90 days will be categorized by public auction to be preceded by a notice to be published in local

newspaper of general circulation, on the city's official website, and in bulletin boards in public places such as the market, city hall,

The city general services office shall set the minimum price per vehicle after an ocular inspection. It shall also receive undertake the registration of interested bidders.

Auction will be by open bidding, with the highest bidder declared as the winner who has to pay the total bid amount within 24 hours. Failure to do so will result in disqualification, with the next highest bidder winning the vehicle.

All proceeds from the auction will be properly accounted for per regulations of the Commission

To ensure transparency, the city treasurer's office will render a report of all the auction transactions. Punto News Team/ Photos: ACIO



Cong Pogi pushes for free national online library

ANGELES CITY -- Pampanga 1st District Rep. Carmelo "Pogi" Lazatin, Jr., on Sept. 4 filed a bill mandating the establishment of the Philippine Online Library and the digitization of all prescribed references for public education.

Under House Bill No. 4356, to be known as the "Establishing the Philippine Online Library and Digitization of Public School References Act," the Department of Education, in coordination with the National Library of the Philippines (NLP), shall be responsible for the creation of digitized copies of all prescribed textbooks and essential reference materials for each year level in elementary and secondary school.

The digitized copies of textbooks and reference materials will be made available through a national online library that shall be managed jointly by the NLP and the Department of Information and Communications Technology (DICT).

The Philippine Online Library shall be accessible to the public, free of charge, through an online platform that may be accessed by students with internet access.


As per the projection of the DepEd for school year 2025 to 2026, there are about 27.6 million enrollees in basic education; however, according to the report of the Congressional Committee on Education, from 2012 to 2022, only Grades 5 and 6 have complete textbooks.

'This data suggests that for the past decade, the Philippine education system has been struggling since our young learners in public schools have been sharing textbooks," Lazatin said.

"The digitization of textbooks and other essential references, and making it freely available online, will give more students access to the learning materials that they need," Lazatin added, "We shouldn't gatekeep knowledge; it should be made available to anyone who wants to learn."

The Philippine Online Library is envisioned as a means to bridge the gap in the learning resources whereby learners may be able to access a whole range of materials in their own

It can be recalled that during his time as Angeles City mayor, Lazatin led the renovation of the three-storey Angeles City Library and



Information Center (ACLIC) into a modernized, state-of-the-art facility, which was formally inaugurated on March 19, 2024.

The renovated ACLIC boasts of a broad range of resources, spacious and comfortable reading and seating areas, and computer work-

As district representative, Lazatin is also set to request P200 million to fund the construction of computer labs in 19 public high schools in the First District in 2026.

Under the project, a state-of-the-art computer laboratory will be constructed in six public high schools in Magalang Municipality, 12 public high schools in Mabalacat City, and in Francisco G. Nepomuceno Memorial High School (FGNMHS) in Angeles City.

Each laboratory will be equipped with 50 computers - with five printers for every 10 computers; two air-conditioners; and one 55-inch smart TV. Team Lazatin PR

Cruzada perpetua

AQUI EN la Pampanga hay mucha piedad pero poca caridad.

It has been seventy-three years, this 2025, since that lamentation over the "wealth in piety but poverty in charity" expressed by Bishop Cesar Ma. Guerrero, the first to occupy the bishopric of San Fernando. noting "the stark class differences between the rich and the poor, the strife between the landlords and the tenants, and a deteriorating socio-political-economic situation bordering on socialism."

These were manifest situations of the imperative of revolution in his See. And a revolution did indeed obtain then in Pampanga, with the Huks already "at the very gates of Manila.

Marked as apostates pursuing the establishment of a "godless" society, the Huks naturally had to be stopped, and their ideology uprooted to "save the country and preserve Mother Church." A strategic policy of the Cold War placed the Church at the bulwark of the war against communism.

It was at the very cauldron of that simmering social ferment that Bishop Guerrero organized the Cruzada de Penitencia y Caridad - the Crusade for Penance and Charity - in 1952.

In revolutionary praxis, the Cruzada served the ends of a counter-revolution. The conscientization of the oppressed masa that was the spark to start the inevitable prairie fire, doused by the sprinkle of holy water, the heart soothed by hymns and prayers, the soul seared with the promise of redemption, of eternal bliss in the hereafter. So long as the hardest of toils, the worst of privations, indeed, all injustices and oppression be borne as Christ did with His cross.

Unrepentant communists would readily see it as the affirmation of that Marxist dictum: "Religion is the opium of the people.'

Images of the Virgen de los Remedios and Santo Cristo del Perdon were taken all around the Pampanga parish churches and capillas where they stayed for days, the faithful seeking their intercession and intervention through nonstop prayers and nightly

A hymn to the virgin was composed with peace as recurrent refrain: "...ica'ng minye tula ampon capayapan / quing indu ning balen quequeng lalawigan / uling calimbun mu caring sablang dalan / ding barrio at puruc caring cabalenan / agad menatili ing catahimican..." (...you gave us joy and peace / to the mother of our province / when taken in procession / in all the barrios in the towns / peace descended upon them...) Forgive the poor translation.

The charity end of the crusade - lamac was institutionalized - all the barrio folk, even the poorest of them, contributed some goods that would accompany the images to their next destination and

shared with the neediest there.

The Cruzada in effect became an equalizing and unifying factor among the faithful, regardless of their socio-economic situation. And relative peace did come to the province. For a time.

The breadth and depth of the devotion to the Virgen de los Remedios of the Capampangan moved Pope Pius XII to approve her canonical coronation as the patroness of Pampanga on September 8, 1956.

Since then, without fail, no matter the rains and high water, the Capampangan faithful flock to the annual commemoration of the canonical coronation. (Covid-19 made the exception in 2020, and limited attendance in 2021 though). In a ritual of renewal of faith in their Lord of Pardon, of rededication to their Indu ning Capaldanan (Mother of Remedies), in celebration of their Tula ding Capampangan (Joy of the Capampangan).

Seventy-three years hence, that "deteriorating socio-political-economic situation bordering on socialism" may have been arrested - the communist insurgency virtually as dead as Marx and Mao, Joema Sison too, if not deader.

'The stark class differences between the rich and the poor, the strife between the landlords and the tenants," though still obtain. In various manifestations, in the farms and factories, in the mills and in the malls - as much the wages of sin, as the sin of capitalism – from workers' exploitation to farmland-grabbing, from contractualization to union-busting.

So, did the good Bishop Guerrero's Cruzada of peace through charity and prayers fail?

So, we do still come in prayerful celebration every Sept. 8, in thanksgiving, in supplication.

O Virgen de los Remedios / damdam ca qng quequeng aus / iligtas mu que't icabus / qng sablang tucsu at maroc / ibie mu ing quecang lunos / 'panalangin mu que qng Dios. (O Virgin.../ hear our pleas / free and save us / from all temptation and evil / grant us your compassion / pray to God for us).

The Cruzada can only continue.

The Public Space

It's a dystopic truth, maybe even ectopic, too

It times of deceit, the British author George Orwel said, telling the truth is a revolutionary act.

We are in in that crucial or critical time, a revolutionary time as part of the truth telling in our society. It's a crazy time, nobody knows if passing or failing the lie detector test will help in resolving the grand infection called corruption that has contaminated at least two-thirds of the government – the legislative and the executive.

The judiciary's skin, by the nature of its separate and unique role, is not in the game of the overwhelming rot of the time. It doesn't build roads or bridges, much less engages in flood control. Alas and alack, the Supreme Court has a nagging issue, too and is adding cortisols, literally and figuratively, to the nation's health.

It's been a long time when the SC has been found to have factually erred in coming with a legal ruling on a political issue based on a non-existent news report. Why it is taking so long to issue a new ruling on the same issue is not known. Suffice it to say, that the SC word is final and is, therefore, infallible. Period.

The nation, given its circumstances, needs greater assurance of certainty and fairness.

Times like this call for a precision surgery to excise the tumor that has been the cause of a malevolent, debilitating disease of the nation. In political lingo, there's a need for a Machiavelian leadership and decision.

Unfortunately, according to the second highest official of the land, now on a world tour of some sort, that political quality is mothballed at the top. What we have, so the world would or should know, is a president who doesn't know how to do his job.

So what happened, it turned out that the executive secretary appeared to have more cojones than the principal and called a branch of government, namely the House of Representatives, to clean up its own house, a mantra if not a metaphor of what's taking place or hidden in plain sight among some, maybe many, of its members.

In another feeble attempt at public relations, the president was portrayed as being teary-eyed at the extent of corruption in government. He should have wept. It's doubtful if Machiavelli was in the

same emotional high or low when he wrote The Prince. Maybe the president simply, habitually romanticized about it but could not bring himself to act the way his idol acted.

As things are, or as a veteran senator spilled AND REBUKED it in privileged speech, a top government executive has been engaged in a questionable ethical practice. The president is supposed to have sufficient intelligence fund to know what's secretly taking place in his neck of the woods.

In fairness, the President wants a better result in his investigation of the horrendous and massive anomalies that have flooded the agencies of government, leaving many in flooded areas wet and wild while holding on sandbags.

It seems he needs a few good private sector people, not anyone in government, to do and honest-to= goodness job. The Certification/Certificate of Sale was duly annotated/registered on TCT No. 561094-R on the 5th page of the subject land title on May 27, 2016 as Entry No. 2016007762 as well as the Notice of Levy Execution on November 6, 2015 under Entry No. 2015015125. Copy of the said Annotation/Registration in the 5th page of the subject land title is hereto attached and marked as ANNEX "J". 17. Sheriff III, Johni Glenn Runes issued a Sheriffs Final Deed of Sale with dispositive portion of which read as follows;

18. Petitioner paid the corresponding administrative fees and dues with the Registry of Deeds of San Fernando City, Pampanga, for total sum of PHP 1,983.28. Copy of the Official Receipt dated May 27, 2016 is hereto attached as ANNEX "L", and made an integral part hereof.

Petitioner has made his best efforts to contact the respondents Sps. Romel B. Due and Percy B. Due in order for the latter to surrender the owner's duplicate copy of TCT No. 561094-R to the petitioner but to no avail.

20. As such, petitioner has to exercise his legal options defined under P.D. 1528 otherwise known as Property Registration Decree, which particularly states that; Sec. 107. Surrender of withheld dunlicate certificates. — Where it is necessary to issue:

Sec. 107. Surrender of withheld duplicate certificates. — Where it is necessary to issue a new certificate of title pursuant to any involuntary instrument which divests the title of the registered owner against his consent or where a voluntary instrument cannot be registered by reason of the refusal or failure of the holder to surrender the owner's duplicate certificate of title, the party in interest may file a petition in court to compel surrender of the same to the Register of Deeds. The court, after hearing, may order the registered owner or any person withholding the duplicate certificate to surrender the same, and direct the entry of a new certificate or memorandum upon such surrender. If the person withholding the duplicate certificate is not amenable to the process of the court, or if for any reason the outstanding owner's duplicate certificate cannot be delivered, the court may order the annulment of the same as well as the issuance of a new certificate of title in lieu thereof. Such new certificate and all duplicates thereof shall contain a memorandum of the annulment of the outstanding duplicate.

21. As per Sheriff Final Deed of Sale (see: Annex K) issued to petitioner John Co Tan, it has been declared that the subject real property covered by TCT No. 561094-R is SOLD, has been declared that the subject real property covered by TCT TRANSFERRED AND CONVEYED to petitioner **JOHN CO TAN**.

22. Respondent, Sps. Romel B. Due and Percy D. Due has until May 27, 2017 to redeem the said real property (TCT No. 561094-R) but failed to redeem after a year from date of entry or registration (May 27, 2016) of the Certificate of Sale. Up to the filing of herein Petition, respondents Sps. Due Tailed to redeem the property one (1) year from the time the Certificate of Sale was entered, annotated and registered (Entry No. 2016007762) in the TCT No. 561094-R of the said real property. As such, respondent Sps. Due have deemed waived and lost whatever residual rights accorded to them by law -the right of redemption within a year from the date of the registration of the certificate of sale. 25. Being so, Petitioner had the right to the issuance of a new certificate of title and if the same cannot be registered by reason of the refusal or failure of the holder to surrender the owner's duplicate of title, the petitioner, being a party in interest, may file a petition in court to compel the surrender of the same to the Register of Deeds. In the event of failure to surrender the same or if for any reason the outstanding owner's duplicate certificate cannot be delivered, the Honorable Court may order the annulment of the same as well as the issuance of a new certificate of title in fieu thereof. Such new certificate and all duplicates thereof shall contain a memorandum of the annulment of the outstanding duplicate.

ORDINANCE NO. 733, S-2025 (PO-443-02-25)

ORDINANCE ESTABLISHING AND INSTITUTIONALIZING A DRUG-FREE WORKPLACE IN THE ANGELES CITY LOCAL GOVERNMENT UNIT AND APPROPRIATING FUNDS FOR THE IMPLEMEN-**TATION THEREOF**

WHEREAS, Section 4 of Presidential Executive Order No. 66, dated October 29, 2018, states that "all government entities and LGUs shall formulate and adopt their respective Drug-Free Workplace Programs, and conduct Authorized Drug Testing among their respective officials and personnel, in accordance with the provisions of R.A. No. 9165 and relevant issuances and circulars of the DDB and the Civil Service

WHEREAS, Board Regulation No. 13, s-2018, issued by the Dangerous Drugs Board provides for the establishment and institutionalization of Drug-Free Workplace Policies in all government offices, including the conduct of authorized drug testing for elective local officials and appointive public officers;

WHEREAS, on January 10, 2023, the Office of the Mayor issued Executive Order No. 03, S-2023, implementing a Drug-Free Workplace Policy in all departments and offices of the Angeles City Local Government Unit (LGU), including random and mandatory authorized drug testing for all Angeles City Government Em-

WHEREAS, since the issuance of Executive Order No. 03, s-2023, the City Government has conducted random and mandatory authorized drug testing for various offices of the Angeles City LGU and there is now an apparent need to institutionalize the Drug-Free Workplace Policy of the Angeles City LGU;

SECTION I. SHORT TITLE

City Ordinance No. 733, Series of 2025 shall be known as the "Drug-Free Workplace Ordinance of Angeles City.'

SECTION II. OBJECTIVE

This Ordinance aims to maintain a Drug-Free Workplace in all departments and offices of the Angeles City

SECTION III. SCOPE

This Ordinance covers all employees of the Angeles City LGU, regardless of appointment status, as well as hired Contract of Service Providers / Job Orders.

SECTION IV DEFINITION OF TERMS

For the purpose of this ordinance, the following shall be defined as follows:

- a. Authorized Drug Testing the testing done by drug testing laboratories accredited by the Department of Health ("DOH"). It shall employ, among others, two (2) testing methods, the Screening Test, which will determine the positive result, as well as the type of the drug used, and the Confirmatory Test, which will confirm a positive Screening Test.
- b.Challenge Test a drug test conducted as a result of a challenge filed by a public officer who tested positive for drug use in a confirmatory test in an authorized drug testing activity.
- c. Confirmatory Test an analytical test using a device, tool, or equipment with a different chemical or physical principle that is more specific, which will validate and confirm the result of the screening test.
- d. Dangerous Drugs include those listed in the Schedules annexed to the 1961 Single Convention on Narcotic Drugs, as amended by the 1972 Protocol, and in the Schedules annexed to the 1971 Single Convention on Psychotropic Substances, as enumerated in Republic Act No. 9165 or the Comprehensive Dangerous Drugs Act of 2002, as amended.
- e. Drug Dependency Examination refers to the examination conducted by a physician accredited by the DOH to evaluate the extent of drug use of a person and to determine whether he/she is a drug dependent or not, which includes history taking, intake interview, determination of criteria for drug dependency, mental and physical status, and the detection of dangerous drugs in body specimens through laboratory procedures.
- f. Mandatory Drug Testing compulsory submission of a government employee or an elective or appointive official to drug testing.
- **g. Non-Compliant Employee –** for the purposes of this Order, this shall refer to employees of the Angeles City Local Government Unit who have failed to appear for both the random and the rescheduled mandatory authorized drug testing for all Angeles City Local Government Employees.
- h. Screening Test a rapid drug test performed to establish potential or presumptive positive result. It refers to the immunoassay test to eliminate a "negative" specimen, i.e. one without the presence of dangerous drugs, from further consideration and to identify the presumptively positive specimen that requires confirmatory test.
- i. Substance Use Disorder ("SUD") term used in Diagnostic Manual 5 which combines categories of substance use, abuse and dependence into a single disorder measured on a continuum from mild to severe. Each specific substance is addressed as a separate disorder (e.g. alcohol use disorder, shabu use disorder) and are diagnosed based on the same overarching eleven (11) behavioral criteria. Clinicians can also add "in early remission," "in sustained remission," "on maintenance therapy," and "in controlled environment" in describing their diagnosis which could either be the following:
- 1. Mild SUD a minimum of two (2) to three (3) criteria has been met. Similar to experimental and occasional
- 2. Moderate SUD four (4) or five (5) criteria met which would be similar to regular and habitual users; and
- **3. Severe SUD –** if six (6) or more symptoms/criteria have been met, which is about the equivalent to an abuser and substance dependent individual.

SECTION V. RESPONSIBILITY OF THE ANGELES CITY ANTI-DRUG ABUSE COUNCIL (ACADAC) The Angeles City Anti-Drug Abuse Council (ACADAC) shall have the following responsibilities under the Drug-Free Workplace Ordinance:

- a. Ensuring the implementation of continuing and sustainable substance abuse awareness and prevention programs and informing all officials and employees about the following:
- 1. The Drug-Free Workplace Ordinance of Angeles City;
- 2. The medical and social risks associated with drug use;
- 3. The administrative and criminal sanctions with respect to drug use and violations of Republic Act 9165, otherwise known as the Comprehensive Dangerous Drugs Act of 2002; and
- 4. The availability of the Employee Assistance Program.
- b. Conduct of random mandatory drug testing, in coordination with the City Health Office (CHO) and the City Human Resource Management Office (CHRMO);
- c. Creation of a Drug-Free Workplace Committee, composed of the following:
- 2. Officer-in-Charge, ACADAC
- 3. City Human Resources Management Officer
- 4. City Health Officer
- 5. City Social Welfare and Development Officer
- 6. City Legal Officer
- 7. President, Association of Government Employees for a New and Dynamic Angeles City (AGENDA)

The Committee shall assist in the implementation of the provisions of the Drug-Free Workplace Policy and ensure the creation of a sustainable Employee Assistance Program, which shall provide resources for and/ or referrals to medical interventions for government employees requiring the same.

The Committee shall also create an Assessment Team composed of personnel with educational and training backgrounds on medicine, psychology, social work, and human resources administration that shall assist in the conduct of substance abuse awareness and prevention programs and in the implementation of the Employee Assistance Program.

SECTION VI. PRE-EMPLOYMENT DRUG TESTING

Mandatory drug testing shall remain a requirement for initial entry to government service (career and non-career service). Any applicant found positive for drug use shall be denied entry to government service.

SECTION VII. GUIDELINES IN THE CONDUCT OF AUTHORIZED DRUG TESTING

The Drug-Free Workplace Policy of the Angeles City LGU shall include the conduct of authorized drug testing, the purpose of which is to prevent the entry of dangerous drugs in government offices and use of dangerous drugs among government employees.

Said authorized drug testing shall be carried out in accordance with the following guidelines:

- A. All employees of the Angeles City Local Government Unit, regardless of status of appointment, including the hired Contract of Service Providers / Job Orders, shall be subject to the conduct of a mandatory, random, and suspicionless authorized drug testing;
- B. All results of authorized drug testing activities shall be strictly confidential. Only the Head/Officer-in-Charge of the ACADAC, the City HRM Officer, and the City Mayor shall have access to such results;
- C. All drug test results and records shall strictly be held confidential, which shall be formally endorsed directly to the City HRM Officer for attachment to the 201 Files of all employees;
- D. Authorized drug testing shall be conducted only by a drug testing laboratory accredited by the DOH;
- E. A positive drug test result from the confirmatory test shall immediately be known to the Head/Officer-in-Charge of the ACADAC, who shall notify the employee concerned. The employee shall have fifteen (15) days from receipt of notice to challenge the result of the confirmatory test. Using the same specimen, a challenge test shall be conducted by a drug testing laboratory accredited by the DOH. All expenses incurred in the conduct of the challenge test shall be borne by the concerned employee;
- F. A positive drug test result from the challenge test is deemed final and the employee shall be subjected to administrative proceedings. Failure to file a challenge within the prescribed period shall make the positive drug test result from the confirmatory drug test final. The City Government shall then take the appropriate
- G. In case of negative drug test result, no further action is needed;
- H. In case an employee fails to show up for the random and mandatory authorized drug testing for their department/office, they are required to:
- 1. Submit a written explanation addressed to the Office of the Mayor within forty-eight (48) hours after their initial drug testing schedule;
- 2. Appear for a rescheduled mandatory authorized drug testing. The time, date, and venue of the rescheduled mandatory authorized drug testing shall be announced by the Office of the City Mayor.
- I. Contract of Service Providers / Job Orders who fail to appear for both the random and the rescheduled $mandatory\ authorized\ drug\ testing\ shall\ be\ considered\ 'Non-Compliant'.\ The\ contracts\ of\ 'Non-Compliant'$ Contract of Service Providers / Job Orders shall be terminated immediately.

SECTION VIII. EMPLOYEE ASSISTANCE PROGRAM

An employee, prior to the conduct of authorized drug testing, may seek proper intervention in coordination with the ACADAC, which shall provide referrals and additional services to the employee concerned. A drug dependency examination shall be conducted in order to determine the level of Substance Use Disorder and the applicable intervention.

Employees who tested positive in the confirmatory test will be subjected to drug dependency examination and rehabilitation. Employees who refuse to undergo rehabilitation will be charged with Grave Misconduct, as stated in Civil Service Commission Memorandum Circular No. 13, series of 2017, and violation of Section 15 of RA 9165.

SECTION IX. SANCTIONS

- A. An employee who refuses, without any valid reason, to submit himself/herself to authorized drug testing shall be charged with the administrative offense of Grave Misconduct.
- B. Any employee found to have tampered the result of a drug test, interfered with the conduct of the drug test or in the release of drug test results, or violated rules of confidentiality of records shall be charged with the administrative offense of Grave Misconduct without prejudice to the filling of a case for violation of Section 32, Article II of R.A. 9165.
- C. Any public officer who violated the provisions of Article II of the Comprehensive Dangerous Drugs Act of 2002 shall be charged with the administrative offense of Grave Misconduct or face disciplinary sanction under Section 60 of the Local Government Code, as the case may be without prejudice to the filing of criminal charges under R.A. 9165 and other relevant laws.
- D. For an employee who tested positive in the mandatory drug testing for a second time after undergoing rehabilitation, the provisions of Section 15, Article II of R.A. 9165 for second-time offenders shall apply. In the case of criminal charges being filed against the employee under R.A. 9165, the Chief Executive may impose a Preventive Suspension on the employee until such a time that the charges have been cleared. Should the employee be found guilty of said charges, the employee may be removed from service, in accordance with the rules of the Civil Service Commission.
- E. The Department of Interior and Local Government (DILG) shall cause the filing of cases for the local government units concerned. The Fact-Finding Committee for Administrative Cases shall hear the erring employees and hired service providers.

SECTION X. REPORTING

Should an employee test positive in the drug test, their name shall be forwarded to the relevant Barangay Anti-Drug Abuse Council (BADAC), the Philippine National Police (PNP), and the Philippine Anti-Drug Enforcement Agency (PDEA) for proper recording and documentation. The employee's name shall be removed from the records of the BADAC, PNP, and PDEA after the employee has finished rehabilitation.

SECTION XI. CONFIDENTIALITY

Any person who, having official custody or access to all data and information relative to the conduct of the authorized drug testing, or anyone who, having gained possession of such data and information, reveals their content to any person not authorized to have access thereto, shall be prosecuted for violation of Section 32, Article II of R.A. 9165.

SECTION XII. REPEALING CLAUSE

All ordinances, rules and regulations, or parts thereof, whose provisions are in conflict with or contrary to the provisions of this ordinance, are hereby repealed, amended and modified accordingly.

SECTION XIII. SEPARABILITY CLAUSE

If for any reason or reasons, any part or provision of this Ordinance shall be held unconstitutional or invalid, other parts or provisions hereof which are not affected thereby, shall continue to be in full force and effect.

SECTION XIV. EFFECTIVITY

This Ordinance shall take effect one (1) week following its publication in at least one (1) newspaper of general circulation in Angeles City and after the adoption by the Sangguniang Panlungsod of the Implementing Rules and Regulations.

ORDINANCE NO. 737, S-2025 (PO-450-04-25)

AN ORDINANCE REGULATING THE OPENING OF THE PERIMETER FENCE ALONG DON JUICO AVENUE AND M.A ROXAS HI-WAY FOR THE EMERGENCE OF BUSINESSES WITHIN THE TERRITORIAL JURISDICTION OF ANGELES CITY, ESTABLISHING STANDARDS FOR PUBLIC SAFETY, AESTHETICS, AND COMPLIANCE WITH EMERGENCY MANAGEMENT REQUIREMENTS AND FOR OTHER PURPOSES.

(Introduced by Atty. Arvin M. Suller)

WHEREAS, the Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances intended to promote the general welfare of the city and its inhabitants, as provided herein by Paragraph 1, sub paragraph II and Paragraph 5, sub paragraph V and VI under Section 458 of RA 7160 otherwise known as the Local Government Code of Philippines:

- (1) Approve ordinances and pass resolutions necessary for an efficient and effective city government, and in this connection shall:
 - (a) Maintain peace and order by enacting measures to prevent and suppress lawlessness, disorder, riot, violence, rebellion or sedition and impose penalties for the violation of said ordinances.
- (2) Approve ordinances which shall ensure the efficient and effective delivery of the basic services and facilities as provided for under Section 17 of this code, and in addition to said services and facilities, shall:
 - (a) Regulate the use of streets, avenues, alleys, sidewalks, bridges, parks and other public places and approve the construction, improvement, repair and maintenance of the same; establish bus and vehicle stops and terminals or regulate the use of the same by privately-owned vehicles which serve the public; regulate garages and the operation of conveyances for hire; designate stands to be occupied by public vehicles when not in use, regulate the putting up of signs, signposts, awnings and awning posts on the streets; and provide for the lighting, cleaning and sprinkling of streets and public places;
 - (b) Regulate traffic on all streets and bridges, prohibit encroachments of obstacles thereon and, when necessary in the interest of public welfare, authorize the removal of encroachments and illegal constructions in public places.

WHEREAS, the local government body recognizes the need for the regulation of the perimeter fence along and M.A Roxas hi-way, within the bounds of the territorial jurisdiction of Angeles City, to adhere to standards that balance the requisites for security with the protection of public welfare, emergency access, and aesthetics and to improve vehicular access and public safety in the emergence of businesses;

WHEREAS, it is in the interest of public safety and the well-being of the community to ensure that opening of the perimeter fence would be regulated well and accesses to be established in the future are appropriately designed and constructed to facilitate better movement of residents, visitors, and public services while maintaining order and safety on the public roads;

NOW, THEREFORE, be it enacted by the Sangguniang Panlungsod of the City of Angeles, as follows:

SECTION 1. DEFINITION OF TERMS

- 1. Perimeter Fence: A barrier erected around a property or specified location that is designed to control or restrict access;
- 2. Access/ Access Point: Any opening or entrance to a property where vehicular or pedestrian movement is permitted;
- 3. Emergency Access: The ability of fire, police, medical, or other emergency vehicles or personnel to reach business premises or individuals in need of assistance quickly and safely:
- 4. Business/es: A plot of land or building used for commercial activities, including but not limited to retail stores, offices, and industrial establishments;

SECTION 2. PURPOSE AND INTENT. The purpose of this Ordinance is to regulate the opening of the perimeter fence along Don Juico Avenue and M.A Roxas hi-way for the emergence of businesses within the territorial jurisdiction of Angeles City, establishing standards for public safety, aesthetics, and compliance with emergency management requirements for the benefit of public access, in accordance with applicable laws and regulations.

SECTION 3. CONDITIONS FOR OPENING OF THE PERIMETER FENCE

- 1. The opening of the perimeter fence for the establishment of accesses shall only be done for public use, as such in cases of future emergence of businesses that would necessitate it;
- 2. It should be properly regulated and upon the completion of necessary

infrastructure and safety measures, including but not limited to road signage, proper lighting, and secure barriers;

2. The accesses to be opened will be subject to the approval and periodic inspections by the City Government of Angeles and Clark Development Corporation to ensure its functionality and safety.

SECTION 4. RESPONSIBLE AUTHORITIES AND TERRITORIAL **JURISDICTION**. The Angeles City Local Government and Clark Development Corporation, who has shared territorial jurisdiction on the future location/s of the to-be-opened portion/s of the perimeter fence along Don Juico Avenue and M.A Roxas hi-way, shall be responsible for the following:

- 1. The construction, installation, and maintenance of the gates and surrounding infrastructure;
- 2. Ensuring that all legal and regulatory requirements, including environmental and safety standards, are met before the opening of the two main accesses and one pedestrian passage.

SECTION 5. TRAFFIC REGULATIONS AND MANAGEMENT

- 1. The future opening/s of the perimeter fence will be subject to all relevant traffic laws and regulations;
- 2. Speed limits, signage, and other traffic control measures will be implemented to ensure the safety of all road users;
- 3. The Angeles City Local Government and Clark Development Corporation shall enforce traffic management to prevent misuse of the future opening/s of the perimeter fence.

SECTION 6. ENFORCEMENT. Failure to comply with the terms outlined in this ordinance shall result in penalties, including fines, closure of the two main accesses and one pedestrian passage, or other actions as deemed necessary by the appropriate authority.

SECTION 7. FUNDING - The funds for the proper implementation of this ordinance may come from the General Fund of the Local Government of Angeles.

SECTION 8. IMPLEMENTING RULES AND REGULATIONS. The Office of the City Mayor thru the City Engineer's Office and Angeles City Traffic and Development Office, along with the technical assistance of all other departments of the city government, may issue the necessary implementing rules and regulations for the strict implementation of the provisions of this ordinance within thirty (30) days following its approval. Such guidelines shall be reviewed periodically by the body every year from its implementation or whenever necessary.

SECTION 9. ADMINISTRATIVE AUTHORITY OF THE CITY MAYOR. – The City Mayor, upon consultation with the city departments, is hereby authorized to issue rules and regulations for the effective implementation of this ordinance. The city chief executive is also hereby granted to enter into agreements with Clark Development Corporation relating to the provisions of this ordinance upon the authority of the Sangguniang Panlungsod.

SECTION 10. SEPARABILITY CLAUSE. - If for any reason any part of this ordinance shall be declared to be unconstitutional or invalid, the other parts of provisions hereof which are not affected thereby shall continue to be in full force and effect.

SECTION 11. REPEALING CLAUSE. - All city ordinances, resolutions, executive orders, or parts thereof, inconsistent herewith are hereby repealed or modified accordingly.

SECTION 12. EFFECTIVITY. - This ordinance shall take effect immediately after its publication in a newspaper of local circulation.

ORDINANCE NO. 738, S-2025 (PO-451-04-25)

AN ORDINANCE AMENDING ORDINANCE NO. 294, S-2011 ENTITLED "AN ORDINANCE ESTABLISHING A LOCAL COLLEGE IN THE CITY OF ANGELES TO BE KNOWN AS THE "CITY COLLEGE OF ANGELES", GRANTING ITS CHARTER, PROVIDING FOR THE RULES, REGULATIONS AND PERTINENT GUIDELINES FOR ITS ESTABLISHMENT AND OPERATIONS THEREOF"

WHEREAS, it has been the declared policy of the State to recognize the vital role of the youth in our society and the need to assist them in their full development;

WHEREAS, the 1987 Philippine Constitution mandates that the State shall promote and protect the right of all citizens to quality education at all levels and shall take appropriate steps to make education accessible to all,

WHEREAS, it is further believed that education is accorded with premier importance towards the full development of the human resource of the city in particular and the country at large;

WHEREAS, it is the firm belief of the Sangguniang Panlungsod that education is an effective tool in emancipating the underprivileged sector of our society from the bondage of poverty, therefore the implementation of any legislative undertaking such as the establishment of a local college/local higher learning institution will definitely transform deserving students with the desired competitive work knowledge, skills and values which are essential in their progressive living as individuals and members of community and society,

WHEREAS, based on the survey, it was found out that a significant number of families in the city failed to send their children for college education because of their inability to cope with the commercialized education in private higher learning institutions;

WHEREAS, the marginalized youth with the capability to pursue college education must be provided with equal rights for quality and affordable higher education;

WHEREAS, cognizant to the importance of college education as a strong foundation in arming the youth for community and nation building, the Honorable City Mayor through the Council's Committee on Education proposed the establishment of the City College of Angeles that will offer different degree courses in the fields of sciences, arts, education, information technology, commerce, engineering and other relevant courses. It shall also undertake research and extension services, and provide progressive leadership in its areas of specialization;

WHEREAS, the aspects of budgetary/funding requirements of the operation of the City College of Angeles has been well deliberated and shall be shouldered by the City Government of Angeles;

WHEREAS, all sectors, both public and private, have expressed and confirmed their approval to the establishment of the college considering that this legislative undertaking shall serve as an important legacy in building a brighter life of our youth today and the future:

WHEREAS, the entire City of Angeles believes in the sayings that the future of the country is the youth and "is not in our boardrooms but in our classrooms":

NOW THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG PANGLUNGSOD OF CITY OF ANGELES IN SESSION ASSEMBLED THAT:

ARTICLE I -TITLE AND COVERAGE

Section 1. Title. This Ordinance shall be known as the "CHARTER OF CITY COLLEGE OF ANGELES."

Section 2. Administrative Provisions and Coverage.

- a. This ordinance establishing the City College of Angeles and granting its charter providing for the rules, regulations and pertinent guidelines for its establishment and Government operations thereof shall be an exclusive undertaking and initiative of the City of Angeles through the cooperation and support of the Department of Education (DEPED), the Commission of Higher Education (CHED), Technical Education and Skills Development Authority (TESDA) and all elected and appointed officials of the city;
- b. The City College of Angeles shall be provided herein of its rules, regulations and guidelines for its establishment and operation.

ARTICLE II - GENERAL PROVISIONS

Section 3. There is hereby established in the City of Angeles, within the powers and limitations hereinafter Angeles, which specified, a higher educational institution to be known as the City College of Angeles (CCA).

Section 4. The City College of Angeles shall be guided by the following fundamental principles:

- a) That the local college shall support the community need for education through affordable, accessible, and high standard of collegiate and continuing education as well as skills training:
- b) That the basic right for higher education of every capable individuals must be requested and be given equal opportunity for development in his/her chosen field of specialization;
- c) That the local college will serve as a catalyst for human development, cultural convergence and unity;
- d) That the local college will be a strong identity of Angeleños in their belief as a united people for education as an instrument for progress and development

Section 5. Vision, Mission and Objectives of the City College of Angeles Vision: "An institution of hope, a thought leader in its area of operation and preferred provider of talents in the Metro Angeles Area."

Mission: "City College of Angeles is committed to offer quality education for the holistic development of competitive and technically capable professionals with deep sense of excellence, resiliency, stewardship and patrimony."

Objectives:

- a. To provide degree and non-degree programs that are relevant to local and global demands and is in compliance with quality standards in education
- b. To strengthen the natural capability of the College through continuous benchmarking, program evaluation, innovation and professional development of the administrators,

faculty and staff

- c. To develop networks and linkages with local and international institutions to ensure quality education
- d. To produce research, which will contribute to the efficient and effective management of the institution and to serve the community better
- e. To develop and strengthen the moral values of administrators, faculty, staff and students
- f. To develop a positive image of corporate social responsibility that will benefit the community
- g. To serve as an active agent for the cultivation, promotion, preservation and appreciation of Kapampangan arts, culture, and heritage

Section 6. The College Seal

The seal of the College is a shield that contains the seal and symbol of the city as well as the year of foundation of the College.

The phoenix symbolizes triumph over tragedy. The man symbolizes every Angeleño.



The broken chains represent the capability of Angeleños to set themselves free from the bondages of man-made and natural disasters. The shield epitomizes dignity and respect for the self.

The olive green color signifies hope for a bright tomorrow. White is a symbol of purity of intentions to provide service to the community. The color gold represents how, like real gold, Angeleños are "tested in fire" of adversities and in the end emerge triumphant.

The Latin phrase "Totalis Humanae" summarizes the mission of the City College of Angeles towards man's total human development.

ARTICLE III - GOVERNING BOARD MEMBERSHIP AND FUNCTIONS

Section 7. The administration and governance of the CCA is hereby vested to and shall be exercised by a Governing Board to be known as the Board of Trustees (BOT) of the CCA. The BOT shall be composed of the following:

- a. The City Mayor as Chairman
- b. The President of the City College of Angeles as Vice Chairman.
- c. The Chairman of the Committee on Education of the Sangguniang Panlungsod as Member
- d. President of CCA Student Council as Member
- e. ALCU Representative/Local College Chief Representative as Member
- f. President of CCA Alumni Association as Member
- g. President of a reputable business firm in the City of Angeles as Memberh. Representative of the prominent citizen of the City of Angeles as Member
- i. President of CCA Faculty Association as Member
- j. CHED Representative as permanent resource person
- k. TESDA Representative as Member
- I. City Treasurer as Member

m. City Accountant as Member

Section 8. The functions of the BOT as prescribed in this Ordinance are: Generally, the BOT is the highest policy-making body of the CCA , and as such, shall:

- a. Set the vision and strategic direction of the CCA, ensuring its alignment with the LGU's development agenda, higher education agenda, and the national government's thrust;
- b. Establish an effective and efficient structure of the CCA;
- c. Ensure sound financial management; and
- d. Approve plans or policies related to the overall governance of the CCA.

Specifically, the BOT shall have the following duties and responsibilities:

- a. Establish policy guidelines, rules, regulations and procedures not contrary to law and which are necessary to carry the purpose and function of the LUC, and ensure participative decision-making and transparency within the institution;
- b. Approve academic arrangements for capacity building of the institution, with appropriate institutions and agencies, public or private, local or foreign, and to appoint experts/ specialists as consultants, or visiting or exchange professors, scholars, researchers, as the case may be, consistent with the provisions of the Transnational Higher Education Act (RA No. 11448), and other guidelines of CHED relative to such academic arrangements;
- c. Approve the curricula, institutional programs and rules of discipline drawn by the administrative and academic councils in accordance with the existing CHED Policies, Standards and Guidelines;
- $\hbox{d. Set policies on admission, retention and graduation of students};\\$
- e. Award honorary degrees upon persons in recognition of outstanding contribution in the field of education, public service, arts, science and technology or in any field of specialization within the academic competence of the LUC, subject to the existing CHED guidelines, and to authorize the award of certificates of completion of non-degree and nontraditional courses, subject to existing CHED policies and guidelines;
- f. Ensure the efficient management of non-academic services such as medical and dental, guidance and counseling, career and job placement, canteen, buildings, grounds, property maintenance and similar services;
- g. Institutionalize and strengthen research and extension programs;
- h. Recommend to the Local Chief Executive the appointment of President/Administrator or equivalent position of the LUC from the list of three (3) qualified candidate/s / applicant/s based on the search made under Section 12 of this CMO;
- i. Recommend to the Local Chief Executive the appointment/designation of the vice presidents, deans, directors, heads of departments, faculty members and other officials and employees whose salaries and wages are wholly or mainly paid out of the local funds and whose appointments are not otherwise provided for under RA No. 7160, as well as those the Local Chief Executive may be authorized by law to appoint;
- j. Fix the tuition fees and other necessary school charges such as but not limited to matriculation fees, graduation fees and laboratory fees, as their respective boards may deem proper to impose after due consultations with the involved sectors subject to compliance with existing CHED policies, standards and guidelines;
- k. Adopt and implement a socialized scheme of tuition and school fees for greater access to poor but deserving student, if in case the LUC is not a recipient of a government subsidy;
- I. Coordinate with the PCM's local Sanggunian to provide for the regular support for the development, operation, and maintenance of the LUC;

- m. Recommend to the PCM's local Sanggunian policies on higher education and other related development legislation on effective governance and management;
- n. Approve consortia and other forms of linkages with local government units, institutions and agencies, both public and private, local and foreign, in furtherance of the purposes and objectives of the institution including its Internationalization initiatives;
- o. Receive and appropriate budget as may be provided, to support of the institution in the manner it may determine, in its discretion, to carry out the purposes and functions of the
- p. Receive in trust legacies, gifts and donations of real and personal properties of all kinds, to administer and dispose of the same when necessary for the benefit of the LUC, subject to limitations, directions and instructions of the donors, if any. Administer the same in the absence of specific directives of the donor. Such donations shall be subject to applicable laws on tax exemptions on donations and gifts, and all applicable laws;
- q. Recommend to and implement the Local Government Unit-approved construction or repair of its buildings, machineries, equipment and other facilities and the purchase and acquisition of real and personal properties including necessary supplies, materials and equipment. Purchases and other transactions entered into by the LUC through the GB shall be subject to applicable laws on tax exemptions on donations and gifts, and all applicable laws;
- r. Approve salaries of faculty members and administrative officials and employees subject to the provisions of the revised compensation and classification system and other pertinent budget and compensation laws governing hours of service, and such other duties and conditions as it may deem proper; to grant them, at its discretion, leaves of absence under such regulations as it may promulgate, any provisions of existing law to the contrary notwithstanding; and to remove them for cause in accordance with the requirements of due process of law;
- s. Approve the absorption/adoption of LGU acquired non-chartered tertiary institutions within their respective PCM in coordination with the CHED and other relevant agencies and to offer therein needed programs or courses, to promote and carry out equal access to educational opportunities mandated by the Constitution;
- t. Establish chairs in the LUC and to provide fellowships for qualified faculty members and scholarships to deserving students;
- u. Authorize, as may be needed, an external management audit of the institution to institute reforms, including academic and structural changes, on the basis of the audit results and recommendations;
- v. Approve the set up on the adoption of modern and innovative modes of transmitting knowledge through different teaching and learning modalities subject to CHED requirements;

- z. Delegate specific duties and responsibilities provided for hereinabove to the President /Administrator or equivalent position and/or other officials of the LUC as it may deem appropriate so as to expedite the administration of the affairs of the LUC

Section 9. Secretary of the CCA BOT:

The BOT shall designate a secretary who shall serve as such for both the BOT and the CCA and shall keep all records and proceedings of the BOT. The Secretary shall communicate to each member of the BOT notice of meetings.

a. The Chairman. The incumbent City Mayor as Founding Chairman shall serve for a term

- c. The term of office of the Chairman of the Committee on Education shall be co-terminus with his/her respective term of the office as member of the Sangguniang Panlungsod;
- d. The other members namely: President of the Faculty Association; President of Student Council; President of Alumni Association; and other members shall adopt the term of the
- e. The President of a reputable business firm in the City of Angeles and Representative of the prominent citizen of the City of Angeles shall be appointed by the BOT upon the recommendation of the Chairman of the Board with a fixed term of three years subject to renewal.

ARTICLE IV — MEETINGS

Section 11. Regular Meetings. Regular meetings of the BOT shall be held quarterly every first Thursday of the quarter at the College or any other place in the City of Angeles as determined by the Board from the last preceding meeting.

Section 12. Special Meetings. Special Meetings of the BOT shall be held at the College or in any place in the City of Angeles upon the call of the Chairman or the majority of the

Section 13. A written notice to the BOT members stating the date, time and purpose of the meetings, be it regular or special, shall be served personally at least three (3) days before

Section 14. Quorum. A majority of all the members shall constitute a quorum to transact official business and decide any question at the meeting.

Section 15. Order of Business. The order of business of the meetings of the BOT shall be as follows;

- a. Call to Order
- b. Prayer
- c. Roll Call
- d. Approval of the minutes of the previous meeting.
- e. Ratification of all the acts and resolution approved by the Ex-Com (not for BOT meeting).
- f. Calendar of Business for the day.
- g. Adjournment

AND COMPENSATION OF MEMBER OF BOT

Section 16. Qualification. All members of the BOT shall be bona fide citizen of the Philippines and with proven responsibility, integrity and honesty.

Section 17. Vacancy. In case of vacancy in the BOT by reason of registration, removal from office, death or any other incapacity of one or more of its members, such vacancy shall only serve the unexpired term of his predecessor.

Section 18. Suspension and Removal. A member of the BOT may be suspended or removed from office upon a majority vote of the members of the Board based on the following causes;

- a. Incapacity;
- b. Incompetence;
- c. Dishonesty;
- d. Conviction of a crime involving moral turpitude; or
- e. Any act detrimental to the interest and welfare of the college.

Provided no member of the Board may be suspended or removed from office without taking into consideration the due process of law.

Section 19. Compensation. The member of the BOT shall serve without compensation except for allowance or per diem set at PHP 5,000 during its regular or special meetings called for by the presiding officer.

ARTICLE VI - ADMINISTRATION OF THE INSTITUTION

Section 20. The Administration:

a. The administration of the CCA shall be vested in the President who shall render full-time service. The powers and duties of the President, in addition to those specifically provided in CMO 18 S2022, shall be those usually pertaining to the Offices of the President of other colleges/universities, and those delegated by the Governing Board The President shall have a term of four (4) years and shall be eligible for reappointment for another term only. The President shall hold an earned doctoral degree, defined as level 8 in the Philippine Qualifications Framework (L8) as stipulated in PQF National Coordinating Council Resolution No. 2014-03 adopted on December 11, 2014 and its amendments thereafter, from a CHED-recognized higher learning institution, with at least five (5) years of relevant administrative experience.

In case of vacancy by reason of death, resignation, or removal for cause or incapacity of the President to perform the functions of their office, the Board shall immediately recommend to the Local Chief Executive the designation of an officer-in-charge (OIC), with the same qualifications as required of a President. The designation shall not exceed a period of one (1) year, renewable for another one year, pending the appointment of a new President/Administrator or equivalent position, subject to existing CSC Rules2. The Board shall immediately create and convene the Search Committee (SC).

The search process shall comply with Annex E of the CMO 18 S2022 entitled Search Process and Minimum Qualifications for LUC President.

- b. The Vice-President for Academic Affairs who shall be appointed by the President and shall serve for a term of the four (4) years, subject to renewal, unless sooner removed for a cause. His powers and duties as well as rate of compensation shall be prescribed by the BOT, provided that he must be a holder of an earned doctoral degree;
- c. The Vice-President for Administration who shall be appointed by the President and shall serve for a term of four (4) years, subject to renewal, unless sooner removed for a cause. His power and duties as well as rate of compensation shall be prescribed by the BOT; provided that he must be a holder of an earned doctoral degree;
- d. The Vice-President for Research who shall be appointed by the President and shall serve for a term of four (4) years, subject to renewal, unless sooner removed for a cause. His power and duties as well as rate of compensation shall be prescribed by the BOT; provided that he must be a holder of an earned doctoral degree.

Suspension and Removal. The aforementioned officers may be suspended from office by a majority vote of the BOT for reason of incapacity, incompetence, dishonesty, conviction of crime on involving immoral turpitude or any act detrimental to the interest and welfare of the college in accordance with applicable laws.

Section 21. Mandatory Plantilla positions. The Basic/Mandatory Plantilla Positions are

Section 24. Academic Coordinators. The Program Academic Coordinator shall be

Section 25. Composition. The members of the faculty of the College shall be selected based on the selection policy of the college, they standard set by the Commission on Higher Education and existing policies of the Civil Service Commission and other meritorious performances.

Section 26. The implementing rules and regulations on recruitment, appointment, promotion, career and personnel development, performance evaluation system, incentive award system, moonlighting, overload, leave benefits, complains and grievance machinery, public sector unionism, discipline, and welfare services including that of part timers shall be promulgated.

Section 27. Members of the Faculty who conducted outstanding researches in their fields of specialization shall be awarded with cash incentives.

Section 28. Working Hours. Full-time faculty members are required to render a total of forty (40) hours of work e eek at the College, divided as follows: twenty-four (24) hours of teaching loads, six (6) hour consultation hours, five (5) hours of research activity, and five (5) hours office work.

However, in the exigency of the service regular faculty teaching loads may exceed up to the maximum of six (6) units and will be compensated as overtime pay as long as it is beyond the forty (40) working hours required by the Civil Service Commission.

A part time faculty or guest lecturer may be given teaching load not exceeding what is provided by pertinent regulations, and shall render contract-based service.

Section 29. Retirement. Retirement of all full-time faculty members shall be compulsory at the age of sixty-five (65).

ARTICLE IX — NON-TEACHING PERSONNEL

Section 30. Qualification Standard. To be appointed to a permanent non-teaching position at City College of Angeles, one must hold an appropriate education background and experience aligned to or allied to one's assigned position. The members of the nonteaching personnel shall be selected based on standard set by the College consistent with the existing policies of the CHED and the CSC. The members of the non-teaching personnel small be recommended for appointment by the President to the Local Chief Executive.

Section 31. Vacant position marked for filling up shall be published in accordance with Republic Act 7041 (Publication Law). The published vacant position shall also be posted in at least three (3) conspicuous places at City College of Angeles, City Hall Building, and /or Community Bulletin Board for at least fifteen (15) days. Other appropriate modes of publication shall be considered.

. Section 32. Filling up of vacant position shall be made after fifteen (15) days from their publication. The publication of a particular vacant position shall be valid until filled up but not to extend beyond six (6) months reckoned from the date the vacant position was published.

Section 33. Members of the Non-Teaching Personnel who conducted outstanding researches in their fields of specialization shall be awarded with cash incentives.

ARTICLE X — STUDENTS

Section 34. Students Admission. Preference in the admission of students shall be given to the bona fide residents of the City of Angeles subject to the selection and admission policies approved by the BOT, provided, however, that no students shall be denied admission to the College by reason of age, sex, nationality, religious belief, or political affiliation.

ARTICLE XI — THE MANAGEMENT COMMITTEES

Section 35. The EXECOM consists of the President and Vice Presidents. Meetings will be held at least once a month.

Section 36. The Management Committee (MANCOM). The MANCOM consists of the President, Vice Presidents, Deans, Directors and Unit Heads. Meetings will be held at least once a month.

ARTICLE XII — COLLEGE COUNCILS

Section 37. The Academic Council consists of the Vice-President for Academic Affairs, Deans, Librarian, Guidance Head, Registrar and Academic Coordinators.

Functions of the Academic Council:

- a. Formulate the fields of study, rules and discipline subject to the approval of the Board and existing laws, rules and regulation;
- b. Prescribe requirements for admission of students to CCA, as well as for graduation and conferment of degrees subject to the approval of the Board;
- c. Exercise exclusive power to recommend students as candidates for graduation or any other persons to be conferred with honorary degrees;
- d. Discipline students within the limit prescribed by the standards of student conduct;

Section 38. The Administrative Council consists of the Vice-President for Administration and all heads of administrative offices.

Functions of the Administrative Council are as follows:

- c. Plan and organize college-wide activities;
- d. Perform actions other than those enumerated above affecting administrative personnel

Section 39. The Research Council consists of the Vice President for Research, Research Head, Ethics Committee, and Institute Research representatives.

Functions of the Research Council are as follows:

- a. Set research priorities, support funding, and promote research excellence
- b. Ensure quality assurance and research process, foster collaboration with external partners, and uphold ethical practices
- c. Evaluate research performance, encourage interdisciplinary work, and provide training for researchers
- d. Support community extension by applying research to address societal needs and advise university leadership on research policies and strategies

Section 40. The College Councils shall meet once a month or whenever the need

Section 51. Repealing clause. Any City Ordinance, resolution and its rules and regulations or any part thereof, which are inconsistent with any of the provision of this Ordinance are hereby repealed or amended accordingly.

Section 52. Effectivity Clause. This Ordinance shall take effect upon its approval.



ORDINANCE AMENDING CITY ORDINANCE NO. 682, SERIES 2023 ENTITLED "AN ORDINANCE PROHIBITING THE SNEAKING-IN/SMUGGLING OF CONTRABANDS IN DETENTION CELLS, JAILS, REFORMATORY CENTERS AND HALF-WAY HOUSES IN THE CITY OF ANGELES" OTHERWISE KNOWN AS THE ANTI-CONTRABAND ORDINANCE OF ANGELES CITY, TO INCLUDE UNDER SECTION 6. call at the oath-taking ceremony of the LPP officials at Kalayaan Hall, Malacañang Palace on Sept. 3.

The president stressed that public funds are meant for the welfare of the nation and not for personal gain.

It was Marcos Jr. himself that exposed irregularities in the Department of Public Works and Highways flood control projects, which prompted a thorough investigation into the matter.

The chief executive expressed outrage upon seeing some "ghost" flood mitigation projects, warning that the private contractors involved would be blacklisted and could face charges of economic sabotage.

"Ngayon, higit kailanman, kailangan ng bansang Pilipinas ang inyong pamumuno upang wakasan ang mga maling nakagisnan," Marcos Jr. said. "Nagsisimula pa lang ang laban at mahaba pa ang ating tatahakin. Umaasa ako na kasama namin kayo sa bawat hakbang, sa pagsusuri sa mga proyekto, sa pagsasaliwanag sa mga nagkukubli sa kadiliman."

President Marcos told the governors to serve as "conscience" and confront critical challenges to build a better future for all Filipinos. "Para sa mga bagong opisyal ng LPP: Magsisilbing gabay. Magsisilbing boses. At higit sa lahat, magsilbi kayong konsensya," he said.

turned over the marker to San Fernando Archbishop Florentino S. Lavarias, D.D., after celebration of a thanksgiving Mass.

Former beauty queen and tourism secretary Gemma Cruz Araneta gave a message on behalf of the Guerrero family.

Installed as the first bishop of the then Diocese of San Fernando (Pampanga) on Sept. 8, 1949, Bishop Guerrero established the Mater Boni Consilii Seminary in Guagua town in 1950, which later relocated to Apalit, and finally in San Fernando as the Mother of Good Counsel Seminary.

In 1952, amid the social unrest in Pampanga, Bishop Guerrero launched the Cruzada de Penitencia y Caridad (Crusade of Penance and Charity) promoting devotion to the Virgen de los Remedios and countering the spread of socialism. Four years after, on Sept.

8, 1956, Pope Pius XII bestowed the canonical crown to the revered image who has since been declared as the patroness of Pampanga.

Also in 1956, Rishon

Also in 1956, Bishop Guerrero brought the Discalced Carmelite sisters to establish a foundation in Angeles.

The bishop resigned in 1957 and was honored by the Vatican as an assistant to the papal throne, holding the rank of papal count. He died

on March 27, 1961. His tomb is beside the Carmel of the Infant of Jesus of Prague chapel at the Carmelit Monastery in Angeles City.

During the installation of the bishop's historical marker, a book on the history of the Mother of Good Counsel Seminary written by former NHCP commissioner Dr. Lino Dizon, himself an alumnus of the seminary, was also launched. Punto News Team/Photo: NHCP

testimony presented by the prosecution to prove allegations against them.

"(T)he prosecution has failed to discharge its burden to present sufficient evidence to support a verdict of guilt against all accused. Wherefore, premises considered, the Demurrer to evidence filed by the accused ... is hereby granted," the Sandiganbayan said.

The court likewise ordered the return of bail bonds posted by all the defendants as well as the lifting of hold departure orders previously issued against them.

Acquitted along with Tumang were municipal accountant Perlita Lagman, Bids and Awards Committee (BAC) chairperson Marlon Maniacup, BAC vice chair Jesus Punzalan, members Romeo Razon, Lucila Agento, Luz Bondoc, and private defendant Wiliam Colis, owner of private contractor Buyu Trading and Construction.

Based on criminal information filed by the Office

of the Ombudsman in 2023, Tumang and the local government officials were accused of favoring Buyu Trading and Construction by choosing it as the supplier of construction materials for road projects in Mexico in 2009 through alternative procurement without conducting a public bidding. Tumang was thereafter ordered removed from office by the Ombudsman.

The Sandiganbayan

The Sandiganbayan said it was not convinced that the actions of the mayor and other municipal officials amounted to "manifest partiality, evident bad faith, and/or gross inexcusable negligence."

"At most, the prosecution evidence points to violations of the procurement laws, which do not equate with violation of Section 3 (e) of RA No. 3019," the court noted.

It also said the BAC explained in its resolution why it did not conduct a public bidding and resorted to shopping as an alternative mode of procurement, citing the urgent need for

the materials because of the dismal road conditions.

The local officials pointed out that in 2009, many Mexico barangays had unpaved roads that were prone to flooding during heavy rains, thus creating emergencies that required immediate action.

With the limited budget of the municipal government, the LGU executives said they opted to speed up road repairs to facilitate the delivery of relief goods and emergency response.

The Sandiganbayan also said there was no evidence to show that the accused were motivated by malicious intent in awarding the contract to Buyu.

It further said the prosecution likewise failed to prove that the respondents took or misappropriated public funds.

It noted that even prosecution witness Engr. Marlon Macabali, municipal planning and development coordinator, testified that the materials for the road repairs were delivered to the intended barangays.

SC RULING

Earlier, the Supreme Court already affirmed the dismissal of the graft and malversation of public funds charges against Tumang and one other co-accused, citing violation of their right to speedy disposition of cases.

In a 14-page ruling penned by Associate Justice Samuel Gaerlan, the SC's Third Division upheld the Sandiganbayan's June 10, 2024 ruling that dismissed the charges filed by the Office of the Ombudsman (OMB) against Tumang and businessman William B. Colis, the owner of a construction company.

Promulgated last Feb. 17, 2025, the SC decision was made public last April 2.

The case stemmed from a complaint against Tumang and Colis for alleged violation of Section 3(e) of RA 3019 (Anti-Graft and Corrupt Practices Act), and Malversation of Public Funds under Article 217 of the Revised Penal Code. *Punto News Team/With media reports*




