



To the Point

Stewards, not owners of the nation's wealth

"TO OUR leaders: You are not the owners of the nation's wealth. You are stewards. And God, who is the true owner, will ask you one day: How did you use what was entrusted to you?"

Thus, Cardinal Luis Antonio Tagle reminded public officials that they are not owners of the nation's wealth but stewards who must exercise honesty and accountability in using public resources.

In a homily on Sunday, Sept. 21, at the Our Lady of the Assumption Parish in Malate, Manila, the cardinal urged Filipinos to pray for leaders and for all citizens to live as trustworthy stewards of God's blessings.

The former Manila archbishop stressed that the mark of a steward is being "trustworthy," not acting

He also echoed the bishops' call for an "examination of conscience" not only for those in authority but for all citizens, noting that the culture itself is in need of transformation.

"The invitation is for everyone to reflect — of course, especially our leaders, but not only them. All of us," said Tagle, who is also the pro-prefect of the Vatican's Dicastery for Evangelization.

The cardinal underscored that prayers should lead people to seek "treasures that will not be destroyed or lost," urging both leaders and ordinary citizens to dedicate their talents and wisdom to the common good.

"We pray for our leaders, we pray for our people, so that our lives may be peaceful," he said. "Let us turn to God, the true owner of our lives."

In Cebu, papal nuncio Archbishop Charles Brown urged the faithful to confront corruption and make caring for the poor a priority.

Speaking during Mass on the eve of the Danao City fiesta, he described corruption as a "plague" and expressed hope that nationwide protests would mark the beginning of a cultural shift toward transparency and fairness.

"We hope that today will be a moment in which [the] nation begins to change, in which we set a new course away from corruption, towards more transparency and more fairness," Brown said in his homily at Sto. Tomas de Villanueva Parish Church.

The Vatican envoy also reminded the faithful that caring for the poor is a Christian obligation with eternal consequences. He used a striking image of heaven's gates, where those who helped the poor during their lifetime will be welcomed.

"When we come to the end of our lives, the poor people that we have helped will help us... they will help us enter into the Kingdom of heaven," he said.

A Martial Law story, my own

A SATURDAY. Up early for a "DG" - discussion group - at the Assumption College in San Fernando. Something uncanny: there is nothing but pure static on the radio. The usual though – light banter, small-town gossip among passengers - at the jeepney from somnolent Poblacion, Sto. Tomas to the capital town.

Something really uncanny: there are no newspapers at the news stands. Only komiks are being hawked by ambulant newsboys.

At the Assumption bus, some sense of gloom, a foreboding of doom, guarded whispers among us students of something terrifying...

On campus, a disturbing quietude. Still some two-dozen hardcore KM-SDK activists go on with the DG originally to finalize the agenda of the demo at the gates of Camp Olivas planned for Tuesday.

Marcos has declared Martial Law. First heard from a kasama with a brother in the military. The PC - Philippine Constabulary - has been rounding known activists since last night. Not even a murmur of Makibaka, Huwag Matakot! heard.

Just then, a platoon of uniformed constables enters the campus. Enough for all of us to find any and all means out of Assumption except the main gate where, we presumed more PCs are posted, maybe even with machineguns.

Downtown San Fernando, in front of the town hall were 6X6 PC trucks, military fatigues are everywhere. Long hair is sheared not by scissors but mostly by bayonets and hunting knives.

Jumped on a passing jeepney, just in time. My long tresses - down to my shoulders and back - saved for the day.

Proclamation 1081 - declaring Martial Law in the Philippines though dated September 21, 1972 came into the open on September 23.

Martial Law! The news is out – even in barriotic Sto. Tomas. Arriving home, in time to see my mom stoking the last flames flickering on a mound of ash that used to be my beloved Communist Manifesto, Das Kapital, Lenin's thoughts in volumes of pamphlets, Mao's The Five Golden Rays and the Little Red Book, Amado Guerrero's Lipunan at Rebolusyong Pilipino, posters of Che Guevara, Marx, Lenin, and Mao.

In between tears, a jumble of Marx-Lenin-Mao thoughts – The history of all hitherto existing society is a history of class struggle... Capital is dead labor, that vampire-like, only lives by sucking living labor, and lives the more, the more labor it sucks...The way to crush the bourgeoisie is to grind them between the millstones of taxation and inflation...Trust the masses, rely on the masses, learn from the masses...The people, and the people alone, are the motive forces of history...

And Che's mind too: What do the danger and sacrifices of a man or a nation matter, when the destiny of humanity is at stake?

All gone in a holocaust!

An early morning date with the neighbourhood barber the next day. After a long while, the sun burns my ears and nape again.

Lie low, really low. Take refuge in the rice paddies. In morbid fear of what tomorrow may bring. So, what hath Martial Law immediately

Resumption of classes. By the main gate of Assumption College, the dreaded Black List is posted - names of activists who will not be re-admitted unless with clearance from the PC commander.

A piece of advice from my political science professor: "Don't go to the PC alone, they will just arrest and detain you, as they did to a number of your comrades. Bring somebody influential

So, whom am I to seek but my spiritual director

and rector at the Mother of Good Counsel Seminary - the Rev. Fr. Paciano B. Aniceto. (I was not even a year out "on probation" from San Jose Seminary.)

At the Pampanga PC Command beside the Capitol, Apu Ceto vouched for me as a character witness before a panel of interrogators, and then took my case to the provincial commander himself – the dreaded Col. Isidoro de Guzman who would later earn infamy in the Escalante Massacre in Negros.

Alone at the interrogation room, I was subjected to romanza military at my every answer the berdugos did not take to their liking.

"KM o SDK?"

Wala po - A smack on the head.

"Name? Alias?"

Caesar Lacson y Zapata. Nickname: Bong. No alias – A slap on the face.

"Ikaw si Carlos. Di ba ikaw itong nasa mga letrato (shoving to my face a number of photographs of marches, rallies and demos)"

Kamukha ko po - the table suddenly kisses

Then off to the detention center at the side of the command. At each single cell, the sergeant – Pascua or Pascual? – shoves my face between the iron bars and asks the detainee: "Kasama mo ito?" and then turns to me: "Kilala mo yan?"

Of course, we knew one another but no one ratted out. Conscientization most manifest there.

Compared with what my comrades suffered under detention, I was given kid-glove treatment by the PC tormentors.

Contusions and all, I managed to be remanded to the custody of Apu Ceto. I have written this and I write it again: "The good father, in what could only be deemed as a leap of faith - in his God unquestionably, in me too, maybe – signed a document that said in part, "...in the event that subject activist-provocateur renew his connection with the Communist Party of the Philippines and its various fronts in the pursuit of rebellion; or undertake acts inimical to peace and order, or in gross violation of the provisions of Proclamation 1081 and other pertinent decrees, the signatorycustodian shall be held responsible and as liable...' with a proviso that in my stead, he would be placed in the PC stockade.

Did he tell me to change my ways? Did he impale in my conscience the gravity of my case, his implication in any instance of carelessness or recidivism on my part thereon?

No. From the Constabulary command, his mere request was for me to please accompany him to church.

Before the Blessed Sacrament, he knelt and silently prayed. He did not even ask me to pray with him. He just motioned me to sit near him.

By the side of the good father, in that darkened corner of the Metropolitan Cathedral, I wept. Washed by a torrent of tears was my rebirth, the renewal of my faith.

No spectacular drama presaged my epiphany, no blinding light, so to speak, shone on my own Damascus Gate. There were but flickering votives. And Apu Ceto."

My return to faith. That's principally what Martial Law wrought.

The challenge to reeducate ourselves: Rizal, Moral Intuition, and the Future of the Filipino

(Please give yourself at least ten minutes to read this — and perhaps a bit more, if you find yourself pausing to reflect on the points that might resonate with you.)

IN HIS recent column, my brother, Randy David, asked a piercing question: What would Rizal advise? He reflected on how Jose Rizal sought change "with wisdom and reflexiveness, to the point of being perceived as merely a reformist." Rizal believed that change had to go deeper than swapping leaders or rewriting laws—it had to spring from the very habits of the people.

Randy's point resonates powerfully today. He wrote that nation-building cannot simply be reduced to changing constitutions or replacing politicians. What is needed, he said, is a grounding in moral intuition. I would go further and add: moral and spiritual intuition.

This is what disturbs me most about our present situation as a predominantly Christian nation. If we are indeed Christian in majority, why has our political life become so corrupt? Why has our faith not yet seeped into the very bones of our social institutions? Why has it not shaped the way we govern, do business, treat our poor, or steward creation?

I say this not to despair but to issue a challenge: we Filipinos need to reeducate ourselves. And by education I mean something more fundamental than formal schooling. Ivan Illich once warned us never to equate education with schooling, for schools can sometimes become instruments of miseducation. Real education, he argued, is rooted in lived experience, shared wisdom, and the cultivation of virtues that make life truly human.

Rizal and the Formation of Intuition

Jose Rizal knew that freedom from Spain was meaningless if Filipinos simply copied their oppressors. "The slaves of today could be the tyrants of tomorrow," he warned. Independence without the formation of conscience would merely recycle oppression under a new mask.

What Rizal was pointing to, though he did not use the phrase, was the need to form what philosophers now call moral intuitions. These are not the rules we memorize from textbooks or the slogans we recite during flag ceremonies. Moral intuitions are the cultivated instincts that tell us, often without much deliberation, what is right or wrong, good or bad, worthy or shameful. They are the second nature that shapes the kind of people we become.

Think of what many of us learned at home, in kindergarten, or from the catechism teacher: do not lie, share what you have, respect elders, say sorry when you hurt someone, love God and love your neighbor. These are simple lessons, but they form the ground of our humanity. Robert Fulghum once wrote, "Everything I needed to know I learned in kindergarten." I would extend that: much of what we need to reeducate ourselves as a nation we first learned in our families, our playgrounds, and our catechism classes.

The tragedy is that as we grow older, these lessons often get drowned out by the noise of ambition, power, and greed. Our institutions do not reinforce them. Instead, they sometimes teach us to cheat, to exploit, to bend the rules, to put family or faction above truth and justice.

Lessons from Philosophers and Theologians Here is where some modern thinkers can help us see what is at stake.

Alasdair MacIntyre, in his classic After Virtue, argued that societies fall into moral confusion when they lose the traditions that sustain virtue. Laws and procedures are not enough; what we need are shared practices that cultivate honesty, courage, justice, and generosity. Without these virtues, no constitution will save us.

Charles Taylor, in Sources of the Self, spoke of the "moral sources" that give societies their sense of direction. When a people forget their moral sources, they drift into cynicism or relativism. Taylor's insight is crucial for us: Christianity is supposed to be our moral source, but has it truly shaped our public life? Or have we treated it as a weekend ritual rather than a fountain of moral intuition?

Johann Baptist Metz, a German theologian who survived World War II, insisted that faith must awaken what he called dangerous memories—the memory of Christ crucified, the memory of the poor and oppressed of history. True faith, Metz said, cannot be reduced to private piety; it must form a public conscience that resists injustice. In our context, this means Christianity should empower us to resist corruption and exploitation, not merely comfort us in suffering.

And then there is Pope Francis, who has reminded us that politics is a "sublime form of charity." This startling phrase means that politics, at its best, is not about personal gain but about the self-giving love that seeks the good of all, especially the most vulnerable.

Even outside Christianity, we can learn from the Confucian tradition, which taught that good governance depends not just on laws but on the virtues of rulers: benevolence (ren) and propriety (li). Leaders, Confucius said, must cultivate their character first, for without it, institutions collapse.

All these voices converge on the same truth: nation-building is, at its root, the formation of moral

The real test begins

FOR THE millennials and the Gen. Z, their involvement and participation in the September 21 Trillion Peso March was more than a protest. It was a strikingly vivid and urgent alarm bell - corruption is no longer tolerable and demands for accountability are growing intolerable.

The turnout was unmistakable. According to Philstar.com reports, organizers expected about 30,000 at EDSA while unofficial reports ranged up to 49,000 at the Luneta Park. Thousands joined in the parallel events in other cities in the country.

Particularly striking was the participation of young people. Students from major universities in Manila and nearby provinces, together with young professionals braved the heat and the rain, led the chants, carried white ribbons, and demanded reform. Their

message, addressed to the Marcos government and all public officials, was loud and clear: corruption is not simply an abstract policy failure but a daily betrayal of the Filipino people.

Popular entertainment and sports figures, stood and walked

side by side with leaders of and meaningful participation. civil society groups and nongovernment organizations. On the other hand, the lay leaders from different parishes, priests and nuns from various congregations were also present. Undoubtedly, the Sunday rally was powerful; but let us face it, protests and chants alone can never guarantee change. Because after this collective gnashing of the teeth punctuated with a unified show of anger and wrath, the burning question remains: what

First, we have to sustain the momentum. Young people can burn bright but keeping them engaged beyond a single event is definitely hard. It is important to provide them sustained civic education, community organizing,

Second, now do we translate this shared anger into cohesive action? Accountability means investigating, prosecuting, and recovering ill gotten wealth. Let us not allow the fires burning deeply in our hearts to wane or flicker even for a second until all the people implicated and found guilty of the anomalous flood-control and other infrastructure project are charged and jailed, until their SALNs are exposed, and until they sign a waiver to reveal their bank accounts.

Third, let us watch closely the government institutions that are tasked to safeguard the truth. The ongoing Senate inquiry into flood control anomalies is promising on paper - but history shows congressional investigations often peter out without a bite. Do not look any farther to prove this point. Alice Guo was able to leave the country, Harry Roque is enjoying humba in The Hague, and

A soulful sip at Sta. Rita's coffee crawl

Some days surprise you. What was supposed to be just a coffee crawl turned into a soulful trip through history, faith, and good food at Wave 2 of the Caloguran Coffee Crawl in Sta. Rita, Pampanga.

Sta. Rita is not just another small town on the map. It is a place where the sacred and the social blend together, and where every stop carries a story worth telling.

Before we fueled up with coffee and carbs, we were brought to the Sta. Rita de Cascia Parish, a 300-year-old Spanishera church that houses the 1st Class Relic of Santa Rita de Cascia, Patroness of Impossible Causes.

St. Rita's life is a testament to how faith flips the script on what we think is impossible. As a child, swarms of bees flew in and out of her mouth without harming her, a sign of divine favor. Later in life, she bore

the stigmata on her forehead, carrying the visible mark of Christ's suffering. And when she passed on in the dead of winter, a rose in bloom was on her garden, proof that grace does not follow the rules of the season.

Standing in front of her relic, you cannot help but feel it: the quiet certainty that impossibility has no power here. It was a grounding start, a sacred pause before the caffeine highs ahead.

After that spiritual recharge, it was time to explore the coffee culture that is brewing new life into Sta. Rita. Each café was not just about food, it was about personality, passion, and community.







Cafe Athalia by Patricia Pineda

What began as a space for her daughter Athalia's birthday has blossomed into a minimalist café with heart. Opened in August 2024, it now serves specialty coffee and a wide range of food, but with a twist. They also sell baby and sleepwear merchandise, making it a lifestyle nook as much as a café. There is even a quiet room designed for conferences or meetings, turning it into a versatile spot for both serious sit-downs and cozy catch-ups.

What makes the Caloguran Coffee Crawl special is that it is not just about hopping from one café to another. It is about uncovering the heart of Sta. Rita. From the centuries-old parish that reminds us of the power of the impossible to cafés that show the town's creativity and warmth, every stop tells a story.







Aw's Brew + Salon by Wendy Booc

Nestled in Becuran, this spot is part café, part salon, and all about wellness. Open for just over a year, it is already the favorite hangout of the youth, especially with Becuran High School nearby. The menu reads like comfort food heaven: pasta alfredo, aligue pasta, Charlie Chan, clubhouse, spam and egg, chicken, corndogs, fries, and more. Pair it with their coffee and you are set for a chill hangout or an afterclass refuel













This crawl showed us that Sta. Rita is not just holding on to its past. It is actively brewing its future, one cup of coffee and one plate of sumptous food at a time.

By the end of Wave 2, I realized this was more than a coffee trip. It was a journey that fed the soul and the senses. Sta. Rita gave us history, faith, food, and caffeine all in one afternoon.

If you find yourself in Pampanga, carve out time for this town. Pause at the parish, soak in the silence, then head out to discover the cafés buzzing with life. Sta. Rita is proof that sometimes the best adventures are not about going far. They are about finding the stories and flavors waiting right where you are.

Thunderous applause welcomed the president, with Gov. Lilia "Nanay" Pineda and Vice Gov. Dennis "Delta" Pineda, **Public Works Secretary** Vince Dizon, Social Welfare and Development Secretary Rex Gatchalian, and **Environment and Natural** Resources Secretary Raphael P. Lotilla at the Bren Z. The RPS II facility features a P53.6-million multi-stage rice mill with a capacity of two to three tons per hour. It includes a pre-cleaner, de-stoner, huller, mist polisher, length grader, color sorter, blending tank, automatic packing machine, rice hull bin, dust collection system, and an air-conditioned control room.

The facility also contained P8.1-million recirculating dryers, each with a 12-ton per batch drying capacity, made of stainless steel and equipped with dual heating systems, a generator set, and complete accessories.

"We are very grateful sa ipinagkaloob ng ating Pangulo. Ana; South Gumain Multipurpose Cooperative and Carmencita Farmers Association in Floridablanca: and the LGU of Magalang.

For farmer-beneficiaries, the turnover of the RPS II facility and farm machinery is life-changing as this will greatly improve both their efficiency and productivity in the community.

With Pampanga's 36,060 rice farmers managing 59,903 hectares of farmland, the turnover is expected to bring down production costs by P2 to P3 per kilogram and reduce postharvest losses by three to five percent, leading to higher yields, better grain quality, and increased incomes for farming households.

Pampanga farmers and cooperatives associations are also set to receive 28 four-wheel tractors and 13 rice combine harvesters under the 2025 RCEF Mechanization Program, further boosting farm efficiency and sustainability.

Nationwide, 151 RPS units have been completed under RCEF 1.0. Of these, 145 were completed under the Marcos administration, reflecting its strong push for agricultural modernization. Punto News Team/PIA-3/ Pampanga PIO

and spiritual intuitions.

Jesus and the Fulfillment of the Law

This was also the core of Jesus' teaching. He clashed with Pharisees who clung to the letter of the law but missed its spirit. He insisted that the heart of the law was love of God and love of neighbor. He went further: love your enemies, pray for those who persecute you, do not return evil for evil.

When Jesus said he came not to abolish the law but to fulfill it, he meant precisely this: to embody it, to internalize it until it became second nature. True morality is not about ticking boxes but about living in such a way that love becomes instinct.

Imagine what kind of society we would have if such love became our collective intuition. Imagine politicians who instinctively shun bribery, business leaders who instinctively think of workers' welfare, citizens who instinctively care for creation. This is what it would mean for Christianity to become not just a religion but a way of life that shapes our social structures.

The Miseducation of a People

The late Renato Constantino once wrote about "the miseducation of the Filipino." He meant that colonial powers had trained us to look outward, to admire the foreign, to doubt ourselves. Randy David's call to ground our nationhood in moral intuition is a challenge to overcome this miseducation.

But miseducation does not come only from colonialism. It also comes from systems that teach us to equate success with wealth, fame, or power; systems that reward cunning over honesty, influence over integrity. That is why we must reeducate ourselves-not only in schools but in families, churches, communities, and movements that form the

This reeducation is urgent for young Filipinos today. You are bombarded

daily with images that tell you your worth depends on followers, brands, or appearances. Resist that. Reclaim the intuitions you learned as children: honesty, kindness, fairness, care for the weak. These are not childish lessons; they are the seeds of a humane society.

A Work in Progress

Am I proud that we are a predominantly Christian country? Honestly, no. Not yet. For if we truly lived by our faith, corruption would not be so pervasive. But I do not despair. I say we are a work in progress.

History shows that societies can change. Rizal believed that transformation begins in small habits. A people who practice self-discipline, who form consciences in truth and love, who nurture solidarity with the poor—such a people will eventually build just structures.

This is not naïve idealism. It is the slow, patient work of reeducation. It is the task of making love second nature, of turning moral and spiritual intuitions into the invisible scaffolding of our national life.

Conclusion: What Rizal Would Advise

So, what would Rizal advise? He would tell us that freedom without conscience is hollow, that institutions without virtue are brittle, that politics without love is poison. He would urge us not to rely merely on swapping leaders or rewriting constitutions, but to reeducate ourselves in the school of life, in the virtues of honesty, justice, and love.

The Philippines is still young. We have stumbled, yes, but we are not doomed. We are a people capable of moral and spiritual renewal. If we commit ourselves to reeducating our instincts—to grounding nation-building in moral and spiritual intuition—then perhaps one day we will become not just a predominantly Christian country but a truly Christlike society. This, I believe, is Rizal's

unfinished dream. And this is the challenge we must now embrace.

one key actor in the PDAF controversial flood-control projects. Will this be another exercise in optics, or will they produce enforceable results. By this, I mean solid indictments, prosecutions, convictions, policy and law reform.

Fourth, let us remain vigilant against any form of distraction. The main issue during the rally was corruption and not partisan politics. If political actors try to hijack or extract electoral advantage, the message may become distorted, and public trust end up being diluted.

Lastly, we have to demand legal and structural reforms. It is never enough to punish erring public officials. While the heat is on, let us lobby for the passage of relevant laws such as anti dynasty laws and freedom of information bill, and even complete overhaul of the party liet evetem. Let us demar the creation of a stronger independent oversight with subpoena powers, the lifting of bank secrecy, implementation of robust procurement reform, and institutionalization of public participation in monitoring government projects.

The September 21 protest showed that Filipinos, including those too young to remember the worst of Martial Law, are not resigned. They threw down a gauntlet. But real accountability, lasting reform and justice don't come from marches, chants and slogans alone. They come from institutions doing their job, from laws being enforced, and from citizens never letting up.
