



21 coastal barangays get gensets, emergency phones from Capitol

CITY OF SAN FERNANDO-To ensure uninterrupted communication between barangays and the provincial Capitol during times of disaster, Gov. Lilia "Nanay" Pineda and Vice Gov. Dennis "Delta" Pineda distributed mobile phones and generator sets to officials of 21 coastal barangays in Pampanga.

These barangays were prioritized in the first batch of distribution being the most remote and often face difficulties in accessing electricity and communication during calamities.

According to the vice governor, the provincial government provided these emergency disaster and monitoring equipment so that barangay halls can serve as charging stations whenever power supply is disrupted. This will allow

officials to stay connected with the municipal or provincial government in case of emergencies or immediate rescue operations.

Each of the 21 barangays received one mobile phone with unlimited call, text, and data services, along with one generator set.

The distribution was joined by board members Fritzie David Dizon, Dr. Kaye Naguit, Vince Clara, and Mymy Gonzales, chief of staff to the vice governor Angelina Blanco, and PDRRMO chief Janica Yambao.

Citizens' group to AC gov't: Scrap septage ordinance

ANGELES CITY — Scrap altogether the suspended city septage ordinance; craft a new one anchored on fairness, transparency, and accountability.

Thus, the multi-sectoral group Advocates for Genuine and Outstanding Services (AGOS) called on the sangguniang panlungsod during a public hearing of its committee on environment and public utilities on Sept. 24.

AGOS lead convenor Alexander Cauguiran, a former city councilor himself, presented his group's position paper questioning the monthly collection of septage fees despite desludging services being rendered only once every three to five years.

"Households and establishments are effectively paying years in advance for services not yet delivered," Cauguiran said, arguing that this collection practice already raises the issue of fairness, accountability, and proper



financial management.

The AGOS position paper maintains that:

Septage fees must be treated as a trust fund. Since payments are made in advance, collections must be safeguarded exclusively for the program.

Interest or financial gains must benefit the public. It would be unjust

for private providers to profit from interest on advance collections

Transparency and accountability are non-negotiable. The service provider and city government must submit regular reports on collections, balances, and utilization, subject to Commission on Audit

(COA) oversight.

Safeguards must be institutionalized. For example, fees could be deposited in a special account managed by the City Treasury, with releases tied to actual desludging schedules or operational

Cong Pogi wants more dialysis centers nationwide

ANGELES CITY — Pampanga 1st District Rep. Carmelo "Pogi" Lazatin, Jr. filed House Bill No. 4747 on Sept. 23, mandating the establishment of dialysis clinics in all national, regional, and provincial government hospitals and the provision of free dialysis treatments to indigent patients.

Under HB 4747, each facility shall be fully equipped with all necessary machines, supplies, and equipment, and manned by an adequate number of medical practitioners.

Free dialysis treatments shall be provided to all indigent and uninsured patients under the proposed bill.

The facilities shall be initiated by the Department of Health, in coordination with the respective local government units, with priority given to provinces and regions with the highest prevalence of chronic kidney disease (CKD).

` "Marami po sa mga mamamayan natin na may CKD ang hindi nakakapagpadialysis dahil hindi nila nakakayanan ang malaking gastos nito, o di kaya naman ay nauubusan sila ng slot sa mga pampublikong ospital," Lazatin said. "Layunin natin sa panukalang batas na ito ang matulungan sila na labanan ang kanilang

The issue of public health is at the forefront of Lazatin's legislative agenda.

On Sept. 25, Lazatin had a roundtable discussion with doctors from the First District where he assured that more rural health units will be built in Mabalacat City and Magalang town during his term.

During his time as Angeles City mayor, Lazatin led the expansion of the renal care unit at the Rafael Lazatin Memorial Medical Center from 22 to 47 dialysis machines to address the issue of patient backlog. Team Lazatin-PR/File photo of expanded RCU at the RLMMC



Bunutin ang sheet piles: Constant cry unheeded

"BUNUTIN ang sheet pile at magkaalaman kung 36 meters nga ba." Visibly livid, Public Works Secretary Vince Dizon barked during his inspection of the Candating flood control project site in Arayat only last Sept. 24 with Independent Commission on Infrastructure special advisor Benjie Magalong in tow. The Baguio mayor has since resigned from the ICI and the sheet piles remained as buried in the mud, as of Sept. 29.

Dizon deemed the Candating project as substandard, impacting that to the very face of Edgardo Sagum, owner of the project contracting firm Eddmari Construction & Trading, No. 4 in the Top 10 flood control project contractors in Pampanga at P653.780 million.

The flood control project collapsing within a year of completion, not to mention a previous collapse even before a prior completion the year before, has all the red flags of its being substandard, reasoned Dizon. Seeing either faulty planning or flawed implementation as the cause. Of course, there is the possibility of both.

Hence, pulling out the sheet piles will provide the answer. That they have stayed unpulled raises more questions and speculations running the gamut from the righteous to the ridiculous, and

Especially given how the call to dig out the sheet piles in questionable flood control projects have reverberated across Pampanga at least for the last two years.

"Bagutan la reng sheet piles," Association of Barangay Captains-Mexico president Terence Napao called out in August 2023, referencing alleged anomalies in the flood control projects contracted to A.D. Gonzales Construction & Trading, bearing the very name of then-House Senior Deputy Speaker Aurelio "Dong" Gonzales Jr., representative of the 3rd District of Pampanga.

Napao subsequently haled Gonzales to the Ombudsman on graft and corruption charges which the Ombudsman unceremoniously junked for "lack of evidence," if memory serves right.

Nature fortuitously provided the evidence veritably vindicating Napao, when, in September 2024, heavy rains washed out a P199.495-million flood control project along the Abacan River in Barangay Suclaban, Mexico, unearthing visibly short-of-specification sheet piles.

The contractor: A.D. Gonzales Jr. Construction & Trading. Project duration: June 13, 2022 to June 7, 2023.

The unraveling in Candating came a month earlier, on August 17, 2024 when the flood control project was damaged at the onslaught of Super Typhoon Carina and the southwest monsoon.

"Bunutin ang sheet piles," cried out former

multi-term Candaba Mayor Jerry Pelayo, in the immediate aftermath, during an interview at the "Gising Pilipinas," hosted by Alvin Elchico and Doris Bigornia over DMM Teleradyo.

"Look if the sheet piles [that buckled and collapsed] were properly compacted or if they met standards, else these were cut short of specifications [for the contractor] to increase profits," Pelayo said.

"This was constructed precisely to mitigate flooding, do not reason now that its collapse is due to flooding," the former president of the Pampanga Mayors League and then-consultant at the Department of Agriculture also noted.

In another social media post, Pelayo alleged the Candating dike constructor, Edmarri Construction & Trading, was also the contractor of some other infra projects in San Simon that were "sira la ngan (all damaged)."

Sobra no pera (they have amassed much money," he said.

In his own turn at Candating, Dizon essentially echoed Pelayo, thus: "Yung dami ng perang binuhos ng gobyerno dito since 2018, tapos Ganyan-ganyan lang...roughly P600 million that is useless now...Pinagkakitaan n'yo lang ito, paulit-ulit."

In a press conference in September last year, former Arayat Vice Mayor Sixto Mallari Jr. articulated the call of the town's barangay chairmen to pull out the sheet piles in Candating dike to determine if these were really short of specifications which could have contributed greatly to its collapse.

'Pero paano po makikita kung pinutol? Nakabaon pa po eh. Bunutin muna, di ba? Para makita," Mallari urged the DPWH. "Pagka binunot po yun, instead na, for example, yung size nga nasa 50 meters, eh kung ang lumabas is 20 meters, talagang pinutol. Di ba?"

Bunutin ang sheet piles. Sounded across two years, amplified with the Public Works Secretary himself making the same call for all to hear. Still unheeded. As of the end of September.

It's getting harder to disbelieve disbelievers of Dizon calling his outrage performative, to the point of ridiculing him as no more than a Marcosian mongrel with all bark and no bite.

Steadfast Above the Storm

IN A time when the nation is gripped by outrage over revelations from a multi-billion- peso flood control scandal, the air is heavy with indignation and calls for mass mobilization.

Political tensions run high, and the streets may soon echo with the voices of citizens demanding accountability. In such moments of national trial, institutions are tested—not only for their strength but also for their integrity.

For the Armed Forces of the Philippines, and most especially the Philippine Air Force, clarity of duty has never been more vital. The Air Defense Command (ADC), entrusted with being both the first line and the last line of defense of our skies, stands as a solemn reminder that the AFP's role is not swayed by the currents of politics but is firmly anchored in the Constitution and in loyalty to the Filipino people.

This is the essence of public service. It is the foundation upon which every member of the Philippine Air Force has sworn to serve: to safeguard not only the nation's sovereignty but also the dignity of its democratic institutions. The ADC, with its critical mandate to guard the nation's airspace, embodies this dual responsibilitydiscipline as the anchor of its operations and nonpartisanship as the assurance of its professionalism.

The present political climate demands vigilance,

but it also demands restraint. The AFP has declared with unwavering resolve that it will not allow itself to be misinterpreted as an instrument of political interest. Its communication must remain uniform, clear, and rooted in honesty and loyalty to the Republic. Civilian supremacy, under civilian authority, is not merely a doctrine; it is the very lifeblood of our democracy.

Even as scandals threaten to erode public trust in governance, the Air Defense Command continues its quiet but resolute mission: strengthening the country's territorial defense posture, maintaining operational readiness, and ensuring that the skies remain secure for every Filipino. This constancy amid turbulence is more than a military function—it is a national assurance.

As the country navigates this storm of political reckoning, the Air Defense Command stands as proof that duty, discipline, and devotion to the people can remain unshaken. Above the noise of partisanship, beyond the pull of self-interest, it keeps its watch over the Republic. Too many crooks spoil the broth

President Bongbong Marcos must have been nonplussed when he opened --accidentally discovered, so they say—a Pandora's box in public works anomalies when some crooks hiding in plain sight confessed their big time shenanigans, or "sins" if you will.

That is said as a concessional understanding of most Fiipinos' theology given that the Philippines was allegedly the first Christian nation in Asia. That historical or theological concession can be best appreciated in that before the Second World War, the country was second only to Japan in

At least, it is much easier to locate it, theologically or developmentally today. South Korea, by comparison, is way, way ahead on both counts. Other much lesser Asian nations are expected to make a breakthrough, another cheery Christian message. The sectarian counterpart is that more Pinoys are now more optimistic, notwithstanding.

Which reminds me of 'what the late Pampanga governor Bren Z. Guiao said that the Kapampangans were congenitally optimistic. He also said that politics is a thankless job, which probably explains why some big time politicians are named as big time crooks. Proportion is perspective or what is power for. Ask a local politician who has never had it like an apotheosis.

Given the current scenario, depressing or otherwise, there were probably less crooks then than there are now sprouting like backyard mushrooms, easily defined as thriving well in darkness. PBBM's discovery of the Pandora's box gave the dark landscape the much-needed sunshine treatment.

There is only one way to find out if a man is honest, Groucho Marx said, ask him. If he said "yes", you know he is a crook.

In the subsequent hearing held in the House of Representatives and the Senate, the results were mixed. Some were forthright; some had to be named as less forthright. In the Independent

Commission for Infrastrjucture (ICI), officials HAVE YET to be evaluated by the Ombudsman for accountability. It may not be soon, given that the Supreme Court has yet to issue a mea culpa in relation to an alleged fictional point in a certain ruling on the vice president's impeachment.

It's amazing, even admirable, how some public engineers had owned up to their crimes, meaning not necessarily the wages is death given the lack of a law for it. A former senator had pushed for it earlier but changed his mind after remembering that some criminals have been making good while serving time in prison.

But politicians, legislators even, have found that the Nile is not only a river in Egypt but a safe place to hide their crimes, nothwithstanding the testimonies to the contrary. Luxury cars owned by lucky contractors have been a give-away. The lavish lifestyle of some government engineers have also indicated that where there is smoke, there is fire.

The A merican most notorious criminal Al Capone said that a crook is a crook and there's something healthy about his frankness on the matter. "But any guy who pretends to enforce the law and steals on his authority is a swell snake." The worst of these punks, he said" is the big politician.

In the Senate hearing, four senators have been implicated in millions, even billions of budget insertions, that led to a slew of anomalous rackets ranging from substandard projects -a commonality according to a whistleblower, ghost flood projects and incomplete ones.

In the wake of such implications, prominent heads and leaders have already rolled. The Senate president, who held on tightly to his post, after being widely criticized for the much delayed impeachment trial, resigned after the revelation. Three senators are still clinging to self=serving denial of innocence while the other one awaits another corroborative testimony. The Speaker is also out but not yet safe, to use a popular mantra.

The father of one senator, who is the founder of a big Christian ministry and is a party list representative, has hinted at a possible legal case against a House legislator for the implication of his son, He also pronounced an Biblical anathema--a curse=against the congressman for the damaging disclosure.

The father's angry reaction was felt by many, especially by Christians, as less than pastoral in tenor and heavily called for falling shorts of the Christian doctrine of forgiveness. The lack of Christian pastoral demeanor draws flak in light of a recent event the United States where the forgiving attitude of the wife of Charles Kirk, a American Christian leader, is contrasted with that of US President T rump and other Christian allies who expressed hatred for the murder.

As it is, Christian doctrines are seen being weaponized, even developed, into a political strategy, against those perceived enemies instead of expressing forgiveness, even love.

As more are implicated in public works anomalies, the ongoing hearings appear to become more confusing and more discombobulated with changing statements, changing hearts, personal threats and political pressures being thrown at every angle and opportunity.

Even the President's ICC isn't spared from intrigues, especially when he declared he would not spare anyone, ally or kin, if found involved in the great anomaly of the century. The resignation by the ICC special advisor Baguio City Mayor Benjamin Magalong has affected the ICC's credibility. The naming of a new special advisor hasn't cured it.

Senate Blue Ribbon Chairman Senator Ping Lacson has insightfully suggested that political power over personal vulnerability is the root of material exploitations between the politicians and the engineers and contractors.

His simple personal equation: either the head of the agency knows, which means he is complicit, or he doesn't, or is incompetent.

The guessing game now is: who goes to jail first, the government engineer, the contractor or the politician?

ONE SAD reality that was highlighted in the ongoing Senate Blue Ribbon Committee hearing on the anomalous flood-control projects is this: opening a bank account in the country today is a test of patience and paperwork for the ordinary Juan's, and a walk in the park for the high and mighty.

Try putting your hard-earned money in a bank and you would realize how the exhausting process seems to assume you are guilty until proven innocent. You need to present two governmentissued IDs, a proof of billing, a

certificate of employment or business registration. If you're self-employed, you need to survive an equally grueling question-and-answer portion to explain how every single peso you earned is not laundered money.

But if you're a politician, or a contractor with the right friends in Congress or at the city hall, the rules seem to bend magically, or even disappear conveniently.

As a former bank operations manager myself, I couldn't help but

wonder how hundreds of billions over a ₱10,000 remittance, while allegediy entered our financial system with little or no scrutiny at all. In fact, hundreds of millions were withdrawn regularly from a provincial branch, in cold cash and in broad daylight, without raising any suspicion.

What ever happened to the Anti-Money Laundering Act?

Enacted in 2001 and amended several times, the AMLA is supposed to be our shield against dirty money. It mandates that banks conduct "Know Your Customer" (KYC) procedures, report suspicious transactions, and ensure the legitimacy of large deposits. But when the rich and well-connected make those deposits, the red flags are nowhere in sight.

In 2021, the Bangko Sentral ng Pilipinas reported that over 44% of Filipino adults were unbanked, citing incomplete documents and lack of trust in the system. But can we blame them? When regular Filipinos get grilled

a privileged few launder millions, sometimes under other people's names, with the full cooperation or inaction of banks, the doublestandard becomes unbearable.

Take the case of Marilou Lipana, the supposed housewifeturned-multi-millionaire involved in the scandal. She reportedly had multiple bank accounts in her maiden name - a blatant no-no. But the AMLA mechanisms didn't kick in until the Senate dragged the issue into the sunlight. So, what were the banks doing? Were they playing blind, or just smart enough to know when not to ask questions?

Even regulatory bodies like the Securities and Exchange Commission have called for stripping public officials of their bank secrecy protections, admitting that the current laws allow corruption to flourish. And yet, legislation to lift bank secrecy for public officials remain



the council to hold barangaylevel consultations so residents themselves can voice concerns before any new ordinance is enacted.

AN ORDINANCE SUSPENDING THE IMPLEMENTATION OF SECTION 6 PARAGRAPH A (III) AND B (II) AND SECTION 7 OF ORDINANCE NO. 487, S-2019: ORDINANCE NO. 640, S-2022: ORDINANCE NO. 697, S-2023, AND ORDINANCE NO. 698, S-2023 "PENDING AMENDMENTS THEREOF."

WHEREAS, Sections 6 of Paragraph A (iii) and B (ii) and Section 7 of City Ordinance No. 487, S-2019 entitled "An Ordinance requiring all Business Establishments in Angeles City to have their respective Septic Vaults, siphoned and vacuumed annually" mandated annual siphoning of septic tanks for all commercial and industrial establishments and institutional structures. The aforesaid Ordinance also required the appropriate clearance from the CENRO for the renewal of business permits:

WHEREAS, City Ordinance No. 640, S-2022 entitled "An Ordinance amending City Ordinance No. 343, S-2014 otherwise known as an Ordinance providing for the Water Quality and Septage Management Systems in Angeles City imposed the payment of "Septage Fee/Environmental Fee" for desludging/siphoning and septage treatment for all residential, commercial, industrial, governmental and institutional stuctures or establishments in the amount of Php 5.00 per cubic meter of water consumed. It also designated the Water Service Providers and/or Water Utilities within the jurisdiction of the City to serve as the collecting arm for the septage fee;

WHEREAS, City Ordinance No. 697, S-2023 entitled "An Ordinance amending Ordinance No. 692, S-2023 entitled "An Ordinance amending Section 15 of Ordinance No. 640, Series 2022 otherwise known as "An Ordinance Providing for the Water Quality and Septage Management System in Angeles City provided for the amended rate of septage fee to be at Php 5.00 per cubic meter with a minimum monthly charge of ten (10) cubic meter and maximum monthly charge of thirty-five (35) cubic meter of water consumed by the water utilities' customers/subscribers. Likewise, it required the payment of Php 10.00 as septage fee for all annual desludging/siphoning services for all classifications of commercial, industrial, governmental and institutional structures or establishments with a minimum monthly charge of fifty (50) cubic meter and maximum charge of one hundred fifty (150) cubic meter;

WHEREAS, City Ordinance No. 698, S-2023 entitled "An Ordinance amending City Ordinance No. 640, S-2022 entitled "An Ordinance amending City Ordinance No. 343, S-2014 otherwise known as "An Ordinance providing for the Water Quality and Septage Management Systems in Angeles City" allowed the collection of an "administrative fee" against the chosen accredited service provider by the Water District;

NOW THEREFORE, be it ordained as it is hereby ordained by the Sanguniang Panlungsod of Angeles City in session assembled that:

Section 1. That an Ordinance suspending the implementation of Section 6 Paragraph A (III) and B (II) and Section 7 of Ordinance No. 487, S-2019: Ordinance No. 640, S-2022: Ordinance No. 697, S-2023, and Ordinance No. 698, S-2023 "pending amendments thereof" be, as it is hereby, approved.

ORDINANCE NO. 746, S-2025 (PO-473-07-25)

AN ORDINANCE ADOPTING SECTION 30, ARTICLE V, OF REPUBLIC ACT NO. 12001, OTHERWISE KNOWN AS THE "REAL PROPERTY VALUATION AND ASSESSMENT REFORM ACT" (RPVARA), AUTHORIZING THE GRANT OF TAX AMNESTY ON REAL PROPERTY TAXES AND SPECIAL LEVIES ON REAL PROPERTY WITHIN THE TERRITORIAL JURISDICTION OF THE CITY OF ANGELES, FOR A PERIOD OF TWO (2) YEARS UPON THE EFFECTIVITY OF THE ACT OR UNTIL JULY 6, 2026.

SECTION 1. Republic Act No. 12001 or the Real Property Valuation and Assessment Reform Act (RPVARA), provides among other things, for the grant of real property tax amnesty. Section 30 of this law states that:

"Section 30. Grant of Tax Amnesty on Real Property Taxes and Special Levies on Real Property. – There is hereby granted on a real property tax amnesty which shall cover penalties, surcharges, and interests from all unpaid real property taxes, including Special Education Fund, idle land tax, and other special levy taxes, prior to the effectivity of this Act: Provided, That the real property tax amnesty hereby authorized and granted can only be availed within a period of two (2) years after the effectivity of this Act."

SECTION 2. The proper assessment for delinquent real properties availing of such tax amnesty shall be:

- a. Penalties, surcharges, and interests from ALL unpaid real property taxes that were incurred prior to the effectivity of the Act on July 5, 2024 shall be waived;
- b. The period of tax amnesty is within two (2) years after the effectivity of RPVARA or until July 5, 2026;
- c. The delinquent property owner has the option of one-time payment or installment payment of the delinquent real property tax until July 5, 2026. However, payment made starting July 6, 2024 will incur 2% monthly penalty interest not exceeding thirty-six (36) months until the delinquent tax is fully paid.
- d.Tax amnesty shall be granted until July 5, 2026, However, since this date falls on a Sunday, the deadline will be extended to Monday, July 6, 2026 in accordance with Section 63: Computation of Periods provided in the IRR of R.A. No. 12001.

SECTION 3. This amnesty shall not extend to the following real properties:

SECTION 4. This ordinance shall take effect upon its approval.

- a.Delinquent real properties which have been disposed of at public auction to satisfy the real property tax delinquencies;
- b.Real properties with tax delinquencies which are being paid pursuant to a compromise agreement; and
- c.Real properties subject of pending cases in court for real property tax delinquencies

Patients benefit from no-balance billing and minimal cash-out packages through PhilHealth.

ACSHMC also announced the expansion of its bed capacity to 115, allowing the hospital to serve more patients with quality and affordable care.

Additionally, its accreditation under the PhilHealth YAKAP Program provides access to primary care services, cancer screening, select laboratory tests, and essential medications.

investments, ranging from P100,000 and above.

Among the documents attached to their complaints is a certification by the Securities and Exchange Commission confirming that Lim's SLGroup Restaurants Inc. which operated the now closed Umpukan eatery here is "not authorized to issue, sell or offer for sale to the public, securities such as but not limited to, shares of stock, investment contracts, debt instruments and virtual currencies without prior registration statement approved by the Commission.'

The complainants allege that most of Lim's 11 companies were not registered with the SEC.

Aside from Lim, three of his staff included as respondents to the complaint are Arturo Canlas III, alias LJ Canlas, Geraldine Tiongson, and Evelyn Dayrit.

Large-scale estafa is not bailable if the crime is considered syndicated estafa under Presidential Decree 1689 or if the amount involved is P100,000 or more under

General Order No. 54, a government search site shows.

The complaint is just the most recent of Lim's legal entanglements.

Garnishment

On July 28, 2025, the Municipal Trial Court in Cities Branch 2 issued a notice of garnishment - Civil Case Mo. 10761 (Collection of Sum of Money and Damages) – to the manager of Land Bank of the Philippines, JASA, City of San Fernando upon the account of Lim and "all other accounts...goods, stocks, interest in stocks and shares and any other personal properties" of Lim in the bank's possession and control sufficient to cover P1,130,000 "with conventional interest of 6% per annum from May 30, 2023 until its full satisfaction."

The garnishment was signed by Christian Anthony A. Concepcion, Sheriff III.

Sum of money writ

On Aug. 13, 2025, Sheriff Marvin Minav served a writ of execution from the Metropolitan Trial

Court Branch 115, Taguig City against Lim ordering him to pay Zyneserve Inc. the amount of P435,528.95 and P8,556.18 (cost of suit) reckoned from July 12. 2024. The sheriff said it took them a year to determine where Lim could be found. His election to the board pointed to them to the sangguniang panlalawigan office to serve the writ.

Arrest order

The Municipal Circuit Trial Court, Third Judicial Region in Mexico town issued a warrant of arrest signed August 11, 2025 by Presiding Judge Richard Gazzingan Evangelista against Lim for three counts of estafa.

Lim posted bail for this arrest warrant.

Strong Take-Up at Cresendo Highlights Tarlac's Rising Property Market

TARLAC CITY, PHILIPPINES—Investor demand is accelerating at Cresendo, Ayala Land's 290-hectare estate in Tarlac, as commercial lots sell out quickly and national brands establish presence in the province.

Phases 1 and 2 of Cresendo's commercial lots have been fully taken up, prompting the developer to roll out Phase 3 inventory worth ₱4.4 billion. Its 32-hectare industrial park is also 98 percent sold, with locators expected to generate around 2,000 jobs once operations commence.

The estate's growth comes as Tarlac posts a 6.7 percent GDP expansion, outpacing the national average and benefiting from infrastructure

links such as SCTEX and proximity to Clark International Airport. Rising household incomes and urban migration have also contributed to sustained property demand.

Brands and Institutions Move In

Several national retailers have opened at Cresendo in recent months, including McDonald's, which unveiled its first "Green & Good" sustainable store in Tarlac. MerryMart Supermarket and 7-Eleven are now operational, while Don Bosco Tarlac has expanded its programs with Senior High School and technical-vocational

U p c o m i n g establishments such as 21st Bean Café, Velvet Vibes, and MiPanda are also expected to boost foot traffic as Cresendo positions itself as a new downtown district for northern Central Luzon.

"The speed of take-up reflects strong confidence in Tarlac's potential as the next commercial hub north of Metro Manila," said Clarence Carcellar, project development manager for Cresendo.

Beyond commercial activity, Ayala Land has integrated civic and lifestyle spaces into the estate. A 1.5-hectare town plaza, multipurpose field, and themed garden are already serving as venues for
