New dairy facility to boost milk production



L IN HIGHER EDUCATION TO SALARY GRADE 17, AND THE SALARY OF PUBLIC NON-TEACHING PERSONNEL TO EIGHTEEN D PESOS (PIE.000.00)

EXPLANATORY NOTE

Education is a fundamental human right and cornerstone of individual human growth and scietal development. Article II, Section 17 of the 1987 Constitution of the Philippines provides at the State shall give priority to education, science and technology, arts, culture, and sports to ster patriotism and nationalism, accelerate social progress, and promote total human liberation and development.

For this purpose, the government continues to explore ways to provide quality education constant challenges, such as the lack of sufficient school buildings and a shortage of ors to cater to the needs of the student populace.

SBMA, BOC sign MOU to regulate admission of recyclable non-hazmat

SUBIC FREEPORT - The Subic Bay Metropolitan Authority and the Bureau of Customs-Port of Subic signed a memorandum of understanding that will regulate the admission of recyclable non-hazardous materials inside this

SBMA chairman and administrator Eduardo

Jose L. Aliño and BOC-Port of Subic district collector Noel C. Estanislao signed the MOU that will boost the recycling sector in the freeport, at the Corporate Boardroom of the Administration Building here on Oct. 2.

'This agreement will not only ensure proper regulation of recyclable

non-hazardous materials, but also enhance our shared efforts to safeguard our borders, protect the environment, and support legitimate industries within the freeport," Estanislao

The MOU stipulates that the SBMA has formulated the proposed guidelines relative to the admission of

non-hazardous materials, in line with the freeport's policies and regulations, and to facilitate the admission of goods and operations in the recycling industry.

The MOU also states that both agencies will coordinate and collaborate to ensure the smooth, transparent, compliant,

ANGELES CITY -- Three days before the celebration of World Teacher's Day, Pampanga 1st District Rep. Carmelo "Pogi" Lazatin, Jr. on Oct. 2 filed House Bill No. 5067, which seeks to increase the entry-level salary of public school teachers, teaching personnel in higher education, and public non-teaching personnel.

To be known as "Entry Level Salary Increase for **Public School Teachers** Act," HB 5067 mandates that the entry-level salary of public school teachers be increased from Salary Grade (SG) 11 to SG 15; of public teaching personnel in Higher Education from SG 12 to SG 17; and for the salary of regular nonteaching personnel in public schools to be P18,000 at the minimum.

"Ang pagtuturo ay isang adbokasiya dahil ang ating mga guro ay naglalaan ng pang-habangbuhay na dedikasyon para dito," Lazatin said. "Alam ko po ang hirap ng ating mga guro, kaya kasama sa

It can be recalled that when Lazatin first announced his intent to run for representative of the 1st District on June 28, 2024, he unveiled his legislative agenda that included the filing of a bill to increase the salaries of public school teachers

With HB 5067, Lazatin makes good on this promise.

Renewable energy powers growth in FAB

A 6-megawatt rooftop solar facility has been installed across 14 factory buildings inside the Freeport, providing locators with direct daytime electricity while reducing grid dependence and minimizing transmission losses.

To meet peak demand, additional capacity comes from the 20-megawatt Mariveles Solar Plant of Citicore Solar Bataan Inc. in Barangay Alas-Asin.

For dependable continuous operations. the Authority of the Freeport Area of Bataan (AFAB) sources baseload power from the Tongonan Geothermal Power Plant

BALANGA CITY – The main in Leyte, which generates zone of the Freeport Area of 600 megawatts to ensure Bataan (FAB) in Mariveles a steady supply that complements the variability of solar generation.

AFAB administrator and **CEO Mohammed Hussein** Pangandaman announced this development during an investment forum, emphasizing that the shift to renewable energy shows how an economic zone can achieve growth while advancing sustainability.

"This combination of resources allows AFAB to sustain industrial activity inside the Freeport while contributing to the country's broader shift toward clean energy," Pangandaman said.

Our dear people in government:

The Filipino people are watching closely. After the revelations of massive anomalies in flood control projects, any move to change the Senate leadership or redirect investigations now would only heighten public suspicion of a cover-up.

We, the Catholic Bishops' Conference of the Philippines, call on all public officials to uphold the integrity of the ongoing inquiries into the flood control corruption scandal. The Independent Commission on Infrastructure (ICI) was created precisely to restore public trust. It must be empowered to investigate fully and freely, without political interference from any branch of government.

The ICI's mandate must include:

- Transparency in its proceedings, findings, and recommendations;
- · Access to all necessary documents and witnesses, including those protected by political privilege;
- Public disclosure of budget insertions and project allocations, especially those tied to unprogrammed or duplicate DPWH projects;
- Protection for whistleblowers and technical personnel who come forward in good faith.

We strongly oppose any attempt to pre-empt or derail the investigation through backroom deals, leadership takeovers, or selective justice. A nation cannot heal when its moral arteries are clogged by corruption and self-interest.

This is a defining moment for public accountability. We urge both Congress and Malacañang to prove that they serve the common good, not partisan power. Let the truth flow freely. Let the ICI do its work — thoroughly, transparently, and without fear or favor.

No to a whitewash. Yes to full accountability. Only through truth can our nation begin to rebuild trust and ensure that flood control no longer becomes another flood of corruption.

The private-public contradiction of BM Estelito, aka Shiwen, Lim

EMBROILED IN legal entanglements ranging from a garnishment order and sum of money writ to a case of large scale estafa and more reportedly coming, Pampanga 3rd District board member Estelito P. Lim alias Shiwen Lim cried harassment and filed a complaint before the National Privacy Commission against Punto! Central Luzon, SunStar-Pampanga, iOrbit News Online, and CLTV-36 - all that have assiduously reported on his cases, and on the cries for justice of the alleged victims of his schemes.

Lim's contention: The publication of his warrant of arrest subjected him to public ridicule and prejudgment; that the inclusion of personal details indicated in his warrant of arrest exposed him and his family to danger and public shame; that this violated his right to privacy.

Privacy, 'tis been many times proven, makes the ready refuge for public scoundrels. No, that is not in the least implied in this instance.

Still, privacy is the last thing Lim should have invoked, given his celebrity status in social media from Facebook to TikTok - indeed, that which he parlayed to a successful run for the sangguniang panlalawigan where he now roosts.

Virtually and veritably, Lim has been too long a public figure before he was elected to public office. And therefore, well within the realm of public interest, open to public scrutiny. Even ridicule and denunciations, if we go by social media posts.

As provincial board member, let Lim be impacted with that fundamental principle enshrined in the Supreme Law of the land: Public office is a public trust.

Of government officers and employees enjoined to "at all times, be accountable to the people, serve them with utmost responsibility, integrity, loyalty, and efficiency; act with patriotism and justice, and lead modest lives."

So, the disclosure of his personal details specifically home address - indicated in the warrant of arrest media published as factual basis for their articles, now constitutes a violation of his privacy?

If this were so, Lim had already incriminated himself long before media published those legal documents attendant to the cases he has been named as respondent.

After filing his certificate of candidacy with the Commission on Elections in October last year, Lim did the perfunctory photo-op showing his accomplished and duly received COC that subsequently made the rounds of mainstream and social media. The COC contained even much more than the personal details in the warrant of arrest that Lim now invokes as a cause of breach of privacy.

Of the COC, Comelec spokesperson John Rex Laudiangco said at the time of filing last October: "It is the specific document required by law to establish the express intent of a person, or aspirant, to run for a specific elective public office, establishing his or her possession of all qualifications and none of the disqualifications, declaring as well his political party affiliation, if any."

Lots of personal details there, if I may.

Given that this is a public document, it is required to be executed under oath," noted Laudianaco.

Furthered Comelec chair George Garcia: "[The COC] highlights the intent to aspire for a particular position. The COC reveals compliance with the qualification requirements of the Constitution and the law. And false material representation can be grounds for cancellation of candidacy or denial of due course coupled with misrepresentation as an election offense aside from the crime of perjury. This is therefore the document for the voters to better know the candidates.'

Public interest. As much for the voters specific in the case of the COC, as for the general public in warrants of arrest.

Quod erat demonstrandum, as my favorite fiscal was wont to say.

The Air Defense Command— **Shielding the Nation Against Delays and Deception**

Actions in disputed waters expose a more alarming reality, notwithstanding assertions of prosperity and peace. While officials insist on postponing a real solution, Chinese Coast Guard vessels harass fishermen with water cannons. Despite calls for moderation, militia ships and dredgers fortify reefs at breakneck speed. International rulings are ignored as if they were merely recommendations, despite promises to enforce the law.

This is not diplomacy; it is a weaponized delay. The consolidation of control gains momentum with each day lost, transforming reefs into runways and shoals into outposts. Trade agreements and loans lose their purpose if the seas that support communities are taken under the guise of patience. Denying sovereignty is the same as postponing it.

The Philippine Air Force's Air Defense Command (ADC), the nation's first line of defense and a symbol of determination, is standing firm against this encroaching intrusion. The ADC is responsible for detecting, identifying, intercepting, and neutralizing any unauthorized flight, suspicious vessel, or threat to our airspace. Its radar stations provide the country's decision-makers with realtime intelligence by spanning our archipelago like an invisible net. Its pilots put in endless hours of training, flying intercept missions that serve as a reminder and a warning: the Philippines won't rest while its seas and skies are put to the test.

The mission of the ADC goes beyond routine. It

is a daily act of national defense against a strategy based on the erosion of boundaries, rights, and will. When others try to stall, the ADC acts. Where hesitation may prevail, our air defenders act. They remind the world that sovereignty is not a promise for the future, but a duty for the present.

There is more to the West Philippine Sea than just water. It serves as a means of subsistence for our fishermen, a conduit for our commerce, and a test of our sense of national honor. Every patrol, radar sweep, and interception conveys the message that we protect our property today, not tomorrow.

The Air Defense Command does more than watch the skies. It stands as proof that a nation aware of its rights and ready to act can never be quietly taken. While others cloak aggression in the language of peace, the Philippines answers with vigilance, discipline, and the unwavering courage to protect its own.

Burukrata Kapitalismo: Ugat ng katiwalian sa BIR, Customs, maging LGU

ANG TALAMAK na katiwalian sa Bureau of Internal Revenue at Bureau of Customs ay hindi lamang bunga ng masamang asal ng mga opisyal — ito ay konkretong manipestasyon ng burukratang kapitalismo, isang sistemang ginagawang negosyo ang pamahalaan at kalakal ang kapangyarihan.

Ang korupsiyon sa BIR at BOC ay hindi na bago. Sa loob ng maraming dekada, paulit-ulit itong lumilitaw sa mga ulat ng audit, pagdinig sa Šenado at Mababang Kapulungan, at mga pahayag ng dating opisyal. Ngunit ang tanong: bakit paulit-ulit?

Dahil ang katiwalian ay hindi simpleng gawain ng mga tiwaling indibidwal — ito ay istruktural na bahagi ng sistemang tinatawag na burukratang kapitalismo.

Sa sistemang ito, ginagamit ng mga opisyal ng gobyerno ang burukrasya o tungkulin sa gobyerno hindi upang paglingkuran ang bayan, kundi upang pagsilbihan ang kanilang personal na interes.

Sa BIR, ayon sa mga ulat, umiiral pa rin ang mga "under-the-table" na kasunduan, pekeng resibo, at mga pabor sa malalaking negosyo o mayayamang Pilipino upang mapababa ang buwis na dapat nilang babayaran.

Ang mga ordinaryong empleyado o kawani, guro at iba pang manggagawa, ay awtomatikong kinakaltasan ng buwis kada sahod.

Sa Customs naman, patuloy umanong umiiral ang tinatawag na "tara system" — ang lagayan upang mapabilis ang paglabas ng kargamento.

Ayon sa mga pagdinig sa Kongreso, ang ganitong sistema ay nagiging daan sa malawakang smuggling at undervaluation ng mga imported goods.

Ang resulta: nalulugi ang lokal na industriya, at ang taumbayan ang sumasalo sa taas ng presyo ng bilihin.

Ang ganitong kalakaran ay hindi aksidente. Sa ilalim ng burukratang kapitalismo, ang mga posisyon sa gobyerno ay nagiging puhunan ginagawang instrumento para sa pagkamal ng yaman at impluwensiya.

Ang kapangyarihang dapat gamitin para sa serbisyo publiko ay nagiging paraan upang makipagpalitan ng pabor, kontrata, at proteksiyon.

Maliwanag na halimbawa nito ang ₱545 bilyong flood control project scandal, na iniimbestigahan pa rin ayon sa mga ulat ng Senado at media. Ipinapakita ng mga kasong

ito kung paanong ang sabwatan ng mga opisyal, kontratista, at negosyante ay lumilikha ng mga proyektong "ghost" o substandard — habang ang mga mamamayan ay patuloy na binabaha at ginagatasan ng buwis.

Ito ang esensya ng burukratang kapitalismo: -Kapangyarihan na ginagawang kapital, at serbisyo na ginagawang negosyo.

-Sa ganitong sistema, ang katiwalian ay hindi na "abnormal" — ito na mismo ang pamantayan. Kaya kahit may mga reporma, reshuffle, o "anti-corruption drive," nananatiling buo ang istrukturang nagpapayaman sa iilan habang pinapasan ng bayan ang krisis.

Ang tunay na laban ay hindi lang sa mga tiwaling opisyal, kundi sa mismong sistemang nagpapahintulot sa ganitong uri ng pamamahala.

Hangga't hindi napapalitan ang sistemang ito ng isang pamahalaang tunay na naglilingkod sa mamamayan, mananatiling gatasan ang gobyerno at ang yaman ng bayan ay patuloy na malulustay.

Kaya taon taon kulang na kulang ang buwis na dapat makolekta para magamit sa gastusin ng pamahalaan.

Kaya madalas nangungutang ang gobyerno para mapunuan lang ang dapat na gagastusin nito sa isang taon.

Sa pinakahuling ulat umaabot na sa ₱16.31 trillion as of end-January 2025 ang pagkakautang na ating bansa. At tayo lahat na Filipino ngayon at susunod pang henerasyon na hindi pa isinisilang ay may pagkakautang na ang magbabayad nito.

Panahon nang itakwil ang burukratang kapitalismo.

Panahon nang ibalik sa mamamayan ang pamahalaan.

Dahil sa bawat pisong ninakaw sa buwis, may serbisyong nawawala;

sa bawat kontratang may lagay, may proyektong hindi natatapos;

at sa bawat opisyal na pinagtatakpan, may mamamayang pinagkakaitan ng pag-asa.

Ang katiwalian ay sintomas lamang. Ang tunay na sakit — ay burukrata kapitalismo.





Band-aid for a deep political wound

DANGEROUSLY SIMPLISTIC. This is exactly what I feel about Sen. Allan Peter Cayetano's proposal that all elected officials resign and the country hold a snap election.

His suggestion may be good enough for dramatic headlines, yet it would never by itself, root out graft, expose the full truth behind the anomalous floodcontrol projects, or restore the Filipino's faith in governance and trust in their leaders.

First, the proposal is constitutionally dubious and logistically implausible. The 1987 Constitution provides no mechanism for mass resignation or a nationwide snap poll beyond the presidency. In a report from the Philippine Daily Inquirer, retired Supreme Court Justice Antonio Carpio has warned that the Philippine Constitution does not clearly allow for such a wholesale dissolution of elected offices outside the regular electoral

timetable.

The Commission on Elections itself admits that organizing a full national election outside the regular cycle would be near impossible within the year. Even the Senate has formally rejected Cayetano's idea, noting that such would only aggravate political instability.

More importantly, a snap election will not automatically cleanse the system. Corruption in the Philippines is not simply a matter of who sits in office—it is a matter of how the system allows impunity.

The ongoing Senate investigation into the DPWH flood-control projects reveals just how entrenched the rot is. Reports show that up to

₱1.089 trillion in flood-control allocations since 2023 may have been lost to fraud, ghost projects, and kickbacks. The Department of Finance estimates an annual loss of ₱118.5 billion to flood-control corruption alone.

Contractors have testified to paying as much as 25 percent in "commissions" to legislators for project approval. Obviously, this not just a leadership crisis—it is a moral and institutional one.

To truly regain public trust, officials must choose justice over theatrics. The Senate Blue Ribbon Committee must conduct an impartial, transparent probe-no sacred cows. Everyone involved, from DPWH officials to lawmakers, must face prosecution and

Anti-Dynasty Bill to break entrenched political family control and open space for new voices. Enact a robust Freedom of Information (FOI) Law so citizens, journalists, and civil society can scrutinize plans, budgets, and bids in real time. Amend the Bank Secrecy Law to allow for investigation of unexplained

wealth among public officials. Review the Party List System to prevent misrepresentation of the marginalized sectors by the wealthy and has-been

And for good measure, President Bongbong Marcos should settle his family's unpaid estate taxes amounting to P203B, apologize to and compensate the families of the victims of human rights violations during his late father's dictatorial regime, return his family' ill-gotten wealth to the government, and advise his minions to stop all efforts at sanitizing history – a gesture so scintillating that it that would prove that accountability begins at the top.



The president had more in store for the OFWs that sent cheers to the rafters of the convention center: "Dahil malapit kayo sa puso ko, magbibigay din ng P5,000 ang Tanggapan ng Pangulo.'

Some 3,000 OFWs and individuals who have OFW relatives from 22 calamity-stricken towns in the province received the Agarang Kalinga at Saklolo sa mga OFWs na

Nangangailangan (Aksyon) financial assistance.

Sa tuwing makakasama ko ang aking mga kababayang OFW, hindi ko maiiwasan na humanga at matuwa sa kuwnbto ng inyong mga buhay," said the president. "Hindi biro ang inyong pinagdadaanan na malayo sa pamilya, magtrabaho sa ibang lugar para sa kinabukasan ng inyong mga mahal sa buhay."
