MESSAGE TO THE CORRUPT:

Restitution completes repentance

REPENTANCE, NOT rhetoric, is what the nation needs.

Thus, declared Kalookan bishop Pablo Virgilio Cardinal David, also president of the Catholic Bishops Conference of the Philippines, urging those involved in the flood control anomalies to confess, make amends, and return what they have stolen from the public coffers.

In a recent video message, David outlined the "essential" steps of Christian reconciliation for those burdened by guilt and the pain carried by their families, to wit:

"First, confession— the courage to admit the wrong that has been done and the good that was left undone.

Second, contrition— the sincere remorse for the harm inflicted on our people and our institutions.

And third, penance through restitution—the willingness to repair the damage and return what has been taken."

Restitution completes repentance, he said.

When these steps are present, forgiveness becomes not only possible but transformative for both the wrongdoer and the nation seeking reconciliation, the cardinal noted.

He cautioned though that true repentance must go beyond words, insisting that genuine healing requires justice and the restoration of what was taken from the people.

David warned that corruption and patronage politics continue to weaken institutions and trap communities in poverty by treating public funds as personal property.

"Stolen public funds must be returned," he said. "The machinery of patronage politics, one that breeds dependency, keeps our communities poor and treats public funds as personal property, must finally come to an end."

He said real reform begins with moral renewal—admitting wrongdoing, seeking forgiveness and committing to repair the harm done to the nation and its people.

That Yolanda-effect

THERE IS something in the series of earthquakes and typhoons of late that I find far and away from the previous calamities that impacted the nation.

Not so much in terms of intensity or in the scope and scale of devastation, as in the global response and concomitant relief. So, has anyone even noticed some semblance of international aid groups coming to Cebu or to any of the disaster-impacted areas?

Donor fatigue? Political intrigue? Whatever, I dare not think. In matters of analysis of this magnitude, I am poorly equipped. Mine is just to look back to what has come to me as Yolandaeffect from the perspective of relief.

Here's a Punto! piece dated Nov. 23, 2013 aye, 12 days short of 12 years, and finding some relevance if only for this.

Epiphany

"GOODNESS IS self-edifying; ethical living satisfies the conscience; virtue is, as proverbially advertised, its own reward, and don't look to God

Thus, the language maven William Safire iterates a moral doctrine in his work subtitled The Book of Job in Today's Politics.

"Prayer has a value in itself. That's the flip side of the negative, don't-look-for-a-materialpayoff lesson. The truly religious person, in Joban theology, not only worships God with no payoff in mind but is uplifted by that unselfish love.'

So, I rearranged the order of Safire's paragraph to transition to the point whence this discussion

PAYOFF TIME. Emphatically tolled across the globe by the devastation wrought by Super Typhoon Yolanda. Notwithstanding the aforesaid Joban precept.

"We will never forget what the Philippines did for us in 2011." So was quoted Kenzo Iwakami, the team leader of the Japanese medical mission to Leyte. In reference to the Filipino nation's contribution to relief efforts at the time Japan was ground zero of the destructive earthquake and tsunami that killed over 15,000 people.

Seconded Dr. Joji Tomioka, sub-leader and medical coordinator for JICA's medical team for disaster relief: "This time, we have to help you. Because two years ago, you helped us. So, this time, this is our turn."

In what could be its largest military overseas aid deployment to date, Japan has dispatched two warships carrying some 1,000 troops, along with 10 planes and six helicopters to join relief efforts in the Visayas. It has likewise pledged \$10 million in aid.

Purely personal payback it was to Kenji Hirakawa who donated 200,000 yen (P87,000) to the relief efforts "for all the troubles my father may have caused to the Filipino people."

"My father lies sleeping in a mountain somewhere in Luzon," Hirakawa said in the letter he sent to the Philippine Embassy in Tokyo, qualifying his old man was a member of the Japanese Imperial Army that occupied the Philippines in World War II and never made it back home.

A tug at the heartstrings was that Japanese pre-schooler who went to the Philippine embassy to donate his piggy bank savings.

PAY IT FORWARD. In 1939, some 1,200 Jews "who otherwise would have almost certainly died in the Holocaust" were given sanctuary in the Philippines.

"The people of the Philippines will have in the future every reason to be glad that when the time of need came, their country was willing to extend a welcome hand." President Manuel L. Quezon's word at the time proved prescient, if not prophetic, today.

"A particularly heroic piece of history (that) should be recalled by the global Jewish community, which owes a debt to the island nation." Wrote Alan H. Gill, CEO of the American Jewish Joint Distribution Committee, in JTA, the Global Jewish News Source.

And the Jewish nation did. Setting a field hospital right at ground zero within seven hours of the arrival of the Israel Defense Force, its 125member delegation of medical doctors, nurses, technicians, lab workers treating as much as 300 patients a day. And members of its Homefront Command coordinating logistics comprising over 100 tons of equipment and supplies.

Aside from treating injuries and ailments, 12 babies have been delivered, the first of whom was named "Israel" in gratitude to the volunteers. Enough to move one to tears.

Writes Gill further: "These efforts now come full circle, especially for one member of our team arriving in the Philippines later this week, Danny Pins. In addition to being one of our development and employment experts, Pins' mother and grandparents were among the German Jews who fled to the Philippines to seek safe haven in 1938. His posting, in many ways a homecoming despite previous trips to the country, is highly symbolic."

'Today, in the wake of one of the worst storms in history, with perhaps more than 10,000 dead and hundreds of thousands homeless, we are fully committed to fulfilling President Quezon's prophecy and returning the favor to the Filipino people. Not just because we are Jews, the heirs to this nation's life-saving actions, but because we firmly believe in mutual responsibility and the idea that each individual life is valuable beyond measure." Beyond mere payback, there rises international solidarity, indeed, One Humanity, most manifest in the Filipino value of kapwa.

SOLIDARITY AND FAITH. The greatest means to survive, and ultimately triumph over a disaster.

This, the people of Pampanga have shown to the world, rising over the devastation, death, desolation, and despair wrought by the eruption of Mount Pinatubo in 1991, and the lahar rampages that buried whole communities in the aftermath.

'The desire among Kapampangans to help is spurred by our own Pinatubo experience." So articulated San Fernando Auxiliary Bishop Pablo Virgilio David at the launch last Saturday of the "Pampanga for Visayas/Palawan" mission which calls on the Kapampangan faithful for donations, the archdiocese's 94 parishes serving as dropoff centers.

A number of business groups, socio-civic organizations and committed non-governmental of organizations throughout Pampanga are likewise engaged in raising funds and relief goods for the victims of Yolanda.

The Kapampangan community, quoted the Inquirer of the good Among Ambo, is "extra generous because of our awareness that we have to look back and to give back."

Awareness evolving to sanctifying grace.

Thus, Ignatius of Loyola: "...to give and not to count the cost, to toil and not to seek for rest, to labor and not to seek for reward, save that of knowing that we do Your will."

Hence, Francis of Assisi: "...where there is doubt, faith; where there is despair, hope; where there is darkness, light; and where there is sadness, joy...For it is in giving that we receive."

Enough to restore one's trust in the innate goodness of man, to renew one's faith in his God.

The ravages of Yolanda are an epiphany for all the world to witness, to experience, to believe.

It's philosophy, or it's politics

The 19th century German philosopher Nietzsche said that adversity builds character. "That which doesn't kill you, he said,"will make you strong."

This much was conveyed by Jose Rizal in his prophetic "The Filipinos, A Century Hence." His people, he said, will emerge eventually, triumphant from the yoke of colonization. It didn't occur to him that massive corruption will be front and center in the nation's life in the future.

Today, that historical piece of work by the national hero would have been considered a satire by Filipino film makers in the same vein that the historic life of Manuel Quezon has been portrayed, to the consternation of the former president's living literates, cinematic or not.

Where did history begin and fiction end or vice versa? The distinction is blurred by literary style, fiction bumping out facts.

Was People Power a fact, fiction or lie? The first Marcos presidency was thrown out of power in February 1986. The second Marcos presidency has removed the EDSA celebration from the national list of holidays starting this year. Do political victors rewrite history, notwithstanding the facts or lies?

The alleged author of 1972 martial law, who's fighting for dear life in an undisclosed hospital, was to have said in a media interview that the ambush on him that eventually triggered the dictatorship was a fake one when fake ones were still a dream. The senator who broke out the sad news with a bleeding heart is facing charges of corruption, among others, based on fiction? The courts will know, for a fact.

Centuries later, a cynic of a wag or vice versa suggested that the Philippines can export local crooks instead of the Filipino overseas workers (OFWs), a vital lifeline to the economy, to rid the nation of such deep malaise. Does the end justify the means?

There's a catch to this insane proposal though. The country will also pay a heavy price in tariff imposed by the Donald Trump on all imports. Recall that even President Bongbong Marcos had to visit the White House to negotiate a lower tariff. Trump extolled PBBM, a solid north denizen, as a genius or a cheapskate for haggling a one percent discount. Beggars are no choosers.

Needless to say, economic experts and other pundits on all sides of the globe continue to extrapolate the numbers if the concept is a fair ex change, considering, for one, how valuable

Filipino nurses and other workers are to their wellbeing. Besides, Filipino crooks are a different creatures altogether. Caveat emptor

Once upon a not so distant past, a political leader or his spimasters came up with a bright slogan while Mt Pinatubo was spewing volcanic ash left and write and burying places. " Eko magmalun, the uplifting message spread across the land, mibangun tamu kgn Pinatubo" "Do not mourn, we will bounce back frm Pinatubo."

The general but xistential threat which was deemed a political correct assessment was that Pampanga has only one option then : pack up, leave and move to a higher place. The politician was not a philosopher but his message hewed close to NIetzsche's hope that the trial due to a natural calamity will bring out a stronger, better people from the disaster.

But not before leaders and movers who were facing the real threat quietly threw invectives and wrong motives against those in national government for kowtowing with the idea that I)nature must take its course and 2) there's serendipity somewhere in a nearby province which, in the light of the recent typhoon proved to be a bad idea. Sight becomes faith.

Well, the squeaky wheels get the oil. Eventually, a multi-million mega dike was built to protect the province's capital city and others against the inundating lahar flow. But not before some political leaders from somewhere complaining it was getting more than its fair share from government.

Then former Senator Blas Ople, a welladmirers of Kapampanganj journalist, brought sanity into the insane discussion. What if the same natural event happened to those who opposed the megadike, would they not ask for the same treatment? End of the argument.

The protester lived happily after the megadike and unsung heroes suddenly sprung from nowhere. Pampanga, which used to be number one in industrial growth rate before Pinatubo erupted, soon regained its economic footing. It, still, is a leading growth environment.

It's not because of the Clark Economic Zone, although it helps a lot, according to its woman spearhead, but because of the unique character of

When progress becomes destruction

DEVELOPMENT SHOULD never be built at the expense of the environment. Yet in the Philippines, this fundamental truth is repeatedly ignored until disaster strikes and lives are lost.

For years, local communities and indigenous peoples have sounded the alarm about carving roads, subdivisions, and commercial estates into unstable hillsides and protected forests. Instead of listening, government agencies and powerful developers brushed aside their warnings in favor of progress and investment. But more often than not, what we call progress ends up looking like destruction.

American economist Herman Daly, pioneer of ecological

economics, reminds us that a nation's economy is not separate from nature but is contained within it. According to Daly, true development does not mean getting bigger but getting better. When growth surpasses ecological limits, it stops being development and becomes damage. We are now living in the consequences of that damage.

The Cebu landslide linked to the Monterrazas project is only the latest example of growth imposed on landscapes not meant to carry such weight. We cannot claim to be shocked because we have seen this pattern many times but chose to look the other way.

The construction of the New Manila International Airport has worsened flooding across Bulacan and Pampanga. Wetlands, considered to be nature's sponge, were reclaimed and paved over. Water that once seeped slowly into marshland now rushes into homes and fields. Families who once farmed

of the survival of the many. Then there is the Kaliwa Dam, which threatens the Sierra Madre, the last great mountain barrier shielding Luzon from the full wrath of Pacific typhoons. To damage that shield is to invite disaster. It puts indigenous communities, millions of downstream residents, and the

country's climate defense at risk. We have already witnessed

natural storms into mass tragedies: Sendong (2011), Yolanda (2013), Ondoy (2009), Ulysses (2020). These were not "acts of God." They were consequences of

deforestation, mining, and

irresponsible land use. Let us be clear. These are not natural disasters; they are policy disasters and economic choices.

We are often praised for our resilience. But let us be honest. Resilience is not a badge of honor but an evidence of how much we are forced to endure. We should not be admired for rebuilding again and again. We should be outraged that we are made to.

If we continue choosing profit over planet, we are not building progress. We are preparing the next tragedy.

And the mountains, rivers, and seas will not stay silent. If we do not finally learn now, their next warning will not be gentle.



ORDER

The count notes petitioner's motion for leave of court to admit attached amended petition, dated September 5, 2025, and admits said amended petition into the records.

Before this court is an amended petition for recognition of foreign judgment, filed by petitioner Marvin V. Paule, Jr., with regard to the foreign divorce obtained in Canada on April 15, 2016, ordering the dissolution of the marriage between him and Jackie Lou Silvosa Paule, also known as Jackie Lou B. Silvosa.

Petitioner, prays that this court recognize said foreign divorce and direct the Philippine Statistics Authority (PSA), through the Civil Registrar General and the Local Civil Registrar of Lubao, Pampanga to: (1) annotate the fact of said divorce on the parties' certificate of marriage, to reflect the dissolution of their marriage; and (2) declare petitioner as capacitated to contract a subsequent marriage.

Petitioner alleges that he and private respondent were classmates in kindergarten. They met again in high school and became a couple during college. They were married on December 8, 2002 in Lubao, Pampanga. For a time, their marriage was harmonious and lived peacefully. They have one child, Nicole Silvosa Paule.

In 2004, petitioner was involved in drug use and was admitted at the Central Luzon Rehabilatation Center for treatment. He alleges that his situation worsened and he suffered a relapse in 2013. He returned to rehabilitation a number of times but was supposedly unable to break free from his addiction. Respondent then decided to leave and relocate with their child to Canada. Respondent filed for divorce with 'le Vancouver Law Courts of Canada. On March 15, 2016, the Supreme Court of British Columbia issued a final order, stating that the parties were divorced.

The petition is sufficient in form and substance. Set this case for hearing on February 4, 2026 at 8:30 in the morning, before this court, at the Hall of Justice, San Matias, Guagua, Pampanga.

Let this order be published once a week for three (3) consecutive weeks in a newspaper of general circulation in the province of Pampanga, expenses to be borne by petitioner. The Civil Registrar General, as well as any person having or claiming any interest in the petition may, within fifteen (15) days from notice of the petition or from the last date of publication of such notice, file the pertinent pleading and appear on the date and time mentioned above to show cause why the petition should not be granted.

Let copies of the petition, its annexes, and this order be furnished the Solicitor General, the Provincial Prosecutor of Pampanga, and the Civil Registrar General.

The court's Officer-in-Charge is directed to furnish the Office of the Clerk of Court, Regional Trial Court, Guagua, Pampanga with copy of this order so that it may be published in accordance with the pertinent provisions of Presidential Decree No. 1079.

This pertains to the petition filed by the petitioner through the Public Attorney's Office, alleging the following:

Petitioner was born on May 17, 1996 to spouses Reynaldo Minimo Ravana and Luisa Barcenas Angeles. She was born second in the order of birth.

On March 5, 2025, she presented her PSA copy of her Certificate of Live Birth to the Department of Foreign Affairs (DFA) satellite office in Balanga, Bataan as a requirement in the application of her Philippine Passport.

During the evaluation, the DFA pointed out that the citizenship of the petitioner's father is not clearly reflected as "Filipino". The word "Dressmaker" is superimposed in the line separating Entry No. 14 (Citizenship) and Entry no. 16 (Occupation). This irregularity has raised doubts regarding the accuracy of the civil registry record and consequently, cast uncertainty on the petitioner's claim to Filipino citizen by

To verify the abovementioned information, the petitioner obtained copies of the Municipal Form No. 102 as well as Civil Registry No 1A from the Office of the Municipal Civil Registrar of Sasmuan, Pampanga and she discovered that the citizenship of her father was clearly entered as "Dressmaker".

The truth is that Reynaldo M. Havana Is a Filipino citizen who was employed as a dressmaker at the time of the petitioner's birth. He was born in Sta. Cruz, Zambales, Philippines to Filipino parents and has resided in the Philippines since birth. The erroneous entry regarding the petitioner's father's citizenship on the Certificate of Live Birth may have resulted from mere inadvertence, wherein the clerk may have mistakenly recorder his occupation as his citizenship.

To establish that her father is a Filipino citizen, the petitioner secured a PSA-copy of her father's Certificate of Live Birth indicating that he (petitioner's father) was born to spouses Leonardo Quiroy Ravana and Rosario Edip Minimo who are both Filipino citizens.

The petitioner's parents were blessed with five children, including the petitioner. In the Certificate of Live Birth of petitioner's siblings, the nationality of their parents is consistently recorded as Filipino. It is only the Certificate of Live Birth of the petitioner that the correct citizenship of her

The petitioner prays that after due notice, publication and hearing, this petition be GRANTED and that an Order be issued directing the Civil Registrar General/Philippine Statistics Authority to reflect in the Certificate of Live Birth of petitioner with Registry No. 96-189 the true and correct citizenship of her father which is Filipino as well as indicate the occupation of her father as Dressmaker at the time of her

Finding said petition to be sufficient in form and substance, the same is hereby set for hearing on December 10, 2025 at 8:30 in the morning with additional settings on January 21, 2026 and February 11, 2026 both at 8:30 in the morning at the courtroom of this Court.

In a letter dated Nov. 11, Lazatin requested the assistance of the DENR in the strict implementation of Angeles City's CLUP to prohibit structures from being built in the protected area of the Sapangbato Watershed.

The congressman is also seeking the assistance of his brother, current Angeles City Mayor Carmelo "Jon" Lazatin II, and the officials of Angeles City in strictly implementing the CLUP.

Likewise, Pogi Lazatin called on the Bases Conversion and Development Authority and the Clark Development Corp. to thoroughly consider the

environmental impact when approving development projects on their property located within the protected area

The area covered by the Sapangbato Watershed is within the political jurisdiction of Angeles City, however, parcels of land in the area are owned by the BCDA and the CDC.

It can be recalled that as city mayor, Pogi Lazatin ordered the closure of several establishments, including restaurants and resorts, that were found erected in the protected area through an agreement between the establishment owners and the BCDA – in violation of Angeles City's

In his time as the city's chief executive, a total of 145,041 seedlings were planted in the watershed through the reforestation program of the Angeles LGU in partnership with the Abacan River and Angeles Watershed Advocacy Council, Inc.

Studies
According to a 2015

report from the European Environment Agency, forests can soak up excess rainwater, which aids in preventing run-offs and damage from flooding.

A 2025 study by Herath, et al. notes that a forest cover functions as a "natural flood defense" by detaining water and reducing the energy of floodwater. An increased forest cover tends to reduce water flow; meanwhile, deforestation causes a sharp increase.

A 2023 study by the University of British Columbia also shows that the loss of forest cover is associated with more frequent and more extreme flooding.
