

Cong Pogi seeks tax incentives for parents, guardians of children with special needs

Pampanga 1st District Rep. Carmelo "Pogi" Lazatin, Jr. has filed a bill granting tax deductions to qualified parents or legal guardians of Children with Special Needs (CSNs) and Youth with Special Needs (YSNs).

House Bill No. 6504 seeks to grant qualified parents or legal guardians of CSNs and/or YSNs a deduction of P50,000 from their taxable income, provided that said amount is used for therapy, diagnostic evaluations by a medical professional, tutoring, transportation expenses to and from a school or medical facility, or specialized instructional materials or assistive devices.

To qualify for the tax incentive, parents or legal guardians must provide more than half of the total financial support for the CSNs and/or YSNs.

"Raising children with special needs entails significant sacrifices and often require expensive treatments and therapies. Beyond the economic challenges of rearing children with special needs, the parents, legal guardians, and relatives also advocate to secure their children's inclusion in government programs," Lazatin said.

Given the number of children with disabilities, there is a dire need for the government to step in and provide support to the parents and legal quardians to improve these children's opportunities and wellbeing," he added.

CSNs are those aged 18 years old and below who are either intellectually-gifted, or who have disabilities, impairments, or handicaps that make learning and other activities difficult and/ or require special attention and services to facilitate rehabilitation. These shall include those with physical/ orthopedic, intellectual, mental, psychosocial, visual, hearing, or learning disability; speech and language impairment; autism; or disability due to chronic illness.

YSNs are those aged 15 to 24 years old with the same characteristics as CSNs stated above.

Qualified CSNs and/or YSNs may be legitimate, illegitimate, or legally adopted, and who are dependent and living with the taxpayer. This also includes CSNs and YSNs placed under the legal custody of an immediate family or relative.

It can be recalled that on Oct. 6, 2025, Lazatin also filed HB 5125 mandating the establishment of National and Provincial Centers for Autism.

Under HB 5125, national and provincial centers for autism will be established to formulate and implement an integrated and comprehensive plan for the diagnosis, therapy, and rehabilitation of individuals with autism.

The centers shall provide free diagnosis, therapy, and rehabilitation; vocational training for adults with autism; employment opportunities for individuals with autism; and counseling,


orientation, and referral services.

The provincial autism centers shall also implement early detection and intervention programs for children under five years old within their jurisdictions, in coordination with the respective barangays for screening, parent education, and early therapy for the children.



AIDS: The world must step up, not step back



THIS WORLD AIDS Day comes amid deep uncertainty, and this year's theme, "Overcoming disruption, transforming the AIDS response," is a clear call to action: the world must step

Gender inequality continues to fuel the AIDS pandemic. Today, 53% of the 40.8 million people living with HIV are women and girls. In sub-Saharan Africa, adolescent girls are acquiring HIV at six times the rate of boys. Violence, unequal access to healthcare, and limited opportunities for leadership all contribute to this crisis—and women continue to bear the brunt of care and support responsibilities.

These inequalities are now deepening. Cuts in global funding threaten to reverse decades of progress, shrinking the very programmes and resources that protect and empower women and girls. But women living with HIV are not victims—they are advocates, leaders, and change-makers. Their voices must be heard, their rights upheld, and their leadership fully resourced.

Against this backdrop, UN Women continues to act. In 2024, we strengthened the leadership capacities of more than 35,000 women in 36 countries and expanded access to prevention and treatment through community-based services, including outreach and legal empowerment across Africa and Central Asia.

The Beijing+30 Political Declaration reaffirms its commitment to women's health as a critical area of concern of the Beijing Platform for Action and pledges to advance the health rights of all women and girls.

This World AIDS Day, let's recommit. We must reverse disinvestment, centre gender equality and human rights in the AIDS response, and maintain political will for prevention, care, and treatment. That means increasing domestic funding, ending violence, and supporting the networks of women whose leadership is transforming lives.

AIDS is not over—and neither is our fight. Now is the time to protect what we've achieved and push forward, together.

A RAINBOW arched over EDSA today—on the first Sunday of Advent, at the height of our "Trillion Peso March" Part 2.

It looked as if it was trying to envelop not just those in Manila but all Filipinos across the country gathered together in solidarity. It appeared like a quiet whisper from the heavens, a soft brushstroke of light across a troubled sky.

Rainbows come only when storms meet sunlight. And perhaps that is what this moment is: the storm of corruption and weariness meeting the stubborn radiance of a people who still dare to hope.

We returned to EDSA because this place holds the memory of peaceful courage. Here, our people once stood unarmed yet unafraid, choosing moral clarity over fear.

Today, as our country confronts wounds inflicted by greed and impunity, we come again not to tear down, but to call our leaders and ourselves back to the path of truth.

The Democracy restored by the EDSA People Power Movement may be flawed, unfinished, fragile, yet it is the only soil where genuine change can take root. And so, we gather to protect it—not through force, but through fidelity.

What moved me most today was the sight of countless communities mirroring this gathering across the archipelago. Parishes, civic groups, families, and young people stood under their own skies, offering their own prayers and witness. It felt as though the whole nation exhaled in unison—a collective longing to heal what has been broken, a gentle but firm refusal to surrender our future to the darkness of corruption.

There was no hatred in the air, only resolve. No violence, only vigilance.

No despair, only the quiet bravery of those who still believe.

And so, the rainbow becomes our Advent sign.



A reminder that God remembers His covenant with His people; that even in unrest, there is a promise shimmering at the edge of the storm.

But covenants are mutual: God remains faithful, and we too must remain faithful—to truth, to justice, to the poor, to each other. If we walk this road together, as one people with one conscience, then the hope we glimpsed in that arc of color today may yet unfold into a future worthy of our children.

EDSA is not a relic. It is a living vow. And today, once again, we renewed it.

The evolution of Bong bong

The big rally last November 30 was a day which marked the death of a national hero who stood against political corruption of his own in his day. The Bonifacio Day event this time, triggered by the massive rot in government anomalies unearthed by this current administration, may have been the last of the latest political mania or "wokeness"

There was a more intimidating gathering previously, ostensibly religious, unmistakably political. All is well that ends well. The political skirmishes will continue, for sure, but it will hopefully logically scale down to what is even more manageable for the nation.

Thank you. Now we can all breathe more easily, meaning, with the advent of Christmas, life is back again to normal, even if government is hard put to explain why or how a P500 budget is realistic for a noche buena. Besides, a sense of a thanksgiving is in the air. There is still much to count blessing for as we end the year with the season of storms ending, too.

Hope springs eternal. For one, President Bongbong is probably over the worst and 2028 beckons. In other words, any idea that entertains that a change in regime will happen is feckless or clueless. A coup or junta on Christmas season--- the longest celebration in this neck of the woods--- is unimaginable or out of touch.

Even if PBBM may not make the timeline to jail those found guilty in the insane rush to steal people's money via public works projects on or before Christmas, there are signs that he's doing his darn best to make good his promise.

He has compelled or persuaded a public works engineer to return P110 million in public works money, a first in the history of the country. More are expected to be returned. Another official is expected to make a better gesture by returning P1 billion sooner or later. PBBM has no competition in this contest, which many believes is a race against time. Retribution, like healing of an injury, is a matter of time.

PBBM must have done his homework. Or, on the other side, those who opposed him have not. There was a brief time, the public became jittery that the political legworks triggered by public works corruption would end up in a political denouement similar to what took place in 1986.

The President may have been ill- advised that the annual celebration of the Peaceful Revolution at EDSA in 1984 should already have a public closure as far as the public holidays were concerned. The advice may have been premature given the subsequent public uprising against corruption

that follow.

To borrow a favorite adjective by an American president, those who thought the PBBM presidency will eventually cave from the great pressure from public opinion was "misundersestimated". There was an anticipation, if not a prayer, to this end. The self-serving logic of the vice president was evident, given the public ruckus. She's ready to take wheels of government. The Constitution is clear, after all.

The timing of the so-called expose against PBBM for instigating the massive corruption in public work projects involving billions was obviously planned, along with the marches and louder calls for him to resign to bring down the present government.

It appeared that PBBM was more than ready and prepared than his vice president. He was a former president's son. He was a former dictator's son. He could have been a future emperor or king's on if history or fate did not intervene in 1986.

He must have learned a thing or two in politics, both in theory and practice from a former dictator. He must have imbibed some Machiavellian tips from an authoritarian leader, although it's doubtful if the younger Marcos practices it. Certainly, the evolution of the former dictator son is shown not by his intelligence or power but by his ability to handle the corruption issues and fallouts, even against him, and the public outcry for justice and reforms.

It has been said that the former dictator thought his daughter was the more important version of him intellectually than the namesake. The senator was also more audacious in vilifying his brother, the wife and the family of drug use.

The senator's public spiel or spill on the day of a huge rally by a large religious group was apparently aimed at PBBM's political jugular. When it failed to work, as a proposed a civilian-military junta was unable to install a new president, the organizers decided to cut the rally off, from three days to two.

AS plain luck or sheer coincidence would have it, a former president's request for interim release from the Internation Criminal Court (ICC) in The Hague was dismissed. This heavily doused any hope that those entertaining a regime change will occur as the former president is set to face soon a case of crime against humanity.





The price of denial in public service

WHEN DEPARTMENT of Trade and Industry Secretary Cristina Roque claimed that P500 could finance a Noche Buena, she was not giving advice; she was actually exposing how detached public officials have become from the realities of ordinary Filipinos.

When she based her statement on her department's official price guide, she forgot that Filipinos live on market prices, not on government charts that do not truly reflect the cost of living in supermarkets, groceries, wet markets, or even sari-sari stores.

When social media erupted with outrage, Filipinos weren't just reacting to the amount; they were reacting to Roque's insensitivity.

When families who now spend nearly P1,500 to prepare a modest Noche Buena hear a government official insist that P500 is enough, that is not providing a guide or an information but more like adding insult to injury.

When Secretary Roque chose to double down rather than admit error, she mirrored a larger disease among government officials who have grown to be allergic to humility and laced with their chronic refusal to apologize.

When public servants defend the indefensible, they send what appear to be a clear message: perception matters more than truth, and saving face is more important than facing facts. When this becomes a rule rather than an exception among various government agencies, Filipinos begin to lose hope in the institutions that are tasked to help them achieve a better life.

When the Department of Health downplays the collapsing state of public hospitals where patients share beds and doctors buy their own gloves, it is the same denial in uniform.

When the Department of Education boasts of new curriculum even as thousands of students continue to study

under trees or in flooded rooms, it is the same blindness to lived experiences.

When the Department

When the Department of Transportation celebrates "modernization" while commuters endure hours in broken trains and overcrowded jeepneys, it is the same disconnect from the daily grind of workers.

When the Department of Public Works and Highways inaugurates roads that crack in less than a year or flood at the first rainfall, it is the same arrogance asked as accomplishment.

When the Department of Environment and Natural Resources touts its strict licensing or successful reforestation programs even as rivers turn black and mountains turn bald,

it is the same illusion of progress.

When officials like Roque speak from podiums instead of public markets, they no longer see what the people see; they only see what reports tell them to believe.

When government leaders mistake criticism for hostility and cling to false pride instead of empathy, they betray the very people they serve.

When P500 is said to buy a Noche Buena, it's not just a miscalculation but a metaphor for the poverty of understanding that has long plagued Philippine governance.

When our officials realize that humility costs nothing, only then can they practice the true meaning of public service.
