Ailing kids get Christmas wish at Pradera Islands



Gov Nanay said her family wished the patients to be imbued with the "Christmas is for children" spirit of innocence, wonder and pure joy, as a break from their medical treatments.





Cong Pogi pushes Anti-Dynasty Bill



Sandiganbayan affirms dismissal of charges vs. ex-Mexico mayor Teddy Tumang, 7 others

CITY OF SAN FERNANDO "Having found no cogent reason to reverse its findings in the assailed resolution, the Court must perforce deny the prosecution's motion for reconsideration."

Thus, t h e Sandiganbayan affirmed its ruling dismissing graft and malversation charges against former Mexico Mayor Teddy C. Tumang and seven other officials for alleged irregular procurement of construction materials for road repairs in 2009 and 2010.

In its six-page resolution issued on Dec. 12, the Sandiganbayan denied the motion filed by the prosecution to reverse the Sept. 3 ruling that granted the demurrer to evidence filed by Tumang and his co-accused.


With the grant of the demurrer to evidence, Tumang and his co-accused - municipal accountant Perlita T. Lagman, municipal planning and development coordinator Marlon De Leon Maniacup, municipal agriculturist Romeo C. Razon, municipal budget officer Lucila M. Agento, municipal engineer Jesus S. Punzalan, and administrative officer Luz C. Bondoc, along with Buyu Trading and Construction owner William B. Colis -were cleared of 64 counts of graft and seven counts of malversation of public

They had been accused of conspiring with one another in the purchase of base course materials for a road improvement project in Barangay Eden, Mexico without undergoing public bidding and that the purchased materials did not even reach the intended recipients, therefore causing damage and prejudice to the government.

The prosecution had argued that the anti-graft court erred in ruling that there was no sufficient evidence presented by the prosecution and that the ruling was a "gross misapprehension of facts" which are "unfounded, speculative

Standing pat on its ruling, the Sandiganbayan said: "The Court stands firm on its findings contained in its assailed Resolution. The prosecution failed to adduce new substantive arguments to convince the Court to reconsider and set aside its findings that the prosecution did not provide sufficient and competent evidence to support a conviction."

The resolution was penned by Presiding Justice Geraldine Faith A. Econg with the concurrence of Associate Justices Edgardo M. Caldona and Arthur O. Malabaguio. Punto News Team/From media reports

Thus, Pampanga 1st District Rep. Carmelo "Pogi" Lazatin, Jr. on Dec. 11 categorically declared his full support Anti-Political Dynasty Bill being pushed in the 20th Congress.

On Dec. 9, Malacañang announced that President Ferdinand Marcos Jr. wants Congress to prioritize the Anti-Dynasty Bill, the Independent People's Commission Act, the Party-list System Reform Act, and the Citizens Access and Disclosure of Expenditures for National Accountability (CADENA) Act.

One of the co-sponsors of the Anti-Dynasty Bill, Lazatin belongs to the third generation of the Lazatin political family.

"Anyone who has followed me throughout my years in public service would know that I have never denied my family's political history. Doing so is not only hypocritical but also does a disservice to the exemplary record of my father, and his father before him," Lazatin said.

"Be that as it may, we serve only at the pleasure of the people. If the will of the people I represent is

for this bill to pass, then I support its passage wholeheartedly," he added.

The solon's paternal grandfather, Rafael "Apung Feleng" Lazatin, served as municipal mayor of Angeles in 1946, as governor of Pampanga from 1951 to 1959, as Angeles City mayor from 1972 to 1980, and as Batasang Pambansa assemblyman from 1984 to 1986.

His father and namesake, Carmelo "Tarzan" Lazatin, served as Pampanga 1st District representative from 1987 to 1998 and from 2007 to 2013, as Angeles City mayor from 1998 to 2007, and as Barangay Balibago chairman in 2018.

Roman wants to feel pulse of people on anti-dynasty law

ORANI, BATAAN - First District Rep. Tony Roman said over the weekend that before commenting he will study first the bill filed in Congress on the anti-political dynasty law and wanted to feel the pulse of the people.

House Speaker Faustino Dy and majority leader and presidential son Sandro Marcos have just filed the bill that Roman said he has not yet read.

"Ang batas di ko pa alam kung ano, bago ko i-define ang dynasty. Ultimately kailangan timbangin. Sinasabi ng Saligang Batas na ang kongreso maaaring magpasa ng batas para ipagbawal ang political dynasty but at the same time, ano kaya iniisip ng taong bayan," Roman said.

"Kasi sa dulo, nasa kanila ang pagpapasya kung talagang dapat ipagbawal ang dynasty. So, I have yet to study ang panukalang batas na ni-file ni Speaker Dy at saka ni majority leader Sandro Marcos.

Tingnan ko lang kung ano ang saklaw noon. Hindi ko pa nababasa kasi kaka-file lang," the Bataan solon said.

"Ano ba epekto ng dynasty? Depende kung maganda ang dynasty o hindi. Kaya nga sabi ko ano kaya ang saloobin ng mga tao kung talagang sang-ayon ba sila na ipagbawal. Hindi ko alam depende din sa definition. Dynasty bang successive o dynasty na sabaysabay?" he furthered.

"To be honest, di pa ako sigurado kasi ang pagpapasya nasa tao kasi kung talagang maganda ang mga namumuno, magaling ang namumuno at nararamdaman nila ang serbisyo ng pamahalaan, hindi ba nagkataon lang na magkakamag-anak?," Roman added.

"So, we don't know, so I'm still on the fence kaya I have to wait," he said.

Roman, a lawyer, is on his first term, winning unopposed in the last elections. He took over the position held for three terms by sister Congresswoman Geraldine Roman.



Garcias to obey anti-political dynasty law when enacted

BALANGA CITY - Gov. Jose Enrique Garcia III of Bataan said Thursday that they will follow what the anti-political dynasty bill will dictate once it passes into a law but asked that lawmakers consider unity and continuity of projects in the bill.

Dy-Marcos bill: Institutionalizing political dynasties

"FOR DECADES, power has been concentrated in the hands of so few political families, and it's about time, if we want... our country to be a real democracy, [to pass the anti-political dynasty bill."

So, Akbayan party-list Rep. Chel Diokno was quoted on Dec. 10, in the wake of President Ferdinand Marcos Jr.'s urging Congress to prioritize the passage of a bill that would ban political dynasties in the Philippines, along with other measures that would help "institutionalize transparency and accountability."

"We cannot underestimate the power of people's expression of their opinion, and napakalakas ng ugong ng call for an anti-political dynasty bill, and all the moral and legal backing is there," furthered Diokno. "Corruption and political dynasties are ... intimately connected, and if we address one, we have to address the other."

Over a dozen years ago, we read an even more euphoric urgency, thus: "Today is a historic moment, if only because for the first time, this was approved at the committee level."

So declared then Bayan Muna Partylist Rep. Neri Colmenares of Nov. 20, 2013, the day the Anti-Political Dynasty Bill (APDB) was approved unanimously - by the House committee on suffrage and electoral reforms.

A consolidation of three bills, the approved measure seeks to prohibit relatives up to the second degree of consanguinity to hold or run for both national and local office in "successive, simultaneous, or overlapping terms."

It also provides for the Commission on Elections to decide through lottery who in the clan would be permitted to run in the election in case none of the candidates in the same family refuses to withdraw.

We all rued where that APBD ultimately went – to the dustbin of good riddance in a House ruled by dynasts. So, should we expect anything different from this new minting of the once doomed bill?

Differently worse, from the looks of it.

True, House Speaker Bojie Dy and Marcos Tercero, Majority Leader Ferdinand Alexander aka Sandro, jointly filed a bill prohibiting political dynasties on the same day Diokno called out for one.

Immediate was the red-flagging of the Dy-Marcos bill, for at least three perceived infirmities: 1) it does not prohibit cross-level or cross-jurisdiction dynasties; 2) It does not prohibit a dynast from immediately succeeding an incumbent relative in the next election; 3) it is silent on party-list abuse by dynasts.

In effect, Dy-Marcos' anti-dynasty bill shall instead institutionalize what it intends to abrogate. It is impacting de jure imprimatur to de facto anomaly.

Stop it now

YOU KNOW, I have a strong feeling that the message supposedly coming from John the Baptist did not really come from him. And I also think that Jesus himself did not believe that the message truly came from John, even if it was delivered by some of John's disciples. I am referring to the painful question supposedly asked by John while he was in prison:

"Are you really the one we are waiting for, or should we look for someone else?"

In simpler words: "Did I make a mistake in trusting you?" If that question did not really come from John the Baptist, then where did it come from? My suspicion is that it came from troublemakers—people who wanted nothing more than to destroy the trust between John and Jesus, and between Jesus and John. In short, they wanted to pit them against each other.

That is why we must be careful about disinformation. This is nothing new. Only the technology has changed. Long before digital technology and social media existed, fake news was already widespread. In fact, it was through fake news that Satan deceived humanity and tempted people to eat the forbidden fruit in paradise.

We heard in the opening line of the Gospel that news about the works of Christ reached John the Baptist in prison—Christ meaning the Messiah whose way John had prepared. And based on what he heard, a message was sent to Jesus with that painful question.

Why do I say that Jesus did not believe the message really came from John? Because of how Jesus reacted. If I put his reaction in simple words. it is as if he said:

Come on—what do you really think of John the Baptist? Do you think he is someone who easily believes rumors? He is not like a reed that bends with every gust of wind. I know him. He is not like that. And he is certainly not someone who pretends to be powerful or passes false judgment."

So the important question is this: why was Jesus being targeted by intrigue? Because some people were jealous of the trust and respect that John showed toward Jesus. (Recently, a media person wanted to interview me and said, "You are being criticized on social media because of what you said at EDSA. What is your reaction?" I replied, "I will tell my reaction privately to those concerned, not in public." Sometimes we might be reacting to what we think someone said, without really listening to what was actually said, and we can't take back our words.)

John held Jesus in such high regard because Jesus himself was deeply humble. In fact, John even pointed Jesus out to his own disciples and called him "the Lamb of God who takes away the sins of the world."

John clearly understood that Jesus was different.

He was not like prophets who were angry and spoke only words of judgment, threats, and condemnation. Jesus looked for the lost sheep. His message to sinners and those who had lost their way was not punishment, but an invitation to change and return to God.

Look at how he treated Zacchaeus and Matthew people known for corruption as tax collectors. He did not say, "Your days are numbered! You will be punished!" Instead, he looked up at Zacchaeus, who had climbed a sycamore tree, and said, "Zacchaeus, come down." And to Matthew he said, "Come, follow me. Let us eat together. Let us talk." When a woman accused of adultery was dragged before him, he challenged those ready to stone her: "Let the one without sin throw the first stone." Then he lifted the woman up and said, "I do not condemn you eitherbut stop living a sinful life."

was inspired by the very direct words spoken by Bishop Tony Tobias when he recently celebrated Mass with members of Congress. His tone was gentle and calm, but his message was strong:

"My brothers, STOP IT NOW."

That was not condemnation—it was an invitation. An invitation to admit wrongdoing, if they truly want to free our country from the prison of corruption. It begins with confession, followed by a humble expression of repentance, and by doing what Zacchaeus did: willingly returning what was stolen.

This is not meant to shame, but to invite those who were tempted and who now cannot even face the people. Life is miserable for those who have stolen. They are not to be envied, but pitied. How can you raise your children and grandchildren with honor if you feed them with money stolen from the people—while so many are hungry, lining up for hours just to get an endorsement letter so a sick family member can undergo surgery?

It is true that among those born of women, John the Baptist was great. But Jesus says that the least in the Kingdom of Heaven is even greater. Why? Because for the sake of the poor and the sinners, the Son of God was willing to give his life for their redemption. How can you not change when you look at the cross and hear the one you crucified say:

"I have paid your debt. All I ask is that you turn away from sin."

Doubt

With a tad over a week before Christmas, the President may not be able to make it to his timeline or deadline to throw into the slammer corrupt officials, big fish or not. Some of them—certainly not all of them - must go to jail, as planned, before noche buena begins, as if it's a political pivot.

"ASK NO QUESTION and you'll be told no lies,"Charles Diclens wrote in the Great Expectation. The time and season for questions and lies were unparallel in a Marcos experience. As the leader of a truth besieged nation, he wants the answer soon not later.

No doubt, he must be doing his best to keep his word. He's on the right and righteous footing. But there are other factors such as evidence, politics, doubt and fairness. After all, as the highest official of the land, he is deemed to give justice to everyone. Nothing exists in a vacuum.

Then there is reasonable doubt which must be fully satisfied before anyone, big or small, is convicted of a criminal offense. In a judicial system that anchors its fairness on the presumption of innocence as opposed to the presumption of guilt, the burden weighs heavily on the court. As to the low-hanging fruits, it may be a different matter ,but fairness must still be observed.

"Our doubts are our traitors," Shakespeare wrote,"and lose the good that we might oft win." Yeah, were in that dangerous phase.

Since the President blew the whistle of massive corruption in flood infrastructure projects, several probes have been done and pieces of evidence linking people to the unprecedented anomalies have been uncovered. The small fish consists of the ordinary staff in government public works. The big fish are no less than legislators. An independent commission (ICC) created for the purpose has already invited both the small fries and the suspected shark s to give their best possible side. Impression should create perception. But the ICC is mere recommendatory to the Ombudsman. Before the Christmas break, the ICC has closed shop until the new year, which may be a different scenario when it comes back to work.

True to his avowed new zeal as an anti=graft body as opposed to his predecessor which was considered lax or laggard when it came to battling corruption in government, the new Ombudsman has filed cases against erring officials.

So far, so good. The Ombudsman has done his prosecutorial duties, it's up to the court to determine conviction based on evidence. That's what's keeping the President from making his vow on time. Due process takes time. Otherwise, zealotry is tyranny.

Note that the new Ombudsman, when he led the case to probe the 100 missing sabungeros, admitted that what he was up against were the best lawyers that money could buy because big money, not big government, was the issue. To this day, only one person was accused. He is still out of

jail. It's the same thing with flood projects corrupt official who remain free. Cases filed, hohum.

In the meantime, the public is left with jitters hanging on the urgent issue of corruption in public works projects. If the President fails to jail as he promised those corrupt officials this Christmas, he must tell the public what's in his mind. Confusion can breed intolerance, a fertile ground for destabilization. And the President's enemies are opportunists at best, which most politicians are, by definition.

It's a good thing that the former president, which is still the incumbent President's real political rival is waiting in the Hague for his trial for crime against humanity by the International Criminal Court. The political story and the nation's narratives would have been altered if he were released.

So far, the former predecessor supporters are virtually paralyzed by his detention is the Netherlands. There is only so much that they can do to mount their hobby horses versus a sitting President. They can march untill their blue, not yellow, in the face but they can run around him to unseat him. Indecisions, however, can be perilous. It's a Machiavellian fear: to be feared is better than to be loved. How does the public look at a soft-spoken, kind commander in chief?

The Ombudsman currently addressing a United Nations forum in the Middle East about what the Philippines is doing vis-à-vis the corruption scandal? It's a public relations job, for whatever it's worth. It will not move the needle until the corrupt are put in jail.

Perhaps, the Ombudsman can make his friends in the UN facilitate the arrest of former Congressman Zaldy Co and his deportation and the enforcement of a red notice flag on former Secretary Harry Roque. These are not miracles and can be achieved by this administration, now not later.

While at it, the President can also certify as urgent, not as a priority, an honest-to good ness anti- political dynasty. To be sure, the presidential son has a filed similar measure in the House of Representaties. But legislators have found the bill that will only result in making current dynasties permanent. Where's the beef, Mr President?

The President still has eight days to go before Christmas day. And he has a promise to keep. To parse the American poet Robert Frost, a miles to go before he sleeps. 2028 is still afar off. In politics, that's still a long time. It can make the President sleepless for eight nights. Or make the compelling case before the courts that putting the corrupt behind bars on Christmas Day is also D-Day for the nation.

Cross your fingers.

I know now that there was no quaranteed spiritual formula to it, but I grew up believing that completing all nine Masses meant our prayer petitions would be

8) On or around 2024, petitioner secured a copy of his Certificate of Live Birth from the of on a round 2024, pertuborer secured a copy of his Certificate of Live Birth from the respondent Philippine Statistic Authority and to his shock and dismay, he discovered that his *date of birth* and his *sex/gender* are erroneous. It appears in his Certificate of Live Birth that the petitioner's date of birth is 16 August 1969, instead of 16 May 1970, which is his true and correct date of birth. It also appears in his Certificate of Live Birth that the petitioner's sex/gender is *Female* instead of Male which is his true and correct sex/gender. These erroneous entries are evidenced by the Certificate of Live Birth issued by the Philipping Statistics Authority 20. Philippine Statistics Authority20.

9) Petitioner is bewildered by the fact that there are erroneous entries in his Certificate of Live Birth issued by the Philippine Statistics Authority considering that there were no erroneous entries when his mother, Leonida C. Marcelo, submitted to the Office of the Local Civil Registrar his Late Registration of Birth21. Further, when he secured copy of his Certificate of Live Birth back on 2011 from the National Statistics Office, there were also no erroneous entries in his Certificate of Live Birth issued by the National Statistics Office22

10) Upon learning the aforesaid erroneous entries in his Certificate of Live Birth issued by the respondent Philippine Statistics Authority, petitioner immediately filed a Petition for Correction of Clerical Error in the Certificate of Live Birth before the respondent Local Civil Registry Office of Porac, Pampanga, seeking correction of the clerical error in his Certificate of Live Birth, particularly Items Nos. four (4) and six (6), described as child's sex/gender and child's date of birth (month and day), from Female to Male and from 16 August to 16 May, respectively, as evidenced by a copy of the Petition for Correction of Clerical Error in the Certificate of Live Birth23.

11) On 28 June 2025, respondent Philippine Statistics Authority issued a copy of petitioner's Certificate of Live Birth containing an annotation for the correction of the erroneous entries of sex/gender and the month of the date of birth of the petitioner, the annotation states;

"PURSUANT TO THE DECISION RENDERED BY MCR EVA S. MANALASTAS-NUCUP DATED FEBRUARY 19, 2025 AND AFFIRMED BY CRG UNDER ORCG NO. 25-2734723, THE CHILD'S SEX IS HEREBY CORRECTED TO "MALE"; AND THE CHILD'S DATE OF BIRTHIS LIKEWISE CORRECTED TO "MAY 16, 1969".

12) Petitioner is grateful that the erroneous entries for the sex/gender and the month of his date of birth in his Certificate of Live Birth have been corrected. However, the entry for the year of his date of birth in his Certificate of Live Birth remains erroneous 25.

13) In the case of Dr. Ruben C. Bartolome vs Republic of the Philippines26 the Supreme Court summarized the rules in Correction of Erroneous Entries, the Supreme Court held

In 2012, Republic Act No. 9048 was amended by Republic Act No. 10172.

In addition to the change of the first name, the day and month of birth, and the sex of a person may now be changed without judicial proceedings. Republic Act No. 10172 clarifies that these changes may now be administratively corrected where it is patently clear that there is a clerical or typographical mistake in the entry. It may be changed by filing a subscribed and sworn affidavit with the local civil registry office of the city or municipality where the record being sought to be corrected or changed is kept.

The foregoing rules may be summarized as follows:

1. A person seeking 1.)to change his or her first name, 2)correct clerical or typographical errors in the civil register, 3)to change/correct the day and/or month of his or her date of birth, and/or 4)to change/correct the sor her sex, where it is patently clear that there was a clerical or typographical error or mistake, must first file a verified petition with the local civil registry office of the city or municipality where the record being sought to be corrected or changed id kept, in accordance with the administrative proceeding provided under R.A. 9048 in relation to R.A. 10172. A person may only avail of the appropriate judicial remedies under Rule 103 or Rule 108 in the aforementioned entries after the petition in the administrative proceedings is filed and late denied.

2. A person seeking 1)to change his or her surname or 2)to change both his or her first name and surname may file a petition for change of name under Rule 103, provided that the jurisprudential grounds discussed in Republic v. Hernandez are present.

3. A person seeking substantial cancellations or corrections of entries in the civil registry may file a petition for cancellation or correction of entries under Rule 108. As discussed in Lee v. Court of Appeals and more recently, in Republic v. Cagandahan, R.A. 9048 "removed from the ambit of Rule 108 of the Rules of Court the correction of such errors, Rule 108 now applies only to substantial changes and corrections in entries in the civil

xxx" (emphasis ours)

14) Considering that the aforesaid erroneous entries includes an error in the year of the date of birth of the petitioner, such erroneous entry if substantial as shifting the birth year of the petitioner significantly alters his age. Thus, a petition for cancellation or correction of entries under Rule 108 is proper. Section 1 and 2 of Rule 108 of the Rules of Court states:

"RULE 108"

Cancellation or Correction of Entries in the Civil Registry

Section 1. Who may file petition. Any person interested in any act, event, order or decree concerning the civil status of persons which has been recorded in the civil register, may file a verified petition for the cancellation or correction of any entry relating thereto, with the Court of First Instance of the province where the corresponding civil registry is located.

Section 2 Entries subject to cancellation or correction - Upon good and valid grounds the following entries in the civil register may be cancelled or corrected: (a) births: (b) marriage; (c) deaths; (d) legal separations; (e) judgements of marriage; (f) judgements declaring marriages void from the beginning; (g) legitimations; (h) adoption; (i) acknowledgements of natural children; (j) naturalization; (k) election, loss or recovery of citizenship; (I) civil interdiction; (m) judicial determination of filiation; (n) voluntary

15) In view of the foregoing, petitioner humbly submits that there is a need for this Honorable Court to issue an Order to correct/cancel the erroneous entry in order to show the true facts of the petitioner's date of birth and to avoid confusion.



Clarice Azarcon-Kong left the airline industry to co-found **Grovest Greenfield Corporation** in 2019, specializing in premium Japanese melons and mushrooms, focusing on ecofriendly, farmer-centric practices.

"We can finally give farmers real benefits—what they truly deserve," Clarice shares, aiming to show the younger generation that farming can be a dignified and fulfilling career. Grovest prioritizes low-impact techniques to ensure farmer safety, efficiency, and stable livelihoods.



Former overseas Filipino workers (OFWs) Kaiselle and Engineer Elmer Atun Jr. returned from Qatar to establish Desmond Farm and Partners Inc. (DFPI) in Pantabangan, promoting eco-resilient farming and farmer support. "What began as our personal dream has become a platform for empowering other farmers and OFWs," Kaiselle notes.

Their Farm Ridge agritourism hub features organic cacao, shade-sharing agroforestry, and solar irrigation, while profits are reinvested in farmer training. Visitors also enjoy Sierra 360, a hexagonal restaurant, and educational tours highlighting sustainable practices.

CSF opens center for autism, neurodiversity

CITY OF SAN FERNANDO — The city government here opened the San Fernando Center for Autism and Neurodiversity (SFCAN!) as part of its commitment to build a more inclusive and supportive environment for neurodivergent persons and their families.
