

## PAL moves turboprop flights to CRK

CLARK FREEPORT – Flag carrier Philippine Airlines is moving all of its remaining turboprop flights in Manila to Clark International Airport by the end of March.

Starting March 29, PAL flights from Manila to Coron and Manila to Siargao will be transferred to Clark.

Flights from Manila to Catarman, meanwhile, will instead be flying from Cebu to Catarman.

PAL said affected passengers may rebook their flights within 60 days from the original travel date or ask for a refund. They may also convert the cost of the ticket to travel credits with a 5% percent bonus value.

The transfer to the CRK is pursuant to the government directive arising coming from the decision in 2024 of the Manila Slot Coordination

## PSC to develop 20-hectare sports hub in New Clark City

CAPAS, TARLAC – The Philippine Sports Commission is set to develop a 20-hectare 20-hectare world-class multi-sports hub in New Clark City here as a new training home for Filipino athletes.

“This is a framework that allows PSC facilities to generate recurring income through sustainable estate and facility management. This ensures stable funding that can be reinvested in national sports development year after year,” PSC chairperson Patrick Gregorio said of its project partnership with the Bases Conversion and Development Authority.

Under the partnership, a 10-hectare multi-specialty sports facility will be developed to help build a complete and

inclusive sports ecosystem for Filipino athletes.

Another 10-hectare area will be allocated for the Philippine Tennis Center, reinforcing a long-term, discipline-based approach to national sports development and strengthening the country’s tennis program.

Aligned with President Ferdinand R. Marcos Jr.’s push to strengthen human capital, promote grassroots sports, and grow regional centers outside Metro Manila, the project is expected to boost sports growth by providing modern training facilities for Filipino athletes and expanding access to quality sports infrastructure beyond the National Capital Region.

## Cong Pogi thanks Marcos Jr., Dizon for flyover funding

Lazatin joined Dizon in his personal inspection of the on-going construction of the 1.1-kilometer flyover on Jan. 30. The flyover is expected to be completed within two years and is expected to ease the flow of traffic along MacArthur Highway.

Lazatin also thanked the president and the DPWH for granting the request of Mabalacat City Mayor Gerald Aquino for the construction of the Atlu-Bola Bypass Road, also within Pampanga’s 1st District.

“Ang Atlu-Bola Bypass Road ay makakatulong para guminhawa ang daloy ng trapiko sa Lungsod ng Mabalacat, lalo na sa mga sasakyan na nanggagaling ng NLEX,” Lazatin

said.

According to Dizon, it is the President’s direct instruction to ensure that infrastructure projects are completed immediately.

“Dakal tang proyekto – e mu keni Pampanga, all over the country – makatengga la. So ing sabi ning presidenti, e ne pwedi ita. Kailangan ariyan tana la ngan, once and for all kasi makalunus la reng kababayan tamu,” Dizon said.

Also present during the inspection of the Sto. Cristo Flyover is newly-appointed DPWH Region III director, Engr. Arnold Ocampo, who used to serve as District Engineer of the Pampanga 3rd District Engineering Office.

A lease agreement was signed on Feb. 3 between Clark Development Corp. and Paco and Friends Corp. for Jacaranda with all those gustatory delights of tacos, paletas, mole, tamales, and enchiladas, plus pastries, coffee, and chocolate. Sit down dining, a chef’s table, private rooms, cocktail service, and outdoor seating complete the concept.

The restaurant will open at Building

2091 along R.C. Santos Avenue, one of Clark’s iconic Barn Houses. The space spans 679 square meters. Investment: P25 million over five years. Jobs: at least 30.

“A cultural fit,” CDC president and CEO Atty. Agnes VST Devanadera calls it:

“It’s about right that we have the Mexican restaurant right here in Clark, where history starts, develops, and is always valued.”

PFC incorporators highlight tradition and innovation, seeing potential in transforming the historic barn house.

“There is no nicer place [barn house] than a hundred year old home where we can showcase what we can do,” Francisco Saucedo, one of PFC’s incorporators, said.

“We want a Mexican restaurant that is authentic, something we can share from our country and our experience. I think Mexico, as a country, has grown a lot. It’s a lot nicer place than I can think of,” he added.

Jacaranda adds a distinct cultural flavor to Clark’s growing roster of lifestyle and tourism offerings, befitting its top MICE destination status.

FILINVEST EXPANDS BEYOND REAL ESTATE:

Hospitality and Retail as Growth Engines

## Fully covered, soundbiting Vince

BY MULTI-MEDIA, that is, is Department of Public Works and Highways Secretary Vince Dizon inspecting on Jan. 30 the collapsed slope protection of the flood control project in Barangay Candating, Arayat, Pampanga, which damaged a total of 20 houses exactly a week ago. Amid the destruction, Dizon perfunctorily ordered a thorough investigation to ensure accountability and directing immediate assessment and repairs to prevent further risks to residents.

Mayhaps, needing a headline chasing soundbite to complement some dramatic reels and photos, Dizon disclosed the names of three DPWH-Pampanga officials who, at that very moment, have been relieved and suspended following a report he received a few days ago that they were extracting up to 8% on DPWH contracts.



Vowed Dizon: "We are going to conduct a full-blown investigation kung totoo ba 'yung report na natanggap ko na humihingi sila ng porsyento sa mga proyekto sa District 2 [Pampanga District Engineering Office 2]."

The Candating flood control project is under the jurisdiction of District 1. "Hindi dito," Dizon said of the assignments of officials he relieved.

## Uncovered, to Vince unseen

ALL TOO obvious, if not telling, amid that field of devastation in Candating, Arayat, Pampanga visited by Secretary Dizon on Jan. 30 is this soiled but unfilled-up DPWH project billboard identifying a "Sto. Cristo Construction & Trading Inc." as contractor/supplier for the "rehabilitation of eroded Pampanga River (sic)" started on May 22, 2025 with target date of completion on Feb. 23, 2026 at the cost of P91,578,485.36.

The once ubiquitous project billboards of the bedeviled Eddmari Construction & Trading at the sunken site have seemingly gone to destruction along with the project.

Curiously, Sto. Cristo Construction & Trading Inc. has not been factored in the failed Candating flood control project, notwithstanding its major part in the rehabilitation efforts,



as evidenced in that project billboard.

Curiouser yet, Sto. Cristo Construction & Trading Inc. is the Top 1 getter of Pampanga's P15-billion flood control projects with P1.713 billion; its major projects

centered in Candaba, Pampanga at Malasik River costing P1.157 billion, and Maasim River costing P341.678 million, per the sumbongsapangulo website.

What gives, Vince? Don't tell us we are merely seeing things?

## The President's point person, DPWH's finger man



YEAH, EVERY Juan — and Juana and Juanix to be universally gender-sensitive — knows Public Works Secretary Dizon is President Marcos Jr.'s point person for infra, and before that for transportation.

Really in character, as Dizon's presidential point-personality merely crossed over from the Duterte administration where it was in fact birthed and bred: 1) as president-CEO of the Bases Conversion and Development Authority, the point man for the development of New Clark City,

notably the construction of world-class sports facilities in time for the 2019 SEA Games — never mind the much-criticized P50-million "kaldero" used as the cauldron for the Games; and 2) as deputy chief implementer of the National Task Force Against Covid-19, the point man for the government's Test, Trace, and Treat (T3) program, even earning him the moniker "testing czar."

So ingrained is this point persona in Dizon that he has come to channel it in his body language, literally with

the forefinger, whether he is inspecting infra projects, fielding media questions, or holding meetings with his minions.

Case in point is his recent inspection blitz in Pampanga where Dizon's finger made a dramatic standout: at the collapsed — for the nth time — slope protection of the Candating flood control project; at the stalled flyover construction project in Angeles City; and at the proposed site for a bypass road connecting NLEX to some barangays in Mabalacat City.

With cleaning DPWH of graft and corruption included in his functions as infrastructure point man, Dizon has naturally assumed the akin persona of finger man, openly demonstrated in Candating when he named three DPWH personnel he suspended for allegedly demanding 8% kickbacks in government projects.

Point person. Finger man. It serves Dizon, the government, and the people well thus far. That we have to concede. May he keep it with the forefinger.

## Culture versus choice

"Excuse me," retired Ombudsman Conchita Carpio Morales, the one who ordered that Senator Joel Villanueva be dismissed but the Senate blithely ignored it," politely interrupted the President's grievous narrative.

Look what's happening at the International Criminal Court where a former president seems to have difficulty in defending his crime against humanity case, His lawyer are all foreigners and highly paid, to boot. So far, the Filipino lawyers handling the case for the Filipino victims are showing remarkable, exceptional competence in the area of international law.

So, PBBM has one good excuse if those being held accountable for the public works mess worth billions in taxpayers money are still free or are still roaming around here and there. Sorry

## End mass promotion, stop promoting failure

FOR YEARS, teachers, parents, and school heads have lived inside this quiet fiction: promotion rates are above 95% while national assessments reveal an entirely different story. Our learners cannot read, cannot compute, and cannot comprehend at the levels expected of them.

The latest Turning Point report by Second Congressional Commission on Education (EDCOM 2) tears the veil off this illusion. Only 30.5% of Grade 3 learners can read at the expected proficiency level. By Grade 12, that number plunges to 0.40%, which is not even one out of every 200 students. We are not just witnessing learning gap but the slow erosion of our children's futures, one grade level at a time.

And yet, year after year, we promote them anyway.

Parents who insist that their children must move up - "*Tutu pu kasing makarine*," "*Tukyan nala pu reng ka-edad na*," or "*Bangkanita eya pu malakwan*" - may not realize how much harm this causes. Theirs is not an act of love but an act of delay. When will they realize that promotion without mastery is a quiet cruelty?

A child who cannot read in Grade 3 will drown in Grade 6, and by the time they reach junior high, school has become a daily humiliation masked by silence. Many eventually drop out, not because they are lazy, but because the system pushed them forward without equipping them to survive.

The cost of repeating a grade is small; the cost of not learning is lifelong.

Teachers know this too intimately. Many hesitate to give failing grades not because the child does not deserve an

honest assessment, but because the paperwork, justifications, interventions, and the blame all fall on them. "Human consideration" is too often used as a shield to protect the adults in the system rather than the learners themselves. True compassion is not about passing students; it is about helping them succeed.

School heads carry another burden. Their performance ratings depend on promotion, completion, and graduation statistics. Every retained student is a red mark. In such a distorted environment, telling the truth about student performance becomes an administrative risk. Mass promotion becomes a survival instinct, not an educational choice. Ending mass promotion, as EDCOM 2 now urges, is necessary. But let's be brutally honest: it will not fix the crisis by itself.

The roots of this catastrophe sink deeper into overcrowded classrooms, curriculum overload, teacher shortages, lost instructional time, poverty, and the absence of strong early literacy programs. We need more than a policy change. We need structural courage.

Ending mass promotion is the first honest step.

But rebuilding trust in our education system and giving every child the dignity of real learning will take far more than simply moving

students up or down. It will require a nation finally willing to confront uncomfortable truths and choose long-term solutions over short-term appearances.

Our children deserve more than promotion. They deserve preparation; the kind that gives them a real future, not just a report card.

**AN ORDINANCE CREATING THE BUSINESS PERMITS AND LICENSING DEPARTMENT (BPLD) OF THE CITY GOVERNMENT OF MABALACAT, DEFINING ITS FUNCTIONS, DUTIES, AND RESPONSIBILITIES, PROVIDING FOR ITS ORGANIZATIONAL STRUCTURE, AND APPROPRIATING FUNDS THEREFORE**

**Be it ordained by the Sangguniang Panlungsod of Mabalacat City, in session assembled:**

**SECTION 1. TITLE.**

This Ordinance shall be known and cited as the "*Ordinance Creating the Business Permits and Licensing Department (BPLD) of the City Government of Mabalacat.*"

SECTION 2. DECLARATION OF POLICY.

It is hereby declared the policy of the City Government of Mabalacat to promote efficient, transparent, and business-friendly governance through the streamlining and strengthening of the business permitting system and enhancement of local revenue generation.

In line with the City's mission to foster sustainable economic growth, it is deemed necessary to upgrade the existing **Business Permits and Licensing Unit (BPLU)** into a full-fledged **Business Permits and Licensing Department (BPLD)** to better perform its mandate and effectively implement the *Ease of Doing Business and Efficient Government Service Delivery Act of 2018 (Republic Act No. 11032)*.

SECTION 3. CREATION OF THE BUSINESS PERMITS AND LICENSING DEPARTMENT.

There is hereby created a department under the Office of the City Mayor to be known as the **Business Permits and Licensing Department (BPLD)**.

The existing **Business Permits and Licensing Unit (BPLU)** is hereby converted and elevated into a full-fledged department, with the corresponding plantilla position of **City Government Department Head I**, subject to the approval of the Department of Budget and Management (DBM) and in compliance with the Civil Service Commission (CSC) qualification standards.

SECTION 4. OBJECTIVES.

The establishment of the BPLD shall aim to achieve the following objectives:

1. To improve the efficiency and transparency of business permit processing and tax collection;
2. To enhance compliance and enforcement of business-related laws, ordinances, and regulations;
3. To promote ease of doing business and ensure full implementation of *Republic Act No. 11032*;

4. To establish and maintain an integrated business database system for monitoring, evaluation, and policy formulation; and,
5. To support the City's economic and investment development agenda through strengthened coordination with relevant departments and national agencies.

SECTION 5. ORGANIZATIONAL STRUCTURE.

The **Business Permits and Licensing Department (BPLD)** shall be headed by a **Department Head** and shall be composed of the following divisions or sections:

1. **Business Permits Processing Division** – Responsible for the evaluation and processing of new and renewal business permit applications;
2. **Inspection and Compliance Division** – Conducts field inspections, verifications, and ensures compliance of business establishments with regulatory requirements;
3. **Business Tax Assessment and Verification Division** – Works closely with the City Treasurer's Office (CTO) for accurate computation and assessment of business taxes, fees, and charges;
4. **Records and Information Management Division** – Maintains a centralized, digitized business registry and database in coordination with the Management Information Systems Office (MISO); and,
5. **Administrative and Support Services Division** – Manages internal operations, personnel, budgeting, logistics, and other support functions of the department.

SECTION 6. QUALIFICATIONS OF THE DEPARTMENT HEAD.

The **Business Permits and Licensing Department Head** shall possess the following minimum qualifications:

- Must be a citizen of the Philippines;
- Of good moral character;

- A holder of at least a Bachelor's Degree in Business Administration, Public Administration, Accounting, Economics, or any related field;
- With at least five (5) years of relevant supervisory or managerial experience in public administration or private enterprise; and,
- A resident of Mabalacat City.

SECTION 7. FUNCTIONS AND RESPONSIBILITIES.

The **Business Permits and Licensing Department (BPLD)** shall have the following functions and responsibilities:

1. Process, evaluate, and issue business permits and licenses in accordance with existing laws, rules, and local ordinances;
2. Assess and verify business taxes, fees, and charges in coordination with the City Treasurer's Office;
3. Monitor and ensure compliance of business establishments with applicable national and local laws, such as those relating to sanitation, zoning, fire safety, and environmental standards;
4. Maintain, update, and secure the official registry and database of business establishments operating within Mabalacat City;
5. Implement, operate, and monitor the **Mabalacat City Business One-Stop Shop (BOSS)** in accordance with *Republic Act No. 11032*;
6. Coordinate with the City Planning and Development Office (CPDO), City Engineering Office (CEO), City Environment and Natural Resources Office (CENRO), City Health Office (CHO), Bureau of Fire Protection (BFP), and other relevant offices for inter-office clearances and evaluations;
7. Recommend policies, programs, and reforms that promote a business-friendly environment and strengthen local revenue generation; and,
8. Perform such other duties and responsibilities as may be assigned by the City Mayor or as may be provided by law or ordinance.

SECTION 8. STAFFING PATTERN AND PERSONNEL.

The **City Human Resource Management Office (CHRMO)** shall prepare the

staffing pattern and organizational chart for the BPLD, subject to the approval of the City Mayor and confirmation by the Sangguniang Panlungsod, in accordance with DBM and CSC standards.

Existing personnel of the former Business Permits and Licensing Unit (BPLU) shall be absorbed into the newly created department **without loss of rank, tenure, or benefits.**

SECTION 9. FUNDING REQUIREMENTS.

The amount necessary for the initial implementation of this Ordinance shall be charged against available funds of the City Government.

Thereafter, the annual budgetary requirements for the continued operation of the BPLD shall be incorporated into the **Annual Executive Budget** of Mabalacat City.

SECTION 10. MONITORING AND EVALUATION.

The performance and operations of the BPLD shall be **monitored and evaluated** by the Office of the City Mayor, in coordination with the City Treasurer's Office and the **Committee on Ways and Means** of the Sangguniang Panlungsod, to ensure transparency, efficiency, and accountability in service delivery.

SECTION 11. SEPARABILITY CLAUSE.

If, for any reason, any section or provision of this Ordinance is declared unconstitutional or invalid by a competent authority, the remaining provisions shall not be affected and shall continue to be in full force and effect.

SECTION 12. REPEALING CLAUSE.

All ordinances, resolutions, or executive issuances inconsistent with the provisions

15. In the case of Vidal-Plucena vs. Balgos, Jr., et. al, G.R. No. 255331, July 10, 2023, the Supreme Court has held that: "what determines jurisdiction is assessed value of the 'property involved' or 'interest therein' ... The assessed value of the entire... property... could not be the basis..."

III  
PLAINTIFFS' TITLES/INTERESTS AND POSSESSION

16. Plaintiffs lawfully acquired undivided portions of the property from defendants, as follows:

16.1 Evangelina Calma Cortez and her late husband Constantino T. Cortez purchased 224 sq. meters from the defendants pursuant to a Deed of Absolute Sale<sup>16</sup> with acknowledgment receipt dated April 29, 2011;

16.2 Ofelia Cortez Taruc purchased 102 sq. meters pursuant to a Deed of Absolute Sale<sup>17</sup> with acknowledgment receipt dated April 29, 2011;

16.3. Spouses Roberto P. San Diego and Benilda B. San Diego purchased 136 sq. meters per Deed of Absolute Sale<sup>18</sup> dated June 15, 2012;

16.4. Victoria S. Miranda purchased 800 sq. meters per the Agreement of Purchase and Sale<sup>19</sup> dated July 21, 2008.

17. Since their respective purchases, plaintiffs have been in actual, peaceful possession and use of their portions. The subject property has no known encumbrance and has not been otherwise sold, mortgaged, or encumbered by defendants in favor of third persons.

11. To facilitate transfer and registration, Plaintiffs Evangelina and Ofelia secured in 2011 the Capital Gains Tax (CGT) Return<sup>20</sup>, Documentary Stamp Tax (DST) Return<sup>21</sup>, and the Certificate Authorizing Registration (CAR)<sup>22</sup>. Plaintiffs acknowledge the need to revalidate due to expiry and will submit a current Certificate.

PRIOR DEMAND; REFUSAL

18. On January 31, 2018, plaintiffs Evangelina and Ofelia, through counsel, sent a demand letter "to respondents requiring surrender of the duplicate of the title and cooperation in effecting transfer and partition within five (5) days from receipt;

19. Respondents received the demand letter but failed and refused, and continue to fail and refuse, to surrender the duplicate certificate of title without any lawful cause;

VI  
BARANGAY CONCILIATION

20. On July 2, 2025, plaintiffs Evangelina and Ofelia secured a Certificate<sup>23</sup> to File Action from the Barangay Sta. Cruz Poblacion of the Municipality of San Luis to comply with the Barangay Justice System requirement;

VII  
CAUSE OF ACTION; RIGHT TO PARTITION

21. Plaintiffs, as purchasers and possessors of undivided portions of the property, are co-interested in the same and have the right to compel partition as prescribed by Rule 69, Section 1 of the Rules of Court. If parties do not agree on partition, the Court shall appoint commissioners to make the partition (Rule 69, Sec. 3). Upon confirmation, the partition and court order shall be recorded with the Registry of Deeds (Rule 69, Sec. 2), Rules of Court (1964). The Civil Code governs effects of partition and delivery of titles (Arts. 1087-1092) Civil Code (1949). The Supreme Court, in Logrosa v. Azares et al., G.R. No. 217611, March 27, 2019, directed the trial court to issue an order of partition after finding co-ownership.

*"Petitioner Rogelio Logrosa filed a Petition for Review on Certiorari assailing the dismissal of his complaint for partition by the Regional Trial Court (RTC) and the Court of Appeals (CA). The subject properties include eight parcels of land. The CA held that the evidence presented by petitioner Logrosa was insufficient to prove co-ownership, but the Supreme Court found that he is a co-owner based on the certificates of title and a notarized Deed of Absolute Sale. The Court also found that the respondents failed to provide convincing evidence to repudiate co-ownership. As a result, the decision of the RTC and CA was reversed, and the RTC was directed to issue an Order for the partition of the subject properties."*

VIII  
ANCILLARY RELIEFS NECESSARY TO EFFECTUATE PARTITION

13. To implement partition, ancillary orders are warranted:

(a) appointment of not more than three (3) competent, disinterested commissioners;

(b) authority to cause a relocation/subdivision survey by a licensed geodetic engineer;

(c) upon confirmation, direction to the Registry of Deeds of Pampanga to cancel TCT No. 643416-R and issue new titles to the parties for their adjudicated portions; and

(d) an order requiring defendants to produce/surrender the owner's duplicate certificate of title to the Court/Registry of Deeds for cancellation and issuance of derivative titles.

IX  
NO OTHER SUITS; CONDITION PRECEDENT

14. Plaintiffs have not commenced any other action involving the same issues and parties; they undertake to submit a verified Certification against Forum Shopping, Verification, and copies of Judicial Affidavits, per the Judicial Affidavit Rule.

V.

# Rotary Clubs’ P5.7-M project brings clean water to Aeta community, school in Floridablanca

FLORIDABLANCA, PAMPANGA — Clean and safe water has become easily accessible to residents of the remote highland community of Sitio Camachile and pupils of Camachile Elementary School with the formal inauguration of a new water system on Jan. 31.

Named the Camachile Water Resources and Sanitation Facilities, the project is a joint effort of the Rotary Club of Dolores in Pampanga and the Rotary Club of Saesongtan in South Korea. It was carried out through Rotary International Global Grant No. 2569386.

Costing P5,742,984, the project covered the water reservoir study, construction work, hygiene and sanitation kits, and professional supervision to make sure the system was built properly.

Rotary District 3750 governor Moon-Ok Kang said her district acted quickly after learning about the water problems in the community. She said she was proud of the members of the Rotary Club of Saesongtan and happy that they could share the project with the students and residents of Sitio Camachile.

Kim Jeong Hoon, International Exchange Standing Committee chairman of RC Saesongtan, said water is one of Rotary’s main priorities because it is essential to life. He stressed that helping communities gain access to clean water is an important mission, especially in areas facing water shortages.

The new facilities are meant to provide a long-term solution to the lack of basic services in the area. The project includes a high-capacity submersible pump, overhead water tanks, and five water refilling stations for community use.

The school also received a handwashing area, a drinking station, and newly built and renovated toilets for students and teachers.

Completed over two Rotary years, the project broke ground in 2025 under the leadership of then-district governor Ariel Jersey and Rotary Club of Dolores president Maureen Gueco.

Rotary Club of Dolores president Albert Lacanlale said the project took years of hard work as it involved technical studies, many meetings, and strict budget reviews before construction could begin, even as its main goal was simple: to give the community and the students reliable access to clean water.

Aside from the water system, the Rotary Clubs of Dolores and Saesongtan also distributed hygiene kits to students and residents. The Korea Saesongtan and Songtan Mindeul Rotary Clubs also donated cash to help build a covered court at the school.

Agriculture Secretary Francisco Tiu Laurel Jr. on Tuesday, Feb. 3 joined Gov. Lilia “Nanay” Pineda, Vice Gov. Dennis “Delta” Pineda, and Mayor Esmeralda Pineda in an on-site inspection of the P414.8-million facility currently undergoing final site development works and equipment installation.

The Provincial Government of Pampanga allocated more than P270 million for site development, road concreting, and construction of the rice complex, while the Department of Agriculture provided P50 million for the procurement of machinery and equipment.

For its part, the Philippine Center for Postharvest Development and Mechanization (PhilMech) supplied two rice mills and five circulating dryers as counterpart support, along with six tractors, four harvesters, and four precision seeders to further assist farmers once the facility becomes operational.

The Pampanga Food Security Complex is a joint project of the DA, PhilMech, and the Provincial Government of Pampanga, designed as a one-stop postharvest service center equipped with mechanical dryers, rice milling systems, and modern storage facilities.

Once operational, the complex is expected to reduce postharvest losses, improve rice quality, and increase rice production efficiency, while helping eliminate middlemen and

improve farmers’ incomes. The DA said the project supports the government’s broader food security strategy by strengthening production, processing, and storage capacities, complementing affordable rice distribution initiatives such as the “Benteng Bigas, Meron Na!” program which was rolled out on the same day at the Lubao Municipal Government compound.

‘Benteng Bigas’ MOA

Coinciding with the rollout was signing of a memorandum of agreement between the Food Terminal Inc. and the provincial government assuring Pampanga of a steady and sustained supply of rice from the national government and specifically clarifying that no subsidy will be provided by the local government unit.

Under the agreement, rice priced at P33 per kilo will be sold directly to beneficiaries at P20 per kilo through the national government’s program.

The DA reported that there are currently 508 Benteng Bigas sites nationwide, serving more than 2.6 million families across 82 provinces.

In Pampanga, the program targets 350,000 households, benefiting more than one million residents.

The Benteng Bigas program is set to run until June 30, 2028, ensuring continued access to affordable, quality rice while supporting the government’s broader food security agenda. **Marie Joy S. Carbungco/PIA-3**

guys, we did need vote a lawyer for president but a former dictator’s son who, by the way, has deleted the usual Edsa Revolution commemoration in February in the list of national holidays.

Maybe next year,who knows. Or when the corrupt people in government are finally brought behind bars as PBBM wished they would spend the rest of their lives.

Don’t lose hope, considering that most Filipinos believe that 2026 will bring better news. For one thing, we have an Ombudsman who believes the best is yet to come to the anti-graft body ever since a former senator was wary of shaking the hands of a former graft buster for fear of losing some of his fingers.

This new kid on the block, another lawyer loyalist of PBBM along with another brother in the Cabinet, impresses many

Those who will think twice, the voters will know what to do. No need for a Constitutional amendment. The CHARTER IS CLEAR ABOUT IT. The choice must trump the culture.

Now in its fourth year, Hann has learned to grow with its surroundings. And as Clark welcomes more flights, more travelers, and more investors, the resort has expanded not only in size but in character, taking on the cadence of a place that knows its role in a region on the rise.



## Worlds Within Machines

Much of the excitement that evening centered around a gleaming row of freshly installed slot machines from Aristocrat Gaming — 270 units in total. Gamers familiar with titles like Dragon Link™, Buffalo Gold™, and Bao Zhu Zhao Fu™ Chapter 2 lit up at the sight of familiar favorites. The debut of Tian Ci Jin Long™ in the Philippines added an electric sense of “newness” to the floor.

For a resort that aims to keep pace with global standards in gaming technology, the partnership carries weight. It marks Hann as a destination not only for leisure travelers but for players seeking world-class entertainment options right in Clark.



## What Leaders Say When the Lights Go On

During the opening program, Daesik Han, Chairman and CEO of Hann Resorts, spoke quietly but with conviction.

“Whenever we venture into something new, there are no guarantees of success,” he said. “But what drives us forward is the courage to innovate and the unwavering support of the people who believe in our vision.”

Around him stood Atty. Agnes VST Devanadera, President of the Clark Development Corporation; Mr. Dennis Andreaci, Senior Vice President of Casino Operations; and Mr. Rod Hackman, Vice President of Gaming Operations. Their presence framed the moment with the unmistakable contours of partnership — private sector ambition meeting public sector stewardship in a Freeport shaping itself for the future.

## The Sounds of Celebration

Opening nights carry their own rhythm — the rustle of dresses, the soft echoes of footsteps across polished floors, the sudden swell of cheers when a ceremonial ribbon falls. The Canyon Café & Winery is a study in quiet duality. By day, it is a haven for coffee drinkers, pastry lovers, and visitors taking a break between meetings or gaming breaks. By night, it softens into a warm wine lounge — intimate, relaxed, layered with possibility. With seating for 52, it feels personal rather than imposing.

On the other hand, Three Woks bursts with the casual vibrancy of East Asia: dim sum, sushi, Korean barbecue plates, and comforting bowls that speak to late-night cravings and shared meals. With space for 148 guests, it embraces the Freeport's diversity and its constant flow of travelers, workers, and guests seeking a familiar taste away from home.

Together, these new outlets join Hann's portfolio of 20 restaurants, cafés, and bars, enriching the resort's growing culinary map.

## A Freeport, a Resort, and a Rising Region

Hann Casino Resort holds the distinction of being Central Luzon's first fully integrated resort, home to over 800 rooms from Swissôtel Clark and Clark Marriott, alongside the 8th Avenue Lifestyle Mall — where regional firsts and well-loved dining names have found a home.

With its expansion now open, Hann is positioning itself for the next wave of growth in Clark. But more than the added machines, rooms, or restaurants, the expansion speaks to something more enduring: the sense that Clark is becoming a place where ideas meet opportunity, and where spaces continue to evolve for the communities and travelers that move through it.

In the quiet glow of the new wing, with its canyon-like contours and warm light falling from above, it becomes clear that Hann's expansion is not only about building bigger. It is about building forward — in tune with a Freeport that is still writing its story, one landmark at a time.
